FIG. 13 is a top plan view of the pill organizer of FIG. 8; and,

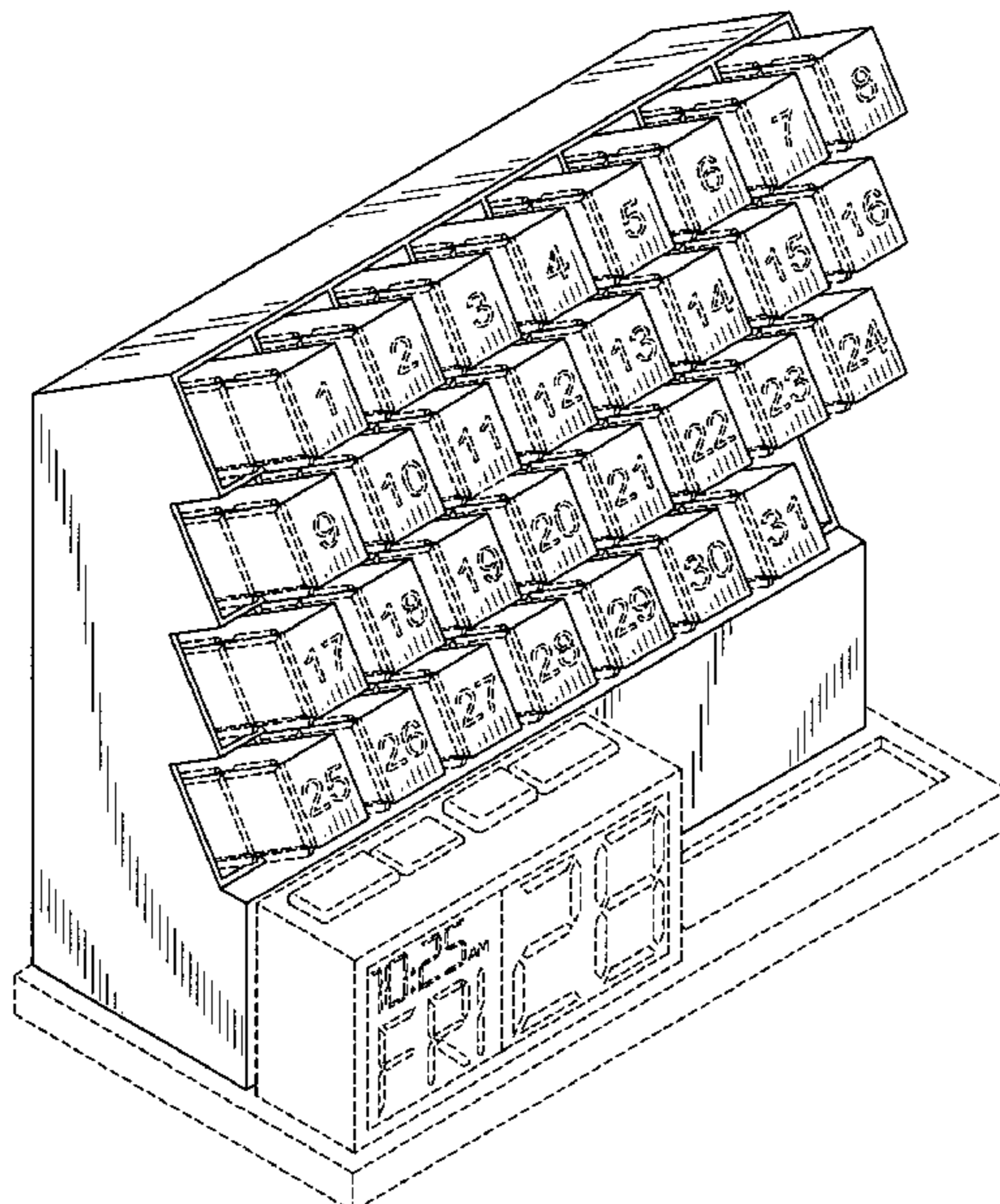
FIG. 14 is a bottom plan view of the pill organizer of FIG. 8.

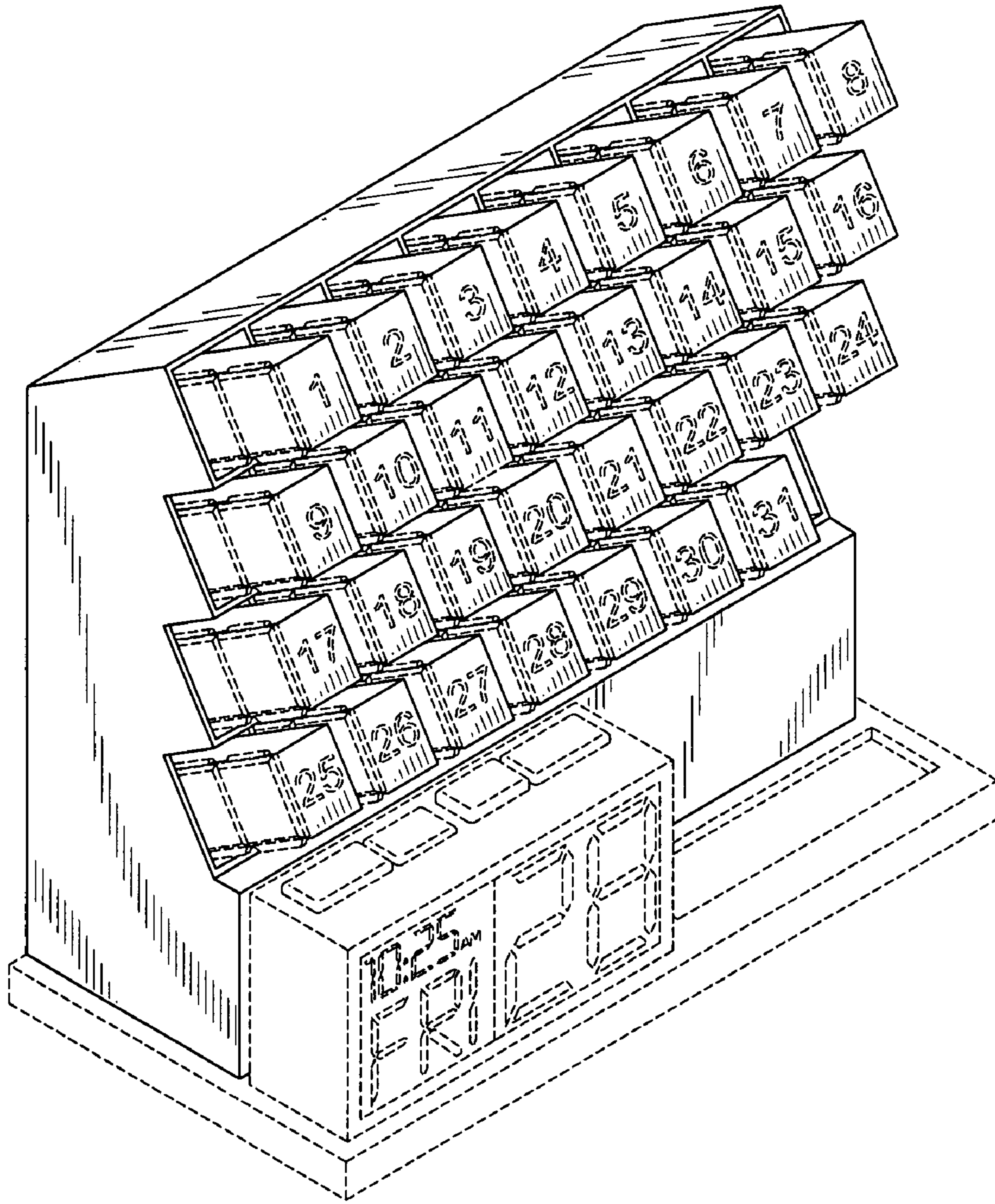

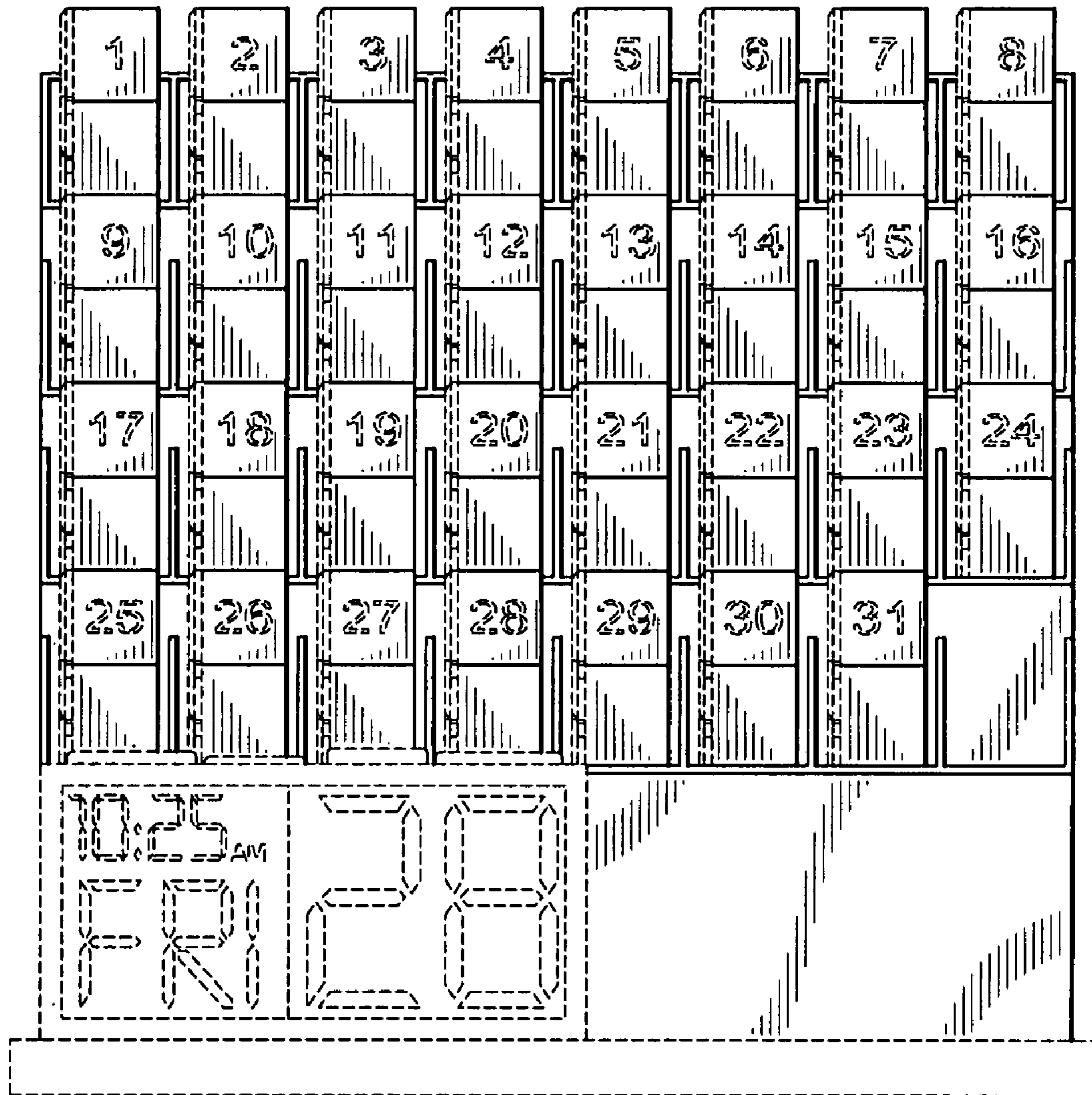

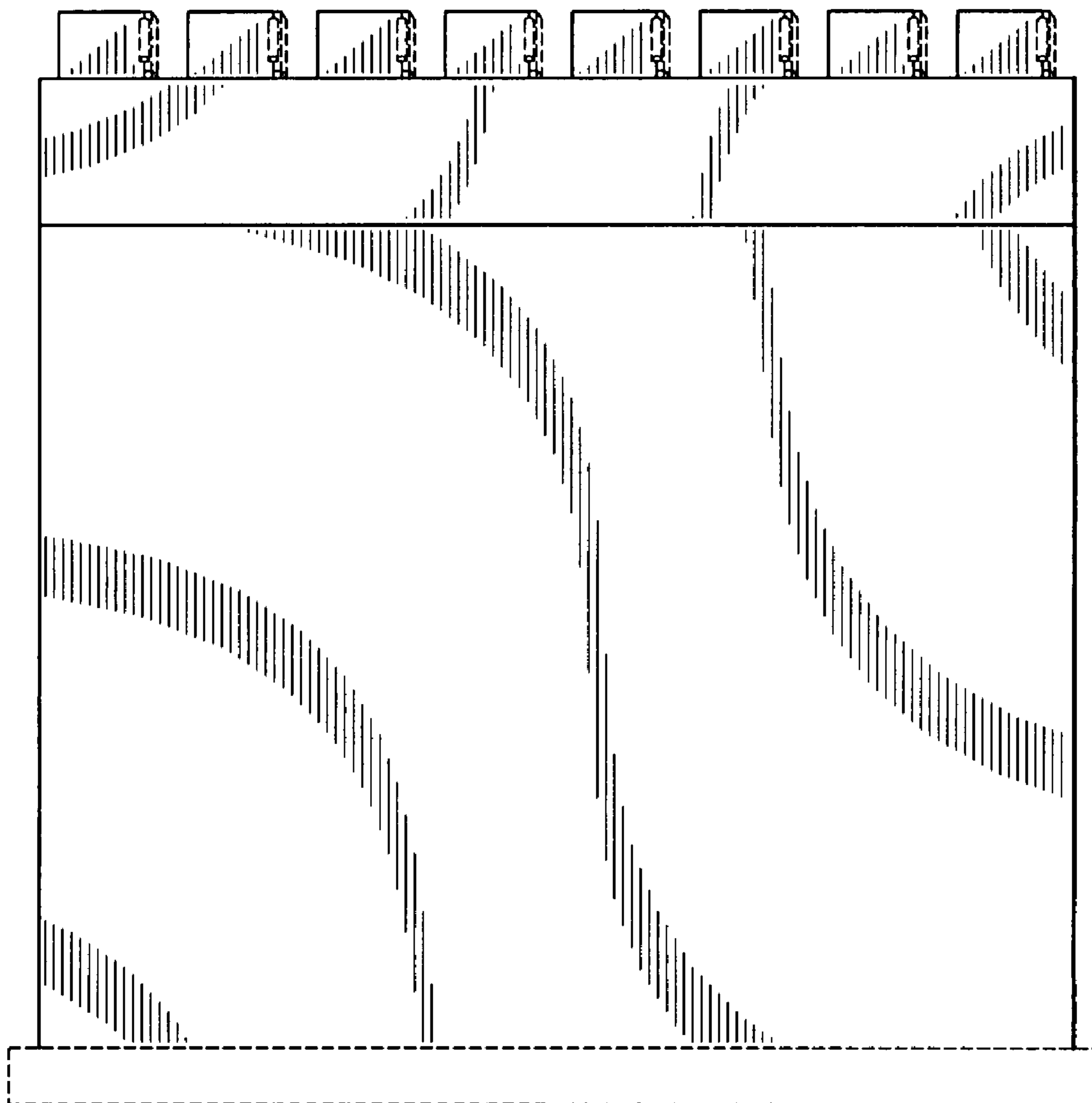

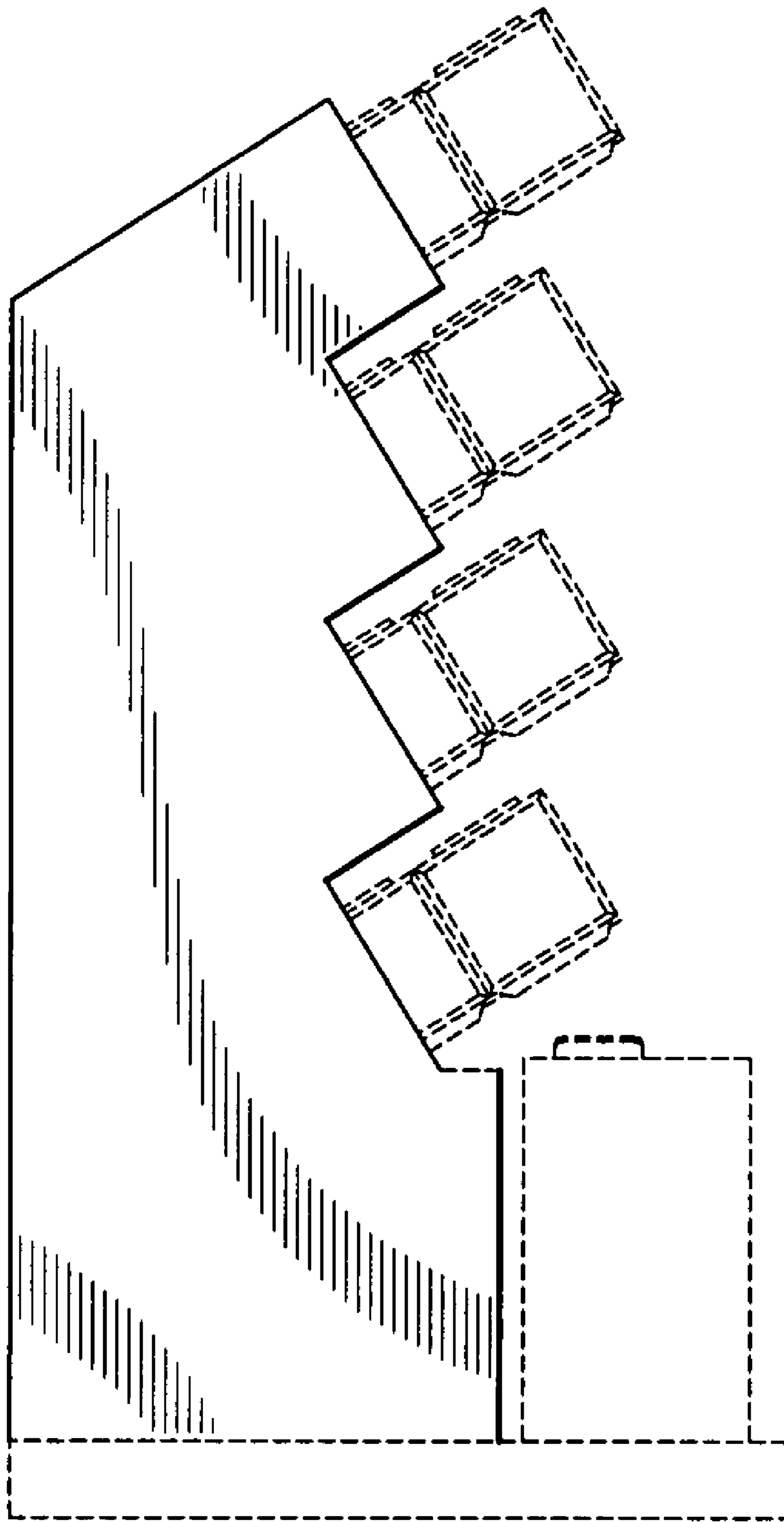

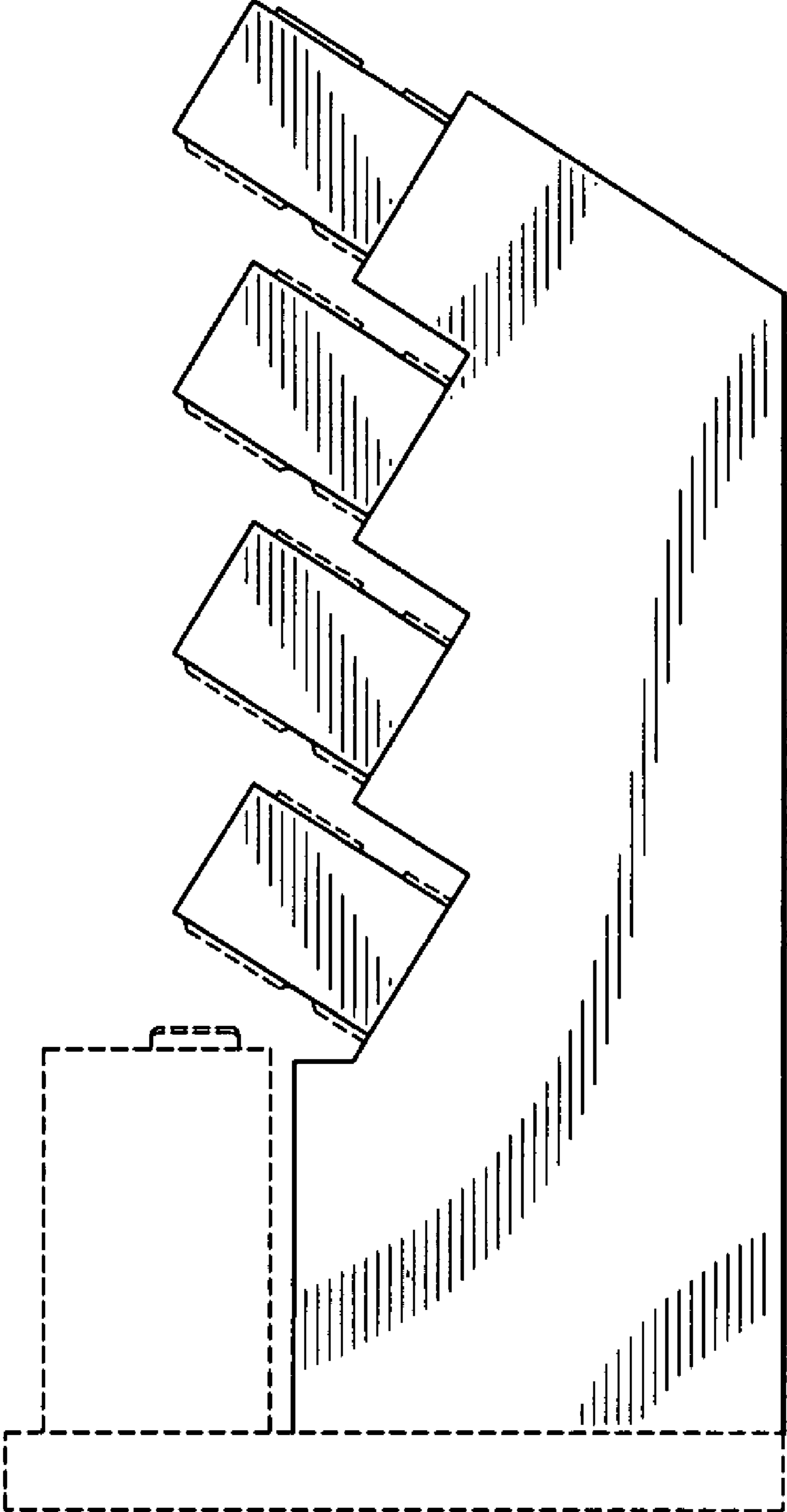

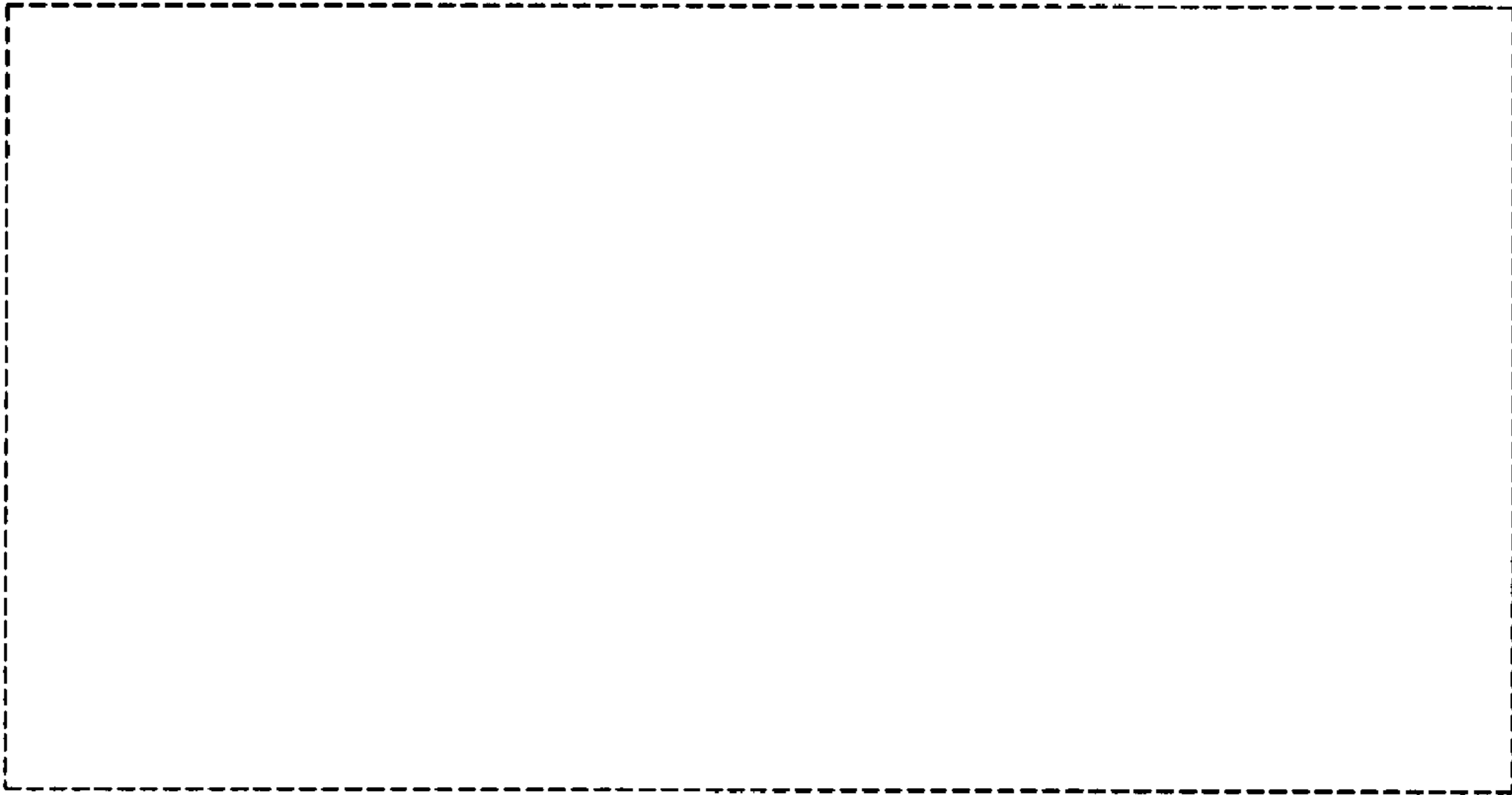

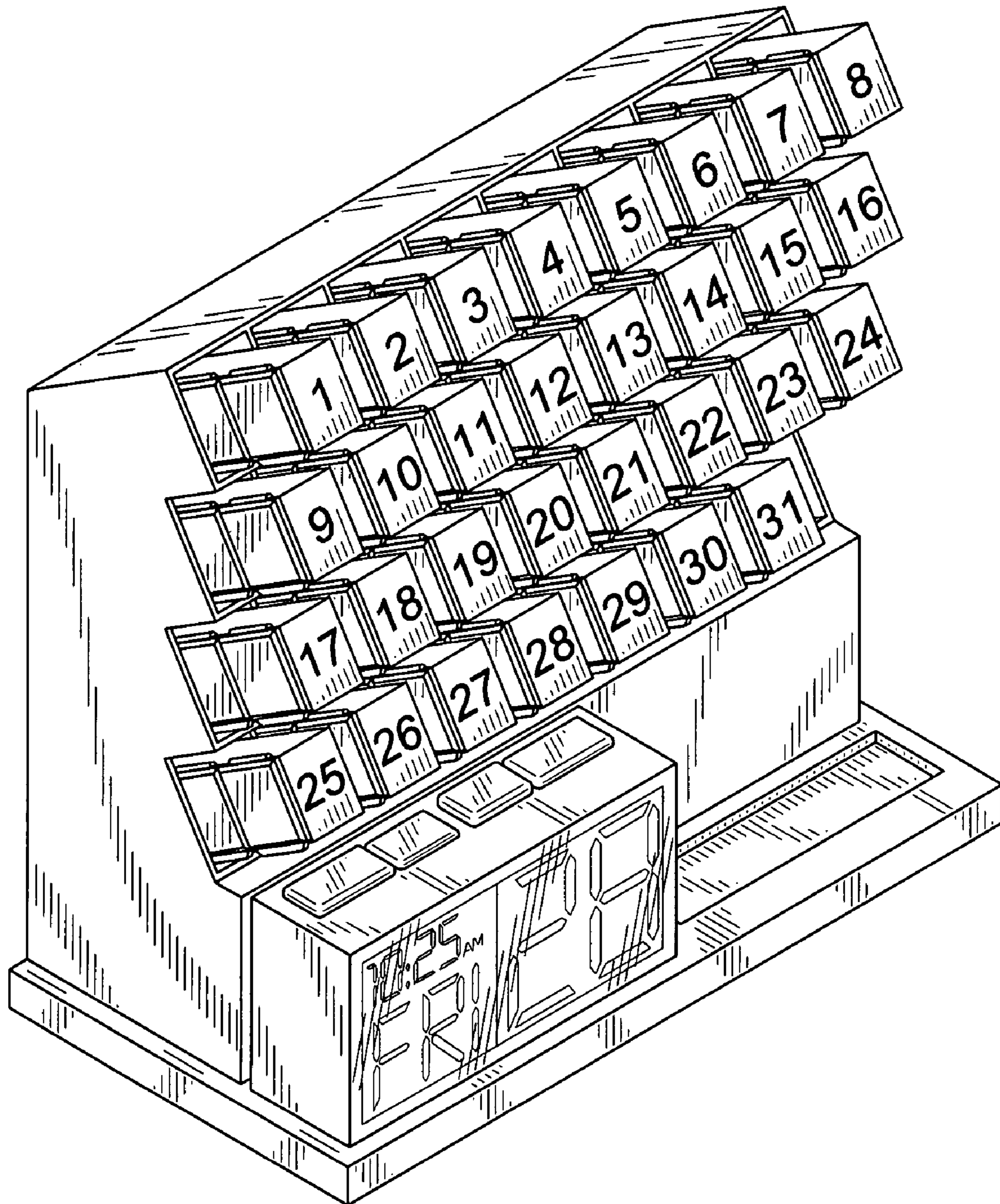

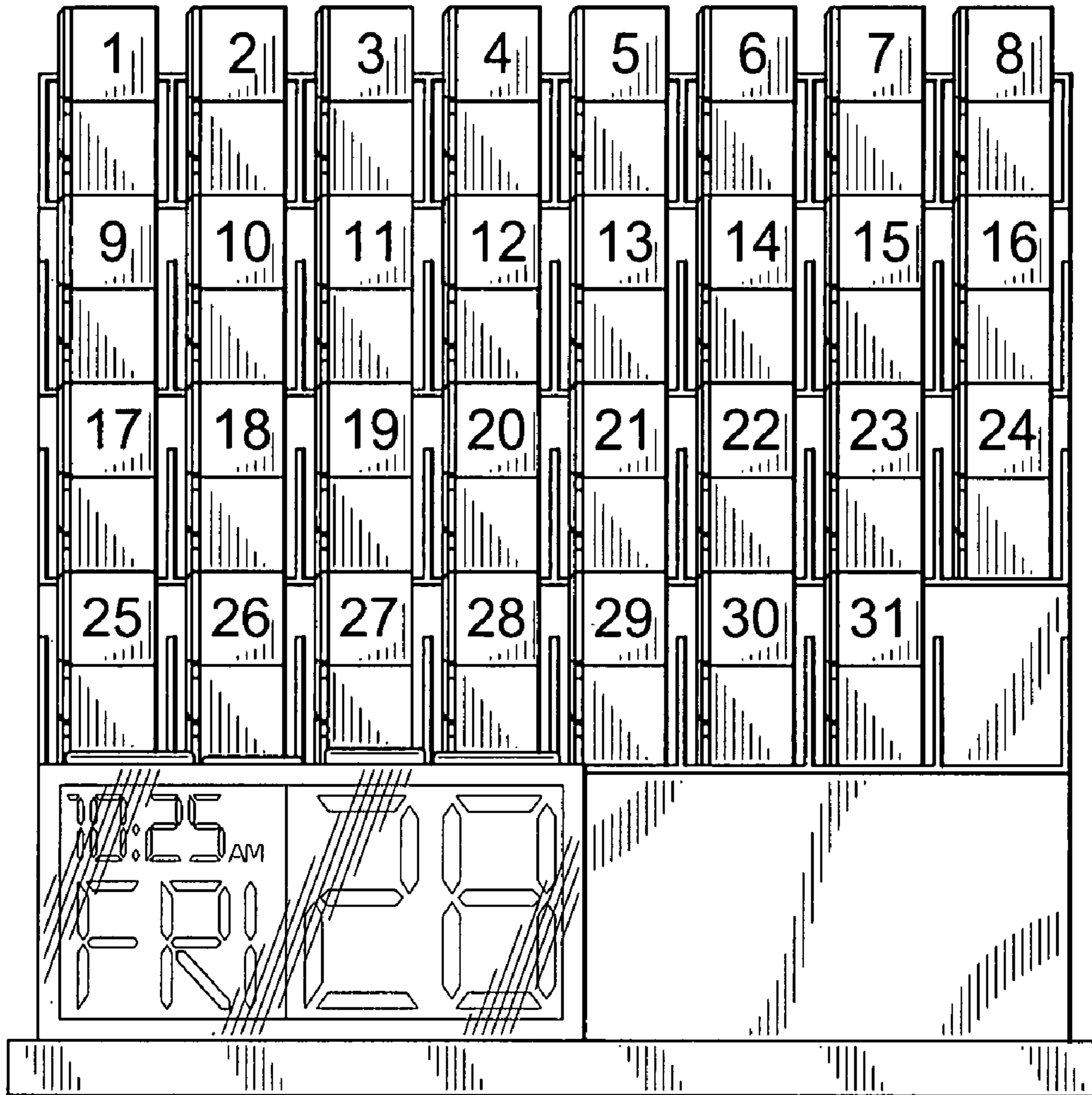

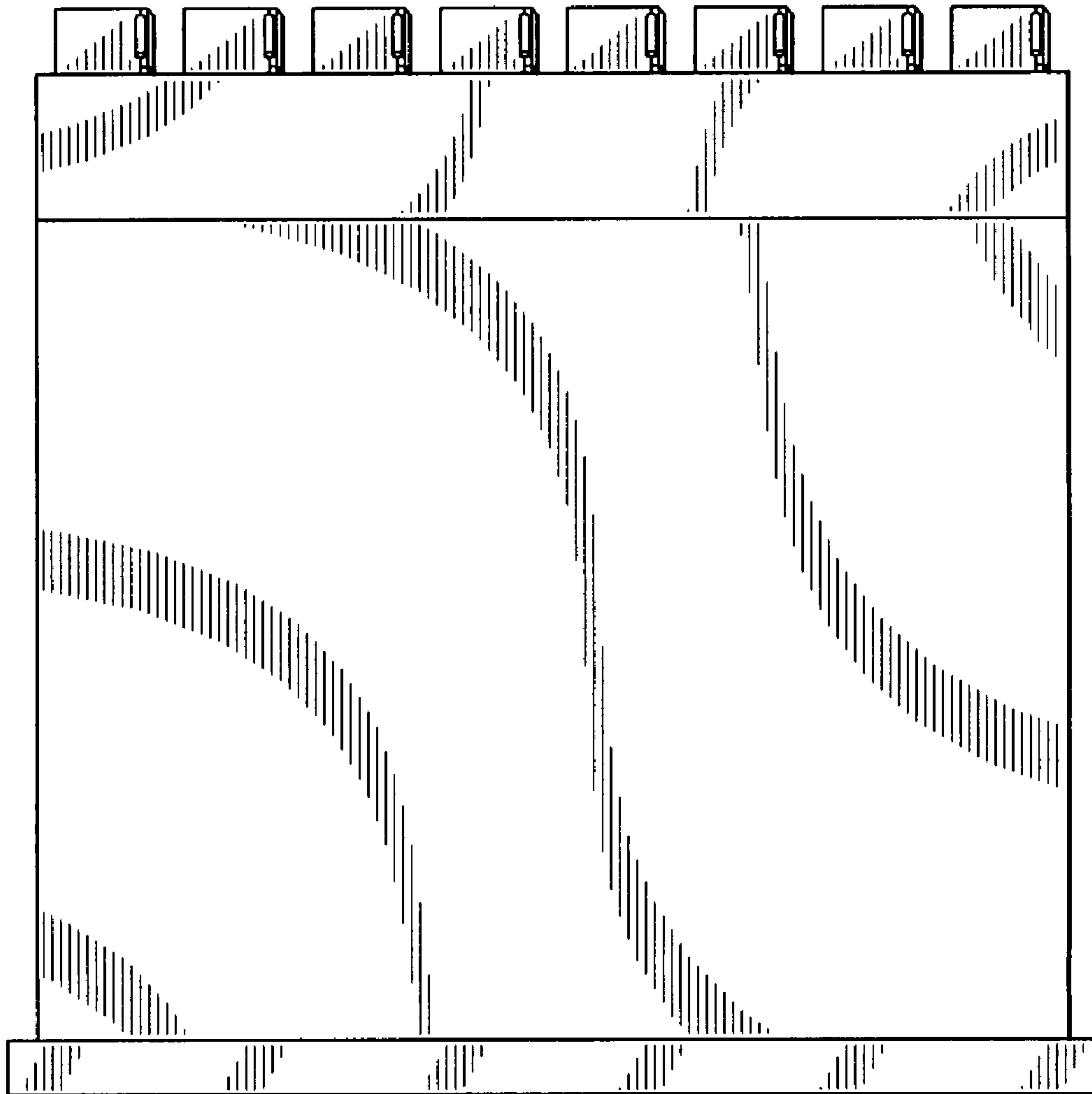

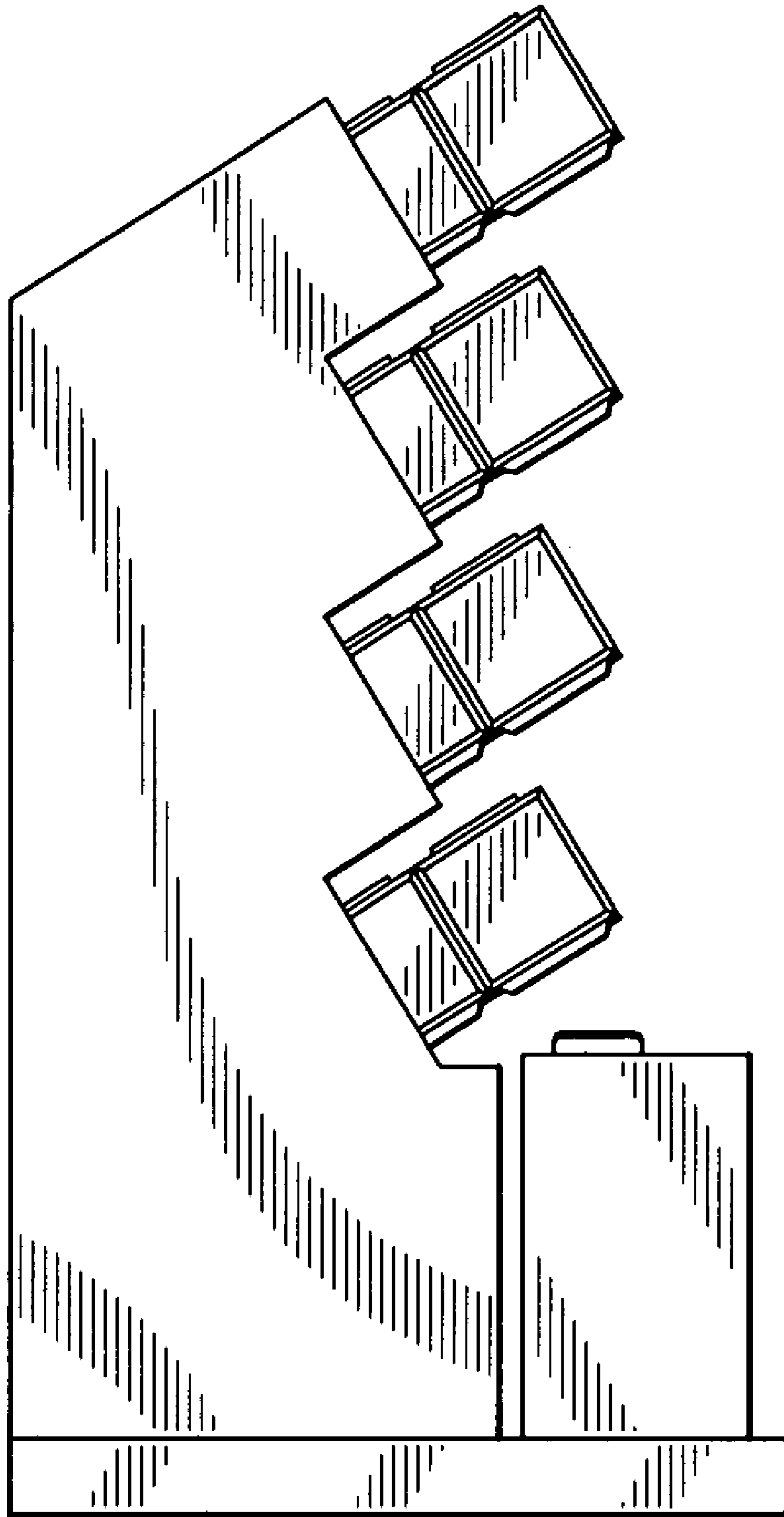

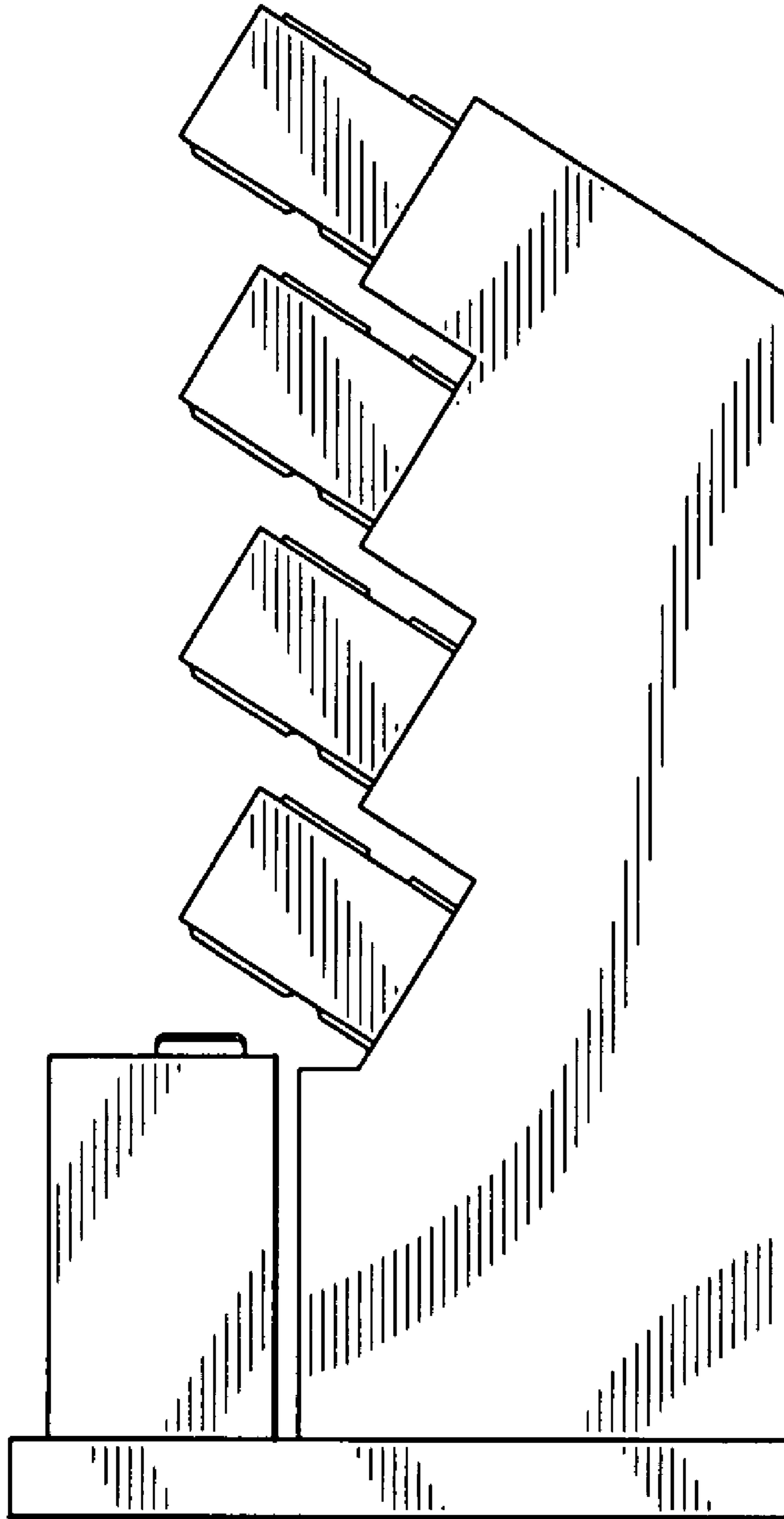

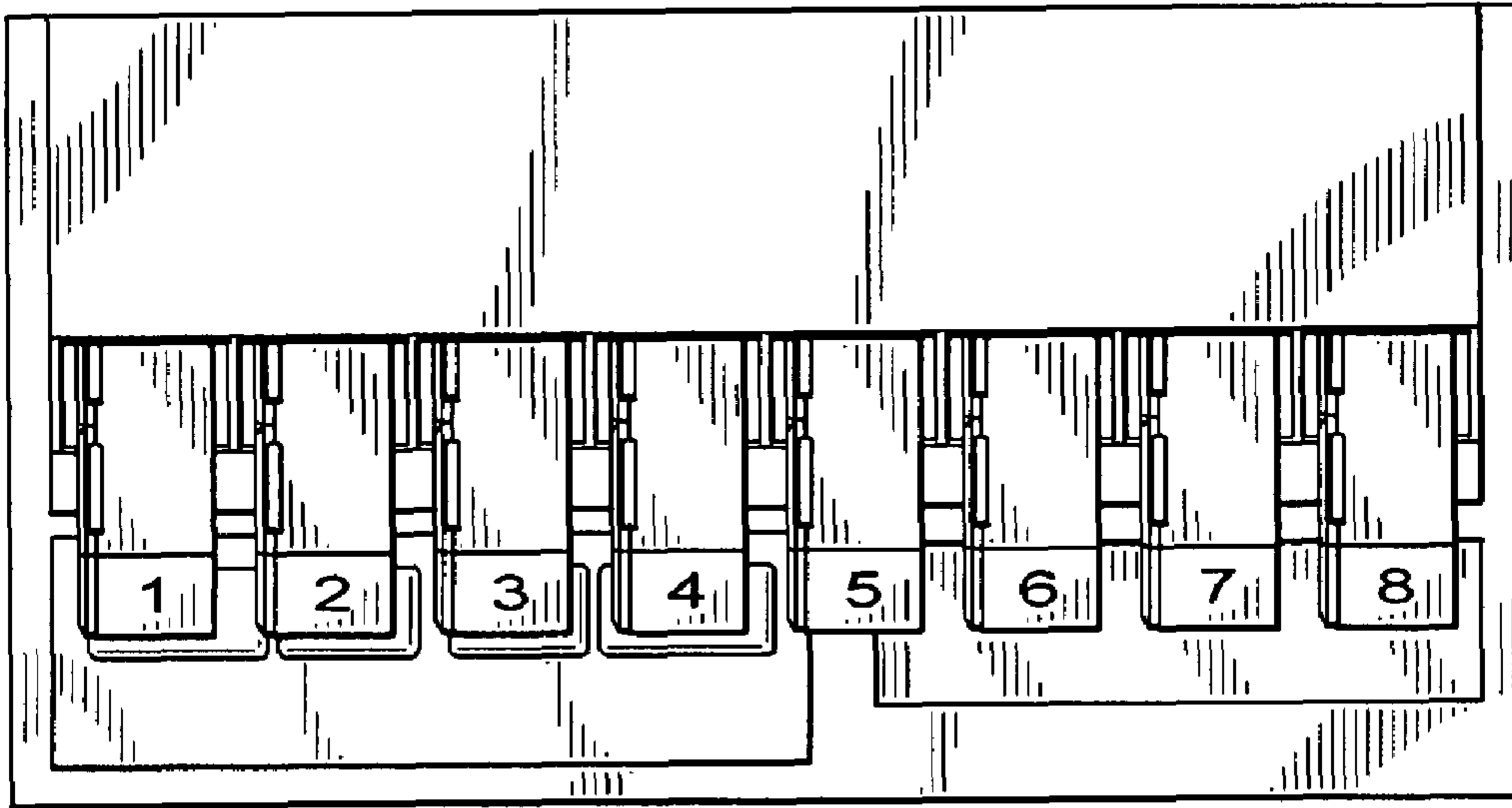

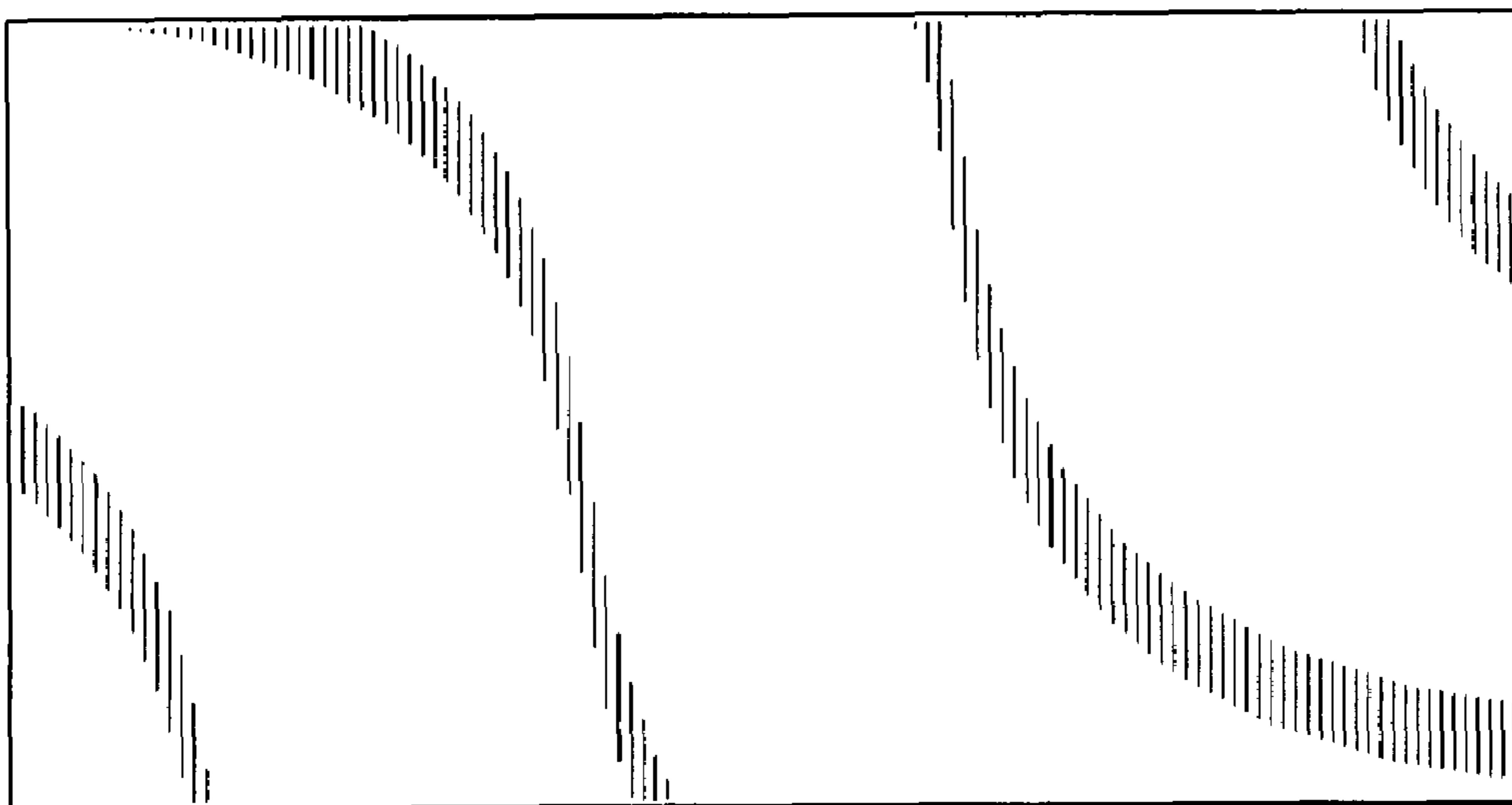
