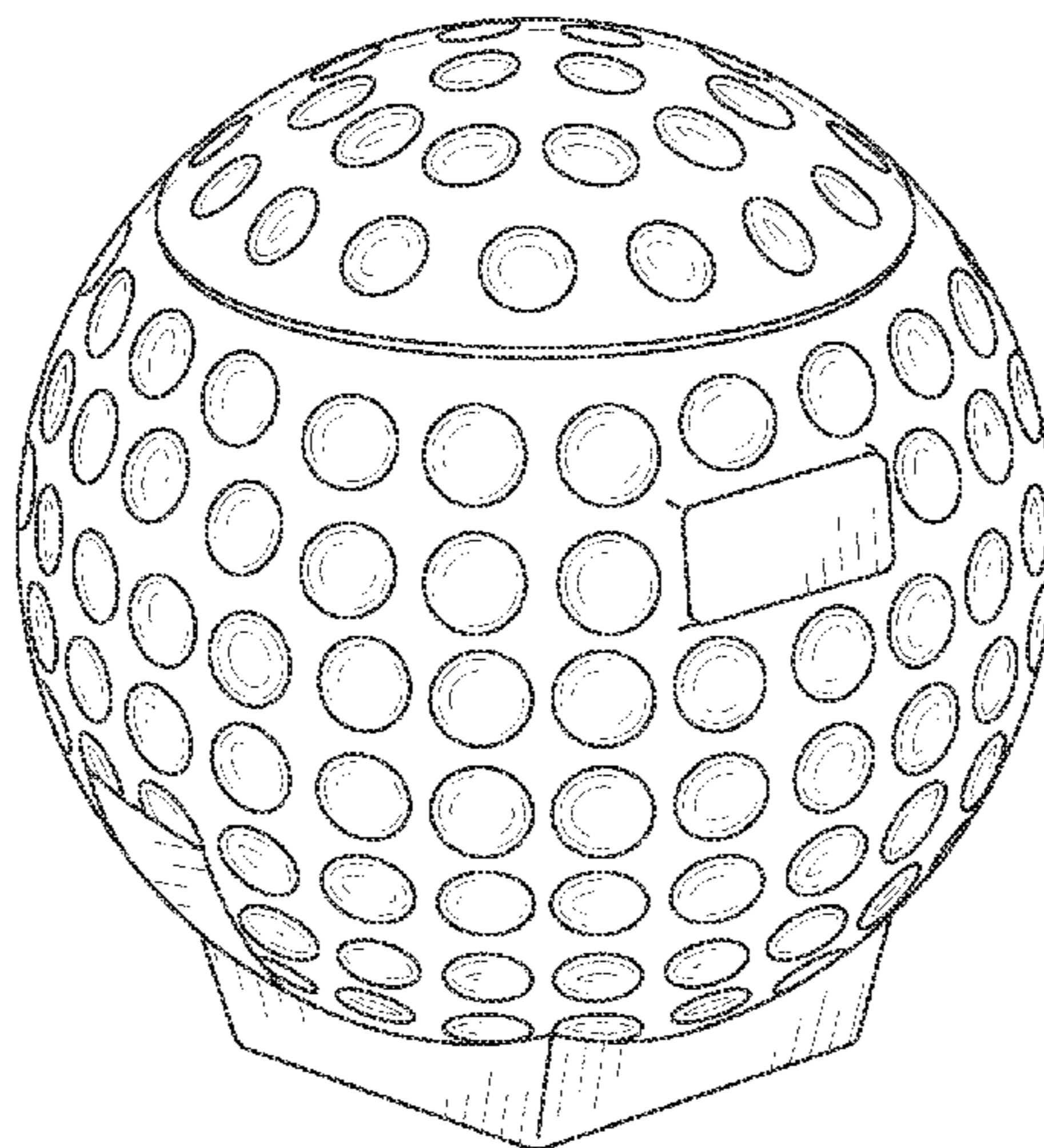
(57) **CLAIM**

The ornamental design for a toy chest, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a toy chest, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view of thereof;
FIG. 4 is a side elevational view of the toy chest, the other side being a mirror image thereof; and,
FIG. 5 is a front elevational view of the toy chest, the rear being a mirror image thereof.

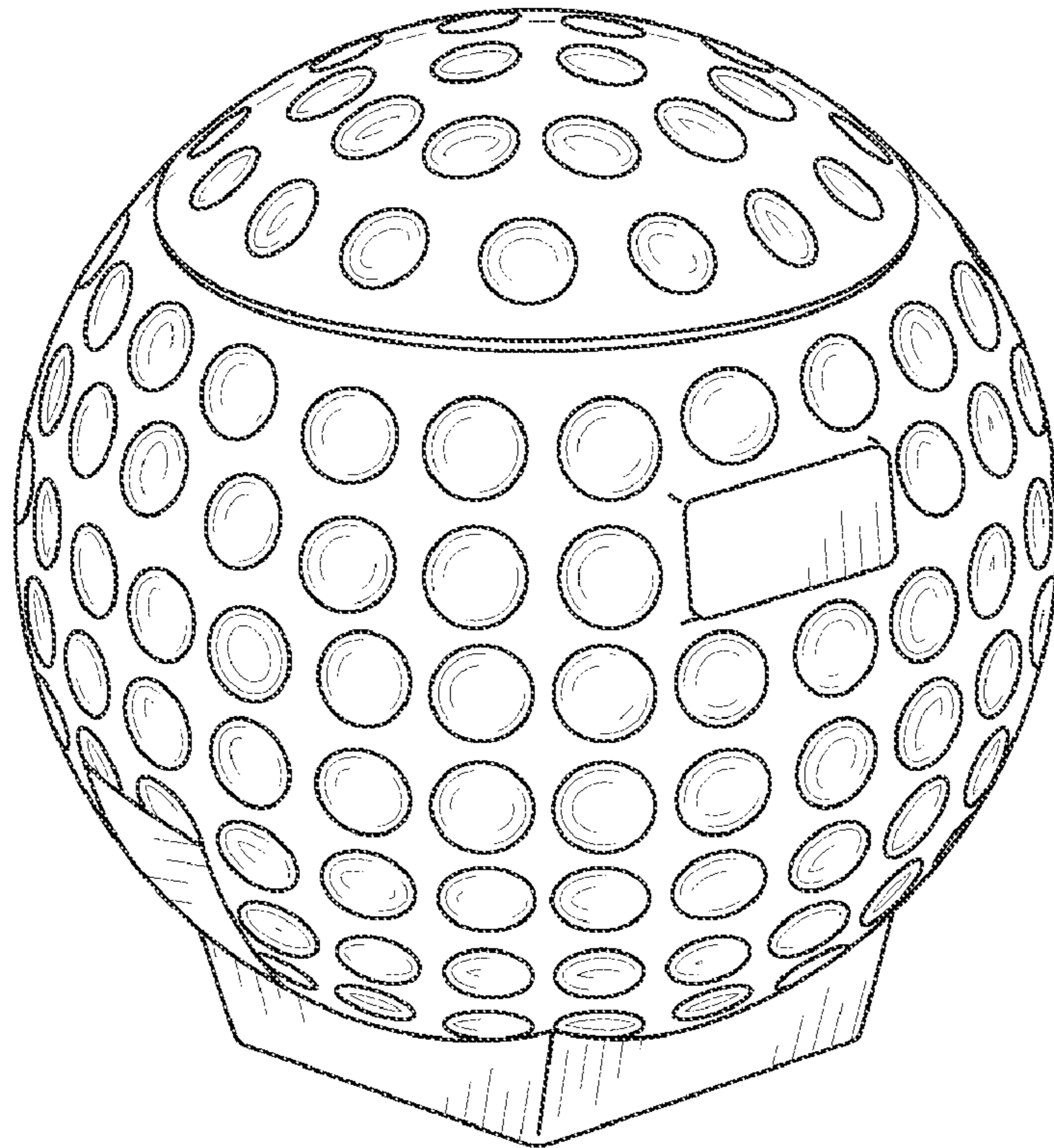

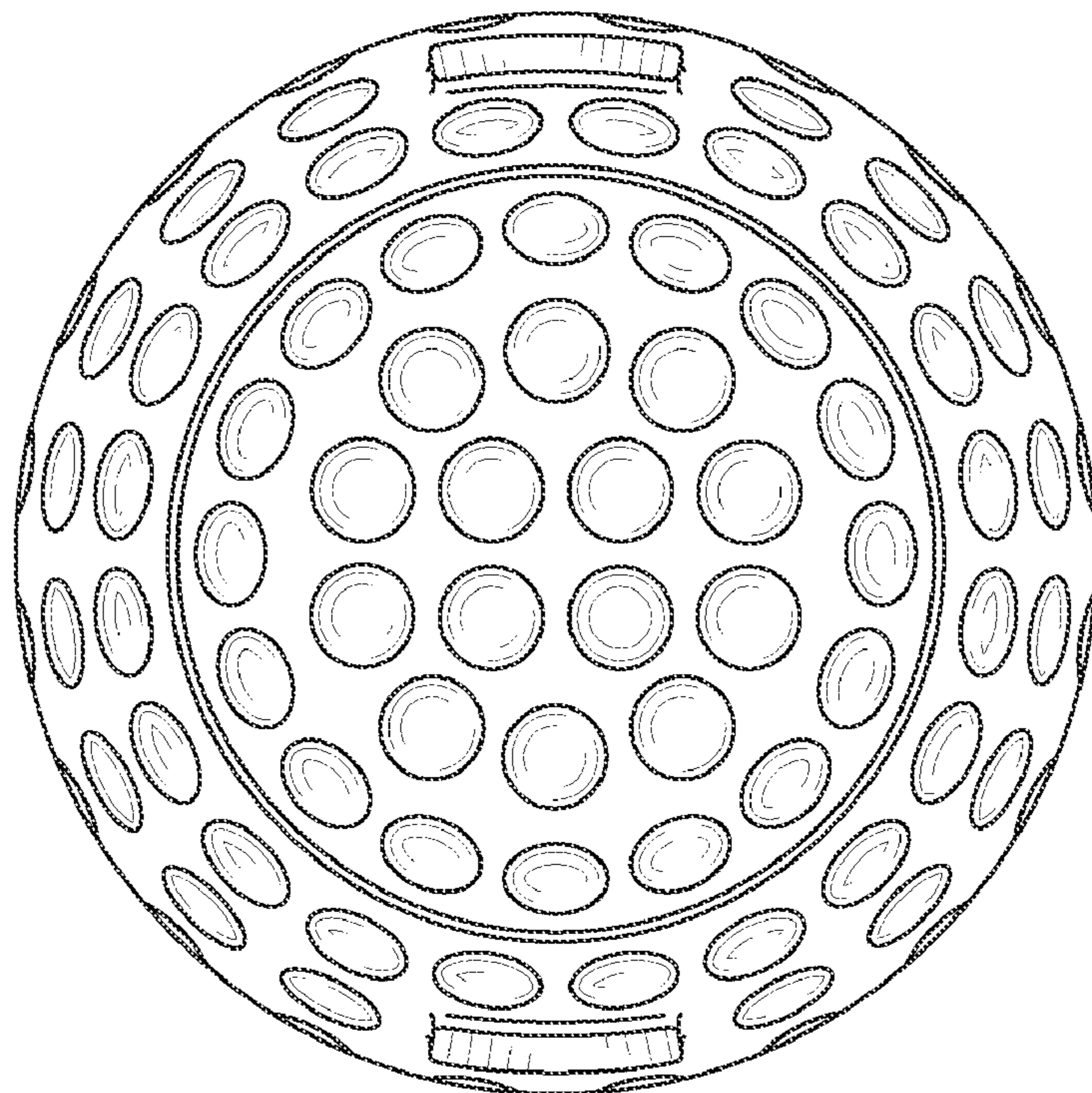

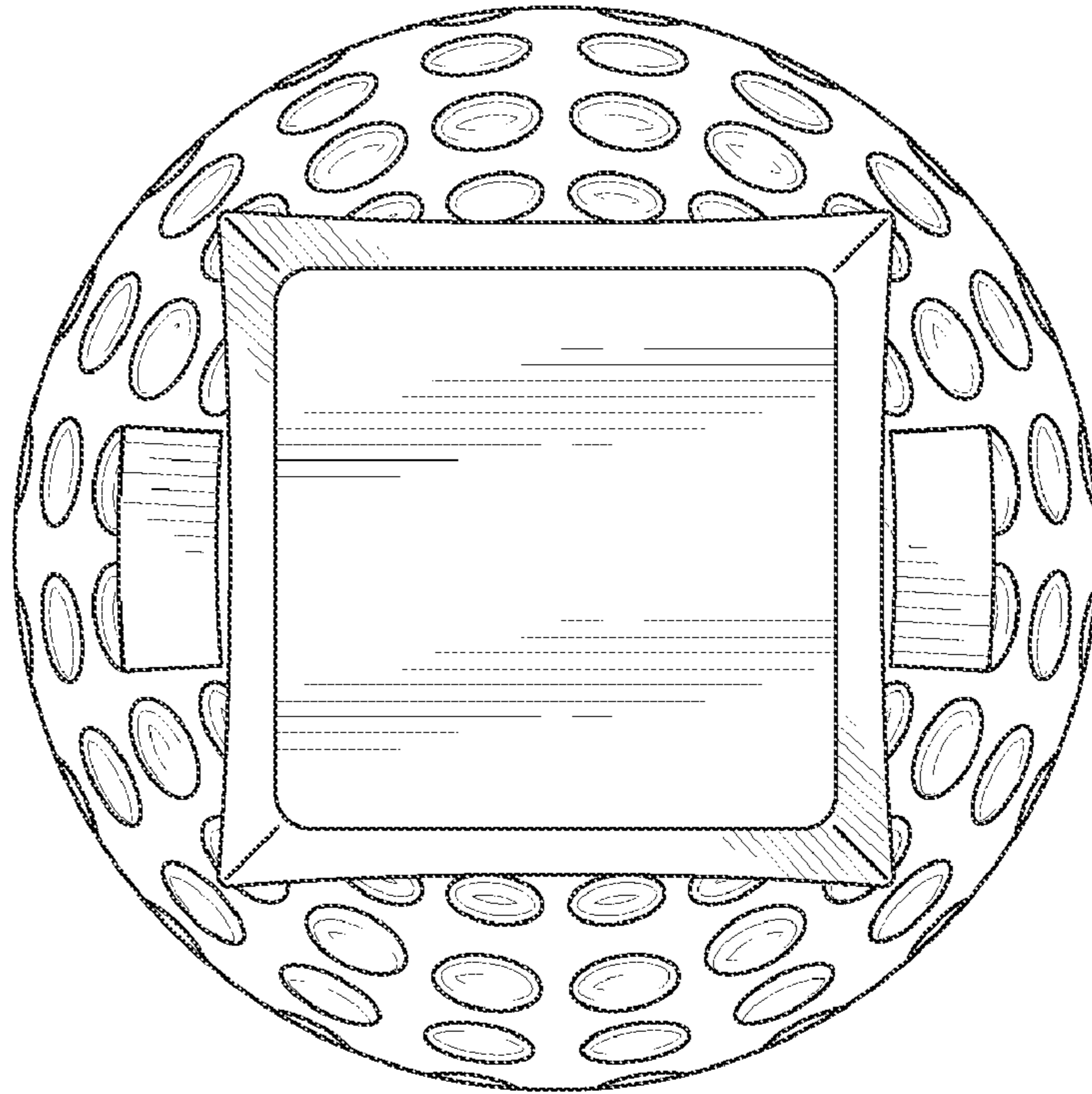

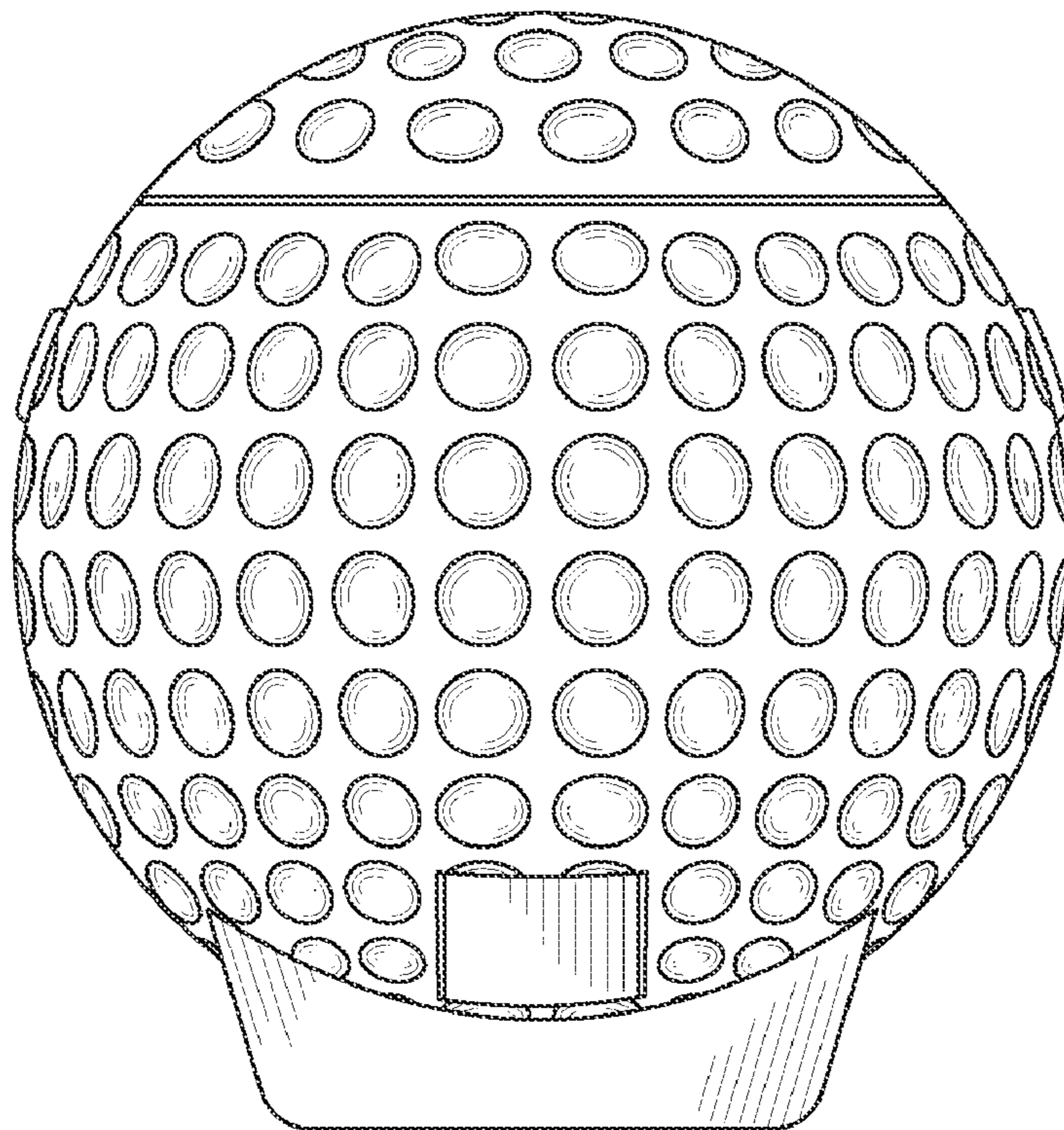

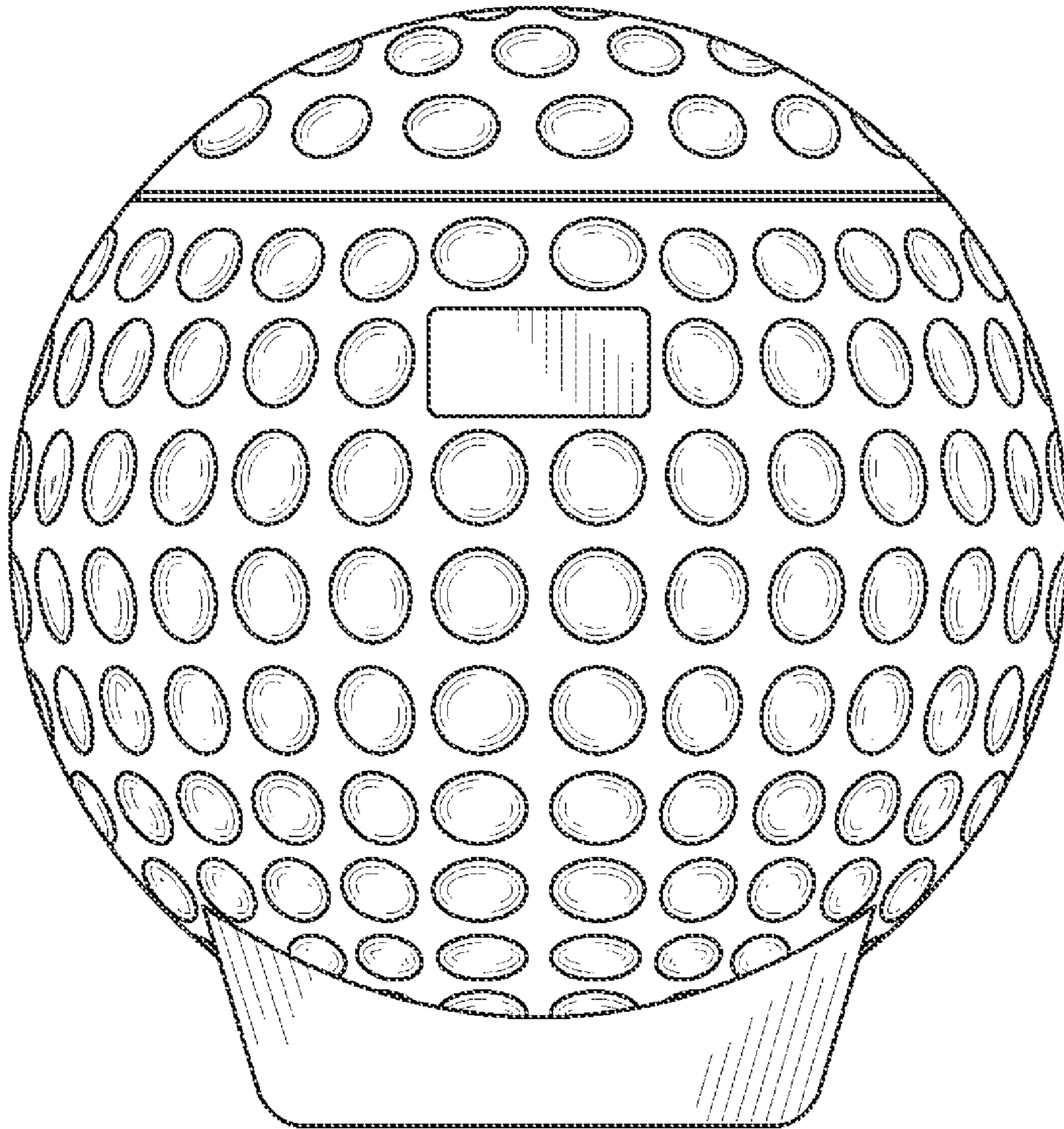
