The ornamental design for a lip mount meter box clamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a lip mount meter box clamp according to my new design.

FIG. 4 is a right side elevation view thereof;

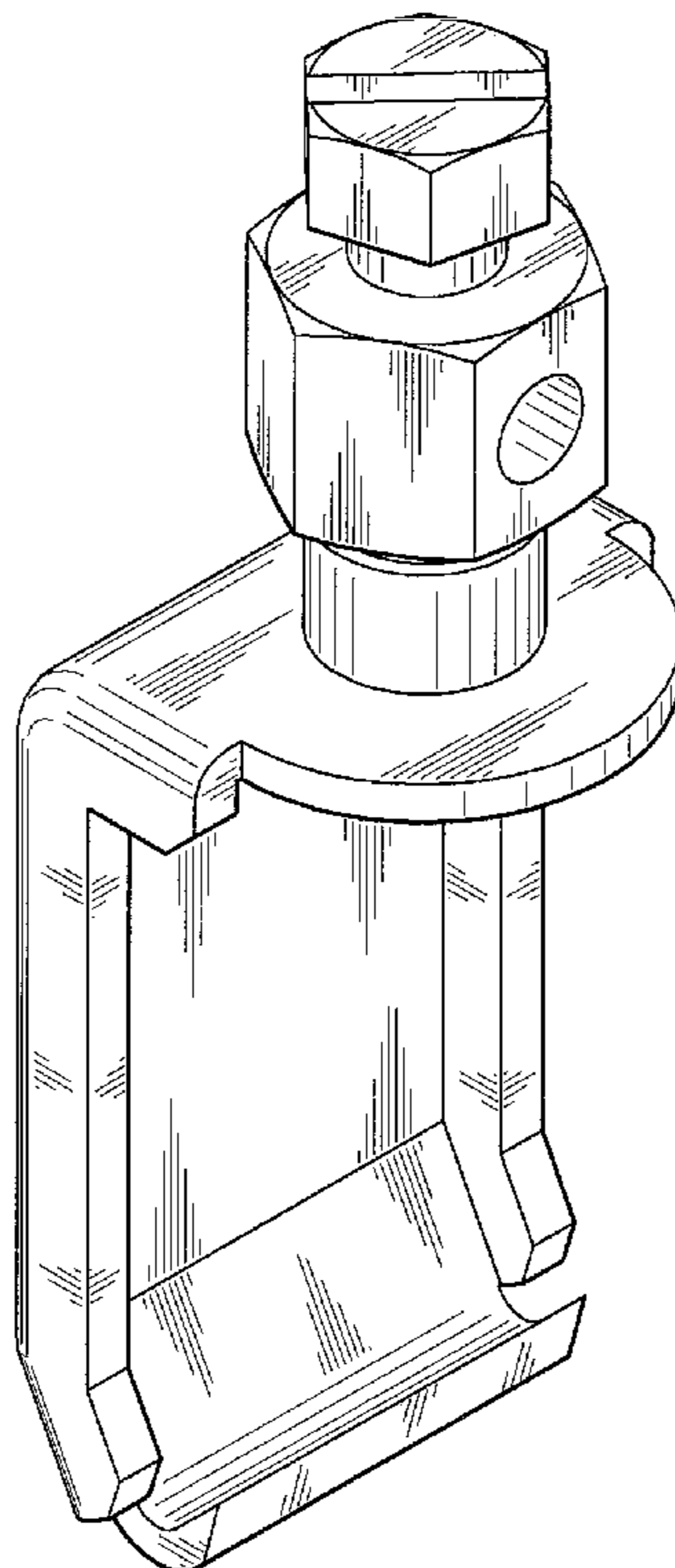

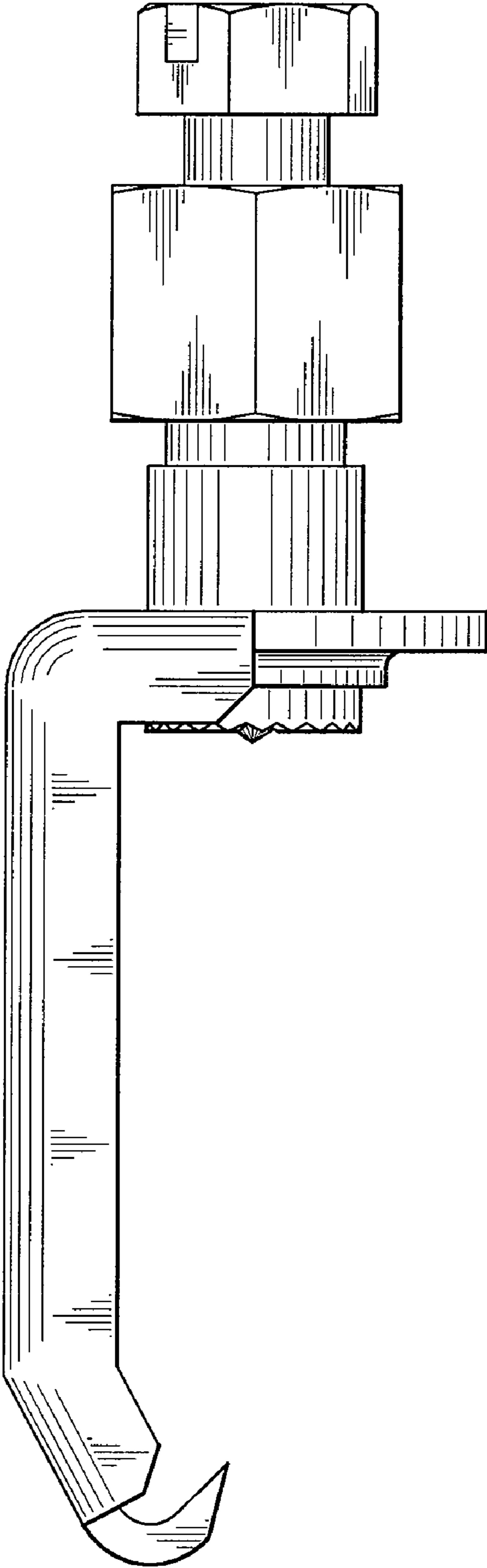

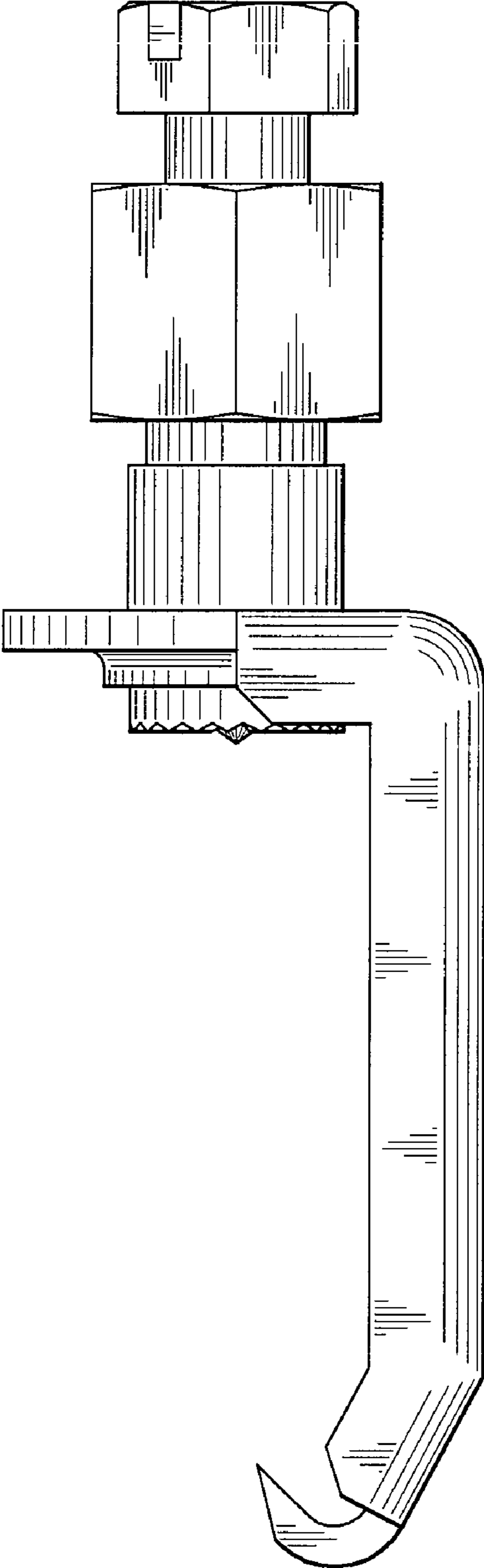

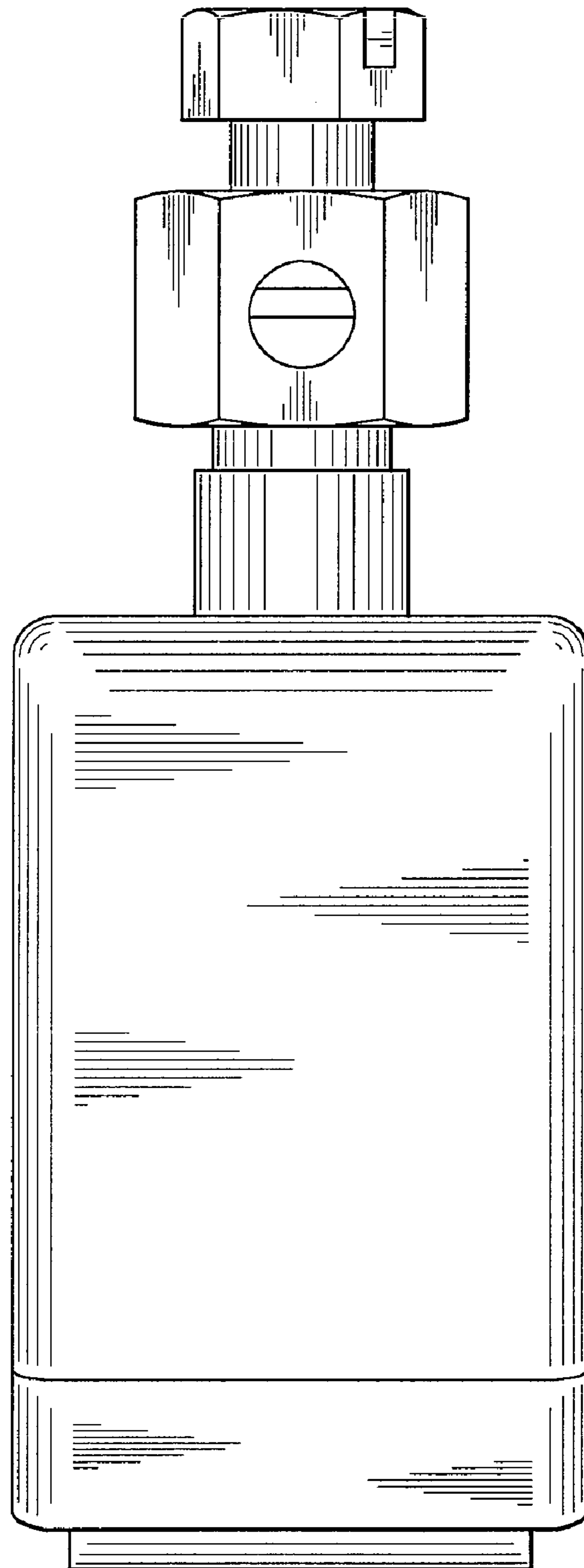

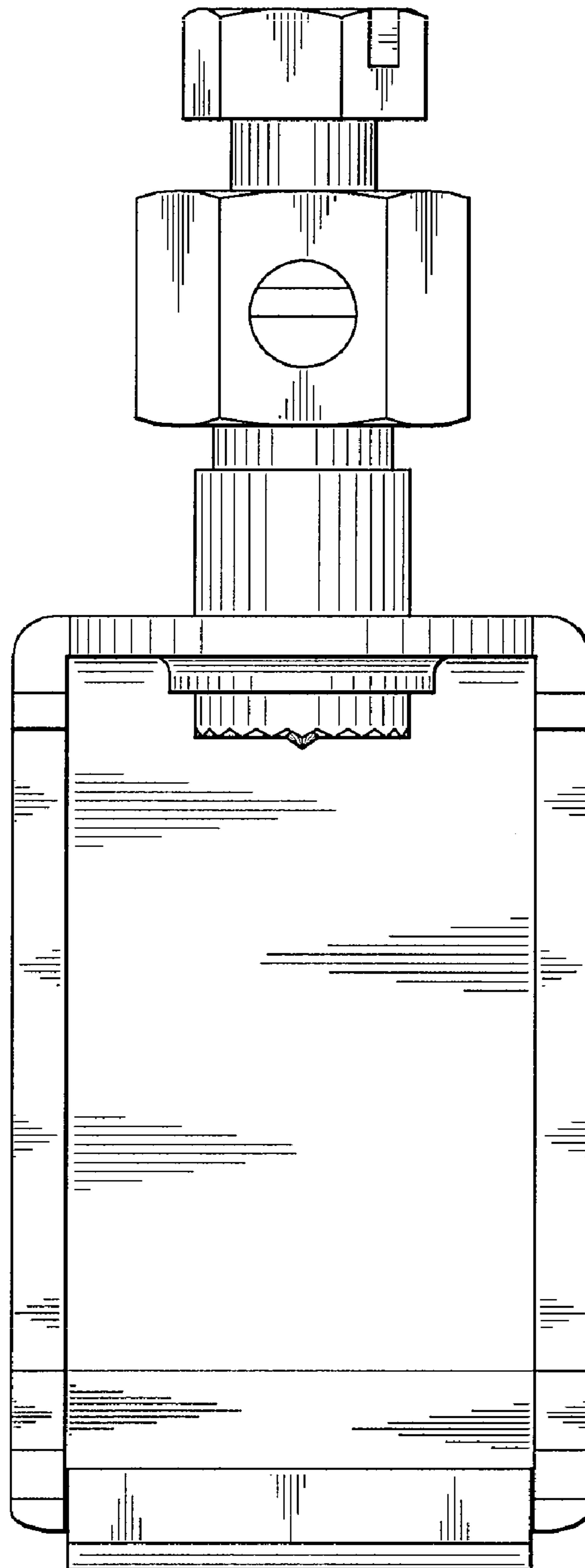

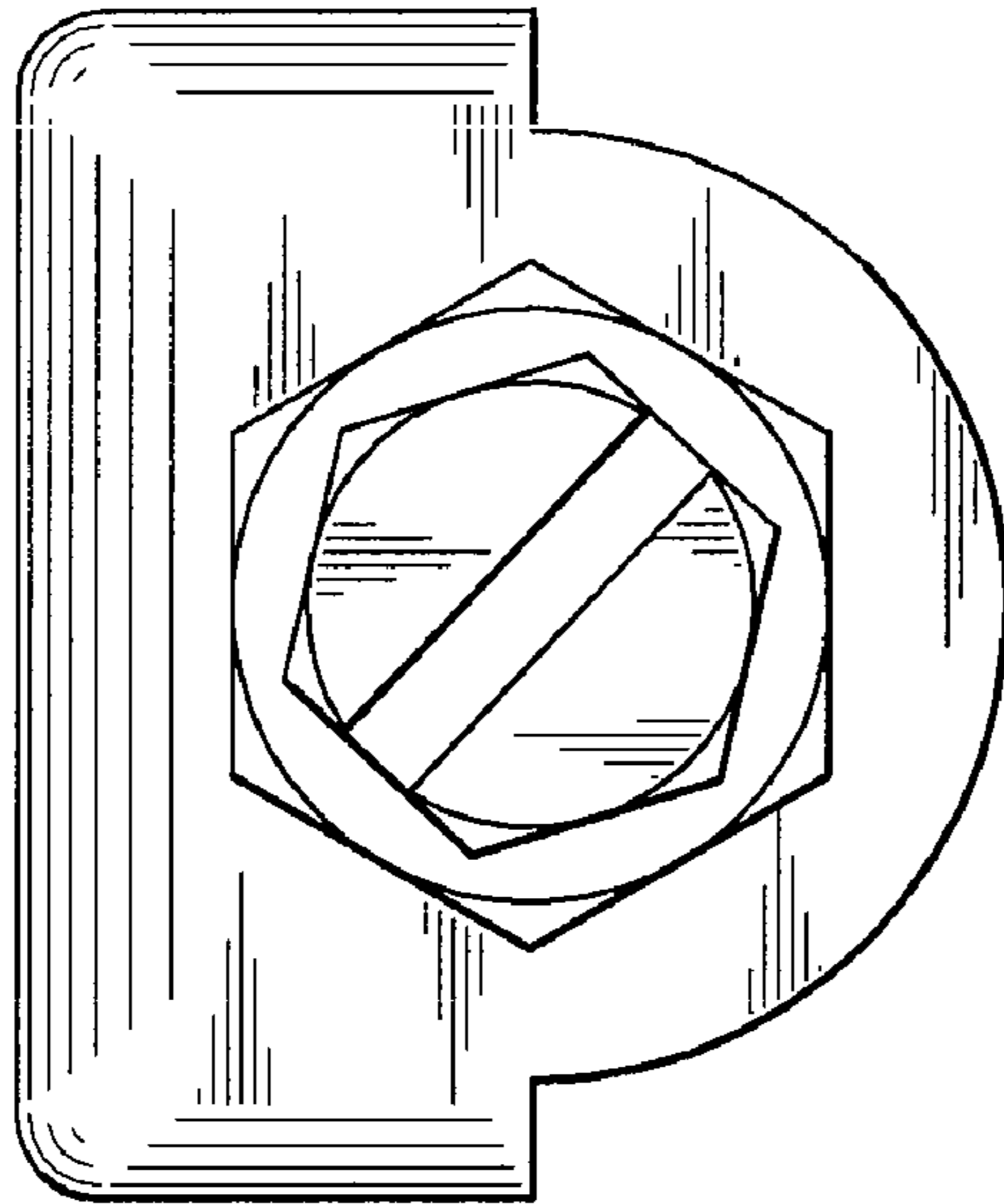

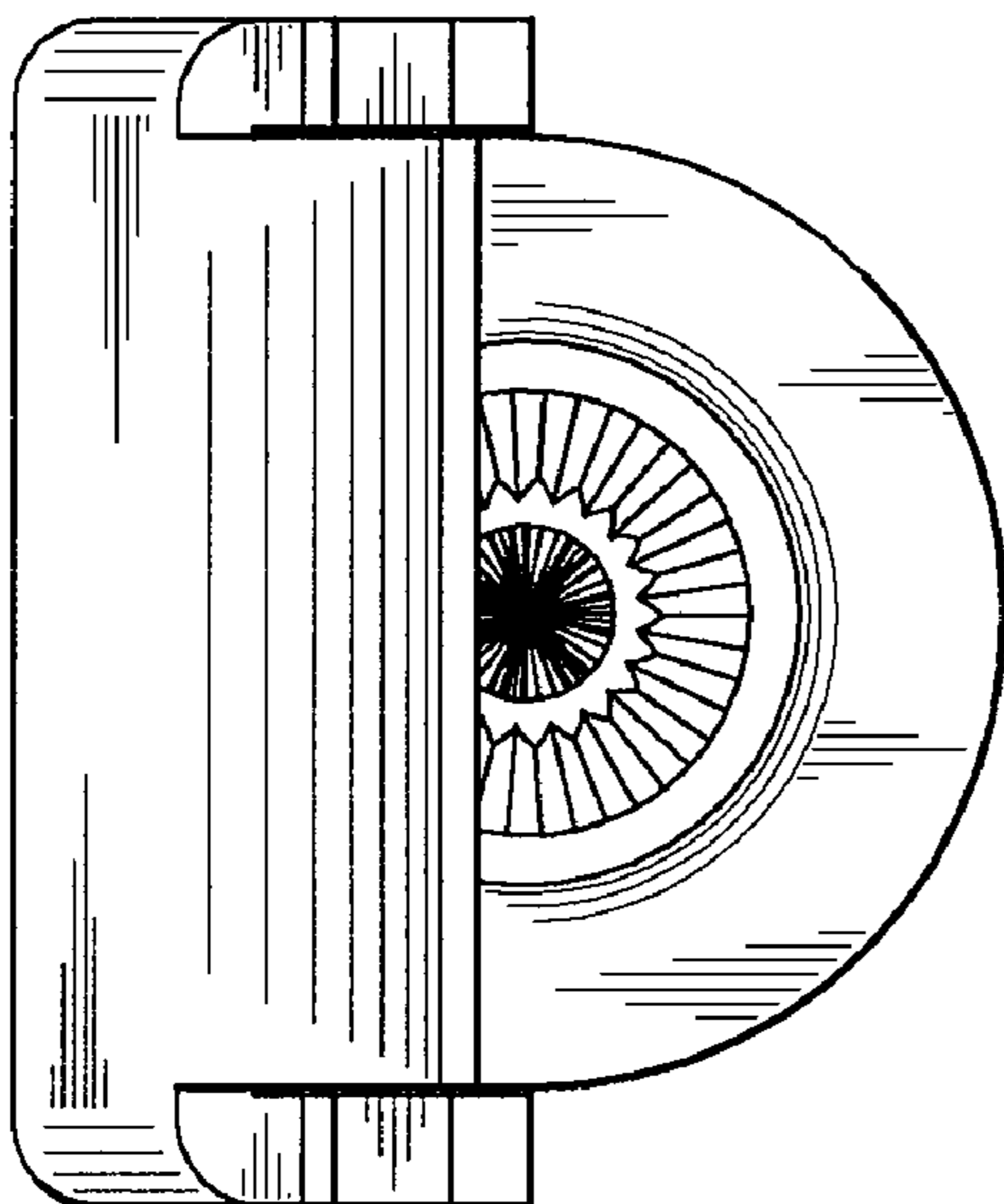
