(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front perspective view of the bottle, wherein the broken line showings of the bottle are for illustrative purposes only and form no part of the claimed design;

FIG. 2 illustrates a front elevation view of the bottle of FIG. 1;

FIG. 3 illustrates a rear elevation view of the bottle of FIG. 1;

FIG. 4 illustrates a left side elevation view of the bottle of FIG. 1;

FIG. 5 illustrates a right side elevation view of the bottle of FIG. 1;

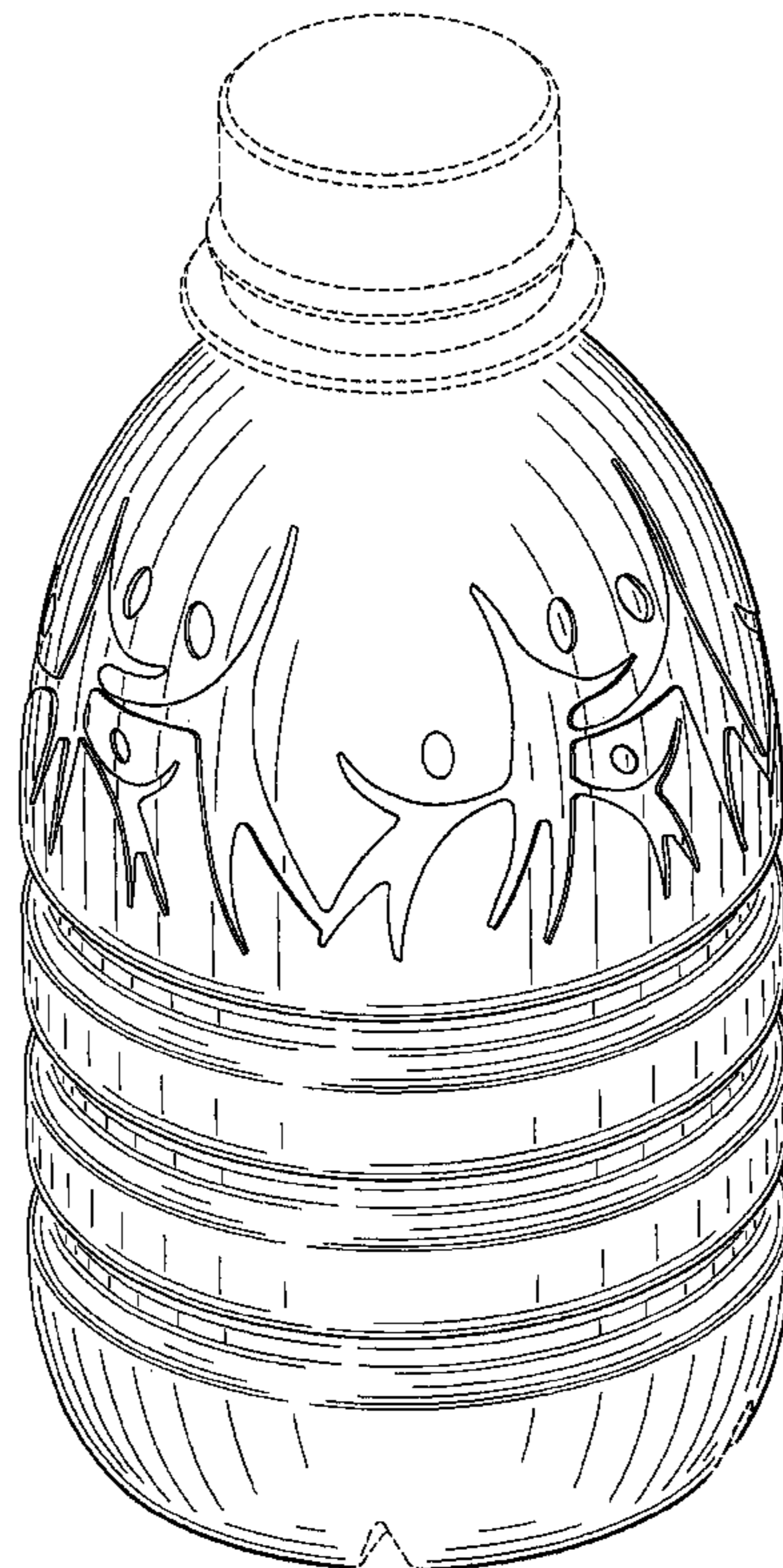

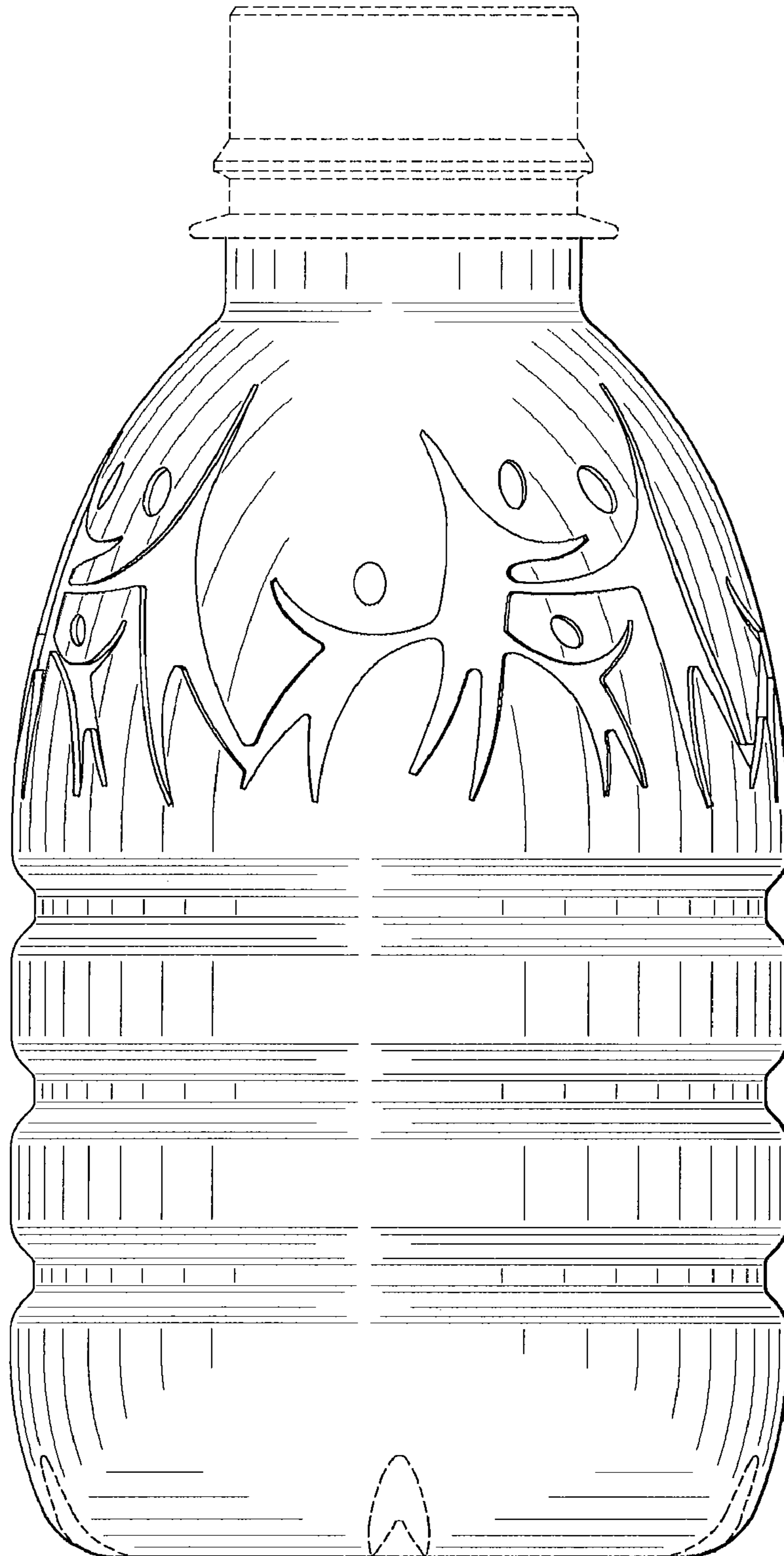

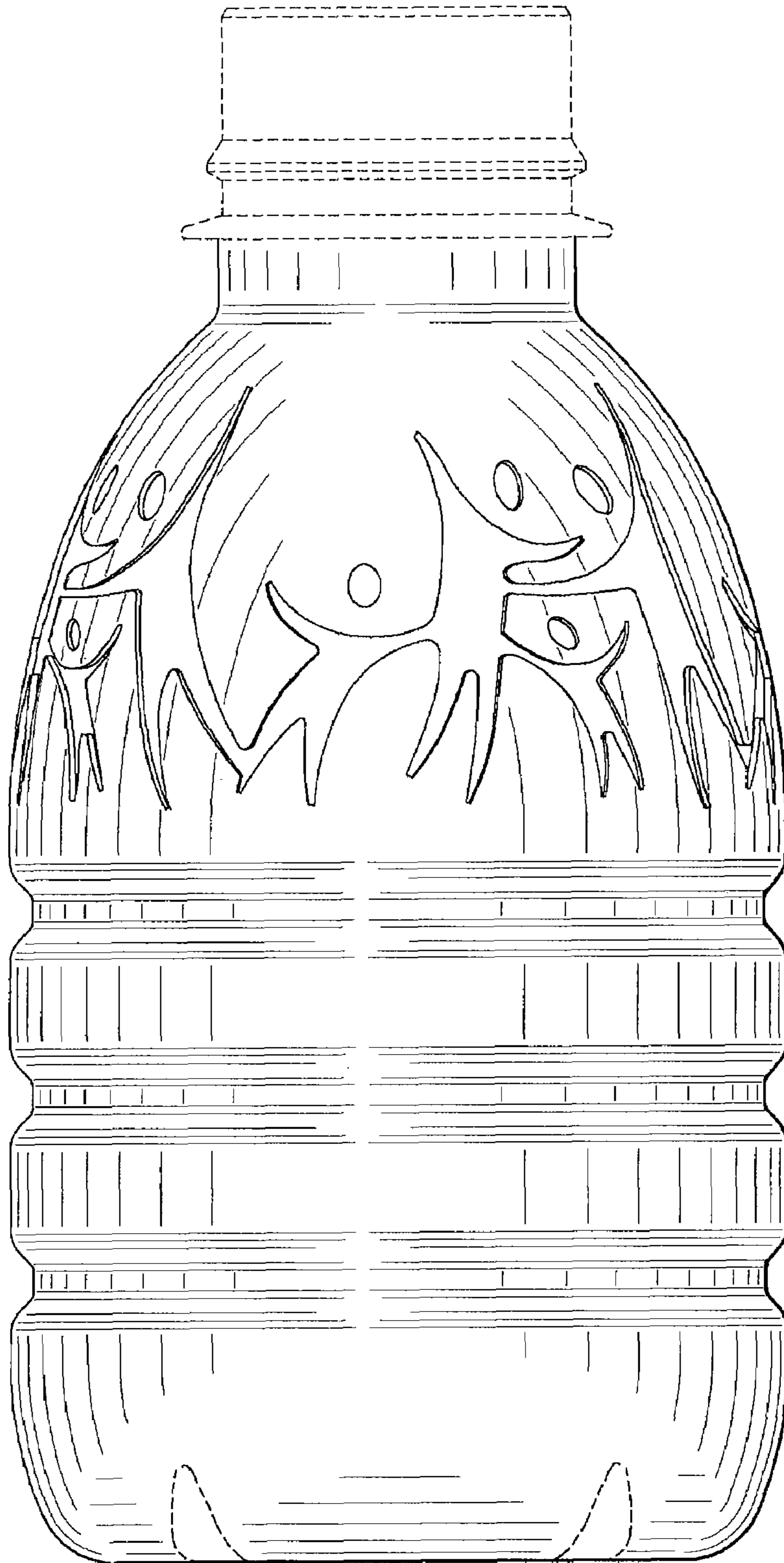

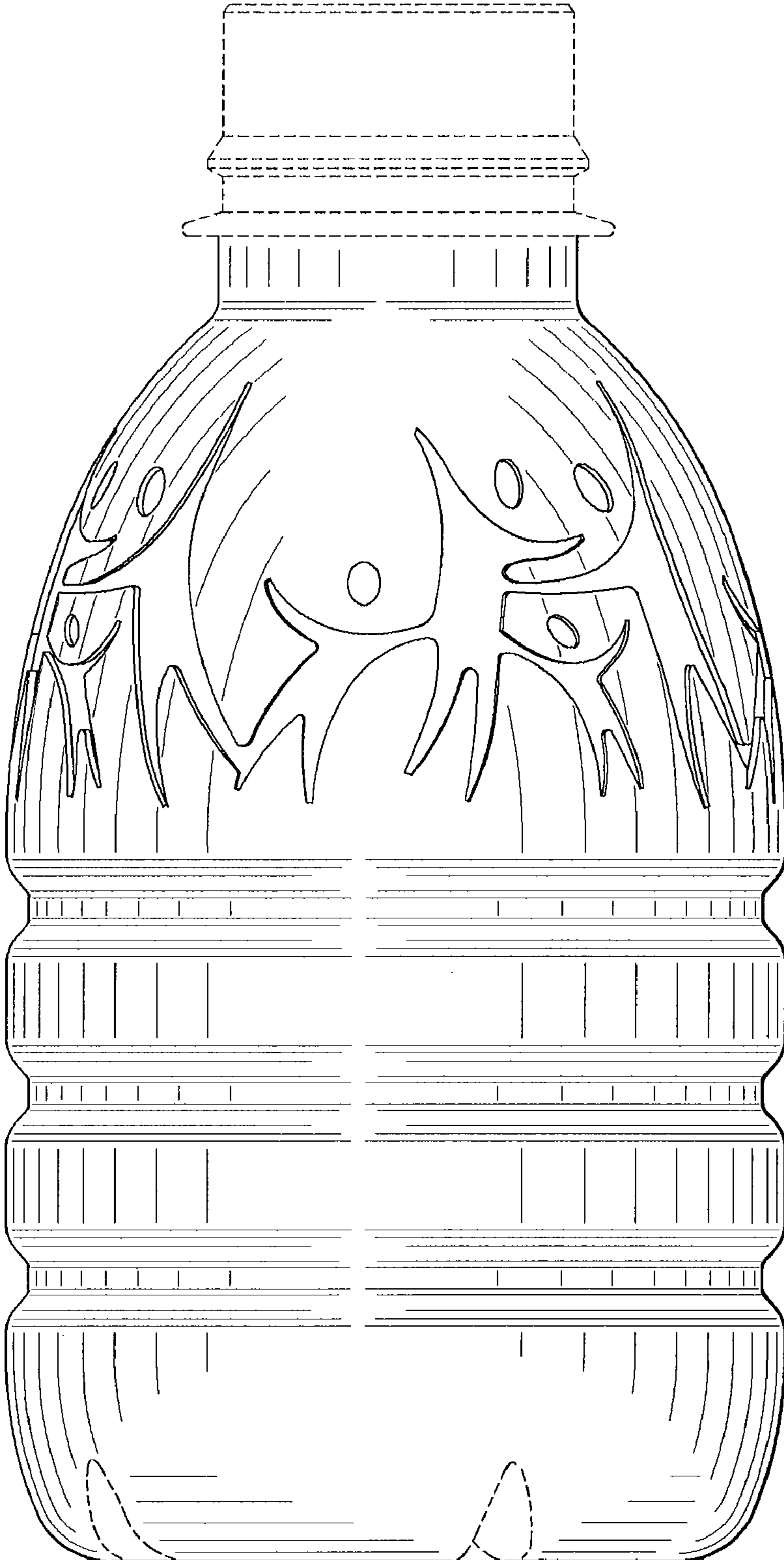

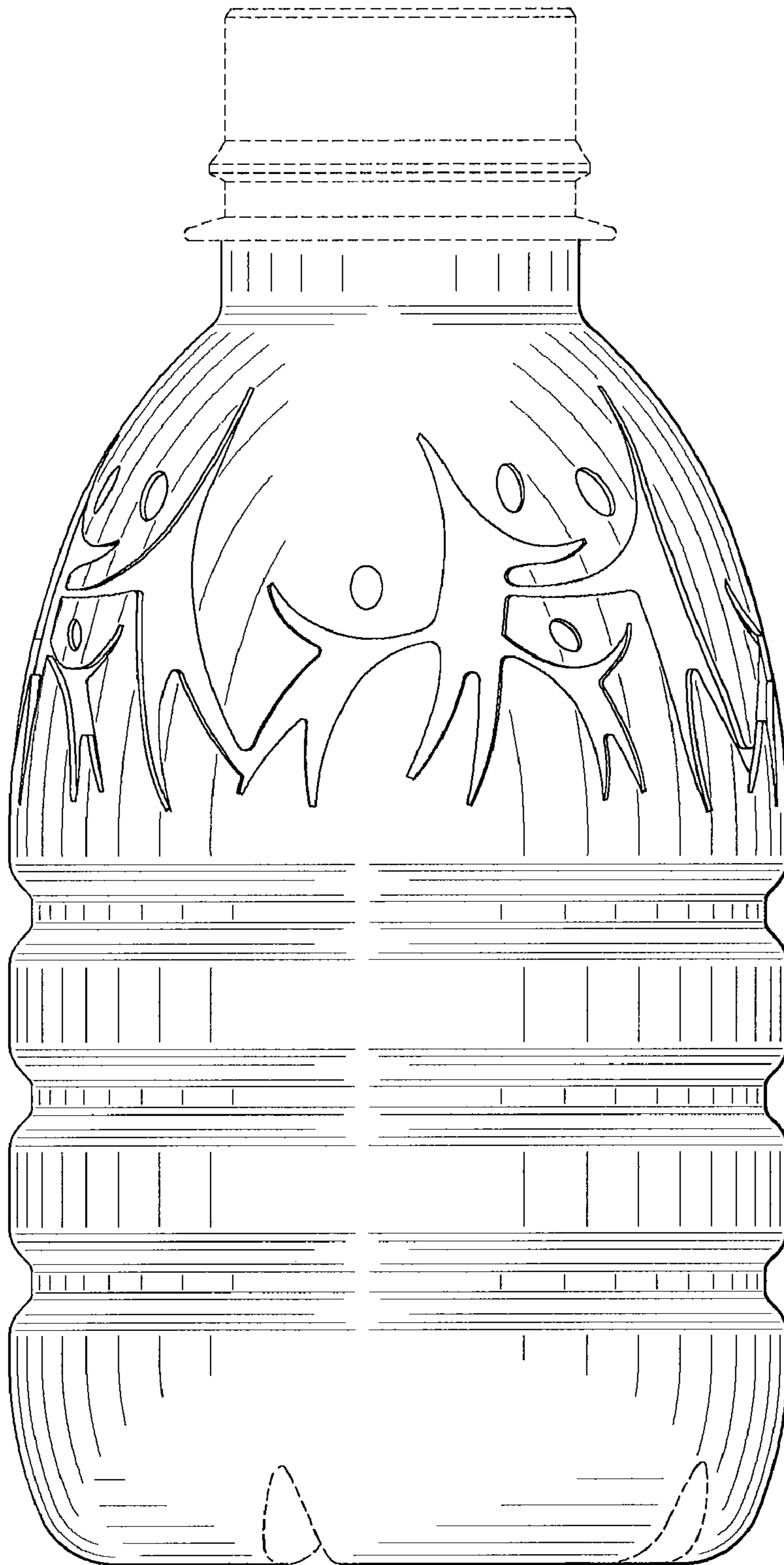

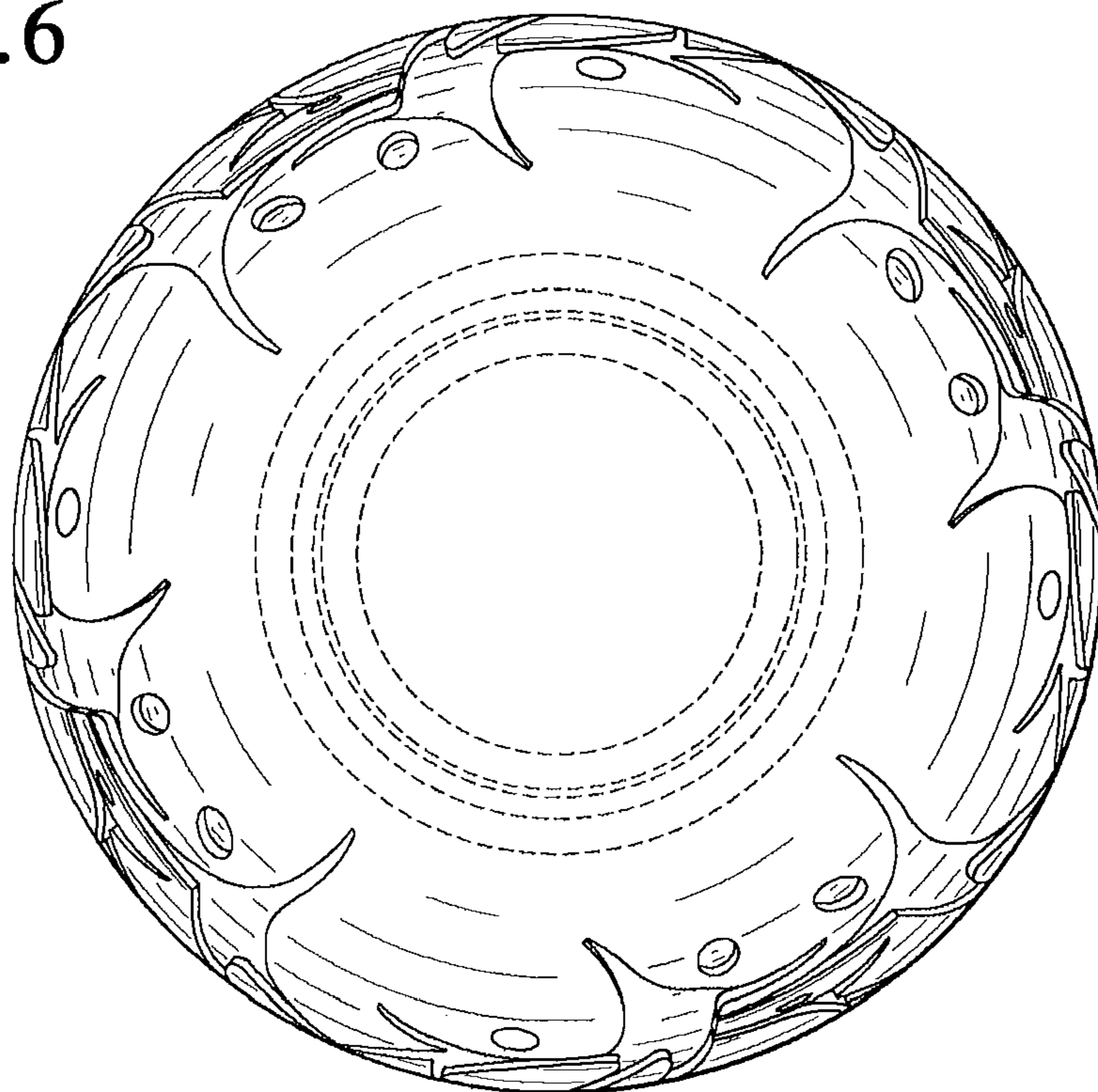
