We claim the ornamental design for mobile phone, as shown.

DESCRIPTION

FIG. 1 is a front/left-side/top perspective view of a mobile phone showing our new design;

FIG. 4 is a left-side elevational view thereof;

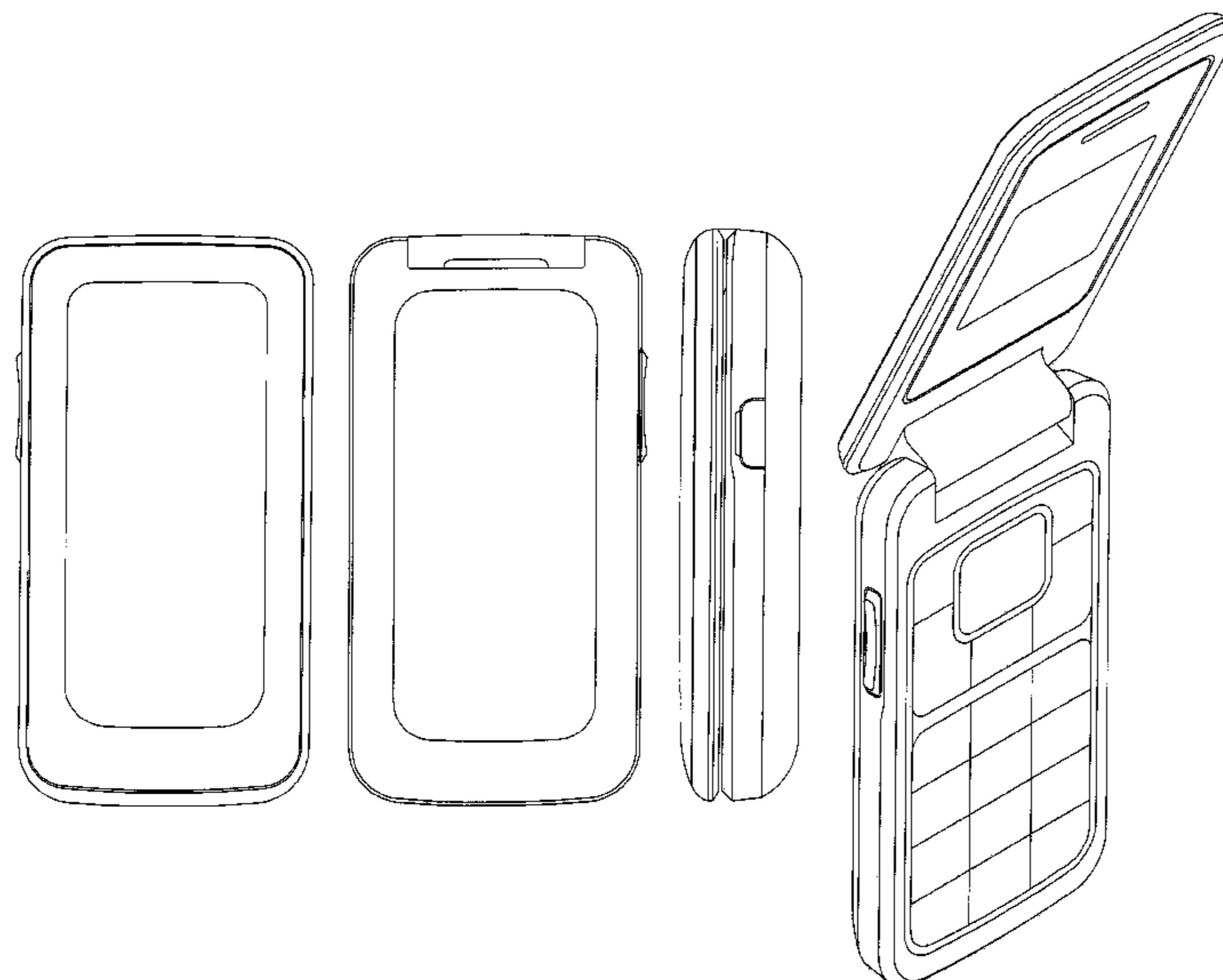

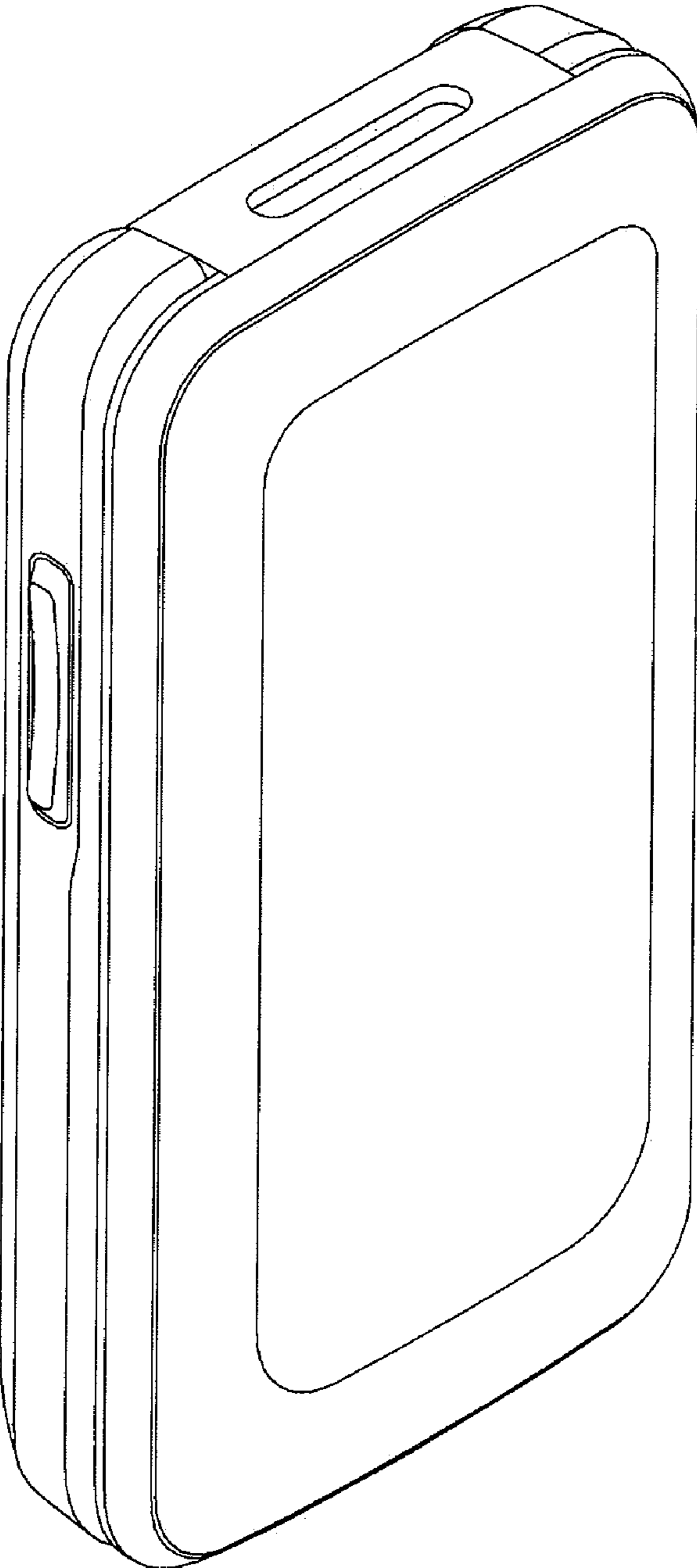

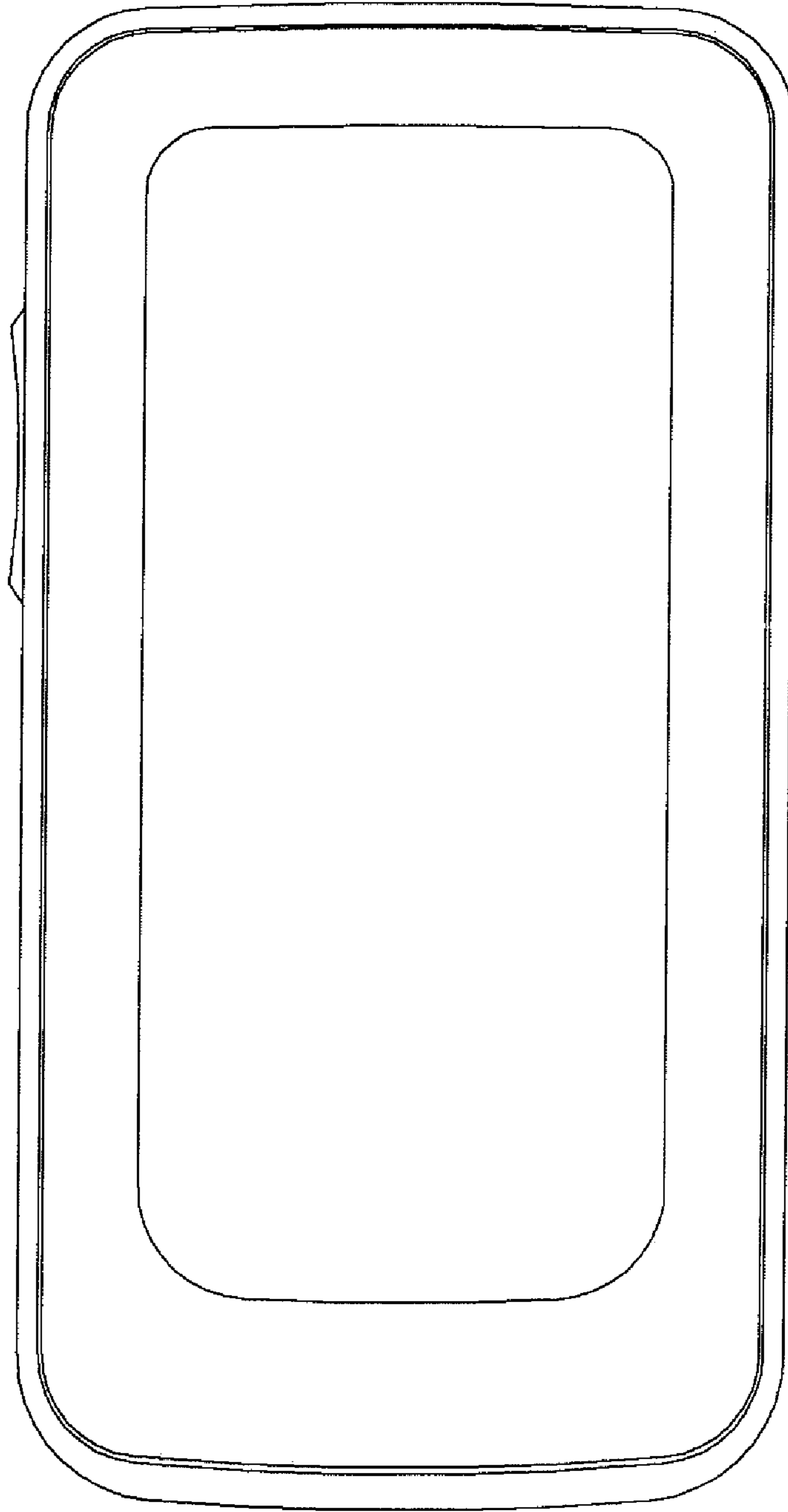

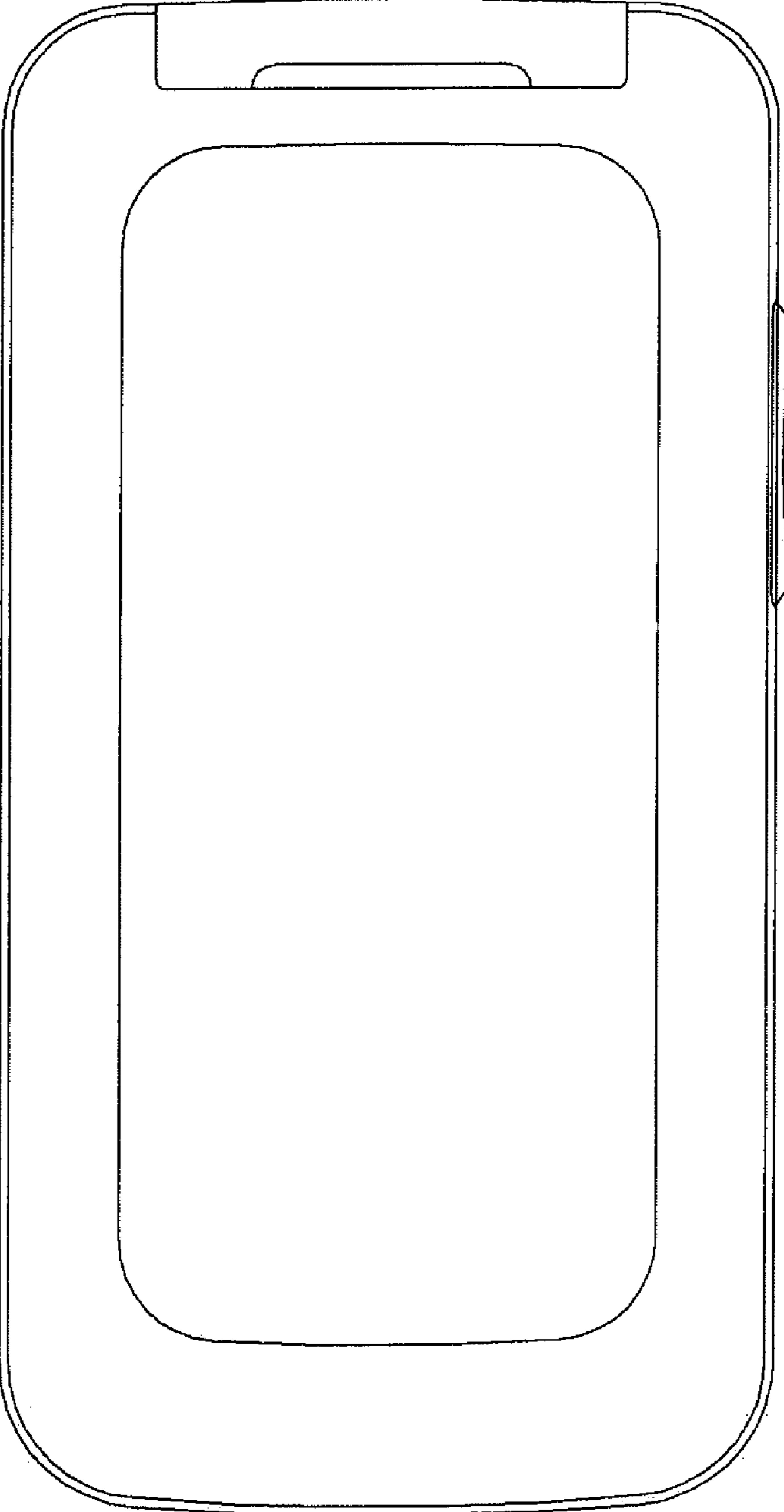

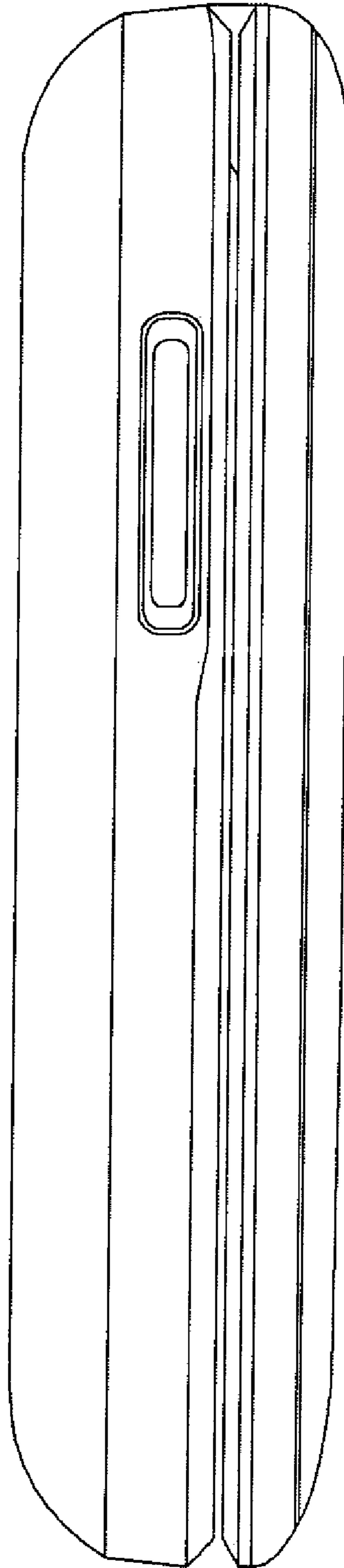

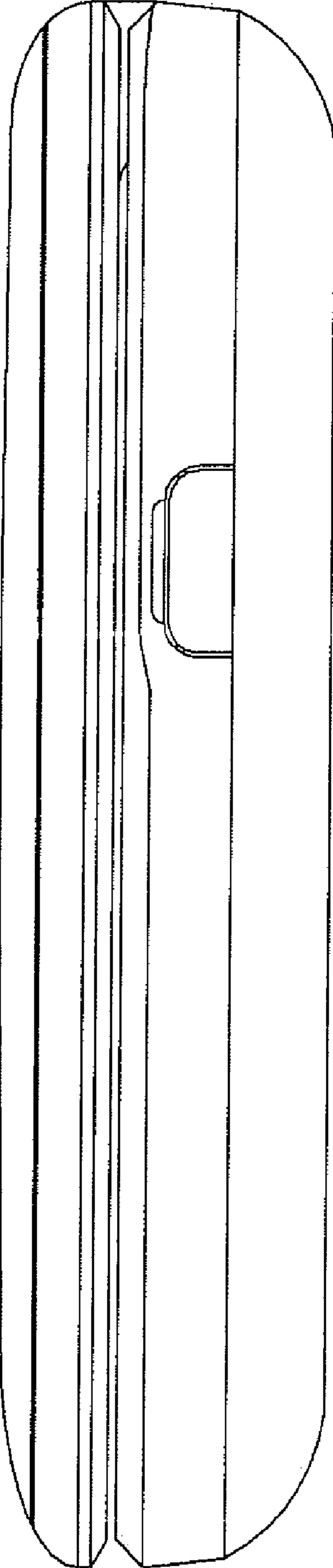

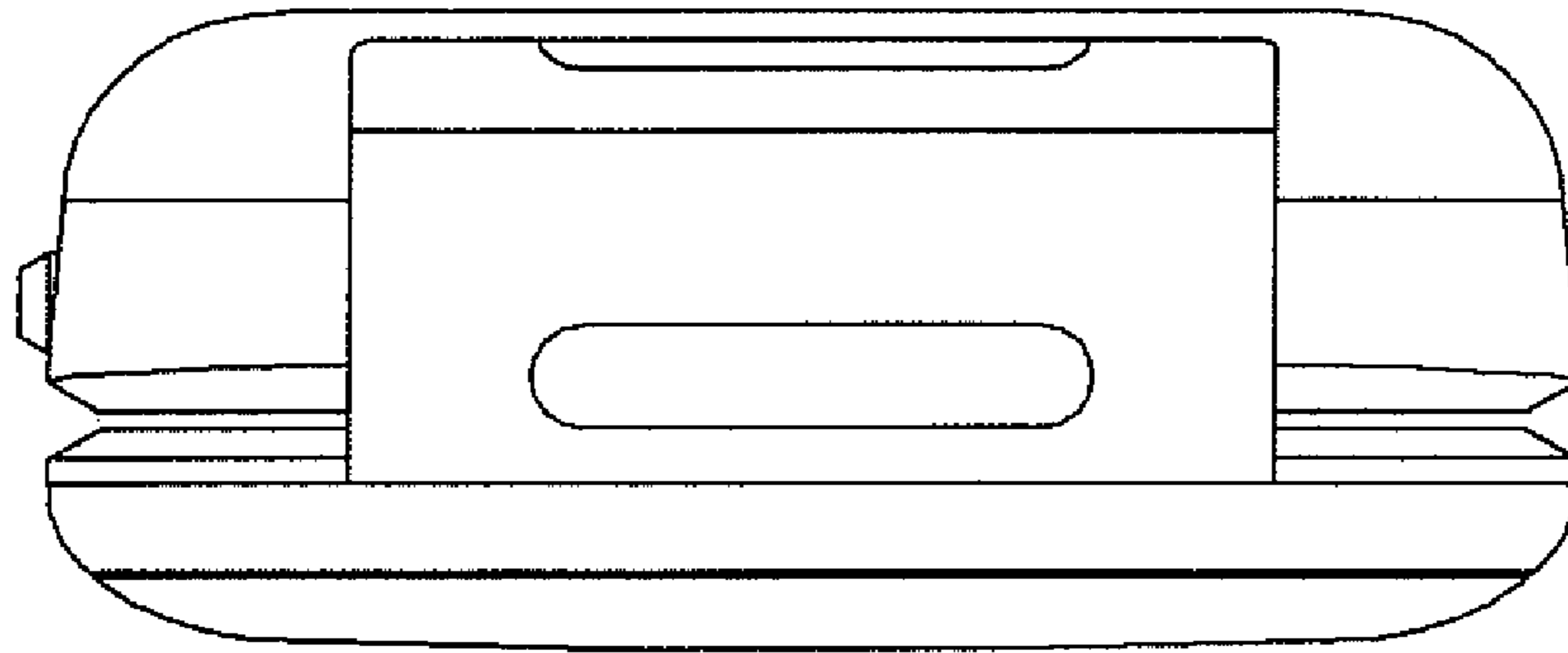

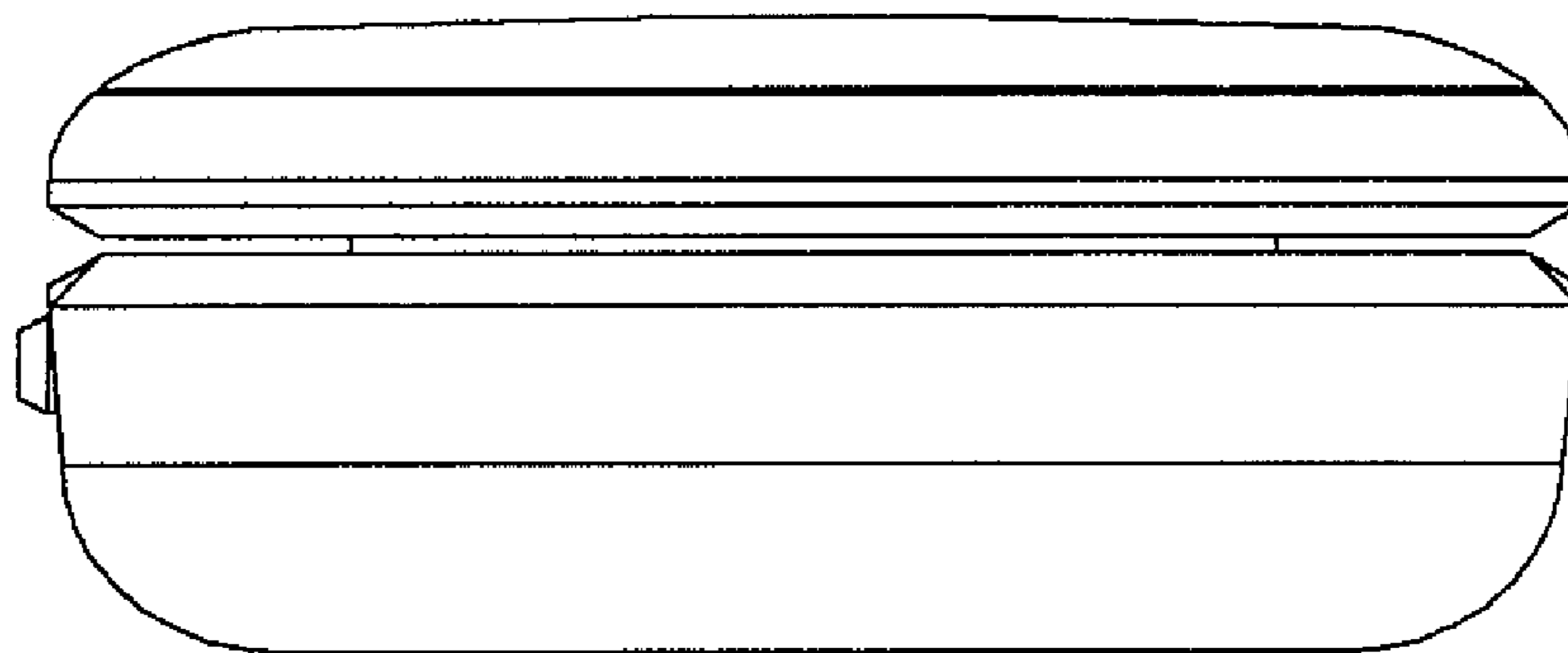
