(57) **CLAIM**

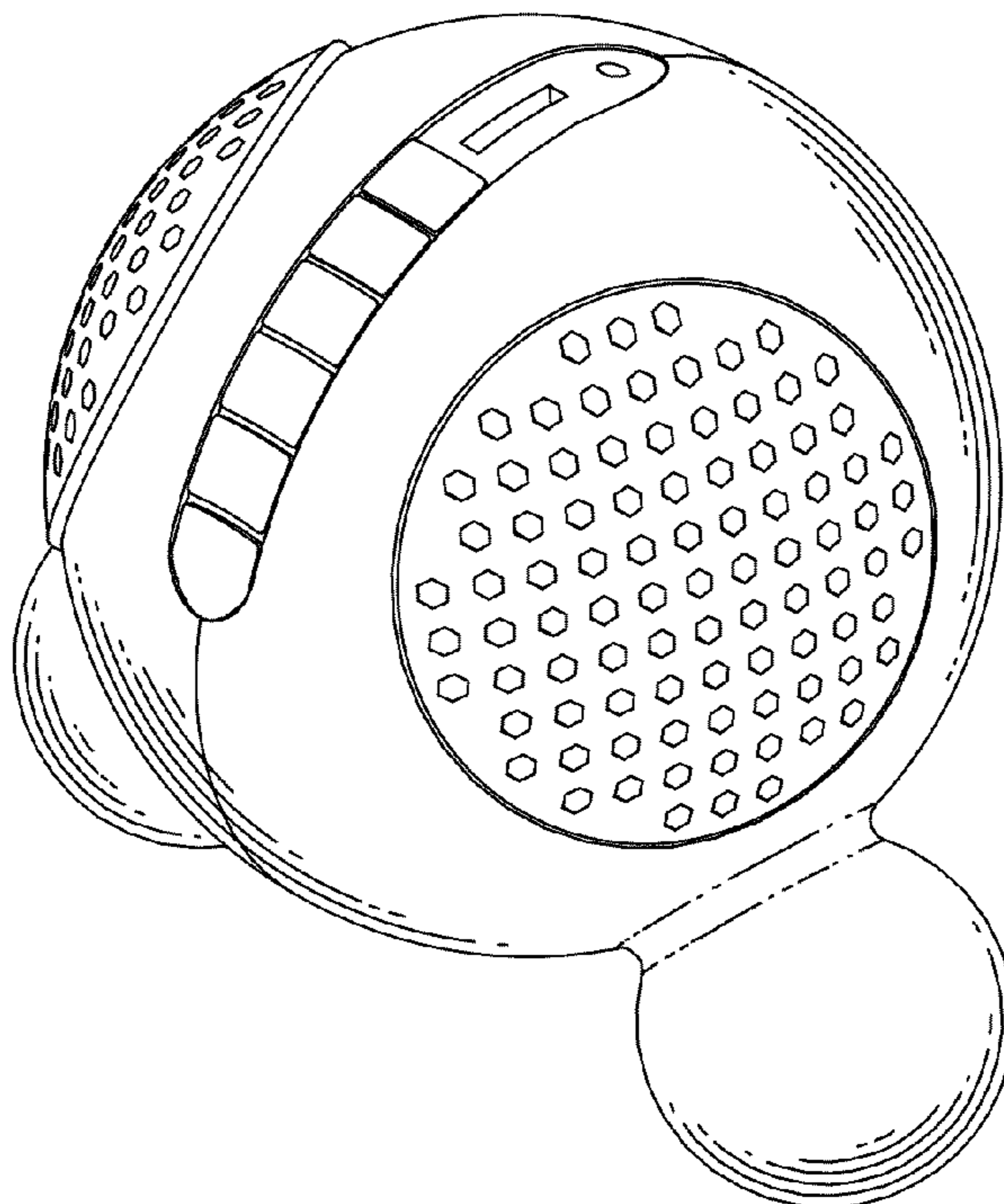
The ornamental design for a player, as shown and described.

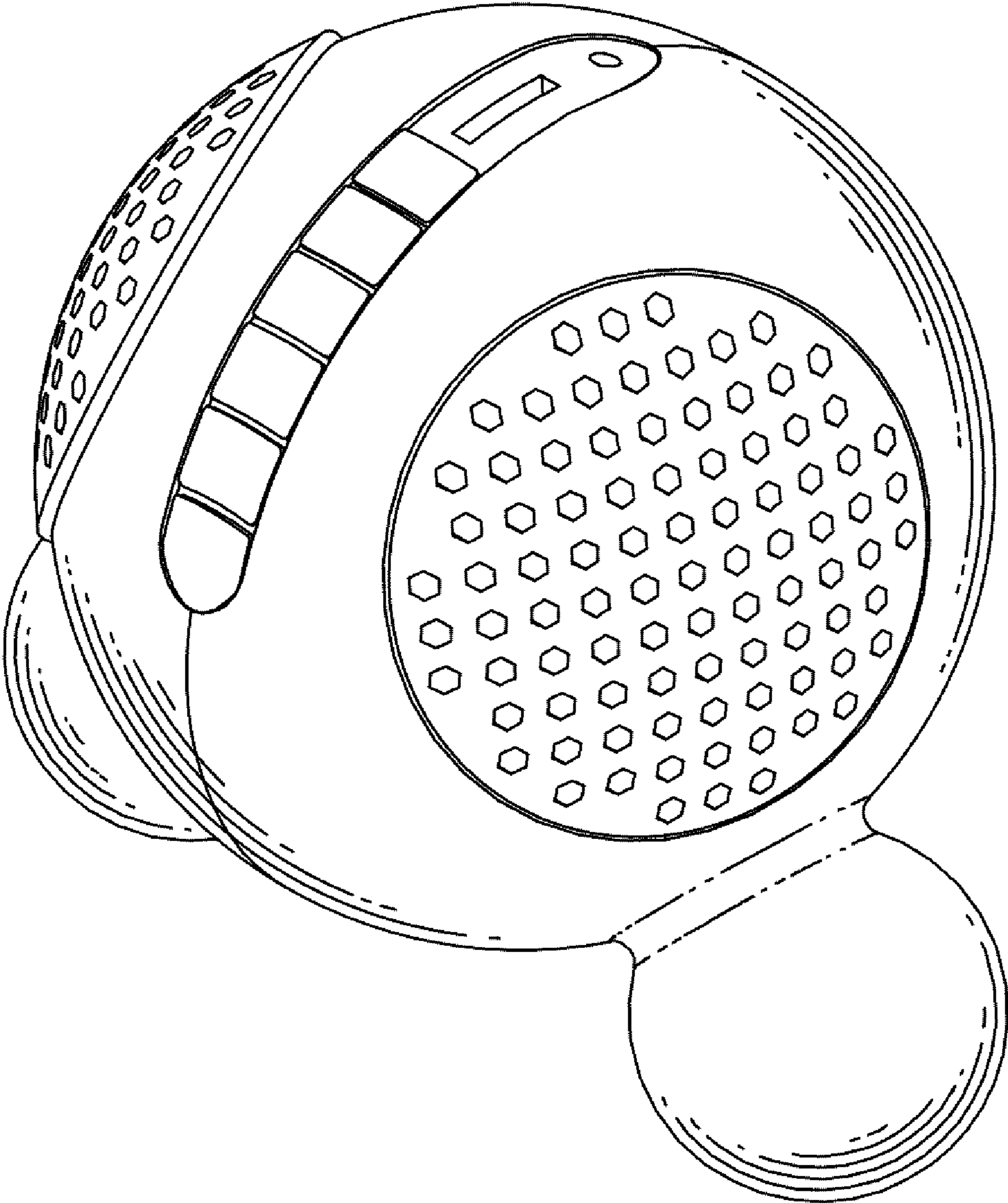

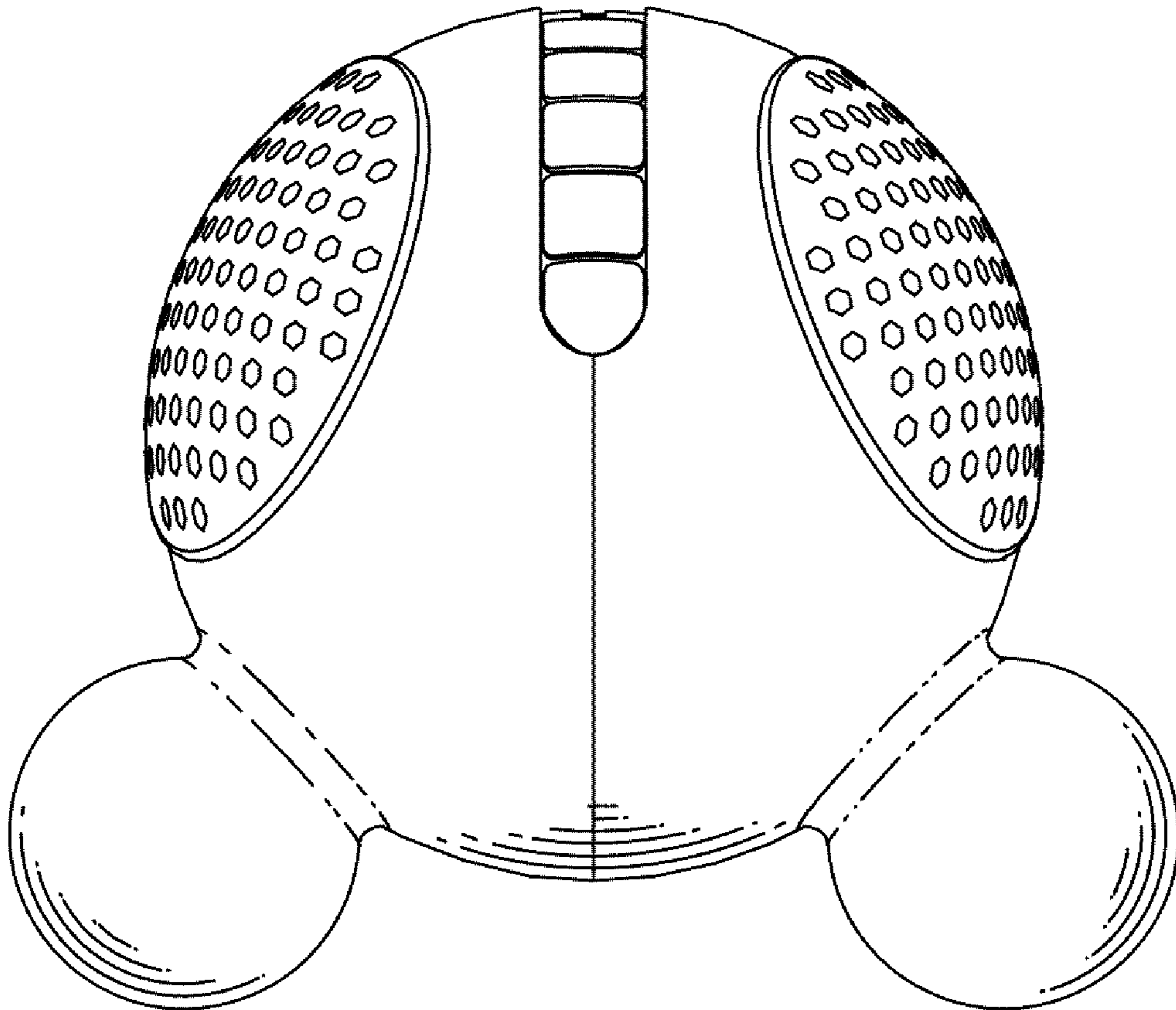

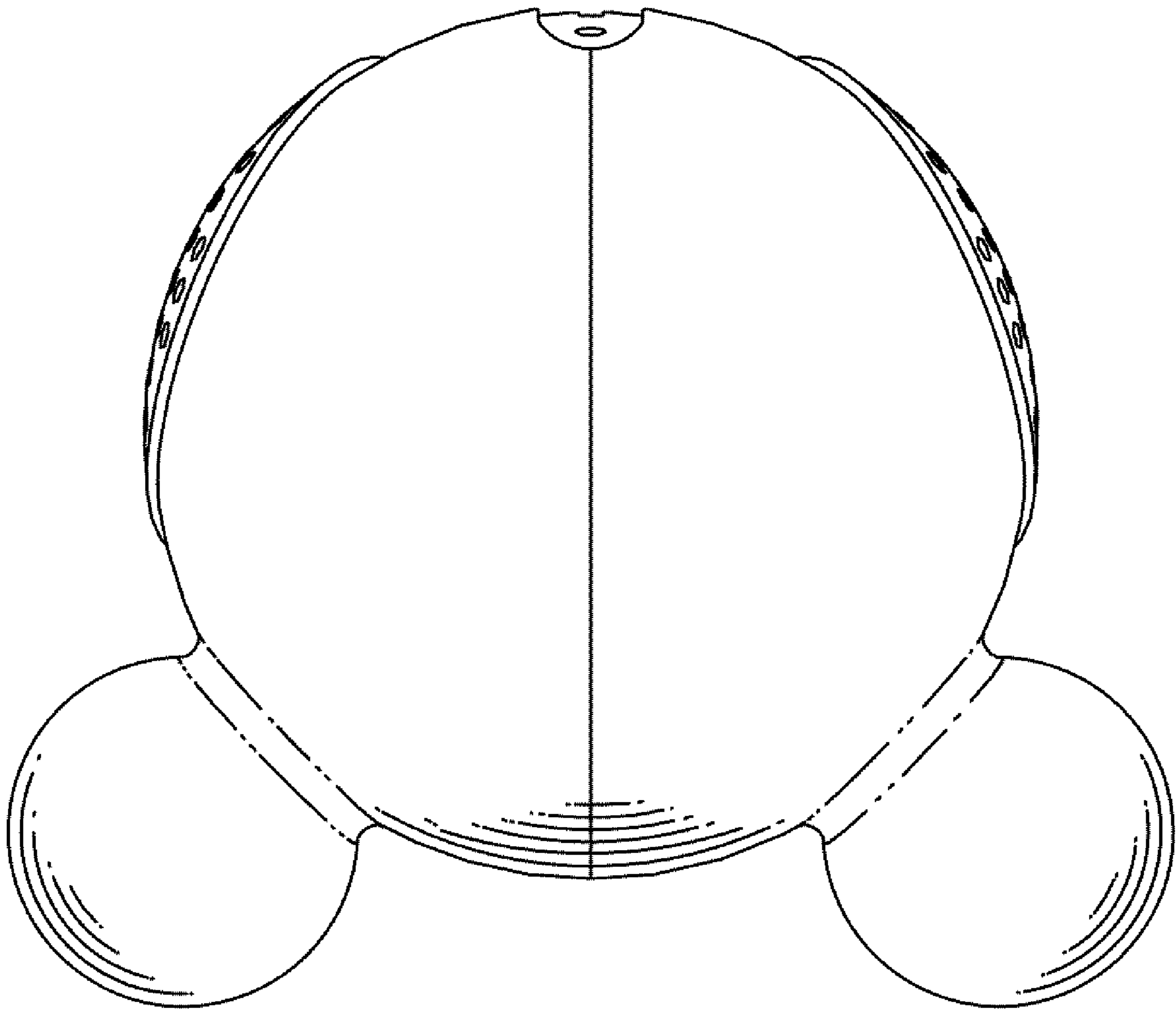

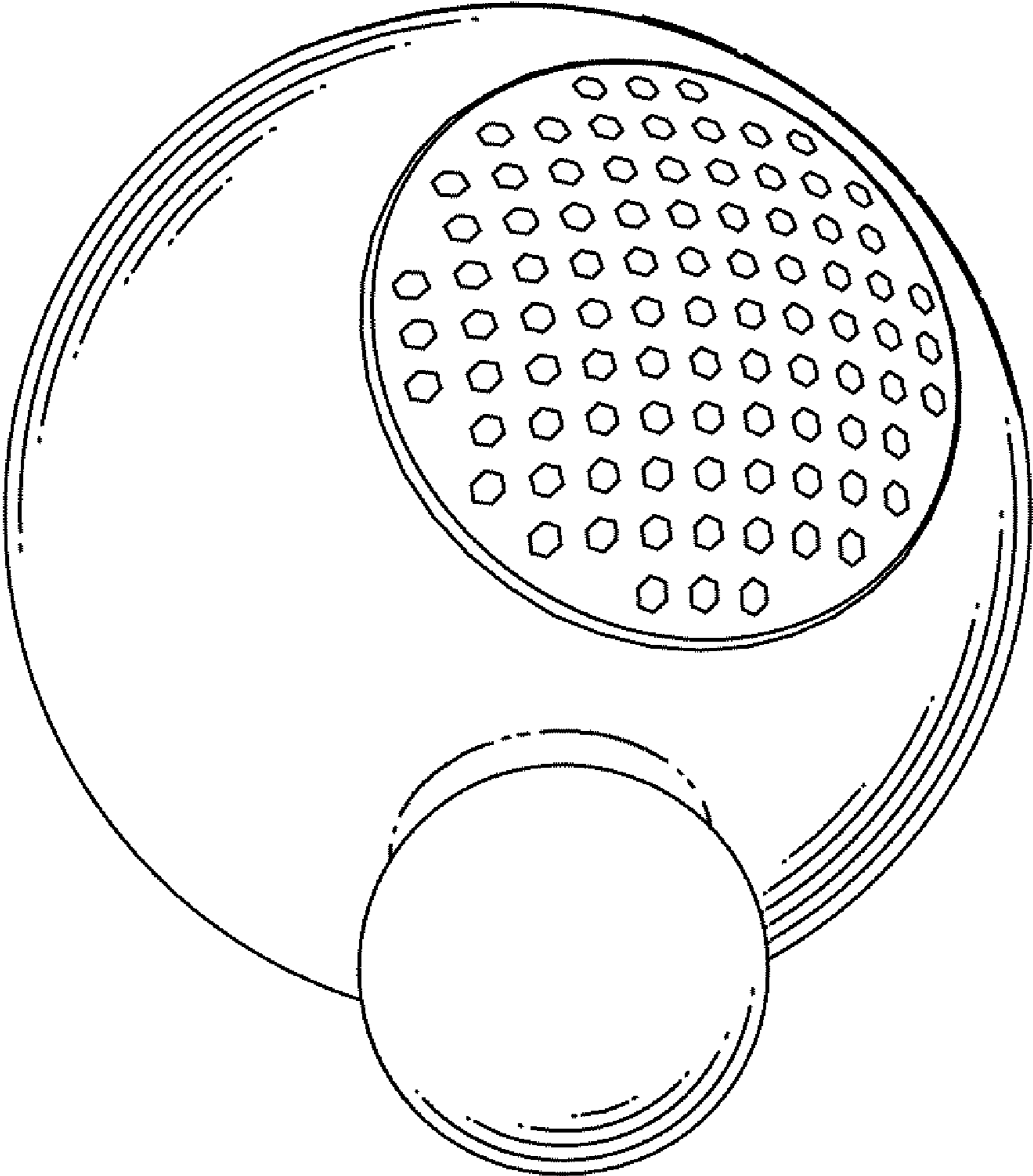

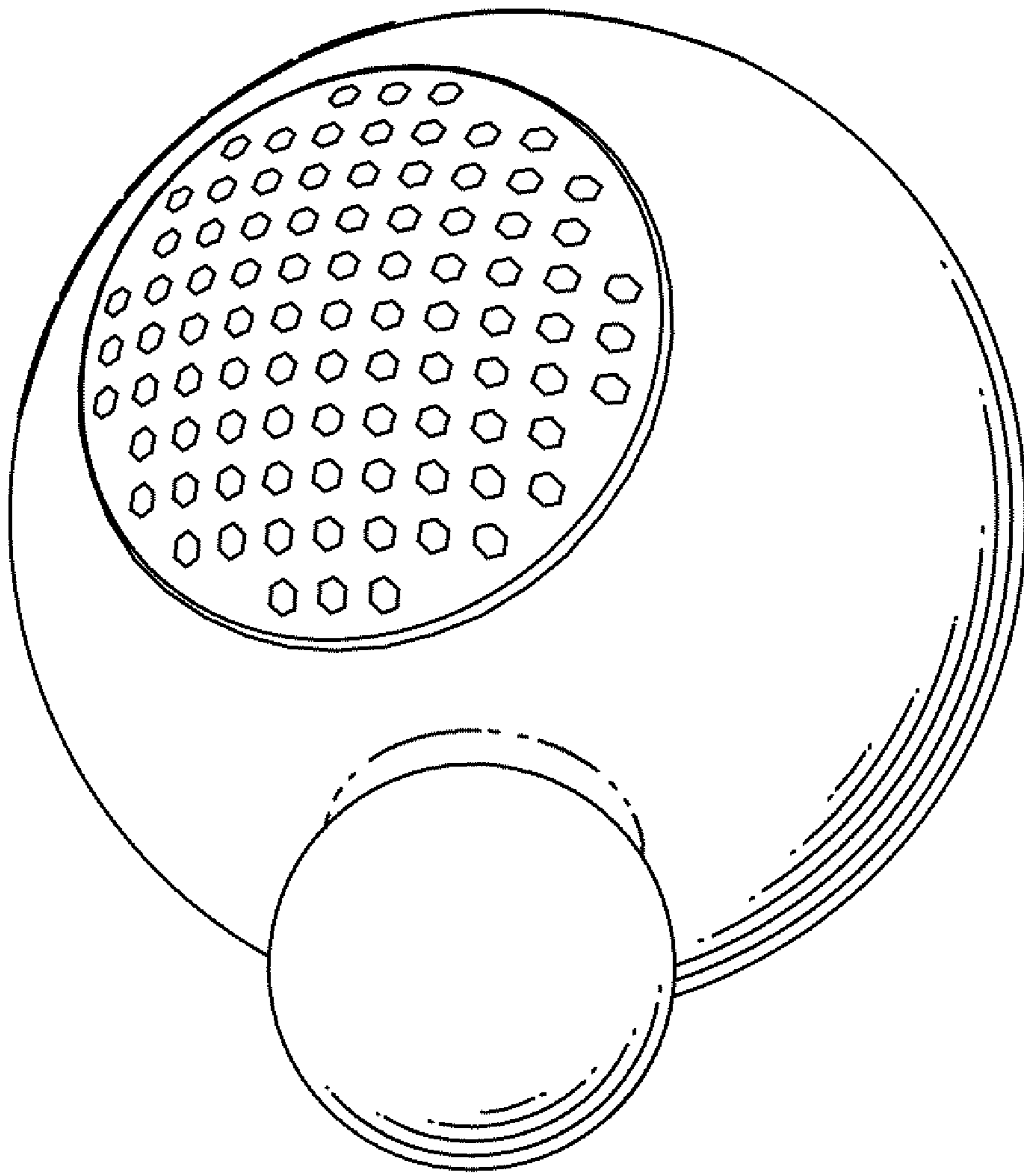

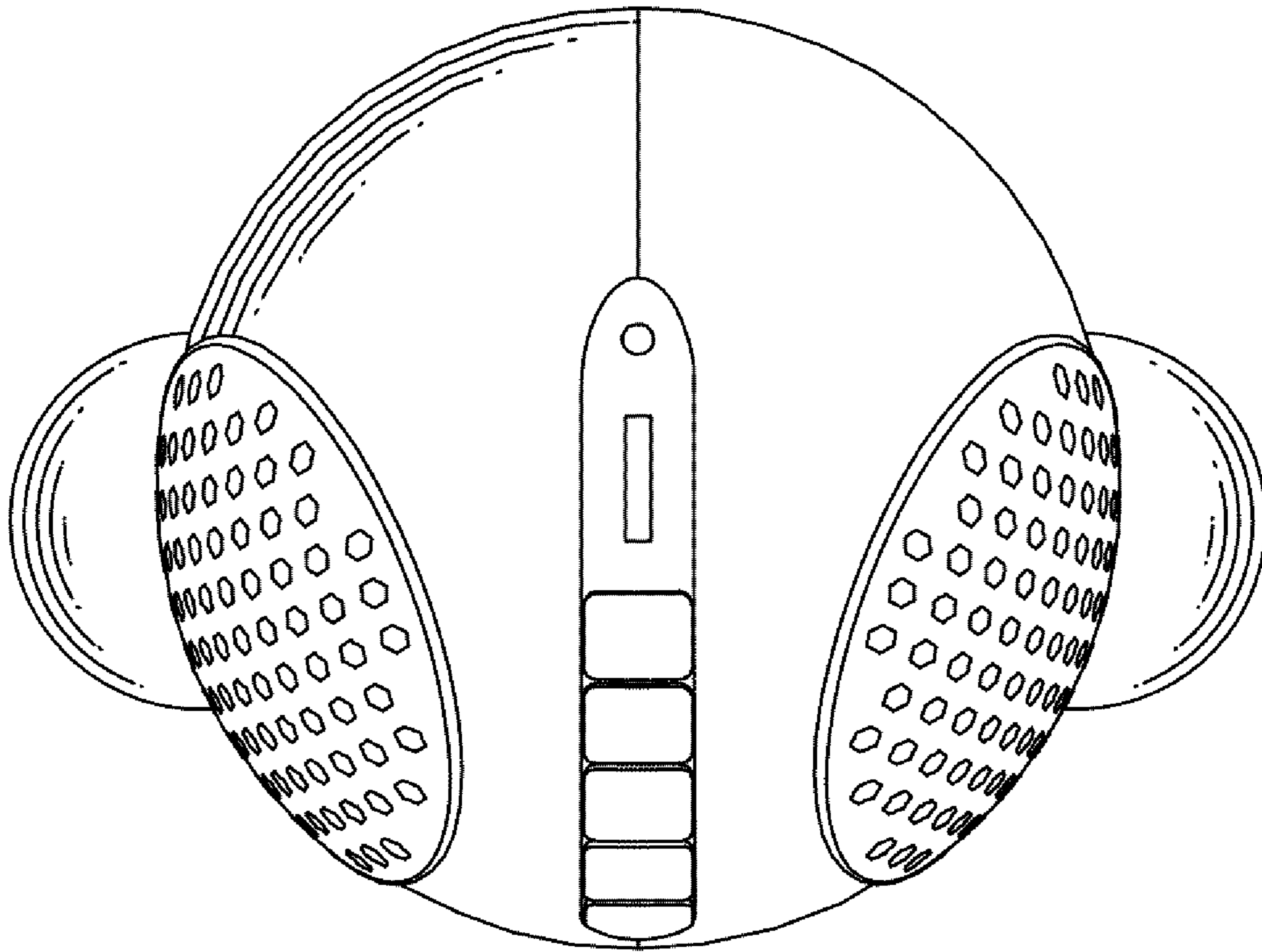

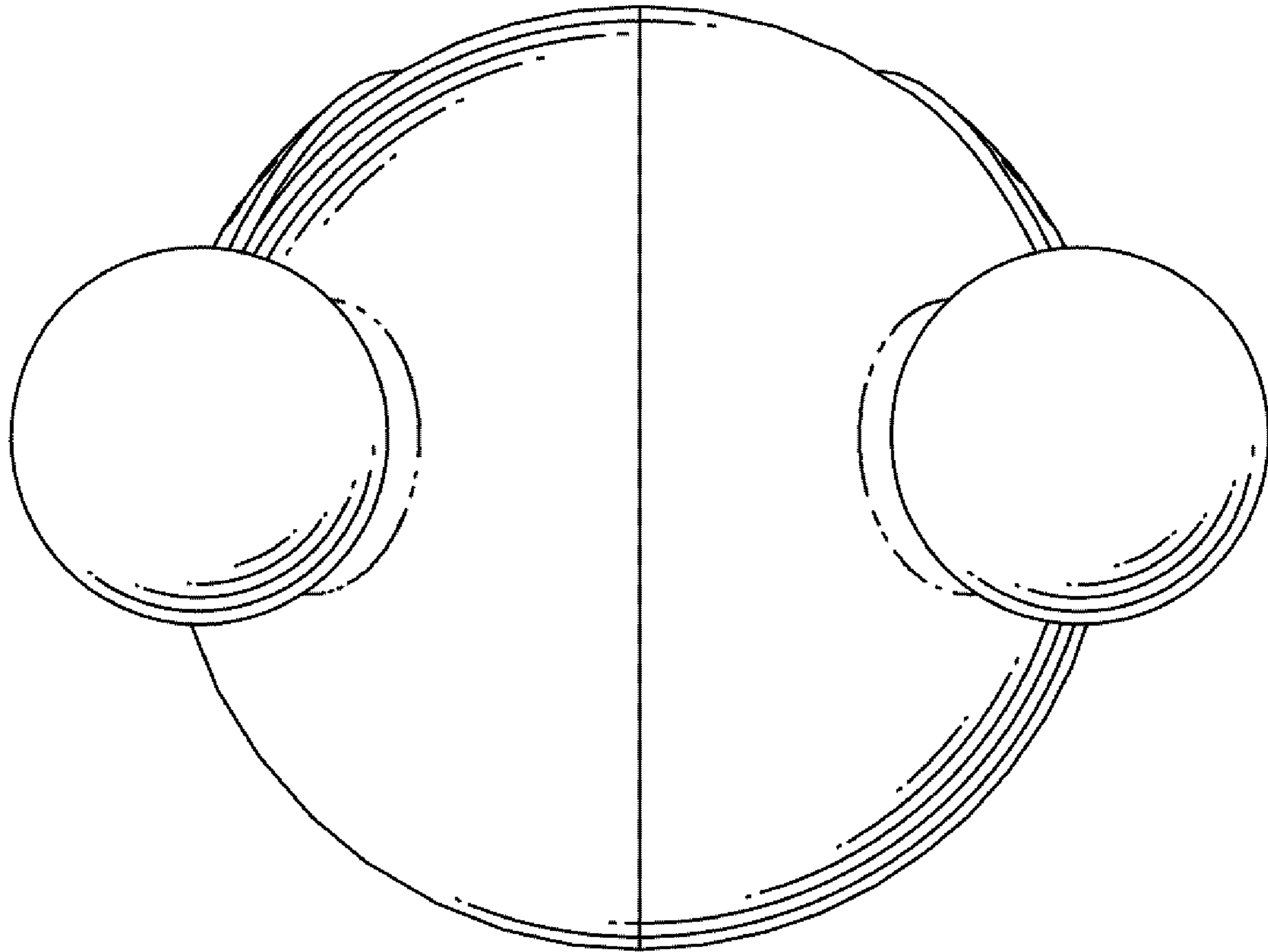
