FIG. 3 is a front elevational view of another representative template thereof;

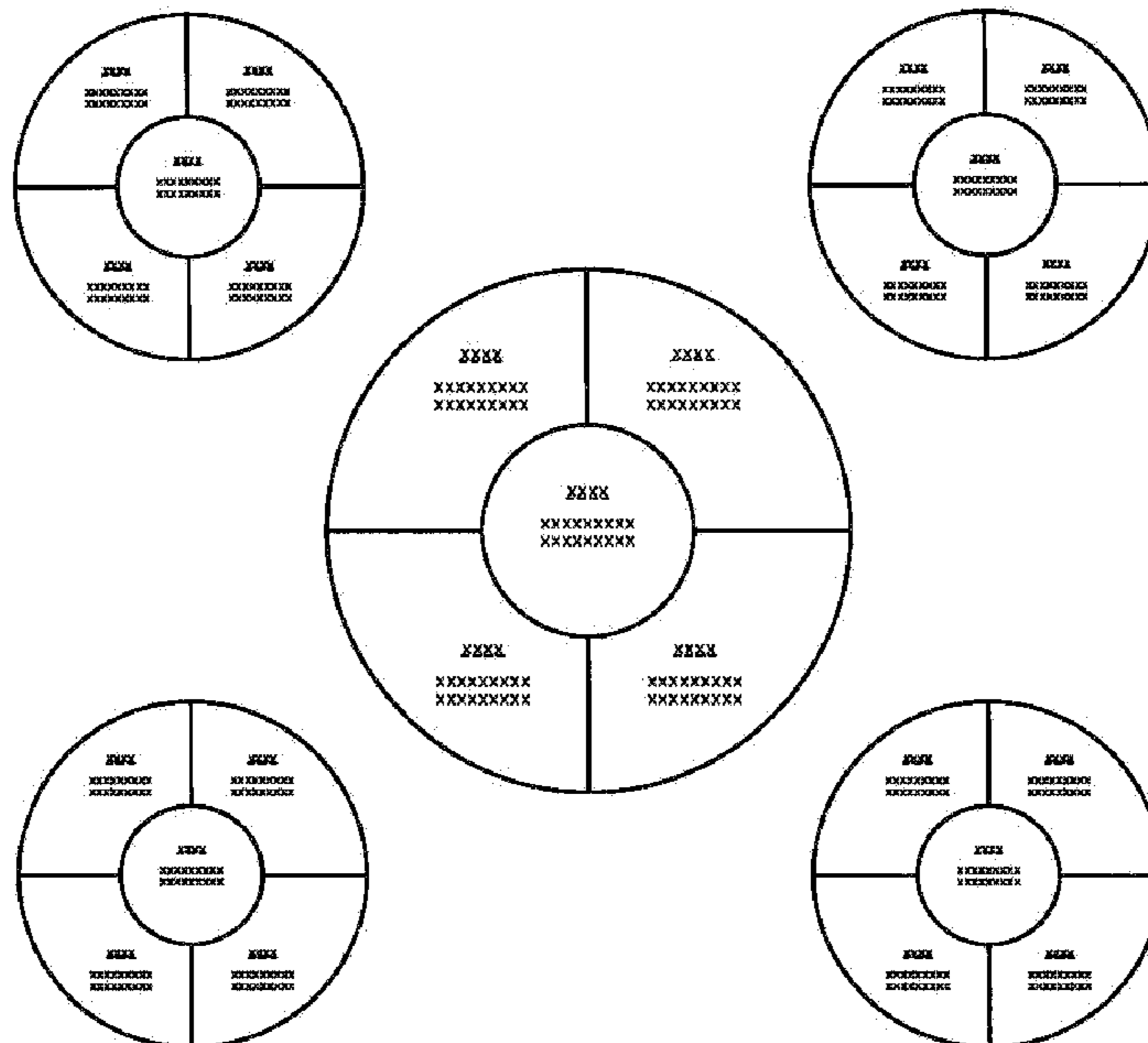
FIG. 4 is a front elevational view of another representative template thereof;

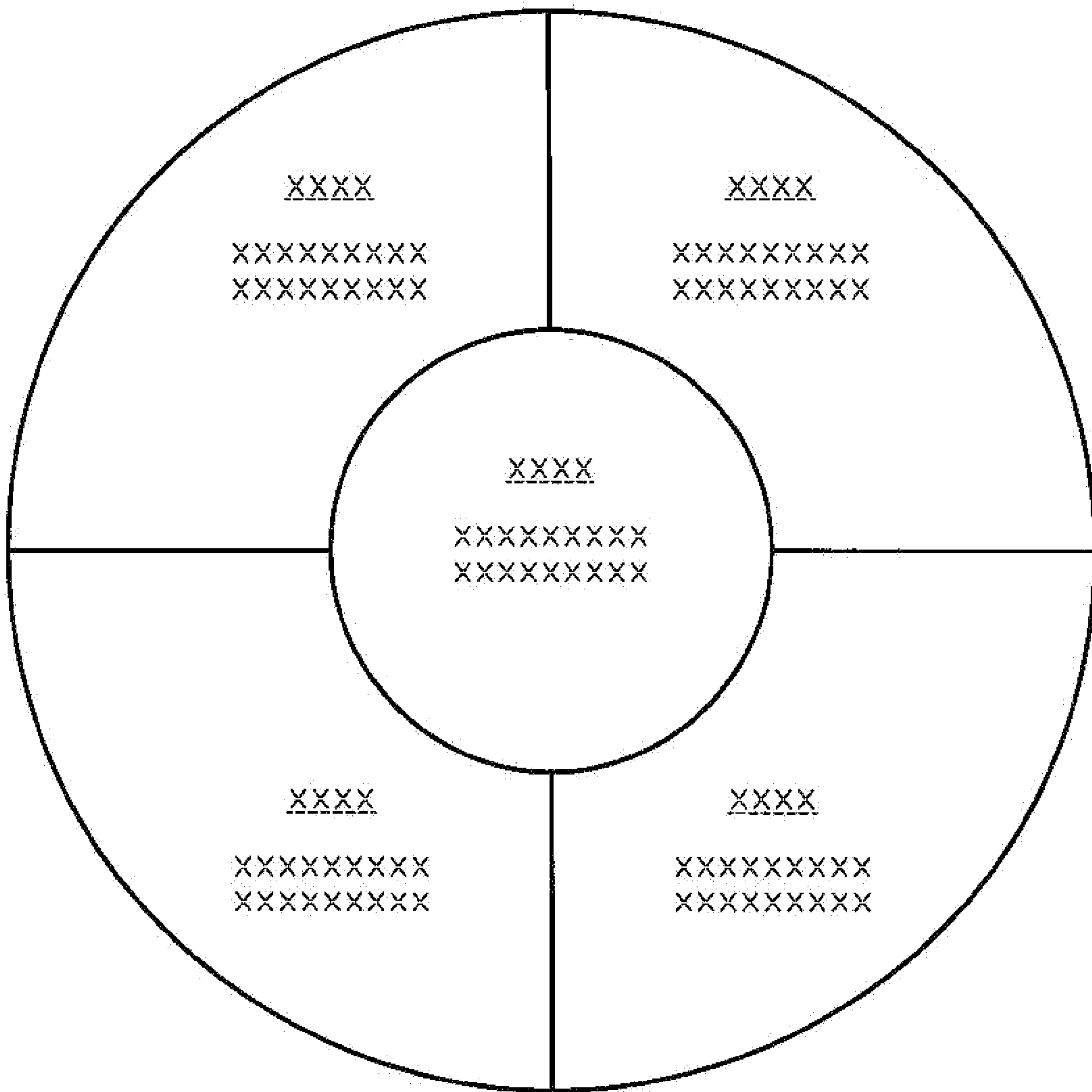

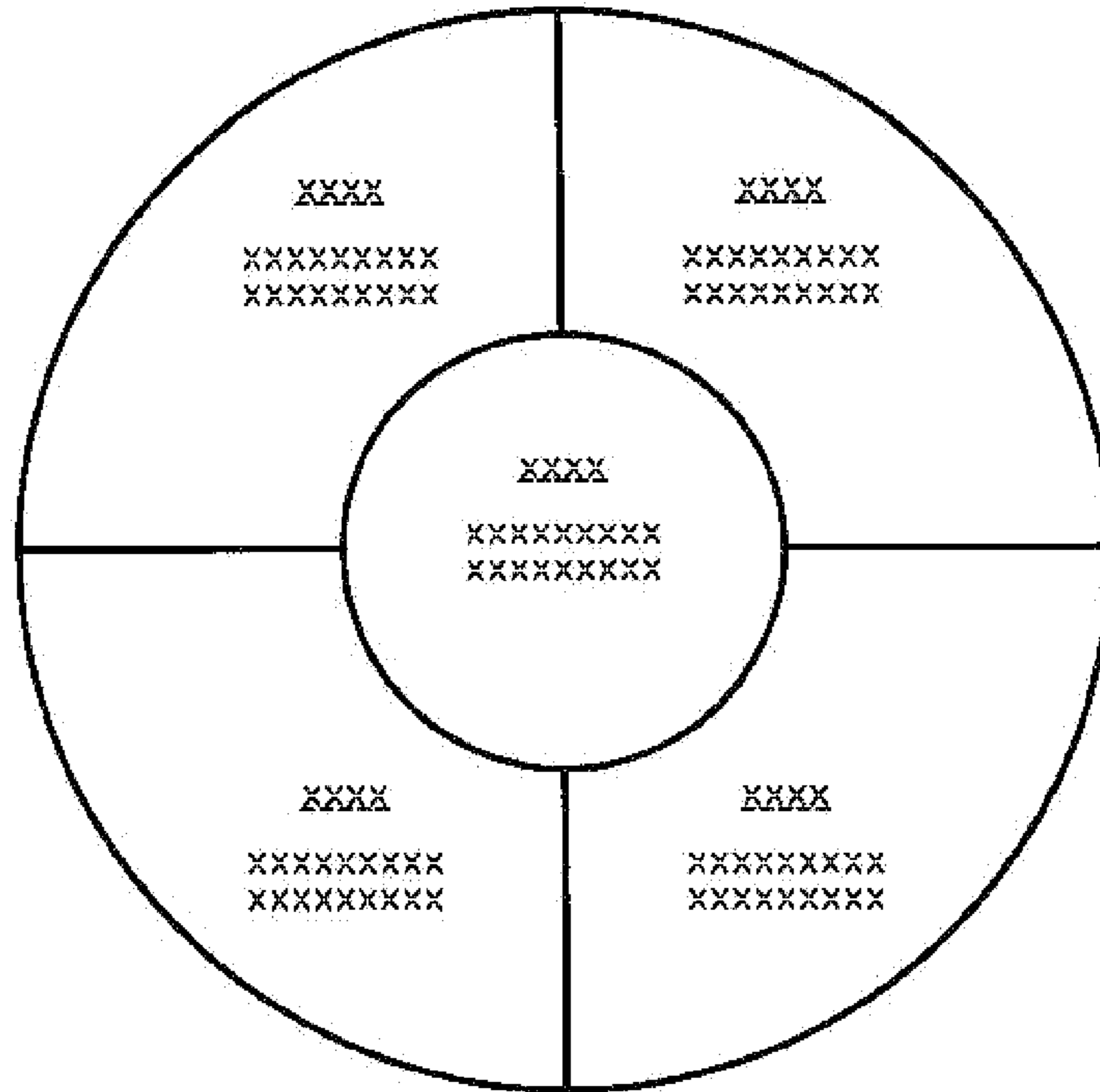

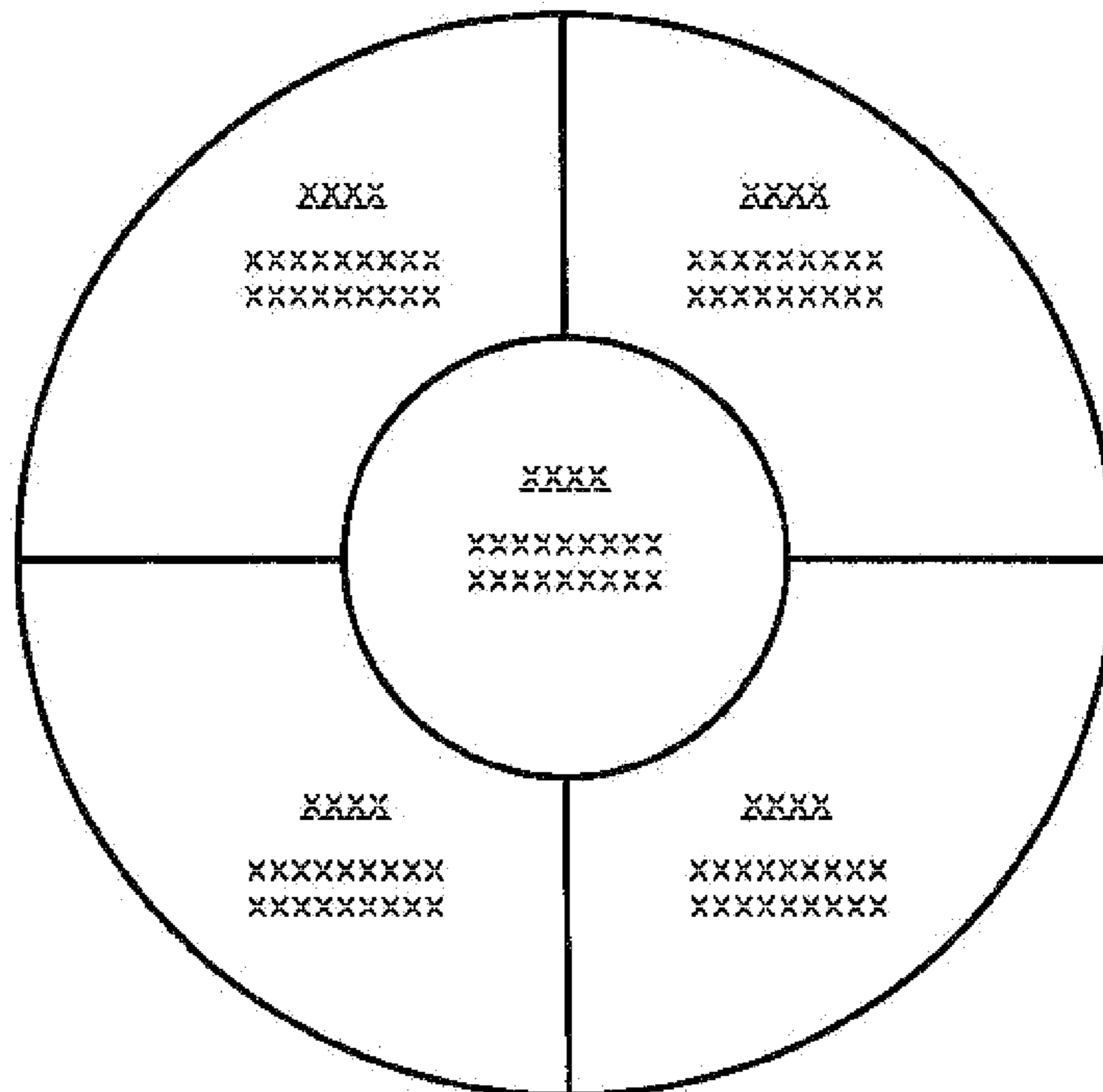

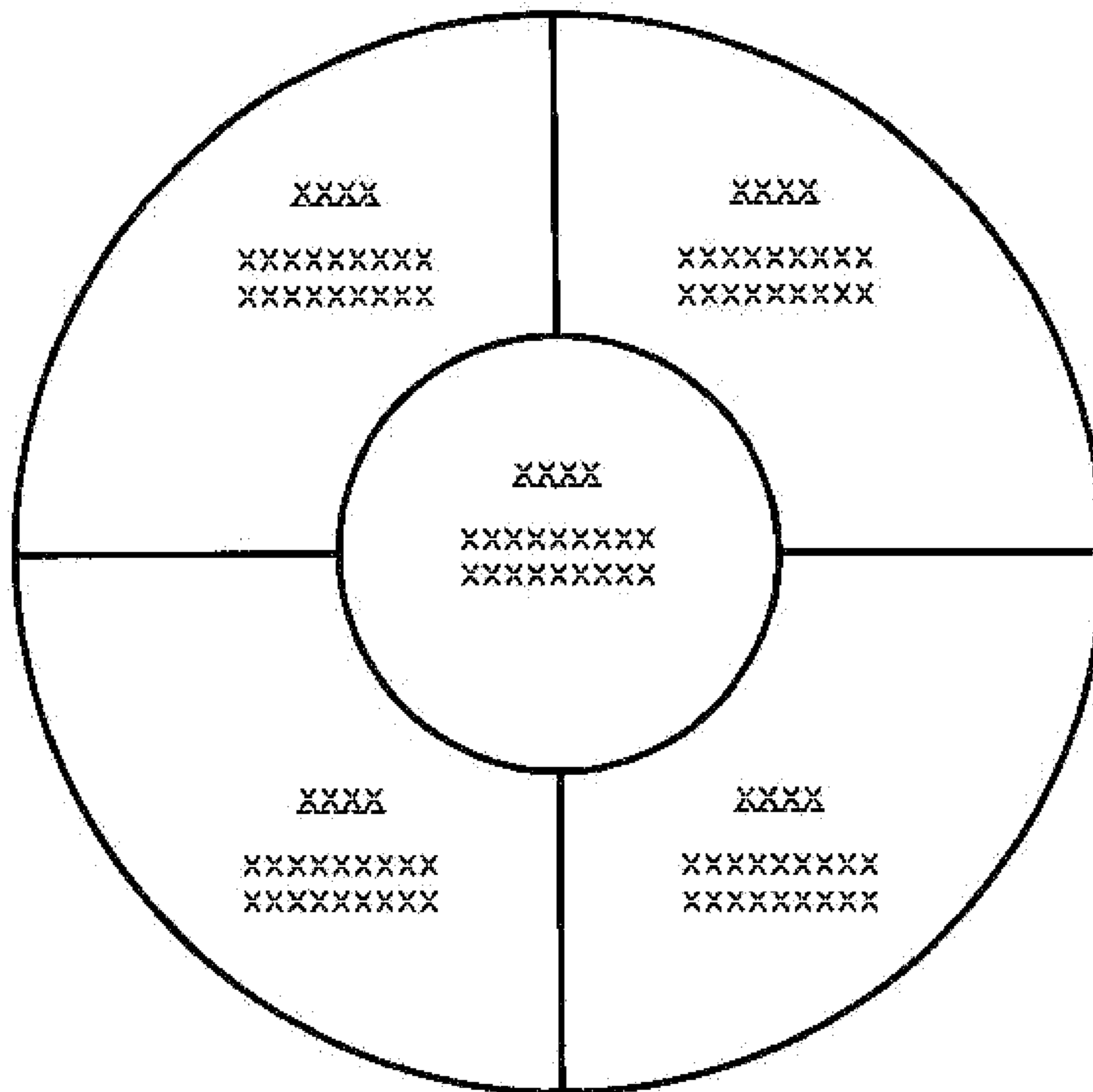

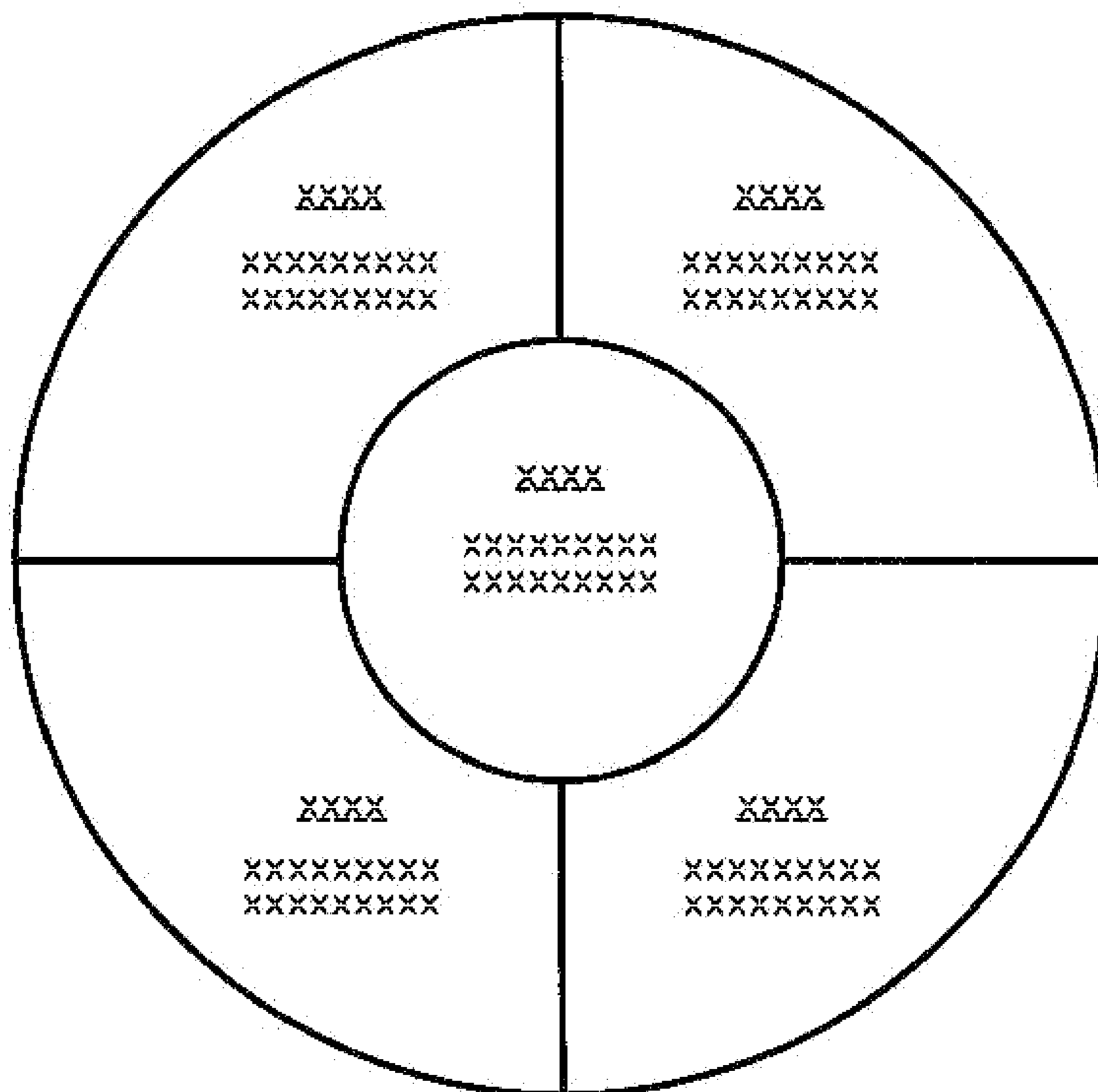

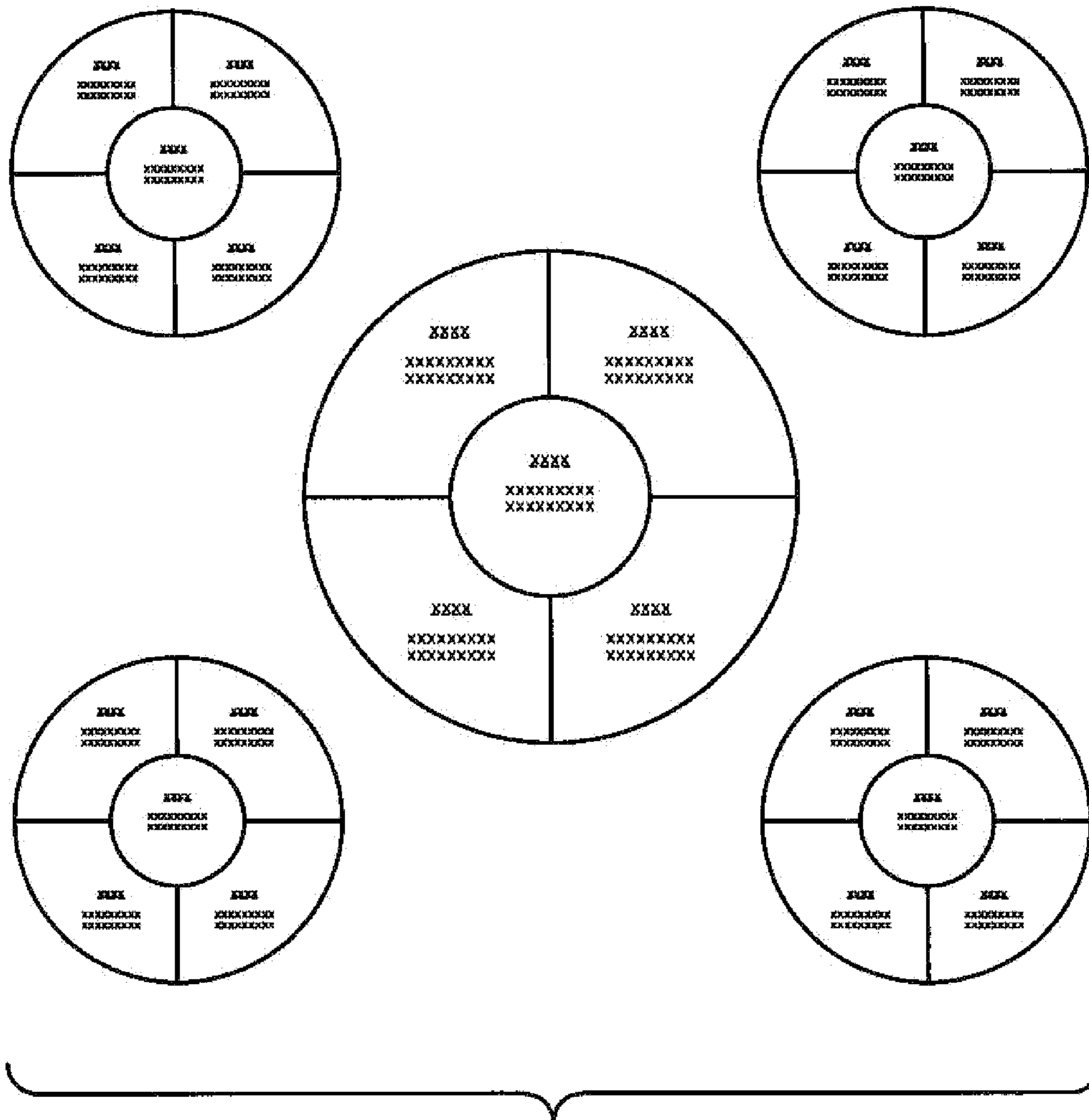
