The ornamental design for a writing utensil holder, as shown and described.

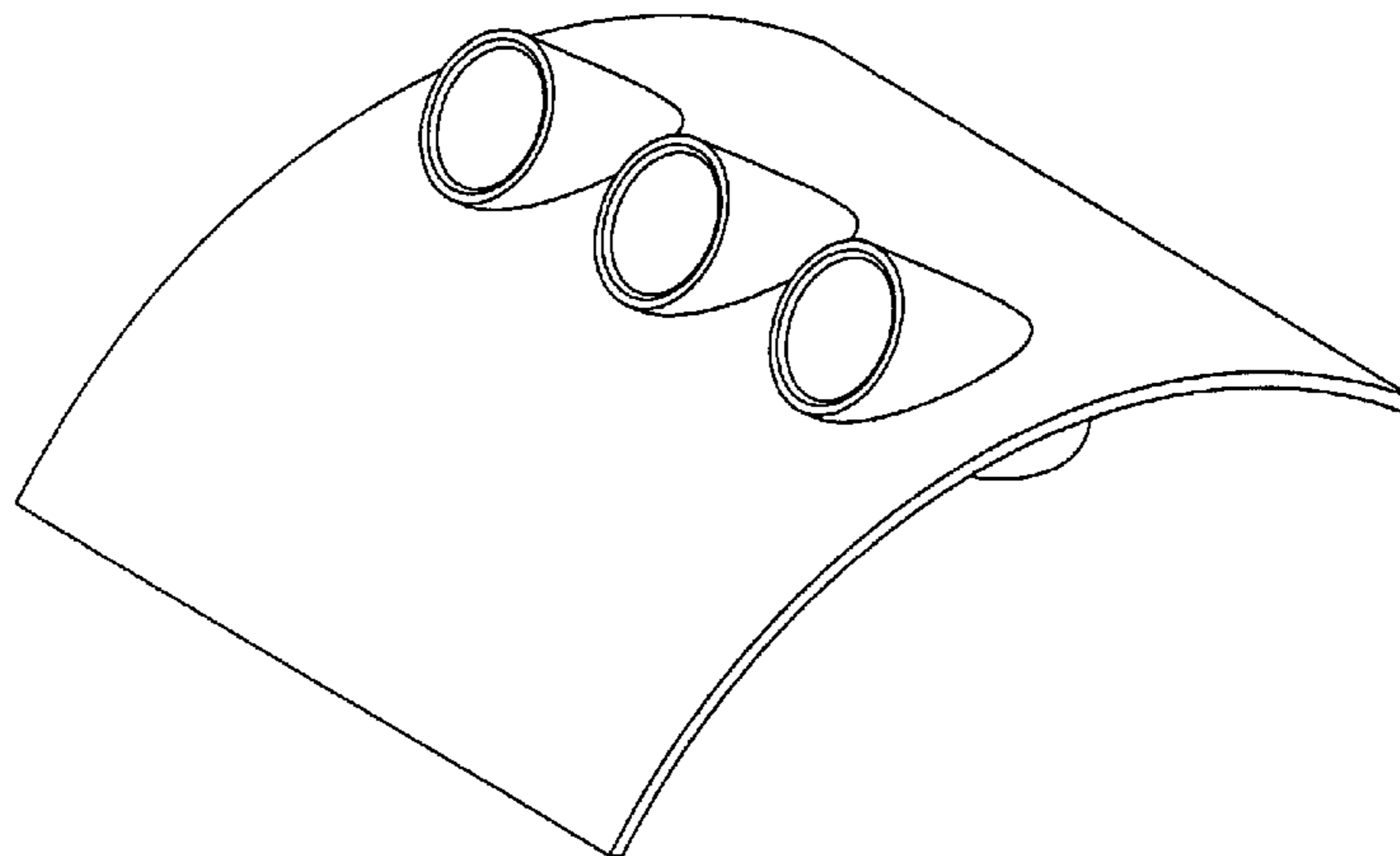
DESCRIPTION

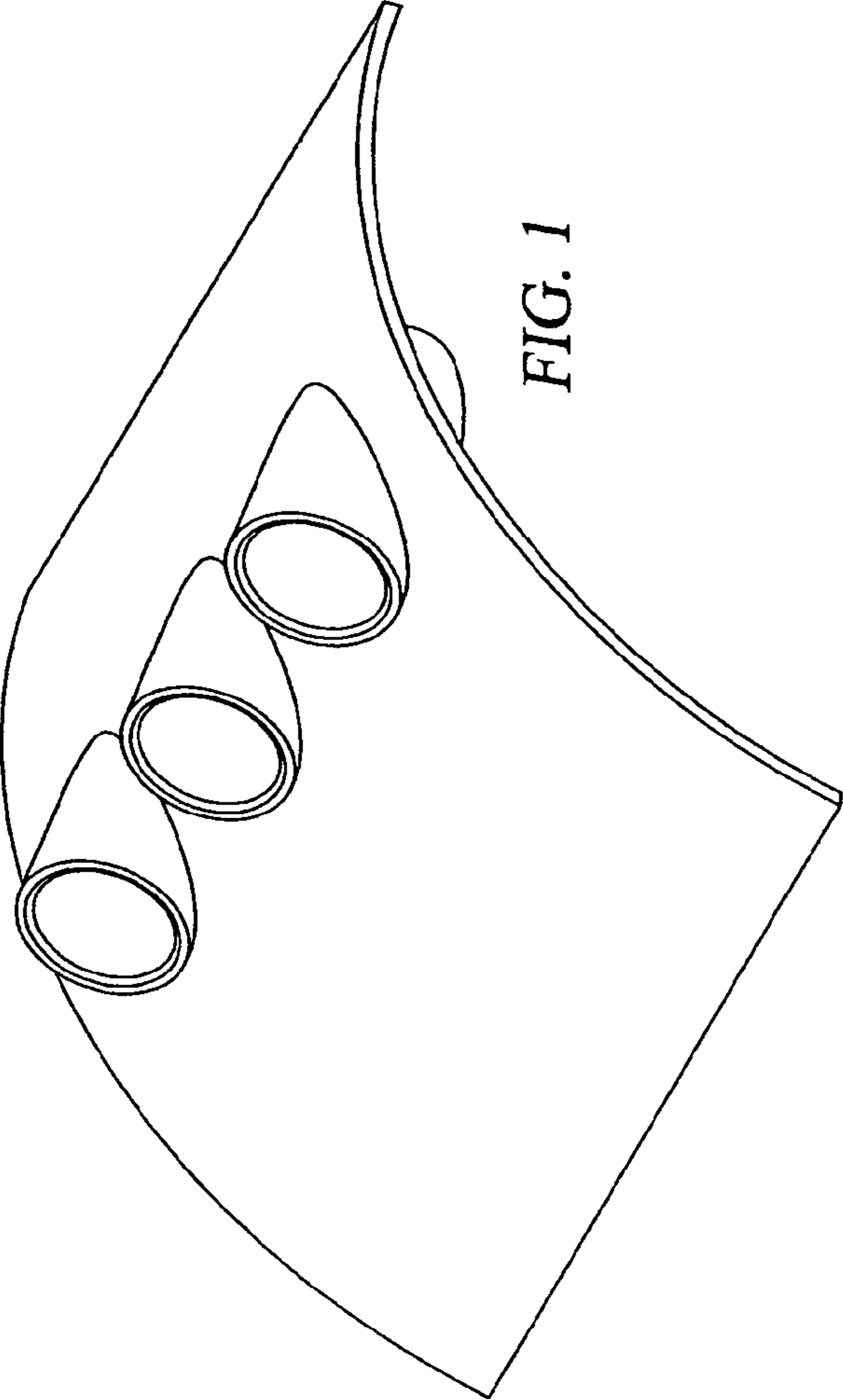

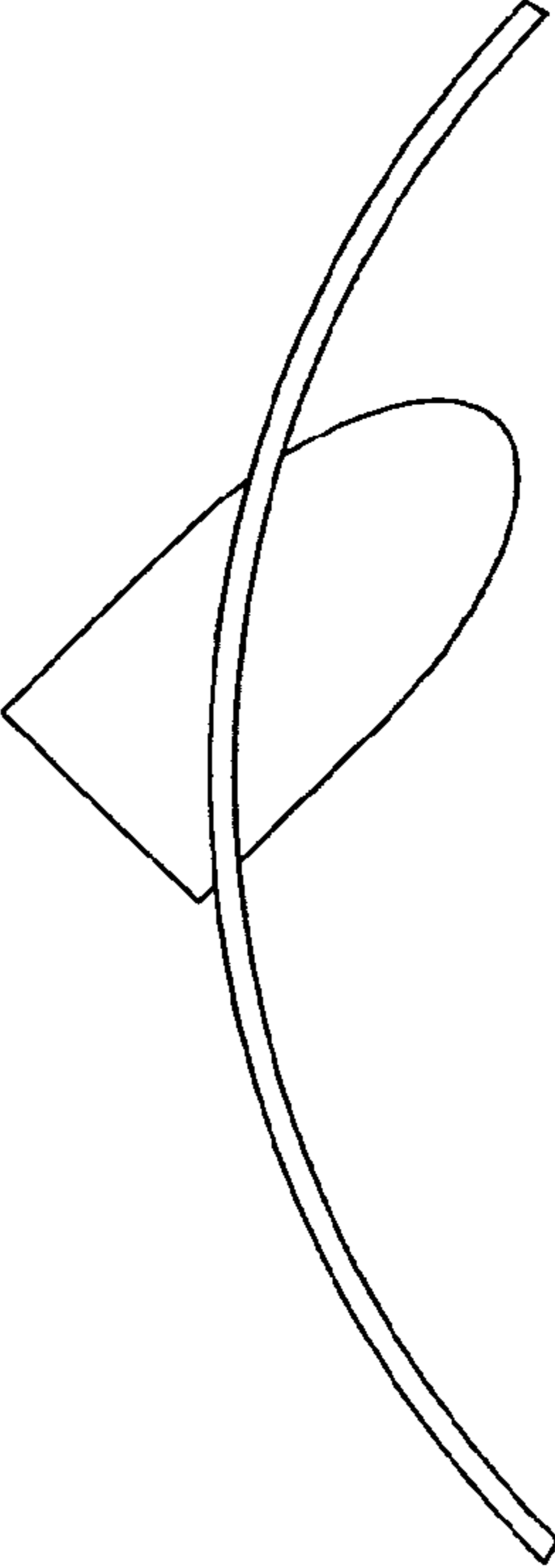

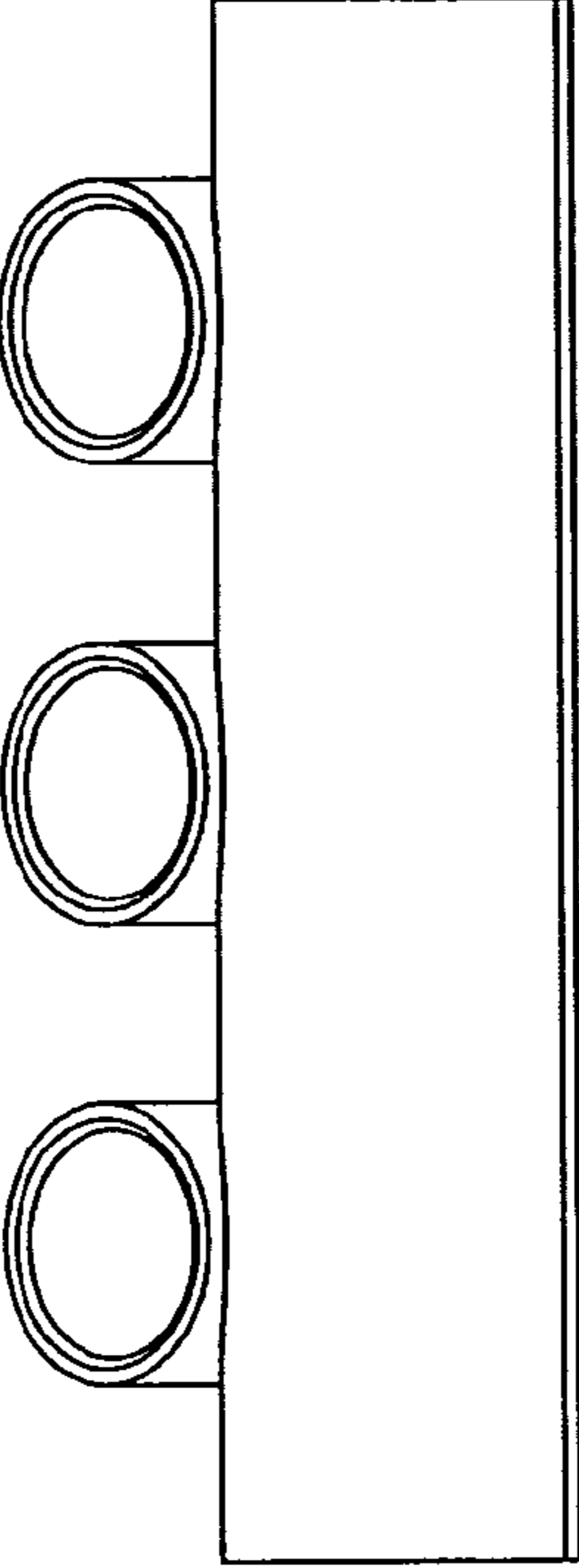
