The ornamental design for the dodecahedron die with musical pitches, as shown and described.

**DESCRIPTION**

FIG. 4 is a side elevation view along viewing lines 4—4 of FIG. 2;

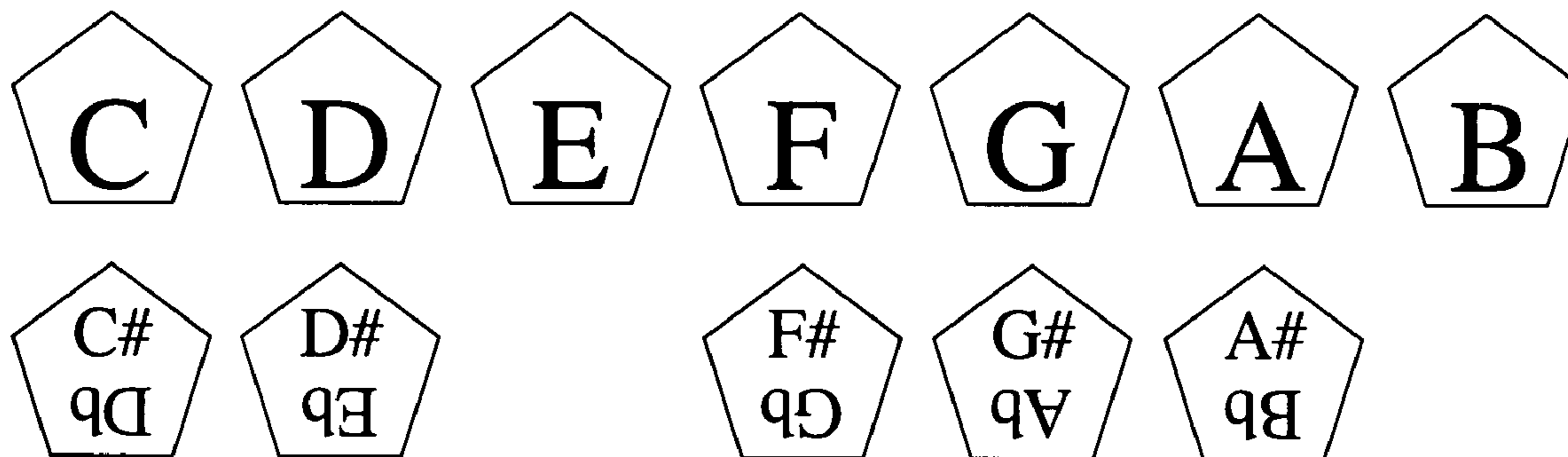
FIG. 5 is a side elevation view along viewing lines 5—5 of FIG. 2;

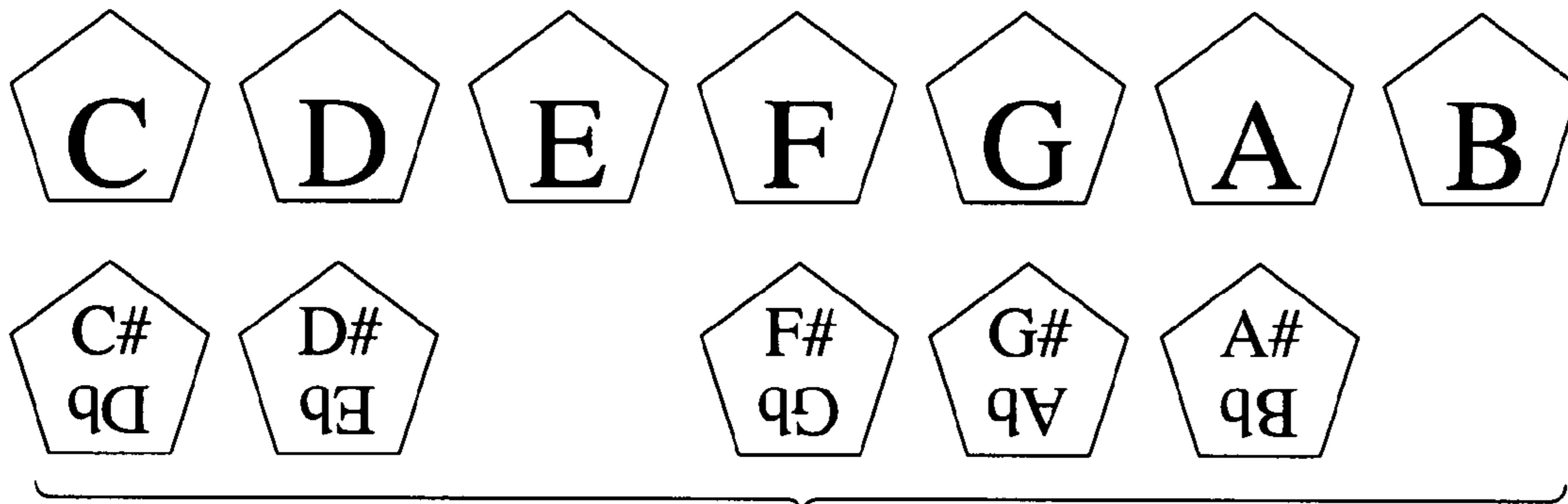

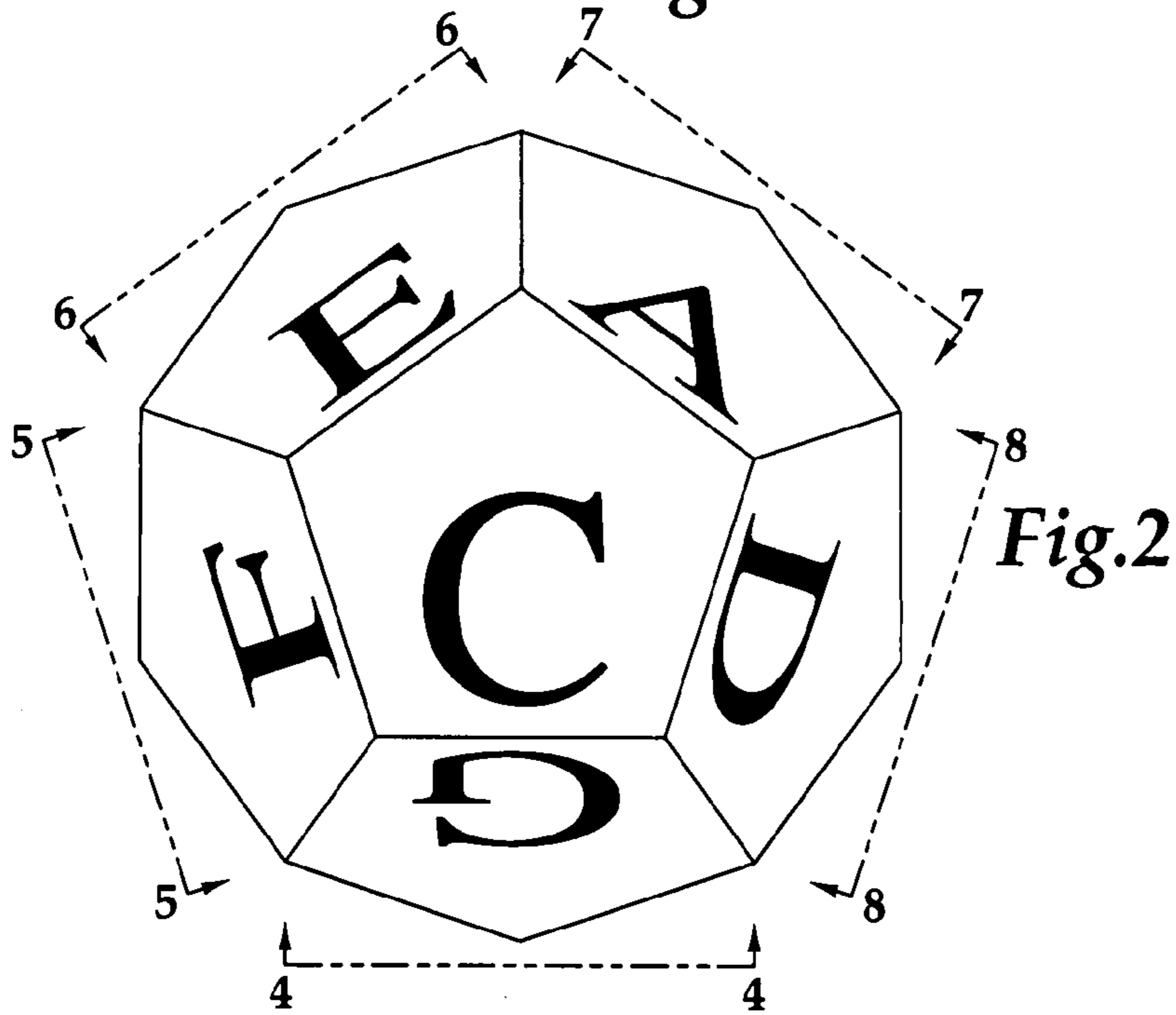

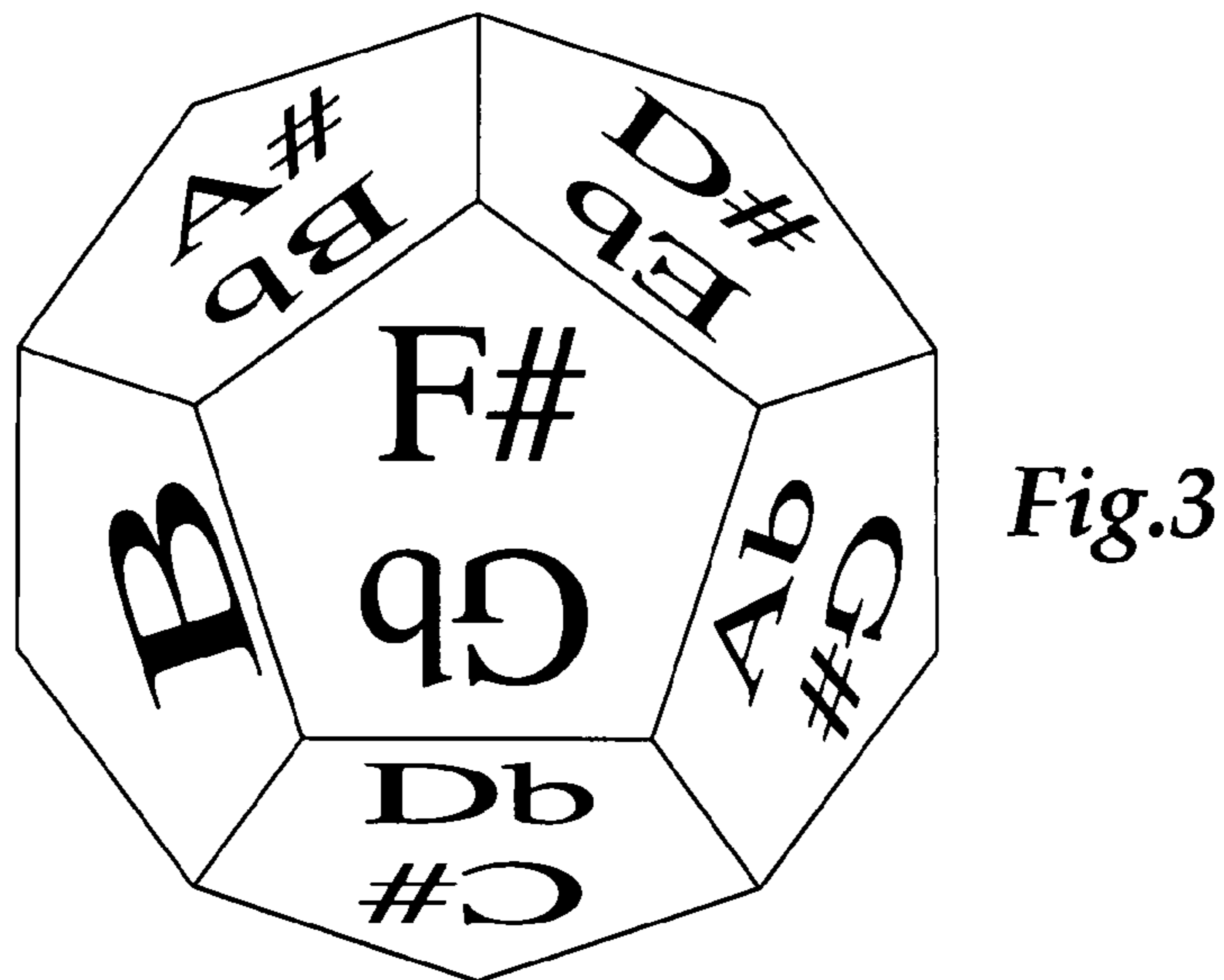
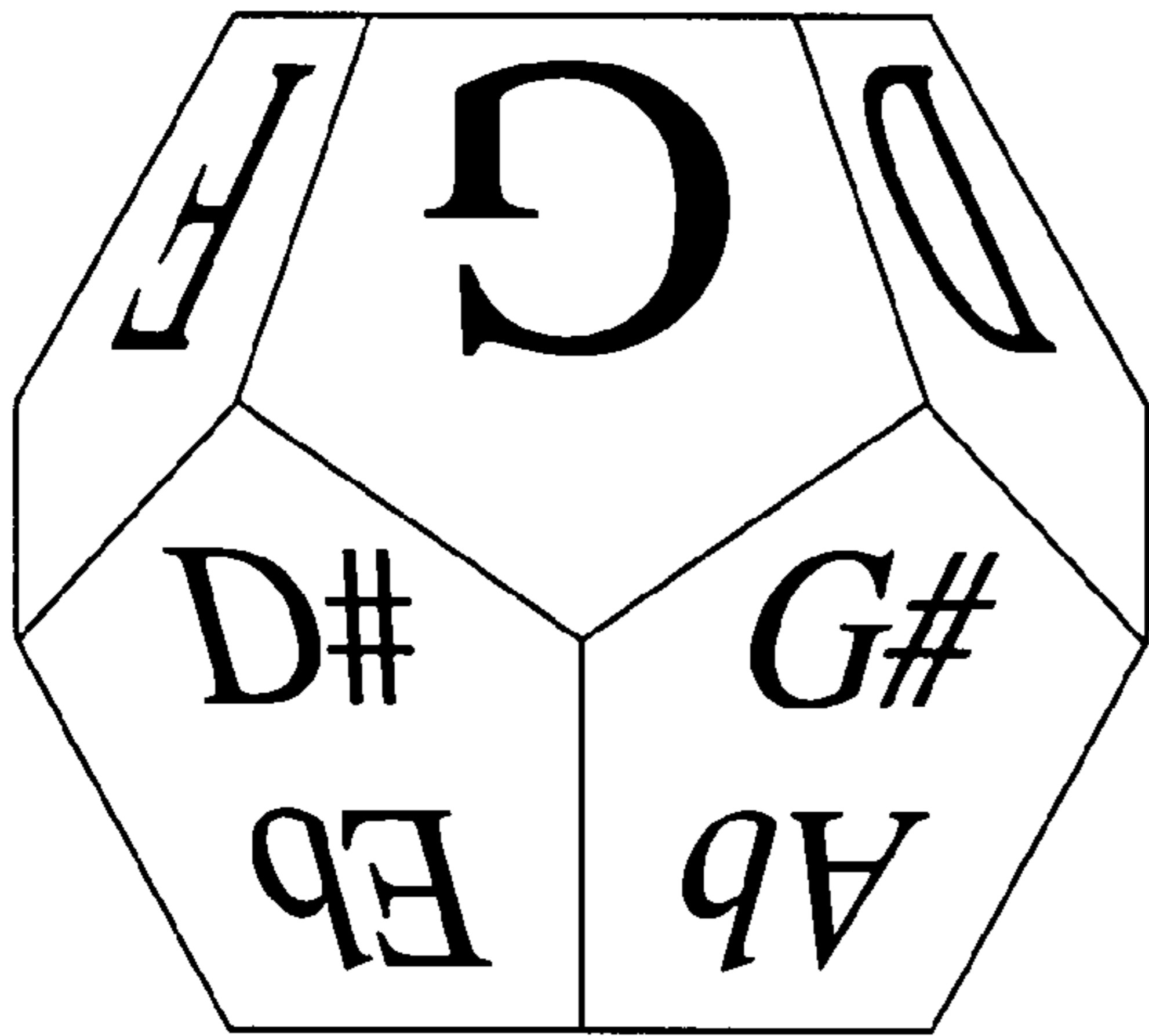
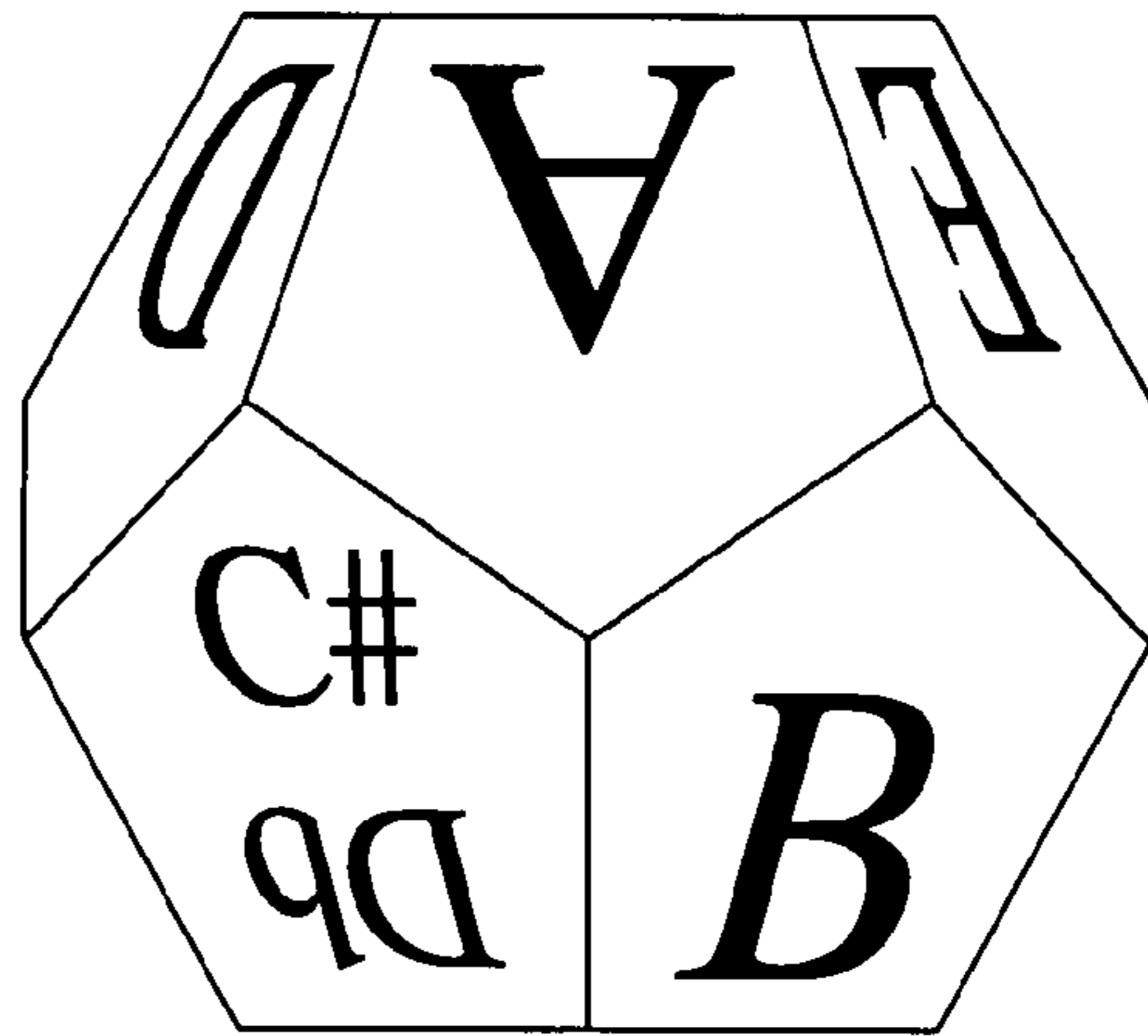


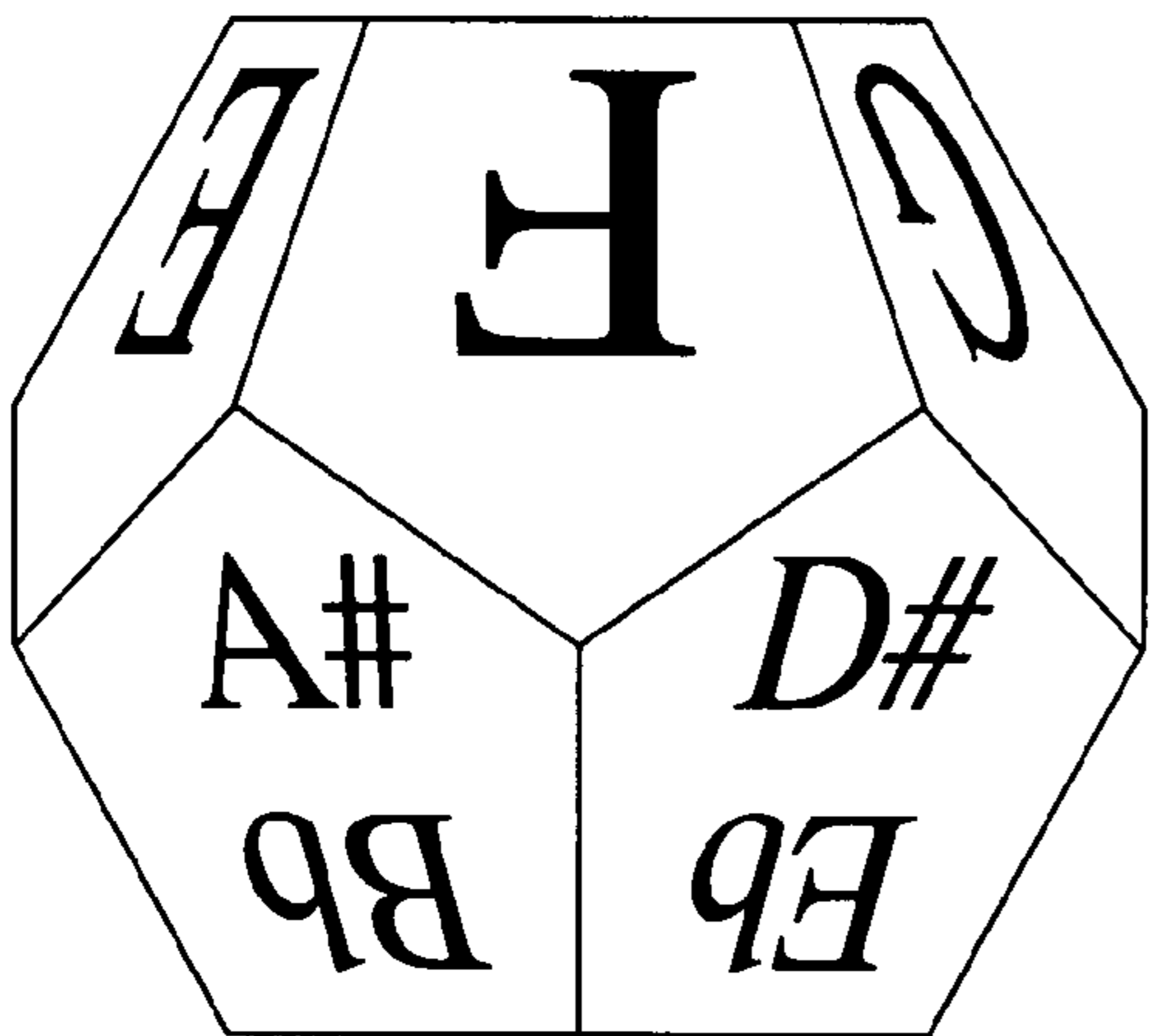

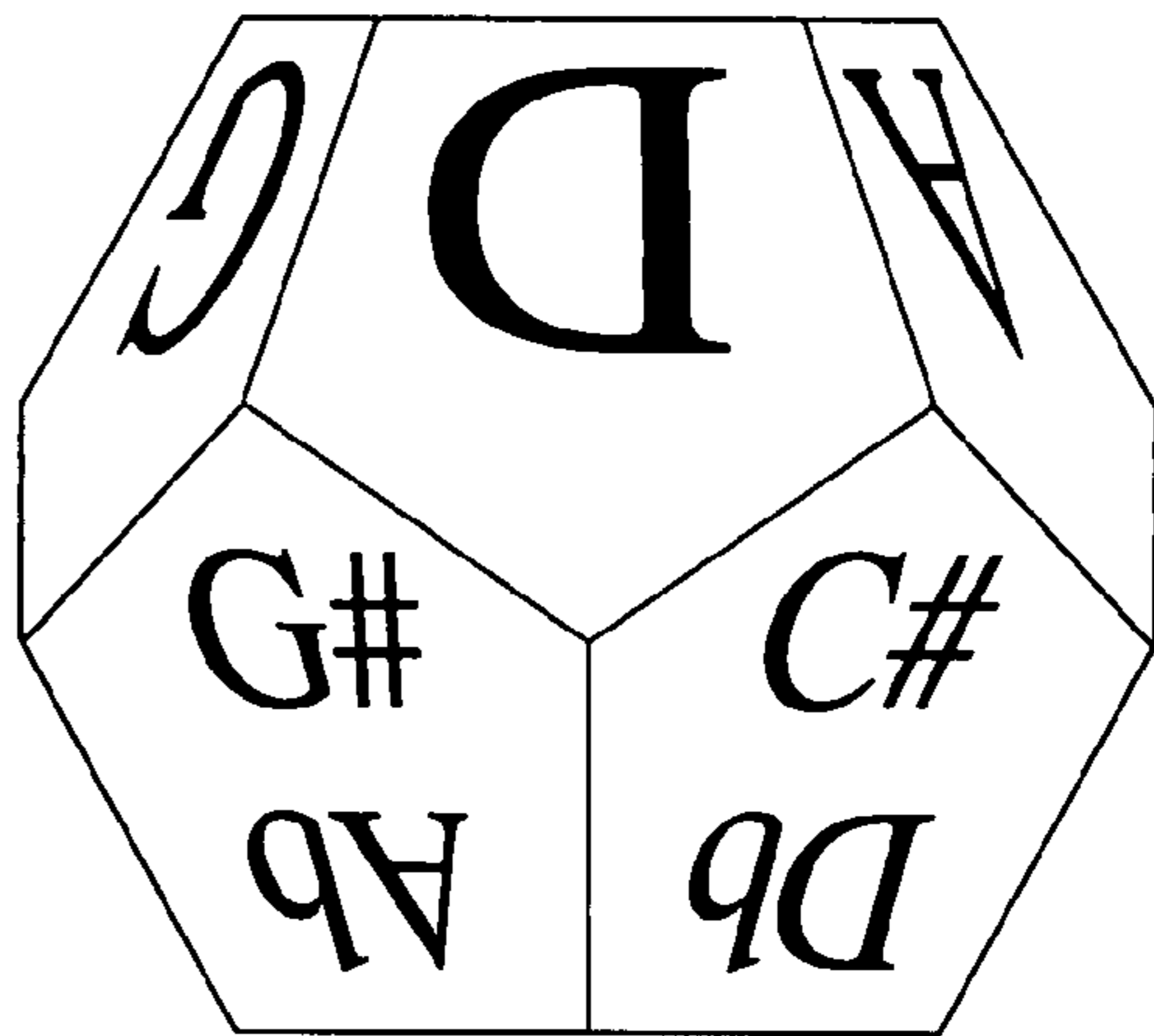

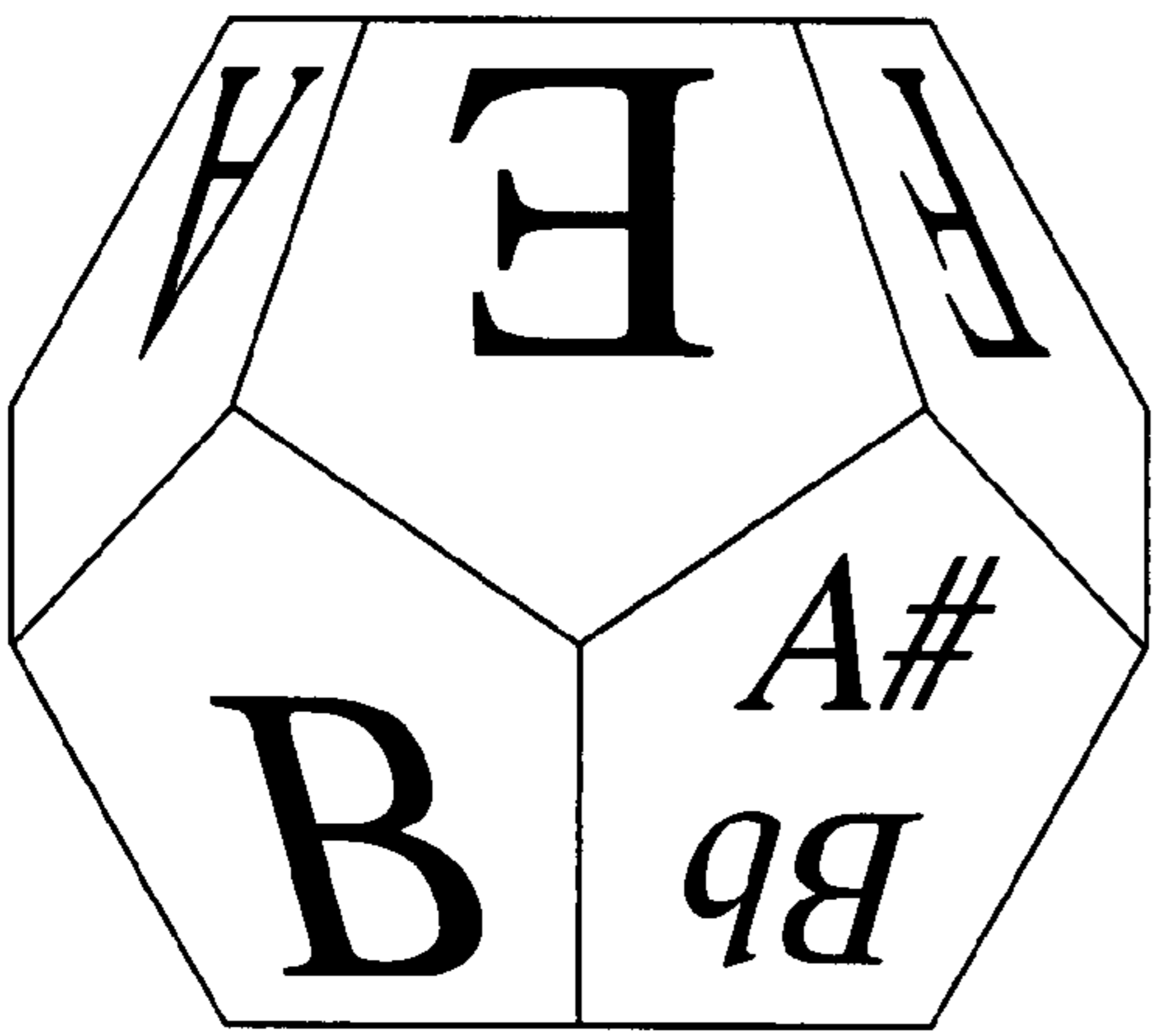
