(57) **CLAIM**

The ornamental design for a set of free weights, as shown and described.

**DESCRIPTION**

FIG. 17 is a bottom longitudinal view thereof;

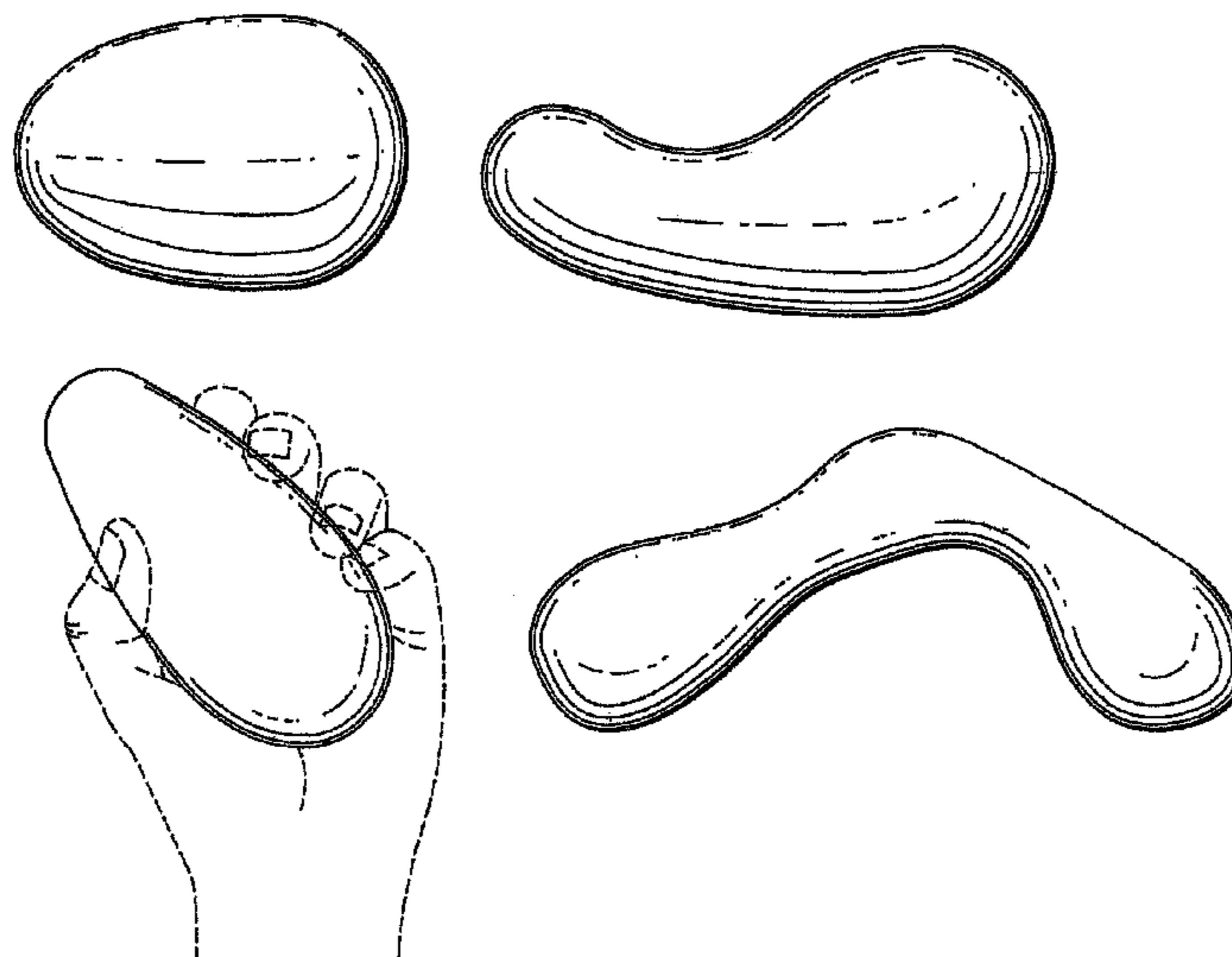
FIG. 18 is a bottom latitudinal view thereof;

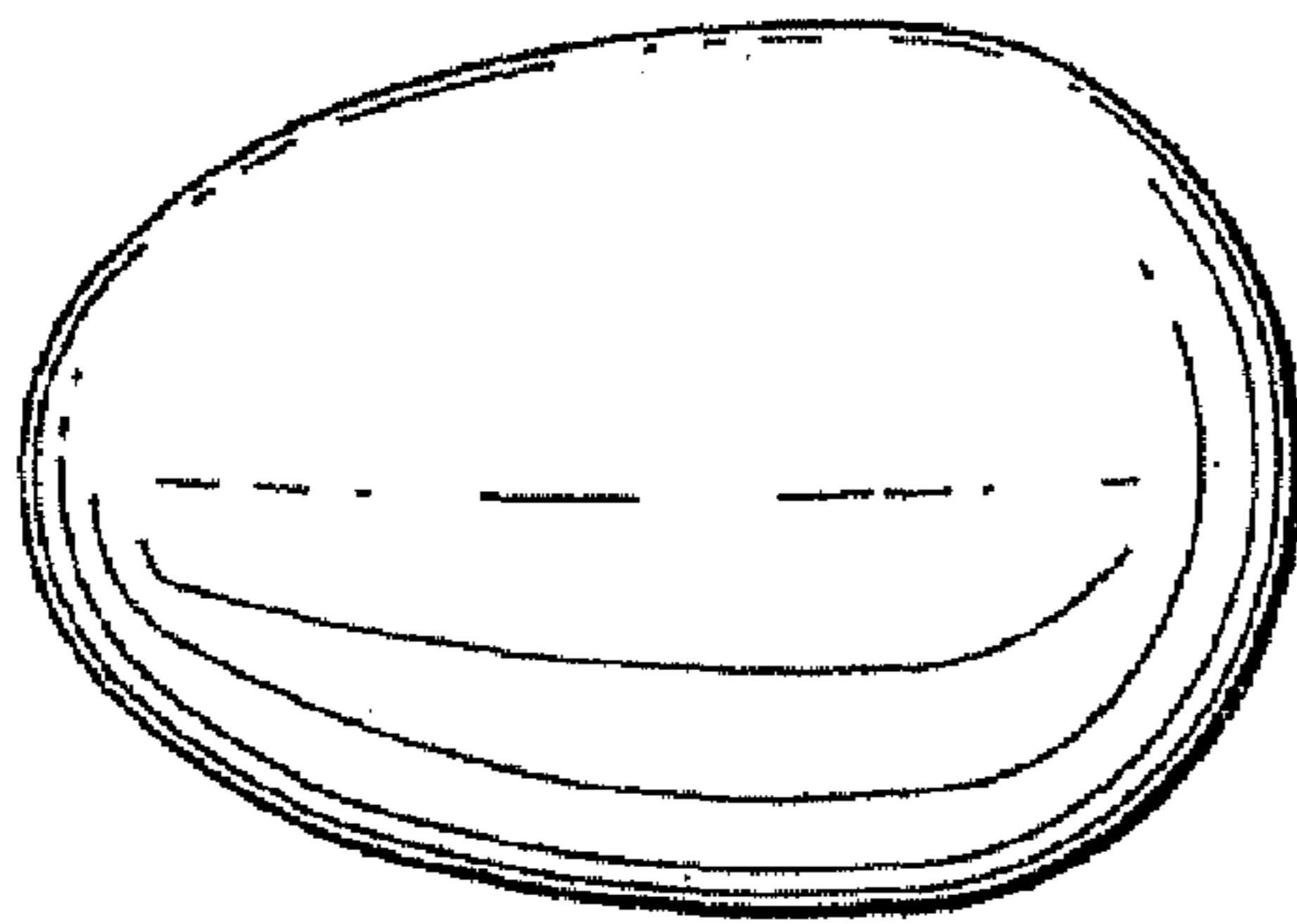
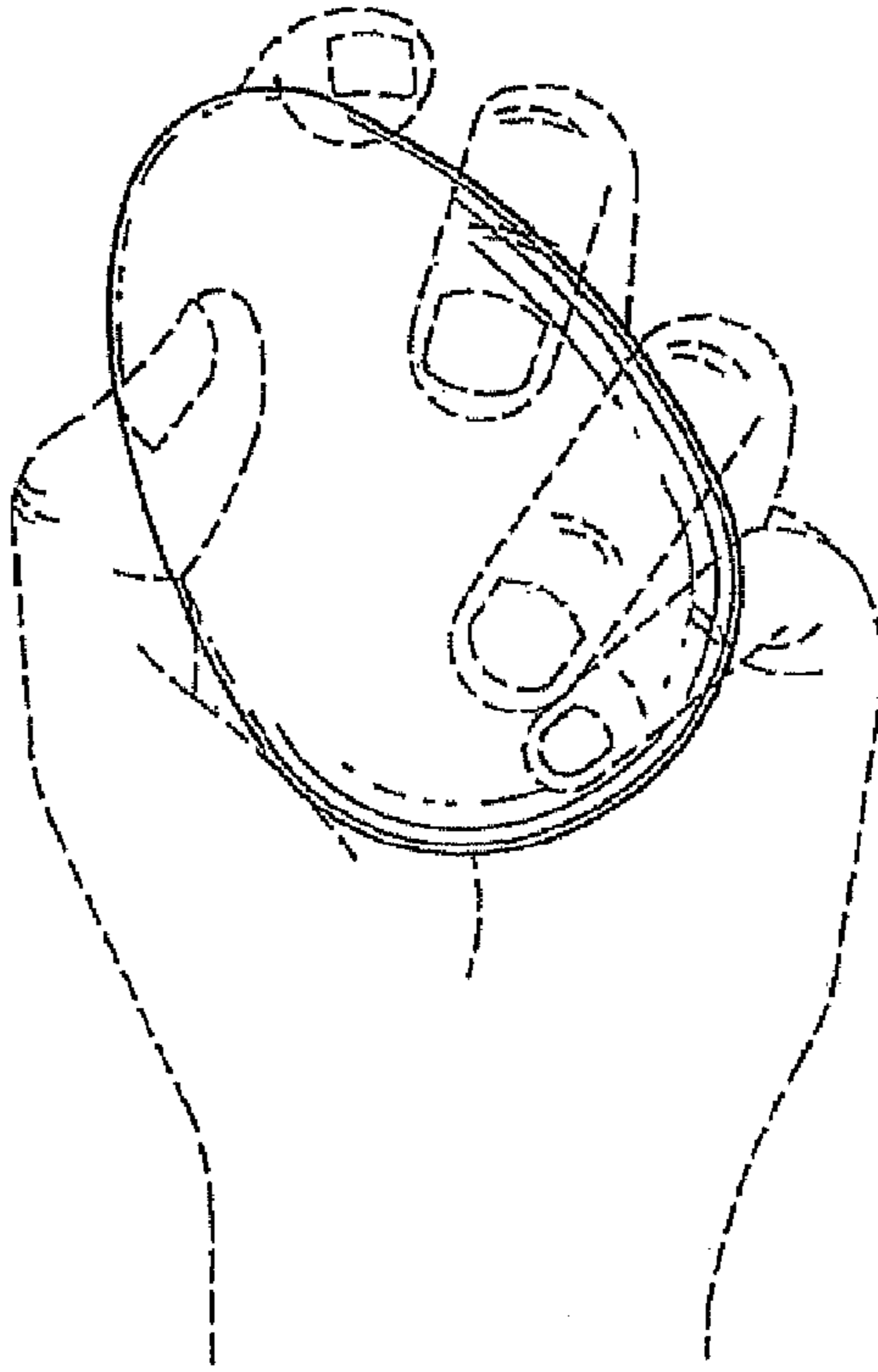

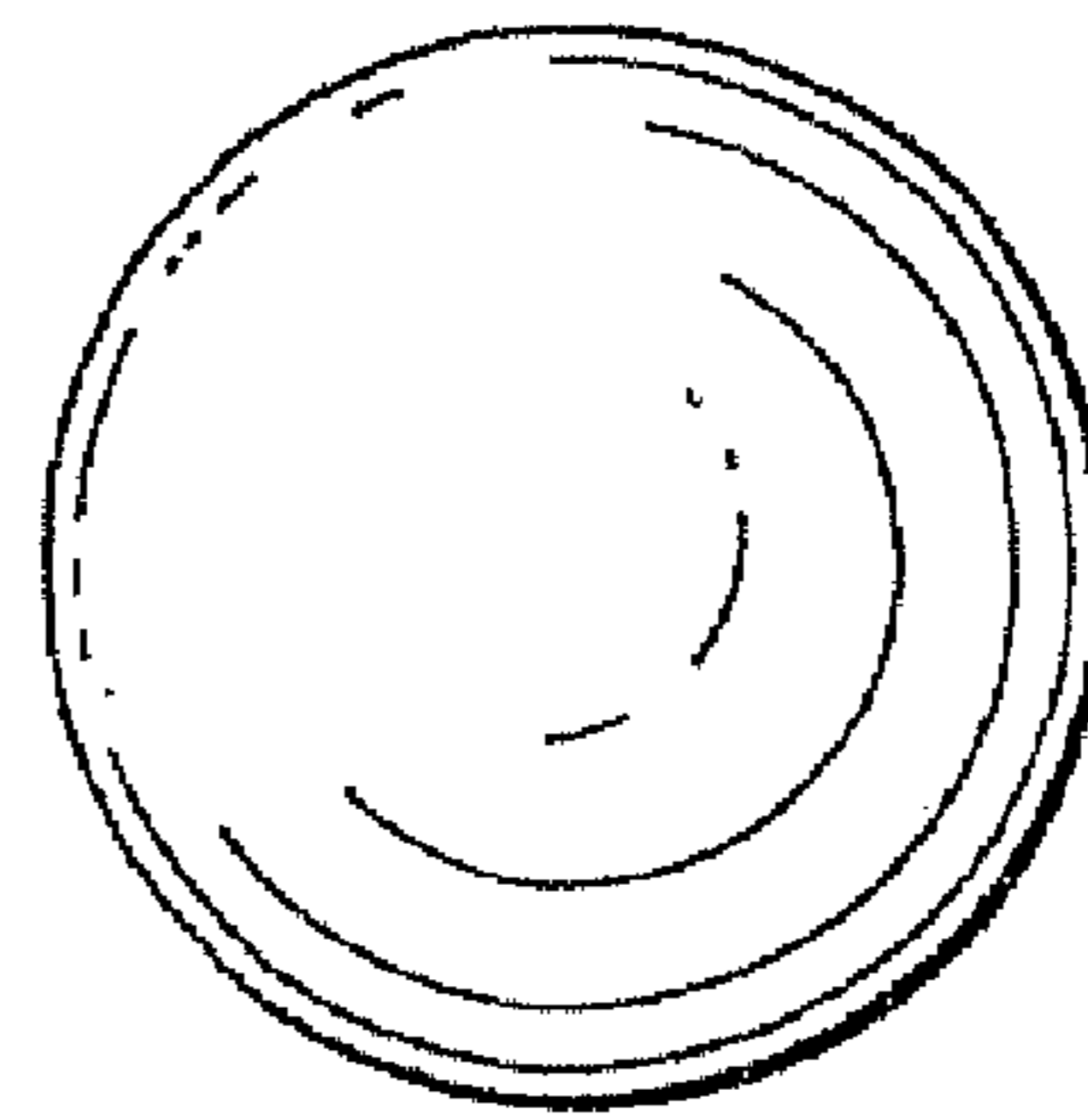

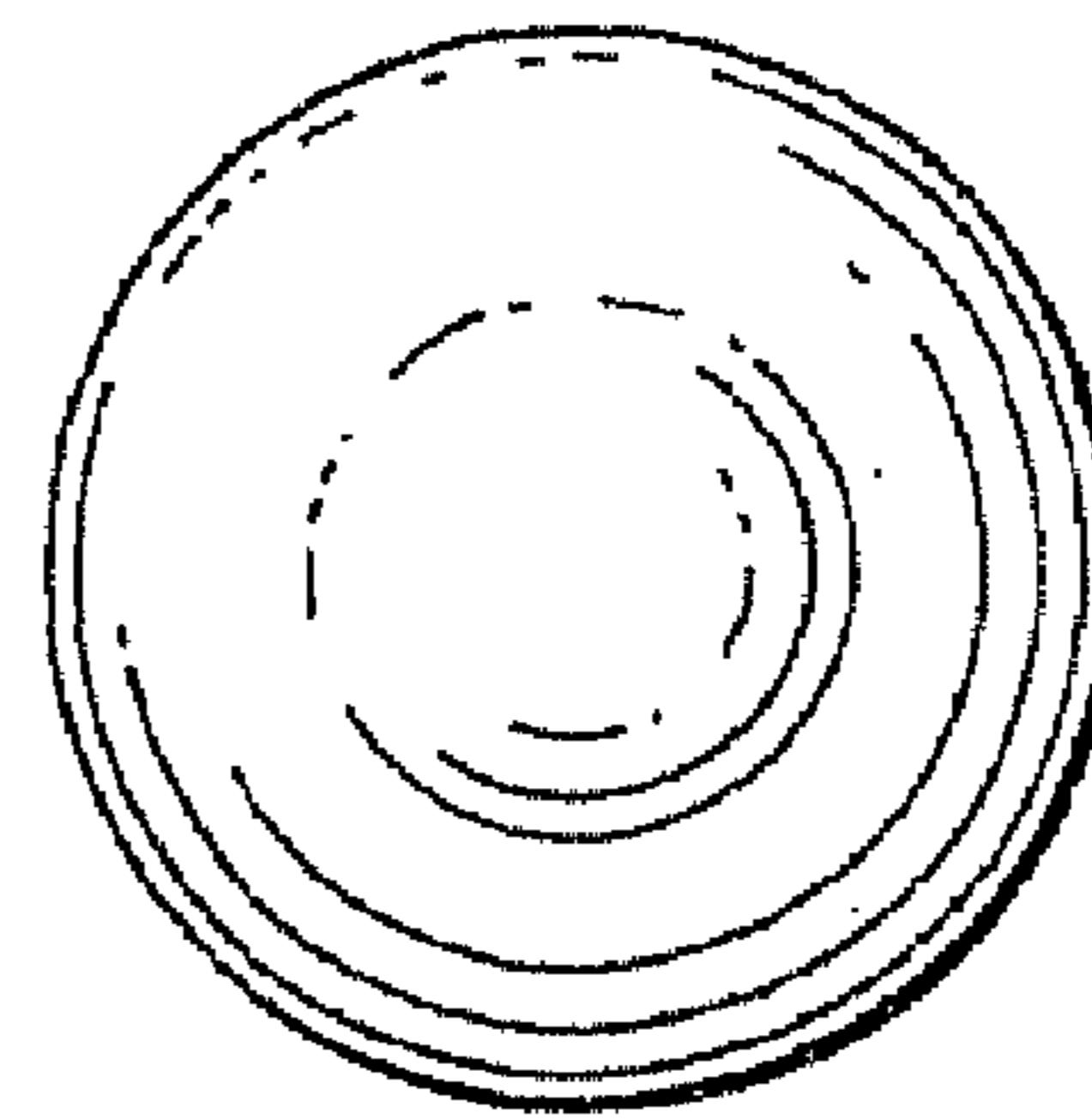

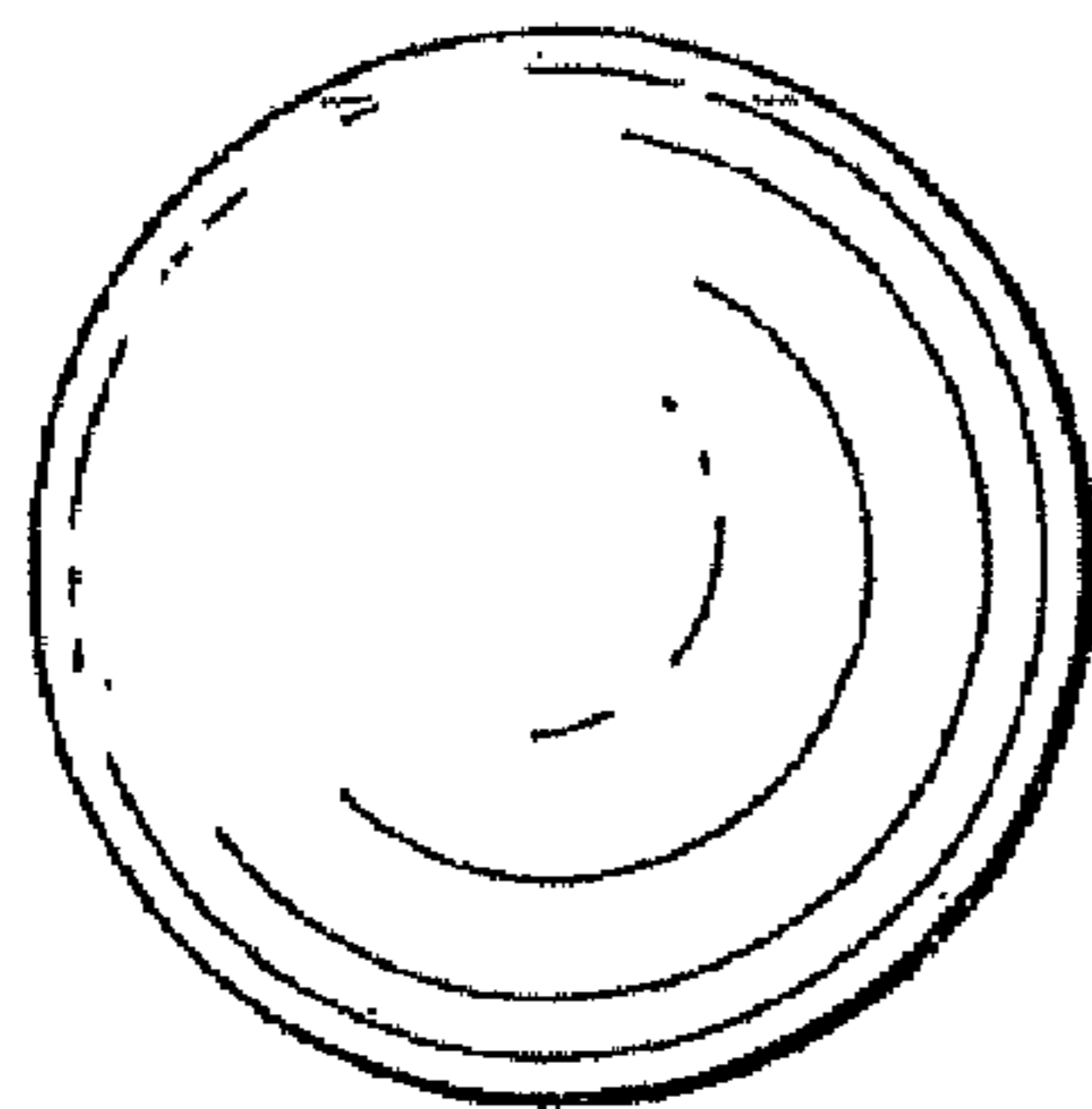
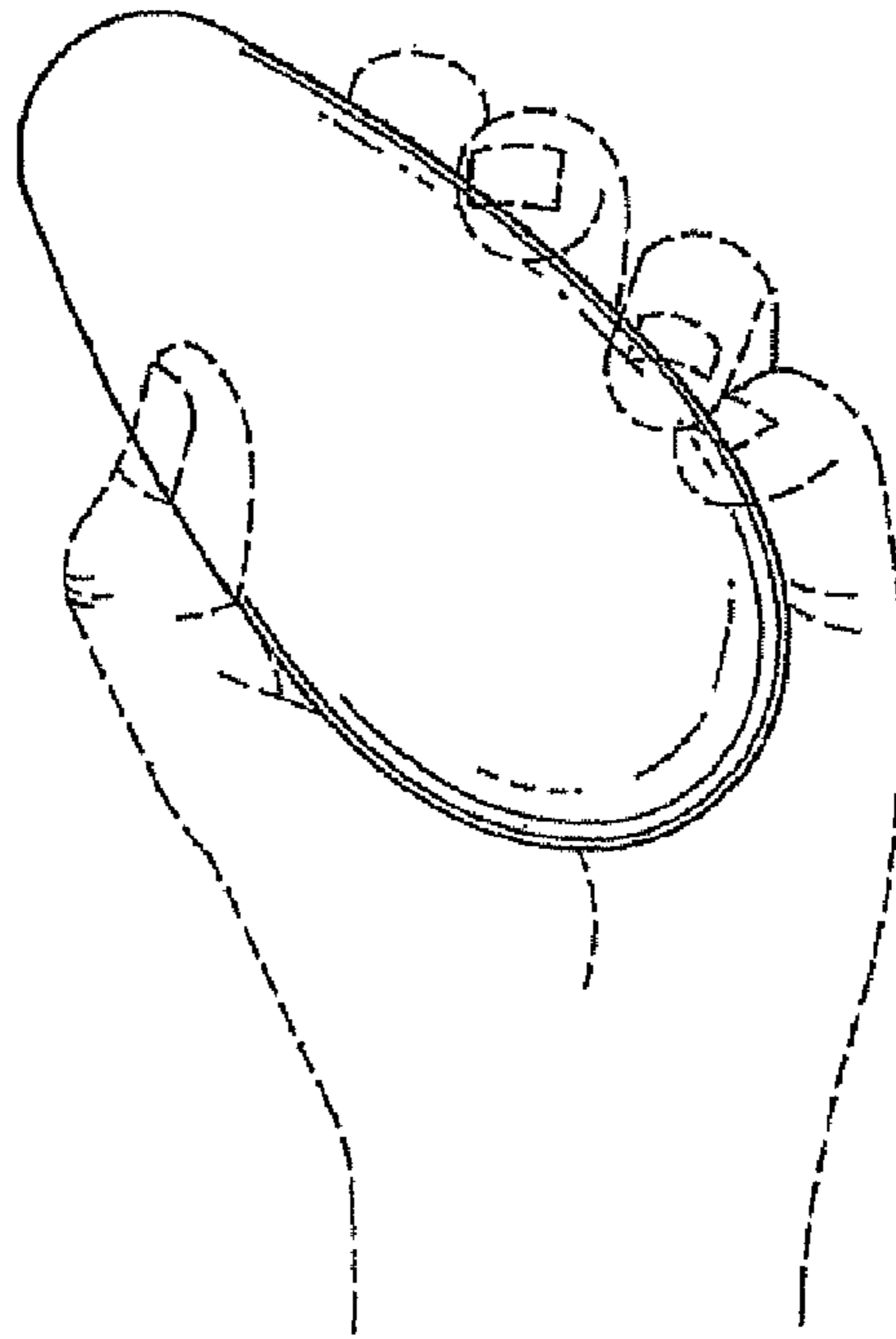

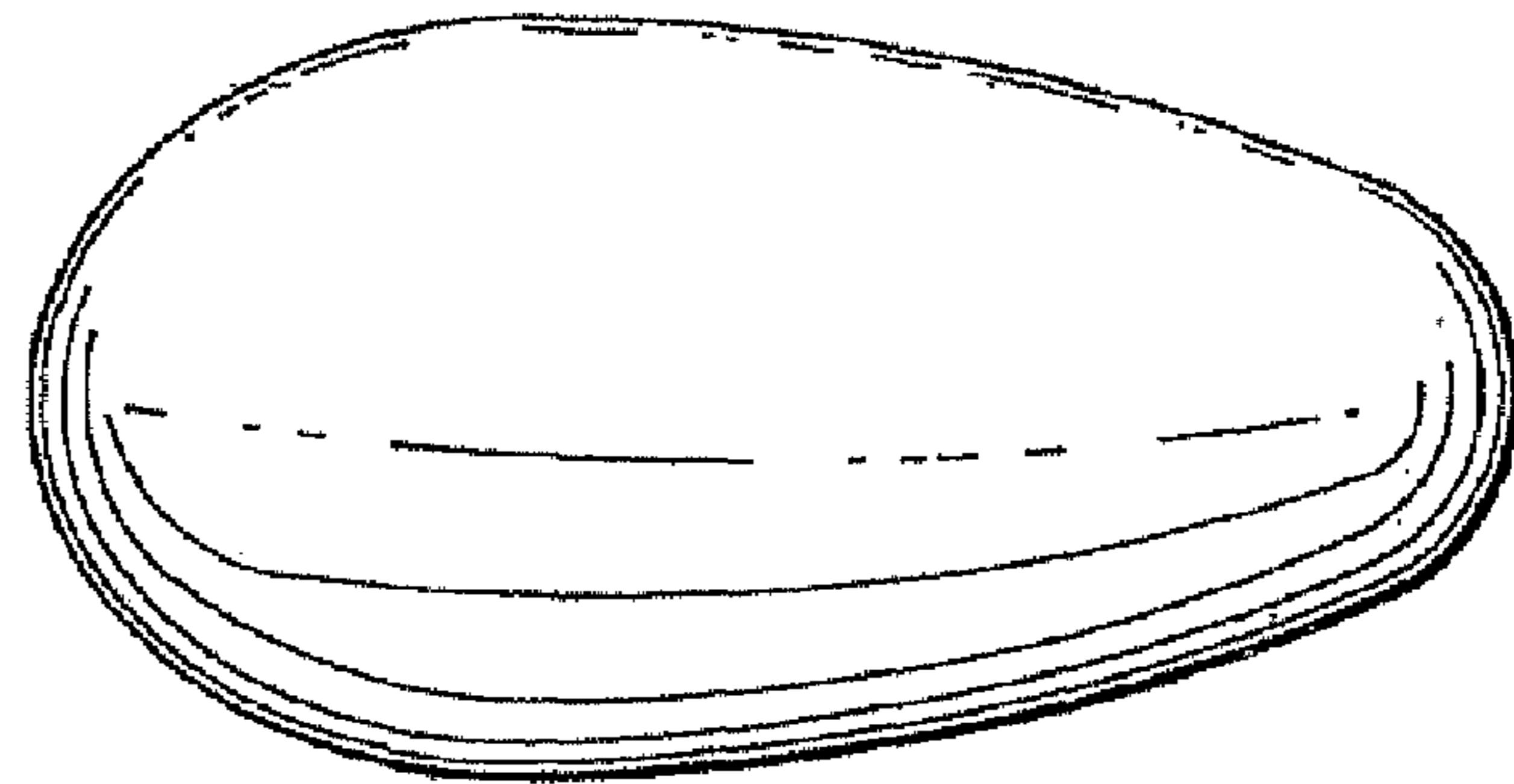

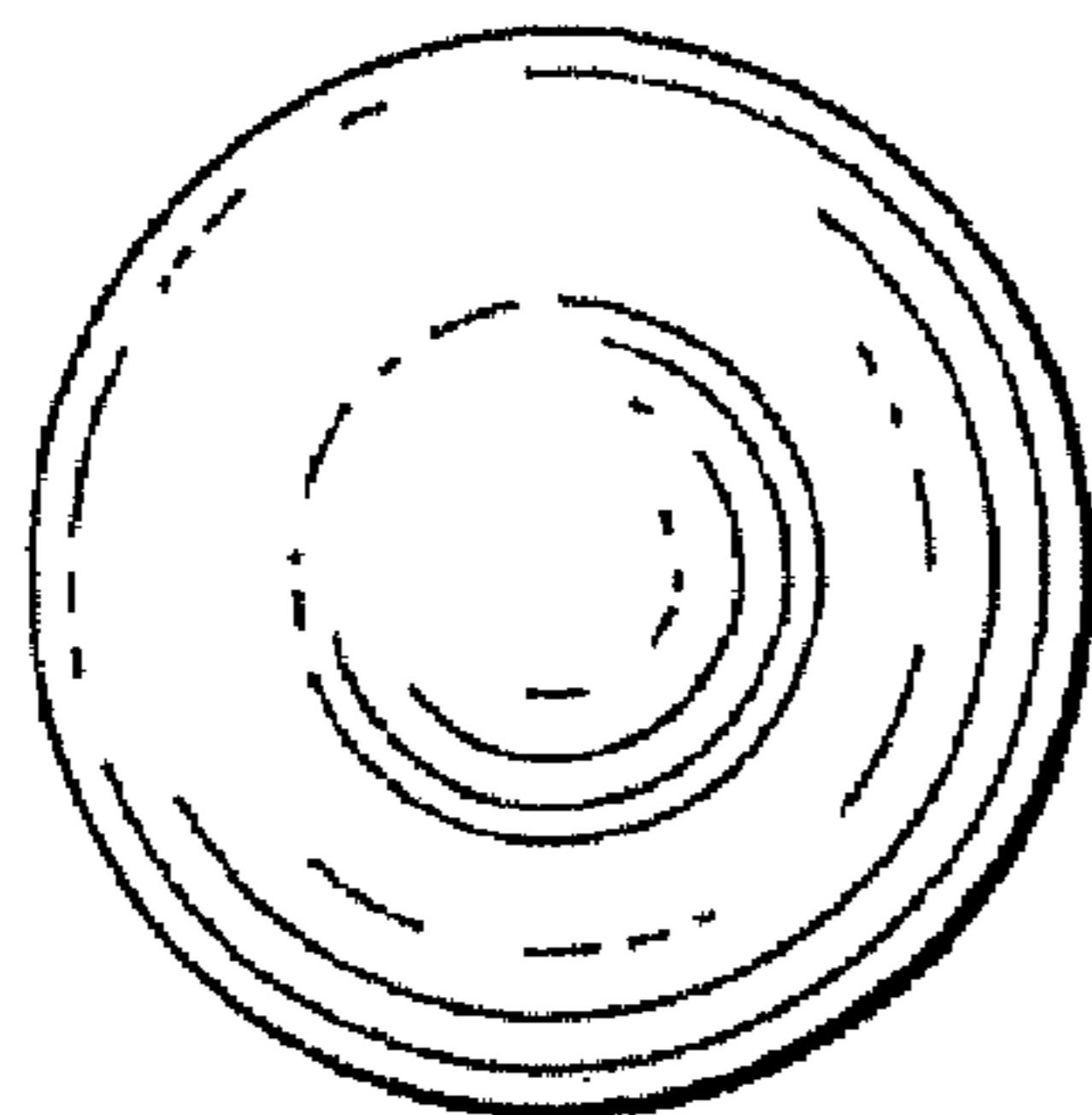

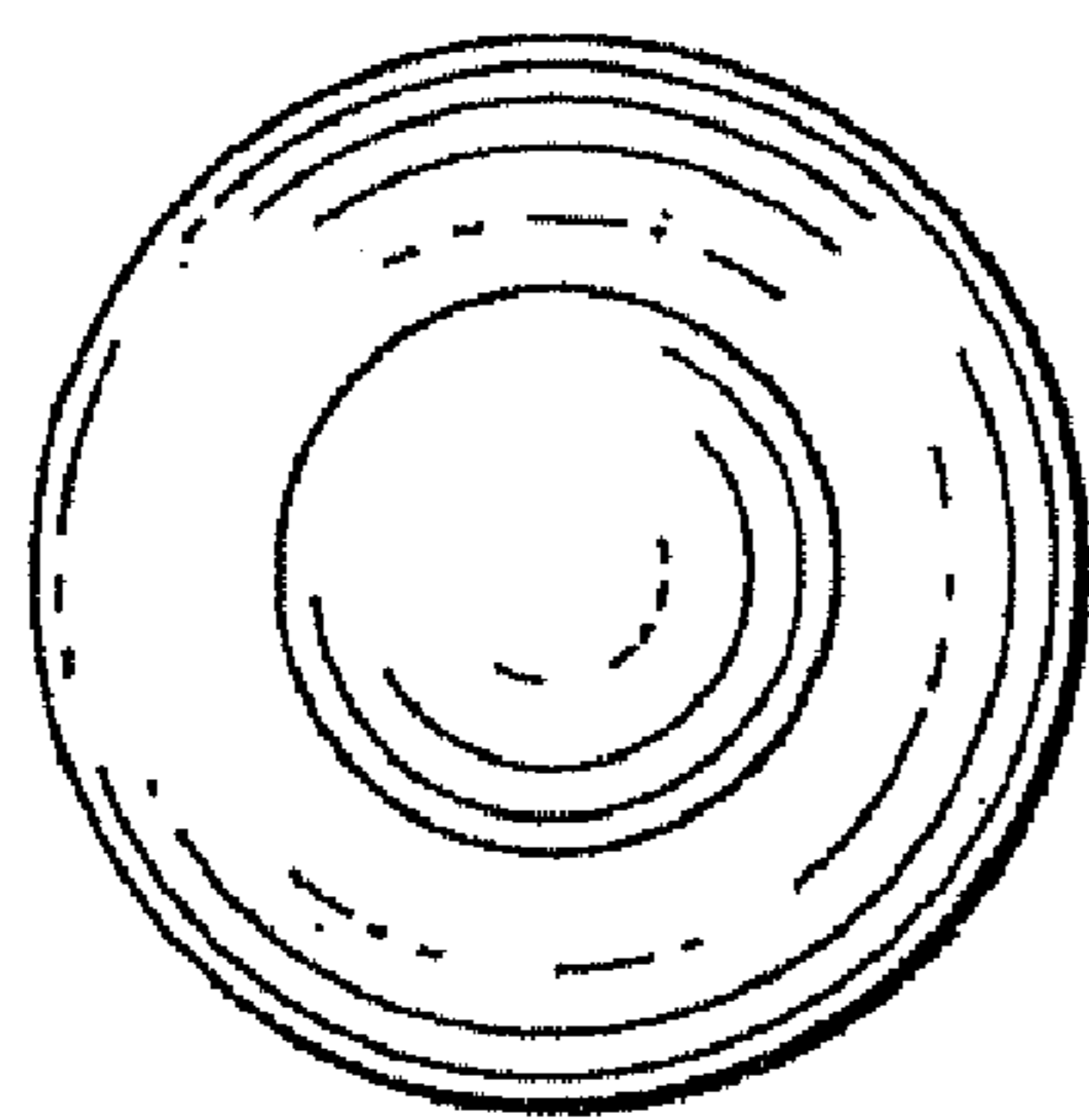
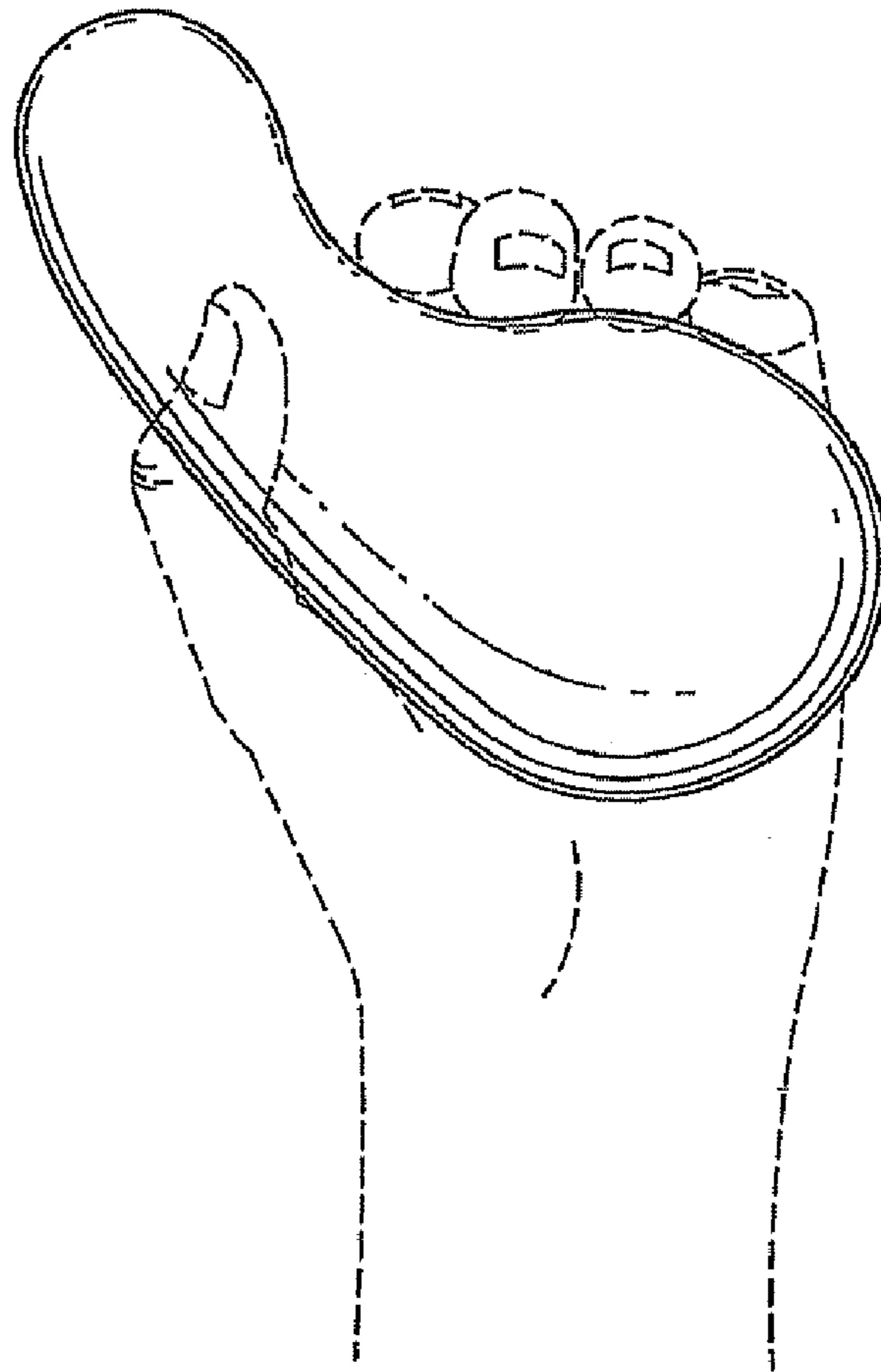

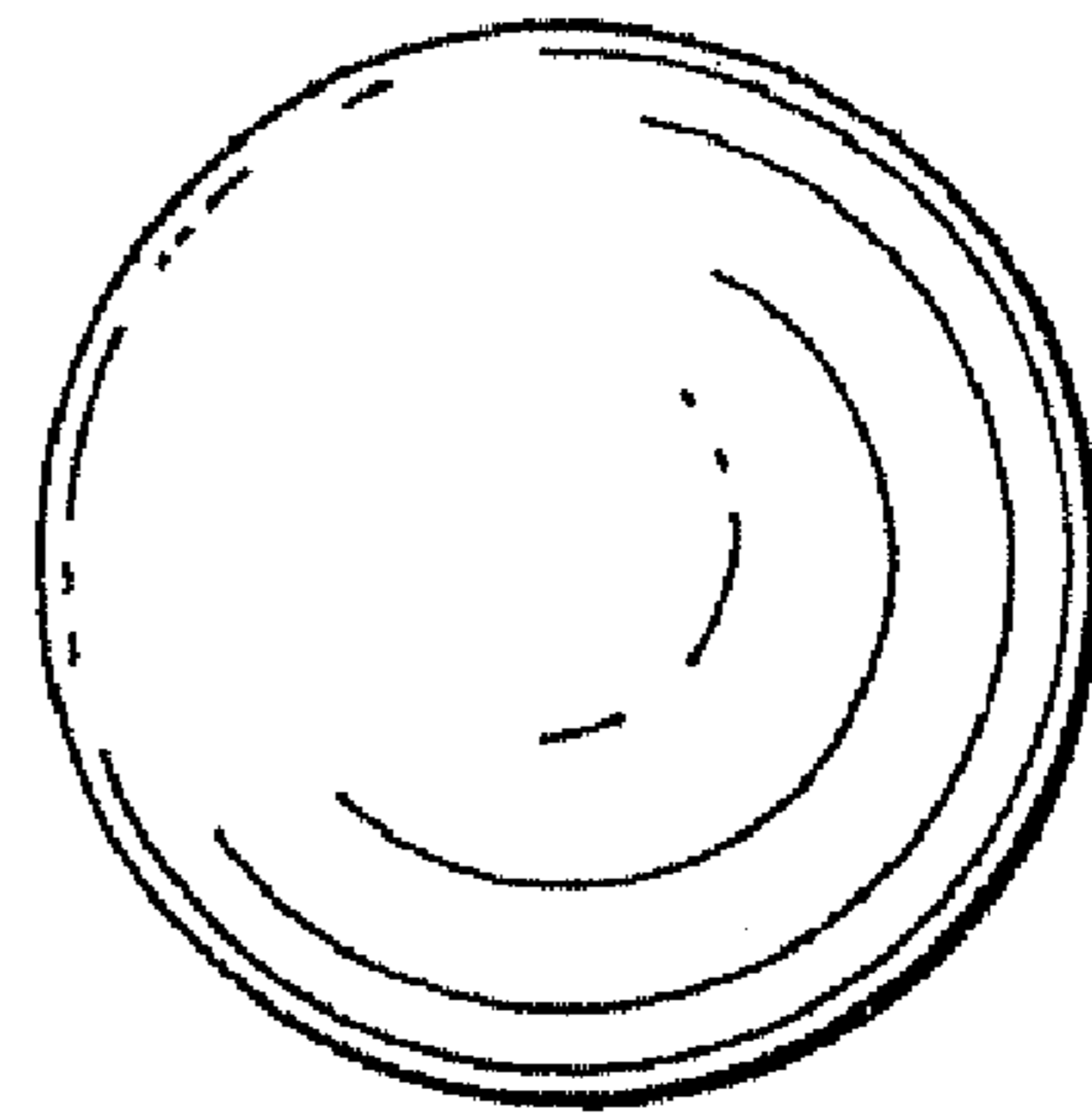

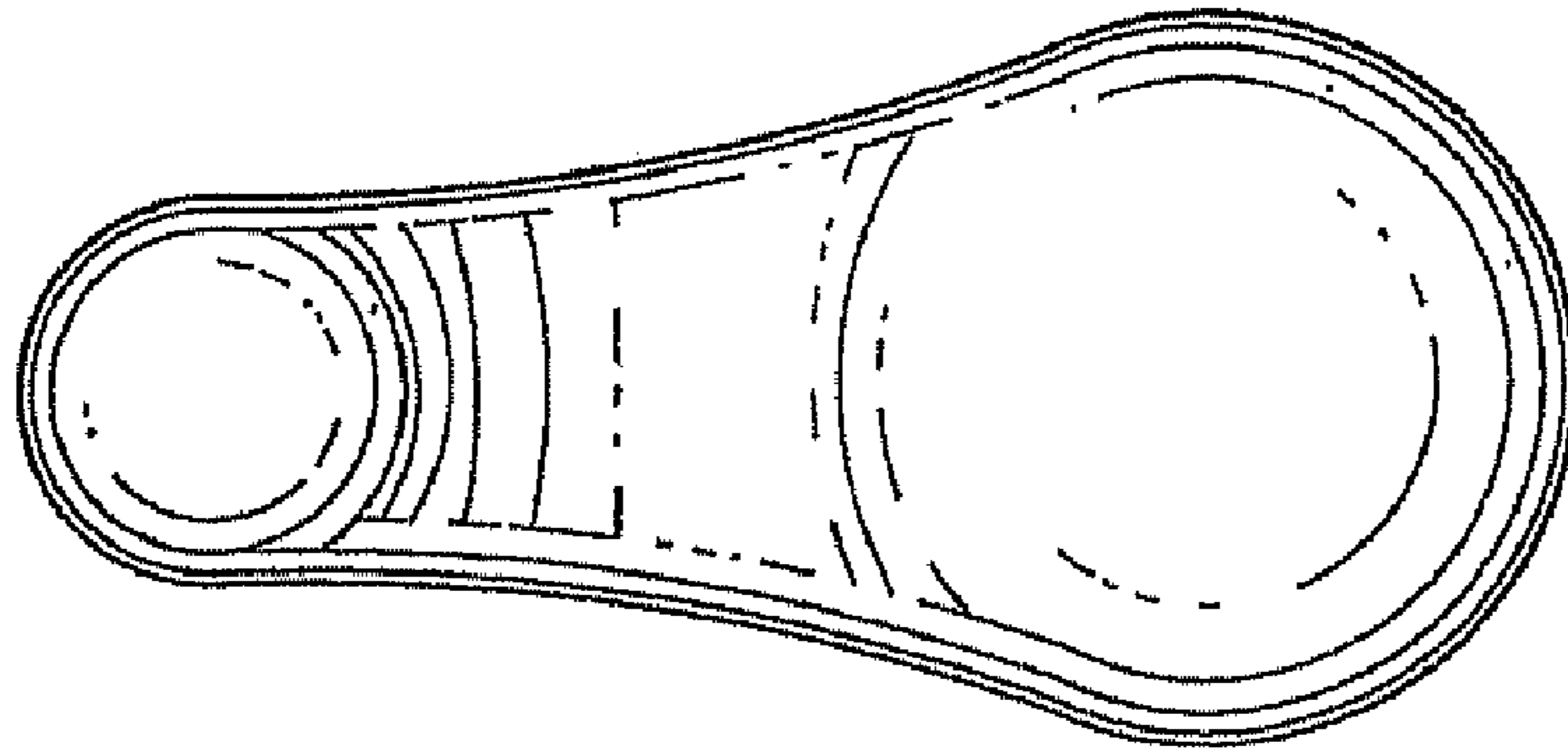

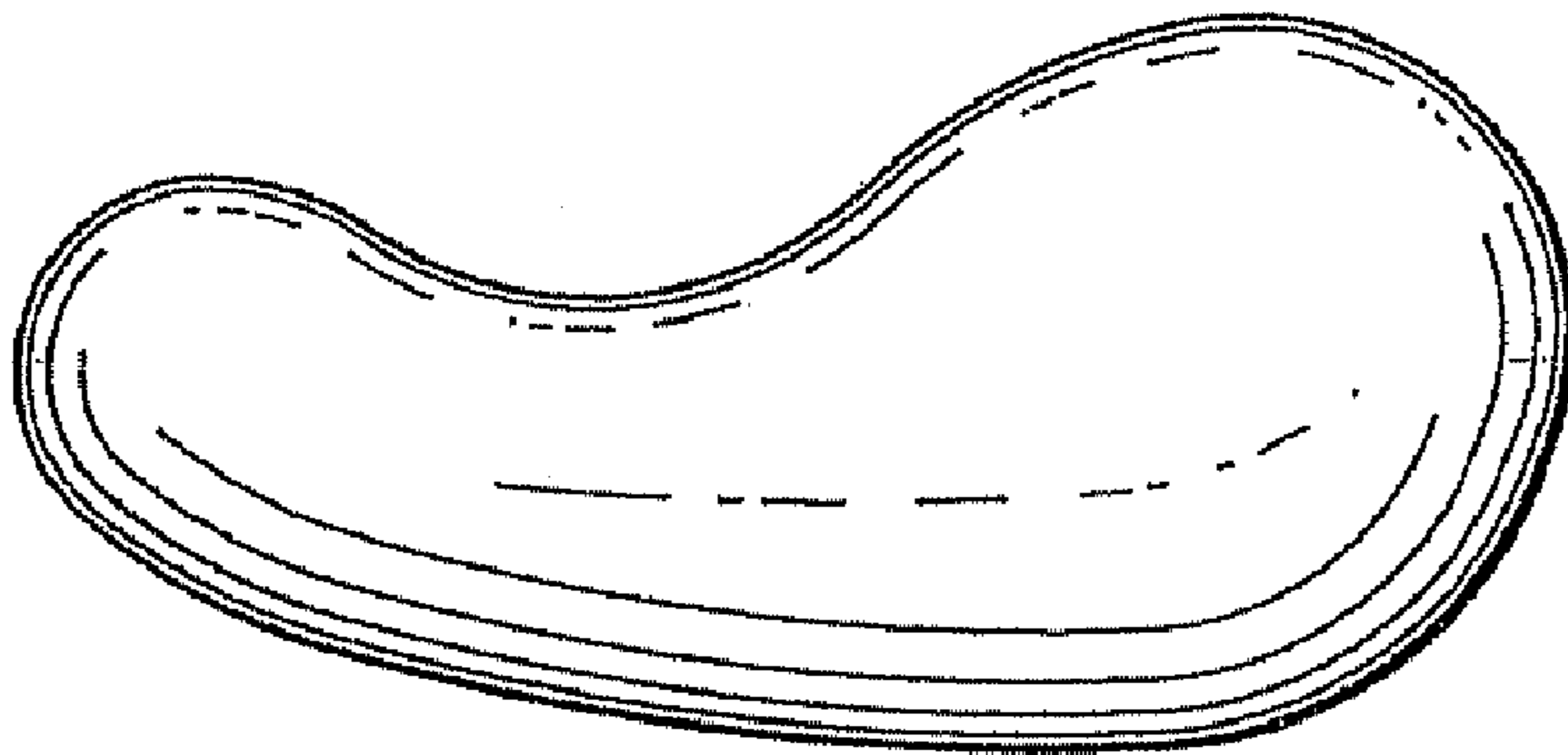

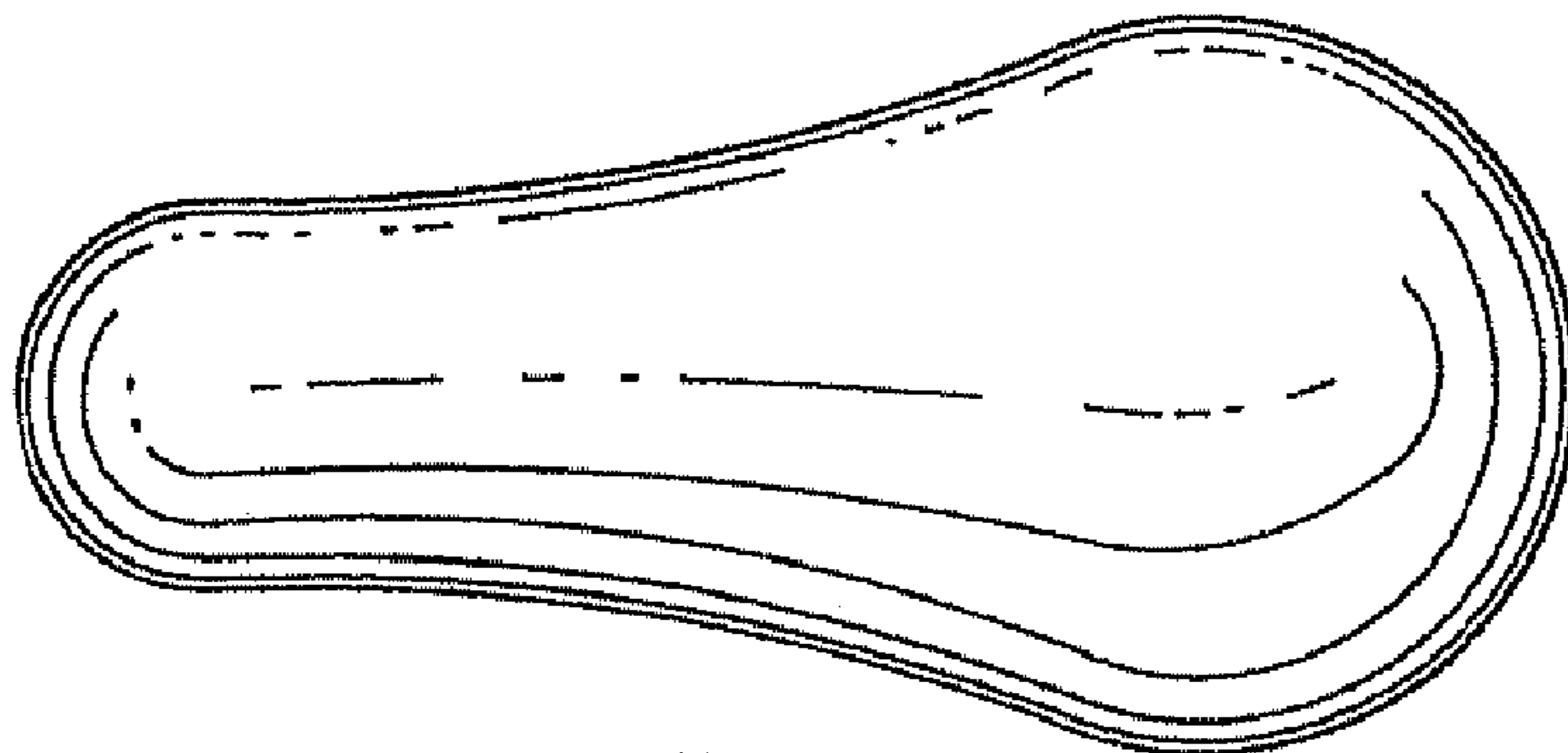

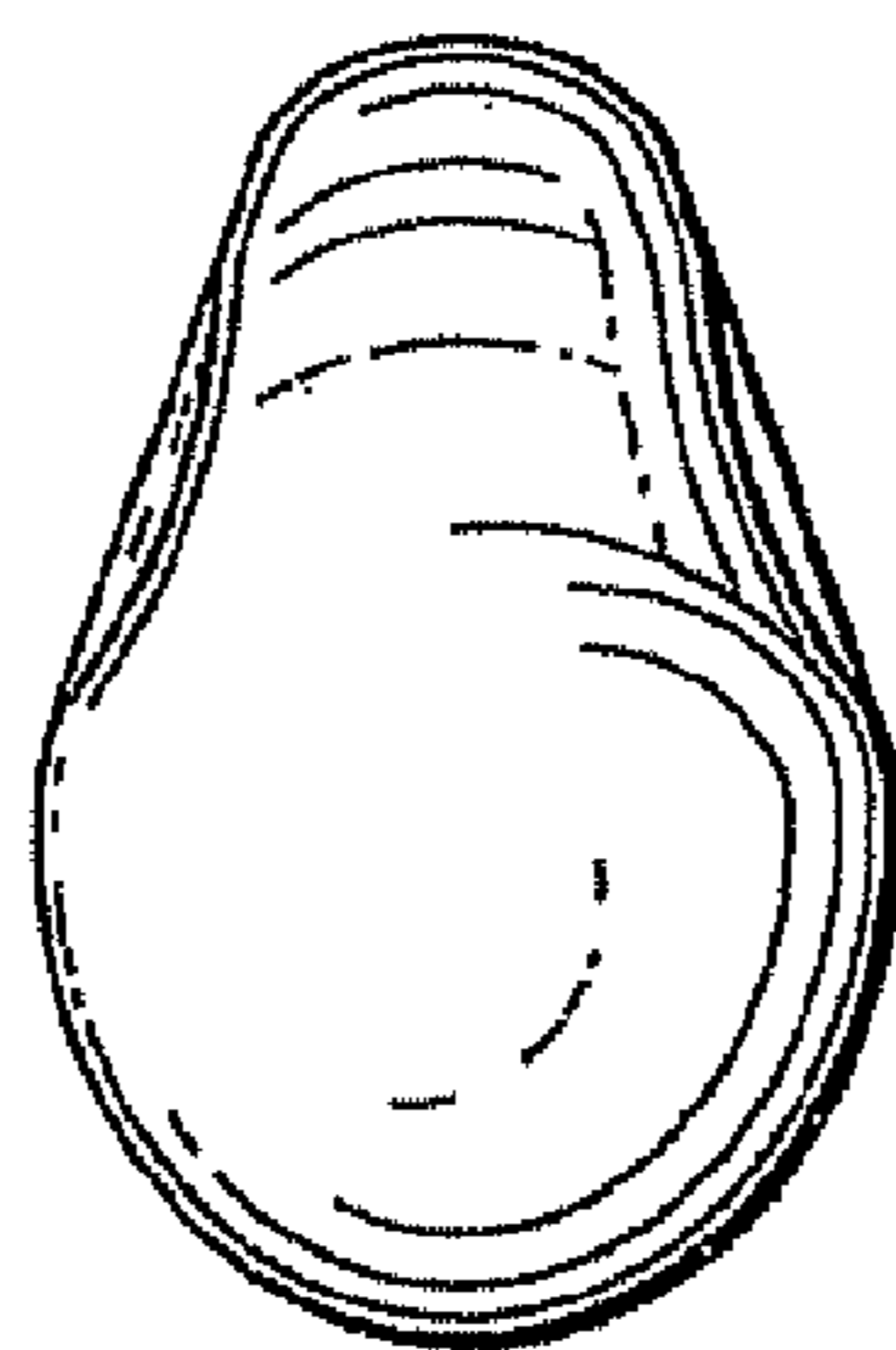
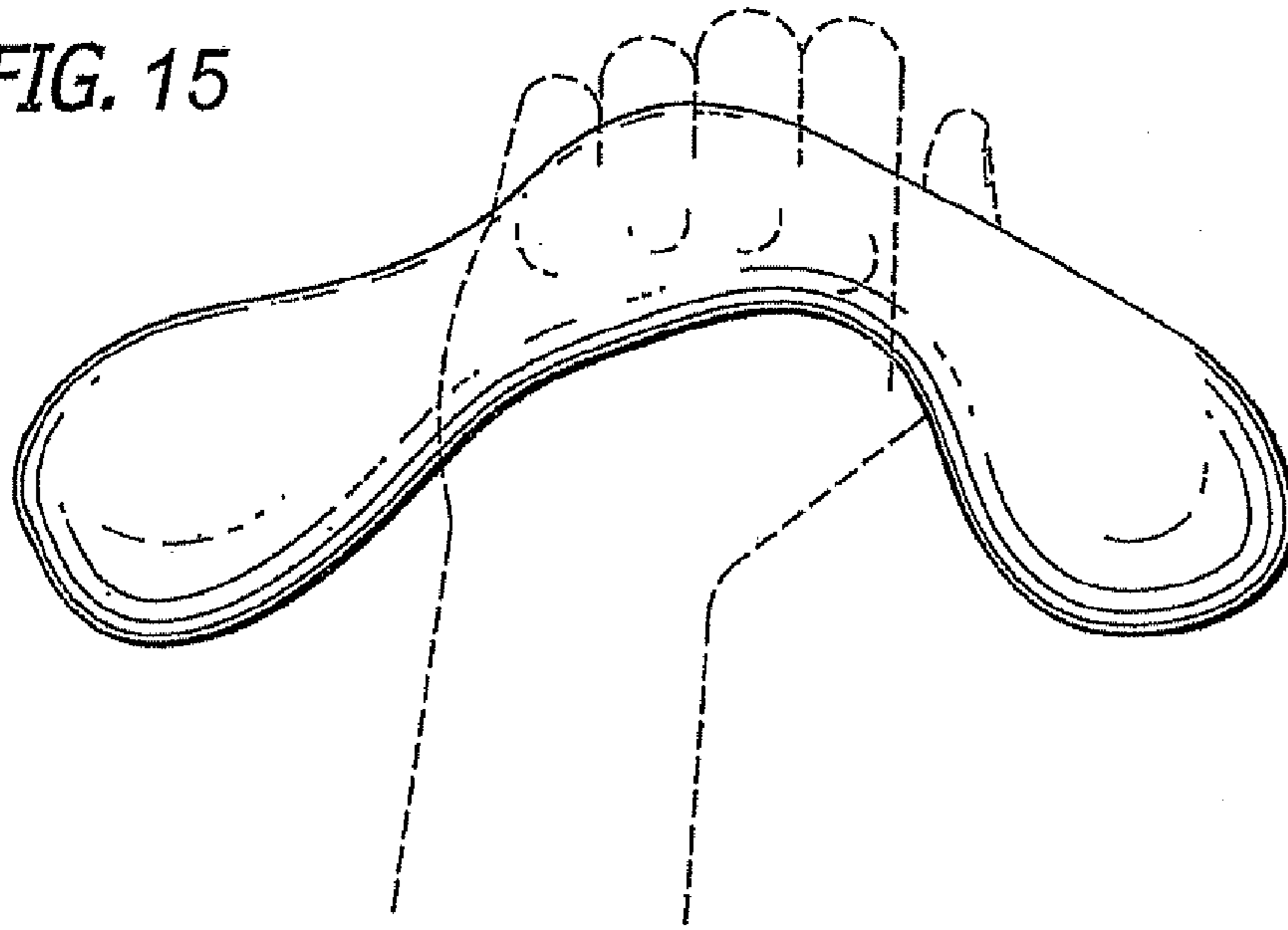

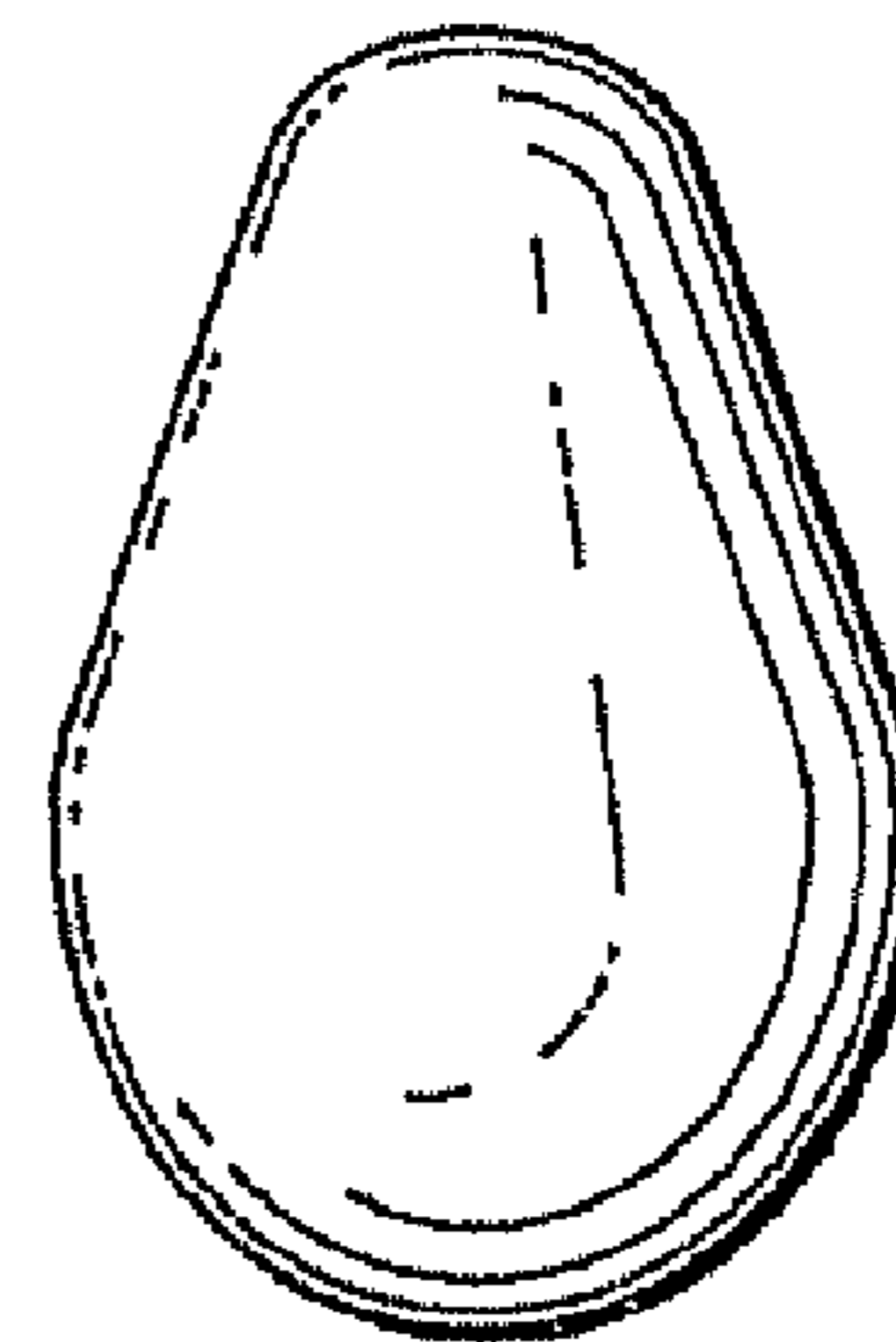

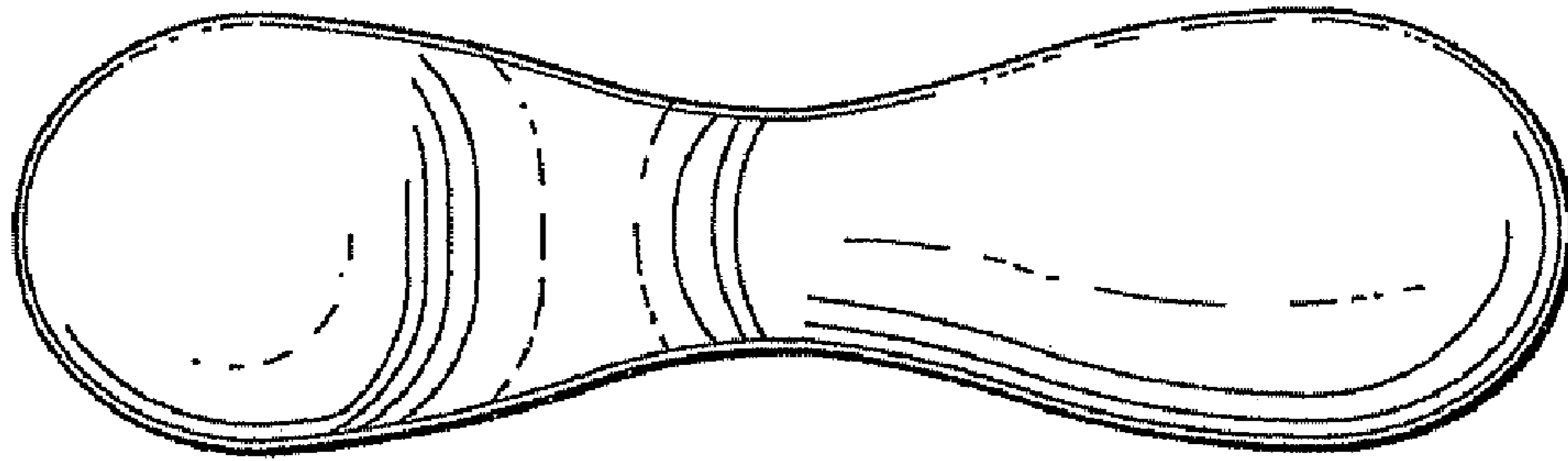

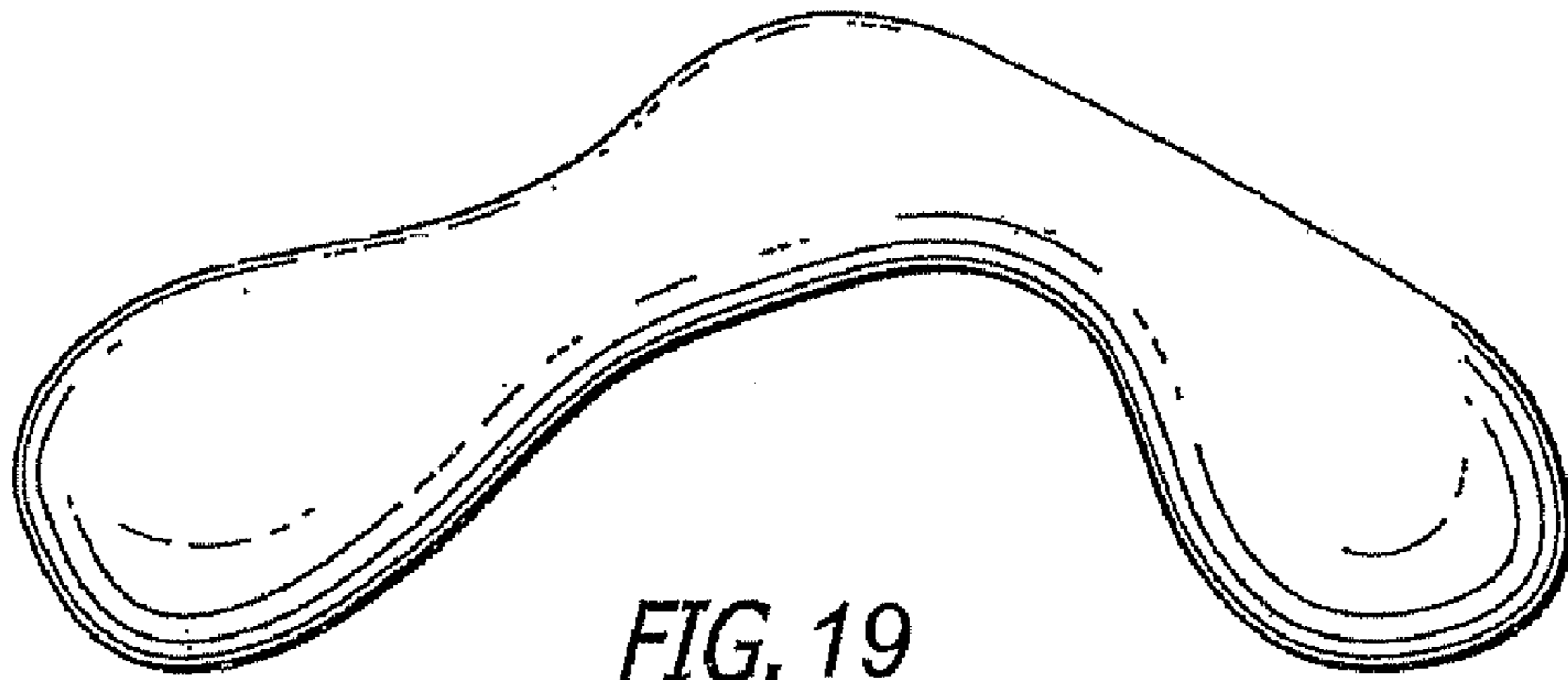

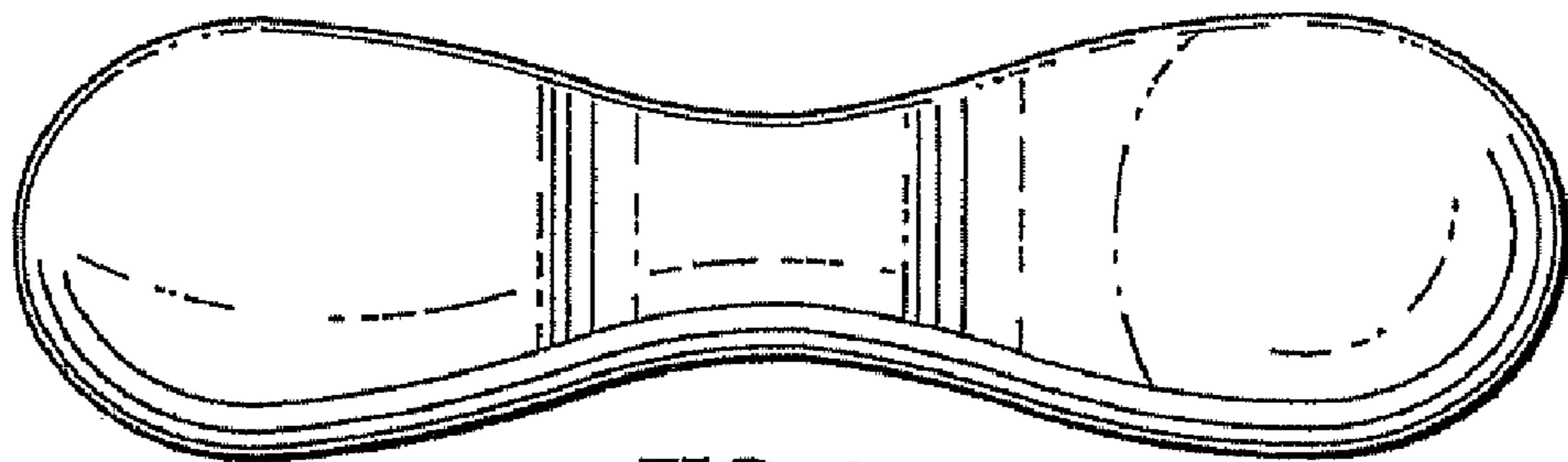
