(57) **CLAIM**

The ornamental design for a set of billiard balls and pocket markers, as shown and described.

DESCRIPTION

FIG. 1 is a top view of one embodiment of a set of billiard balls and pocket markers, showing the new design;

FIG. 16 is a perspective view of FIG. 10;

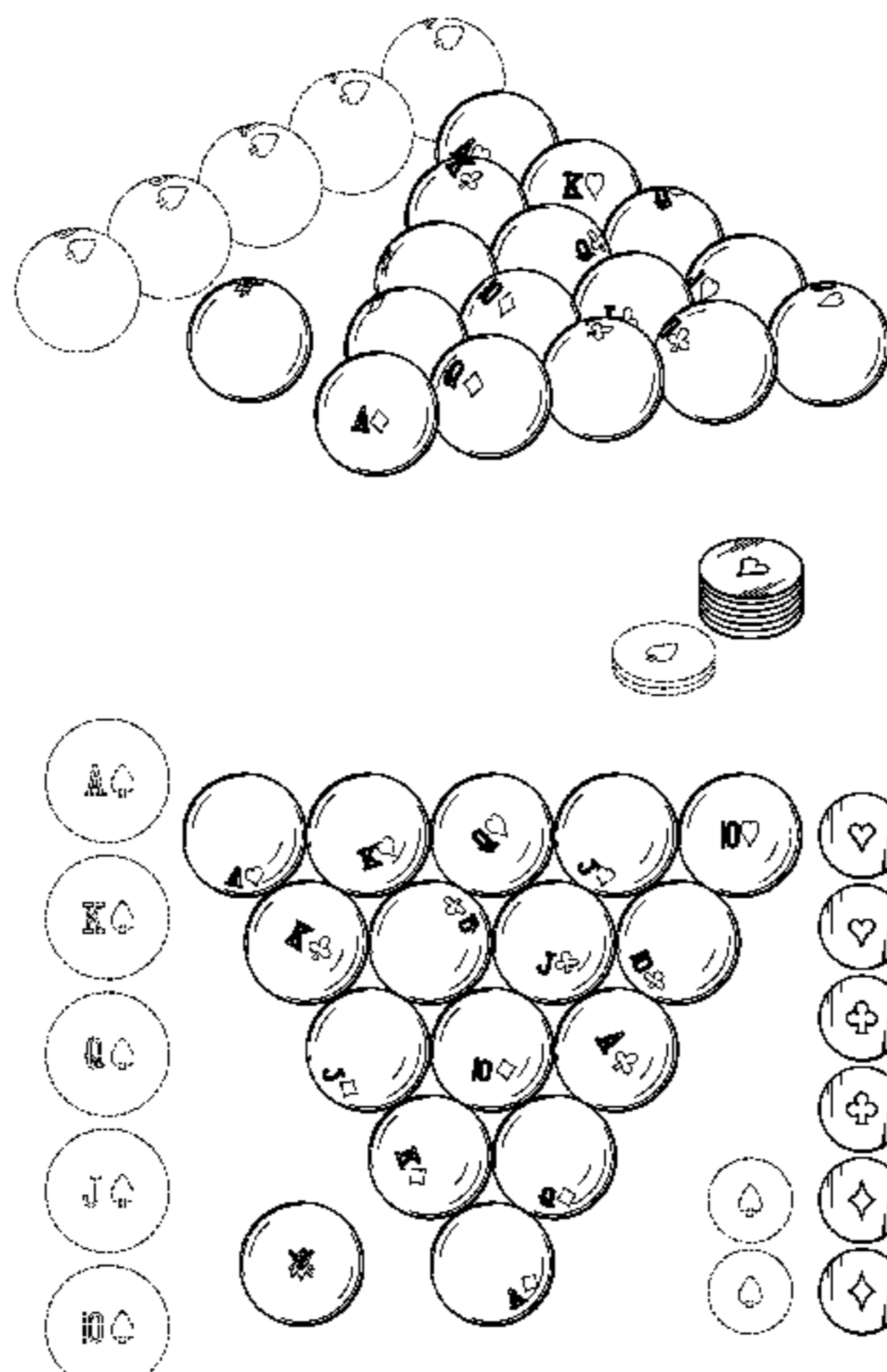
FIG. 17 is a top view showing the embodiment of FIG. 8 with the markers in an alternate position;

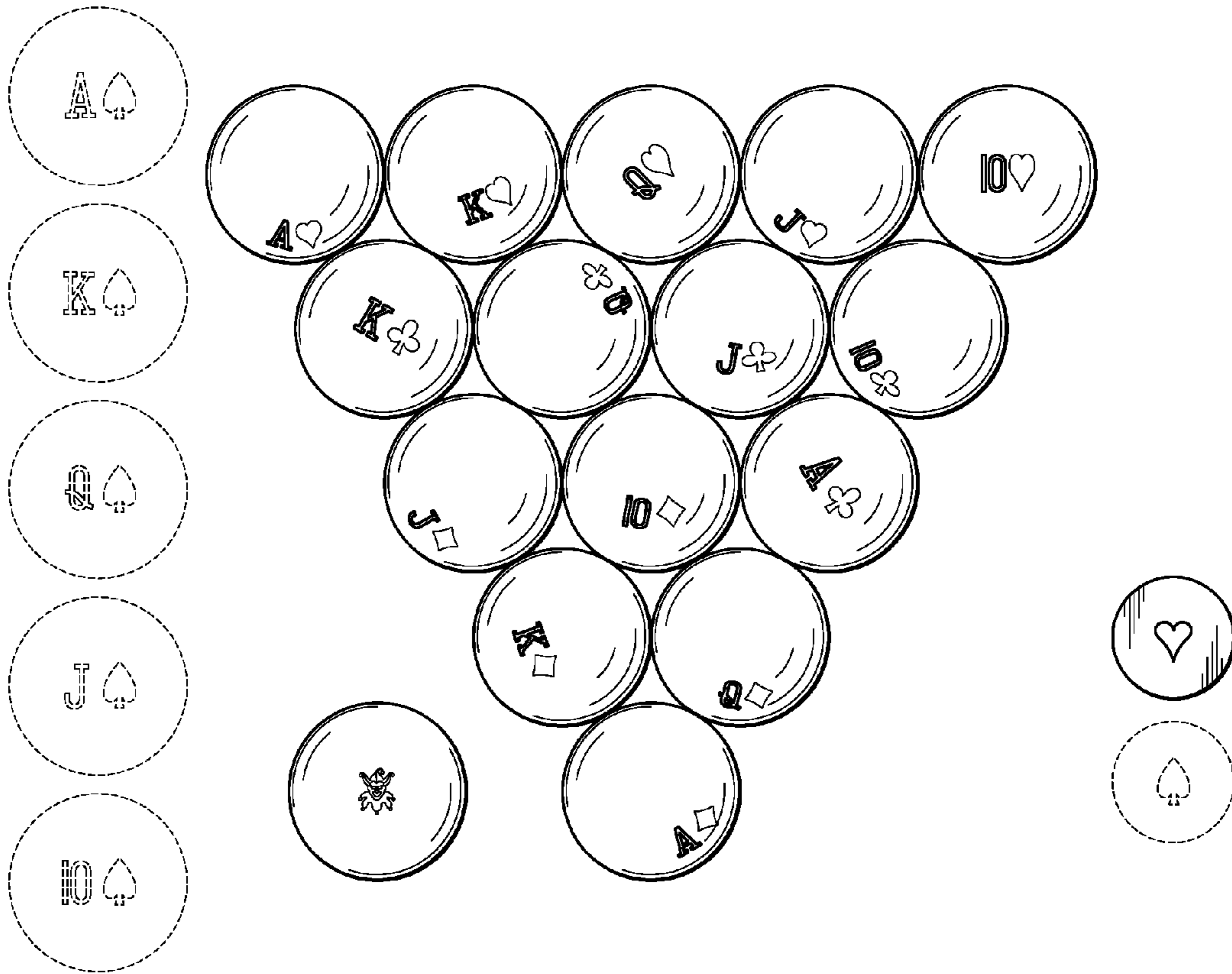

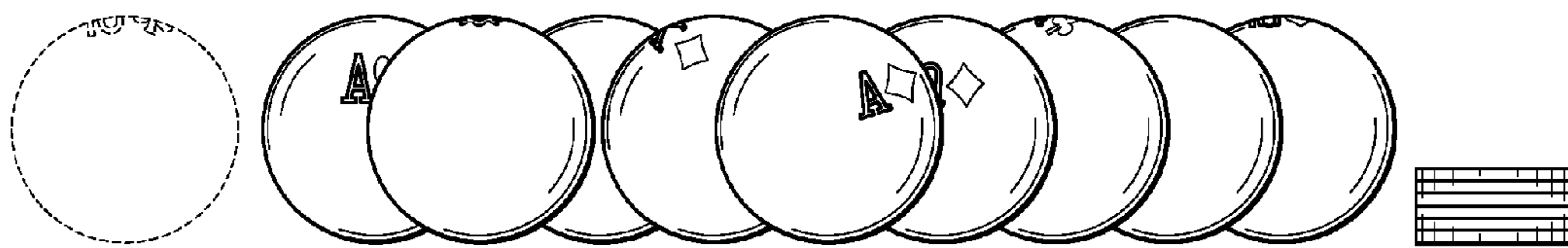
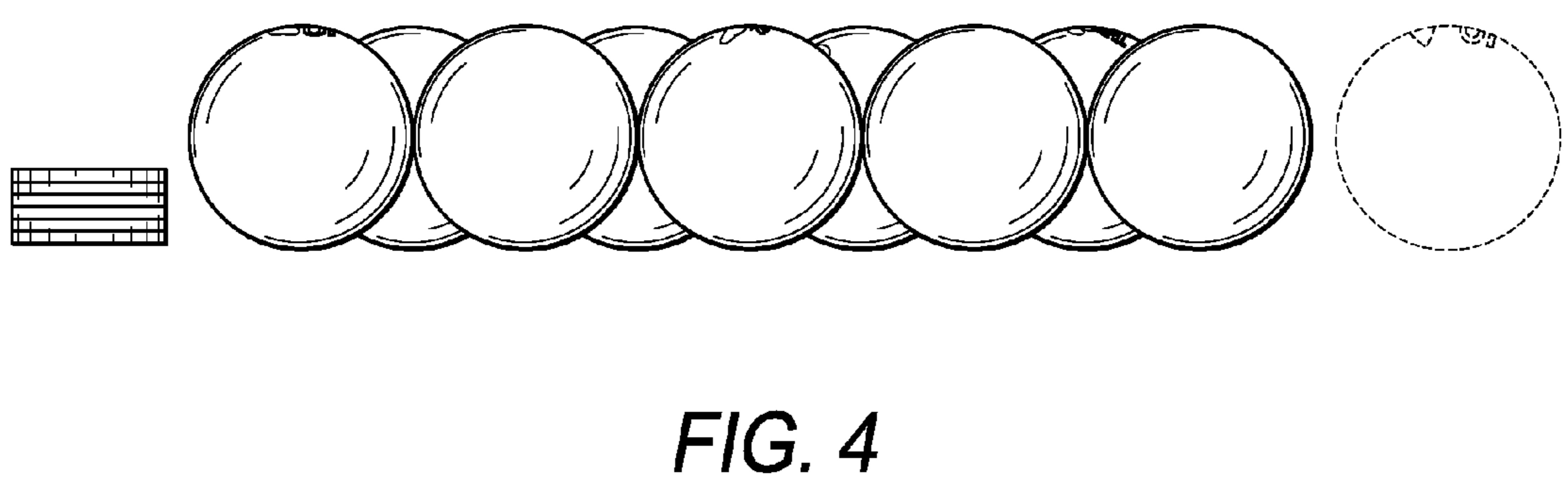
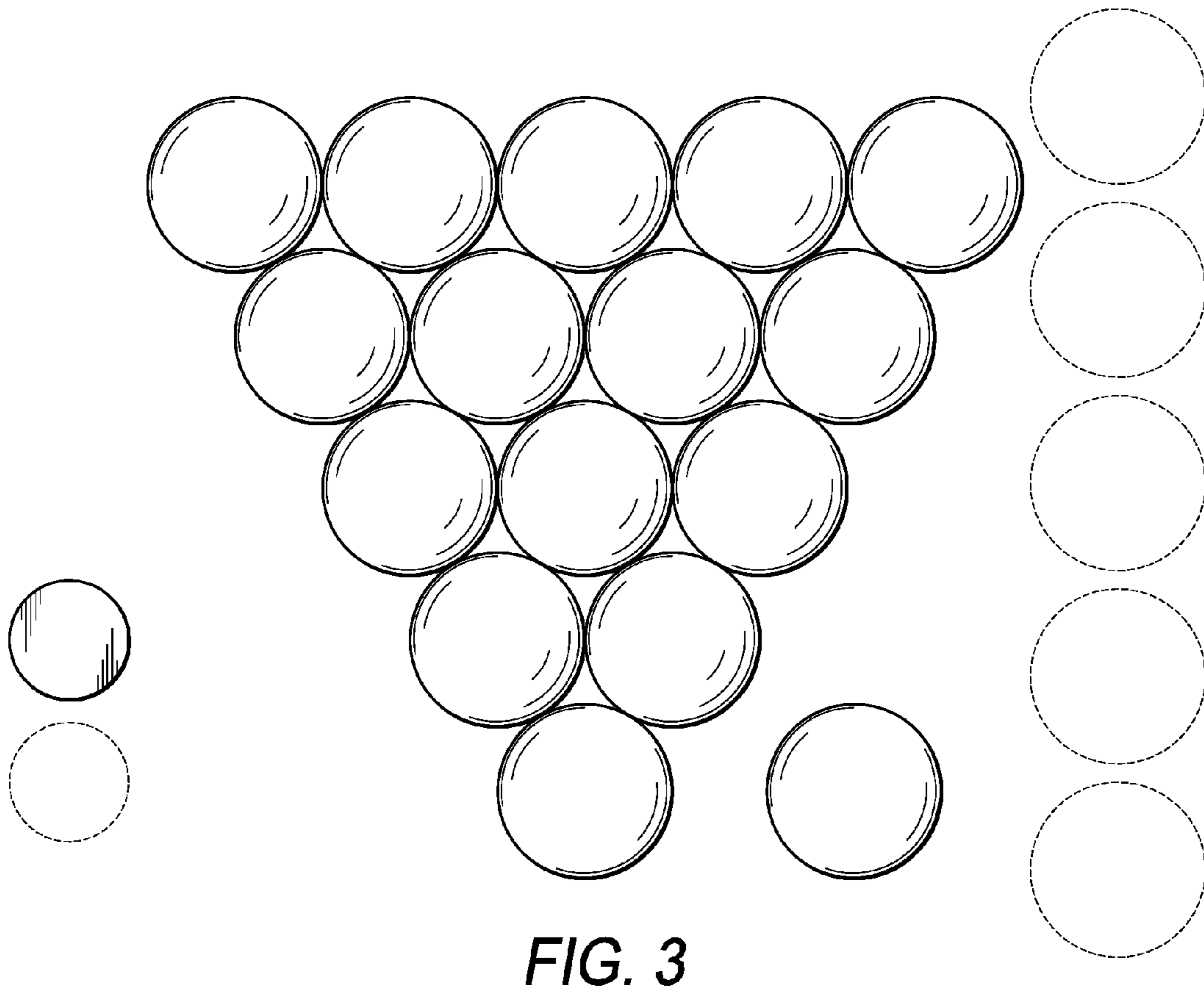

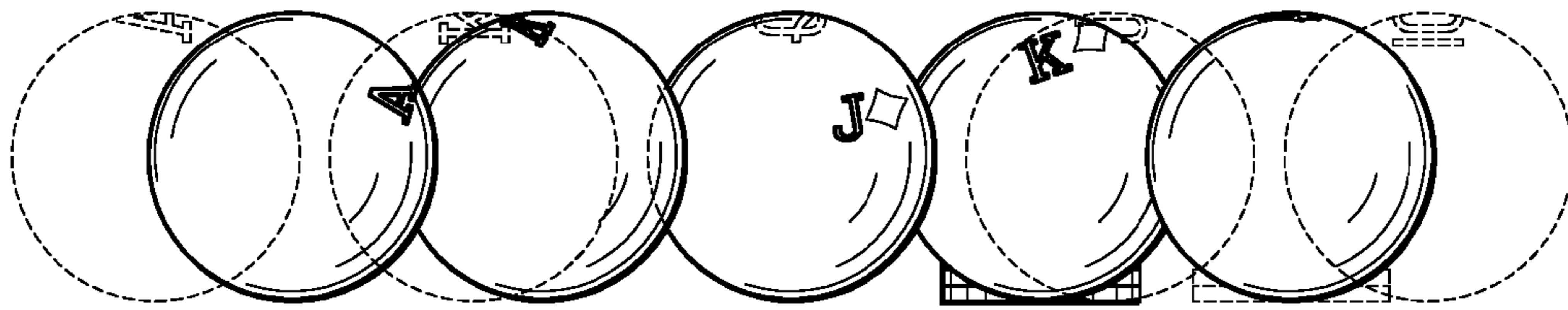

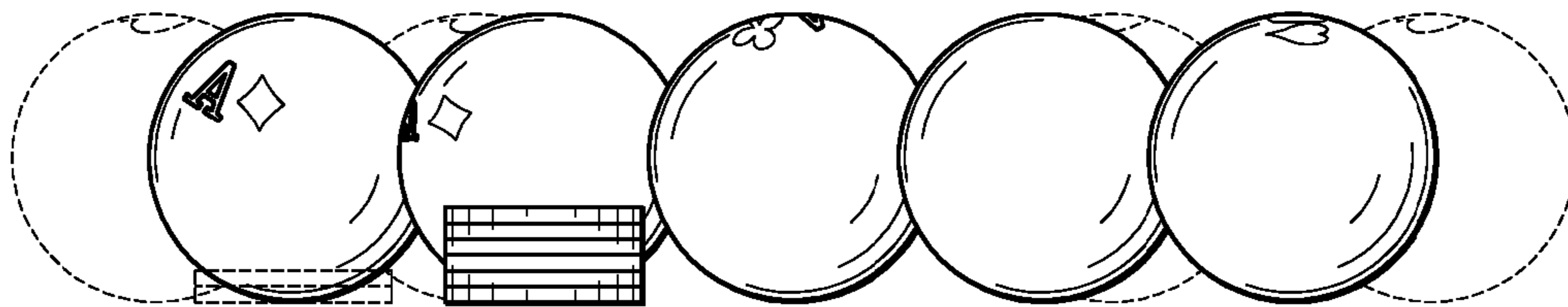
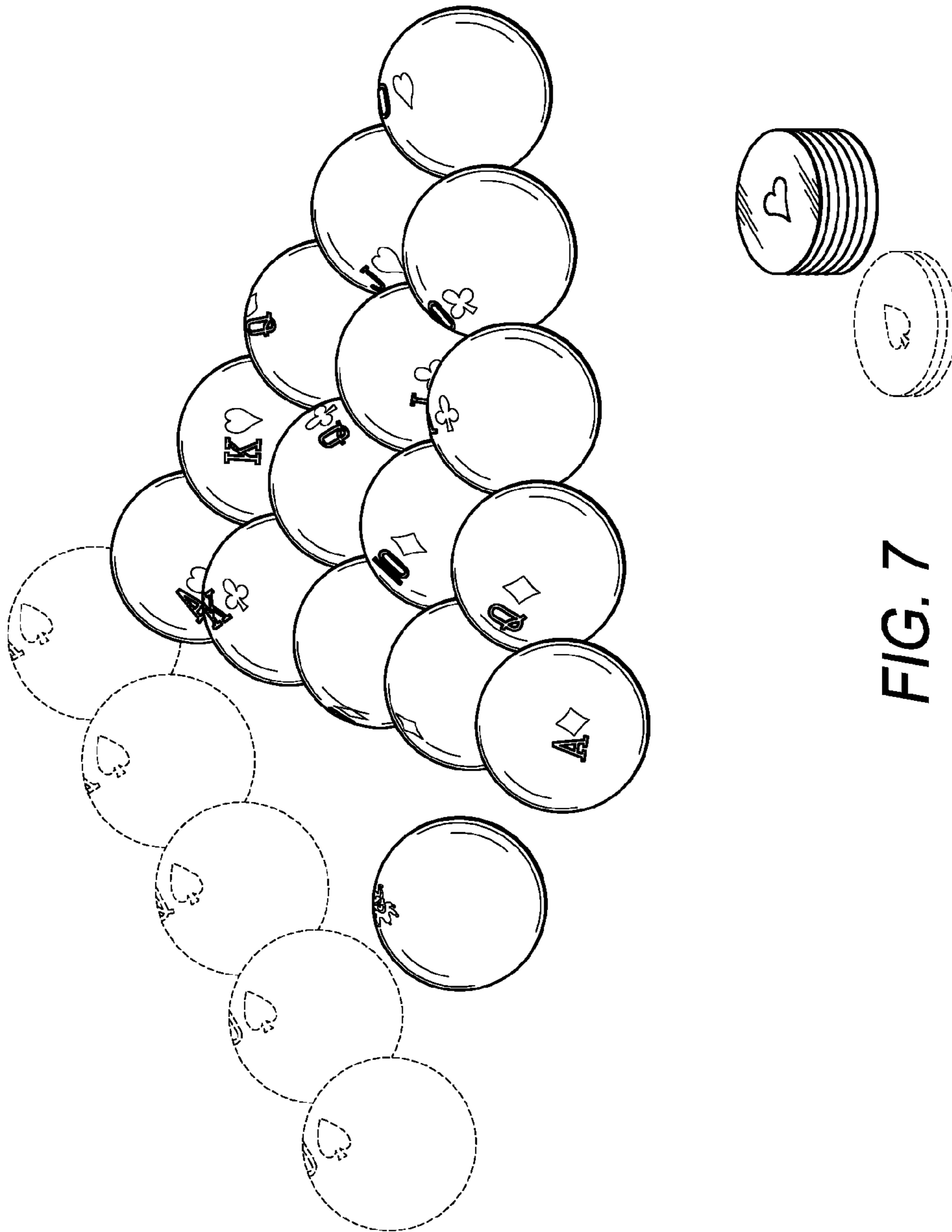

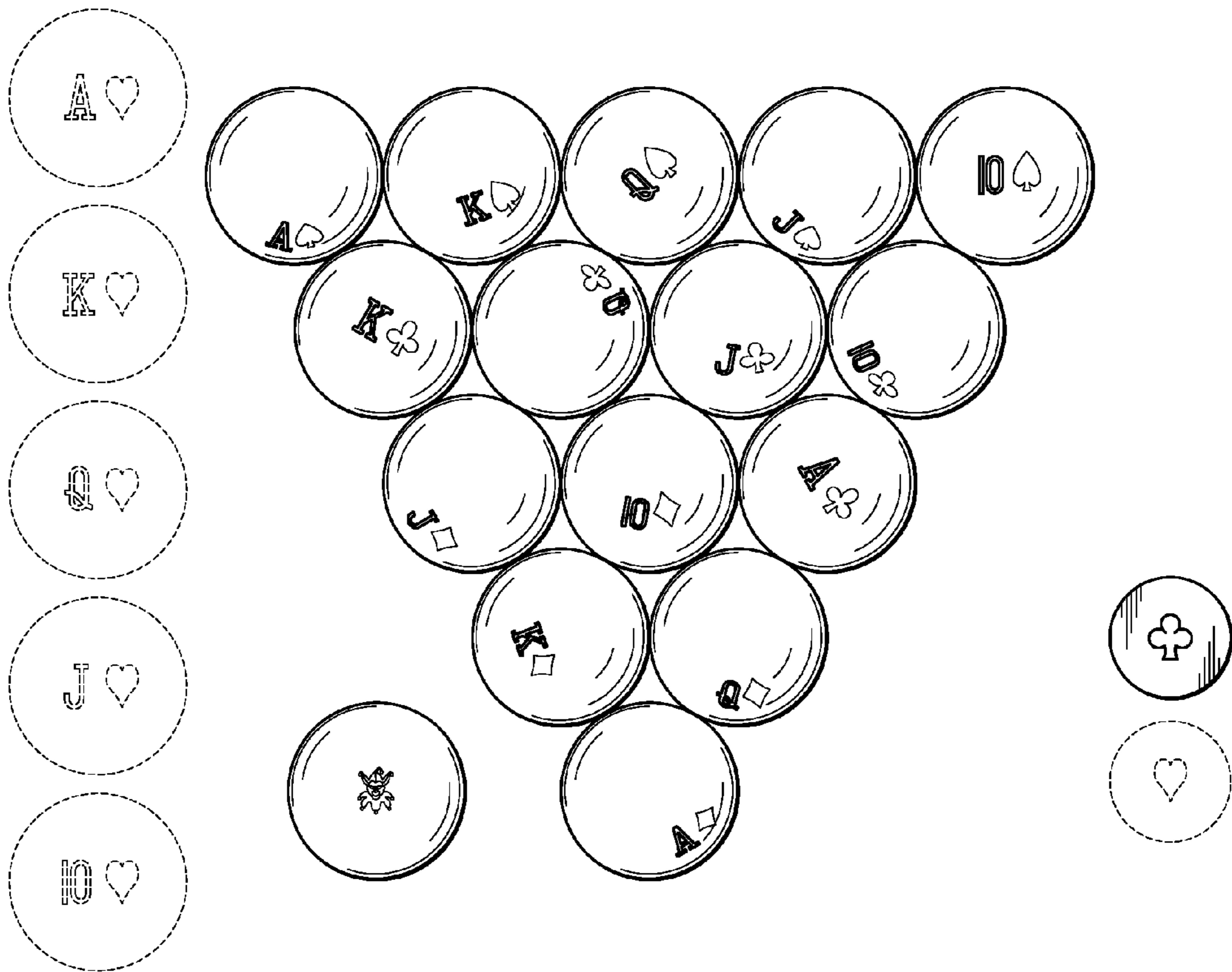

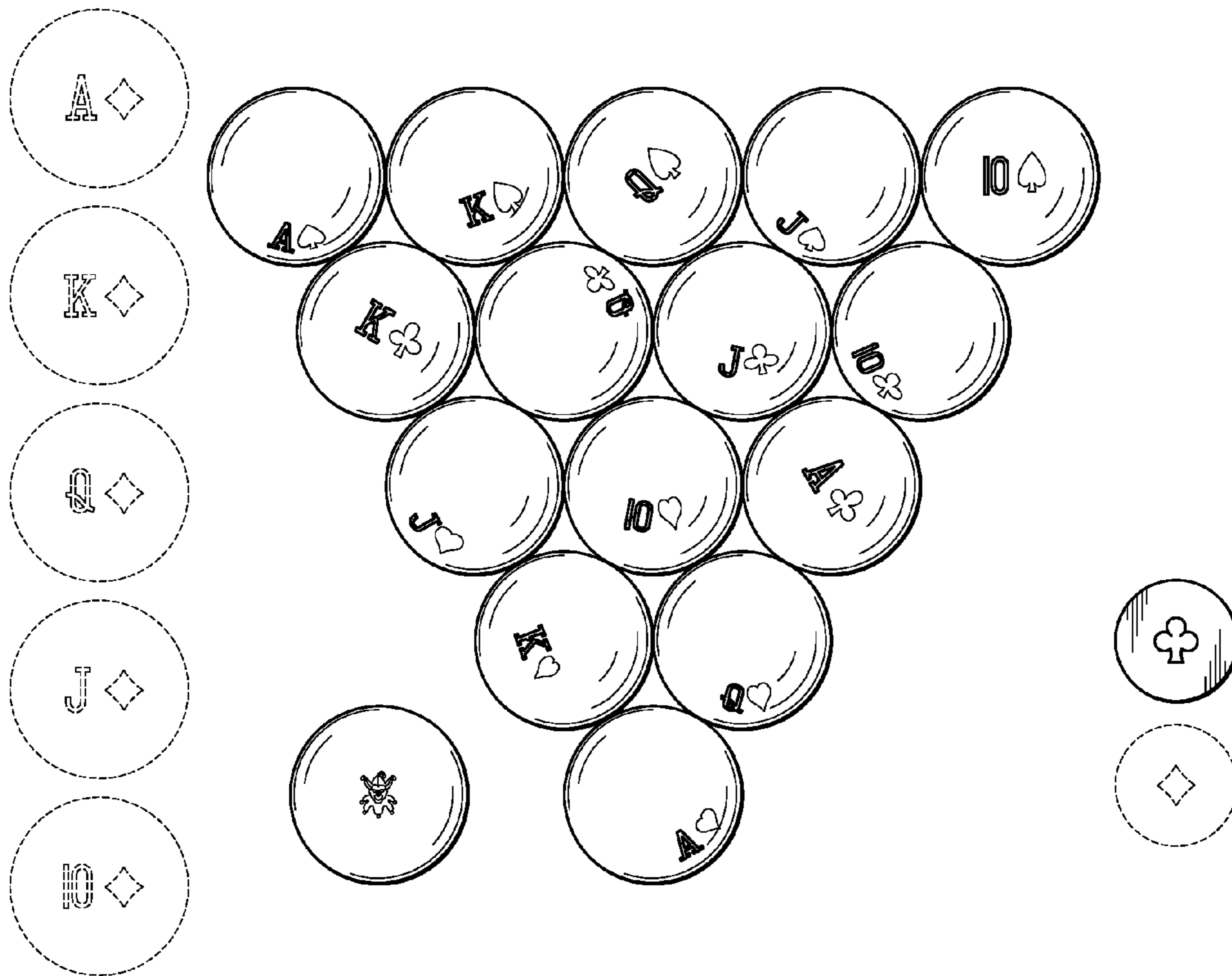

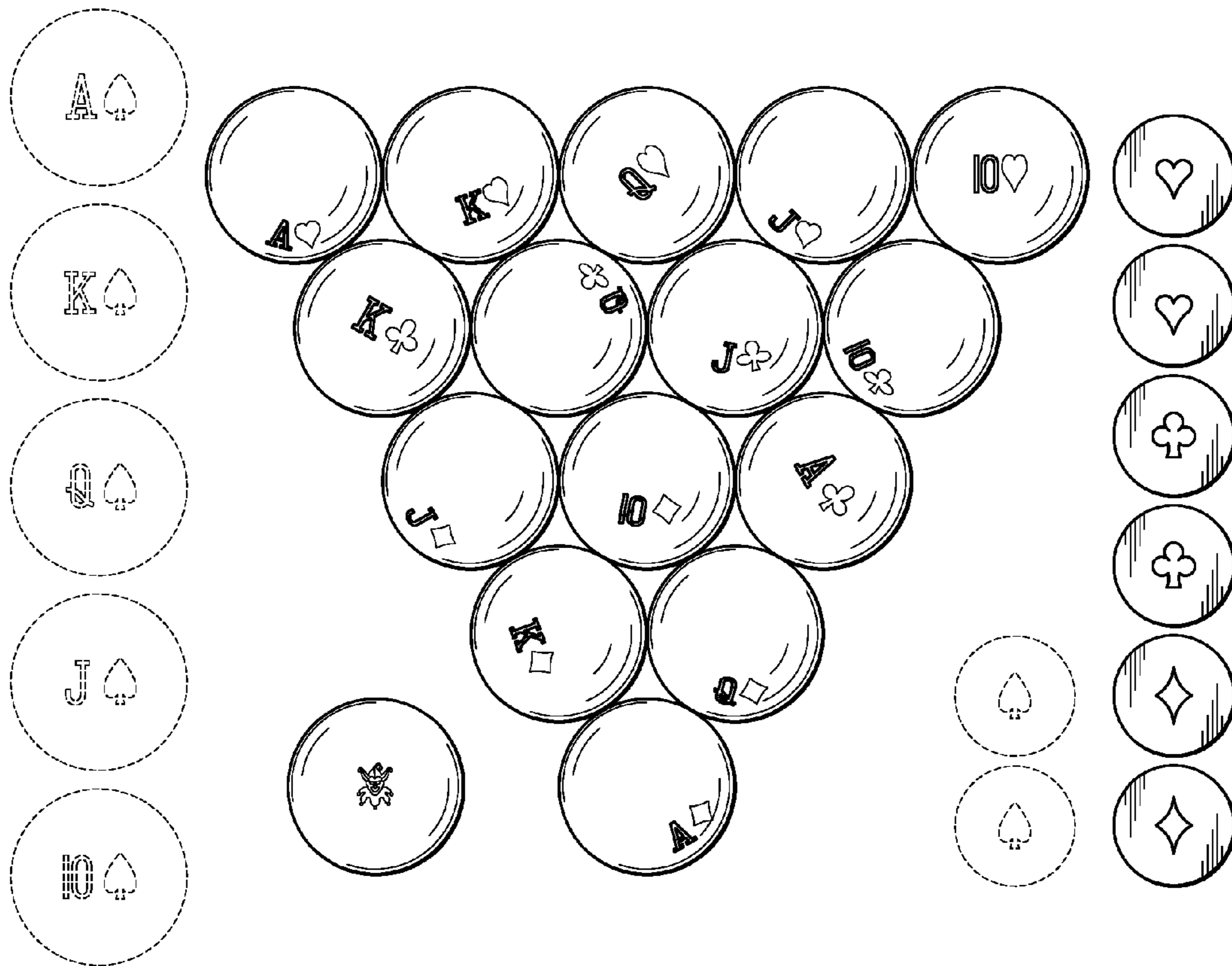

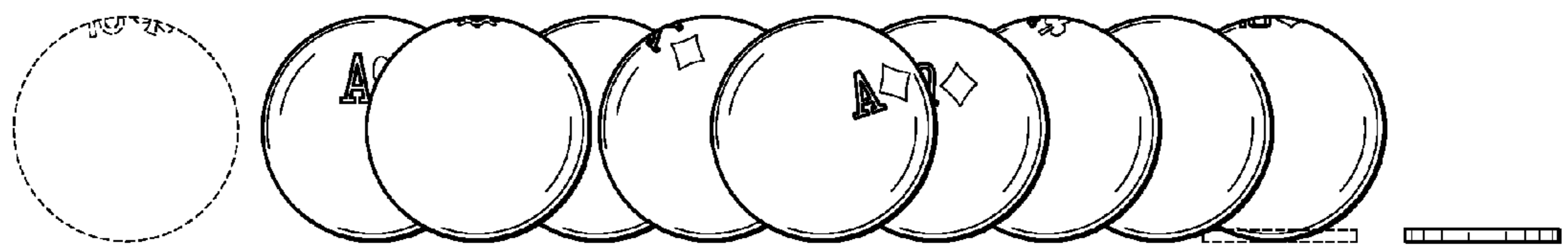

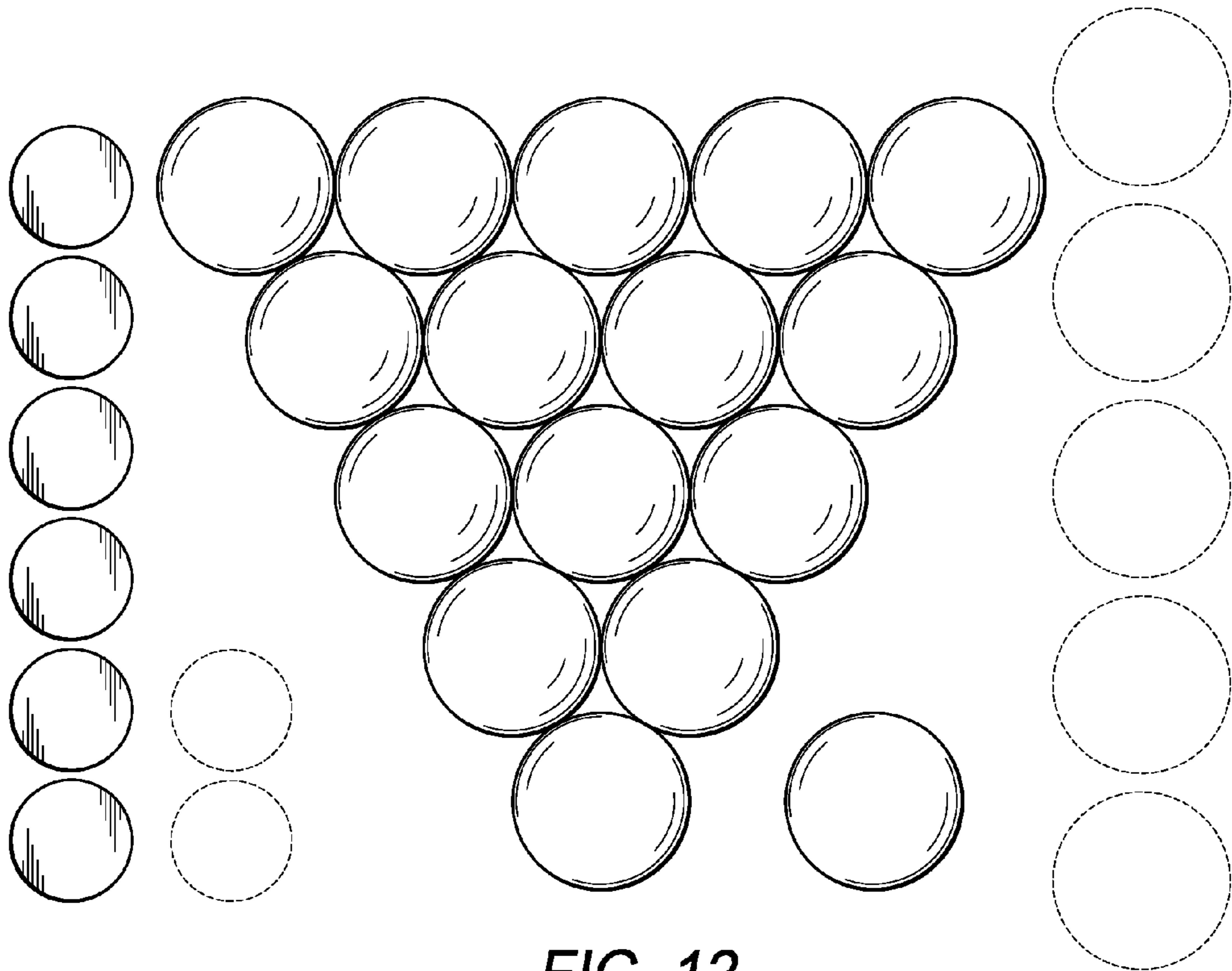

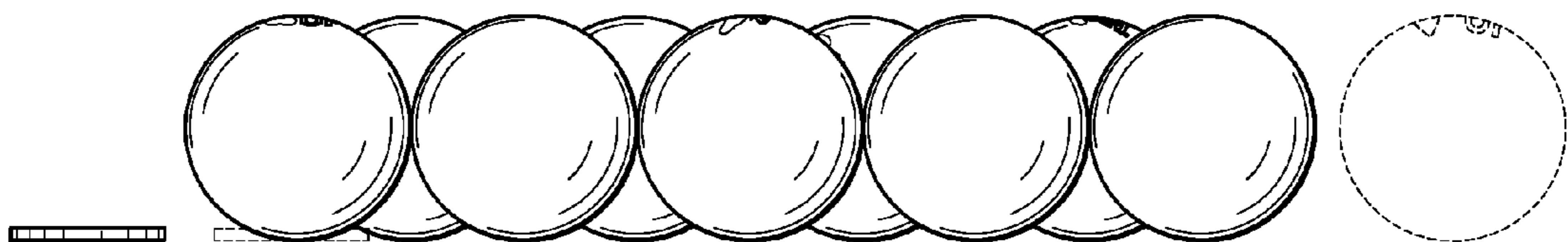

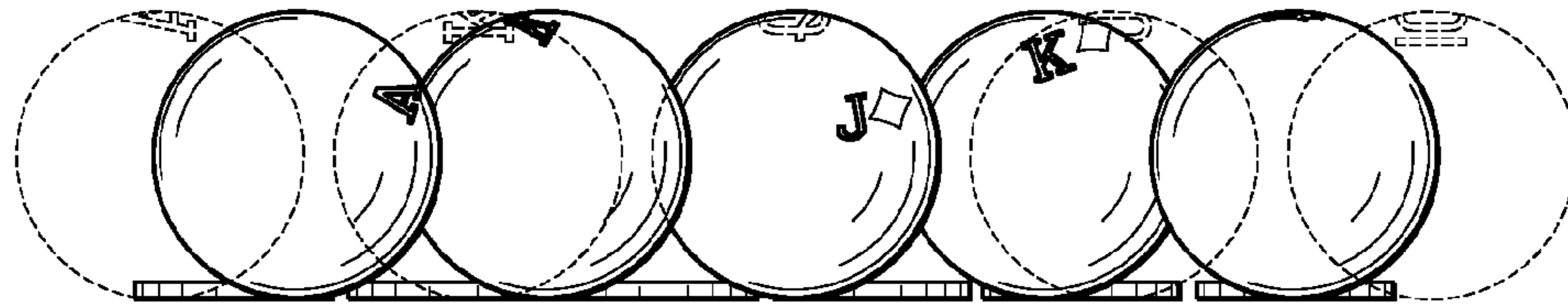

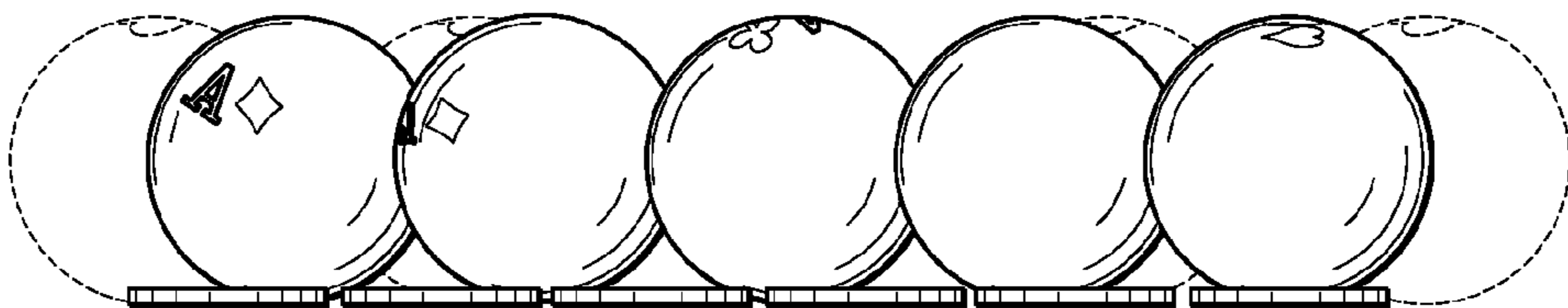

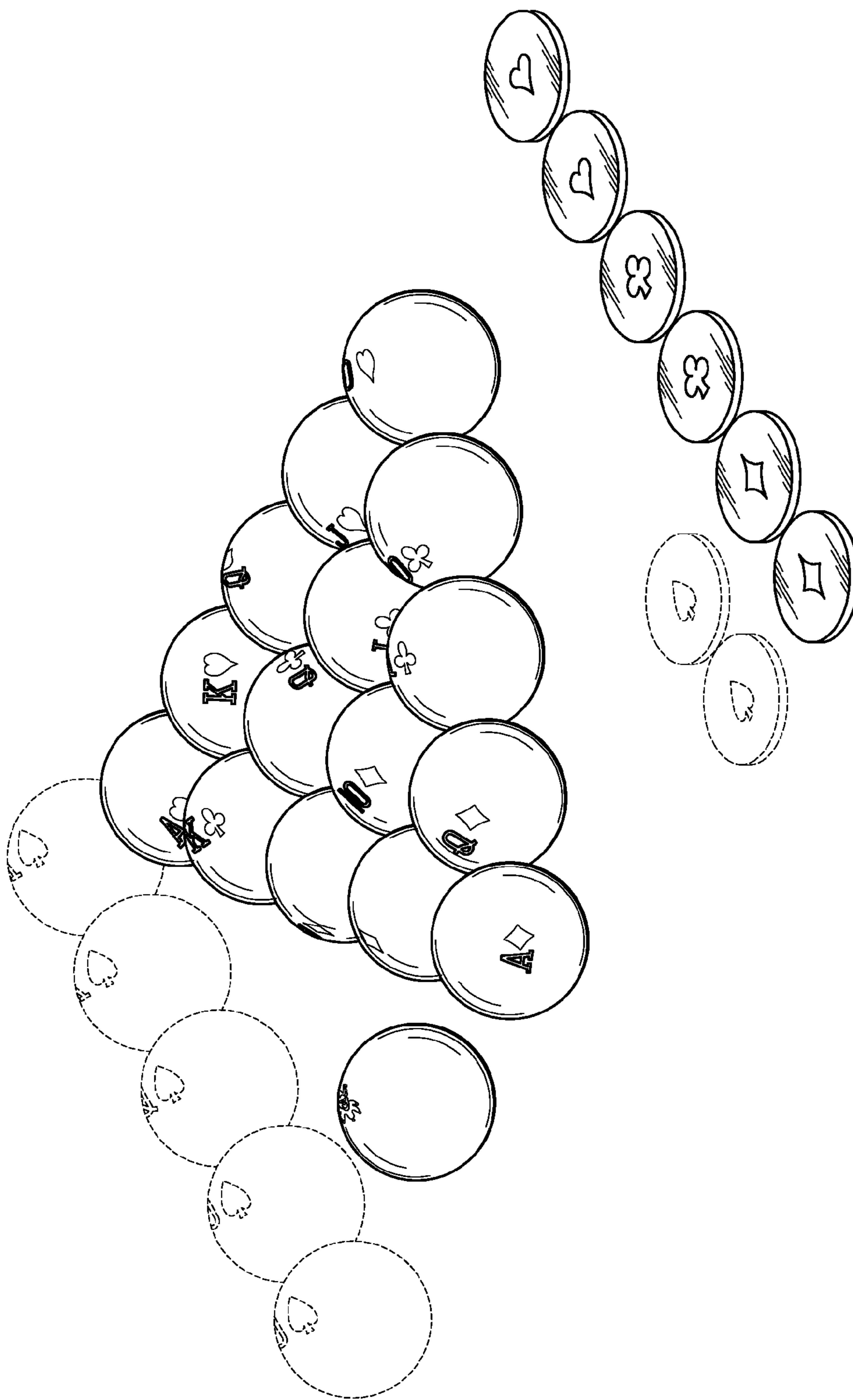

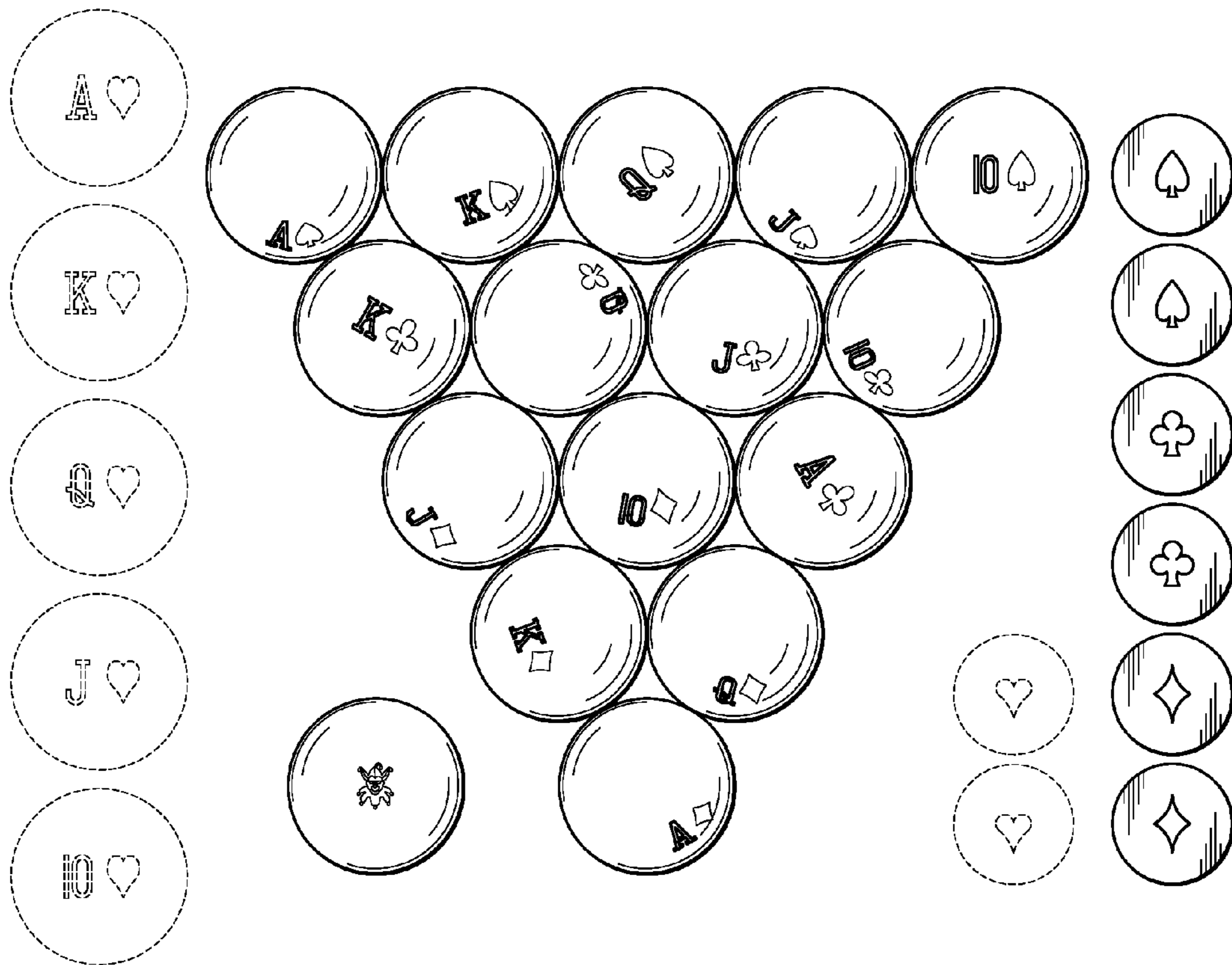

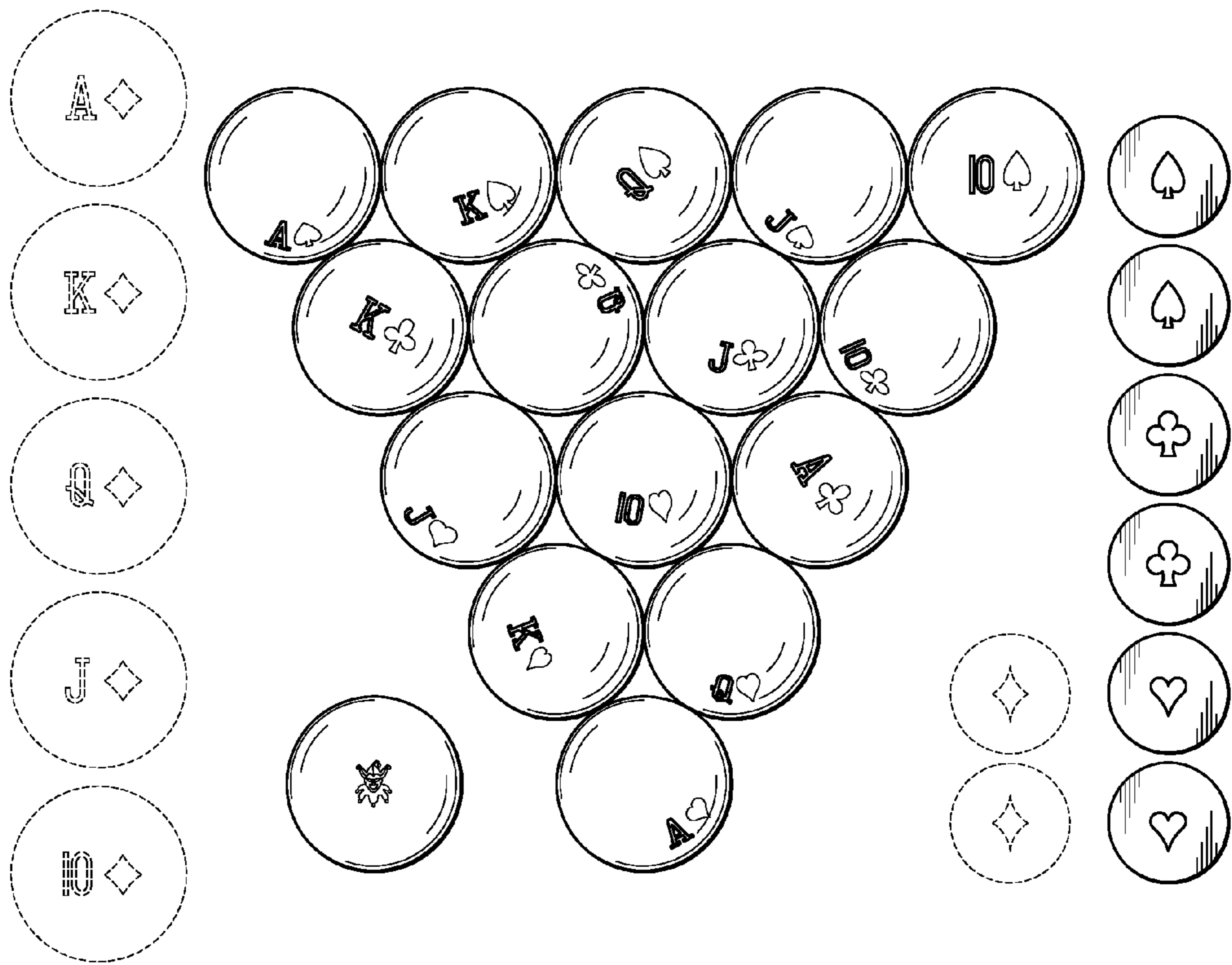

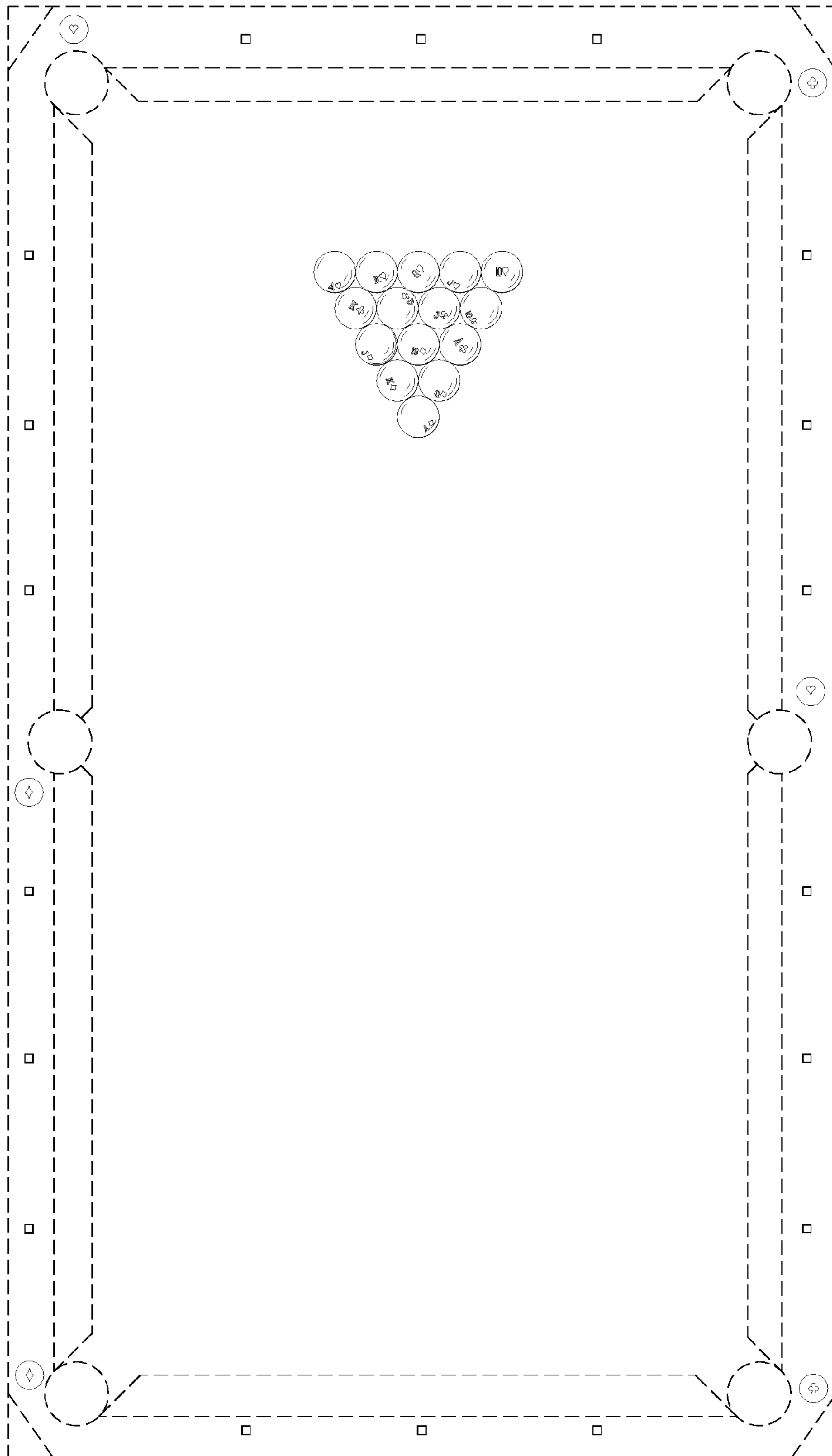
