DESCRIPTION

FIG. 1 is a perspective view of a conduit plug showing my new design;

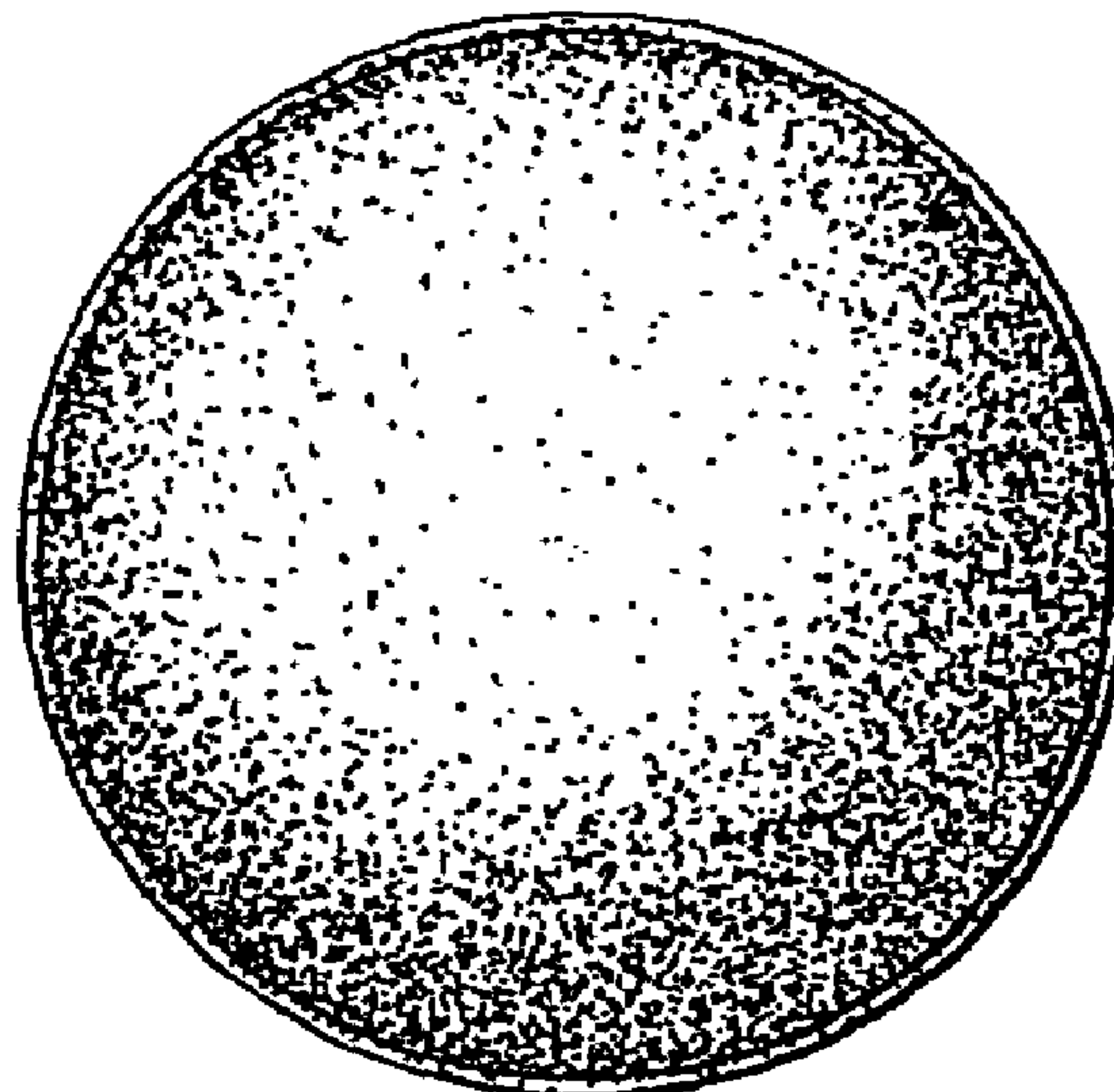
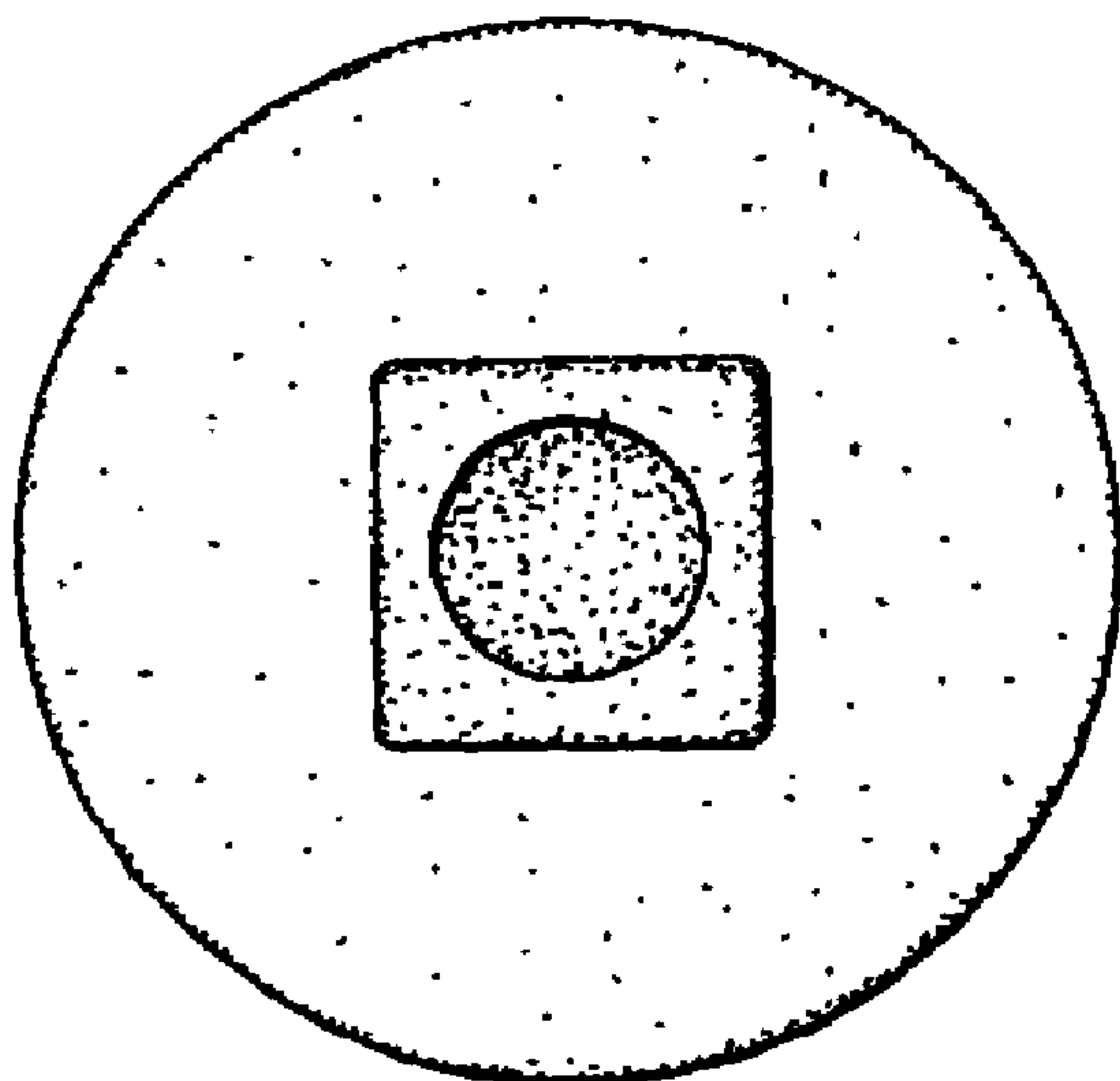
FIG. 2 is a front elevational view of the conduit plug of FIG. 1 with the rear elevation, right side elevation, and left side elevation being mirror images thereof;

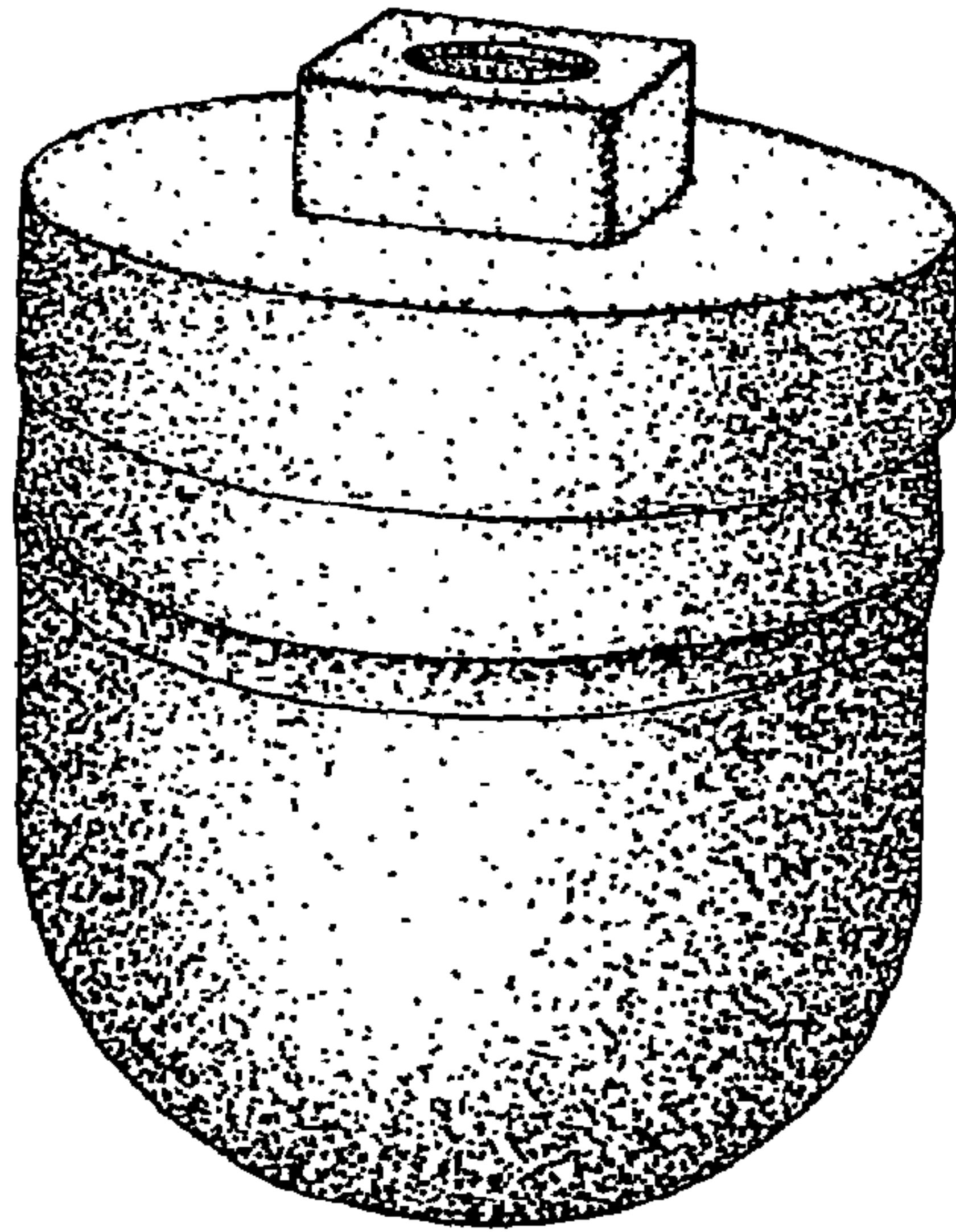

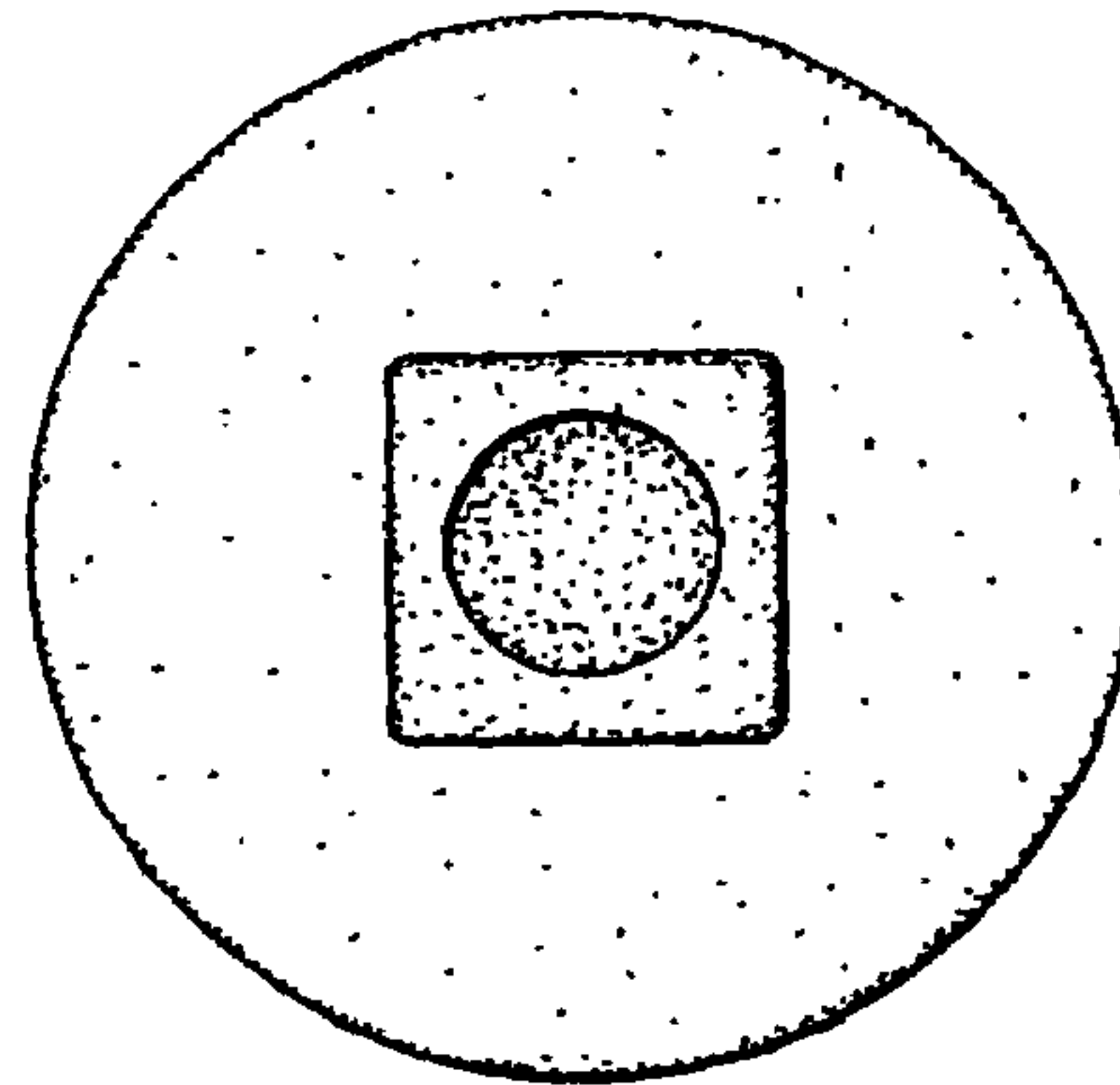

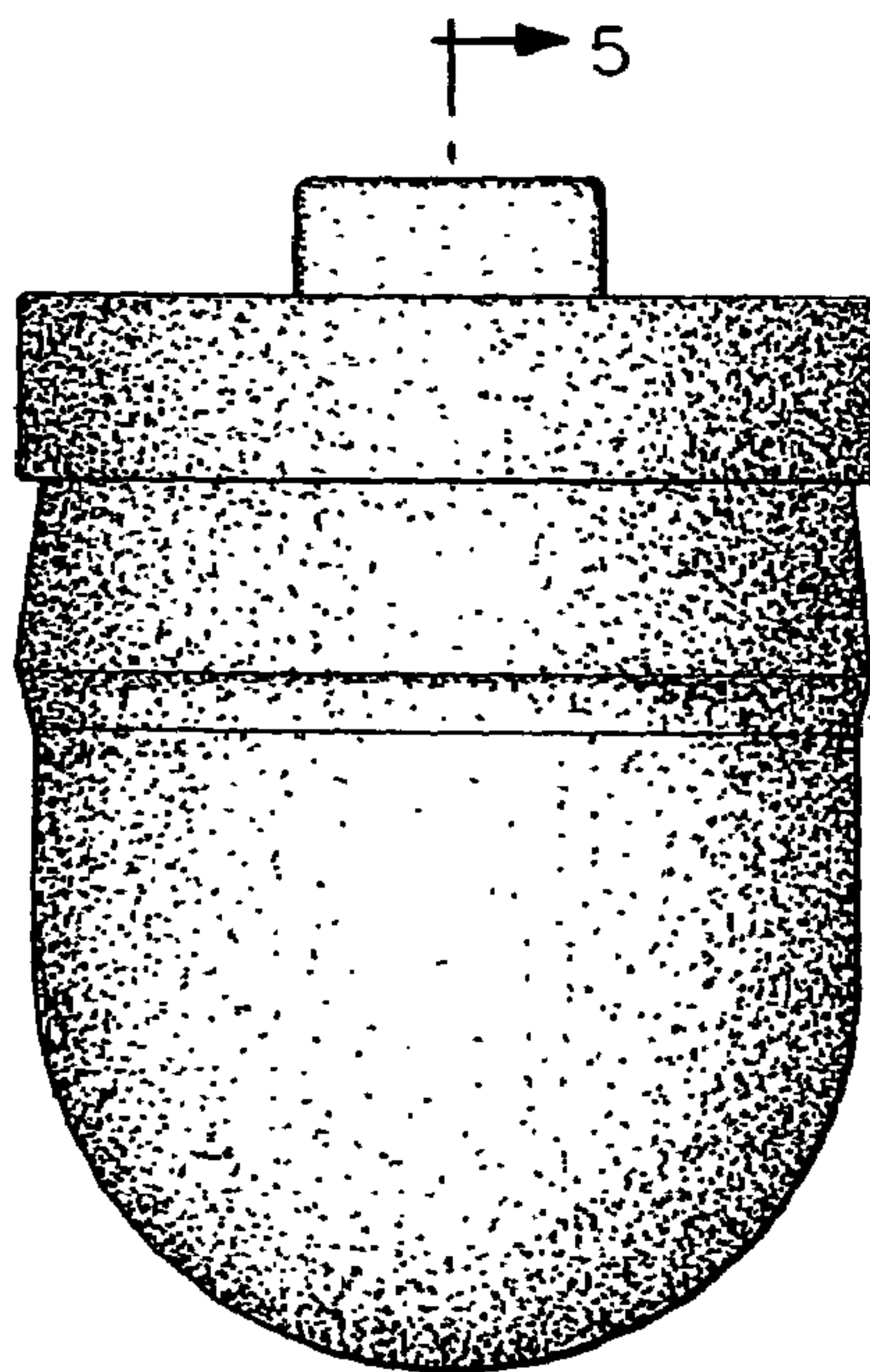

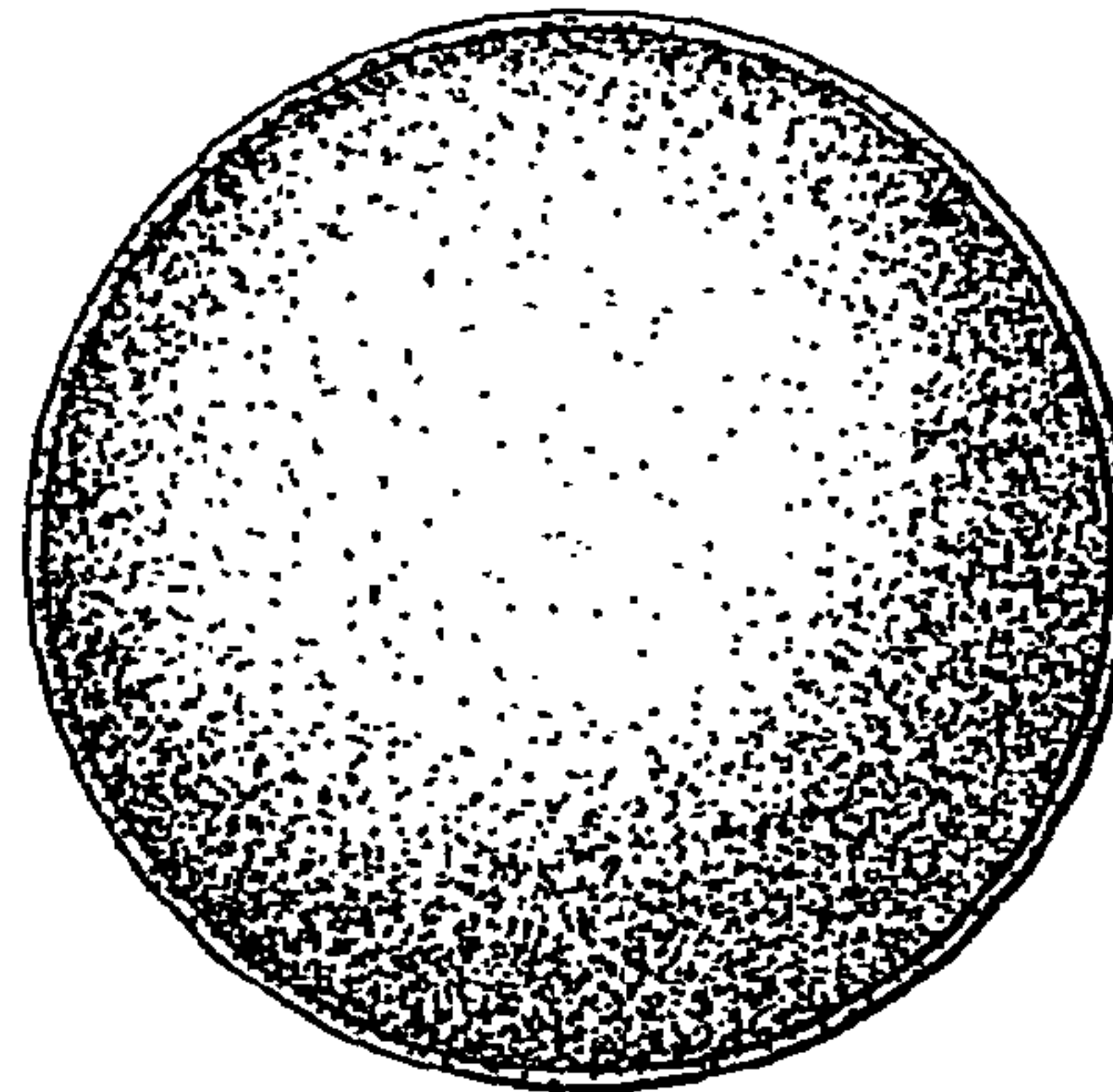

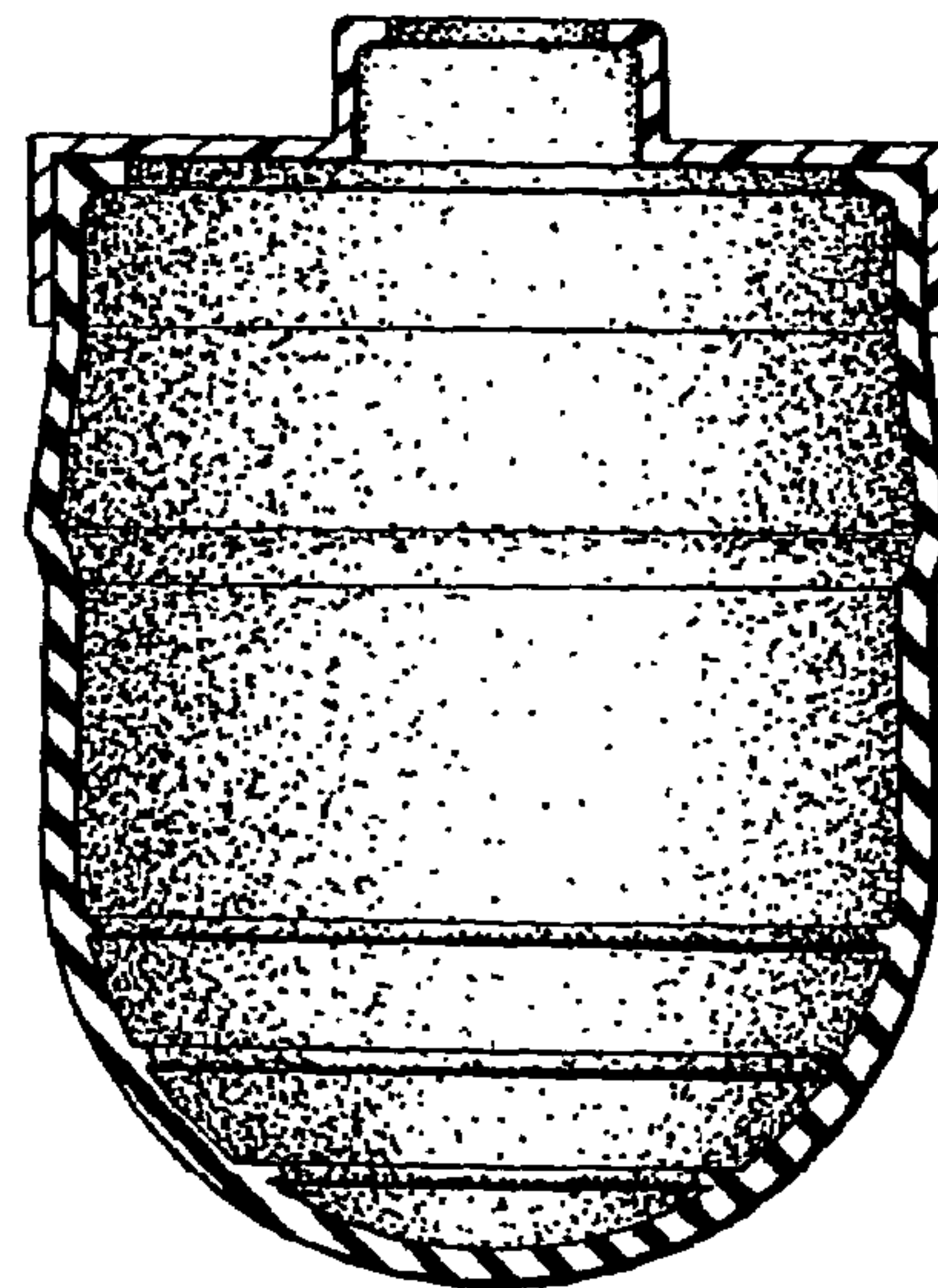
