(57) **CLAIM**

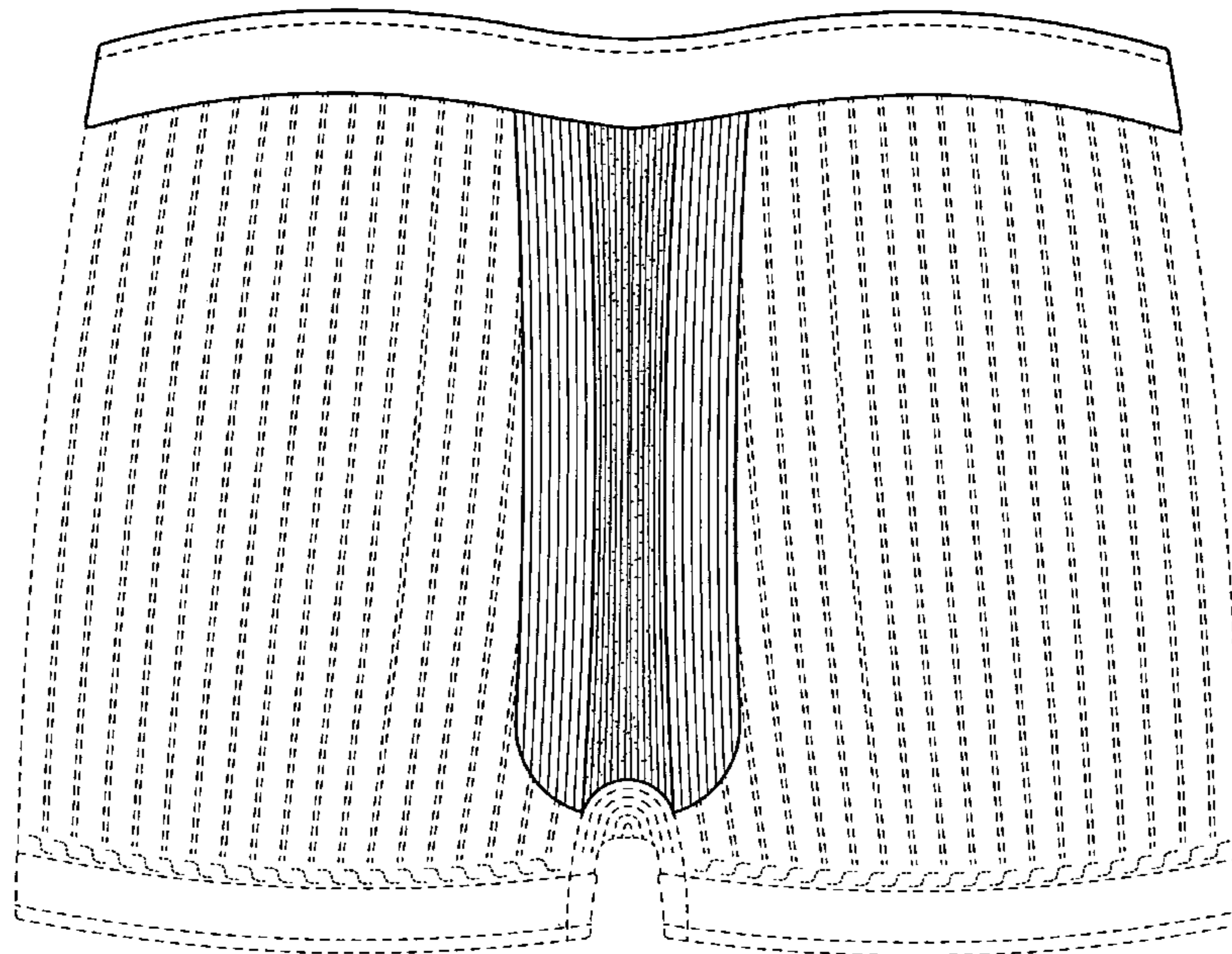
We claim the ornamental design for an undergarment, as shown and described.
