(57) **CLAIM**

The ornamental design for an organizer for portable electronic devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal perspective view of an organizer for portable electronic devices with a cover in an open position, including power cords for said portable electronic devices shown in phantom lines that are not part of the claimed design.

FIG. 2 is a frontal perspective view thereof with the cover in a closed position.

FIG. 3 is a frontal view thereof with the cover in the open position, including power cords for said portable electronic devices shown in phantom lines that are not part of the claimed design.

FIG. 4 is a frontal view thereof with the cover in the closed position.

FIG. 5 is a top plan view thereof with the cover in the open position, including power cords for said portable electronic devices shown in phantom lines that are not part of the claimed design.

FIG. 6 is a top plan view thereof with the cover in the closed position.

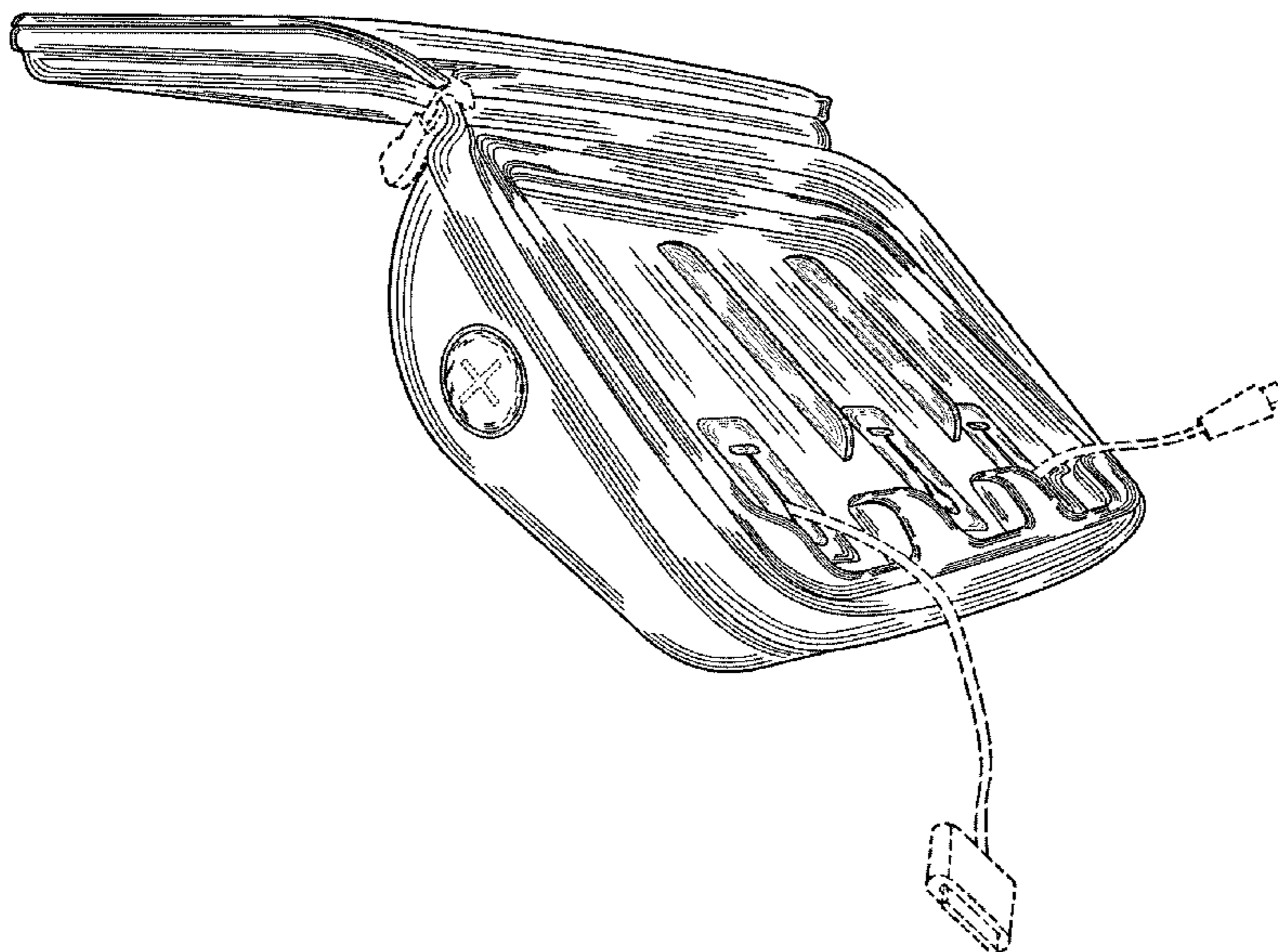
FIG. 7 is a bottom plan view thereof with the cover in the closed position.

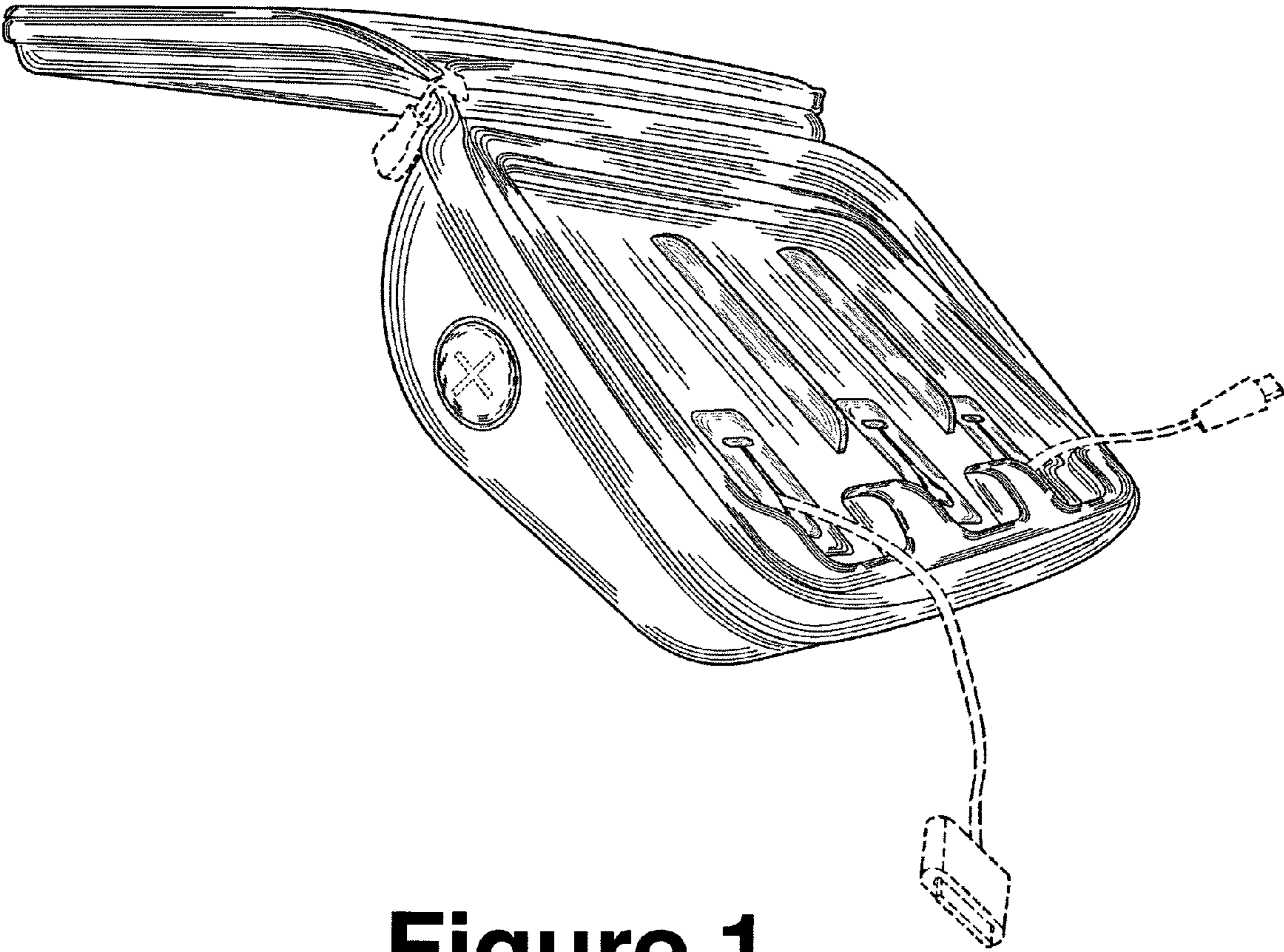
FIG. 8 is a rear view thereof with the cover in the closed position; and,

FIG. 9 is a side view thereof with the cover in the closed position.

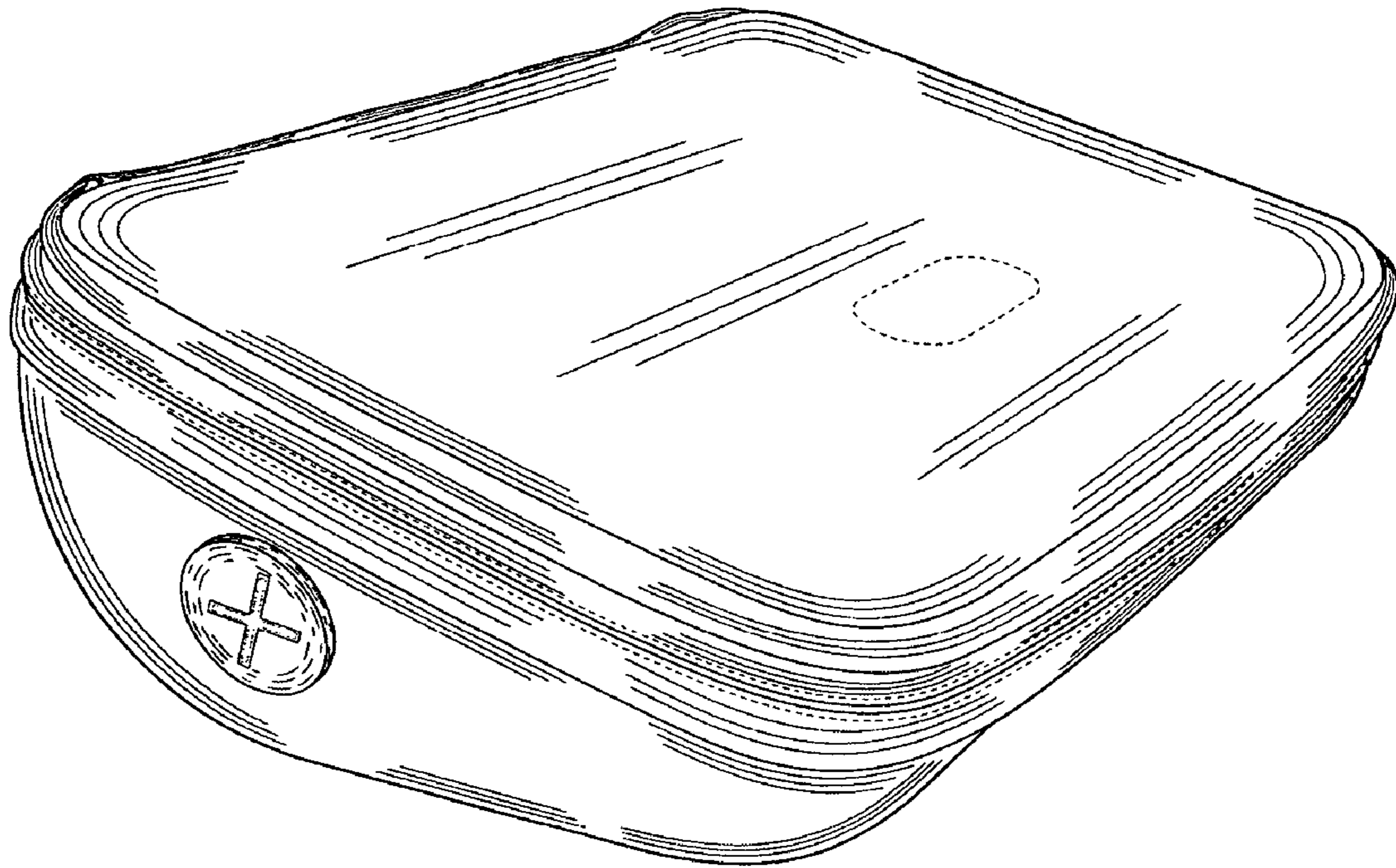

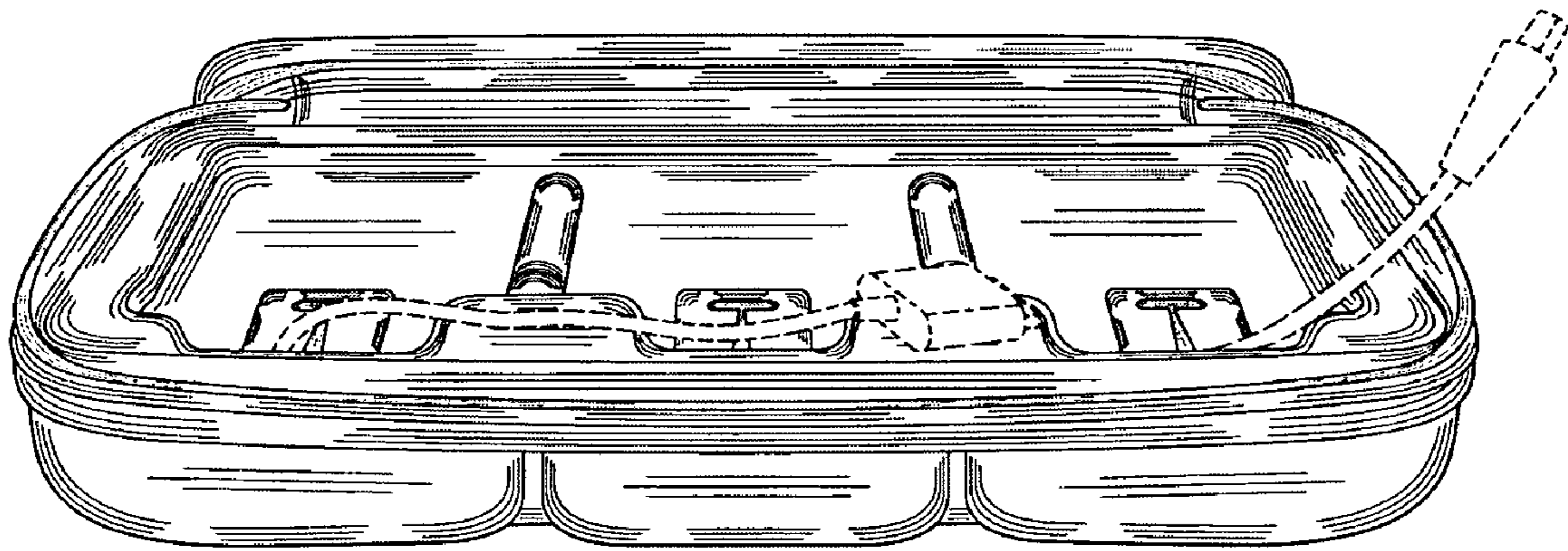




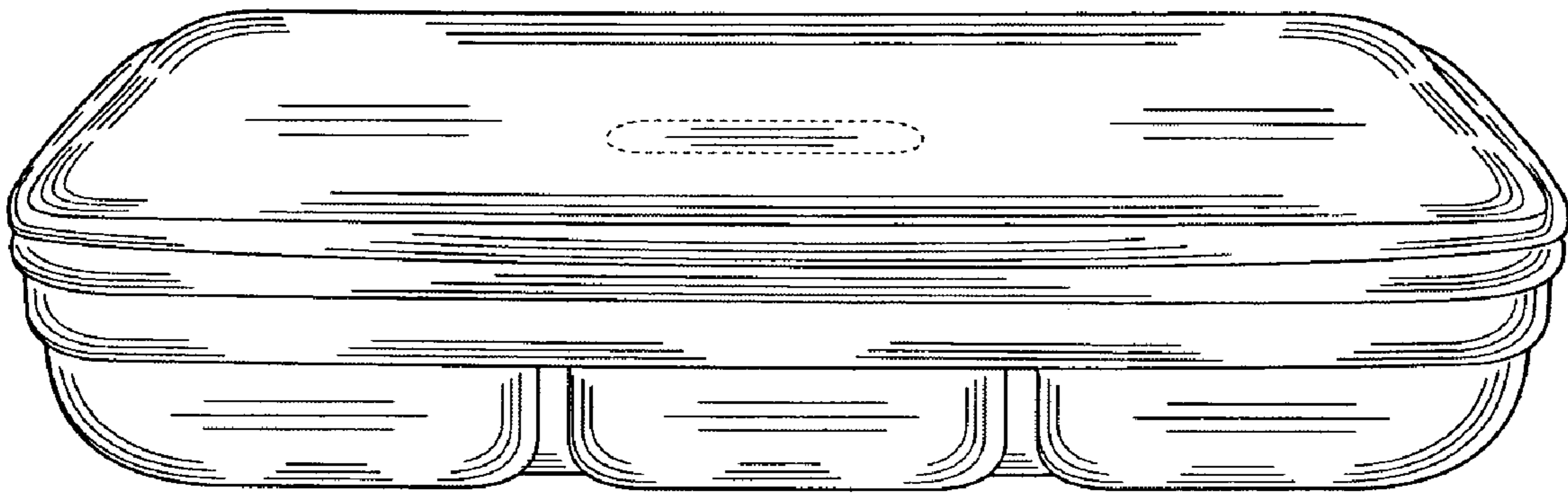

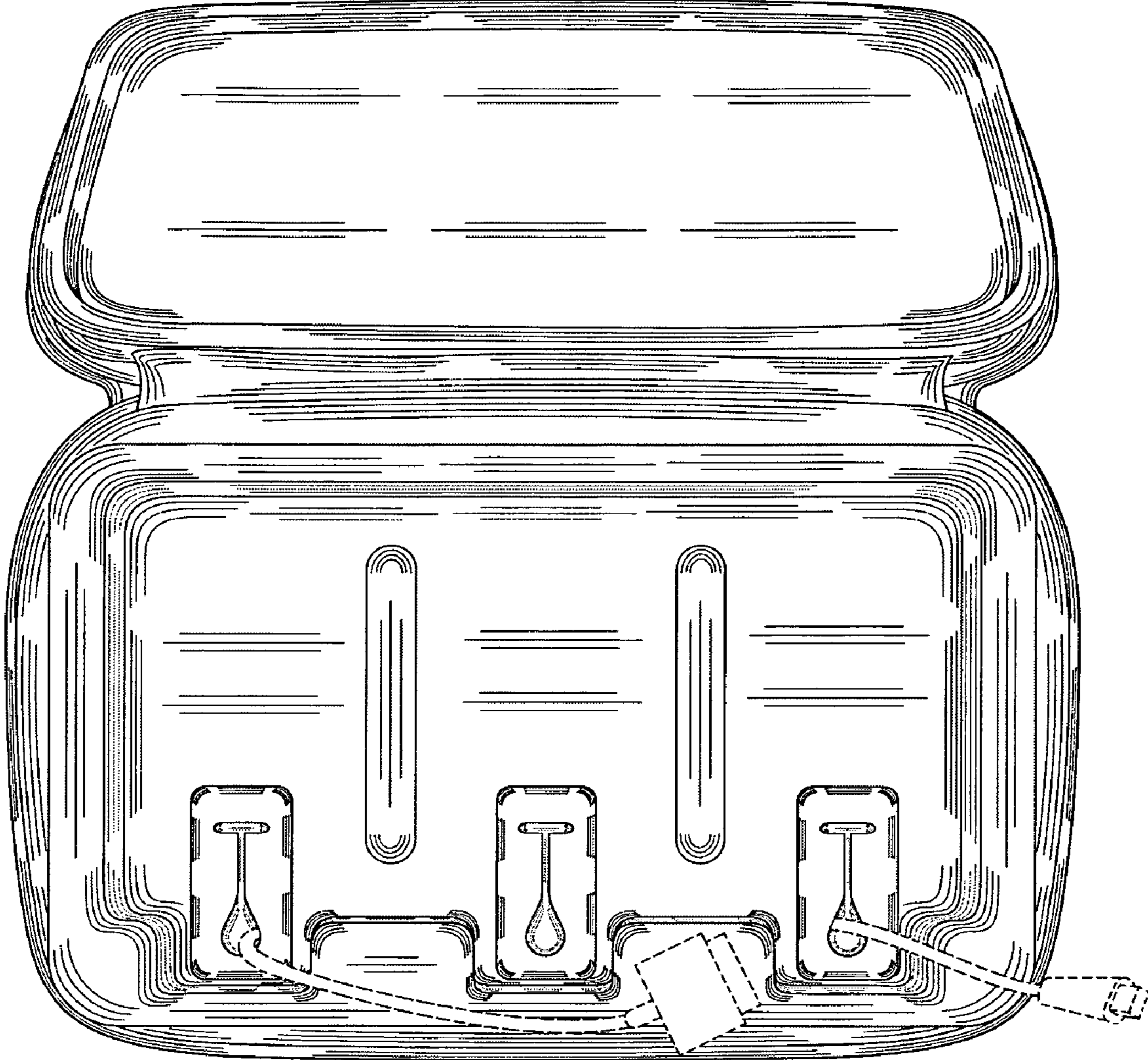

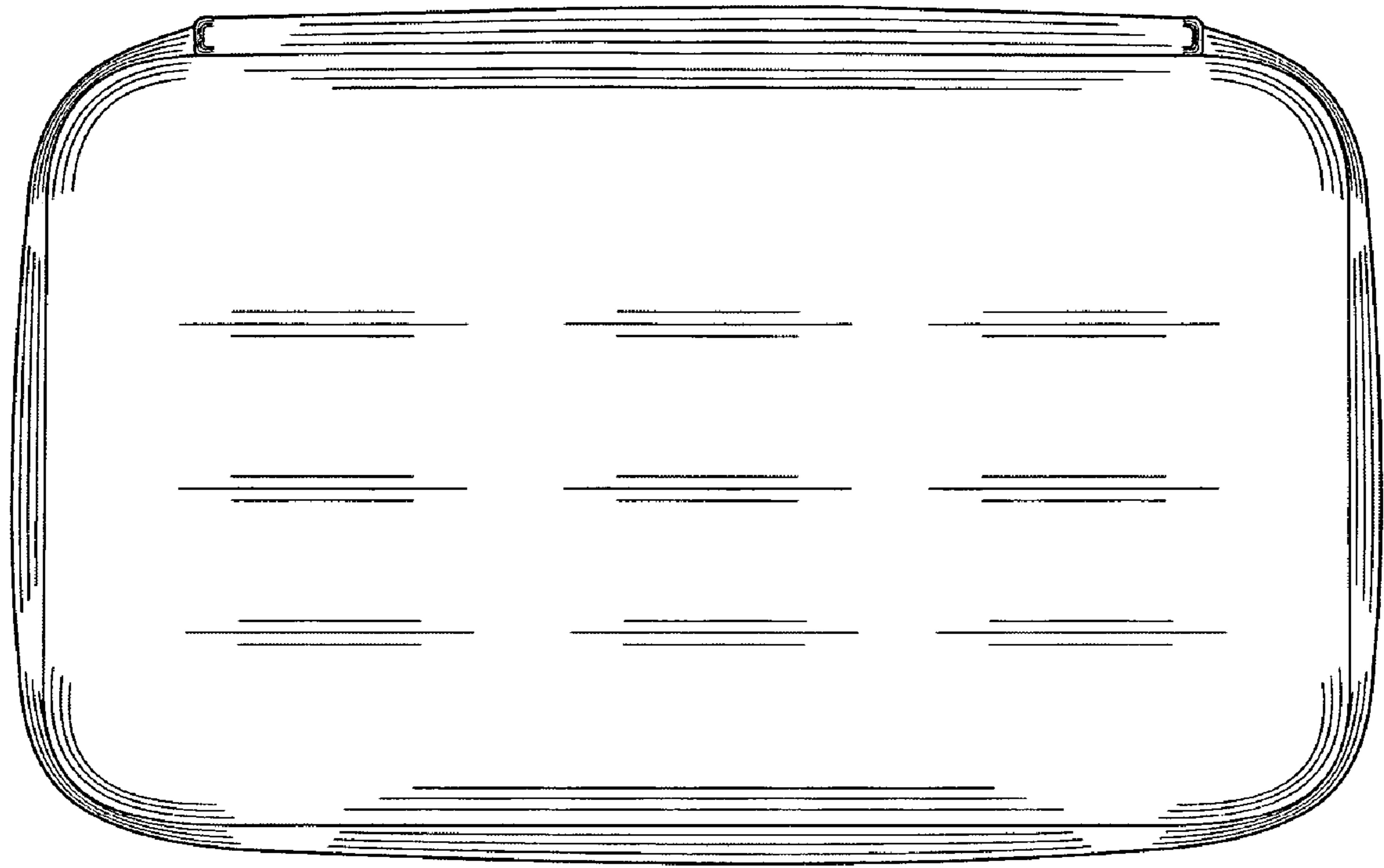

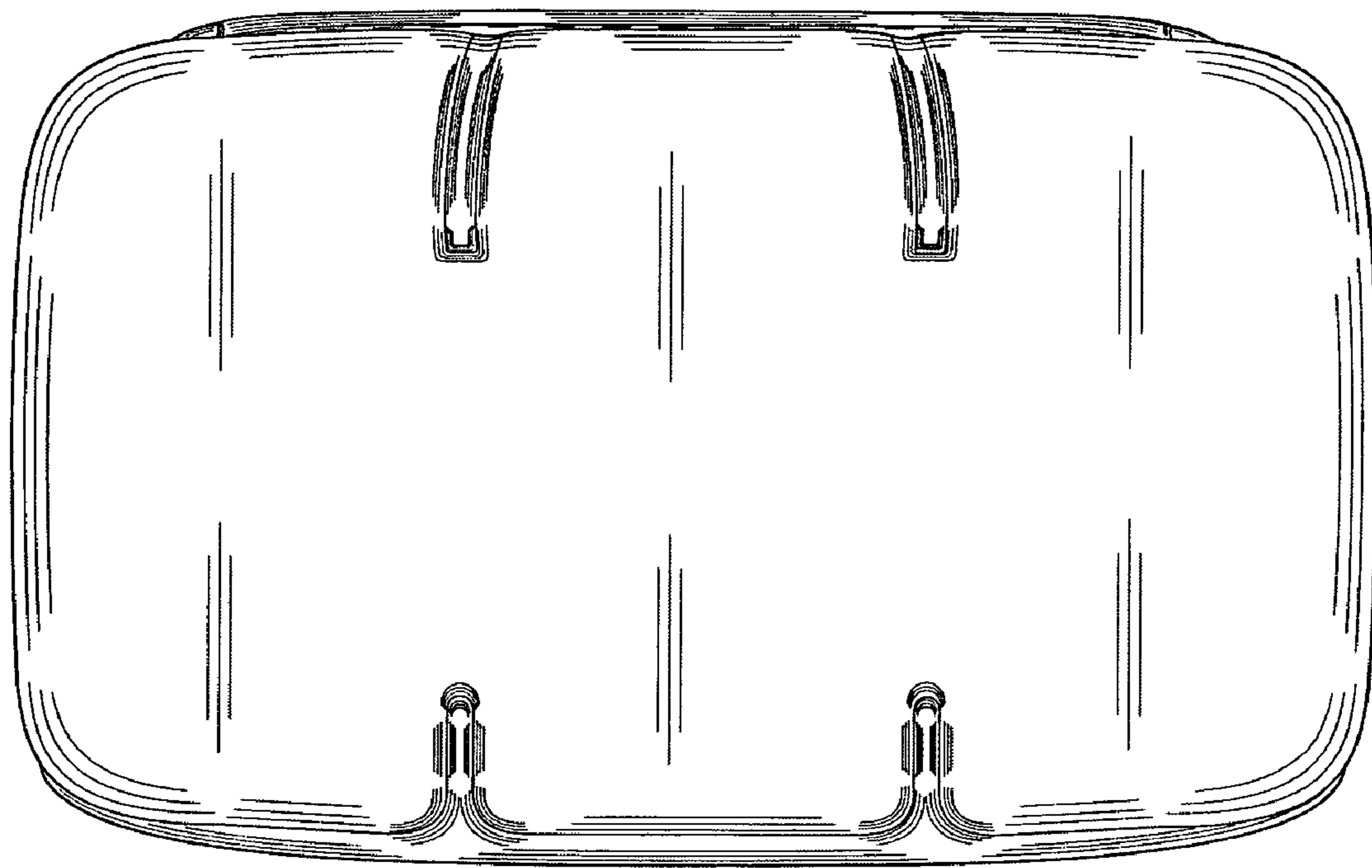

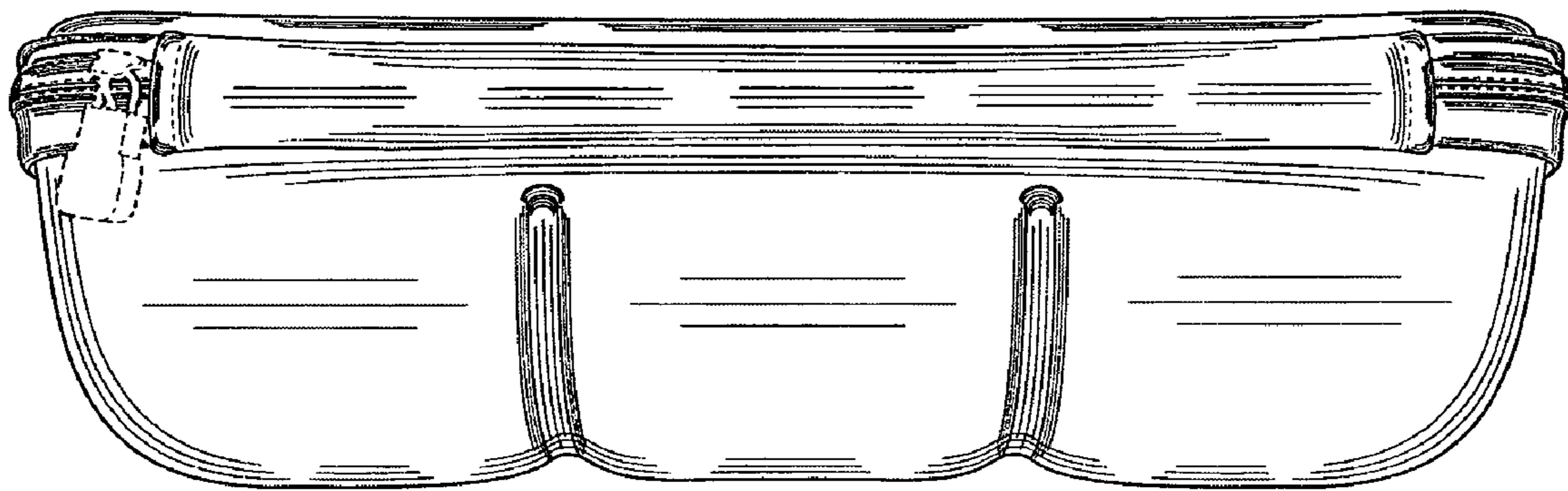

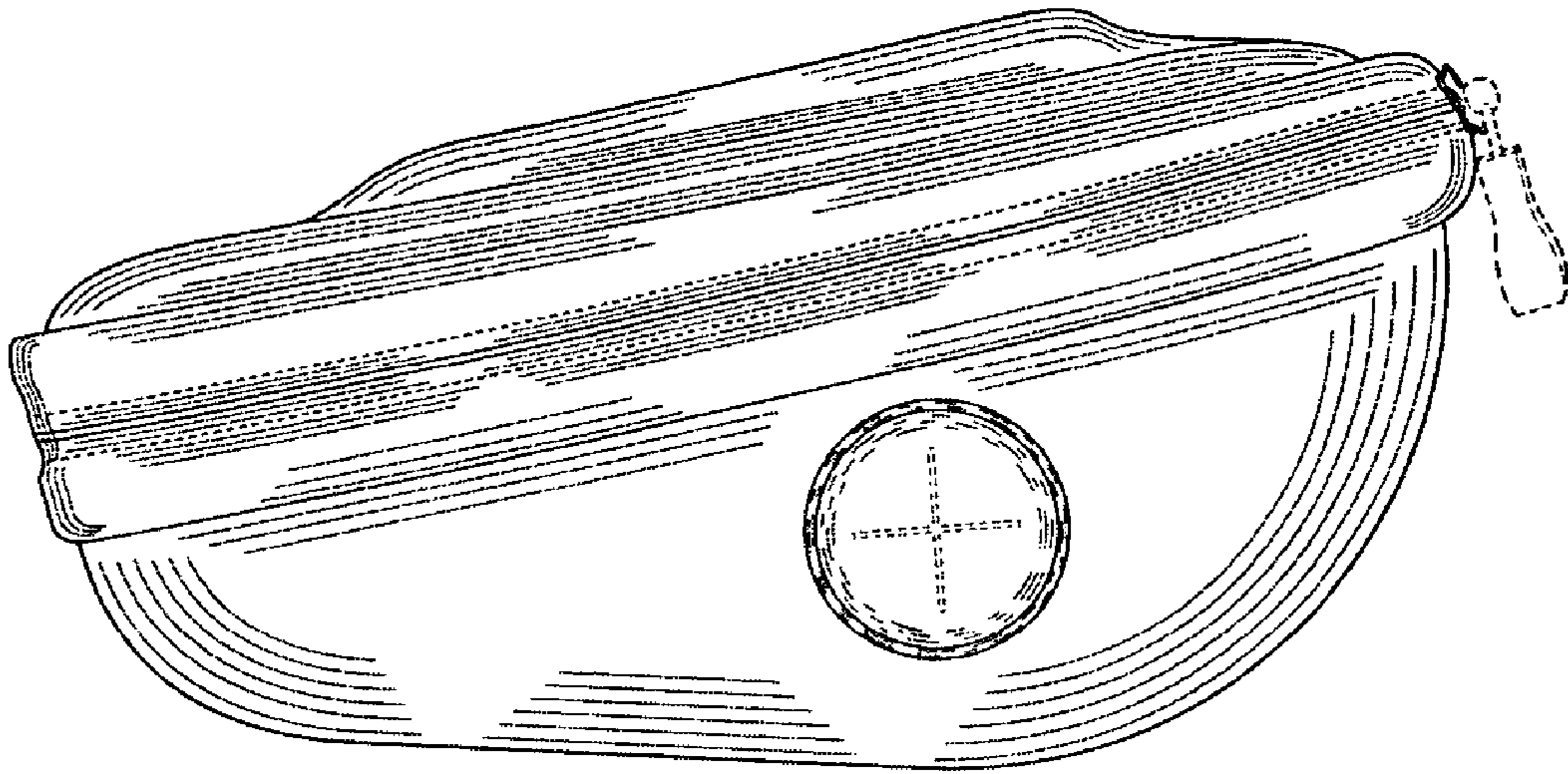
