The ornamental design for a wire reel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front quarter elevated isometric view of a wire reel.

FIG. 2 is a top view of a wire reel.

FIG. 3 is a front view of a wire reel.

FIG. 4 is a bottom view a wire reel.

FIG. 5 is a rear view of a wire reel.

FIG. 6 is a left side view of a wire reel and is enlarged in comparison to the other views; and,

FIG. 7 is a right side view of a wire reel and is enlarged in comparison to the other views.

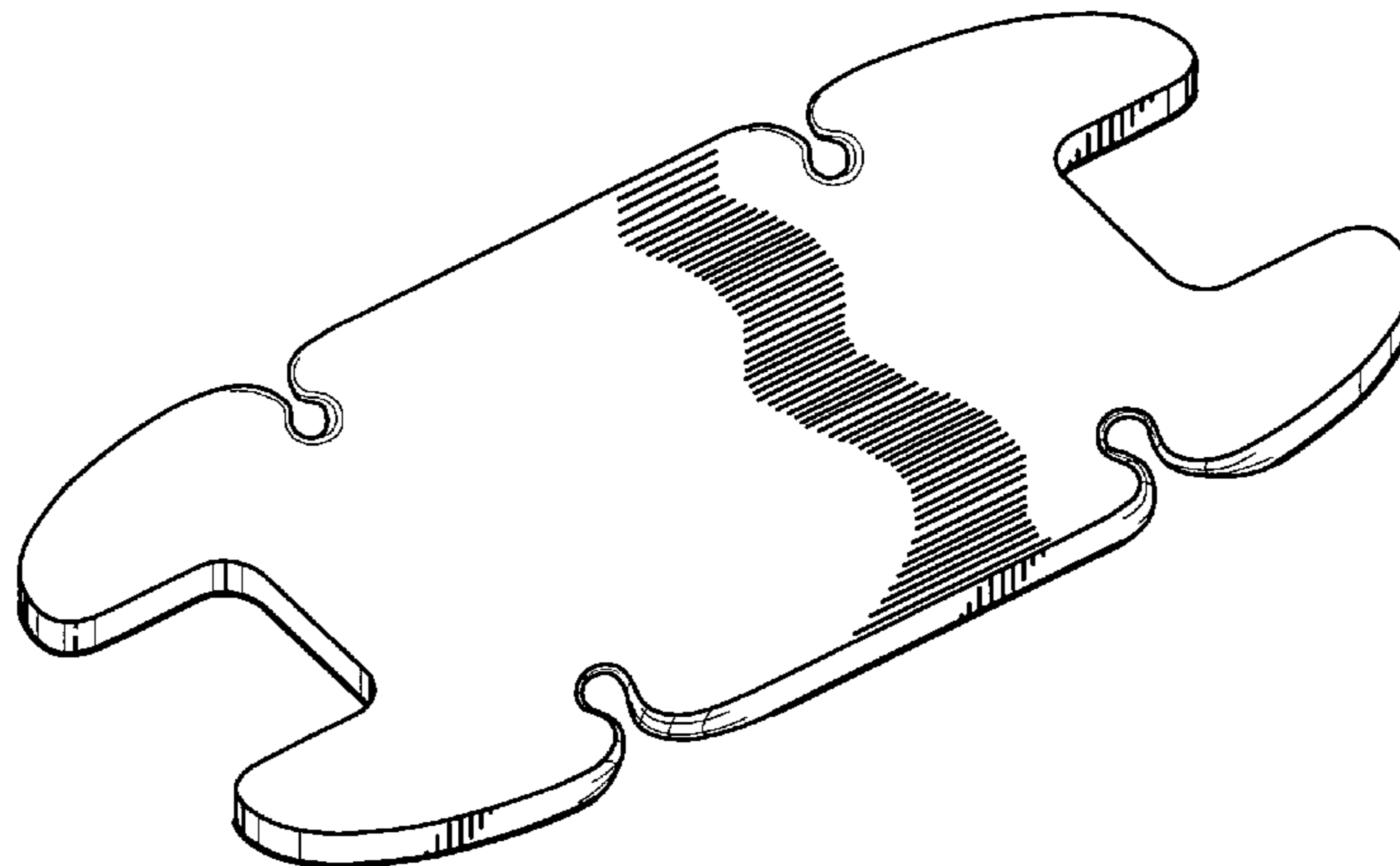

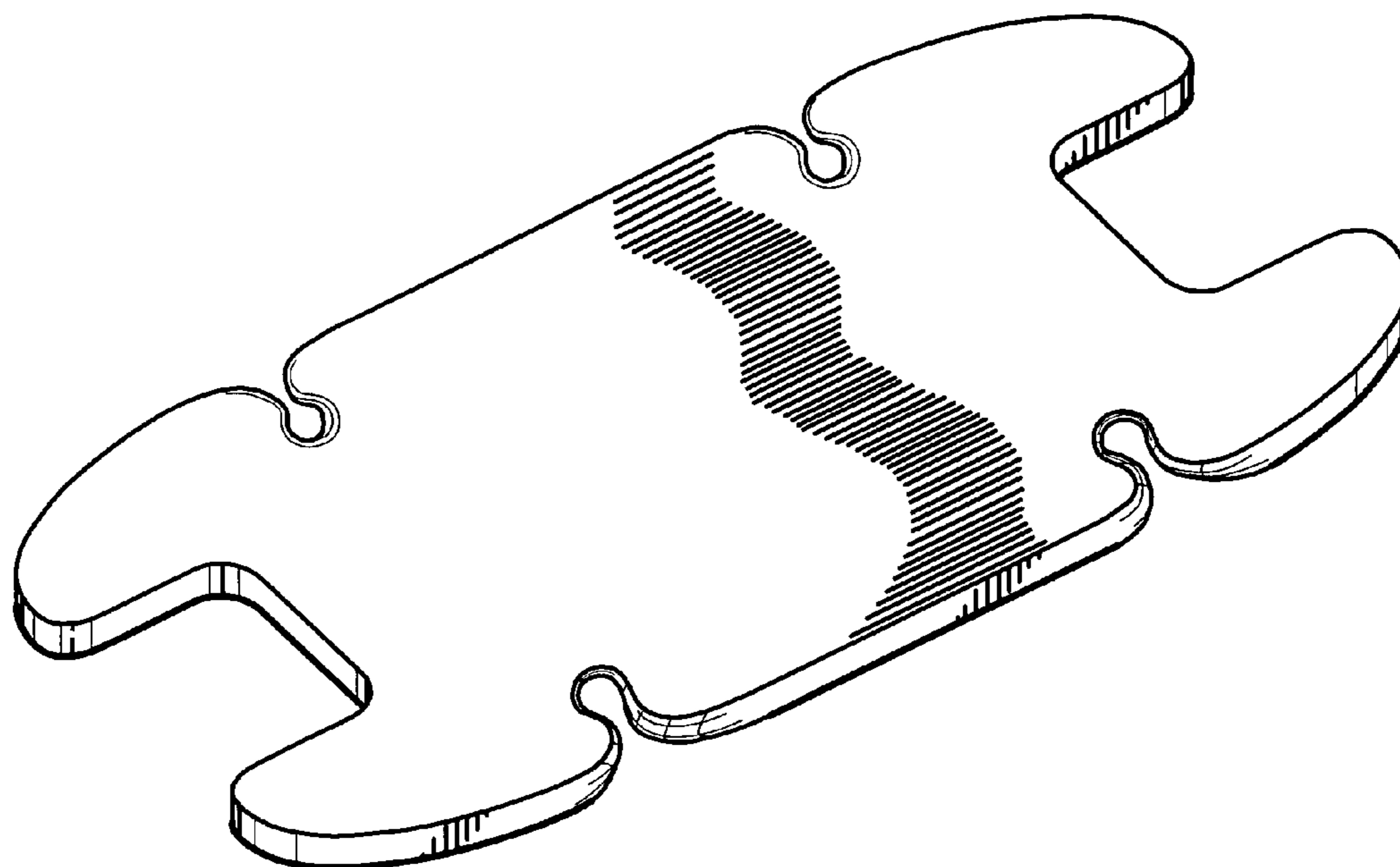

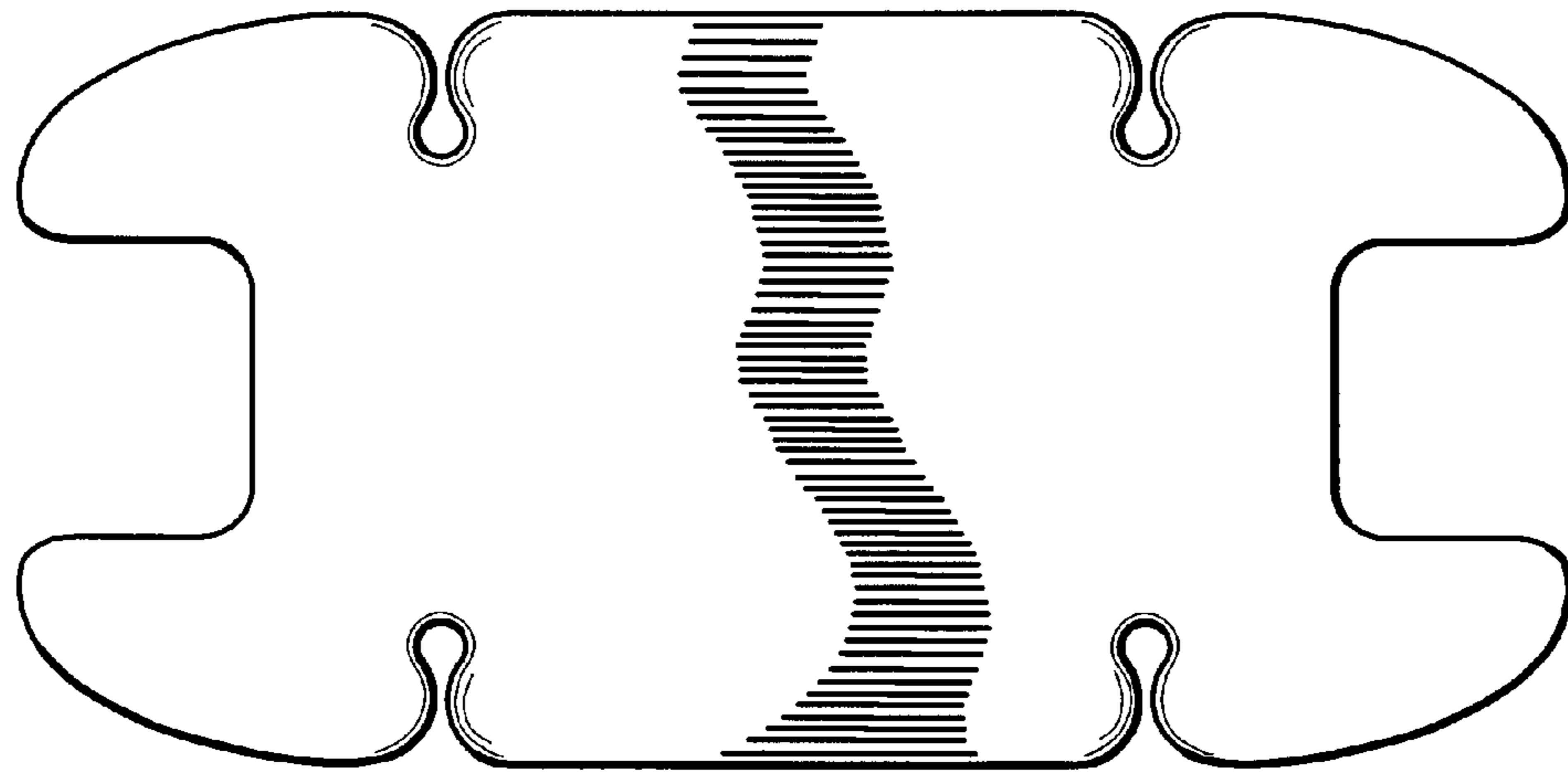

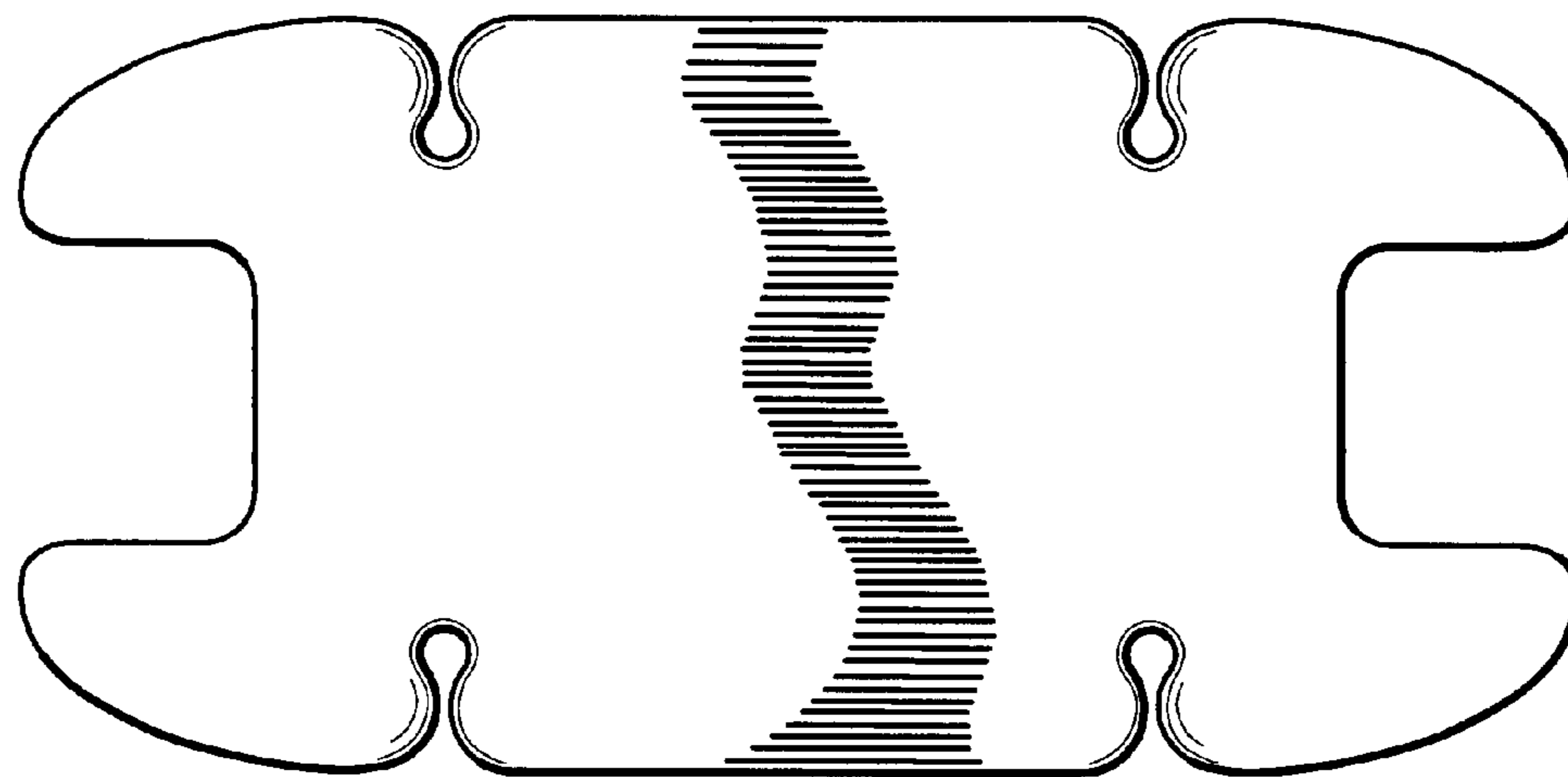
