(57) **CLAIM**

The ornamental design for a holder for carryout food, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a holder for carryout food, showing my new design, the broken lines indicating the way in which carryout food is held but forming no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a side elevational view thereof from the right of FIG. 2, the side elevational view from the left of FIG. 2 being the mirror image thereof;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.

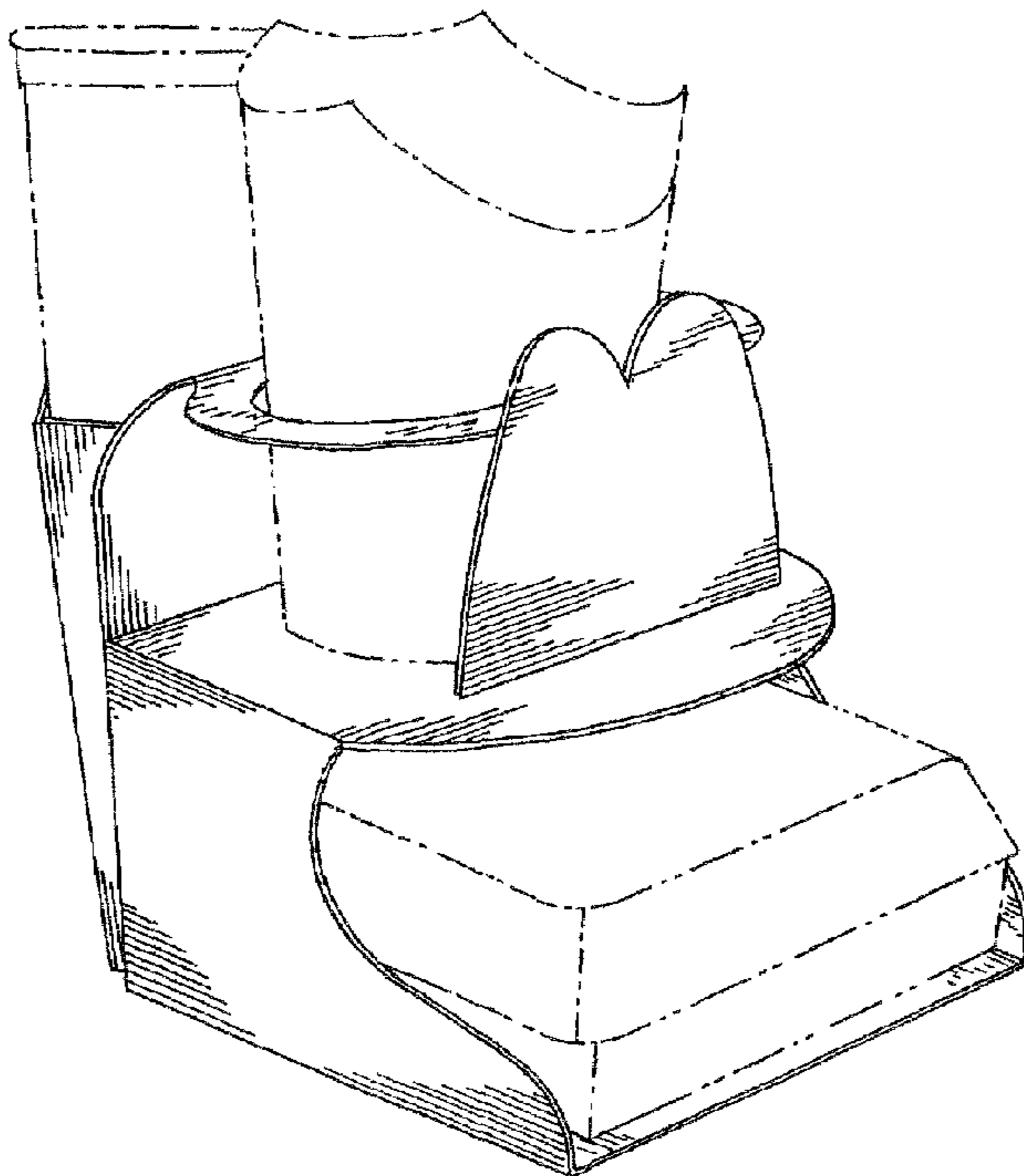

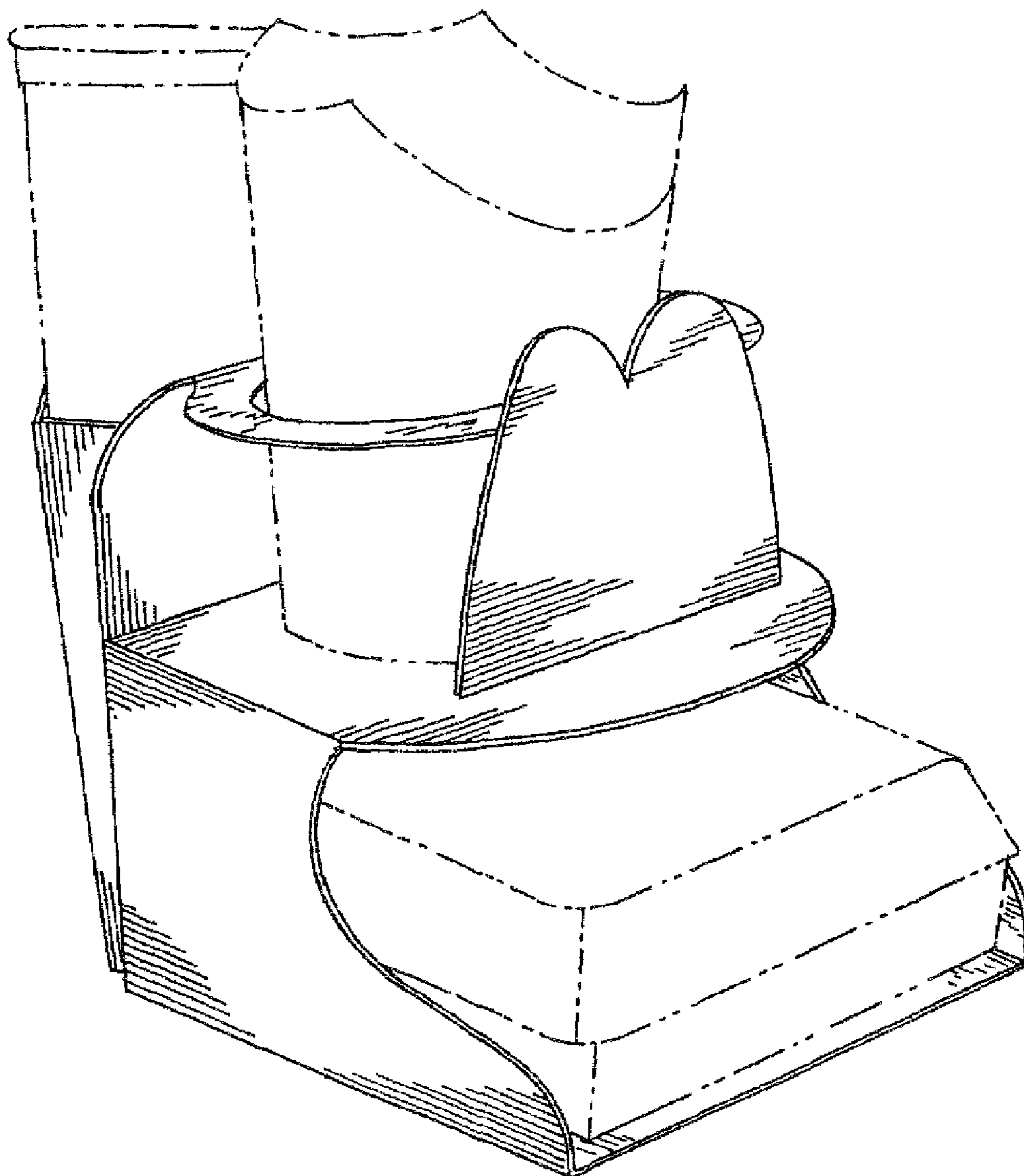

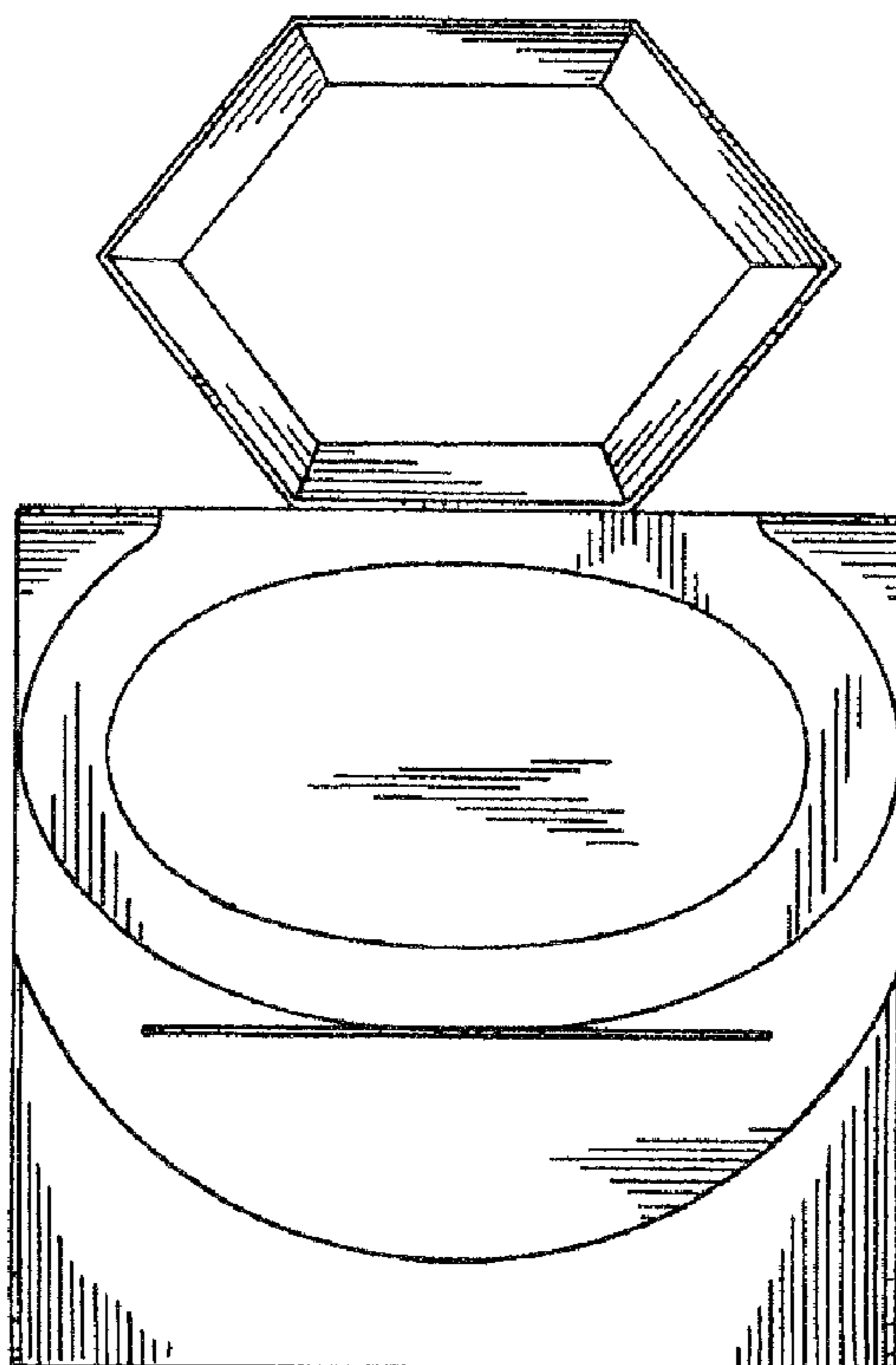

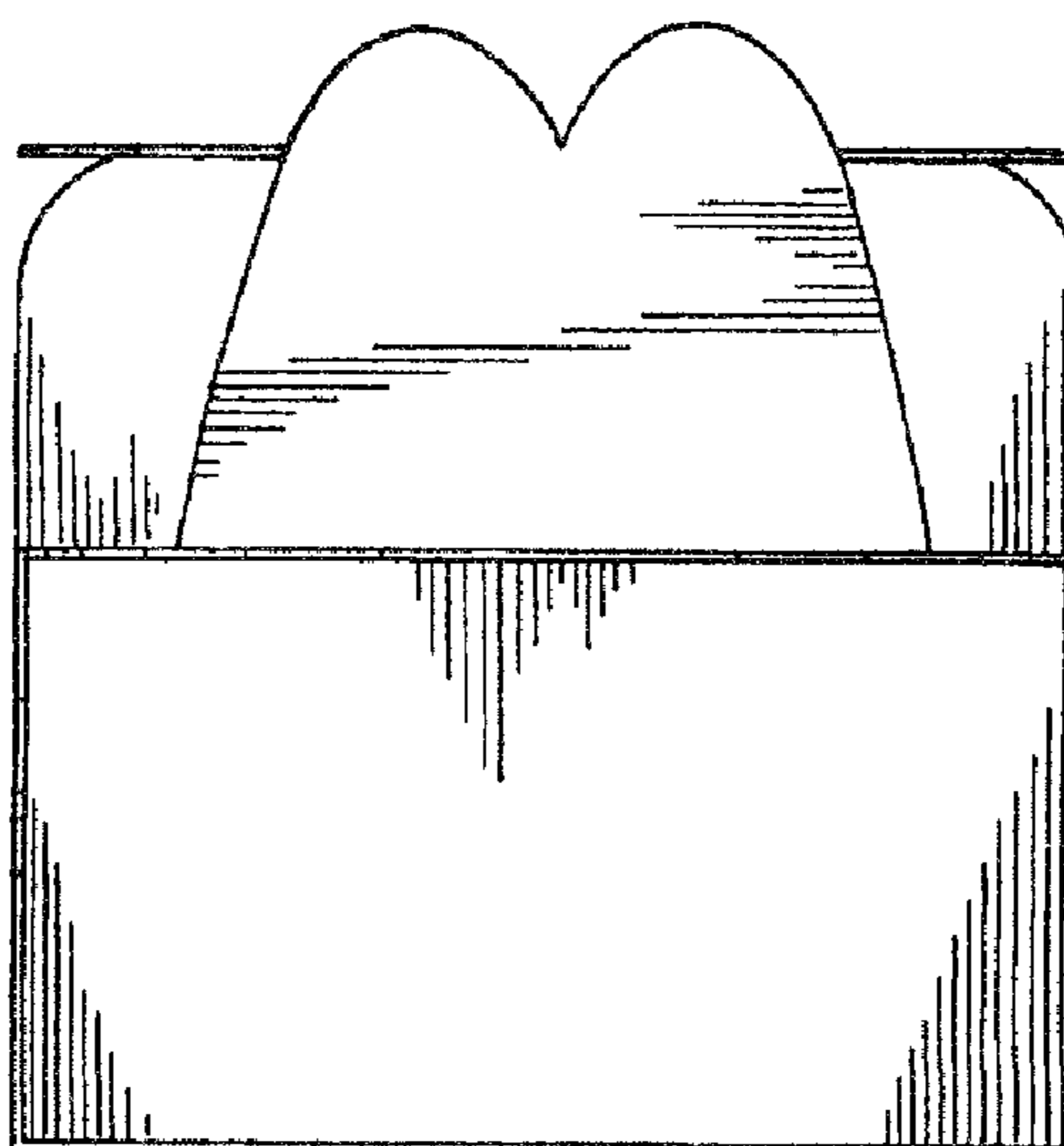

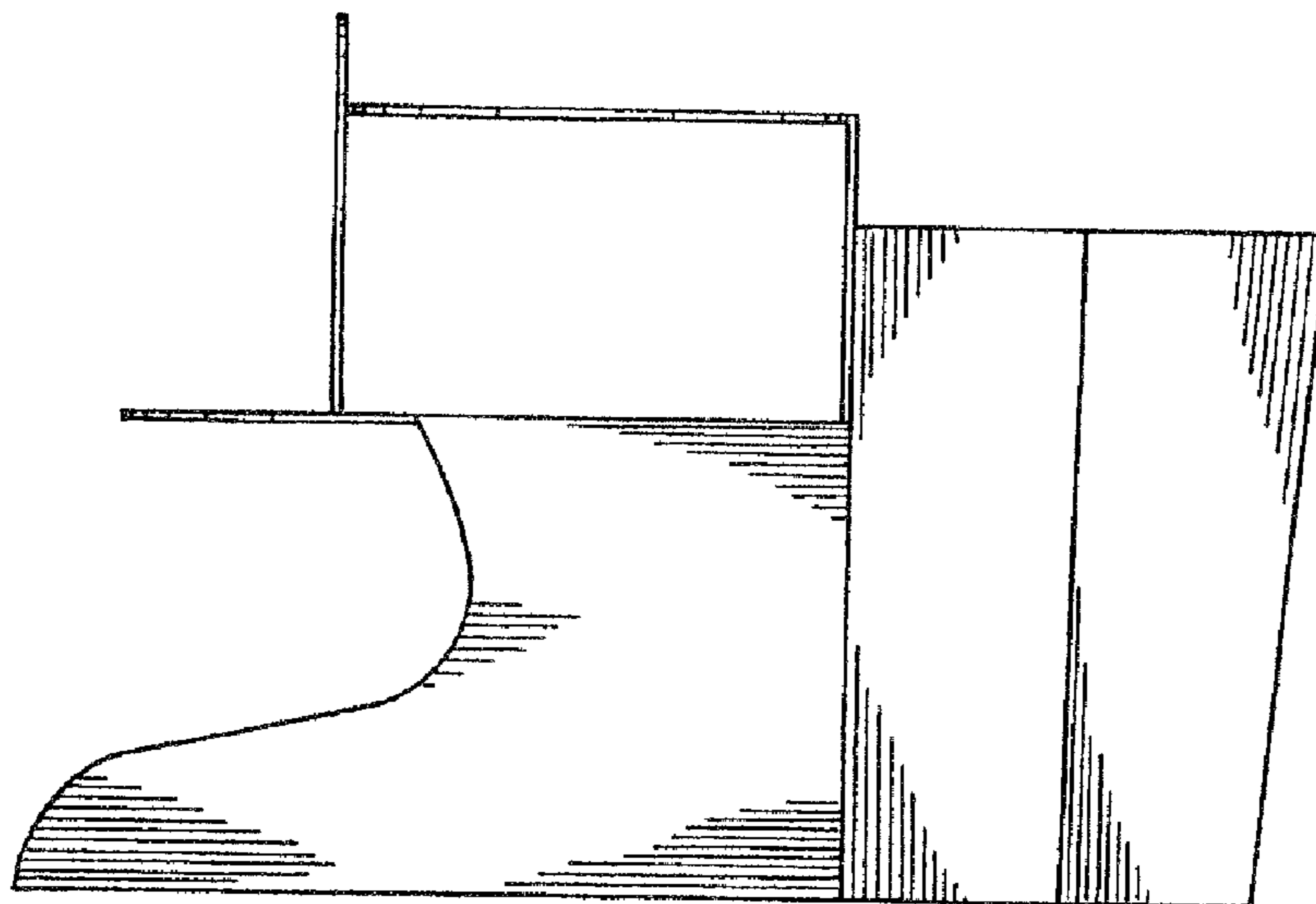

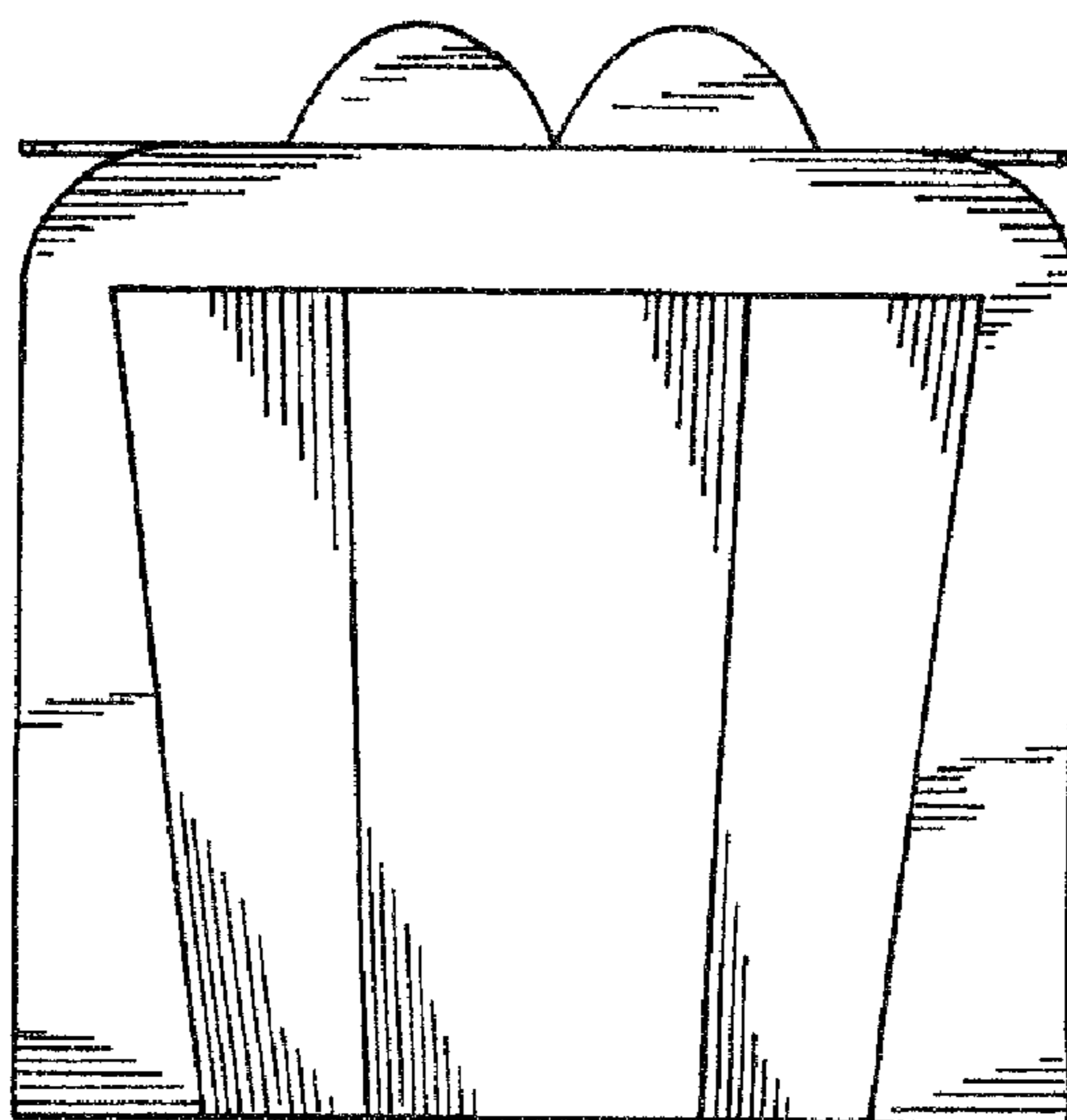
