(57) **CLAIM**

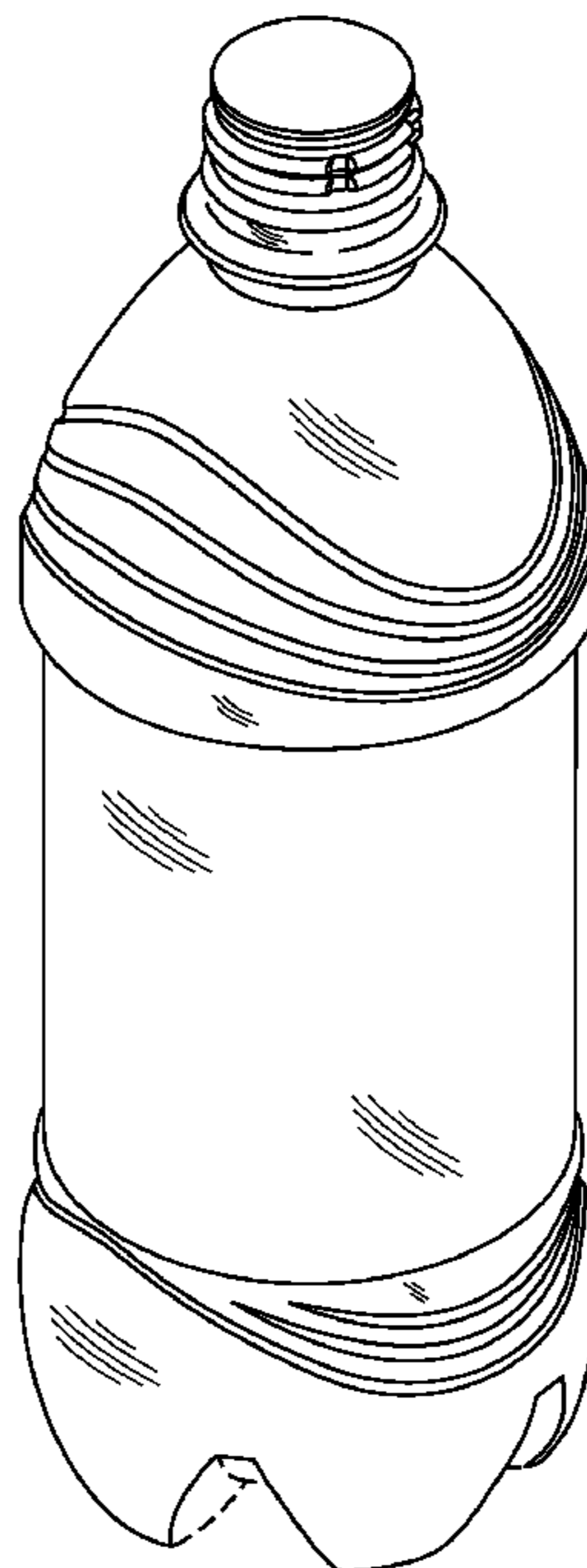
We claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, right, front perspective view for a bottle;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a rear elevational view;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a front elevational view thereof.

The dash lines immediately adjacent to the shaded areas of the bottle represent unclaimed boundaries of the claimed design. The dash lines showing the remainder of the bottle are for illustrative purposes only and form no part of the claimed design.

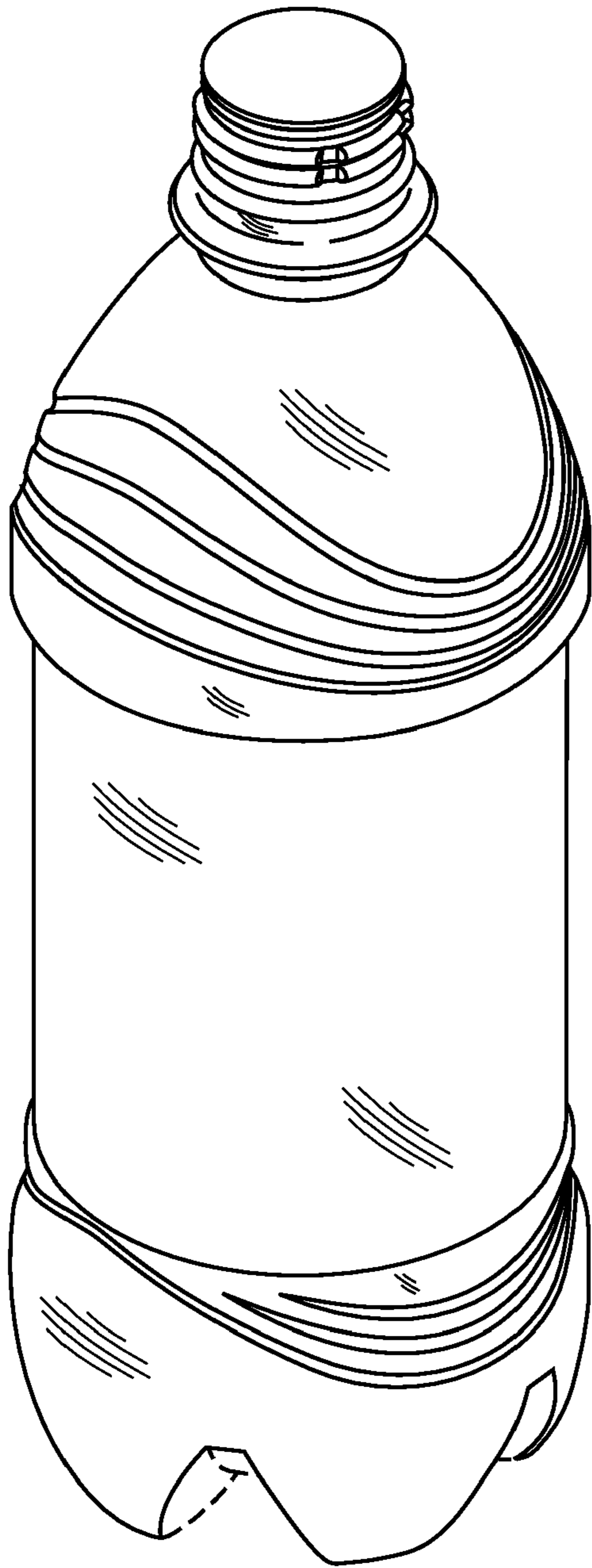

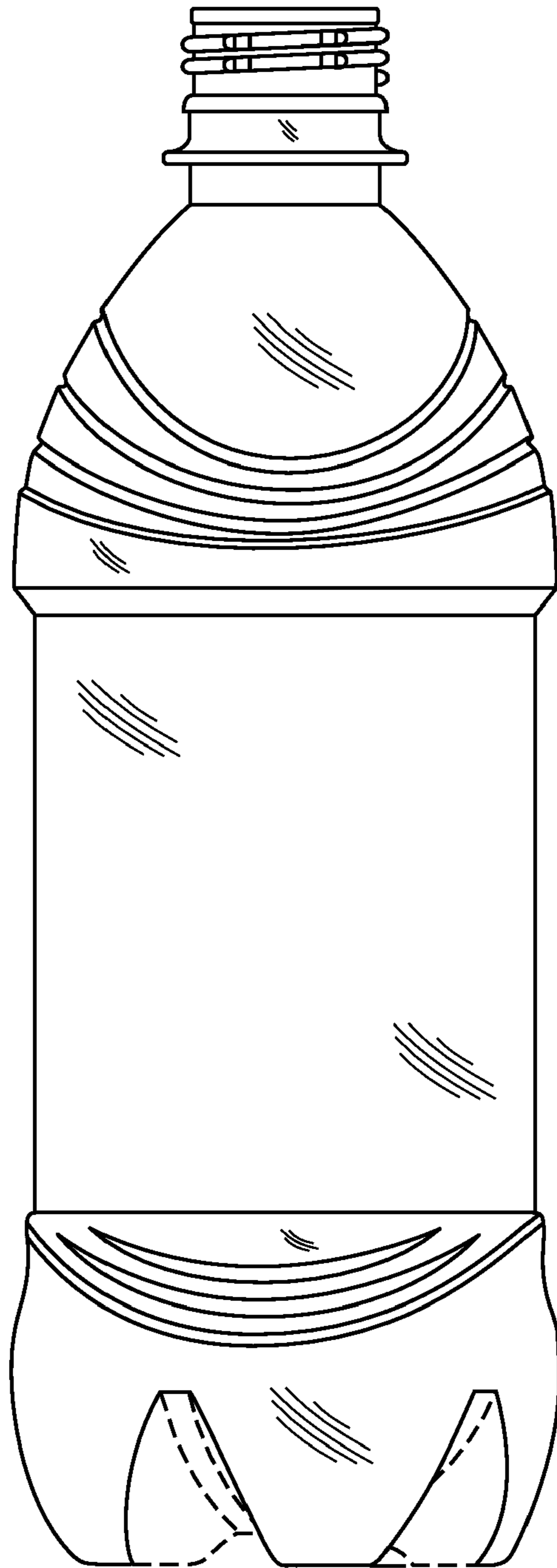

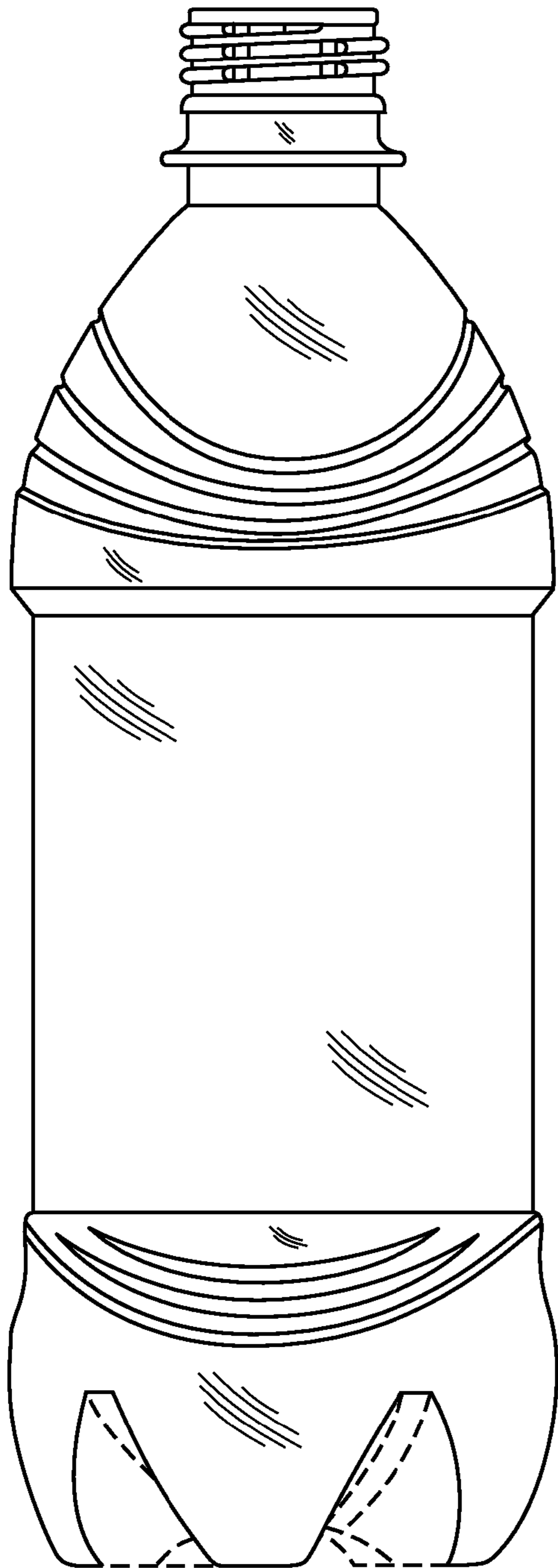

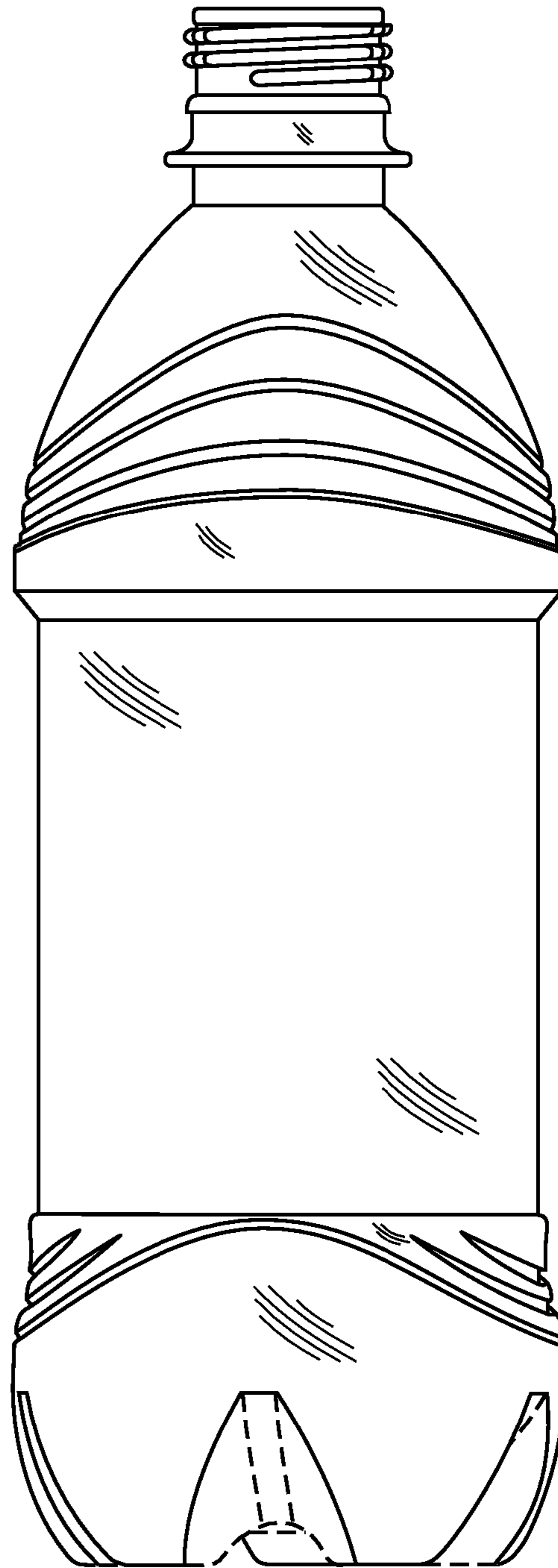

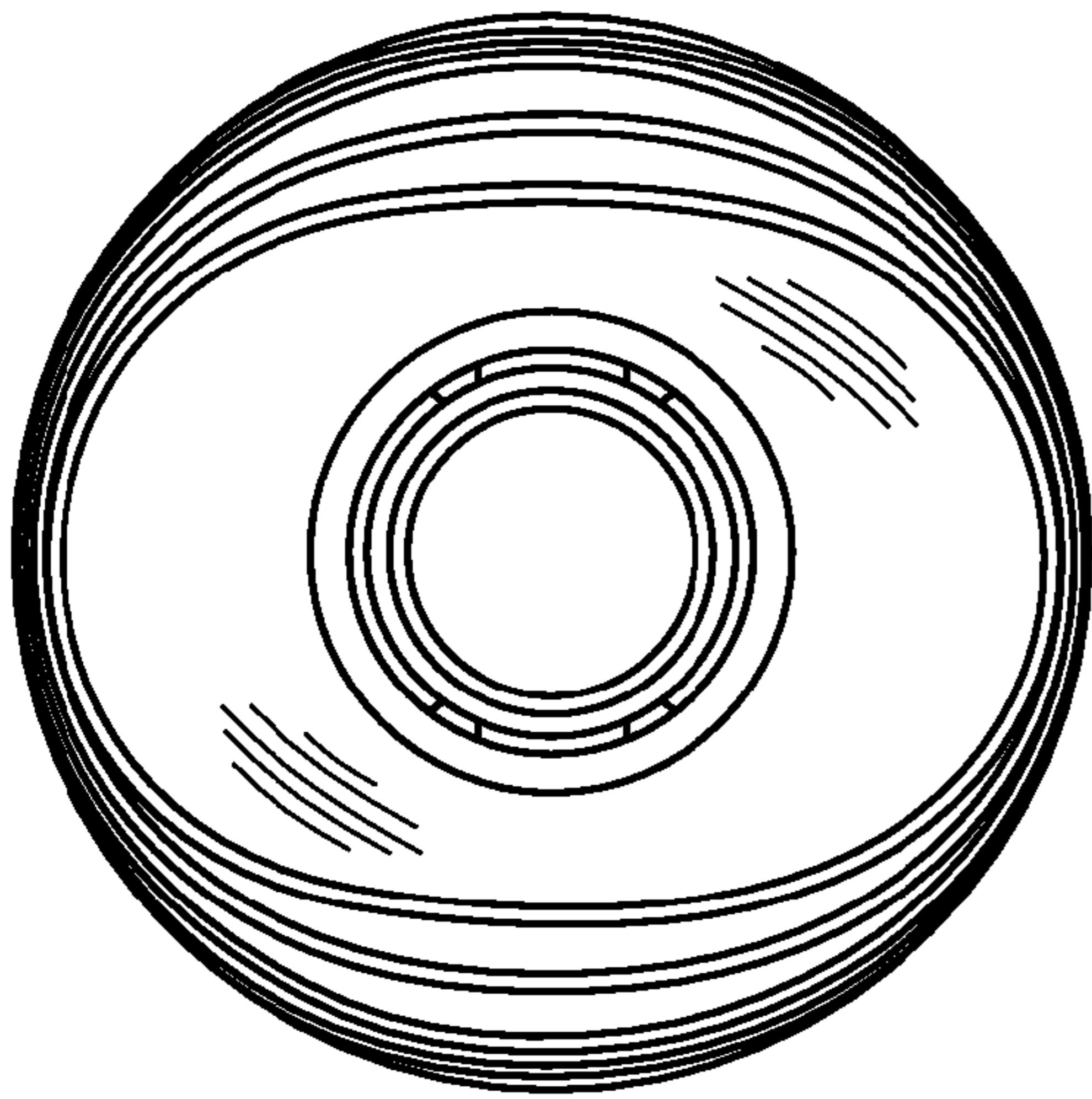

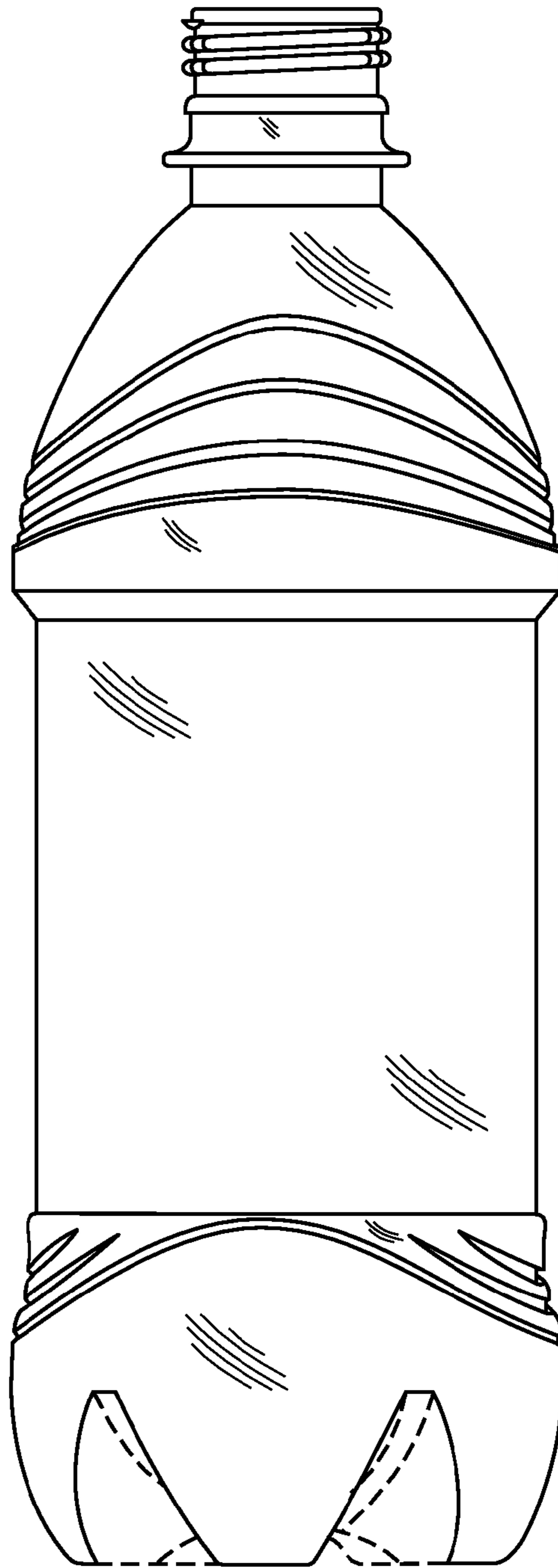
