(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a bottle of the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof, rotated 90° clockwise from FIG. 2;

FIG. 4 is a rear elevational view thereof, rotated 180° clockwise from FIG. 2;

FIG. 5 is a right side elevational view thereof, rotated 270° clockwise from FIG. 2; and,

FIG. 6 is a top plan view thereof, shown in the same orientation as FIG. 3.

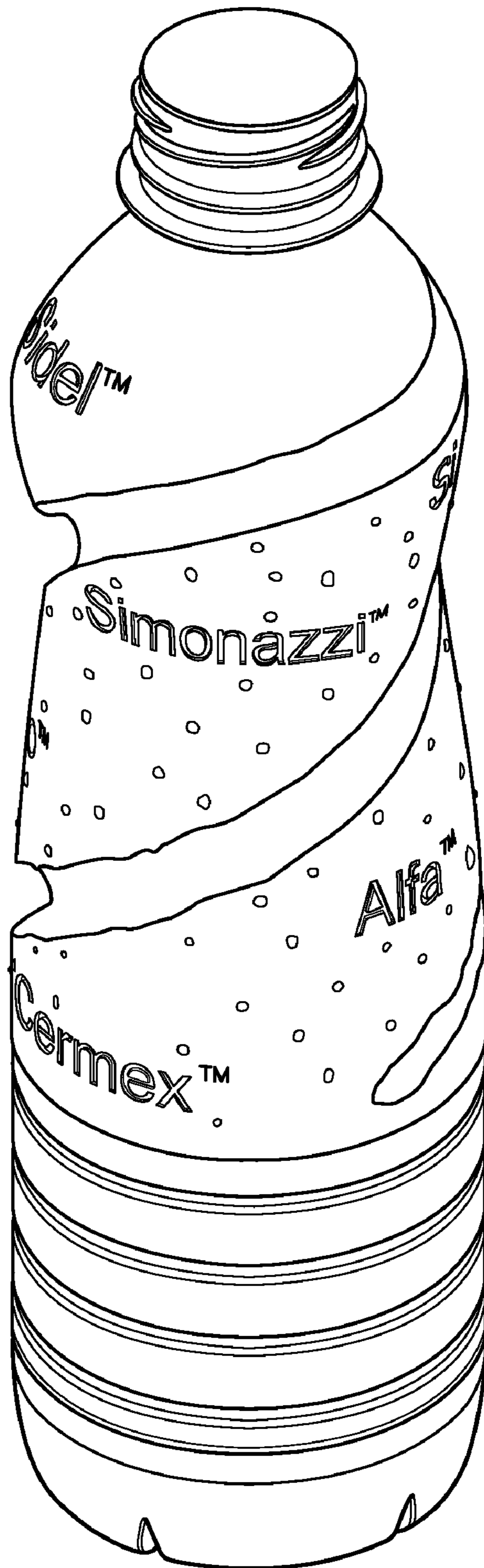

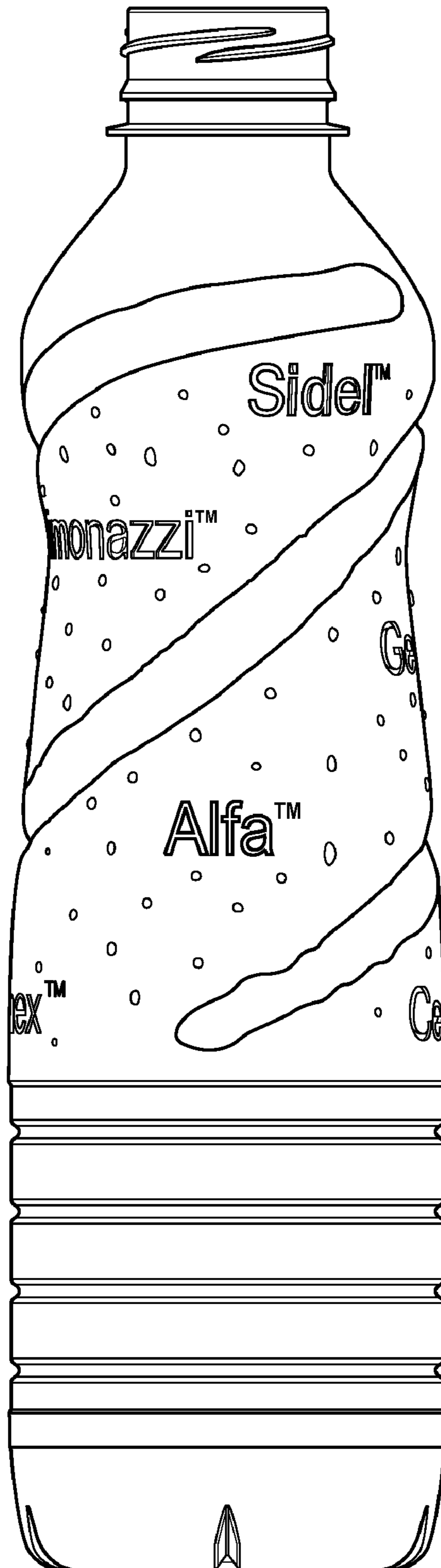

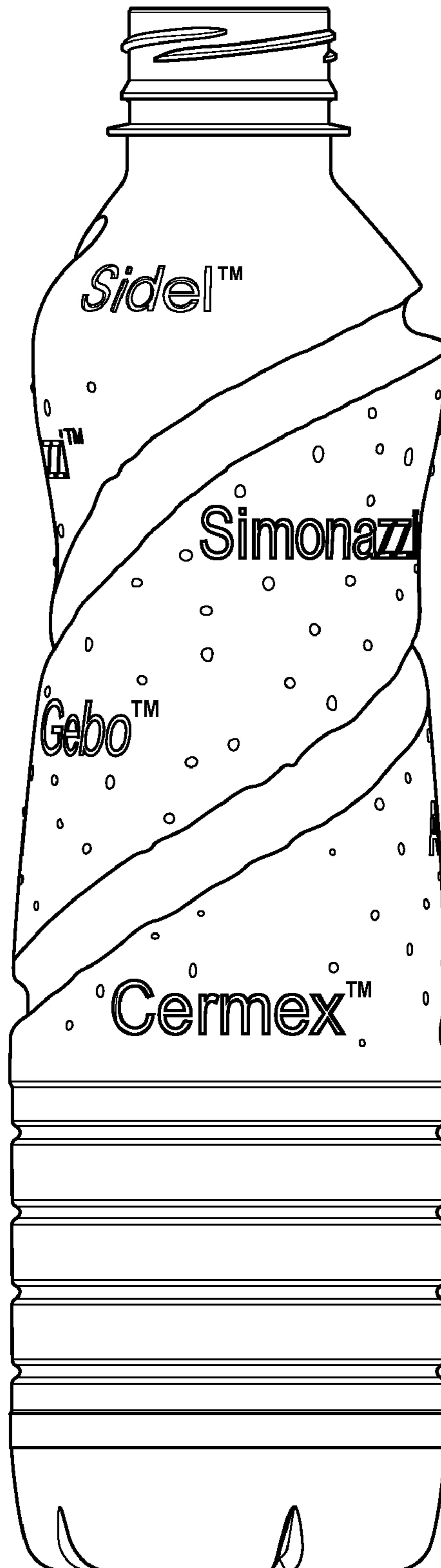

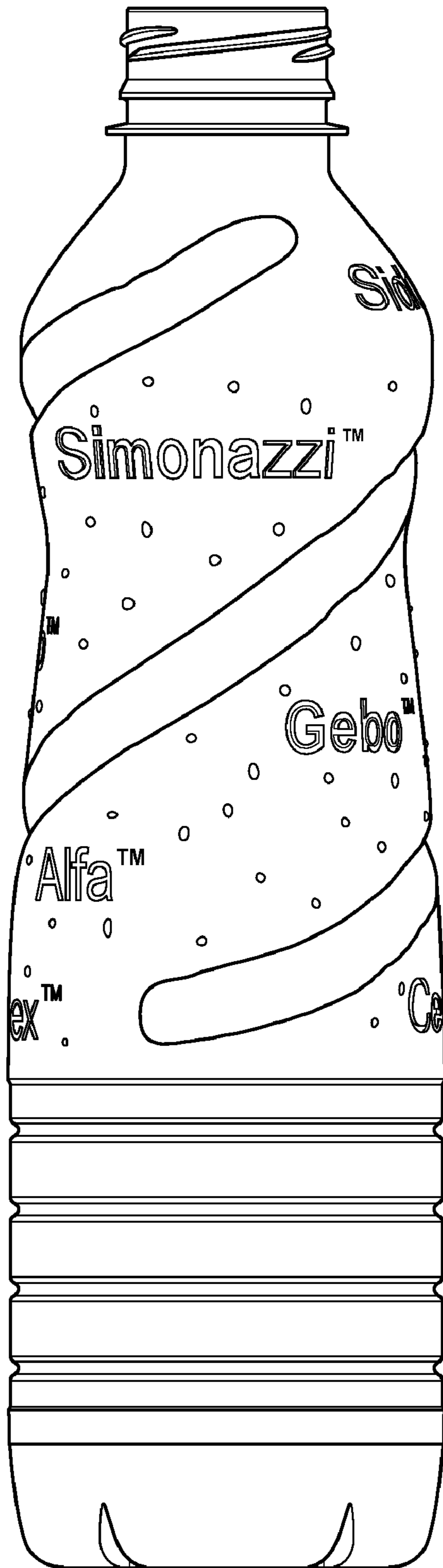

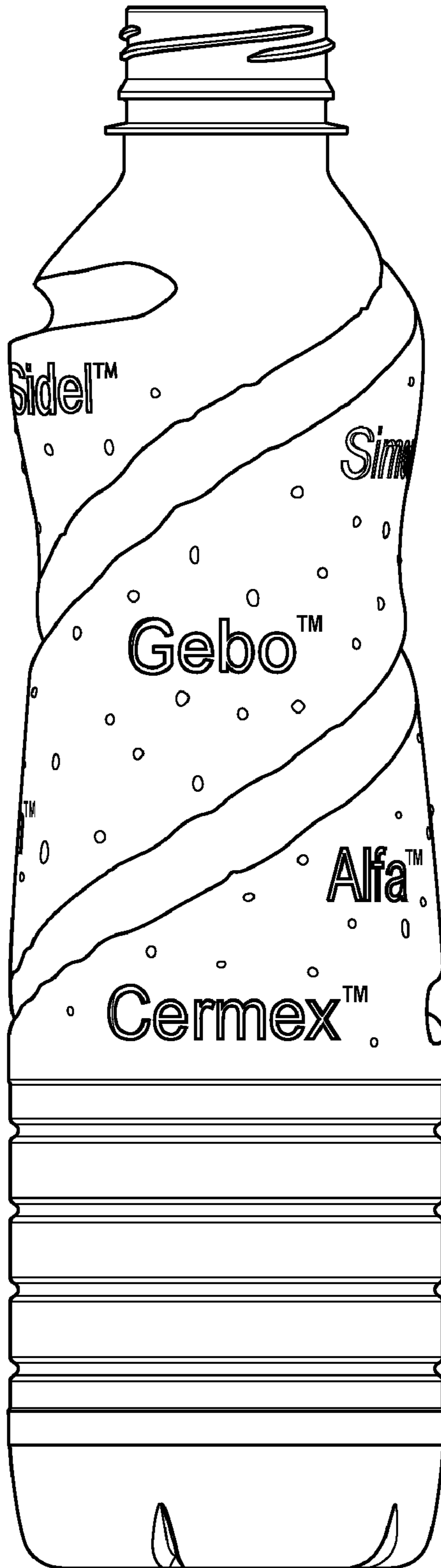
