(57) **CLAIM**

The ornamental design for a mouse pad in the shape of a basketball jersey, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a perspective view of a mouse pad in the shape of a basketball jersey.

FIG. 2 is a front elevational view of a mouse pad in the shape of a basketball jersey.

FIG. 3 is a rear elevational view of a mouse pad in the shape of a basketball jersey.

FIG. 4 is a top view of a mouse pad in the shape of a basketball jersey.

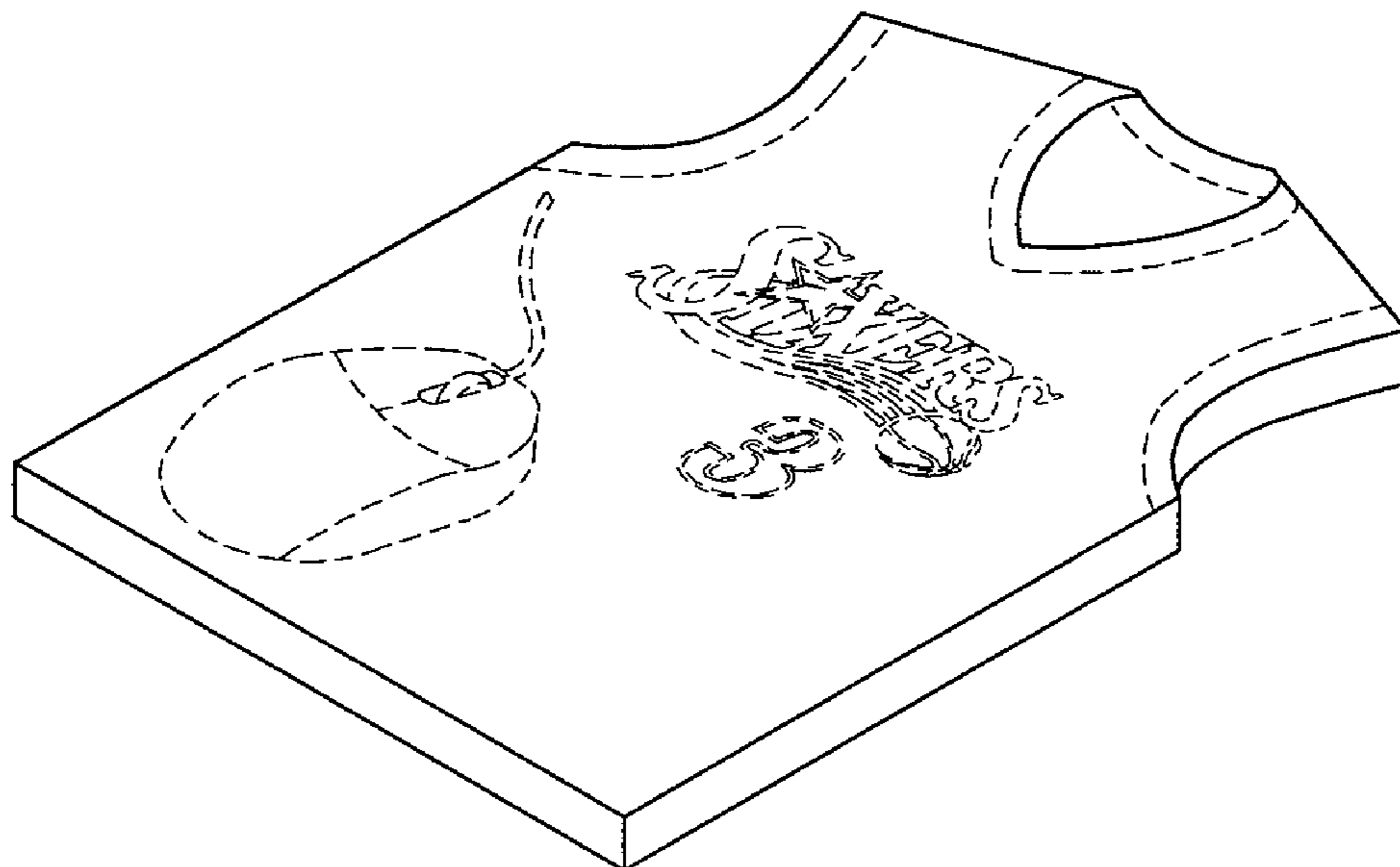
FIG. 5 is a bottom view of a mouse pad in the shape of a basketball jersey.

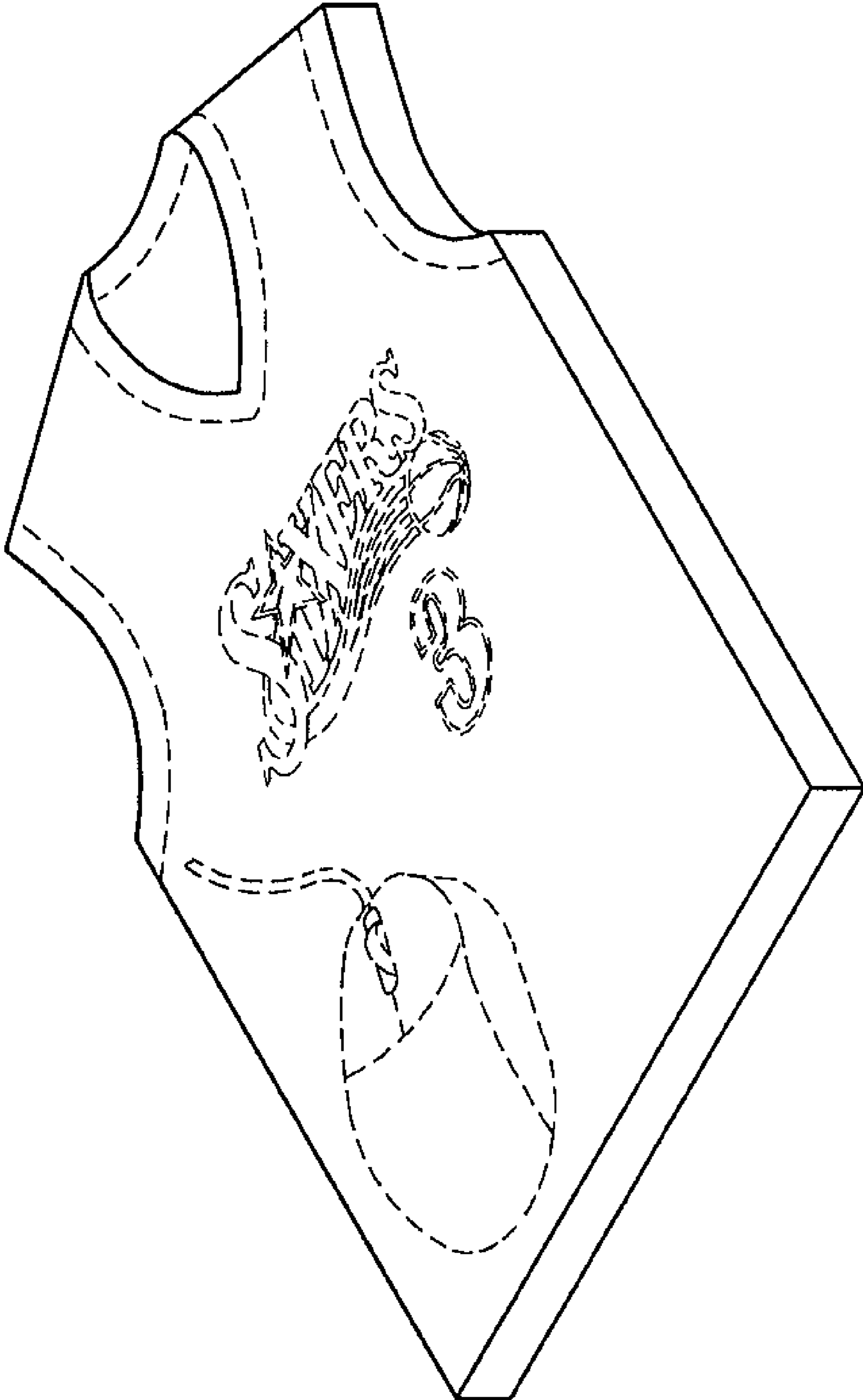

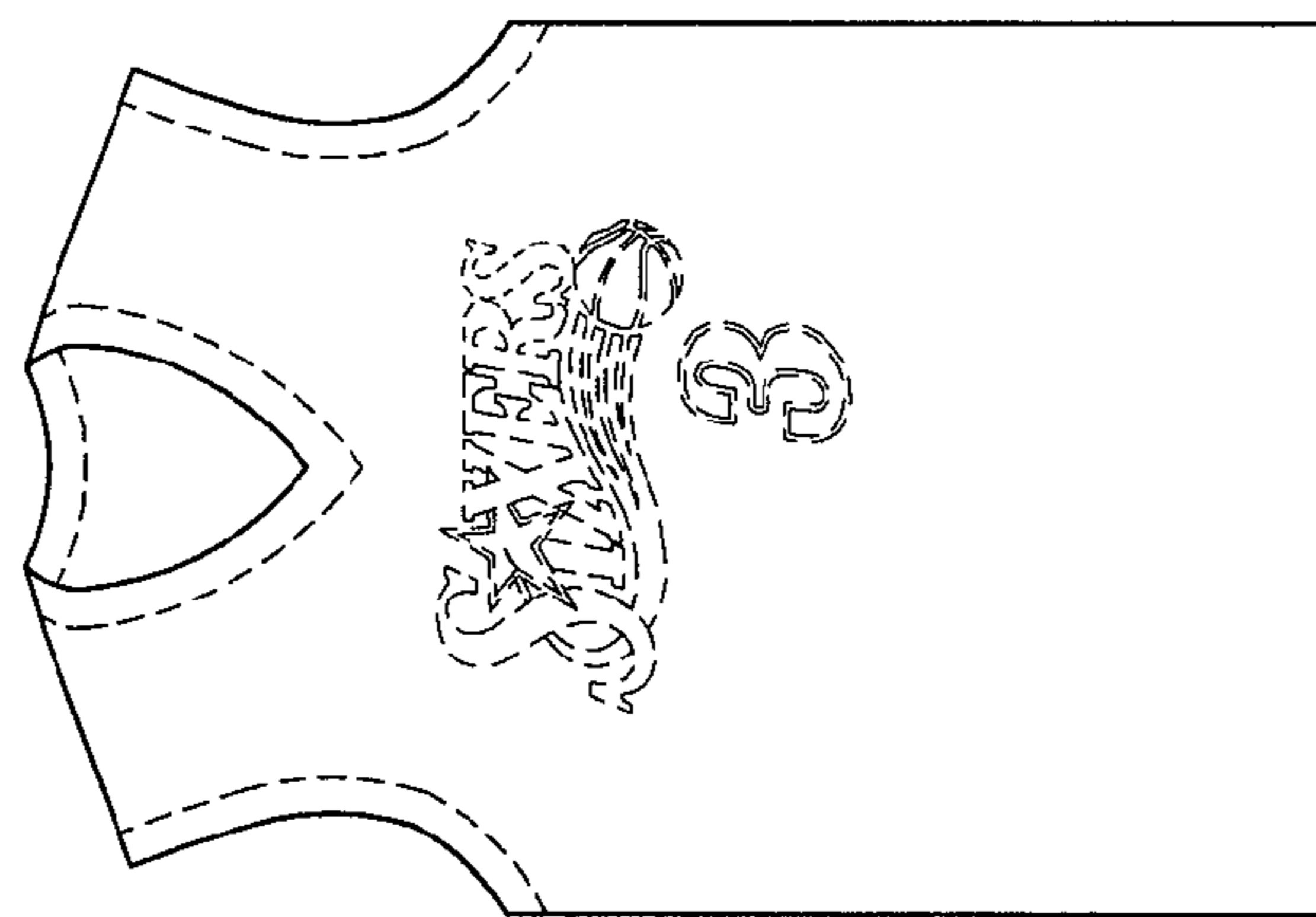

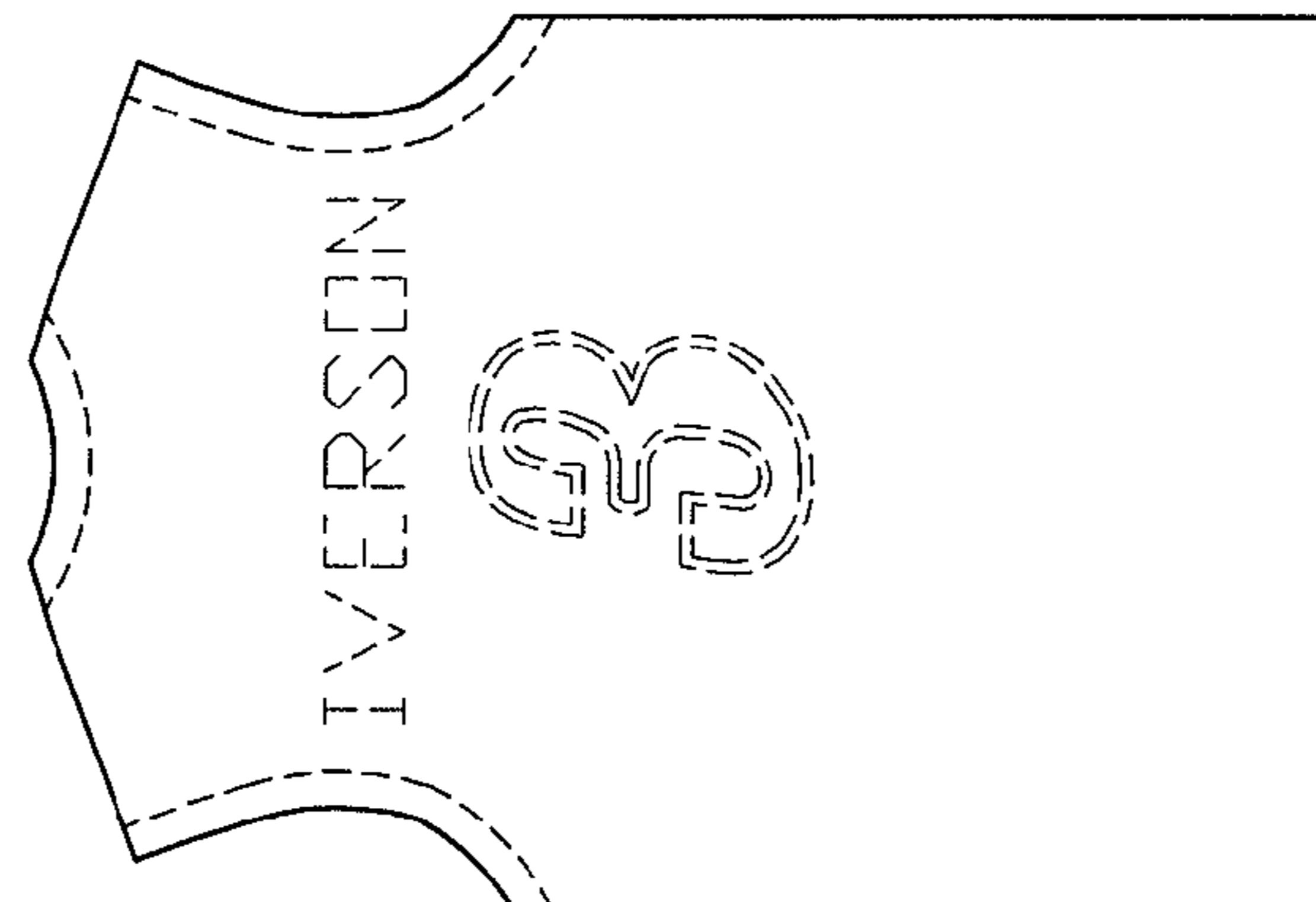
