**DESCRIPTION**

FIG. 1 is a perspective view of a computer printer, showing my new design;

FIG. 3 is a front elevational view thereof;

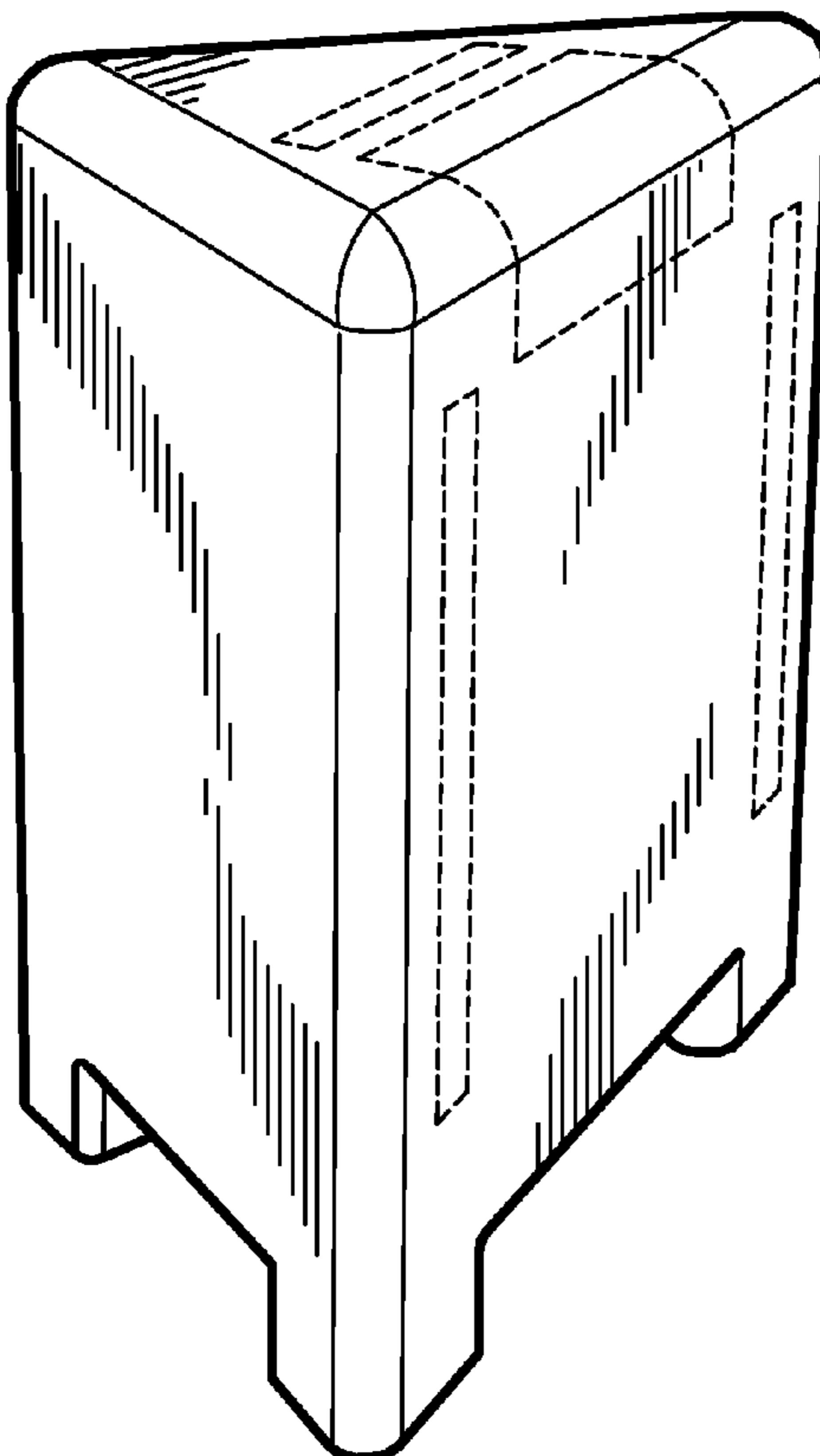
FIG. 4 is a bottom plan view thereof;

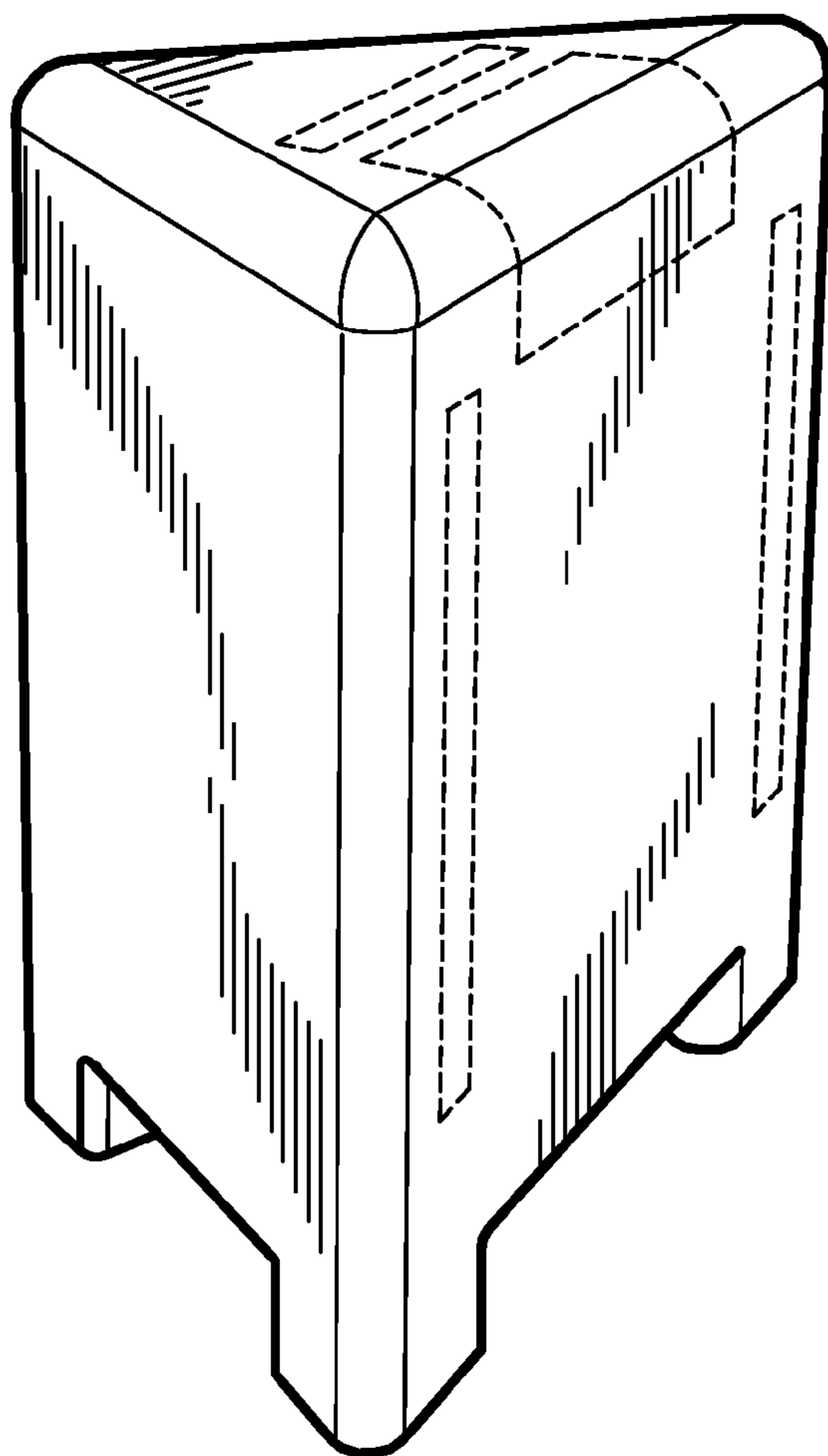

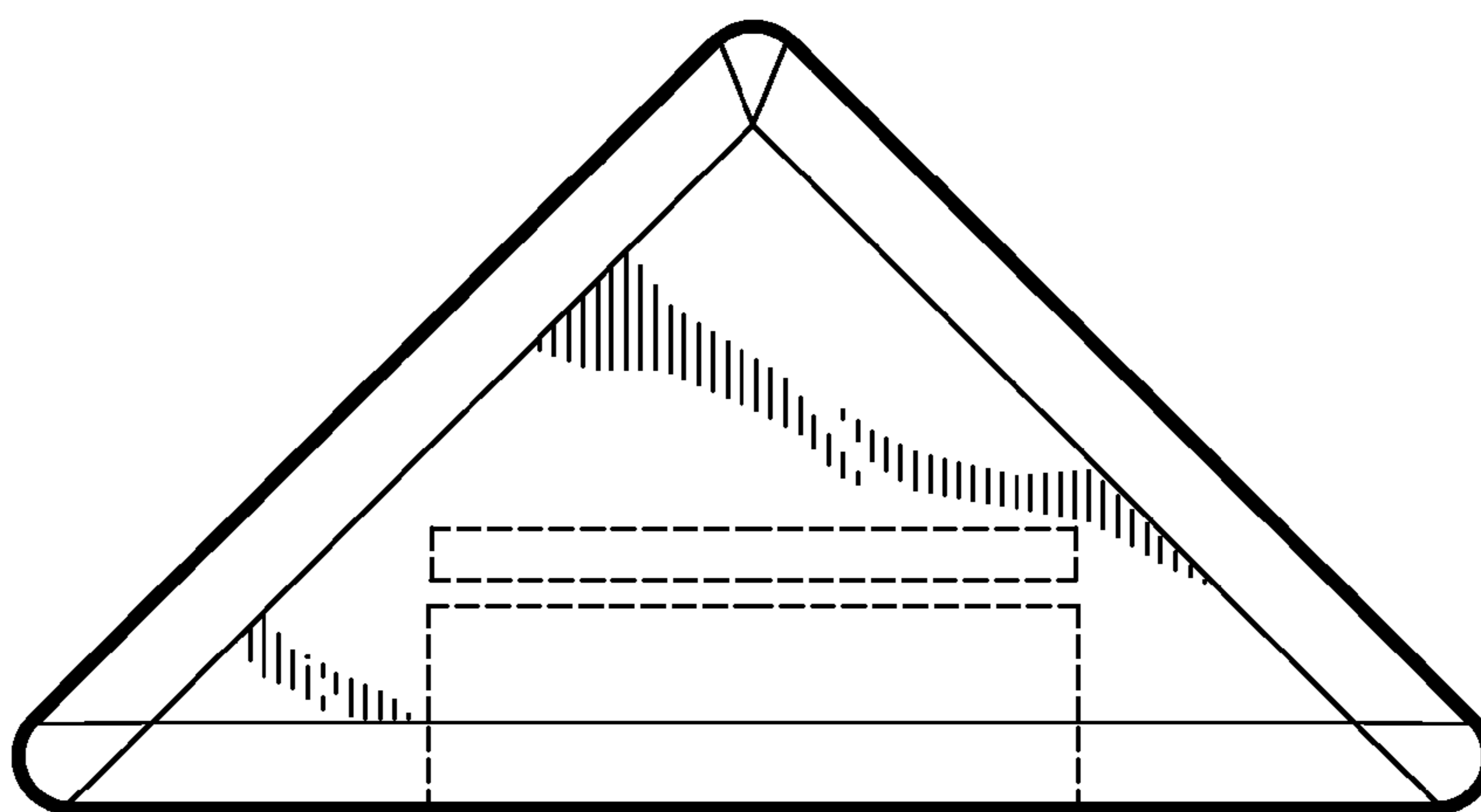

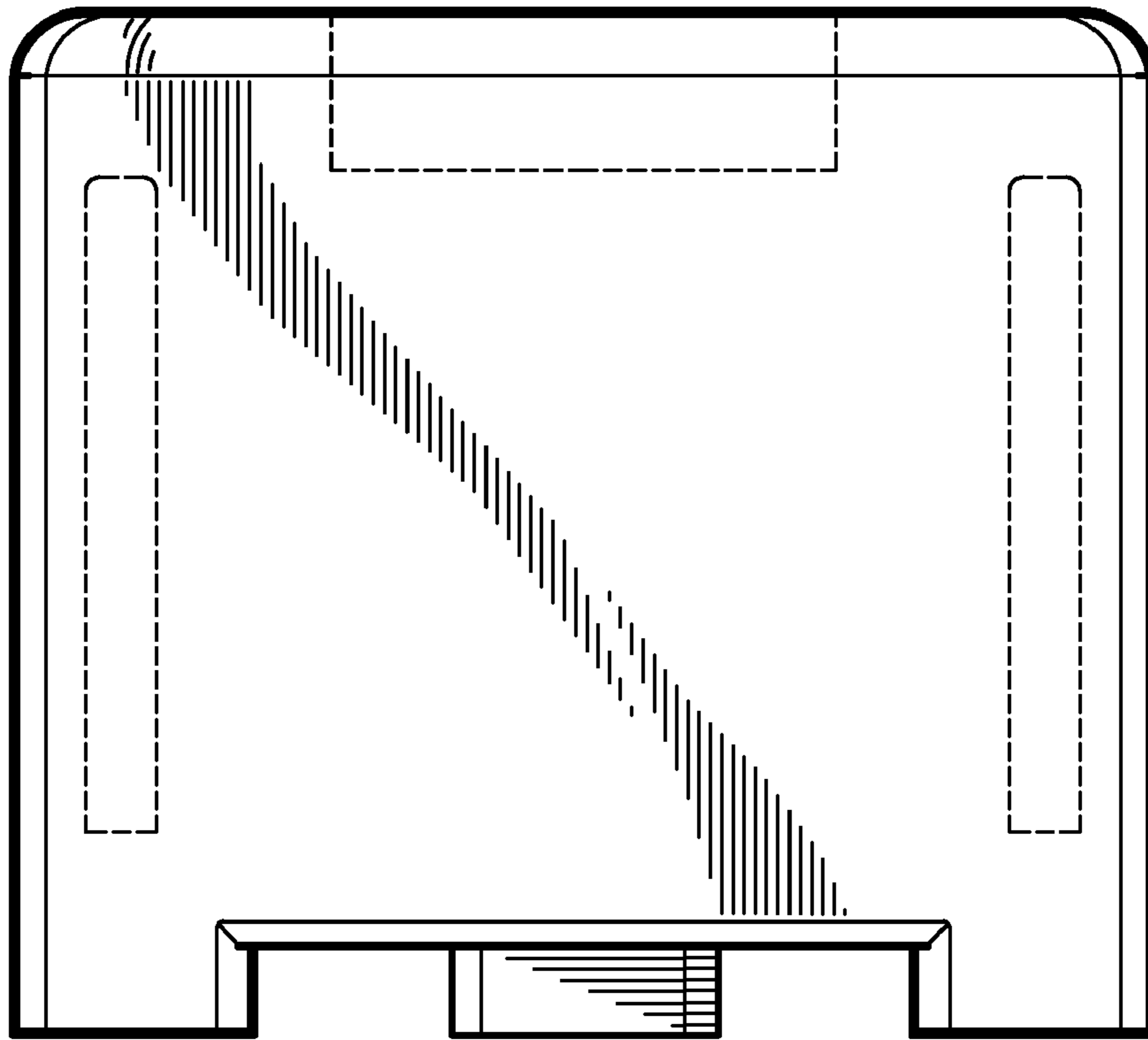

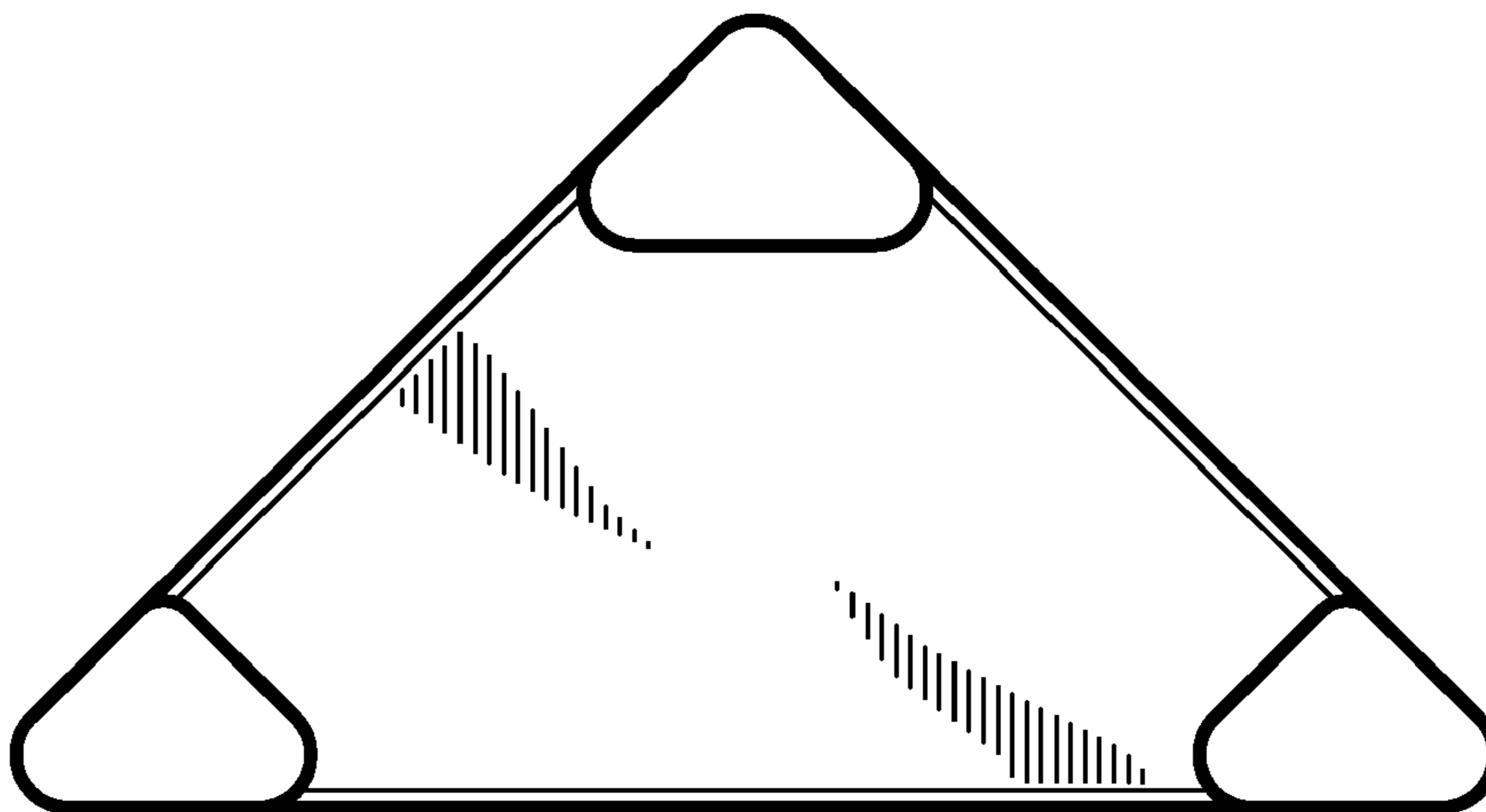

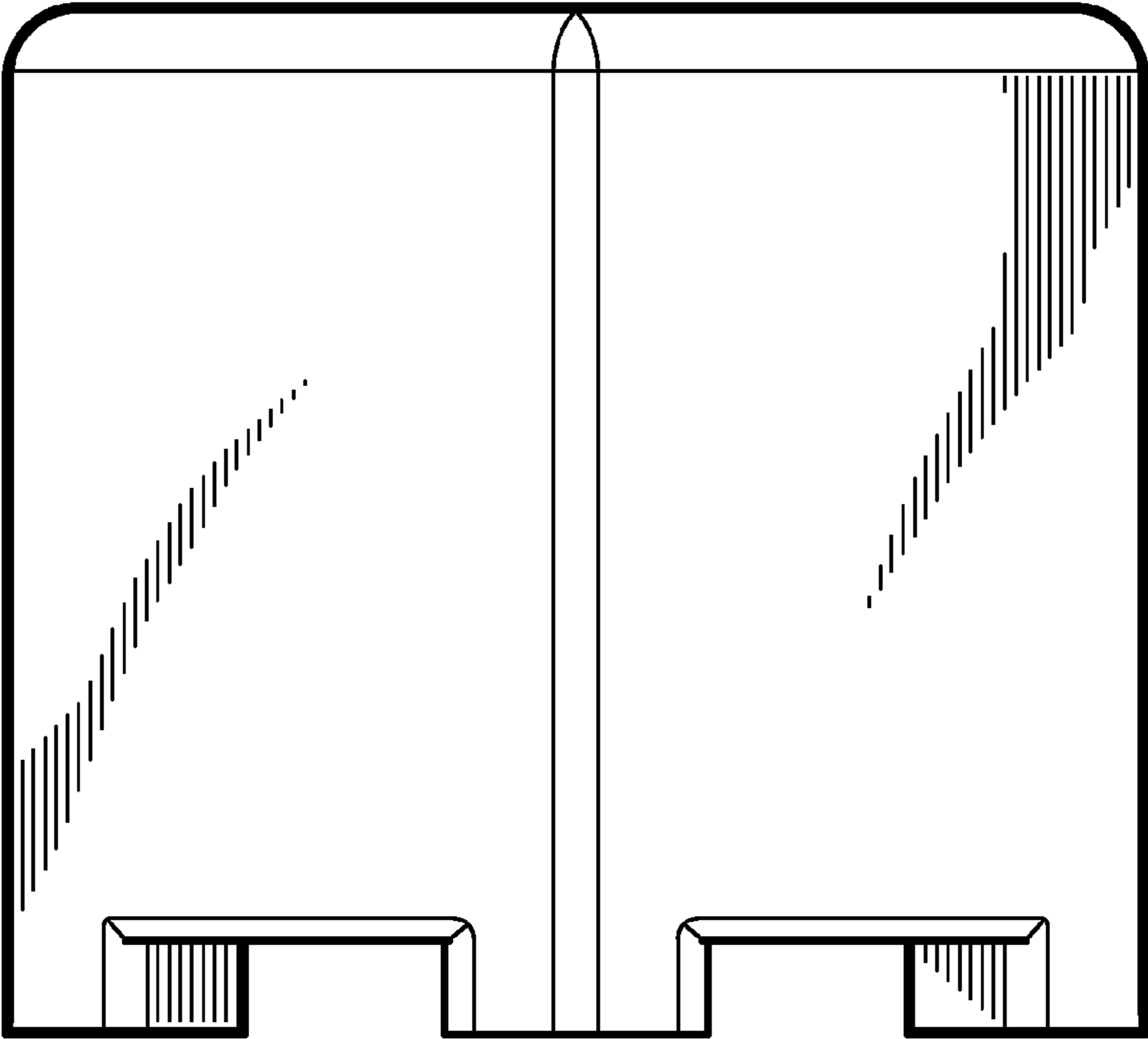

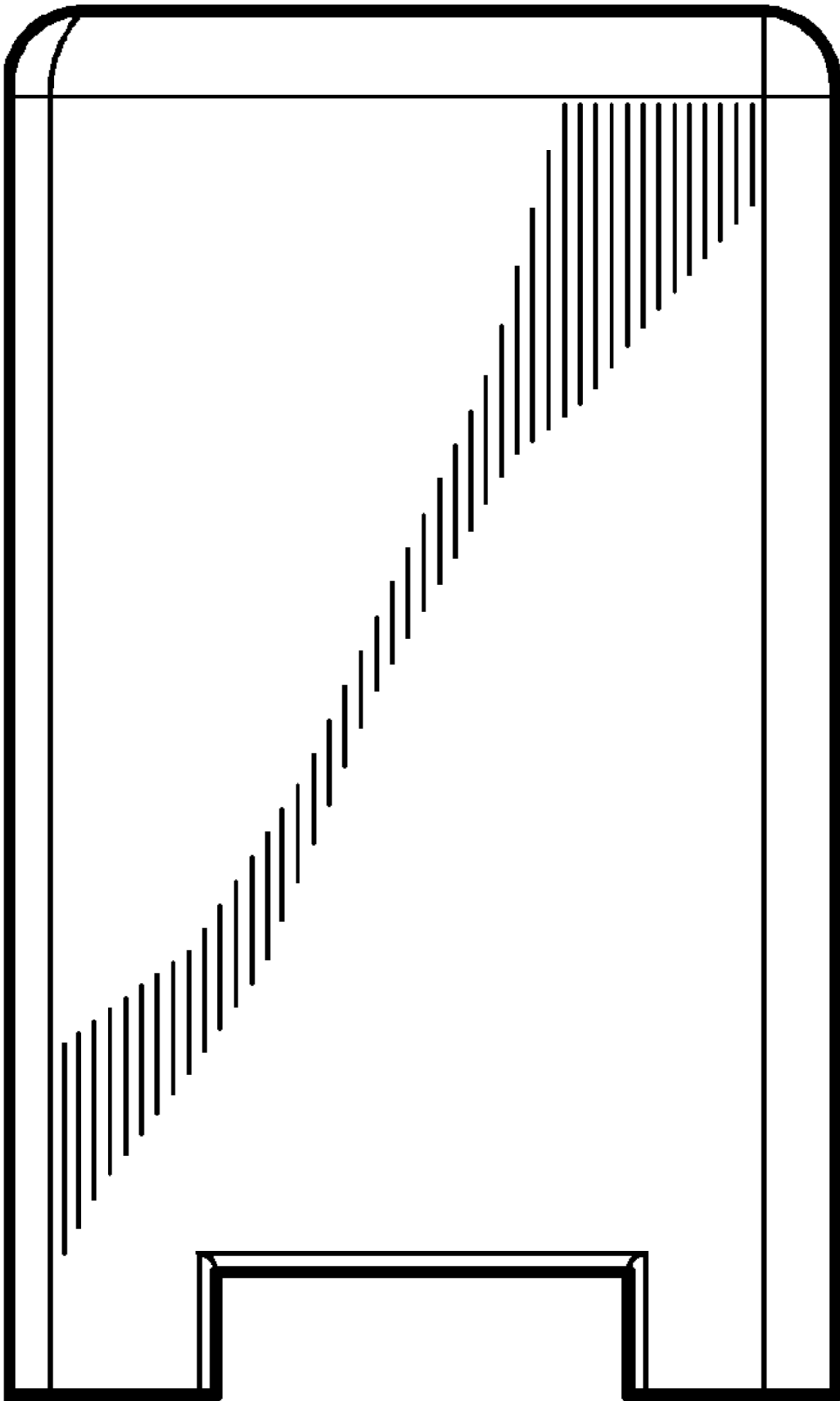
