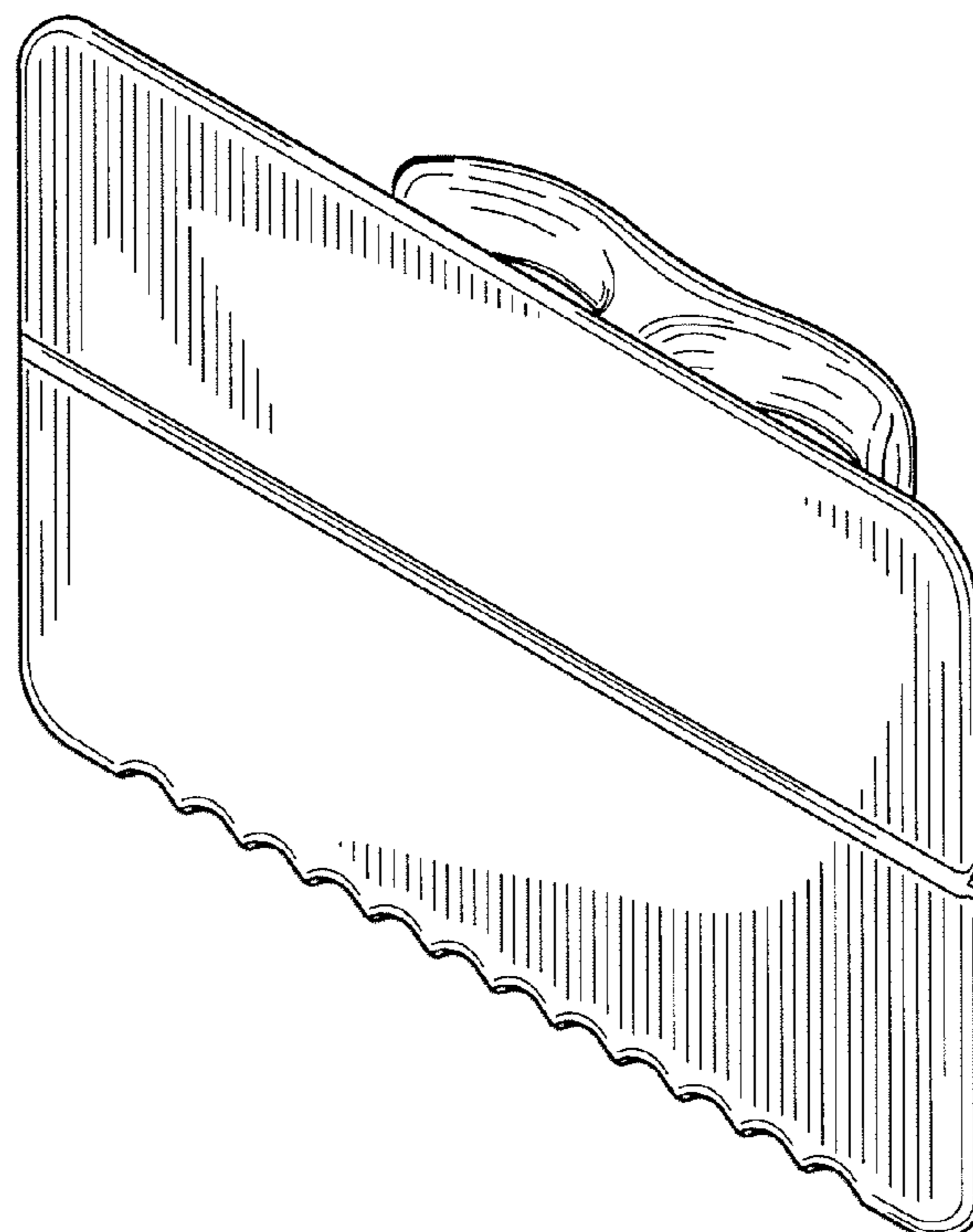
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a finger guard;
FIG. 2 is a top view of the finger guard;
FIG. 3 is a back view of the finger guard;
FIG. 4 is a bottom view of the finger guard;
FIG. 5 is a left side view of the finger guard, the right side view being a mirror image; and,

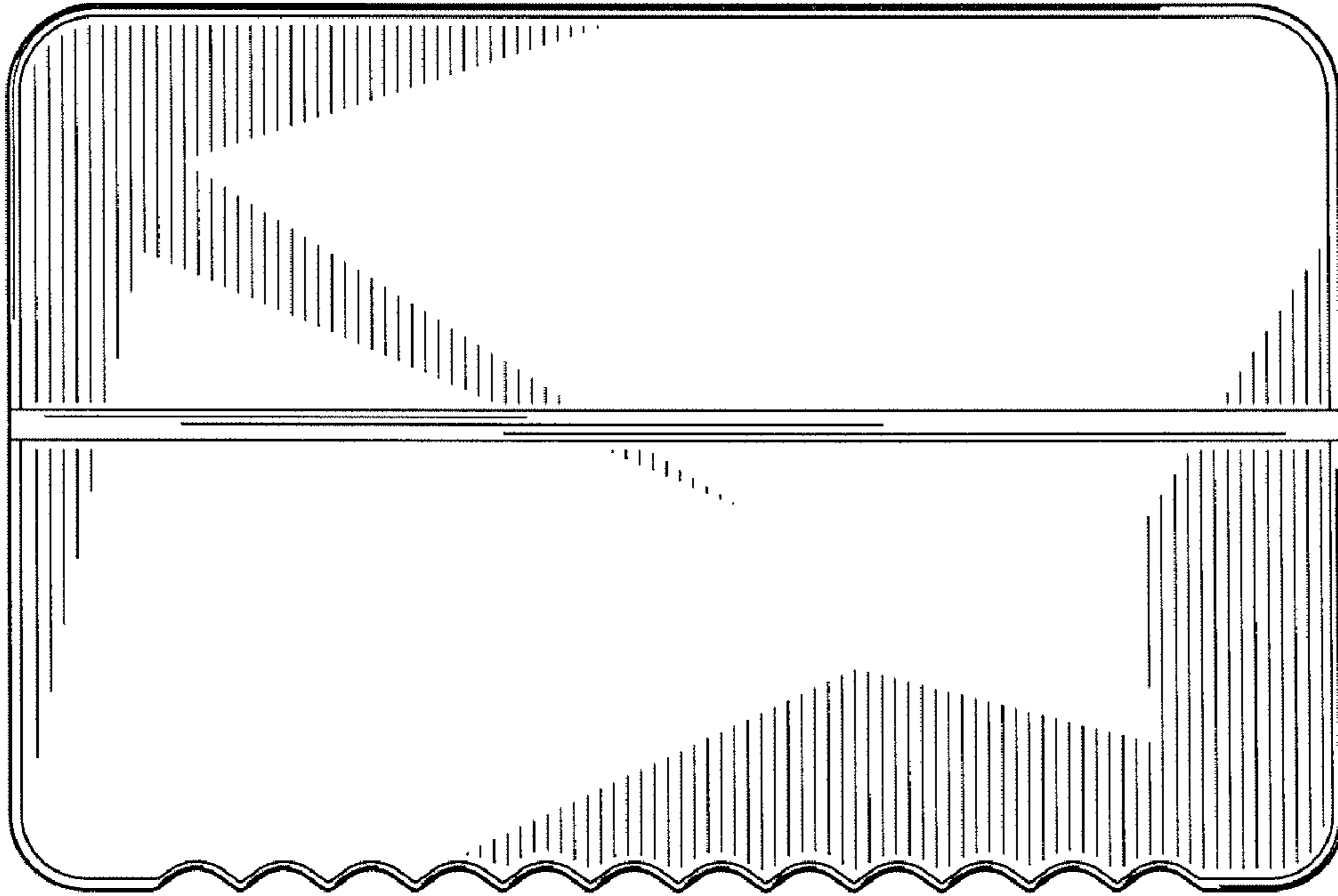

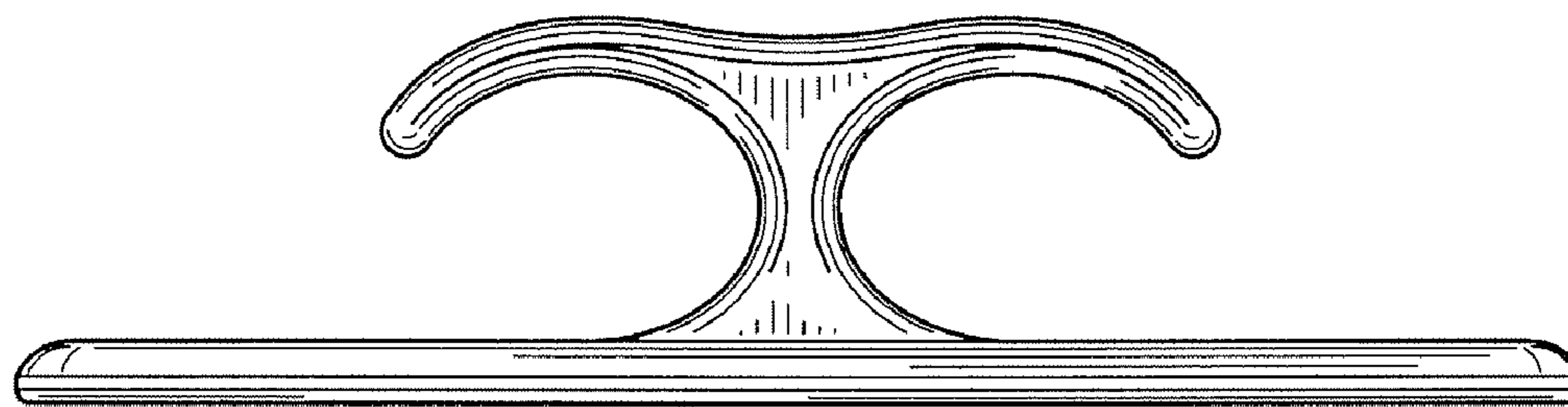

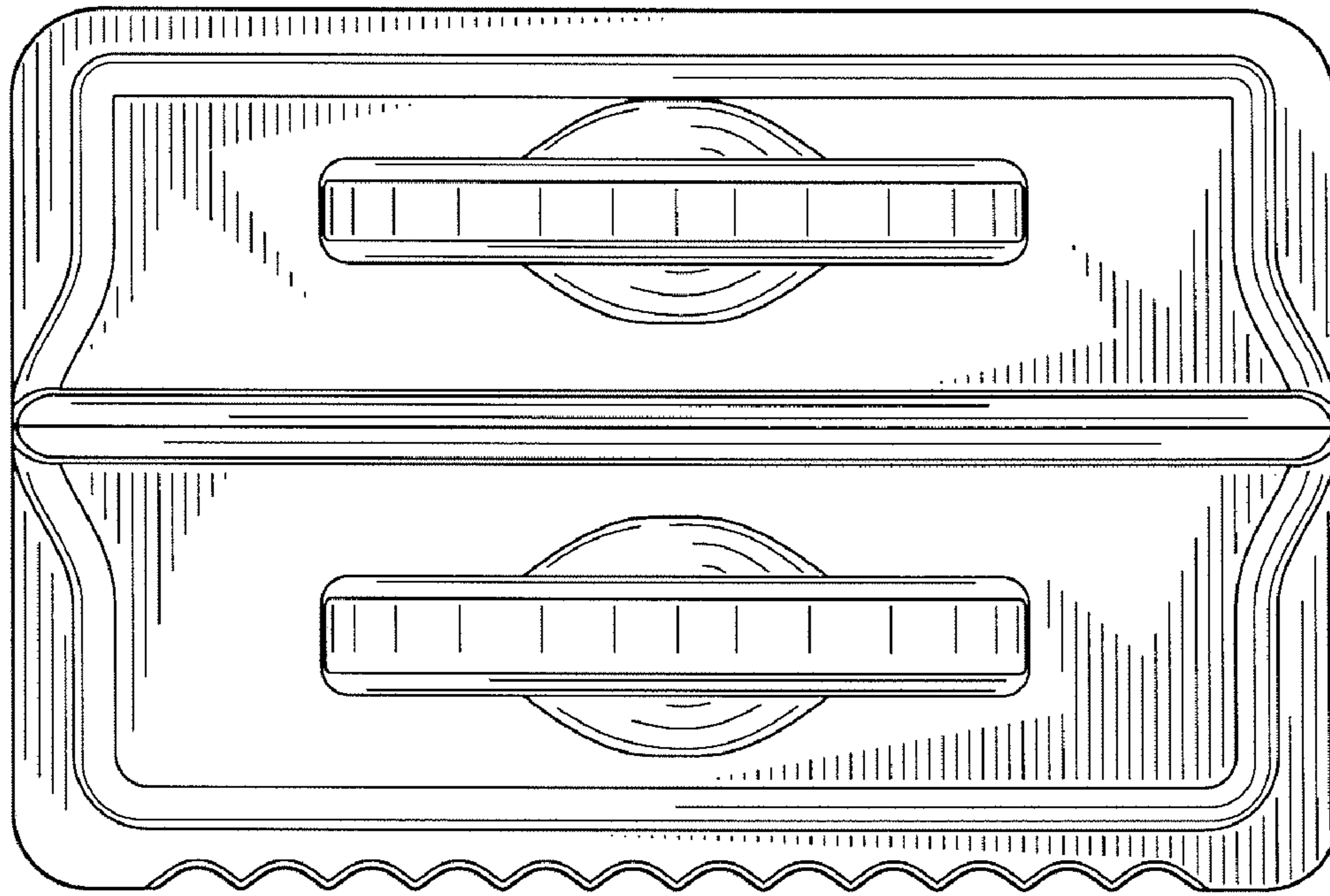

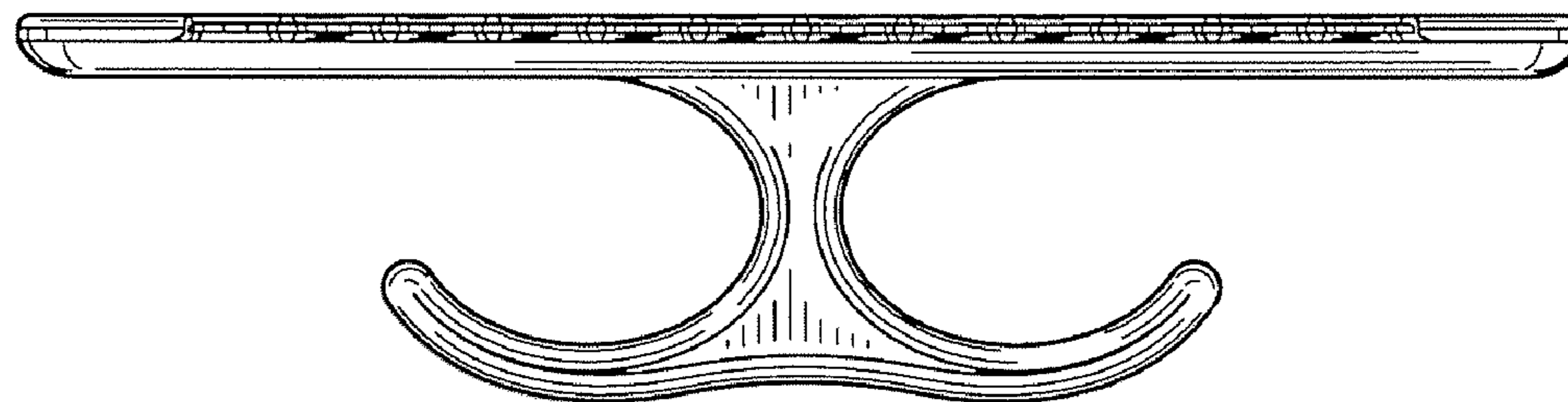

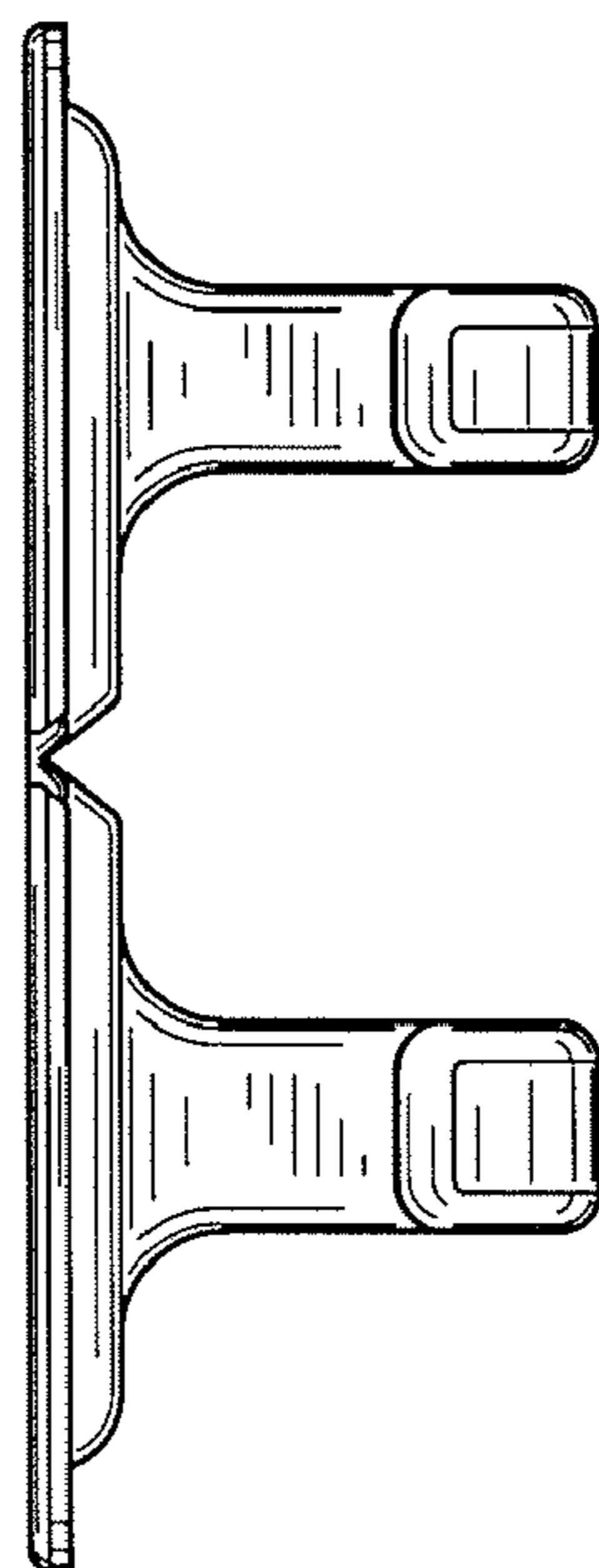

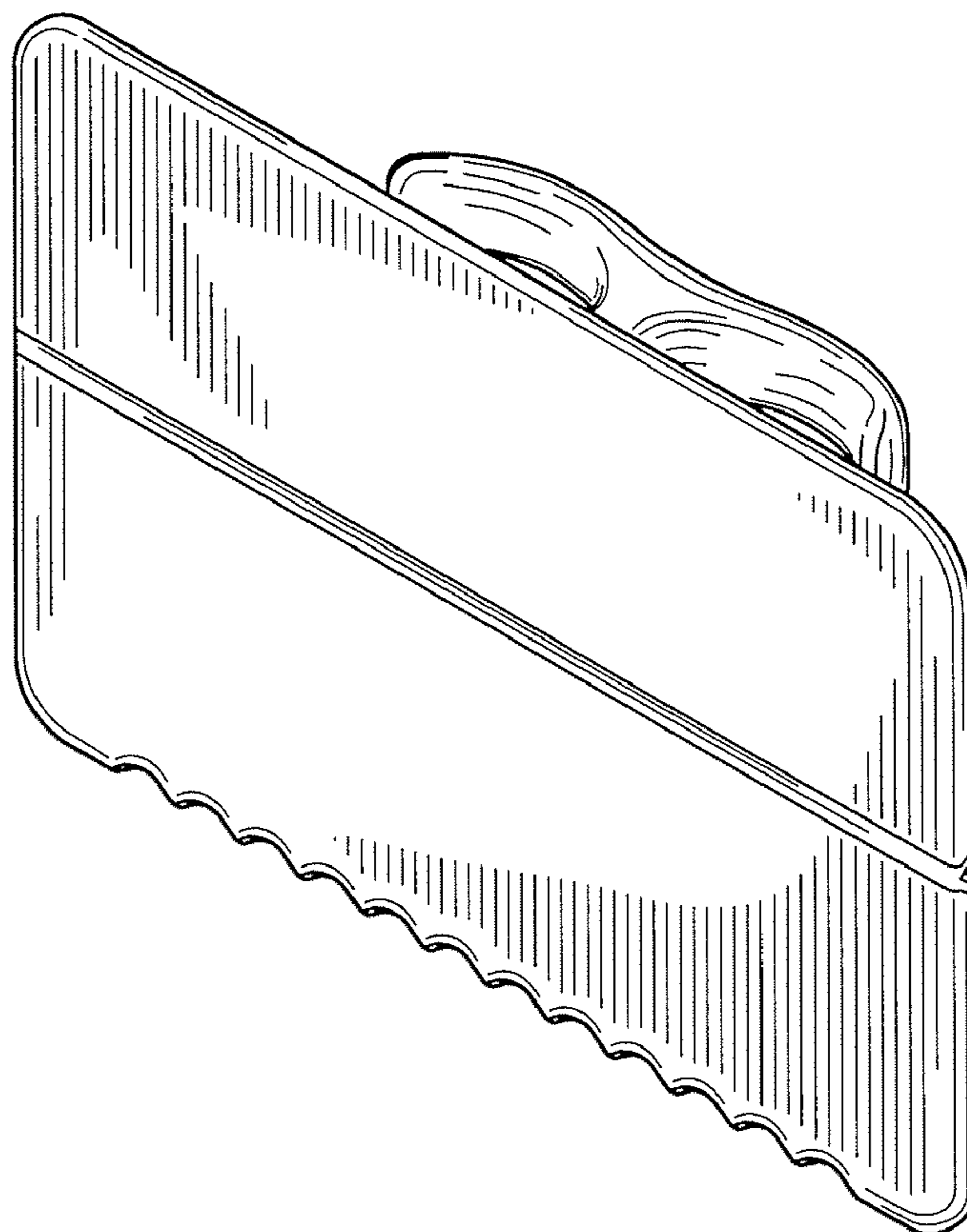
