FIG. 3 is a lateral side view thereof;

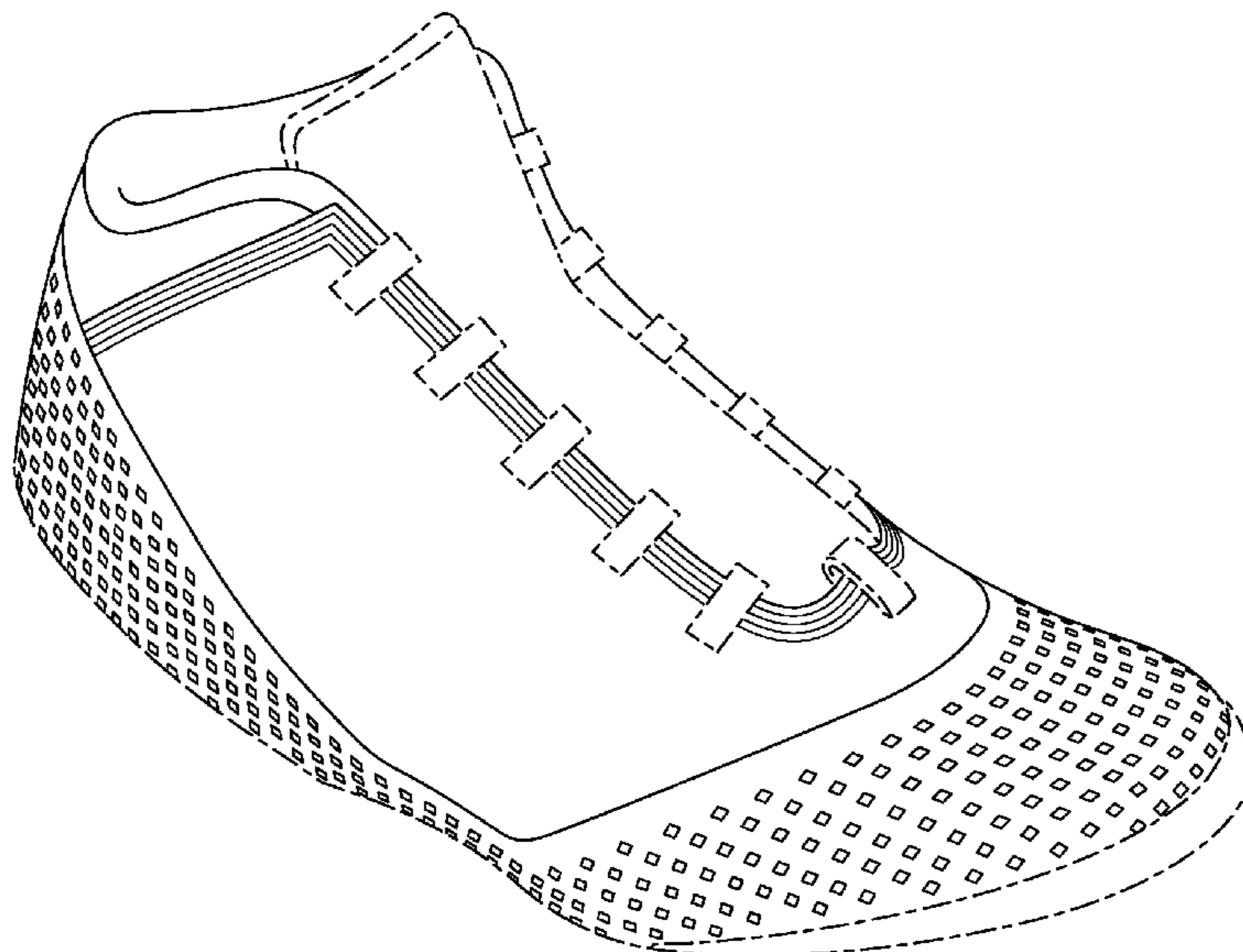
FIG. 4 is front view thereof;

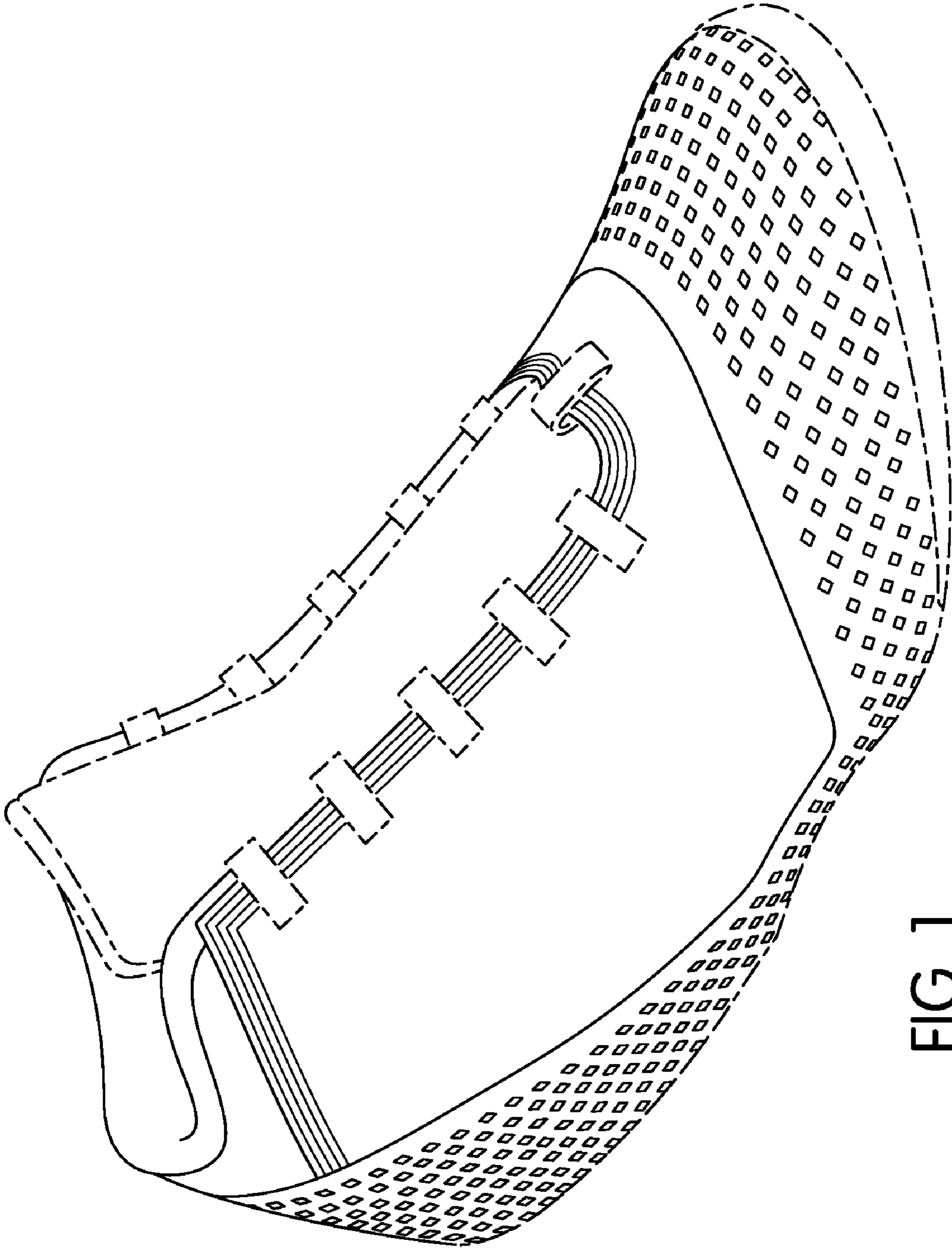

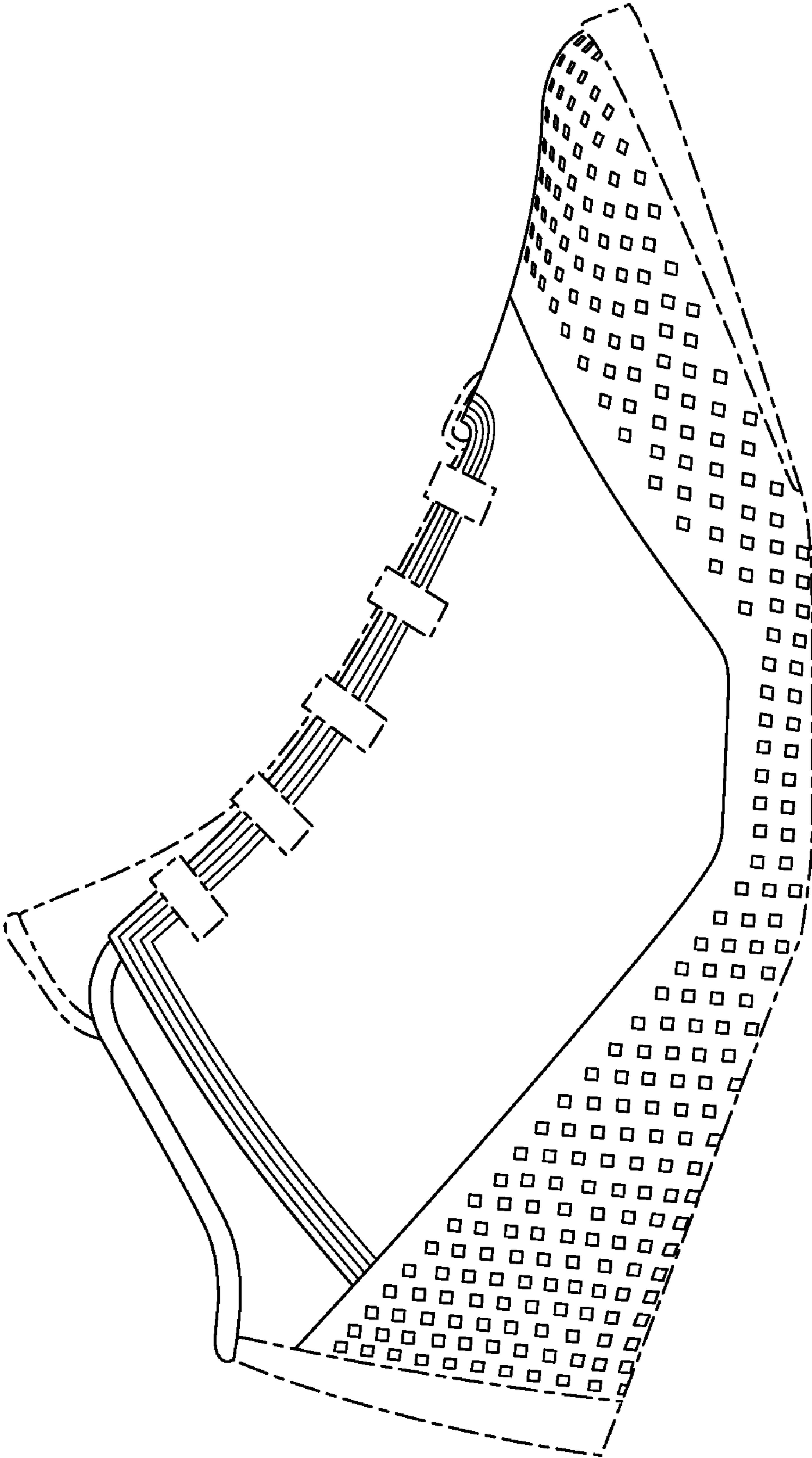

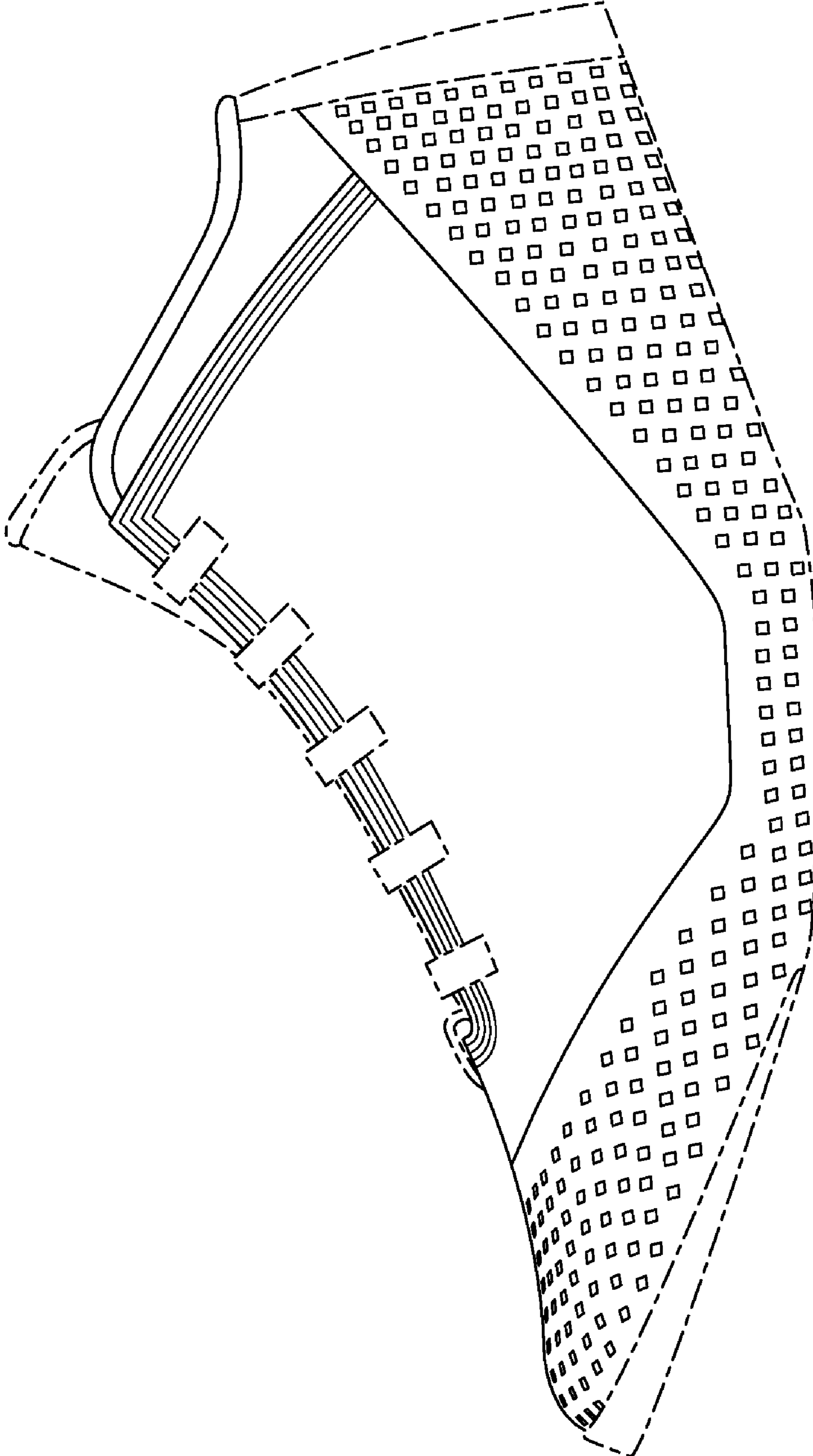

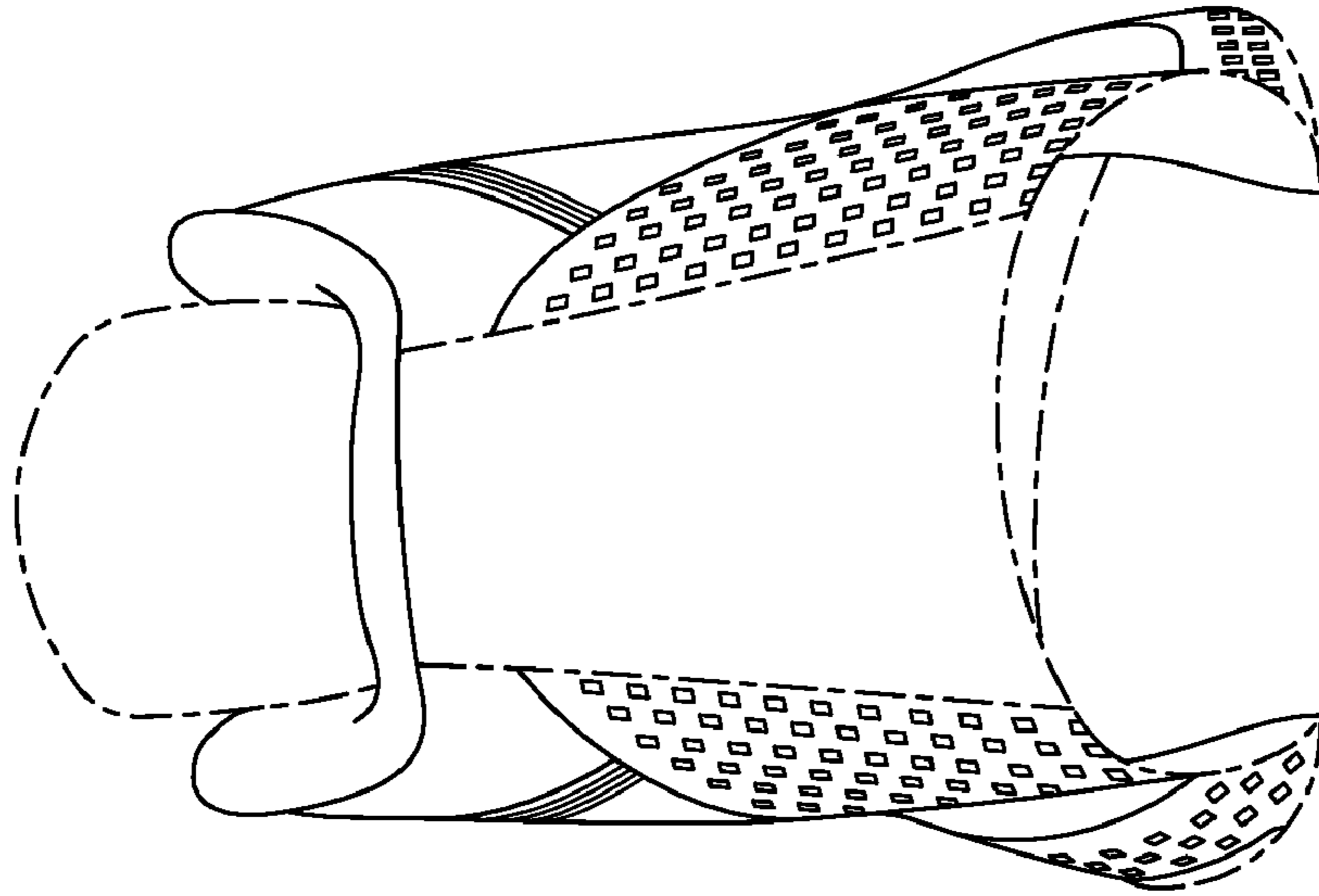

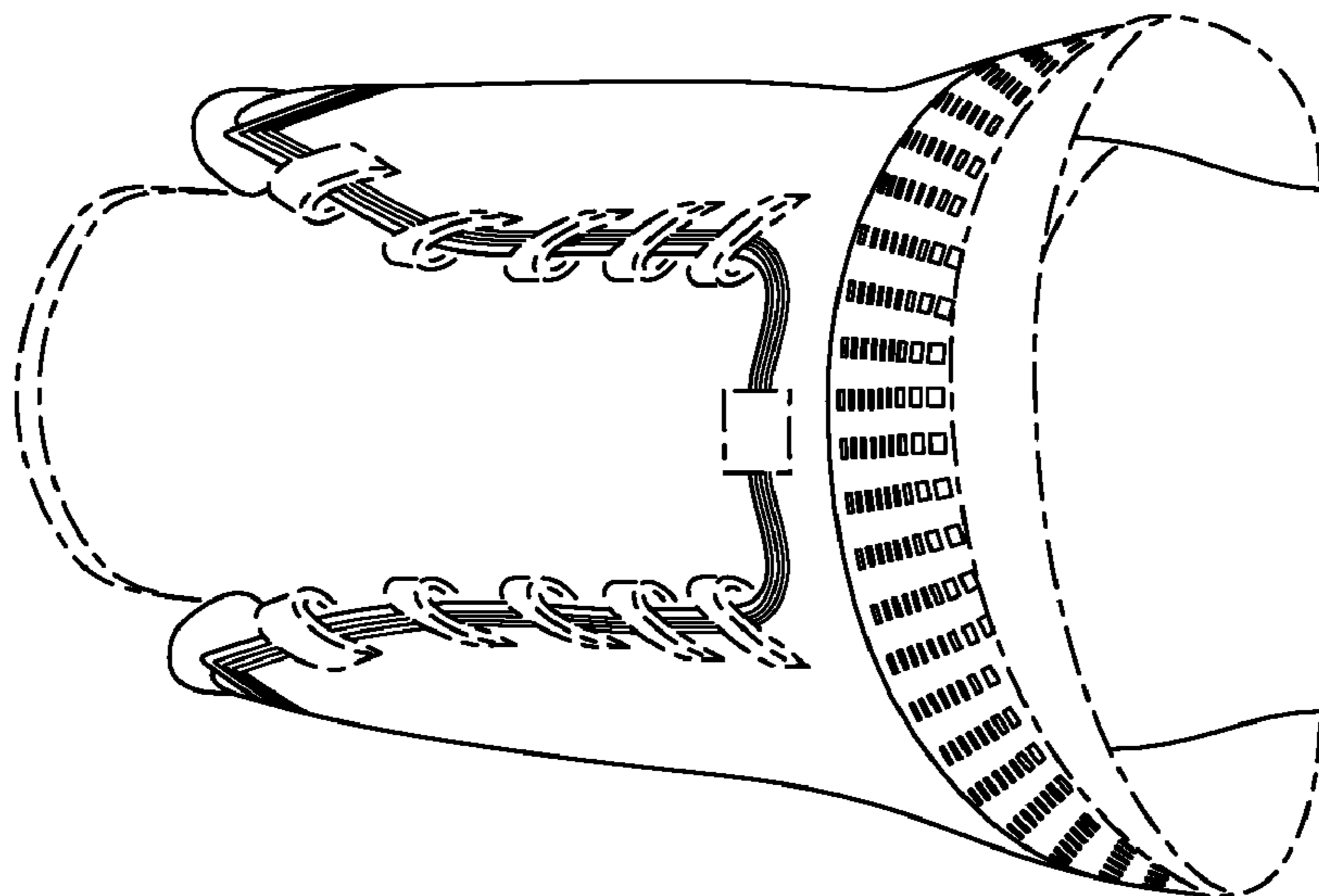

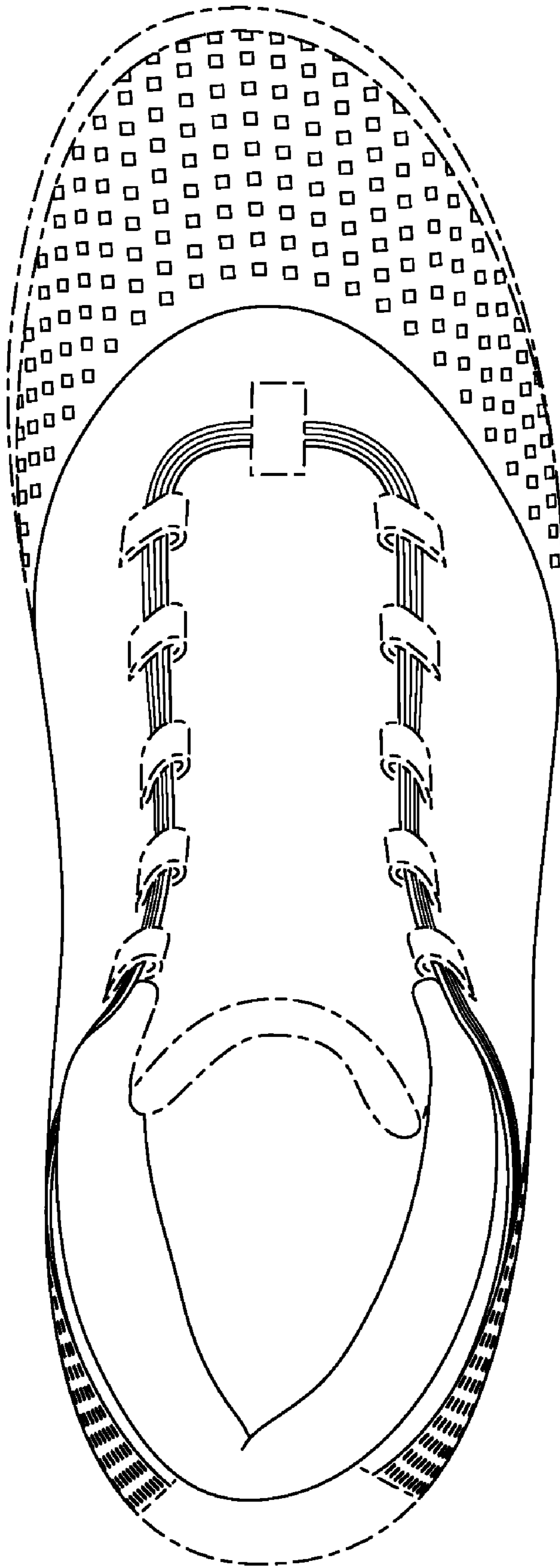
