(57) **CLAIM**

The ornamental design for a storage box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the present invention with the storage box shown closed;

FIG. 2 is a front perspective view of the storage box as shown in a closed position;

FIG. 3 is a rear view of the storage box thereof;

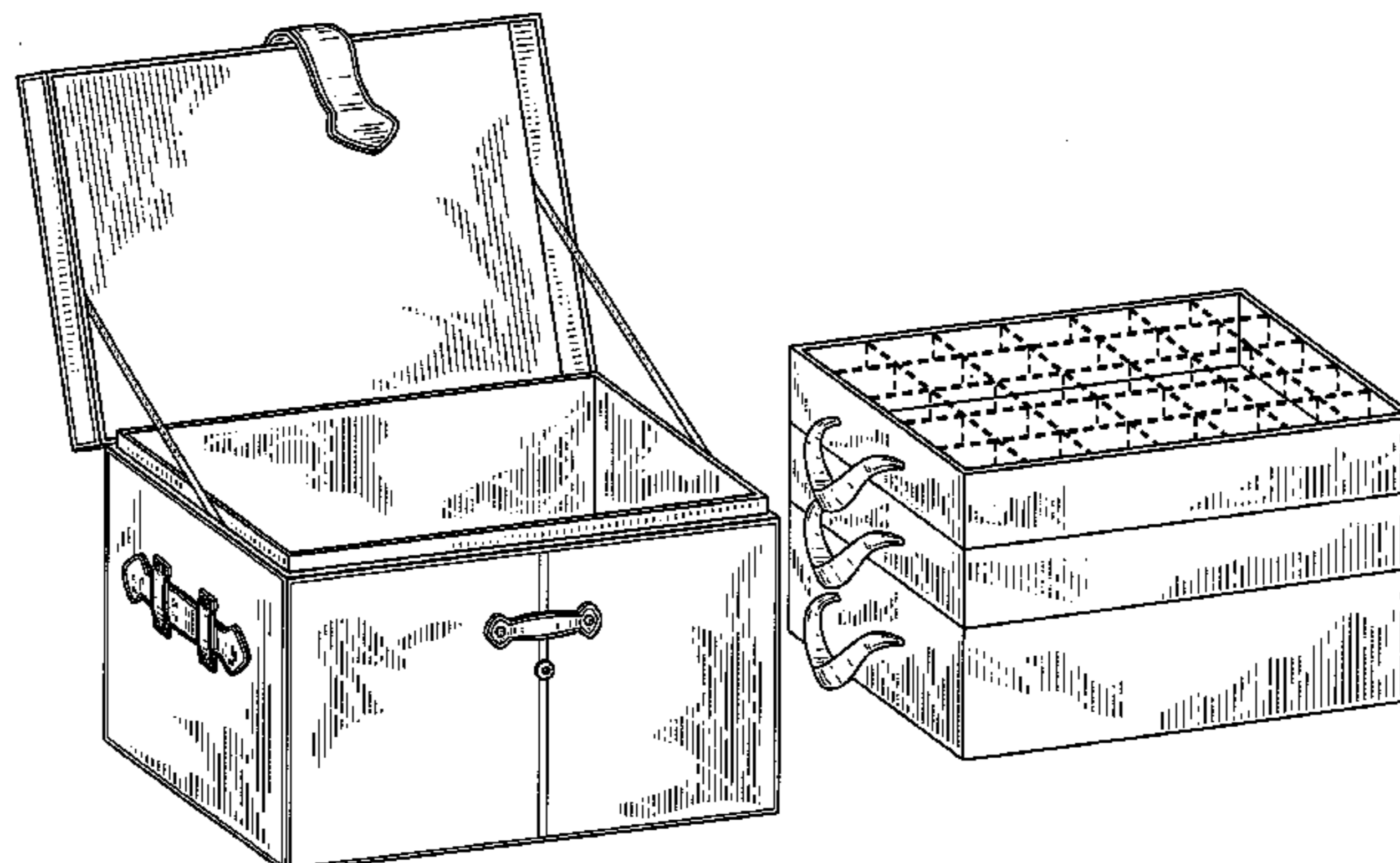
FIG. 4 is a right side elevational view, which is a mirror image of the left side view, thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a perspective view of the storage box showing the lid of the box open and a top tray within the box with the tray compartments shown in dotted lines for illustrative purposes only;

FIG. 8 is a perspective view of the storage box with its lid open and showing three trays which normally reside within



the storage box stacked on top of each other and with the compartments of the top tray shown in dotted lines for illustrative purposes only;

FIG. 9 is a front view of the storage box with its lid open alongside three trays which normally reside within the storage box;

FIG. 10 is a rear view of the storage box with its lid open alongside three trays which normally reside within the storage box;

FIG. 11 is a left side view of the storage box, which is a mirror image of the right side view, with its lid open alongside three trays which normally reside within the storage box;

FIG. 12 is a top view of the storage box with its lid open and alongside three trays which normally reside within the storage box with the compartments of the top tray shown in dotted lines for illustrative purposes only;

FIG. 13 is a bottom view of the storage box with its lid open and alongside three trays which normally reside within the storage box;

FIG. 14 is a perspective view of the storage box with its lid open alongside one tray which normally resides within the storage box with the compartments of the tray shown in dotted lines for illustrative purposes only;

FIG. 15 is a front view of the storage box with its lid open alongside one tray which normally resides within the storage box;

FIG. 16 is a rear view of the storage box with its lid open alongside one tray which normally resides within the storage box;

FIG. 17 is a left side view of the storage box, which is a mirror image of the right side view, with its lid open alongside one tray which normally resides within the storage box;

FIG. 18 is a top view of the storage box with its lid open and alongside one tray which normally resides within the storage box with the compartments of the tray shown in dotted illustrative purposes only; and,

FIG. 19 is a bottom view of the storage box with its lid open and alongside one tray which normally resides within the storage box.

The dotted lines in shown in FIGS. 7, 8, 12, 14, and 18 are directed to environment and are for illustrative purposes only, forming no part of the claimed design.

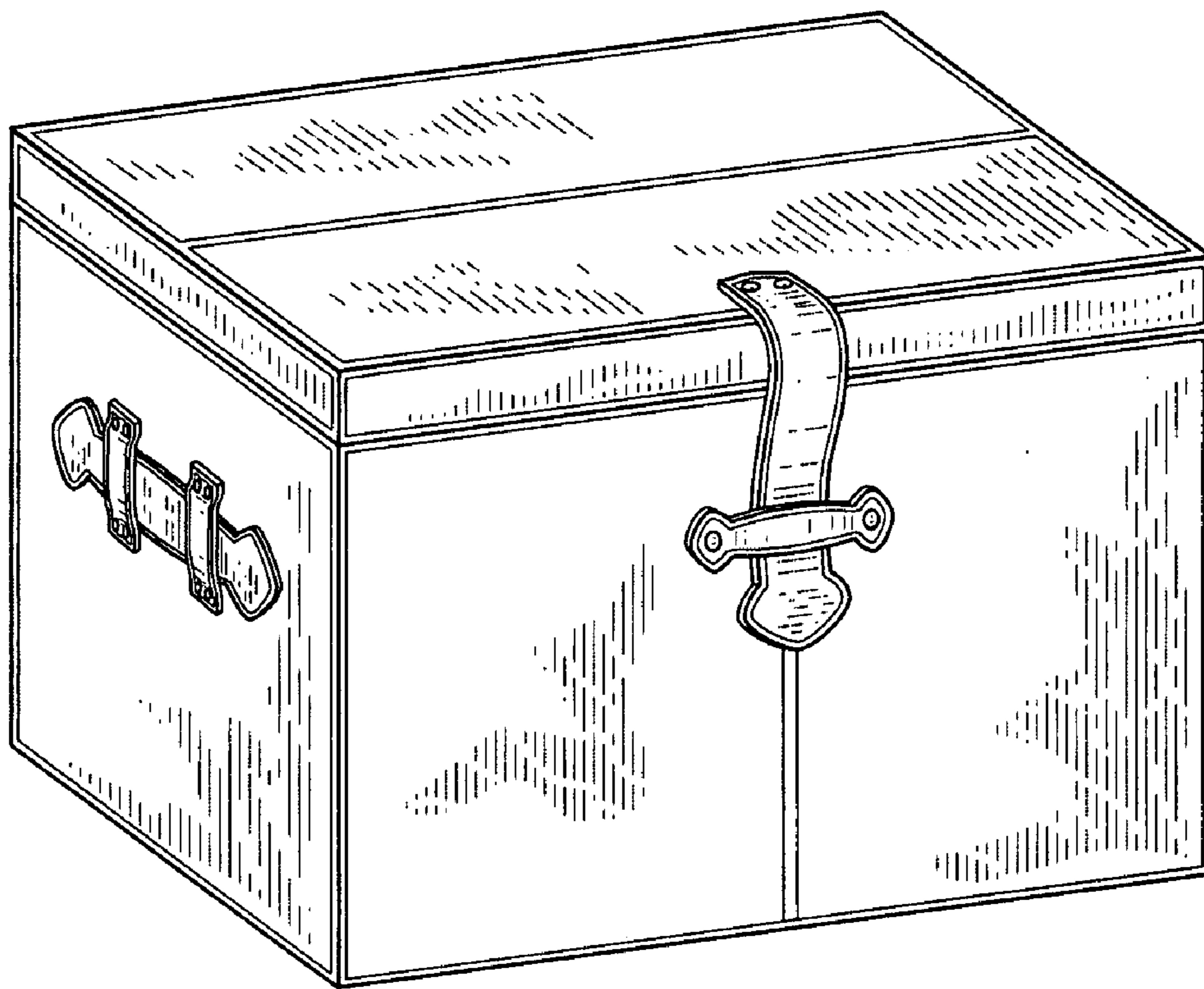

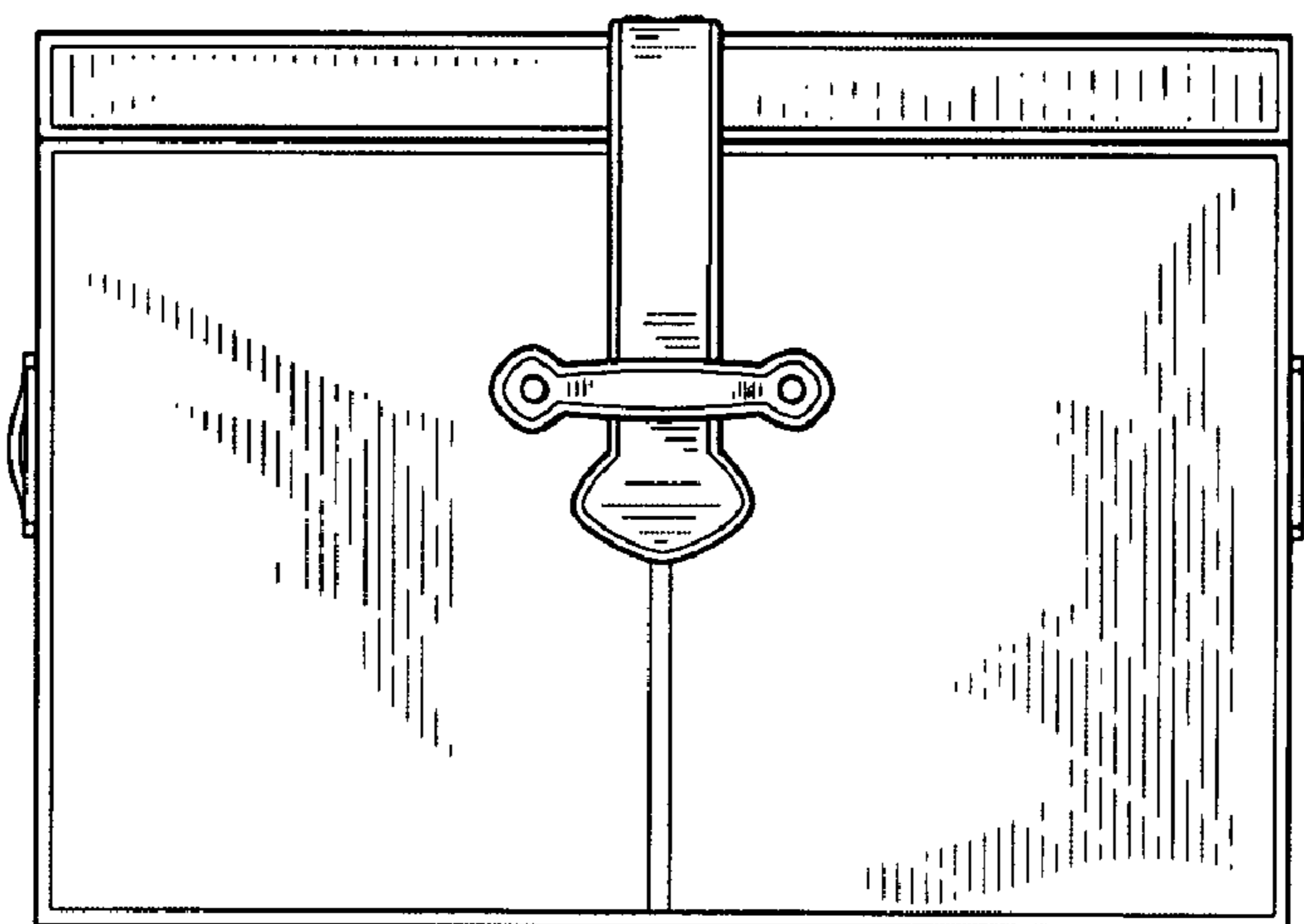

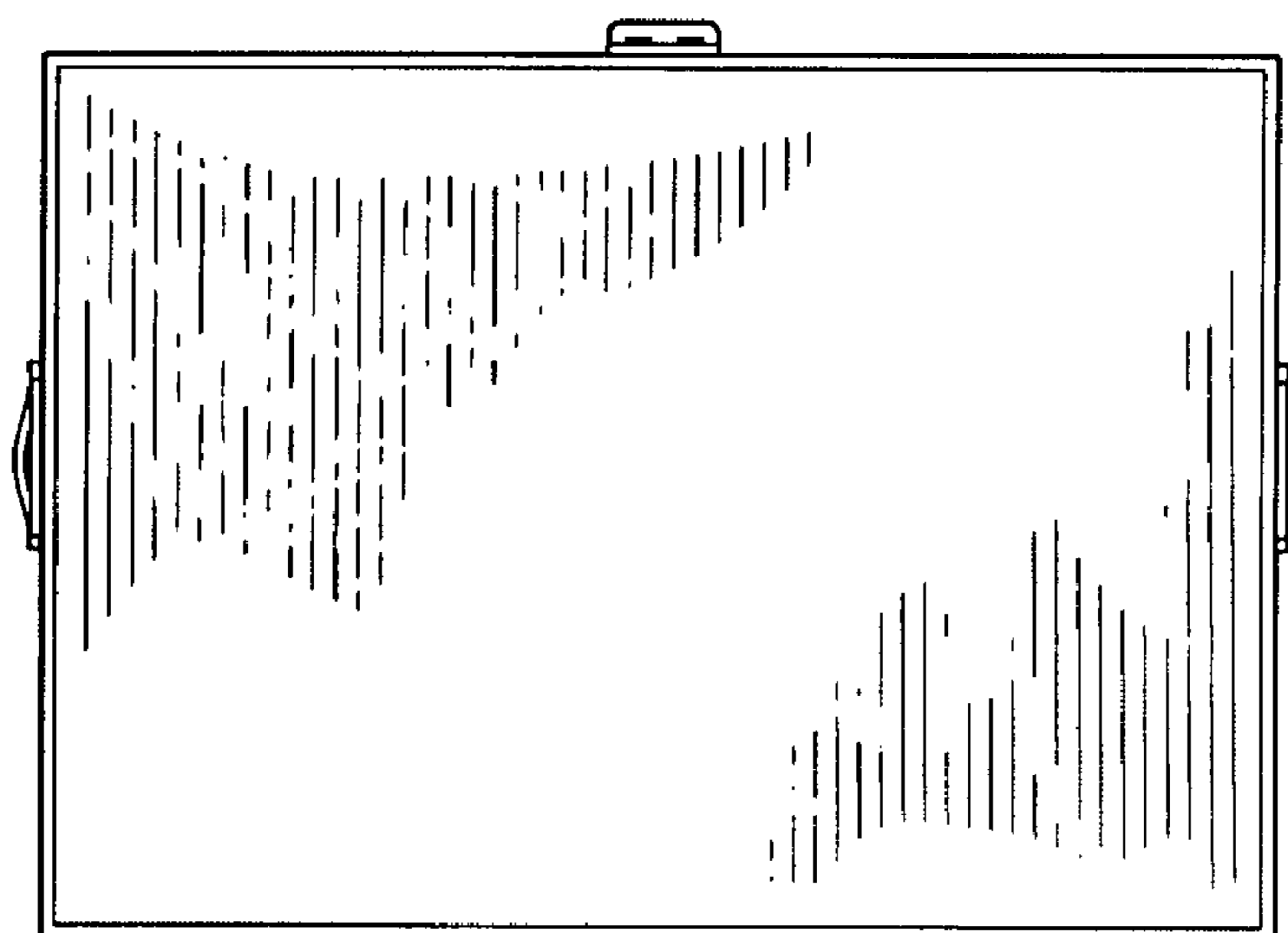

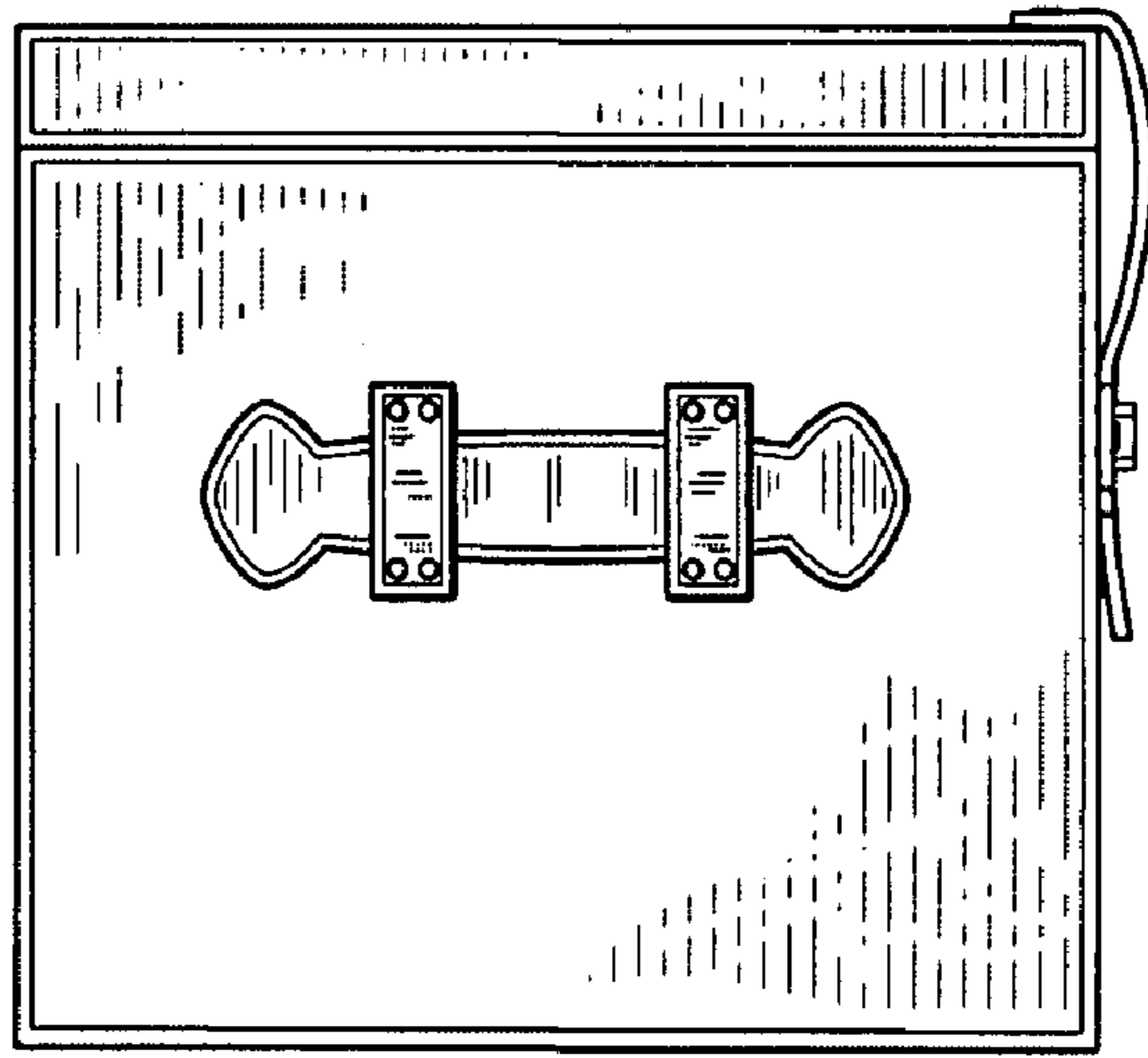

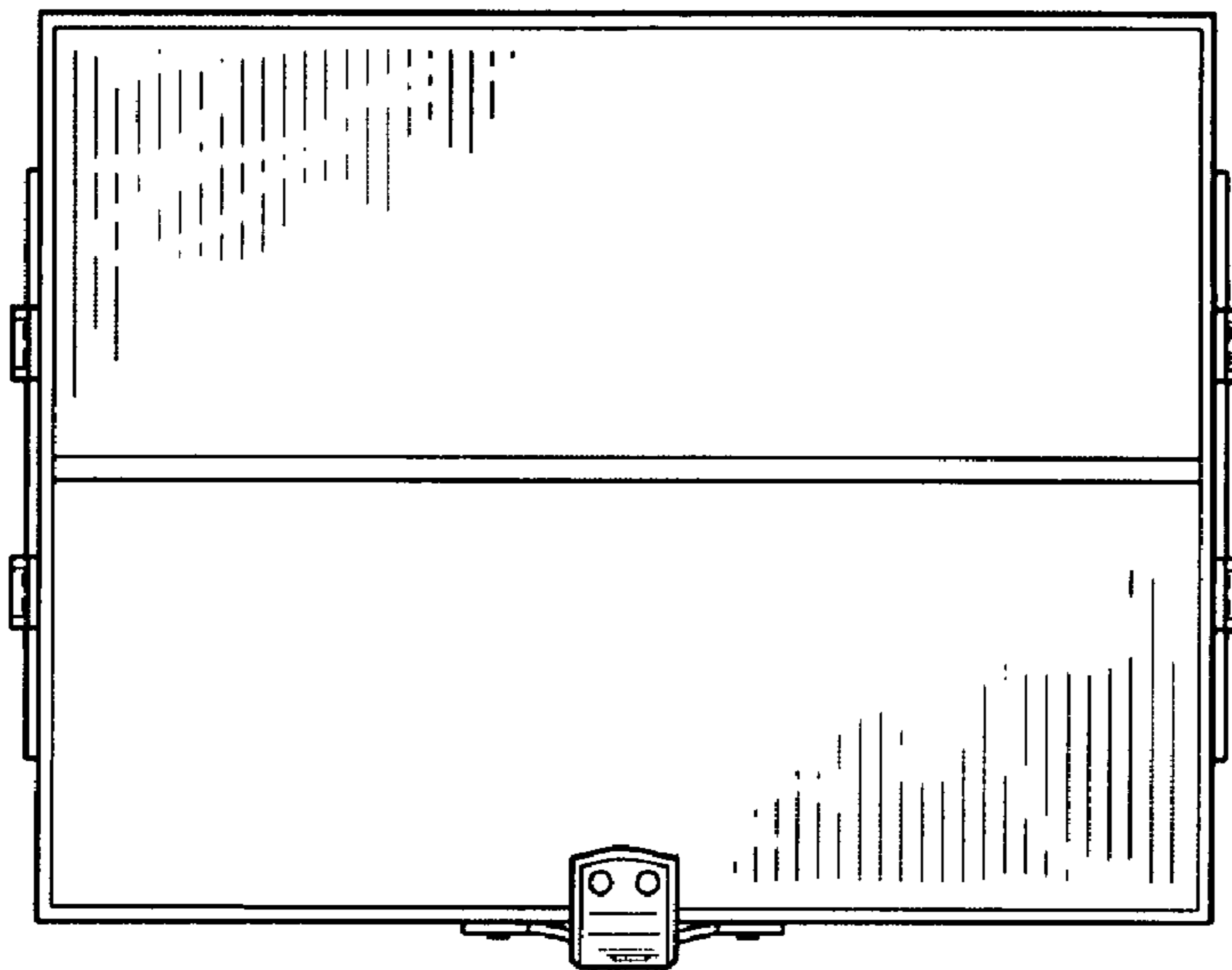

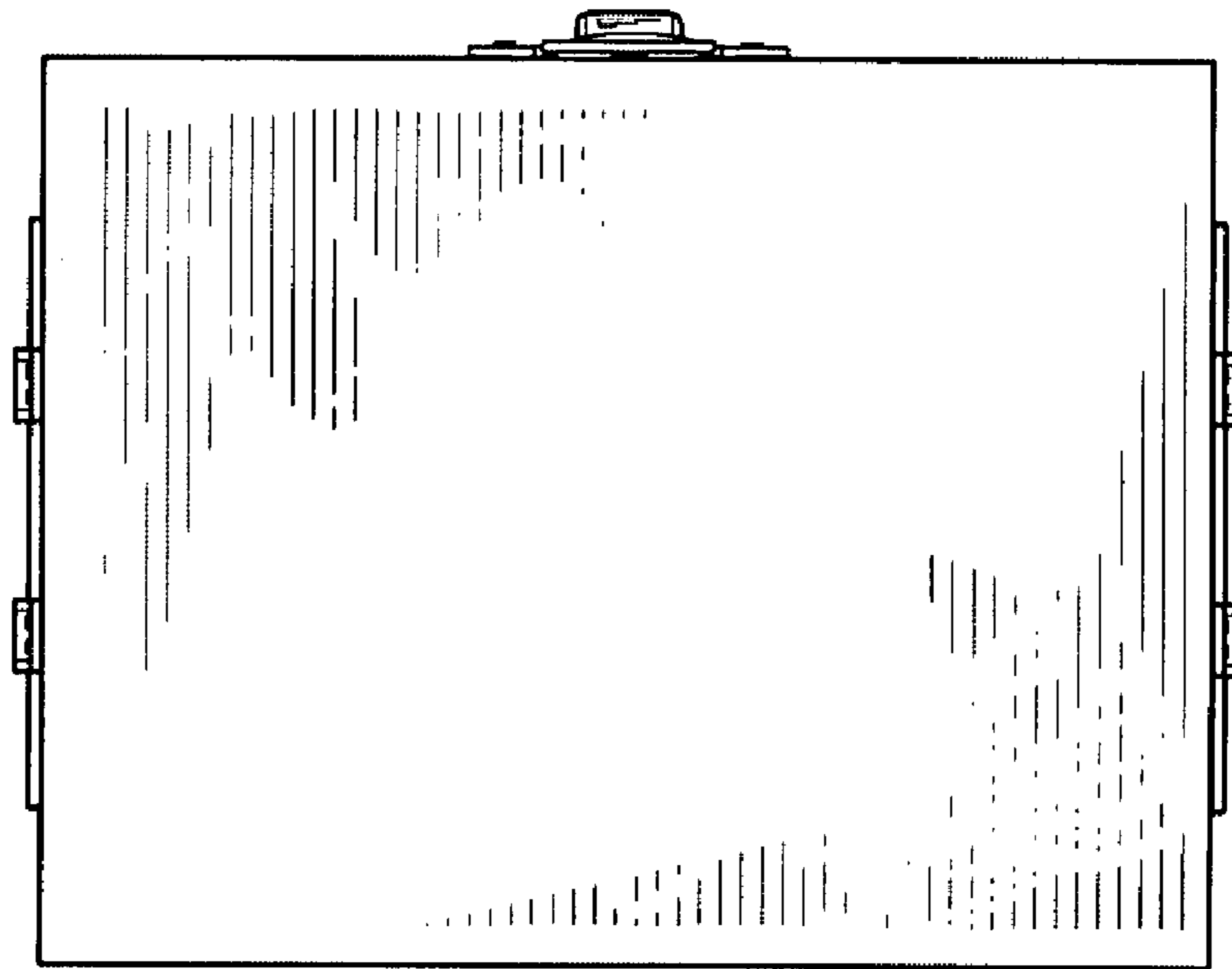

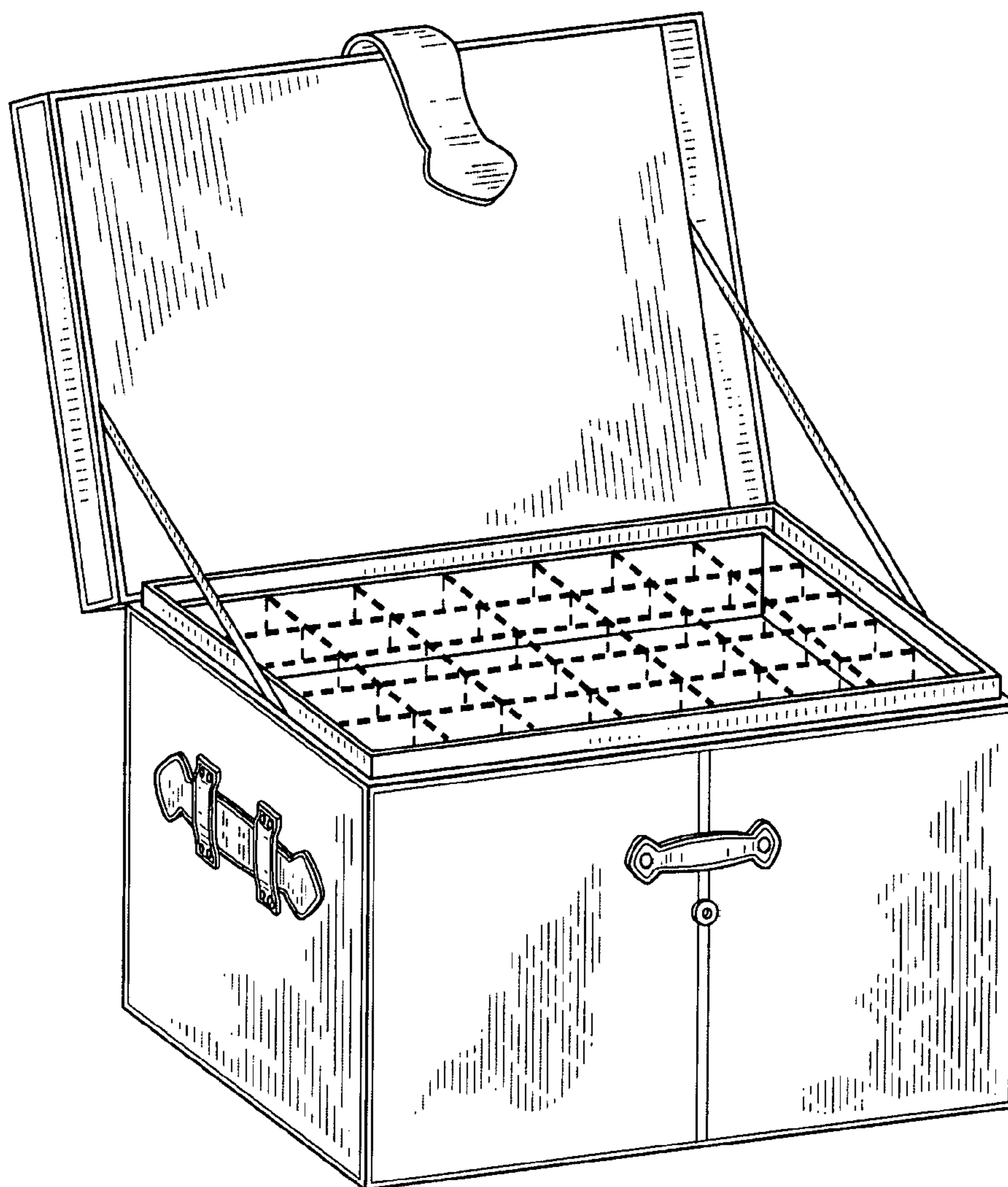

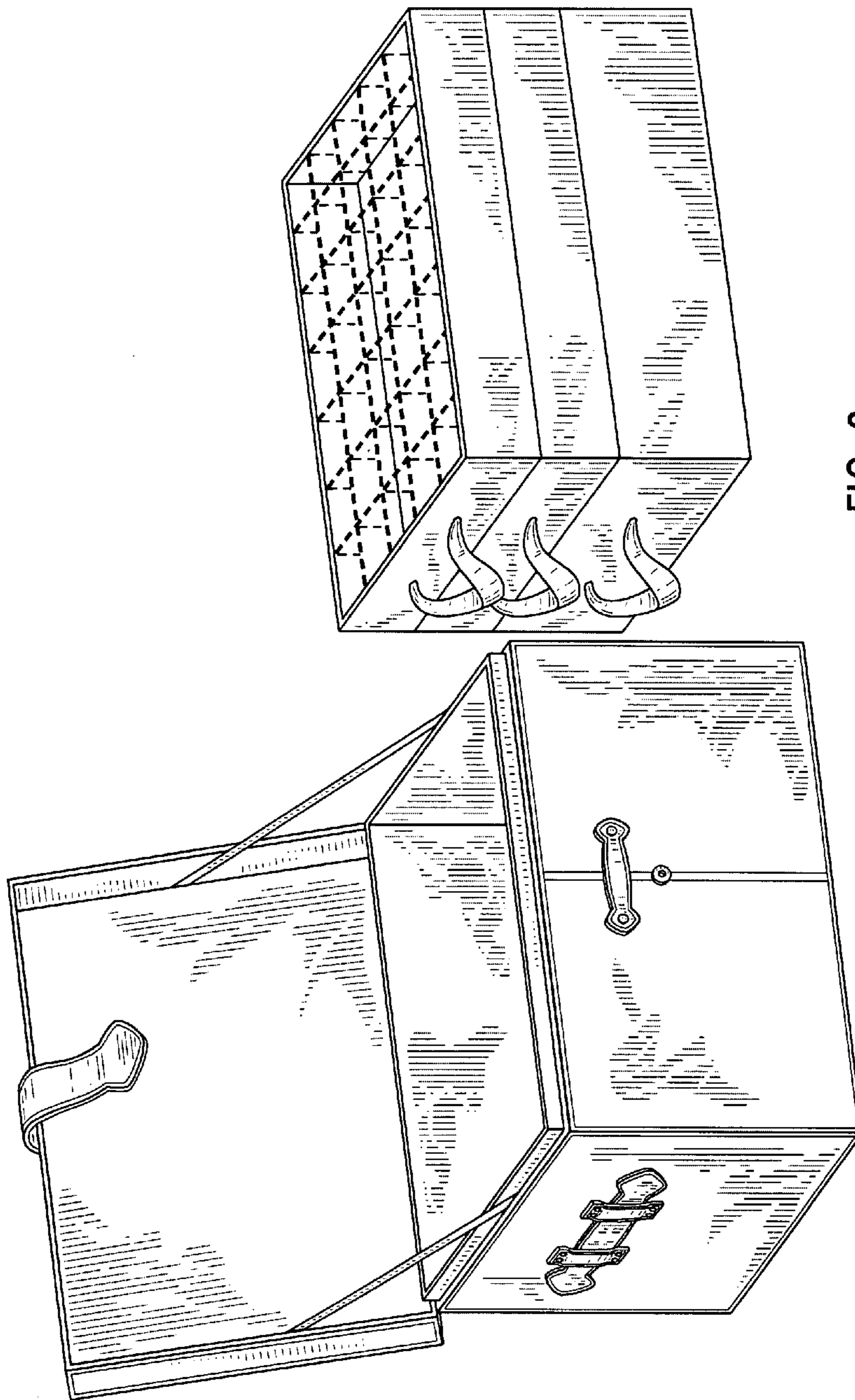

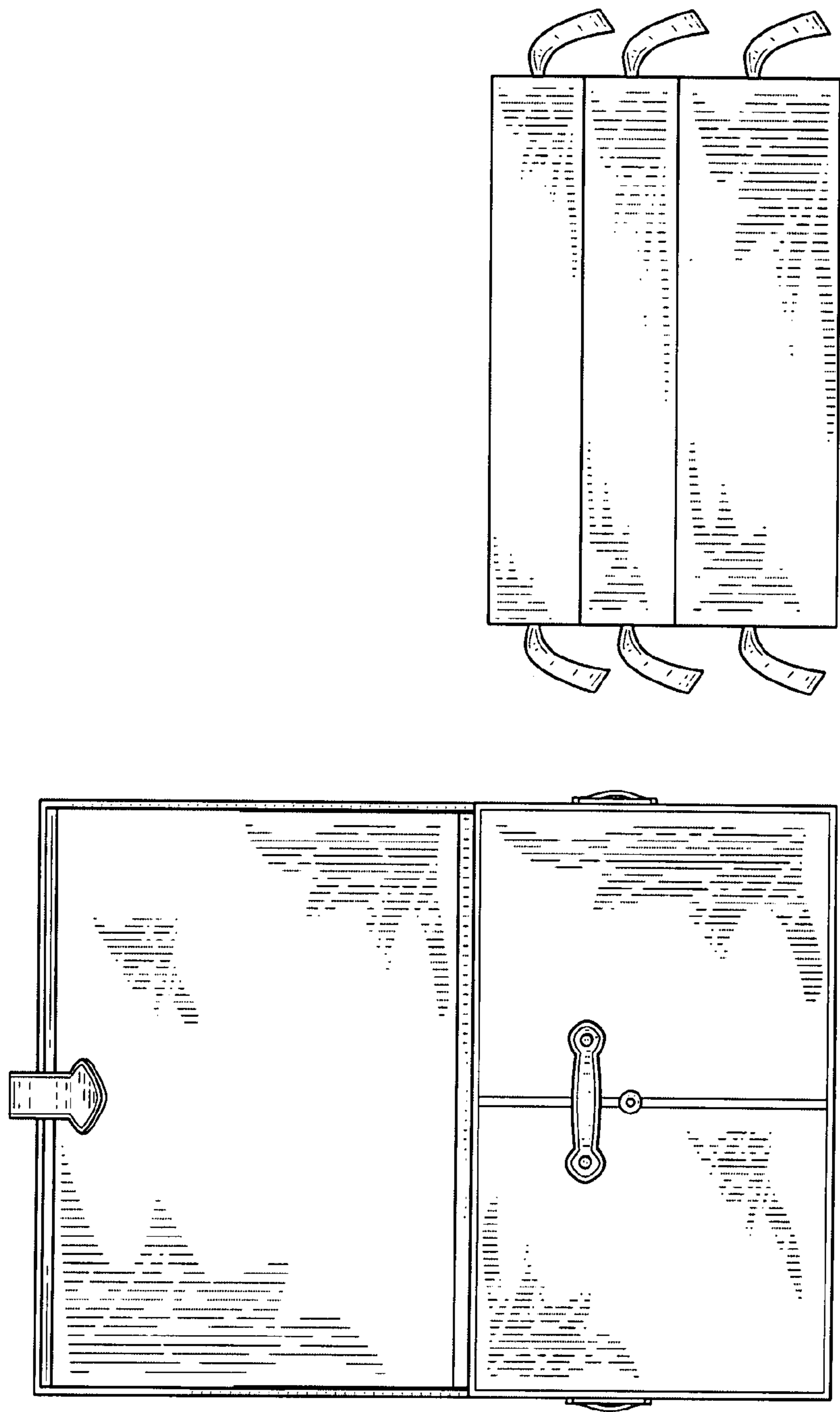

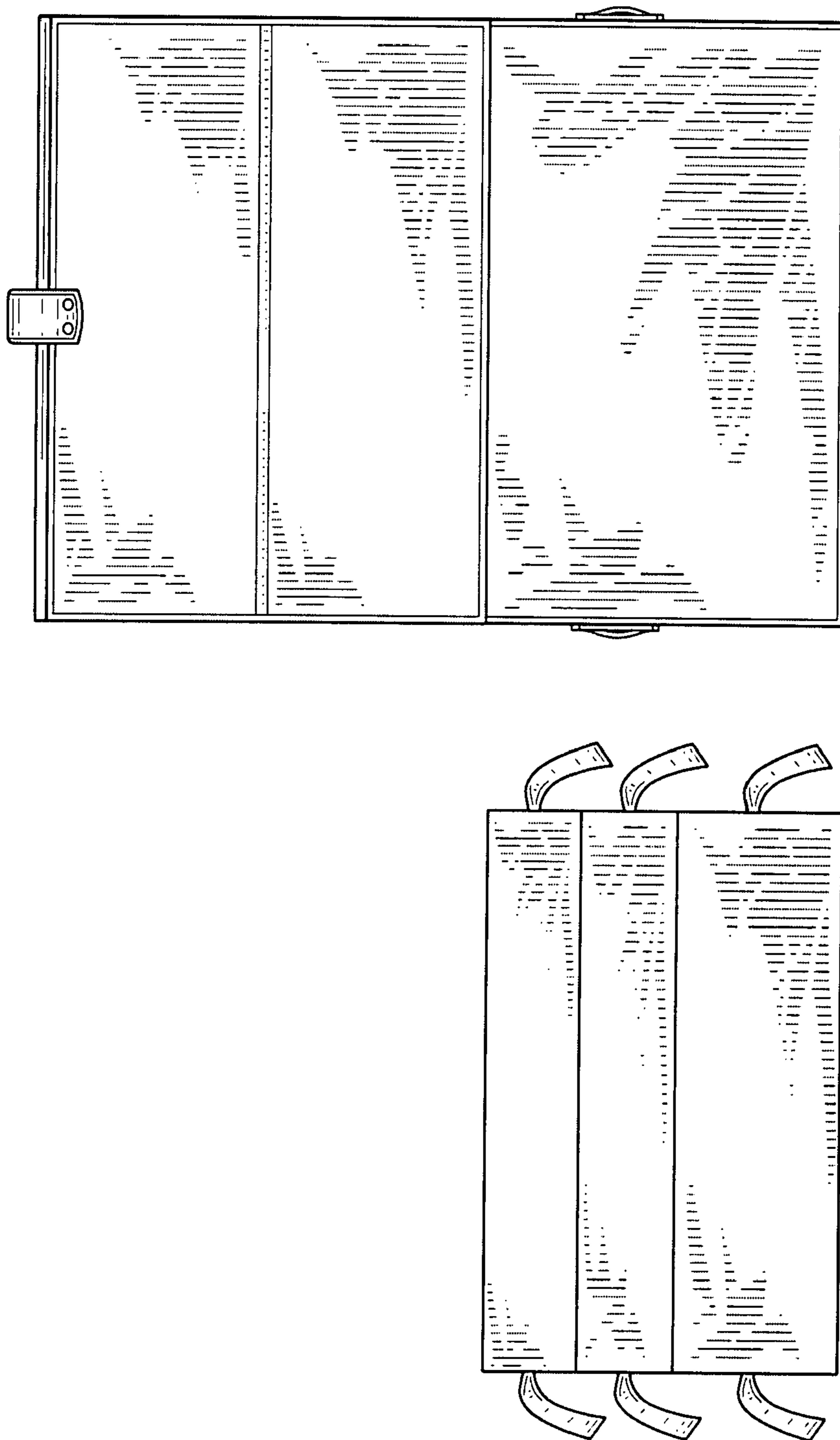

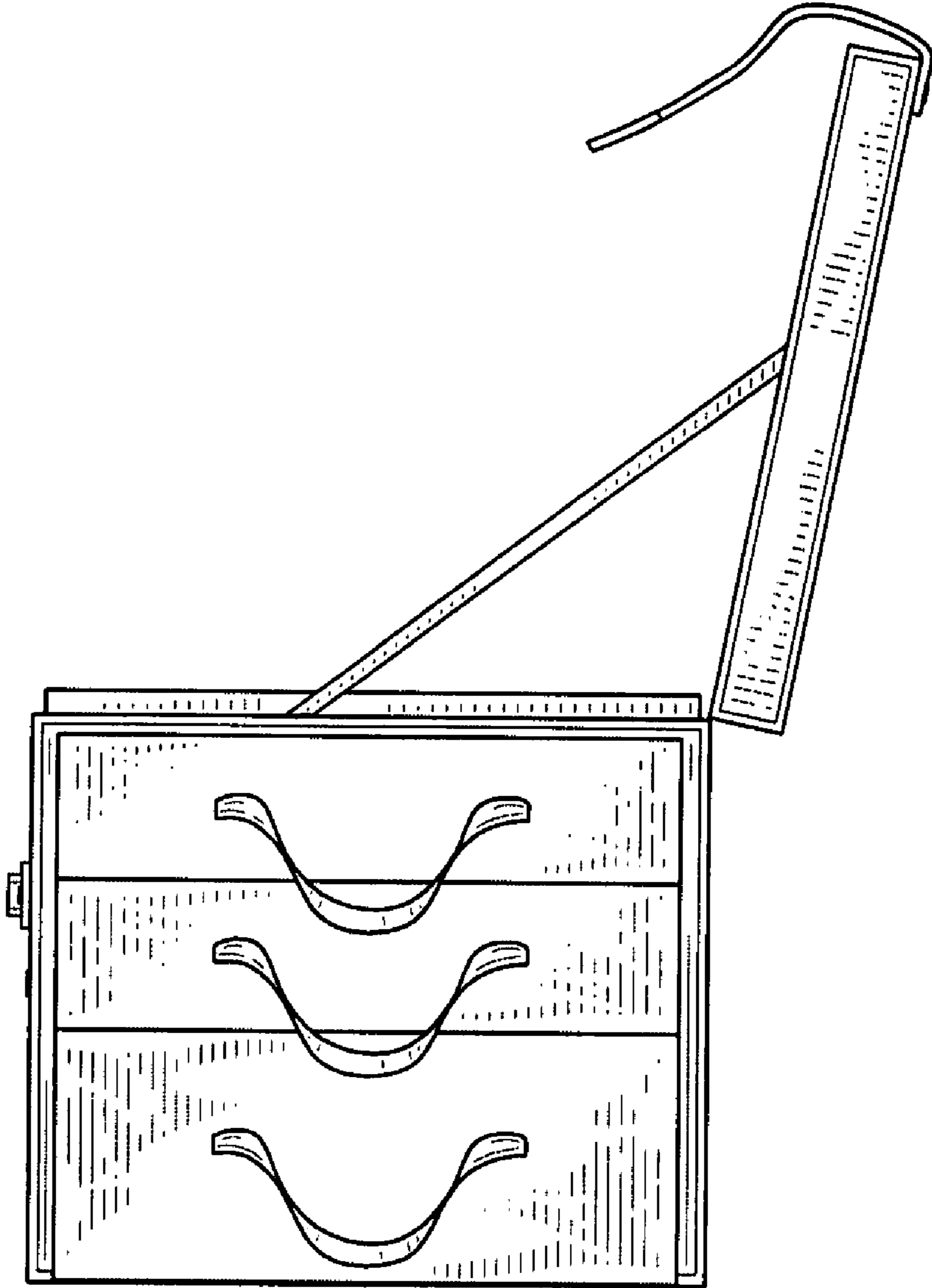

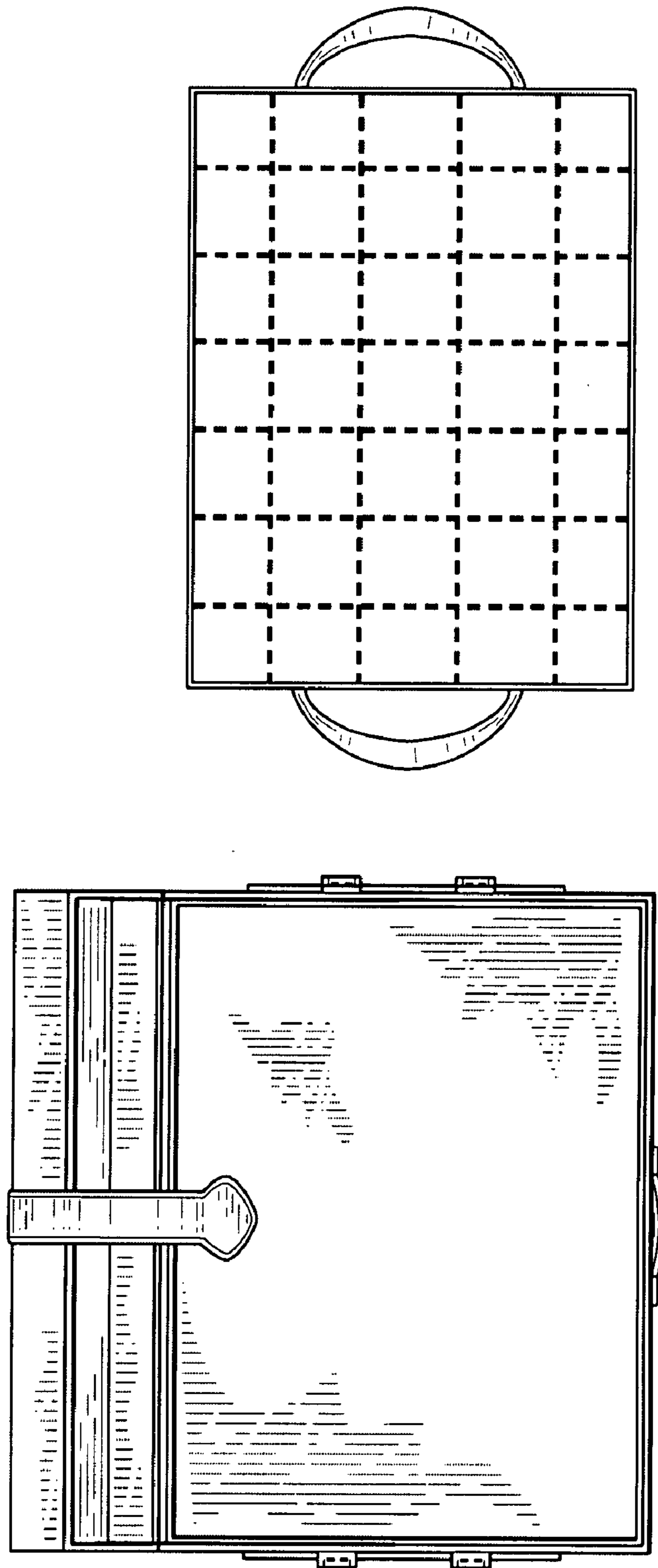

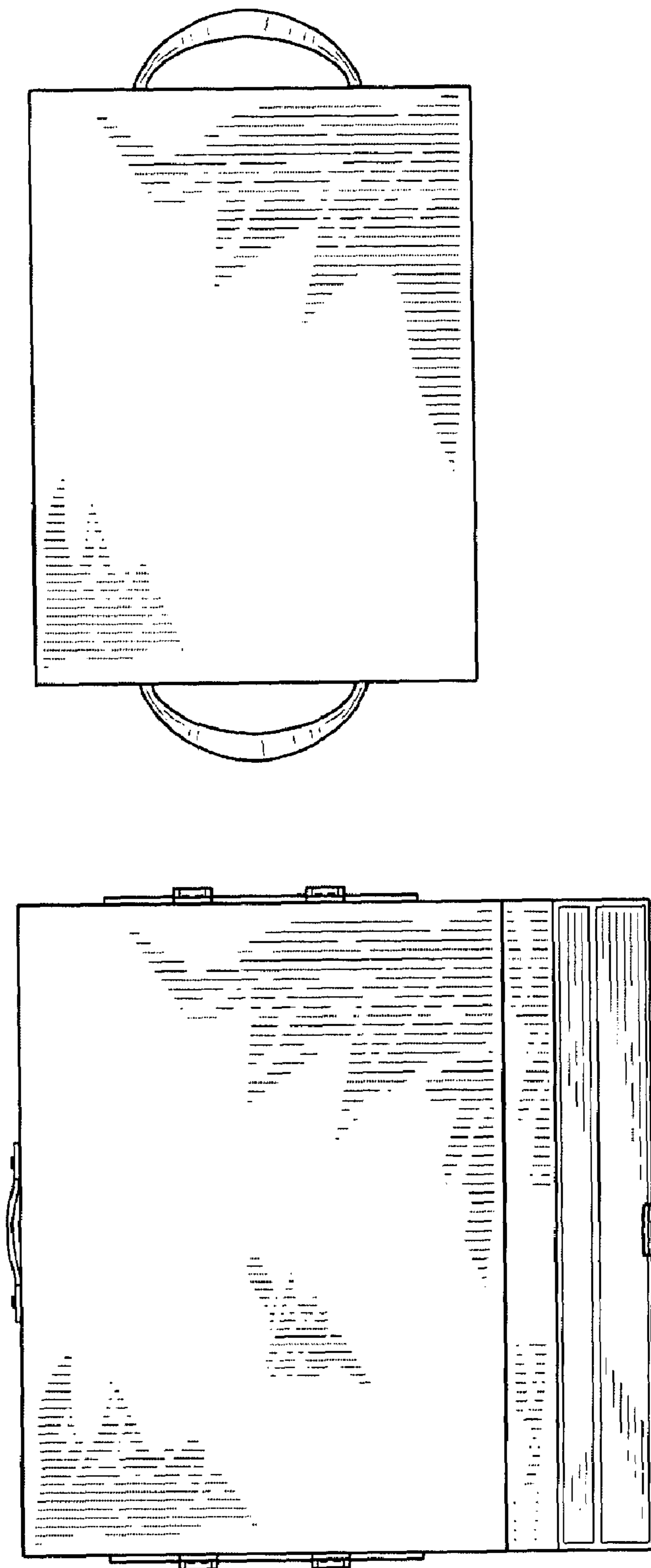

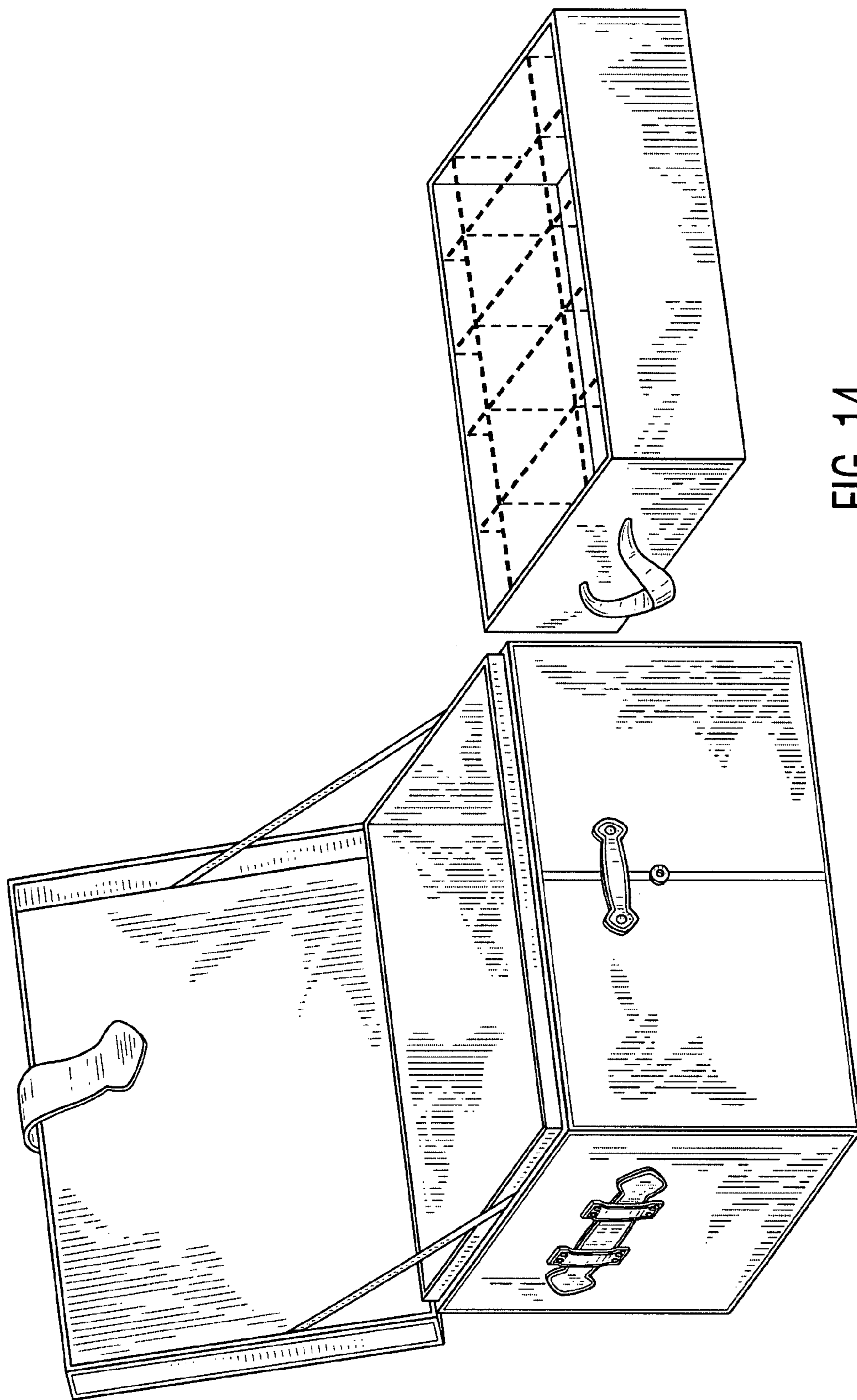

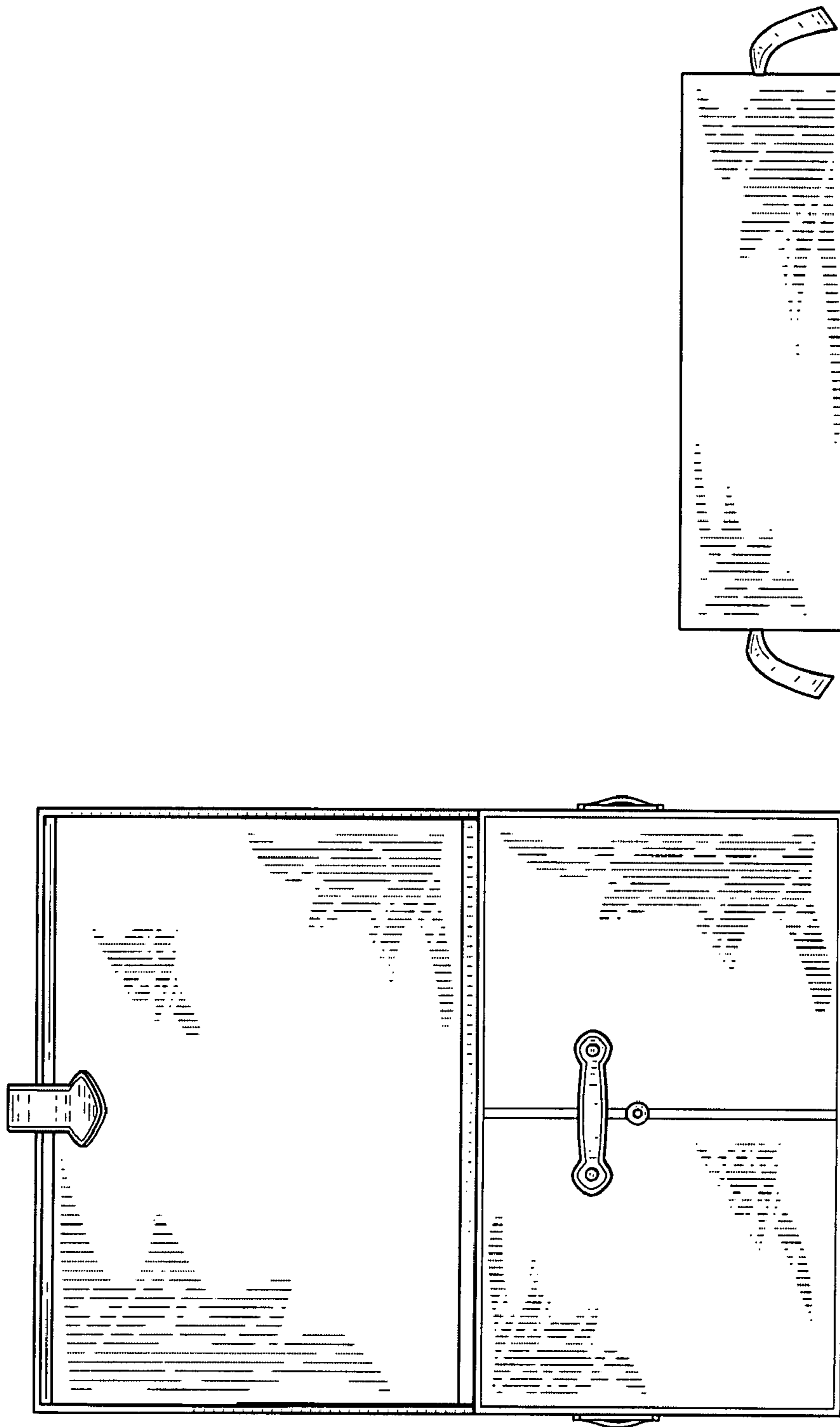

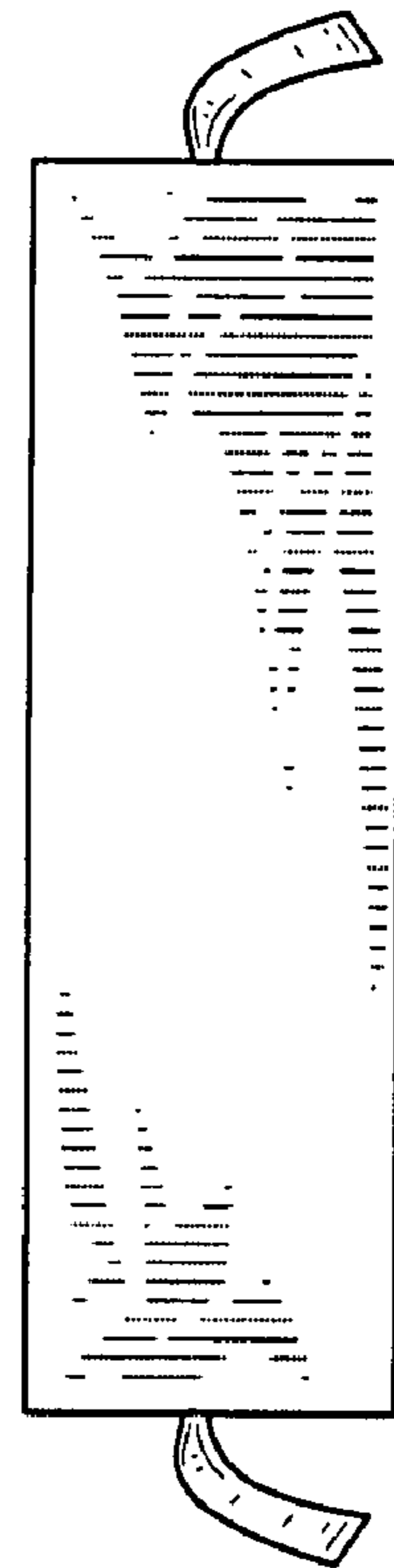
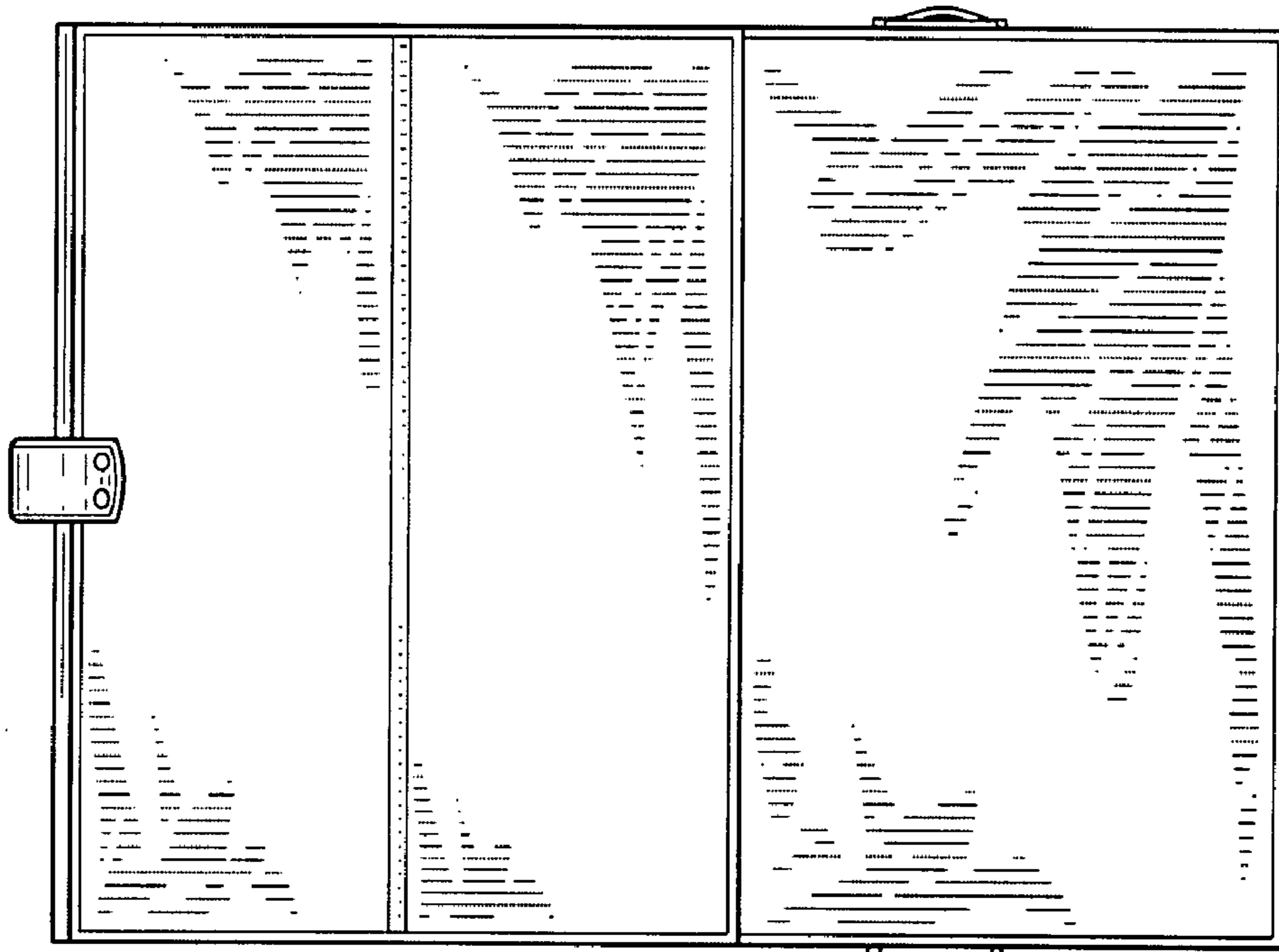

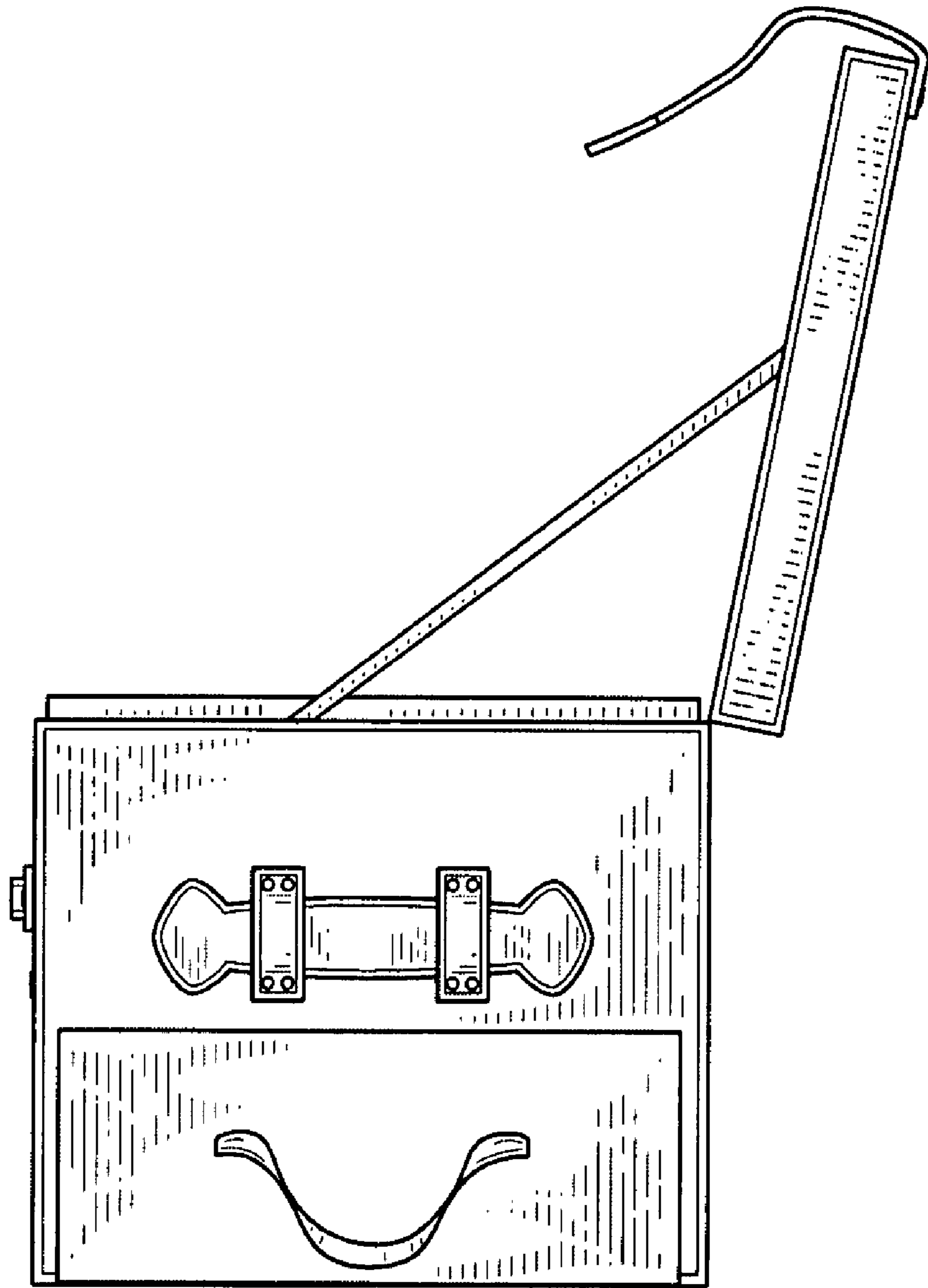

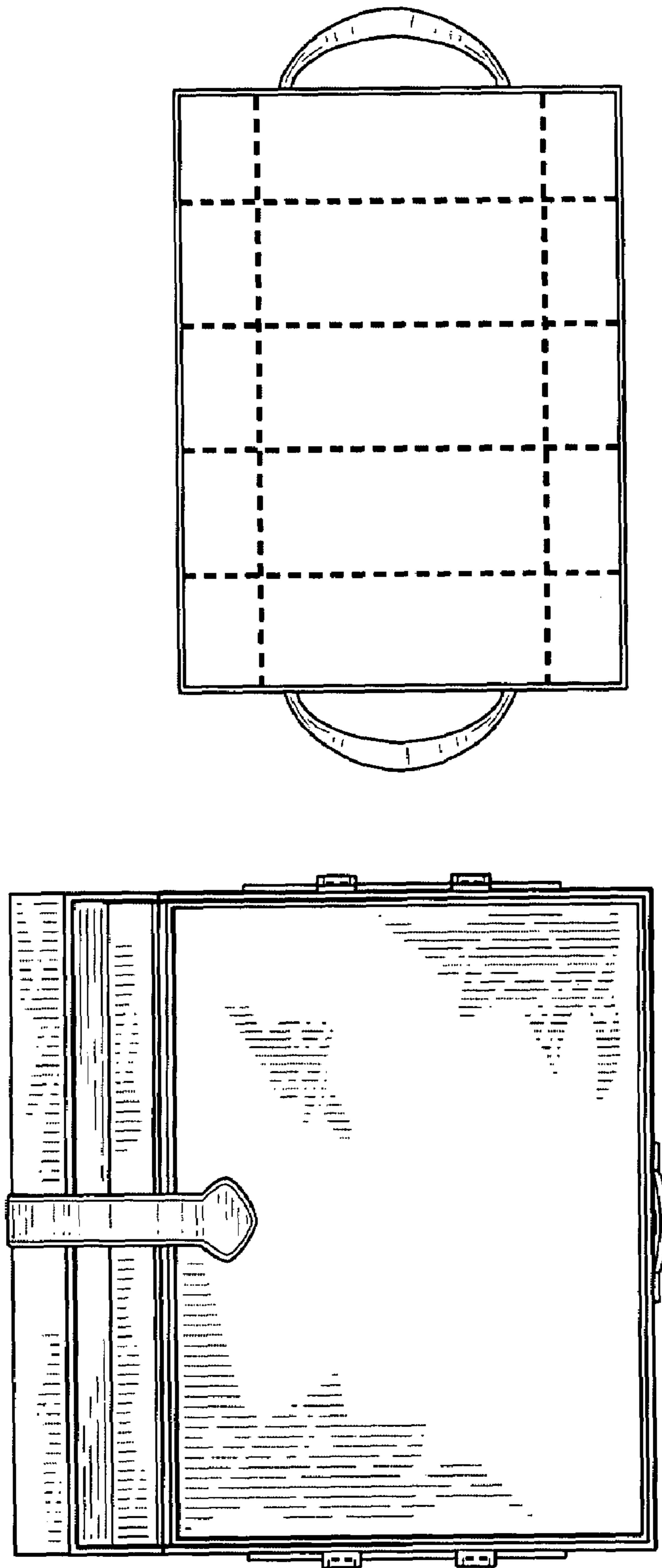

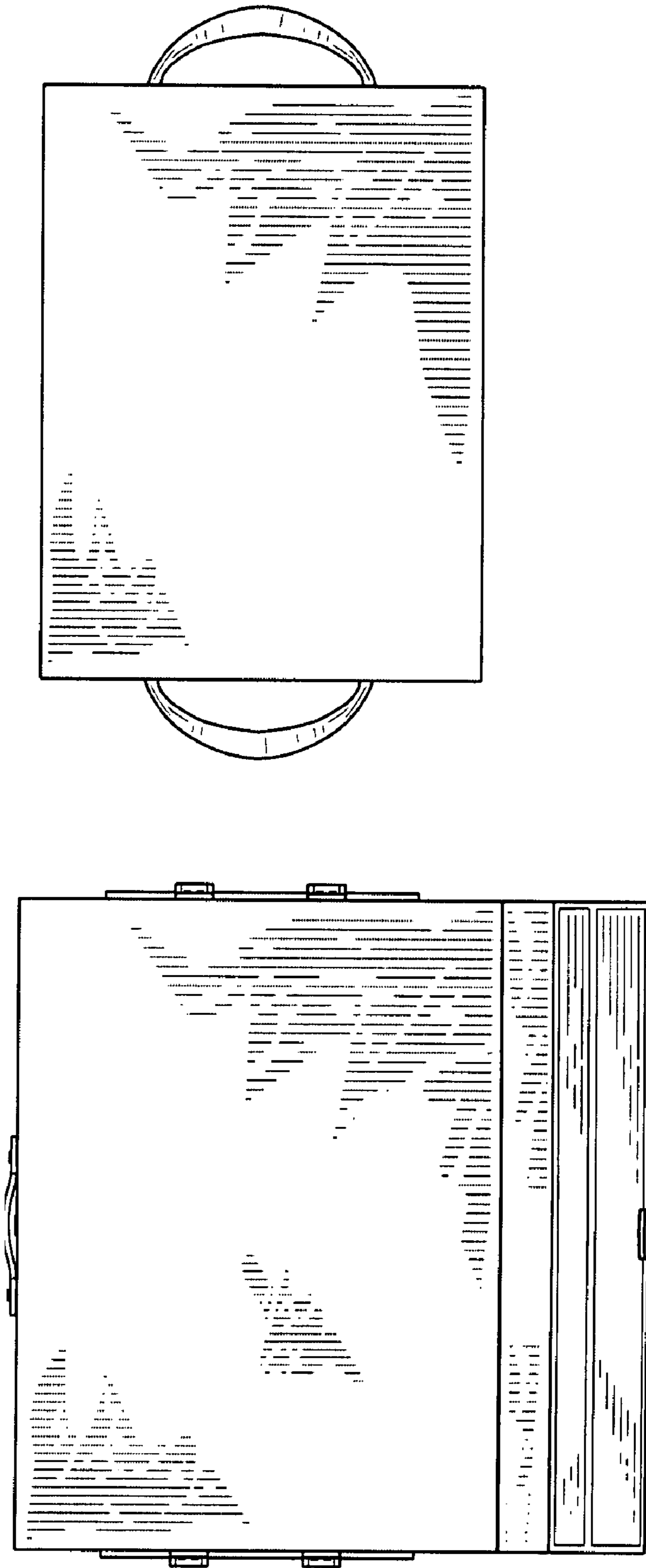
