(57) **CLAIM**

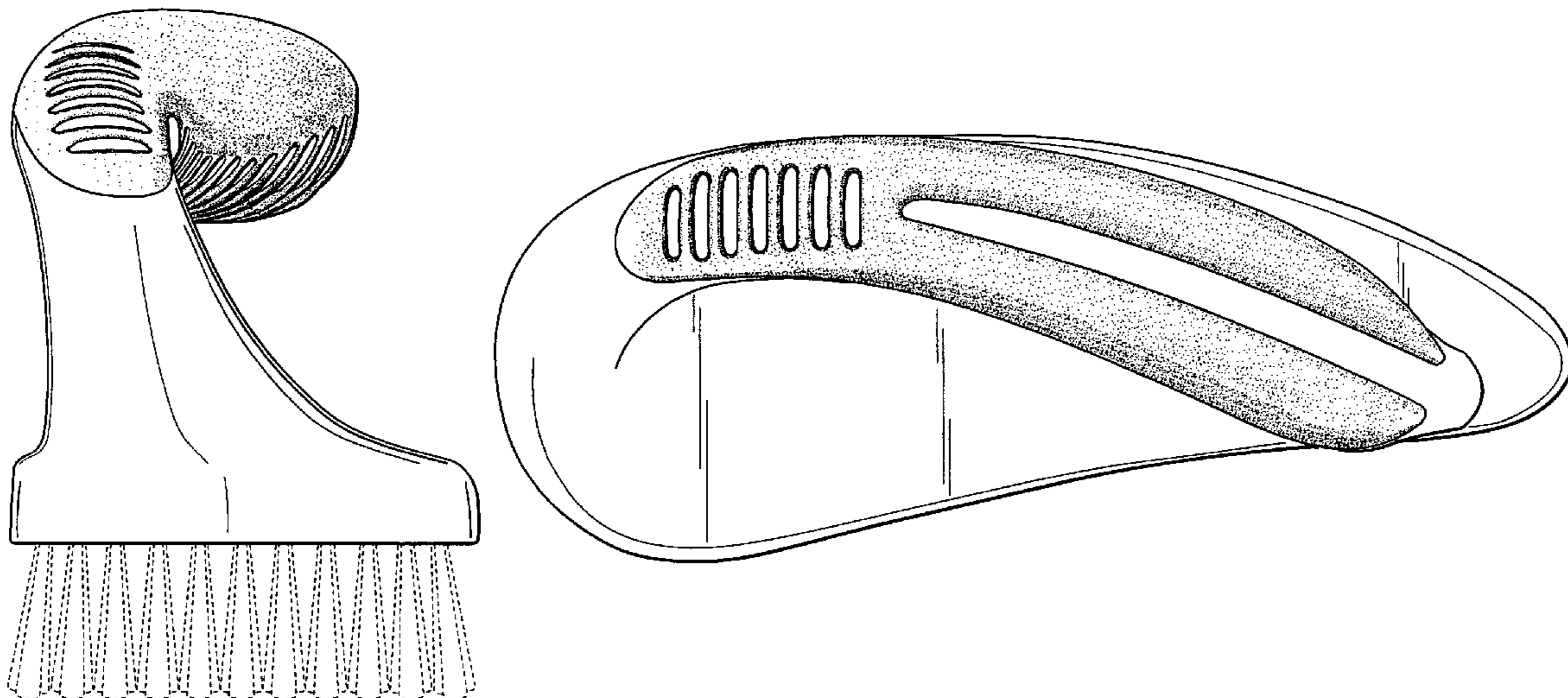
The ornamental design for a portion of a brush, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a portion of a brush showing our new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a rear right perspective view thereof; and,

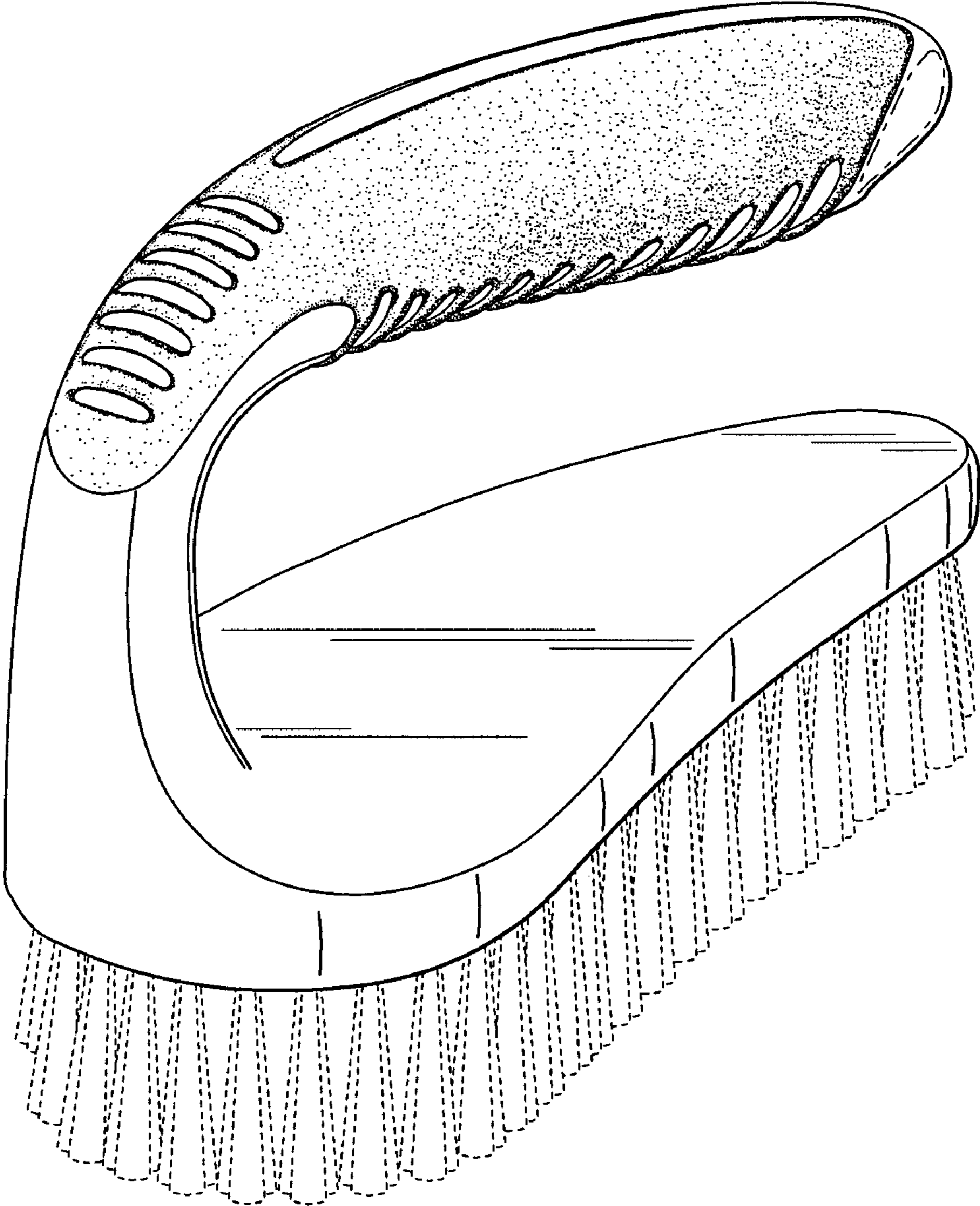

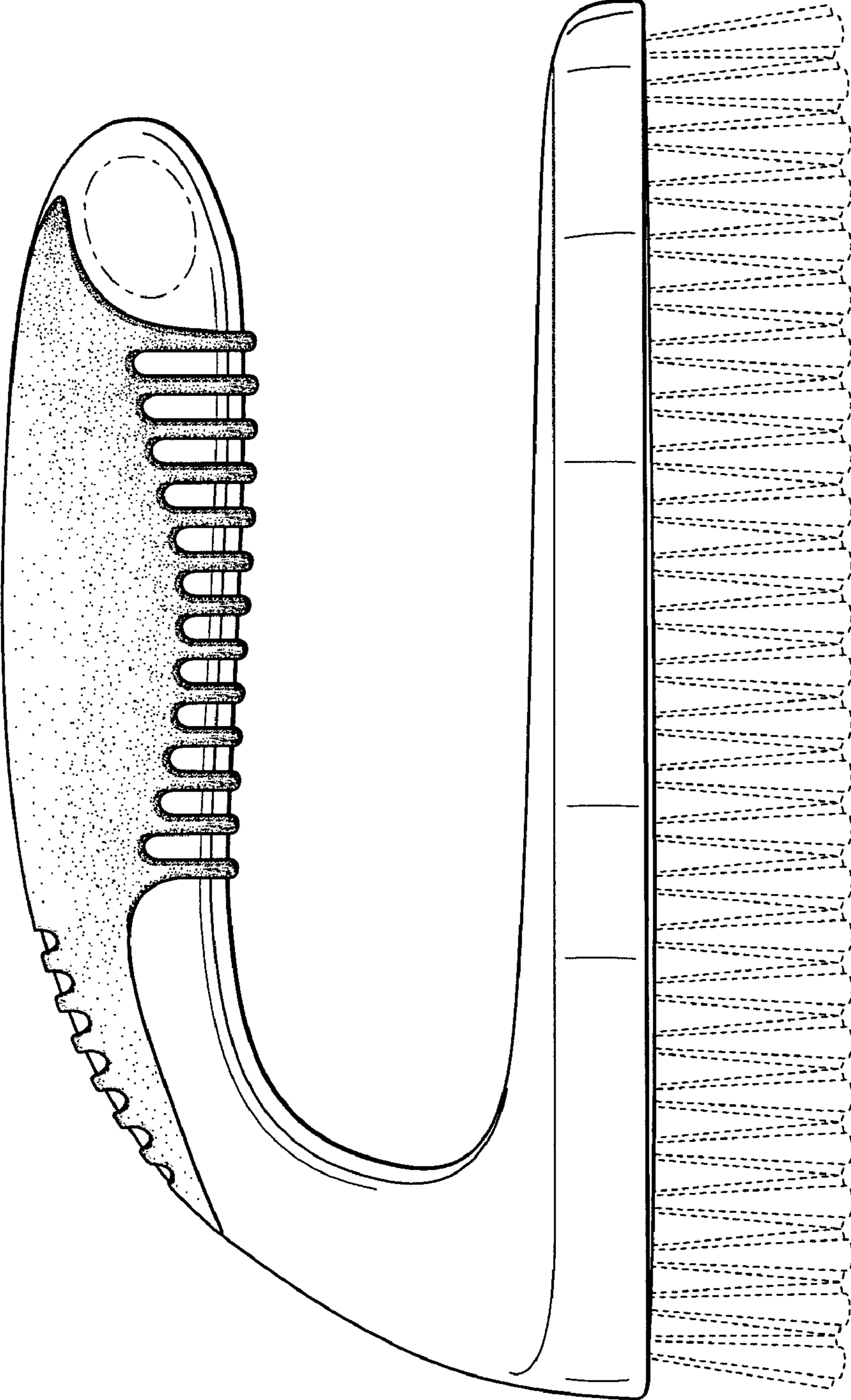

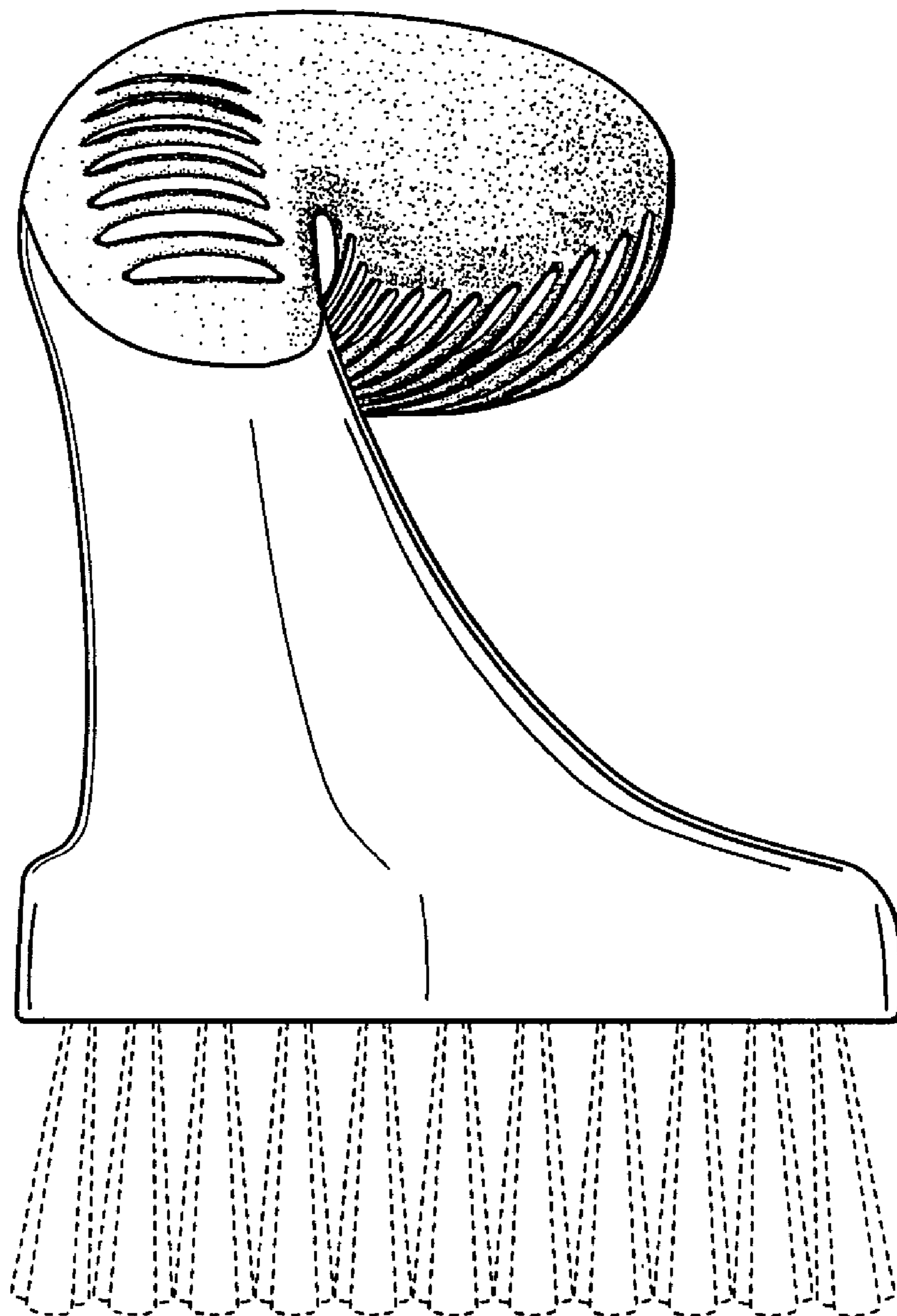

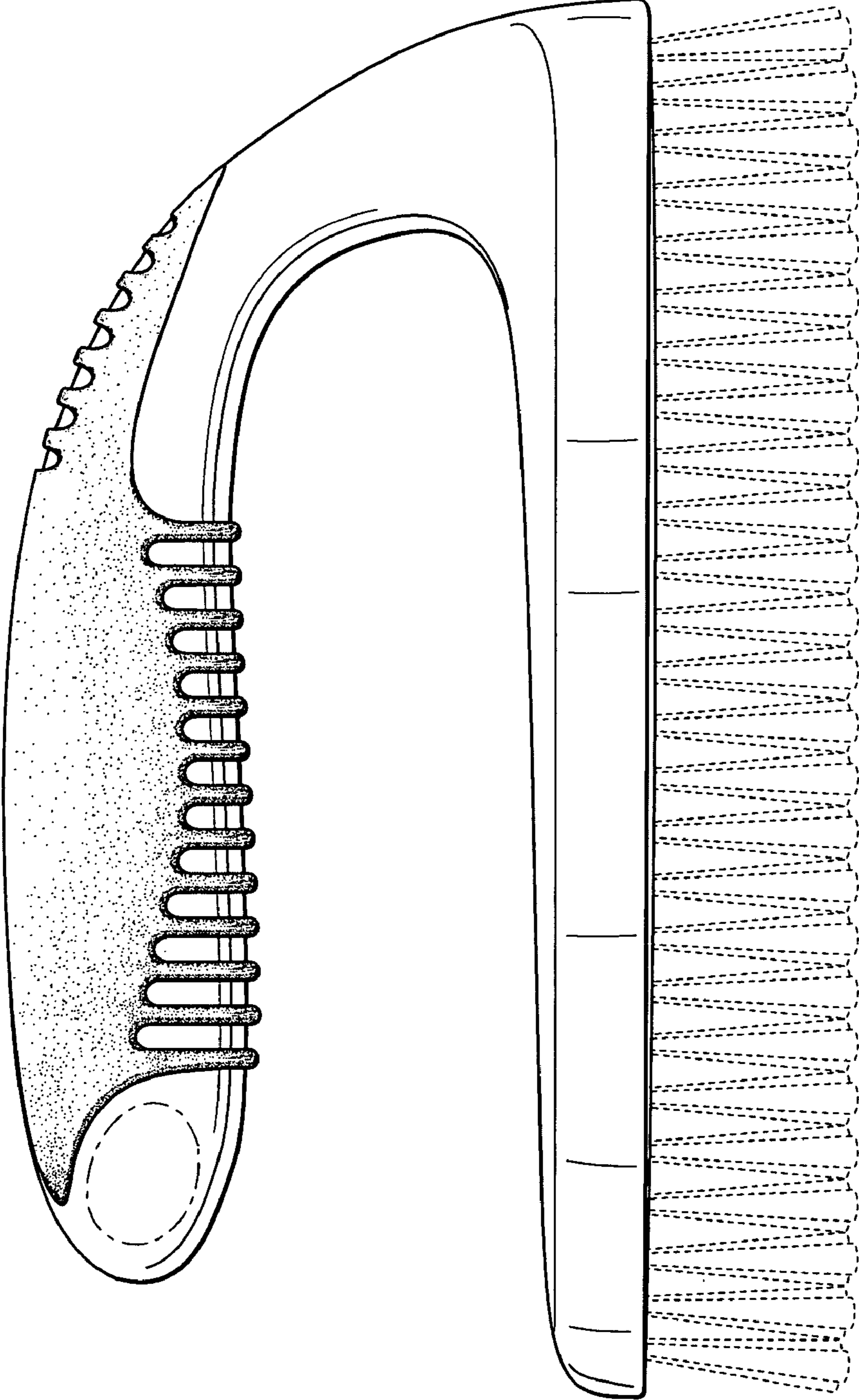

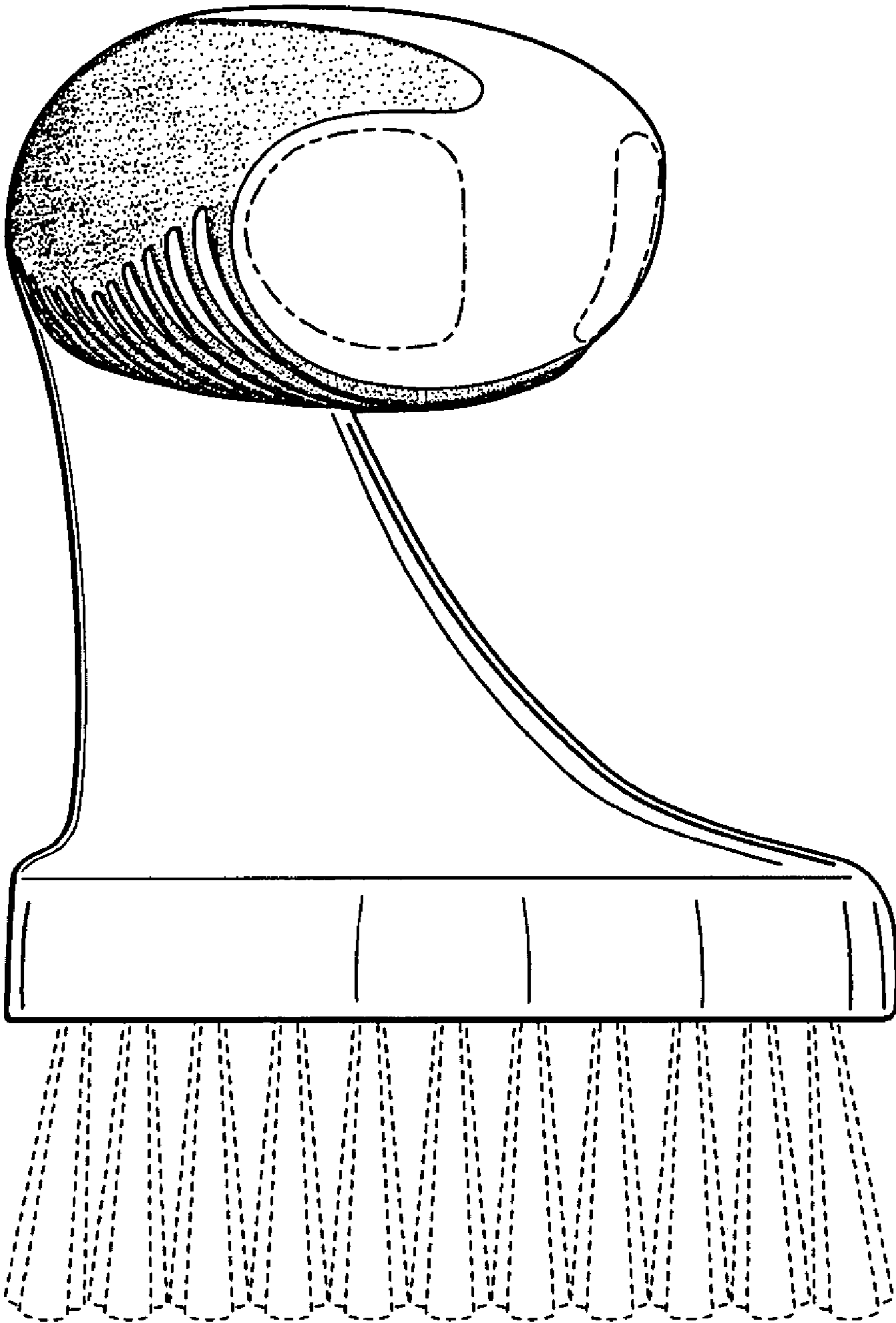

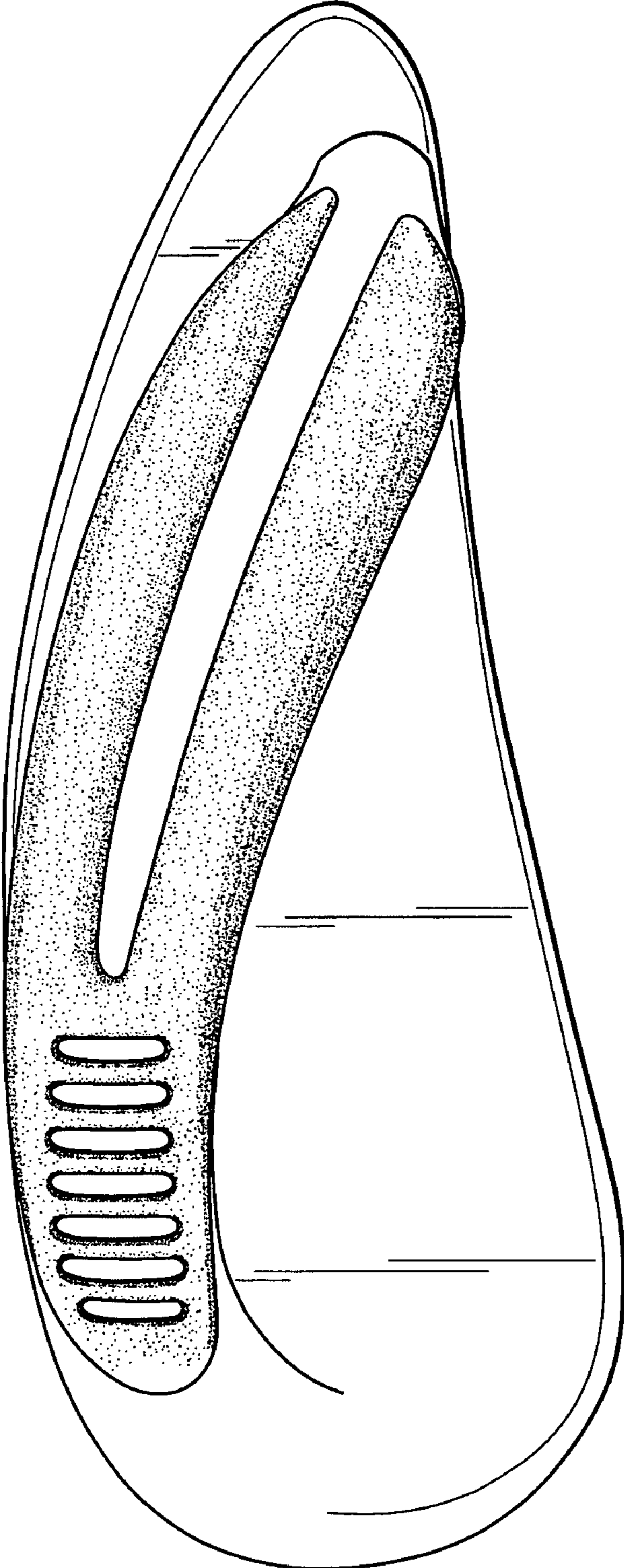

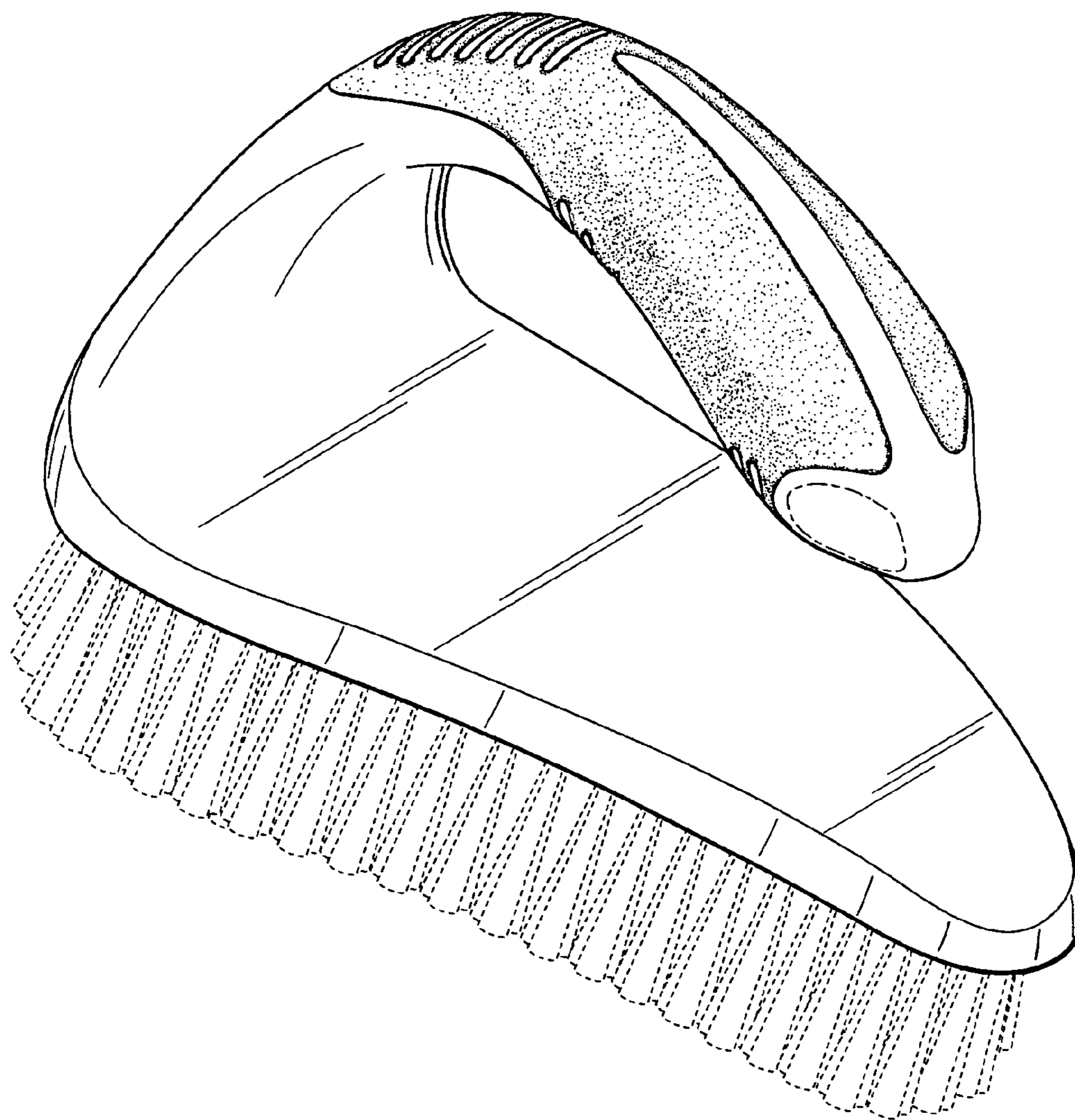

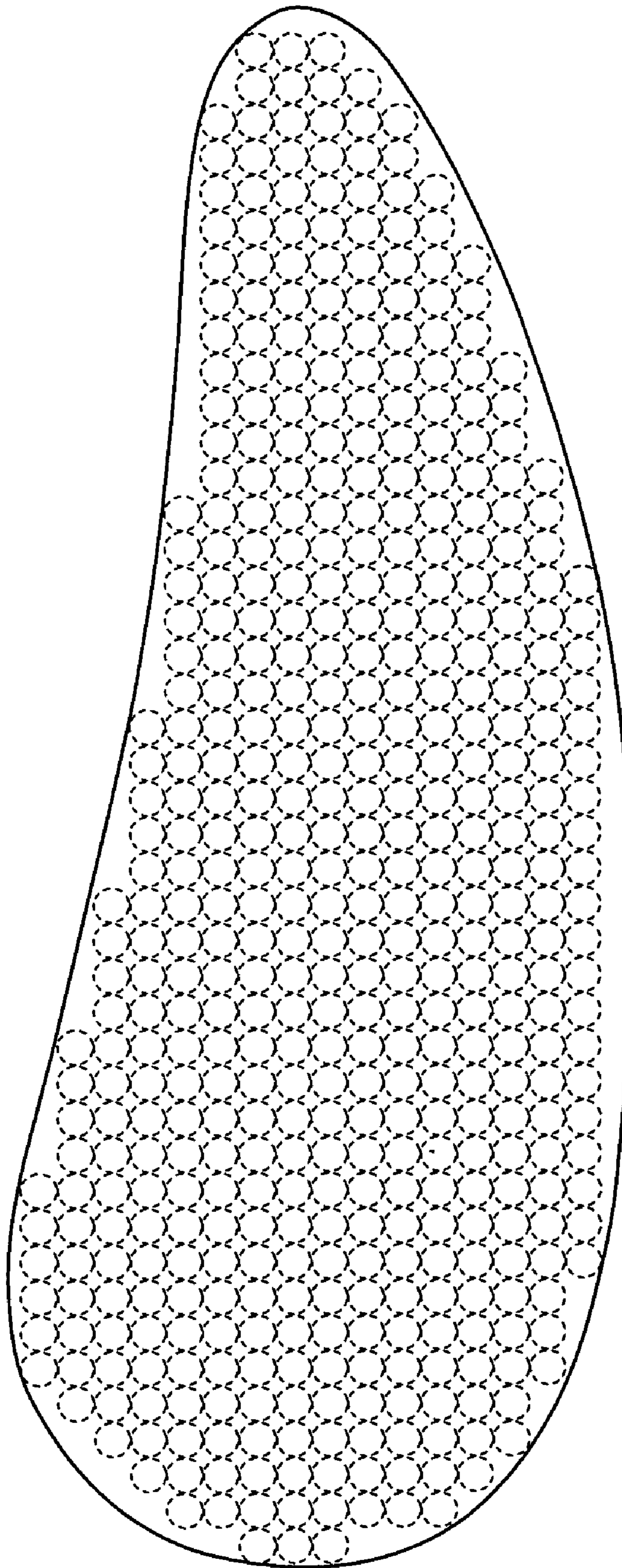
