FIG. 3 is a side view of the chair, as shown in FIG. 1;

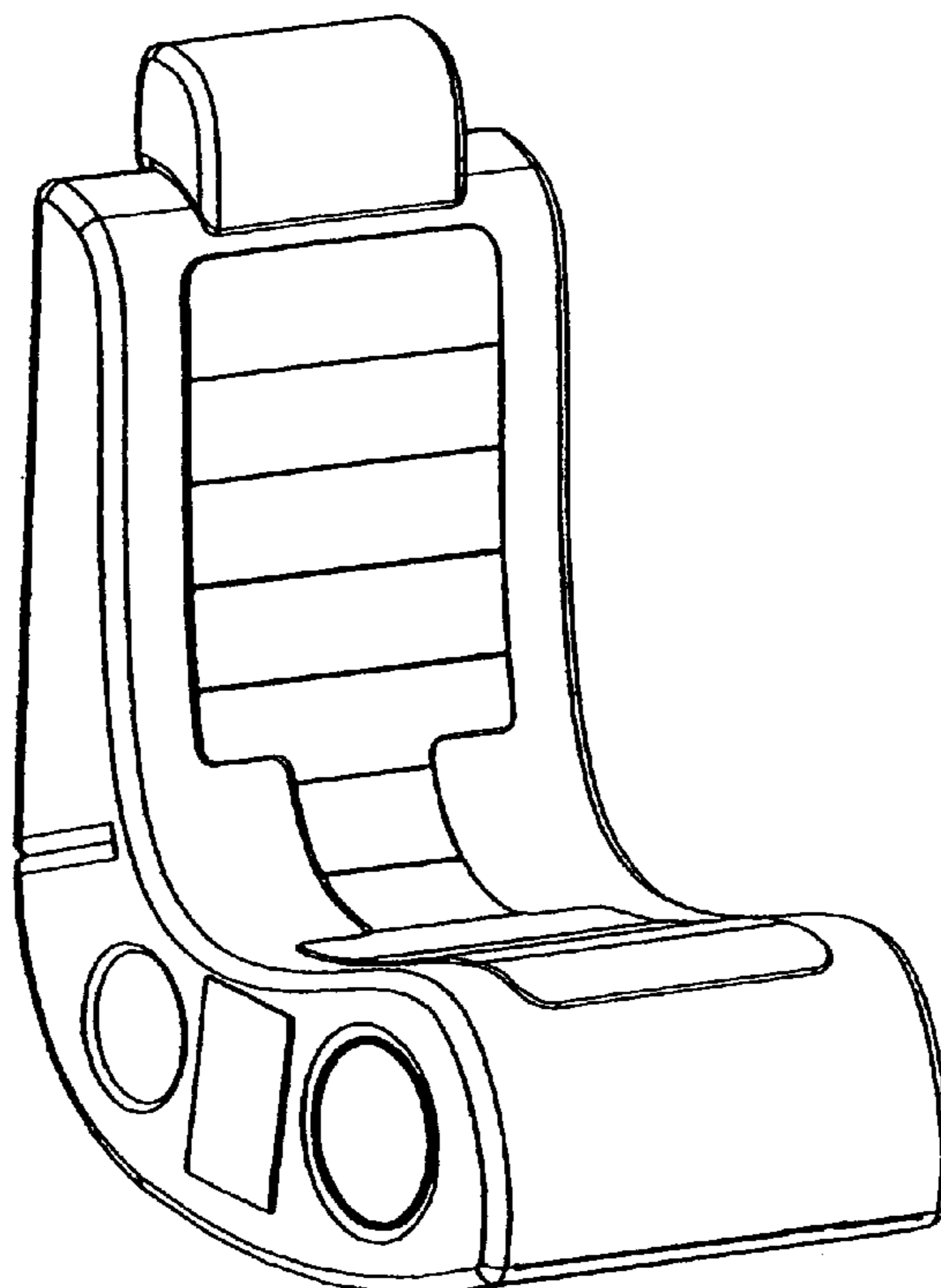
FIG. 4 is a side view of the chair, opposite the side view of FIG. 3, as shown in FIG. 1;

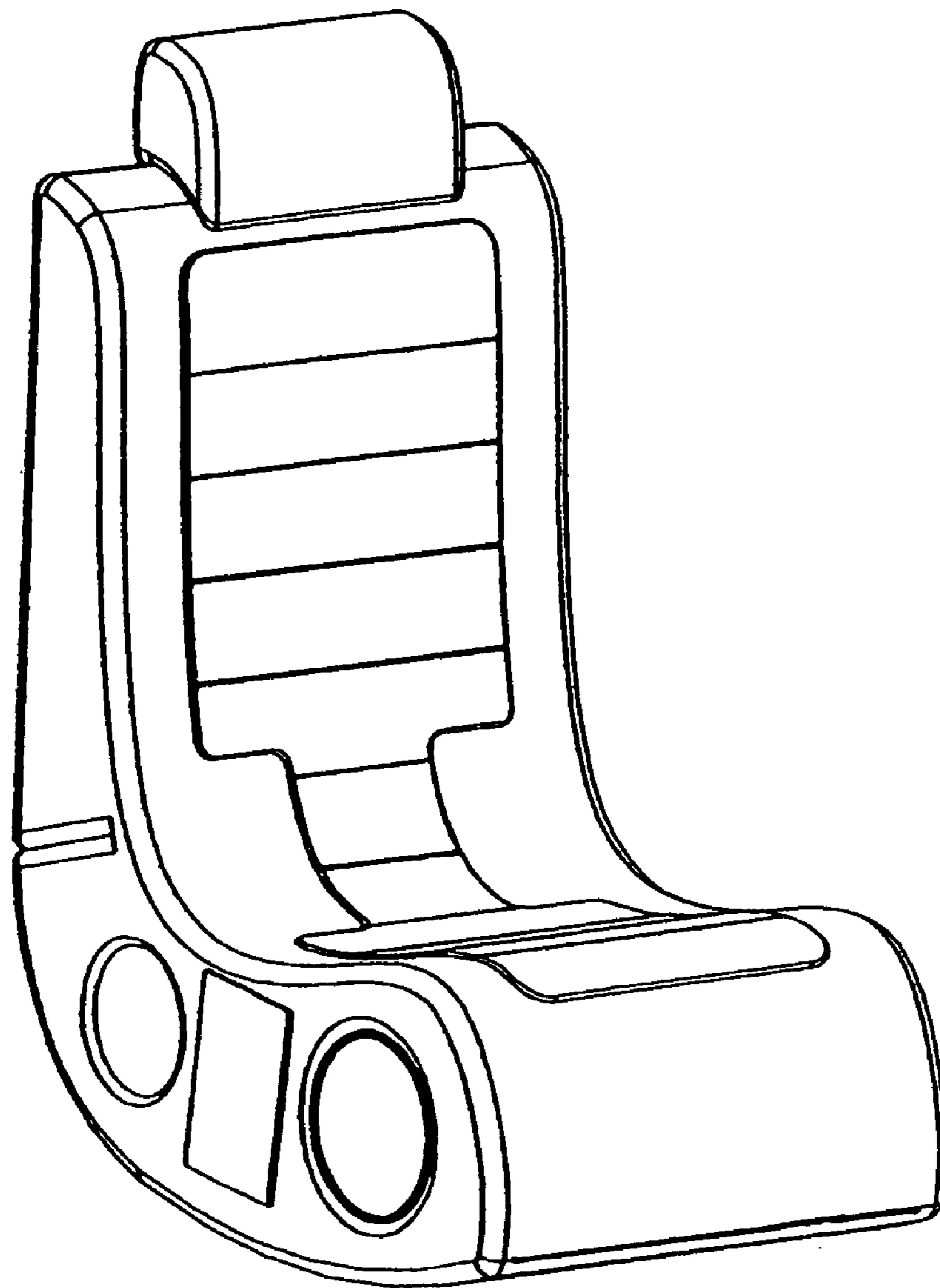

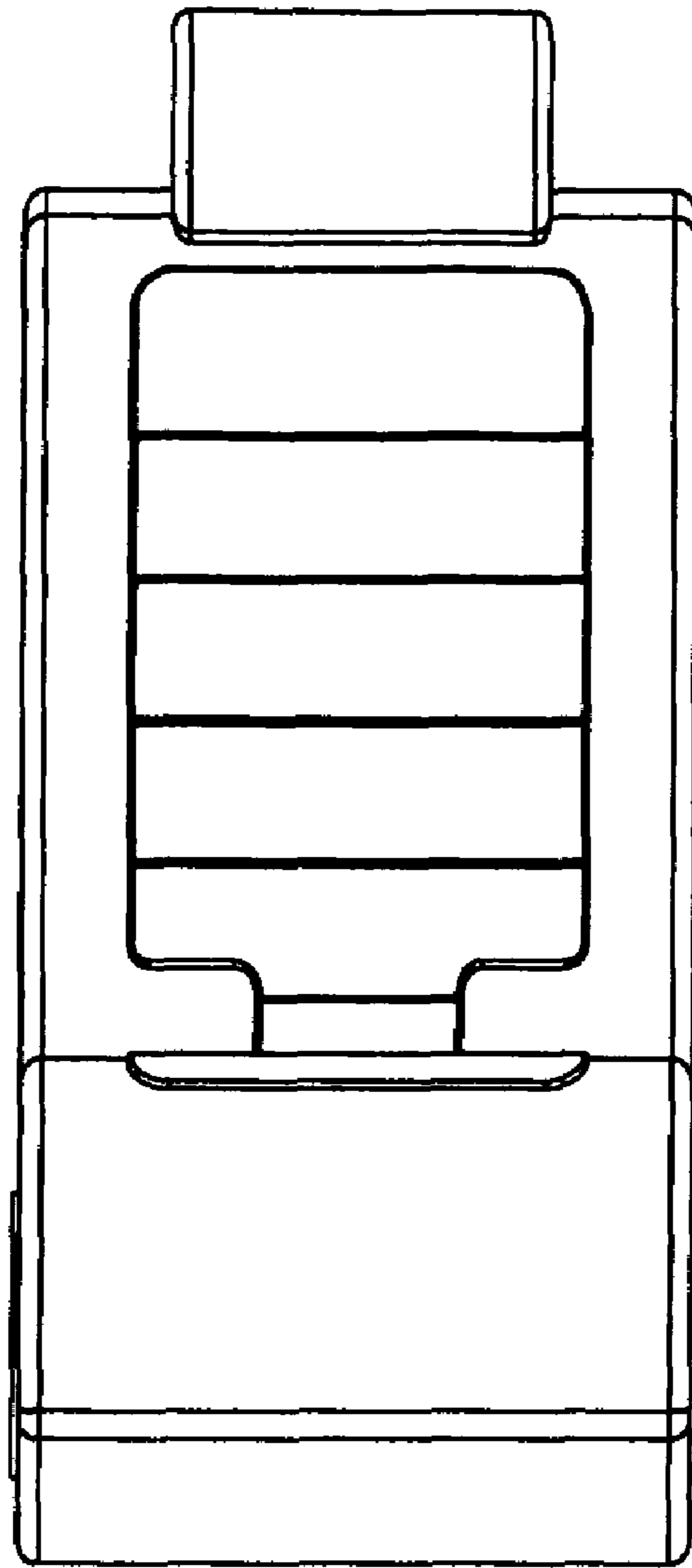

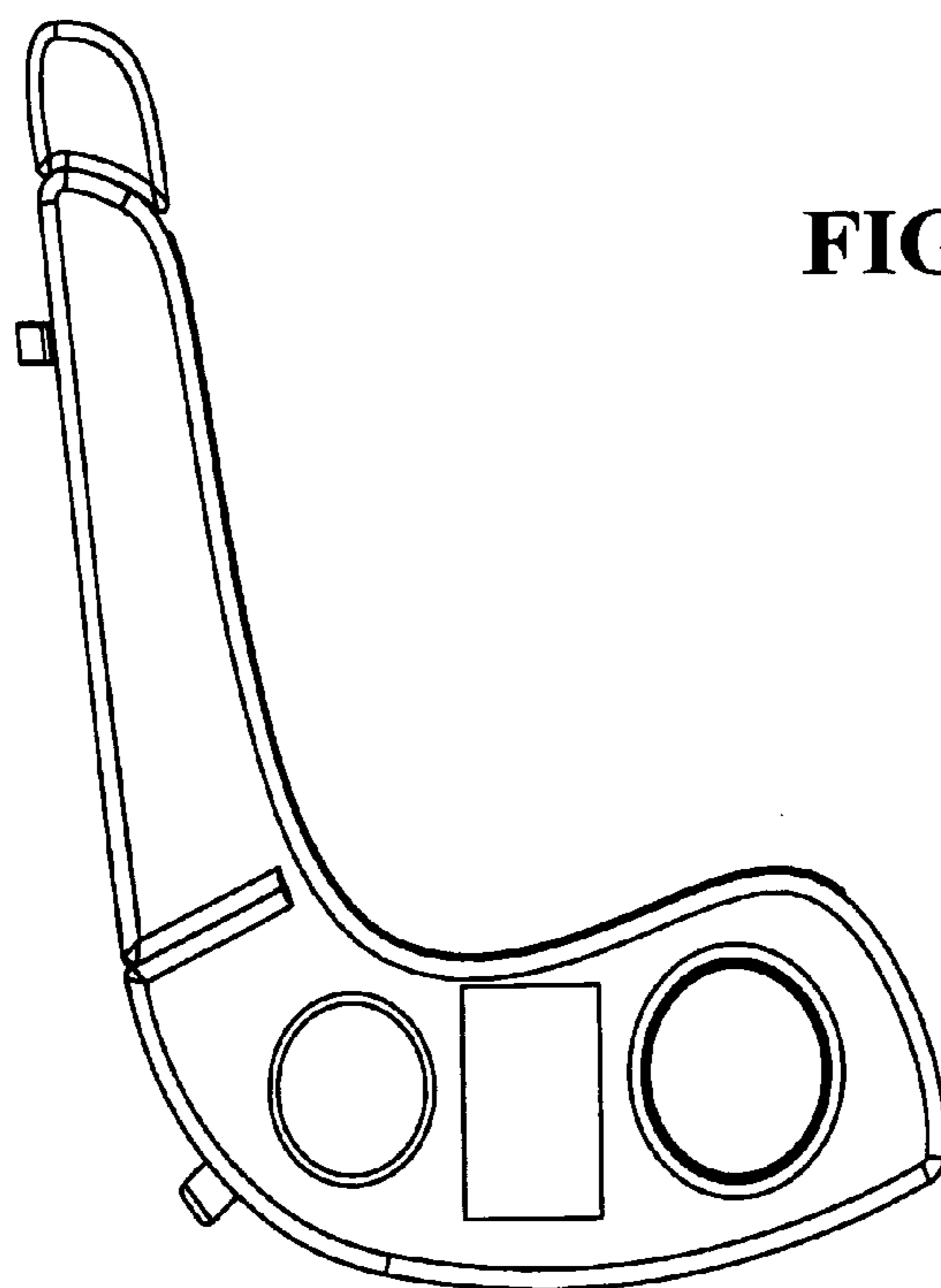

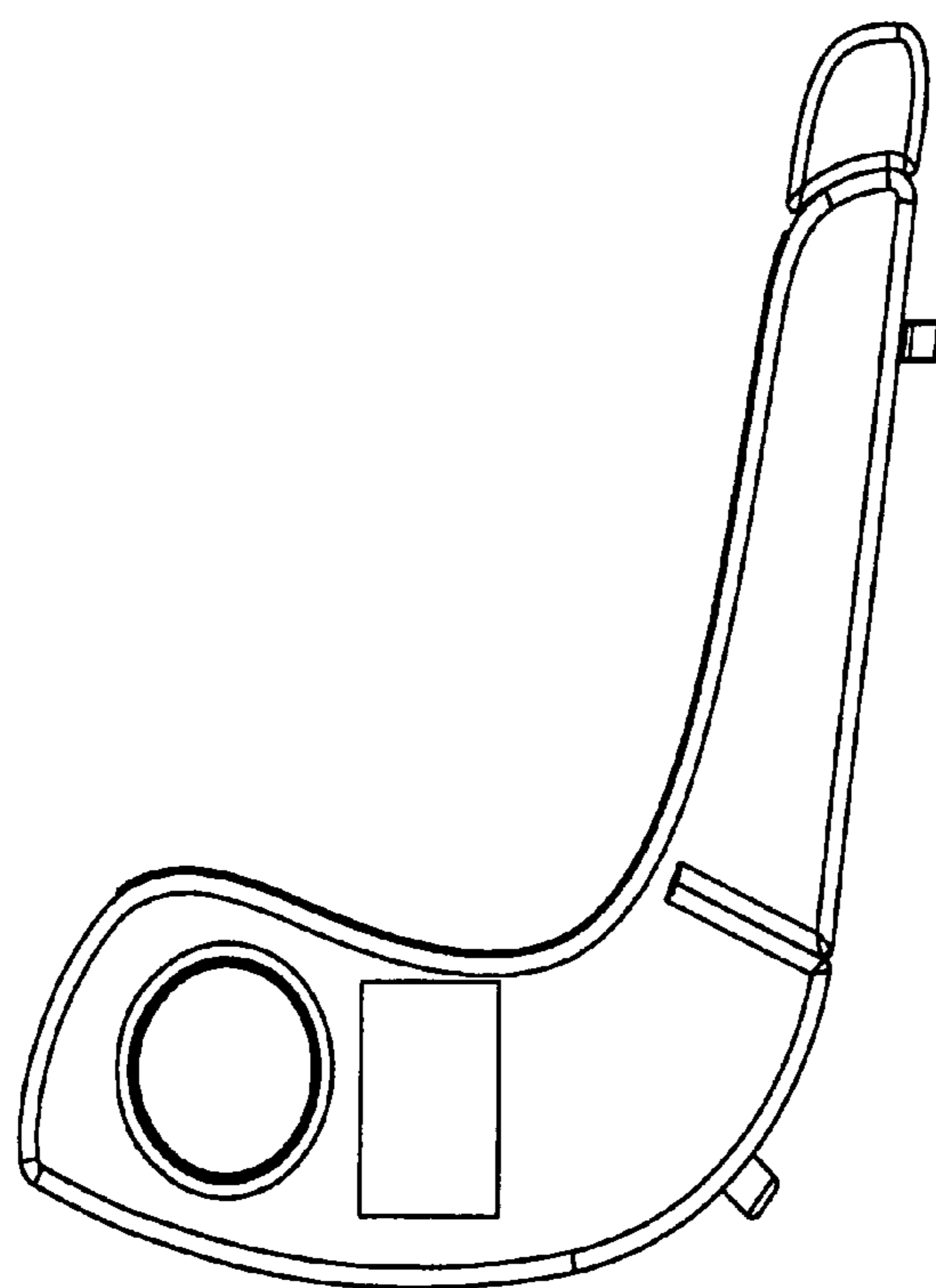

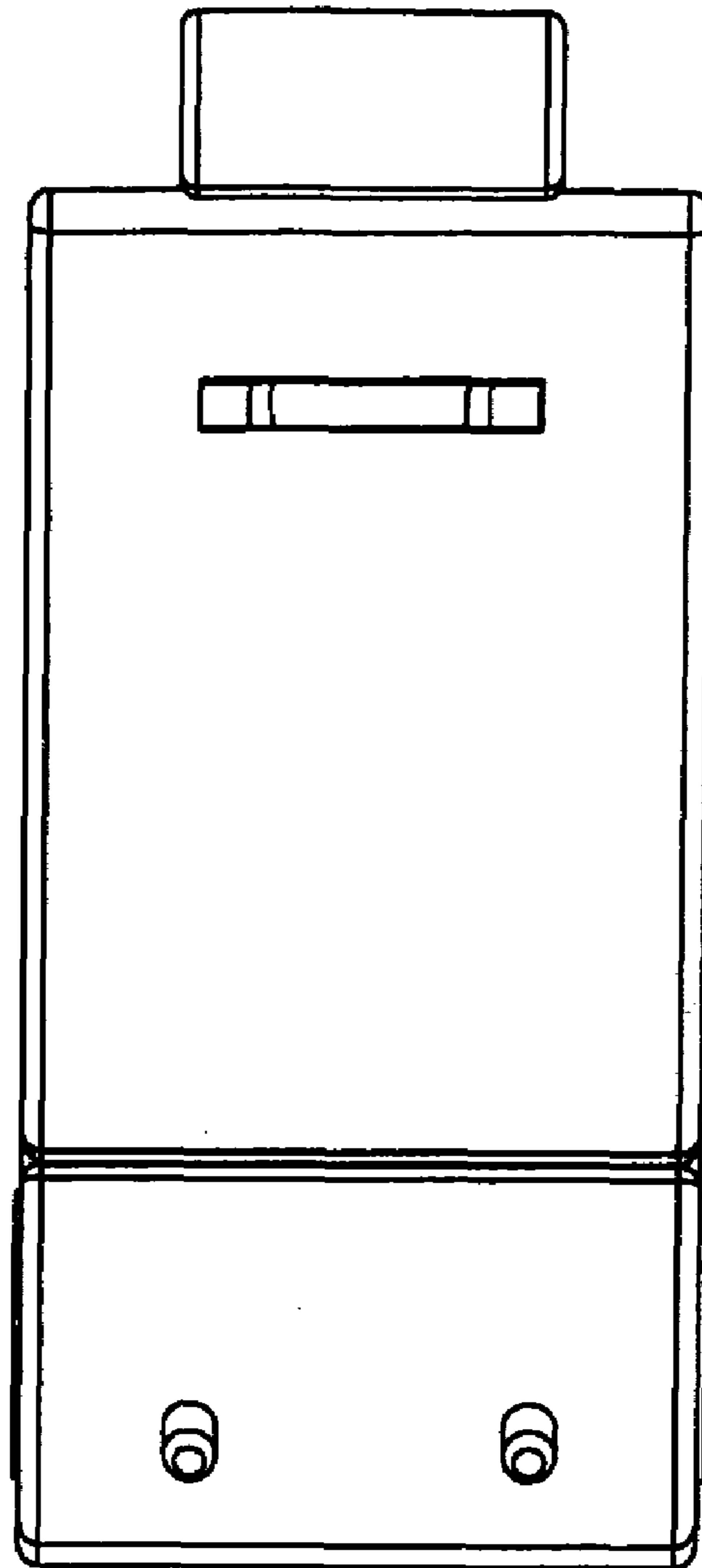

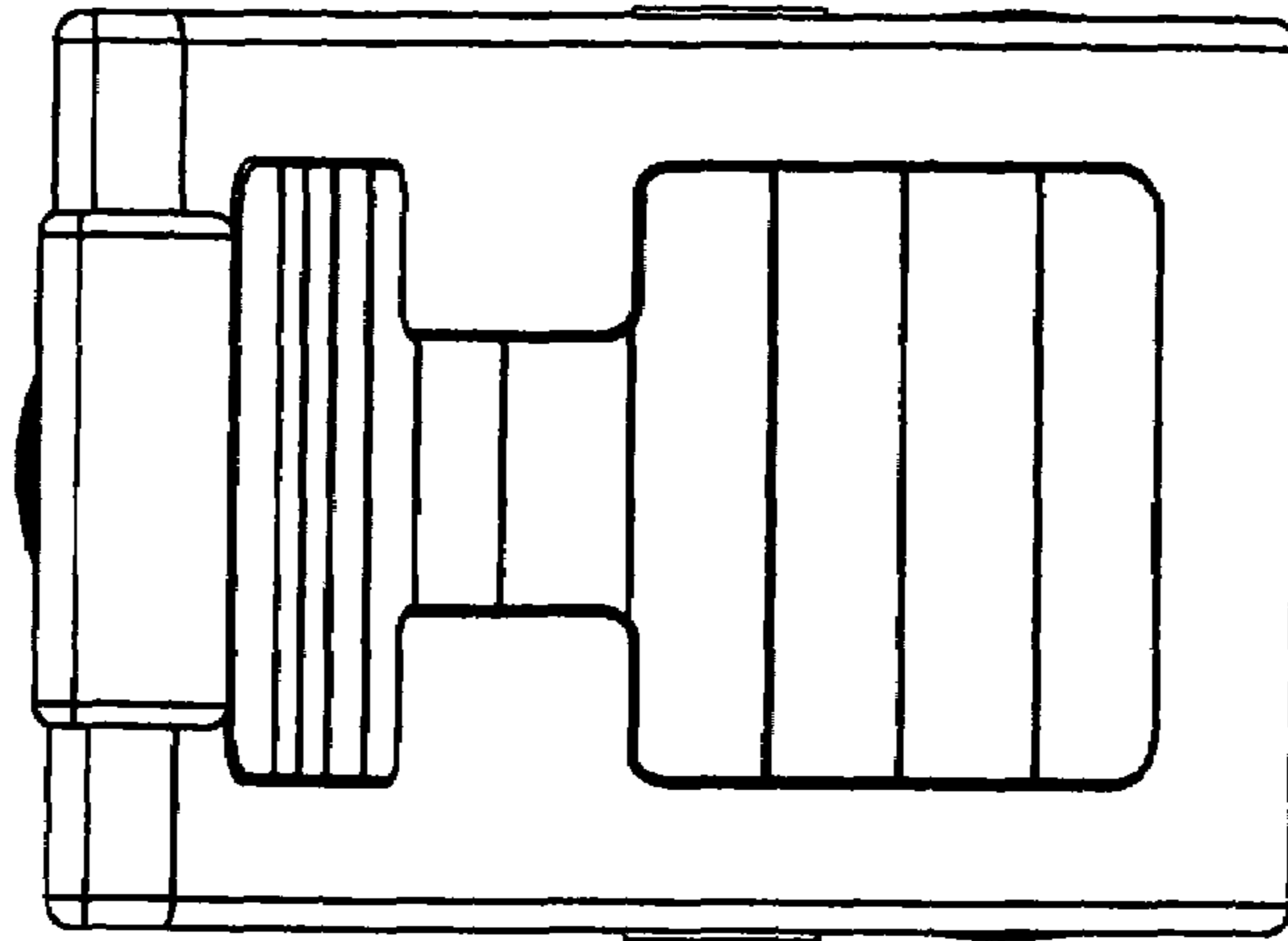

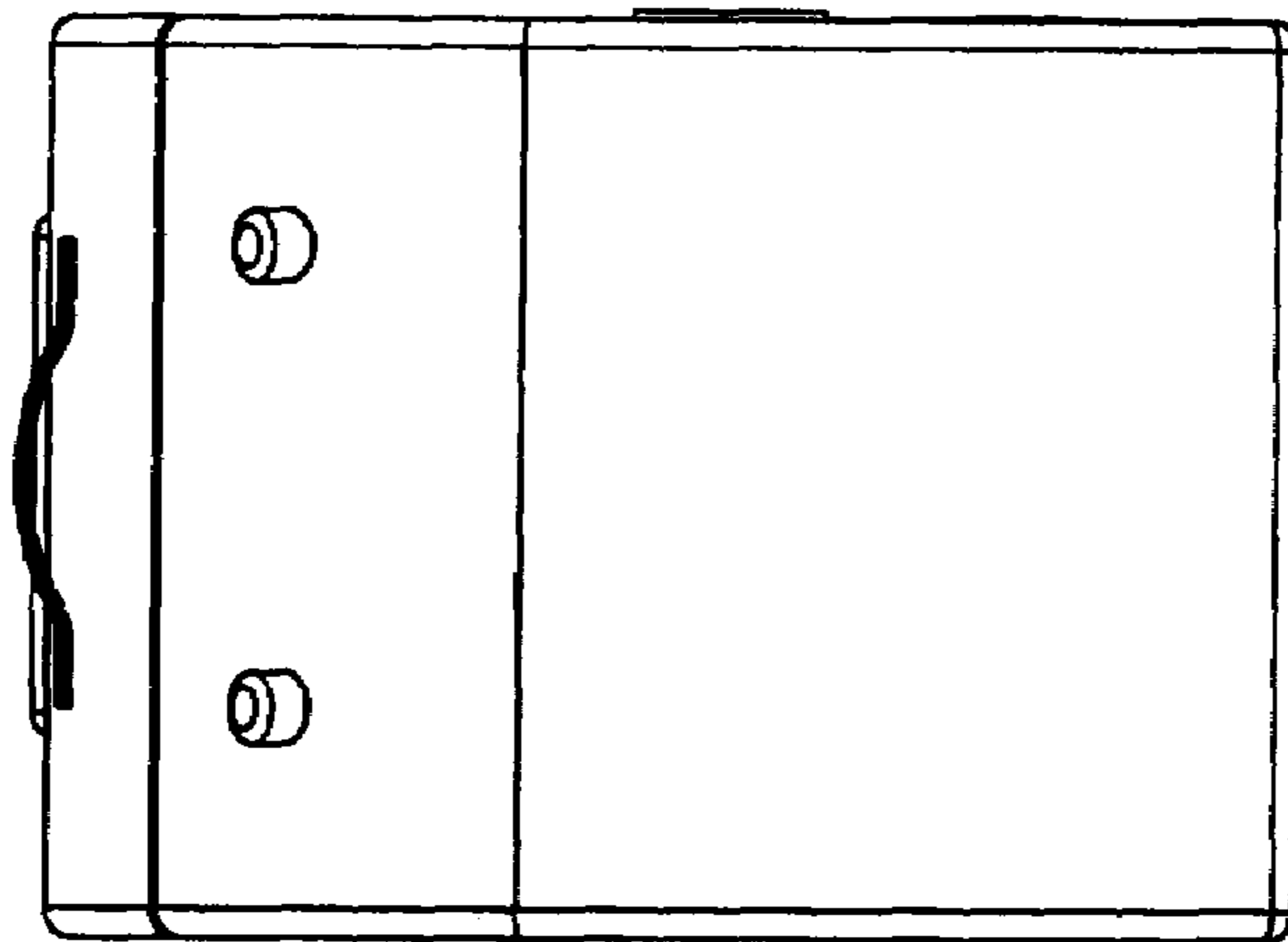
