FIG. 4 is a side view of the handle;

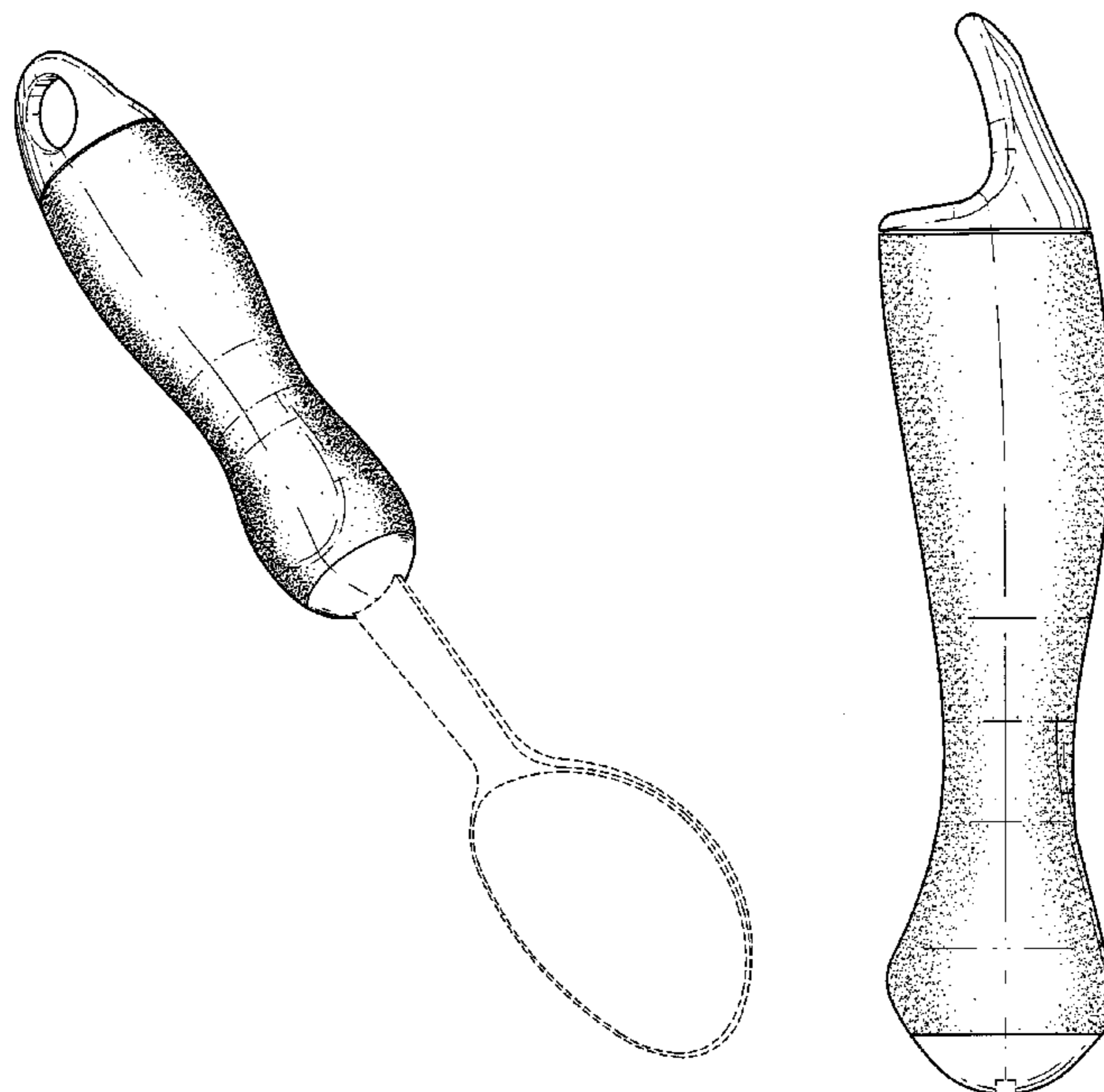
FIG. 5 is a bottom view of the handle;

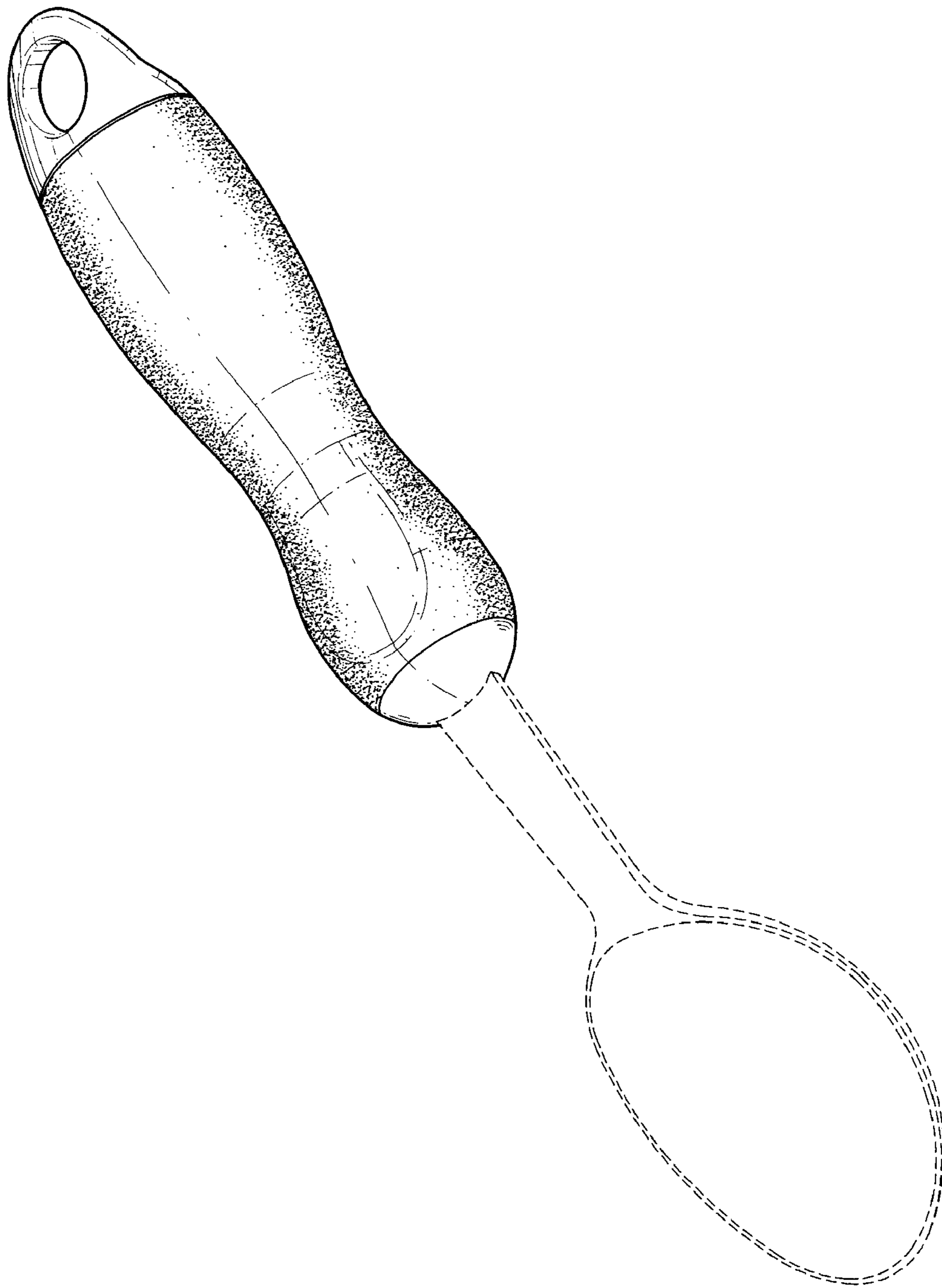

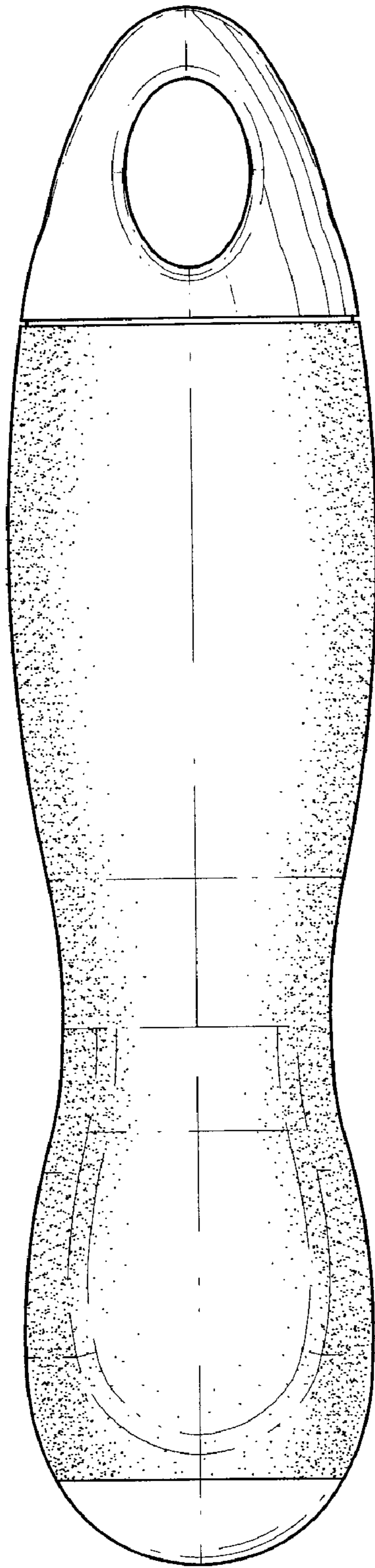

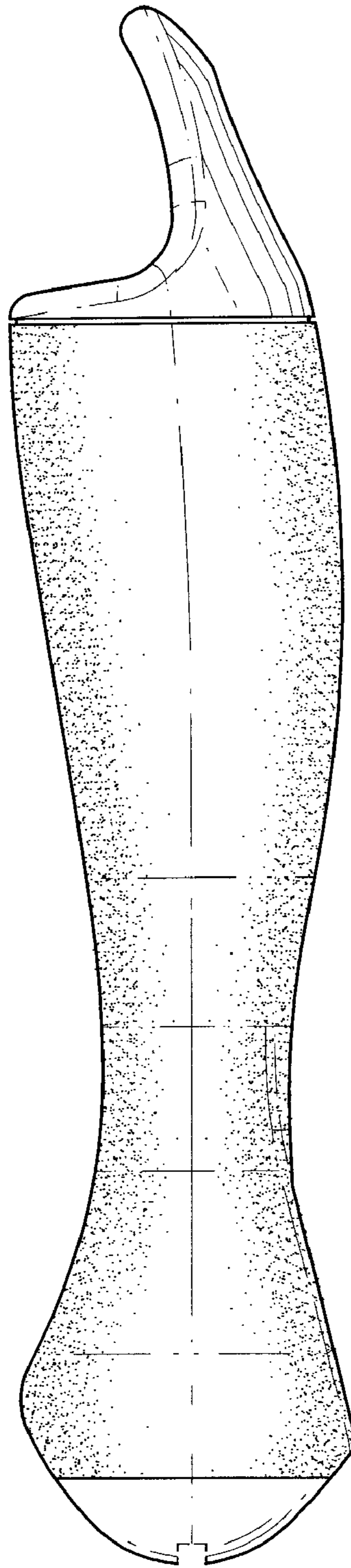

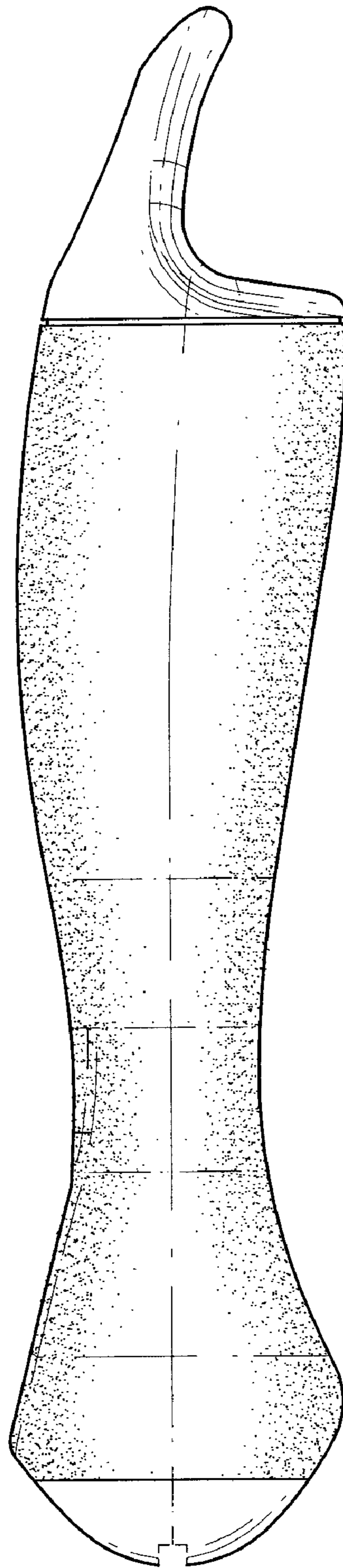

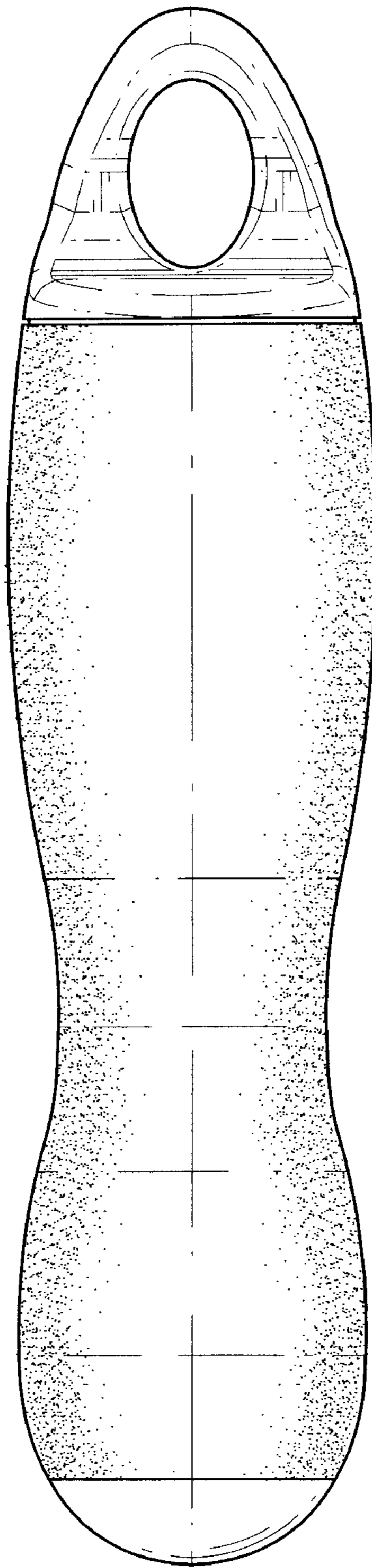

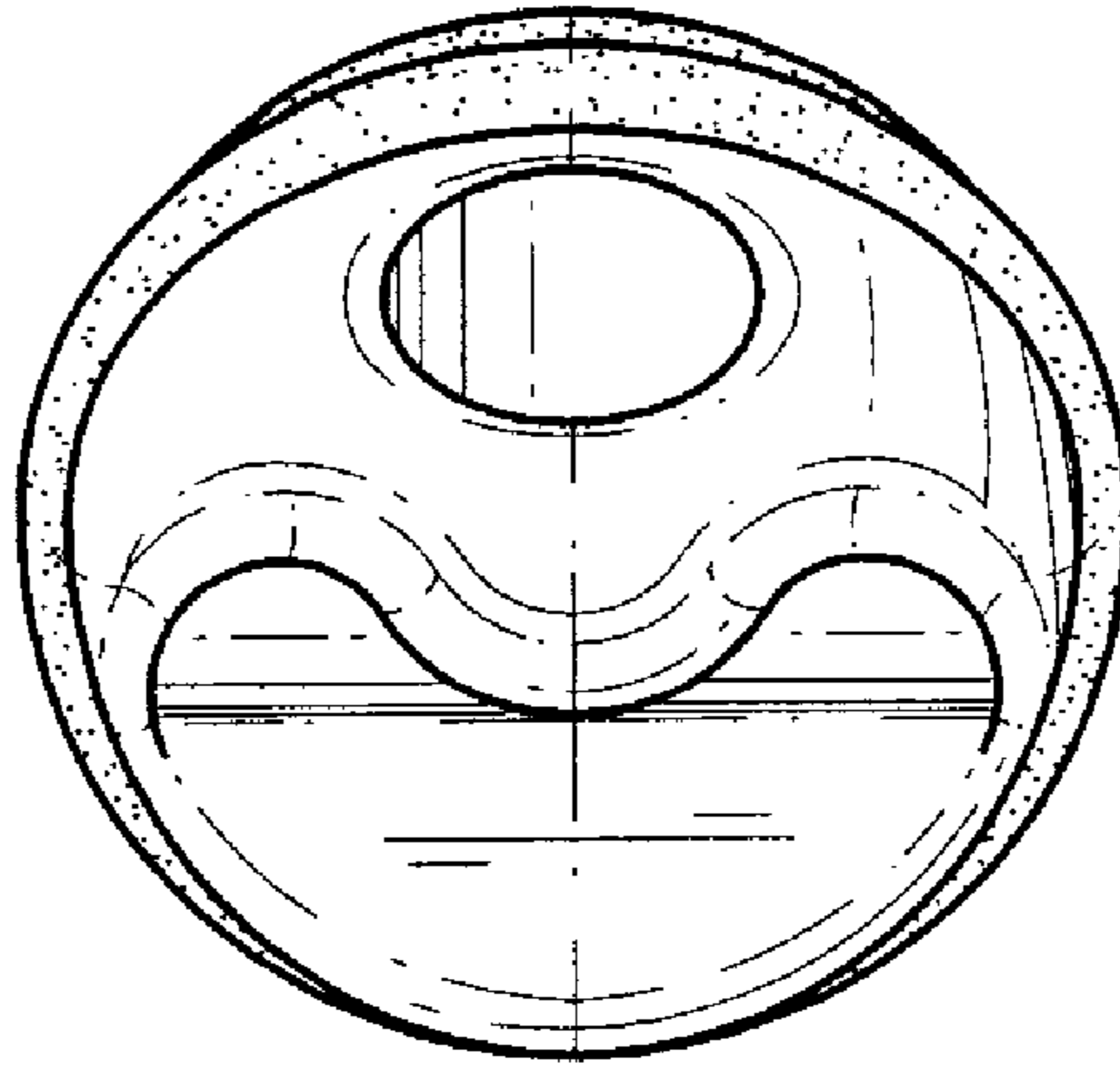

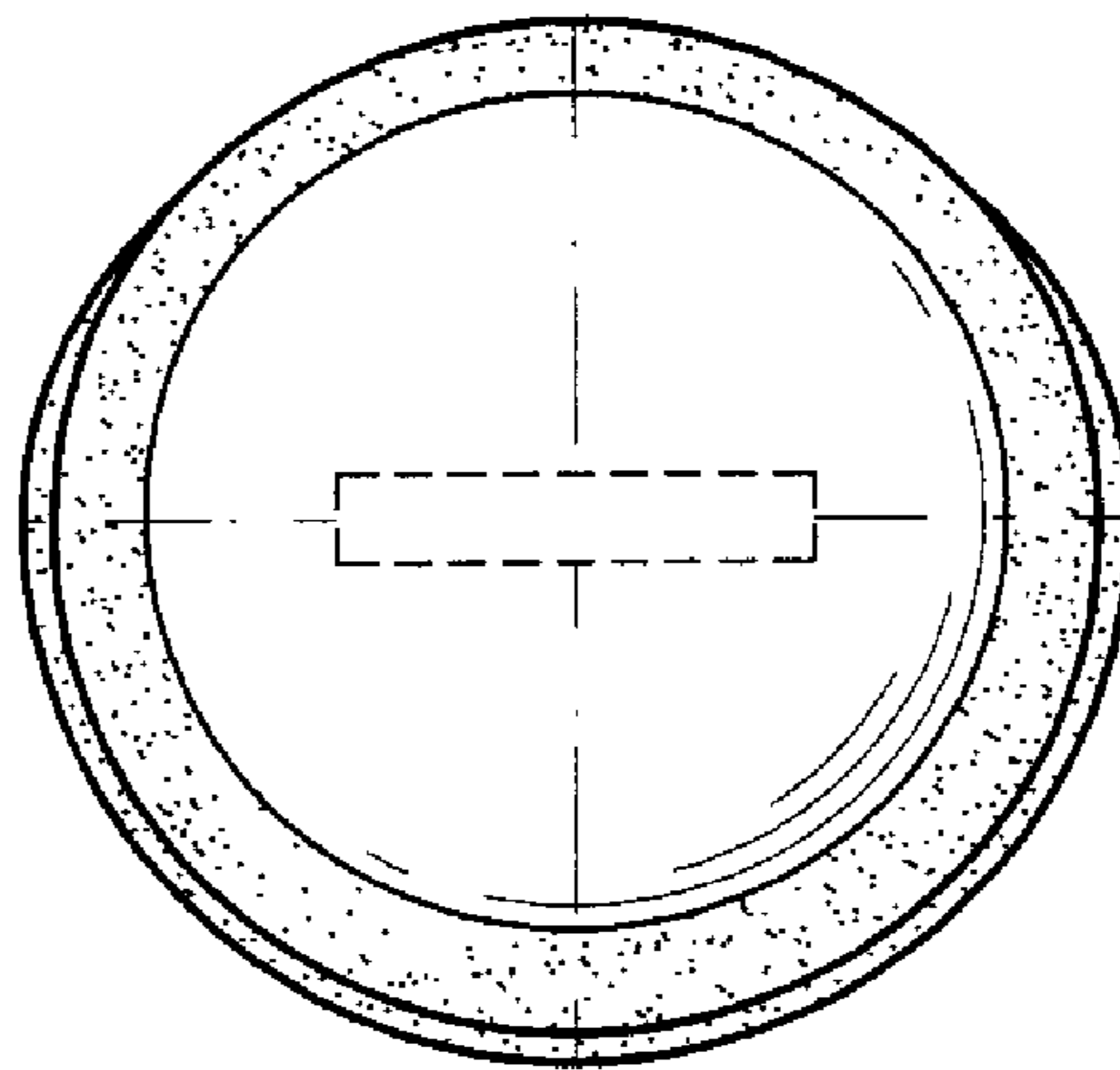
