(57) **CLAIM**

The ornamental design for a steamer insert apparatus, as shown.

DESCRIPTION

A device for insertion into a kitchen pot for steaming a hot dog bun or the like, while providing access for insertion and removal of a hot dog or the like.

FIG. 1 is a perspective view of a steamer insert apparatus.

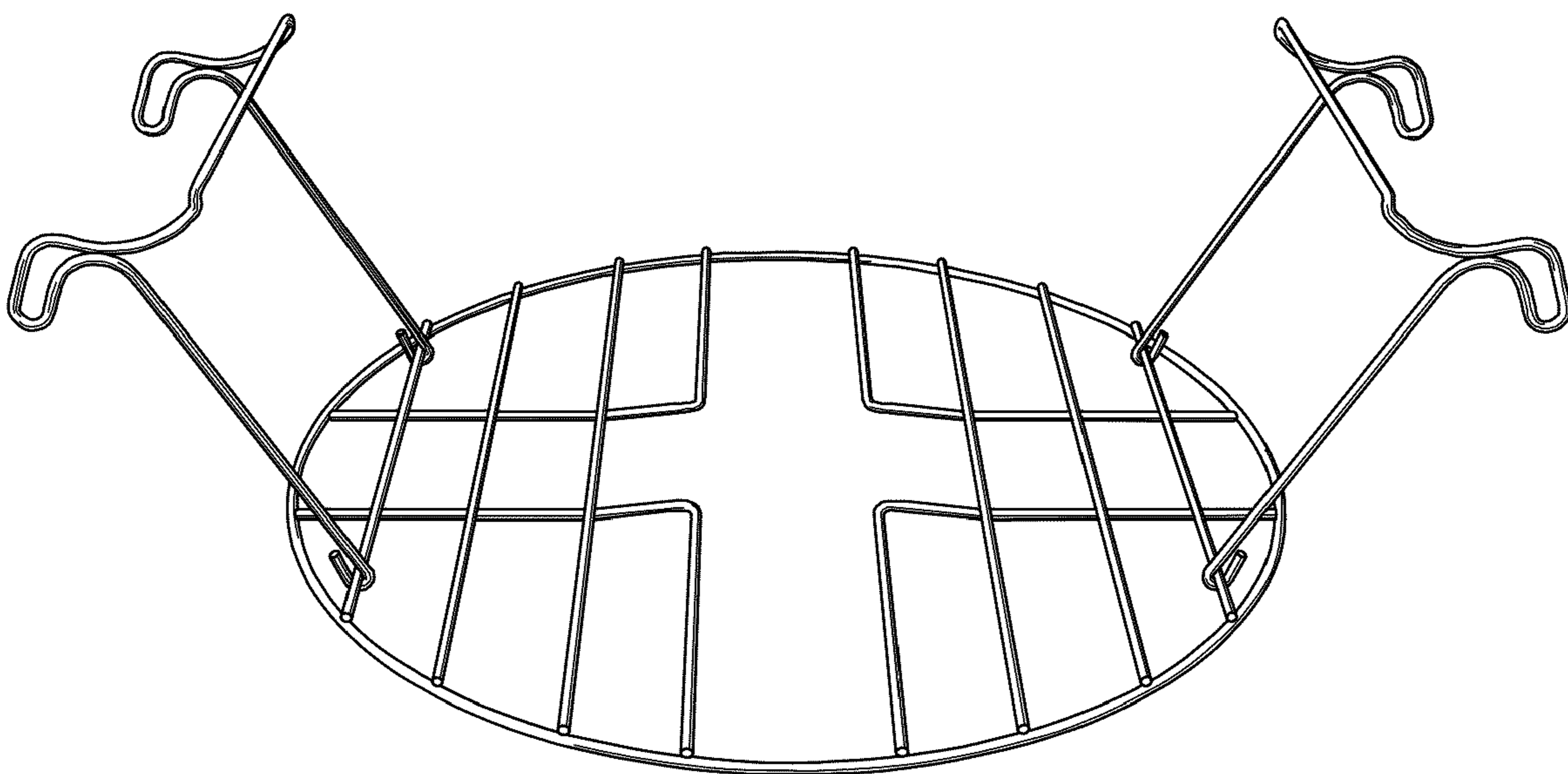
FIG. 2 is a top plan view of a steamer insert apparatus.

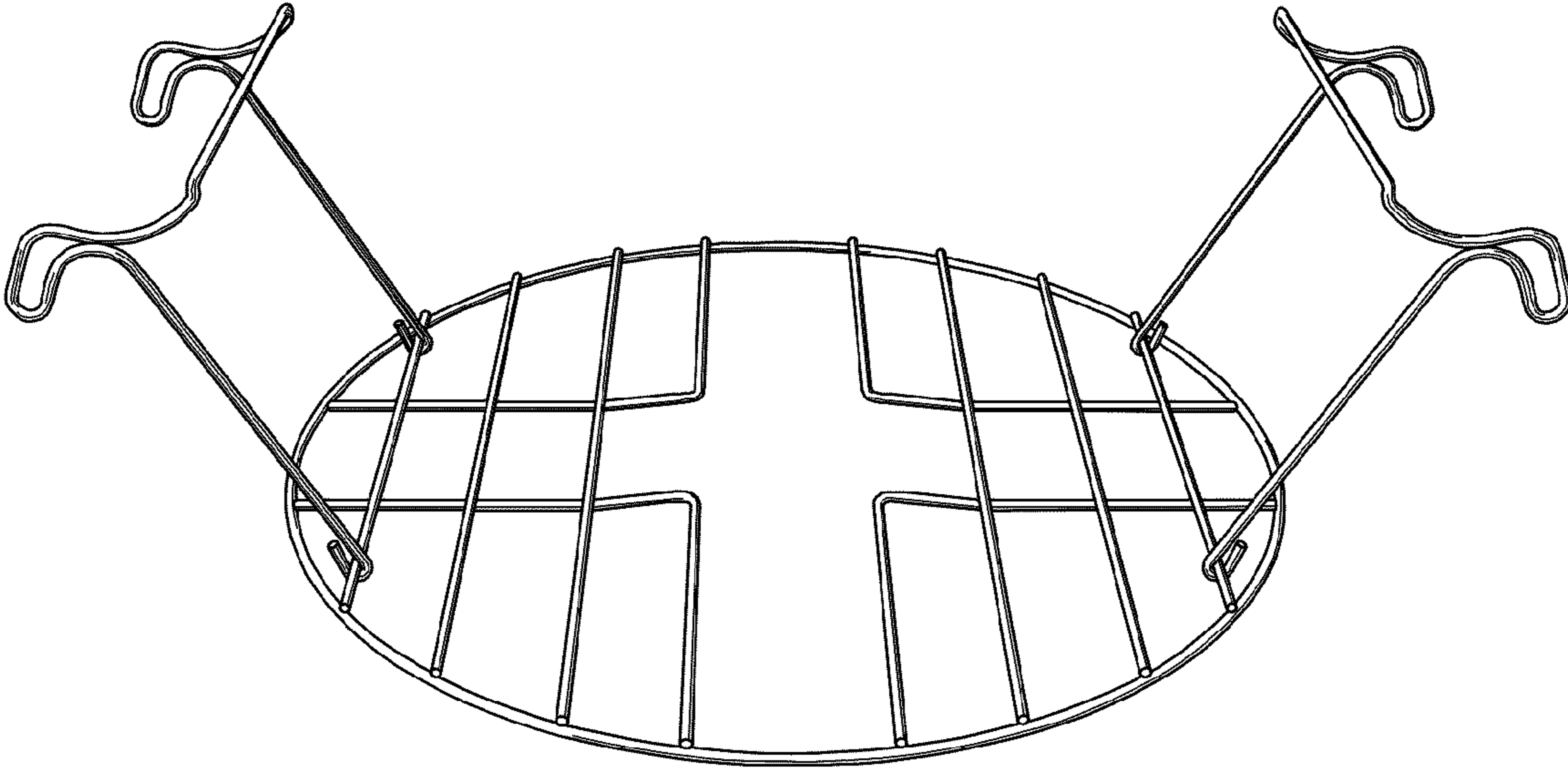

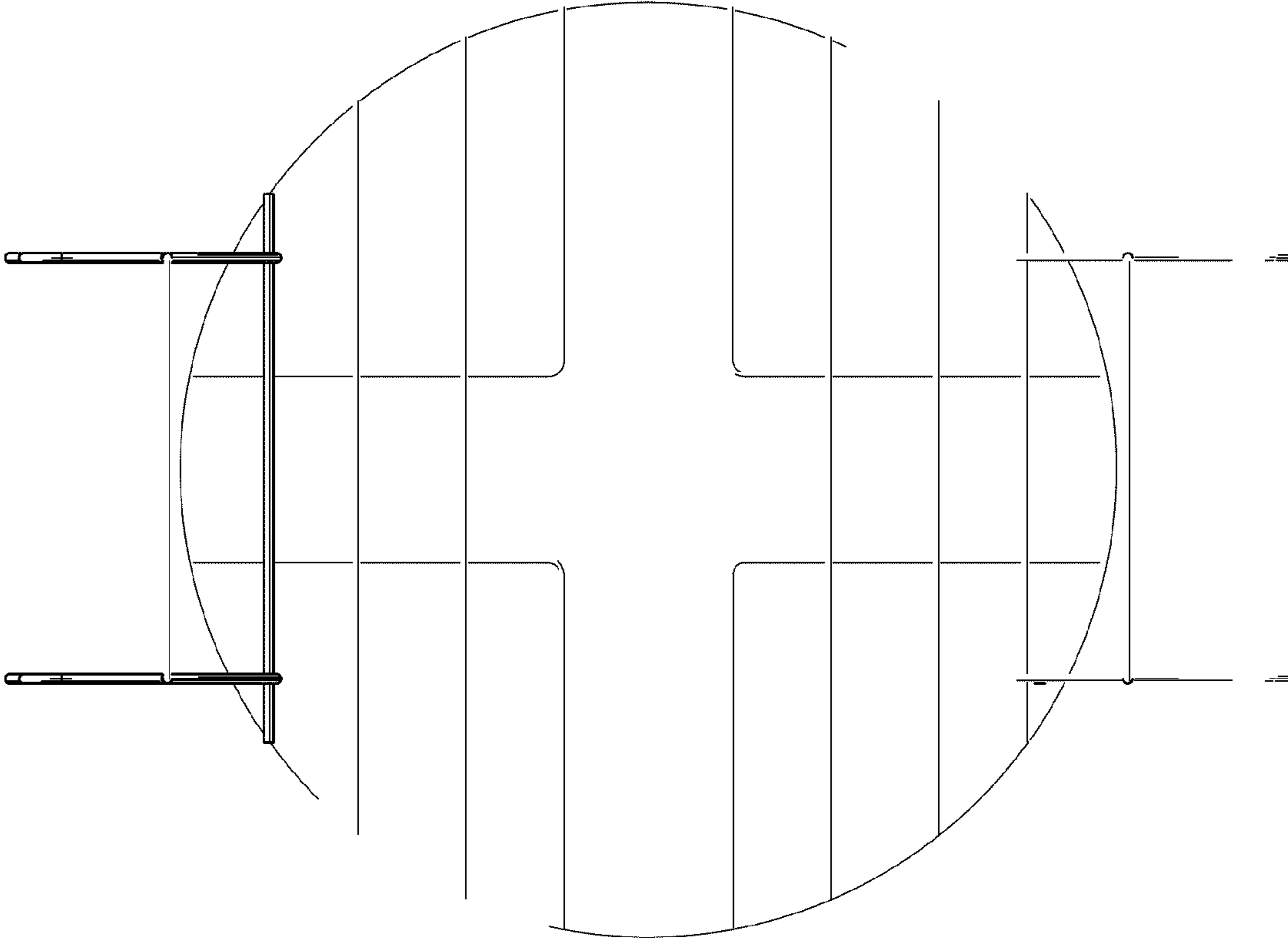

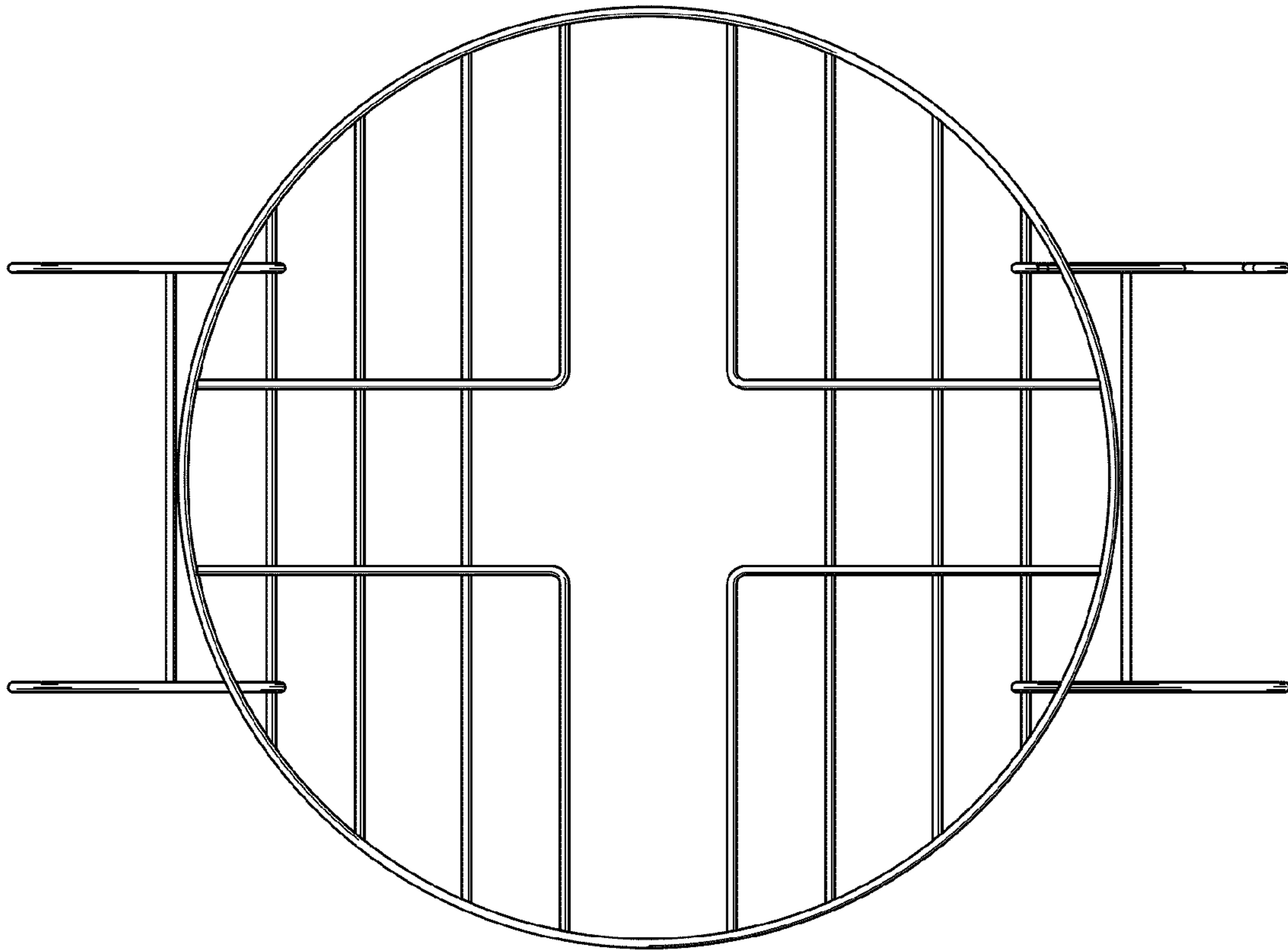

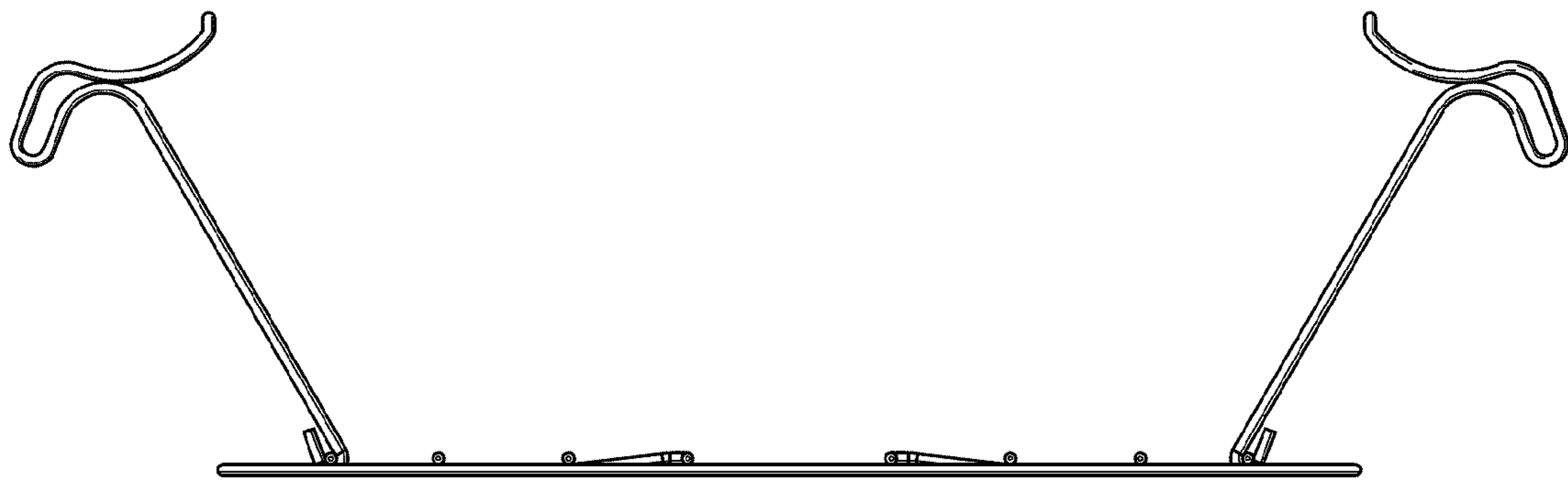

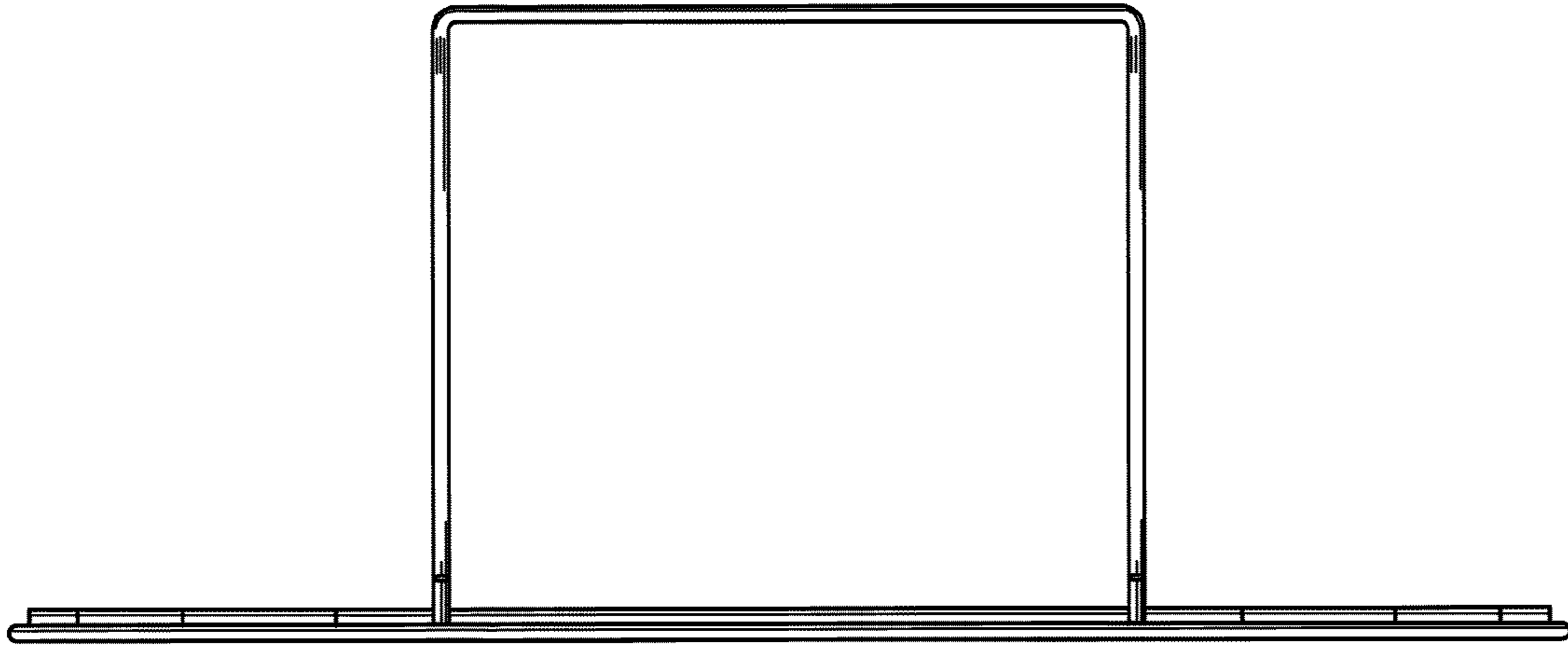
