(57) CLAIM

The ornamental design for flip cap with mirrored top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flip cap with mirrored top, illustrated with the flip cap in an open position, showing my new design;

FIG. 2 is a front elevational view of the invention, illustrated with the flip cap in a closed position;

FIG. 3 is a rear elevational view of the invention, illustrated with the flip cap in the closed position;

FIG. 4 is a left-side elevational view of the invention, illustrated with the flip cap in the closed position;


FIG. 5 is a right-side elevational view of the invention, illustrated with the flip cap in the closed position;

FIG. 6 is a top plan view of the invention, illustrated with the flip cap in the closed position; and,

FIG. 7 is a bottom plan view of the invention, illustrated with the flip cap in the closed position,

The broken line showing a container in the figures is included for the purpose of illustrating the invention in use, and forms no part of the claimed design. The bottom plan view of the invention is not visible when in use, and forms no part of the claimed design.













