FIG. 1 is a perspective view of a diamond showing my new design;

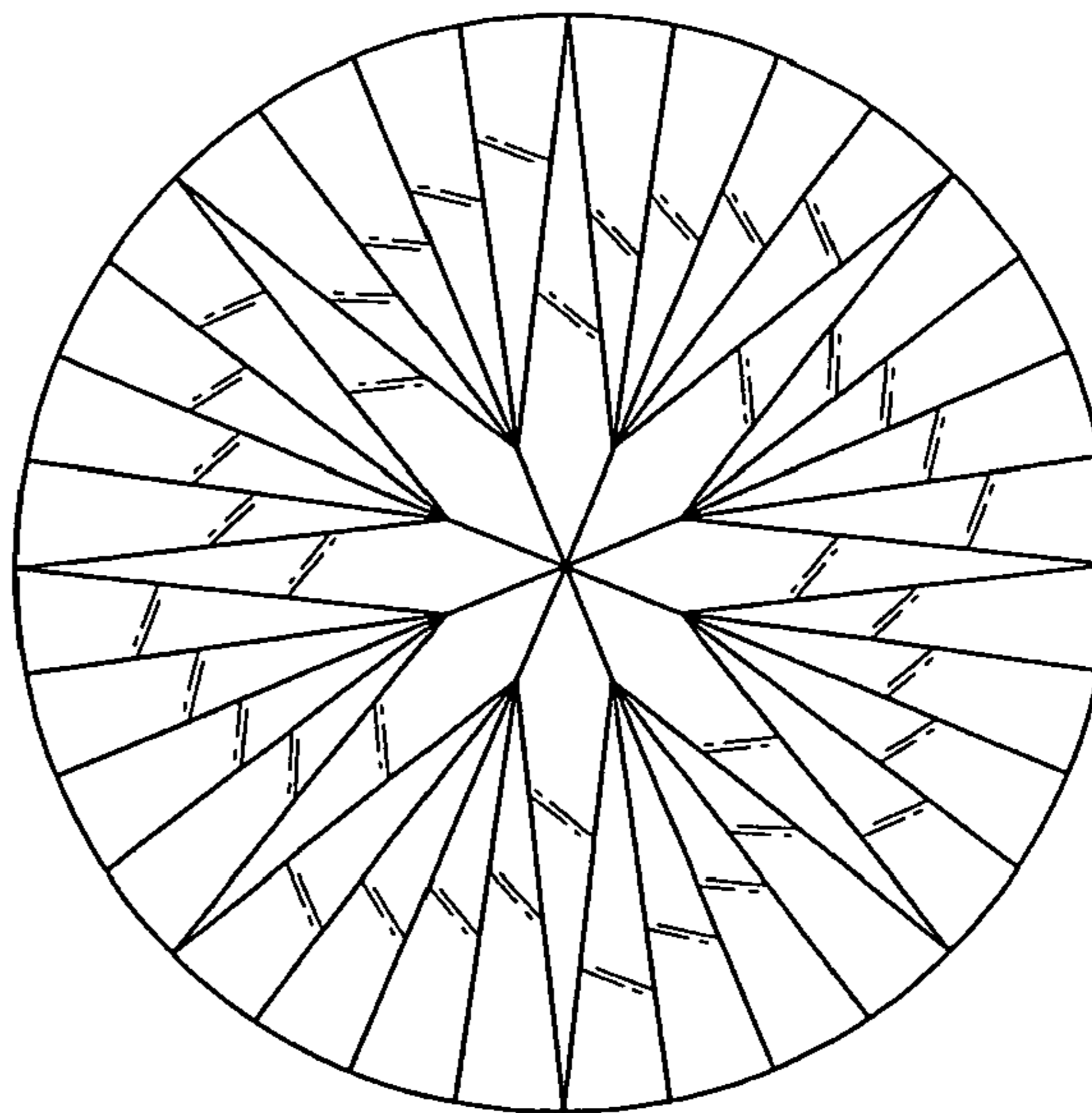
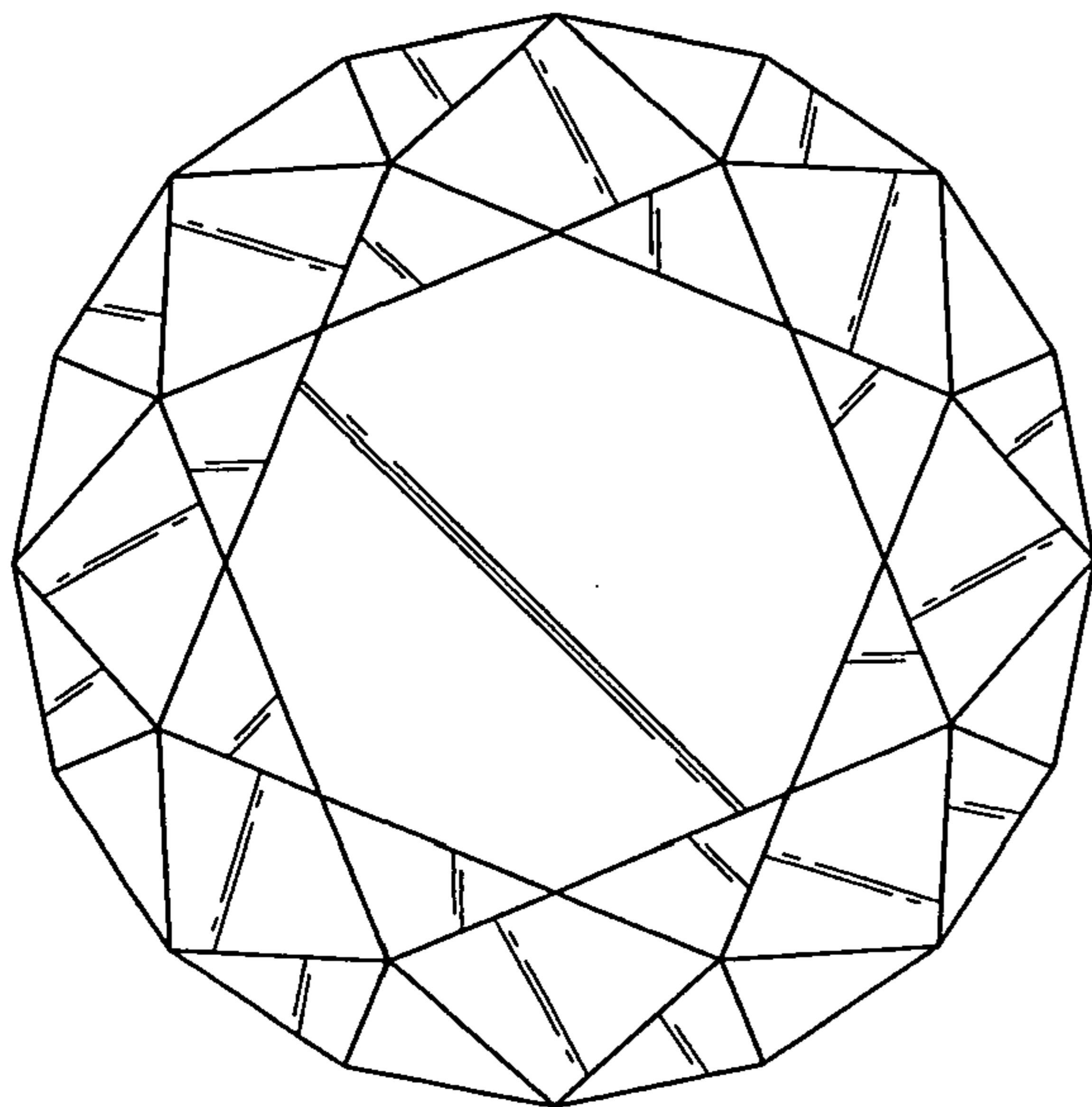
FIG. 2 is a perspective view of FIG. 1 showing the gemstone slightly rotated;

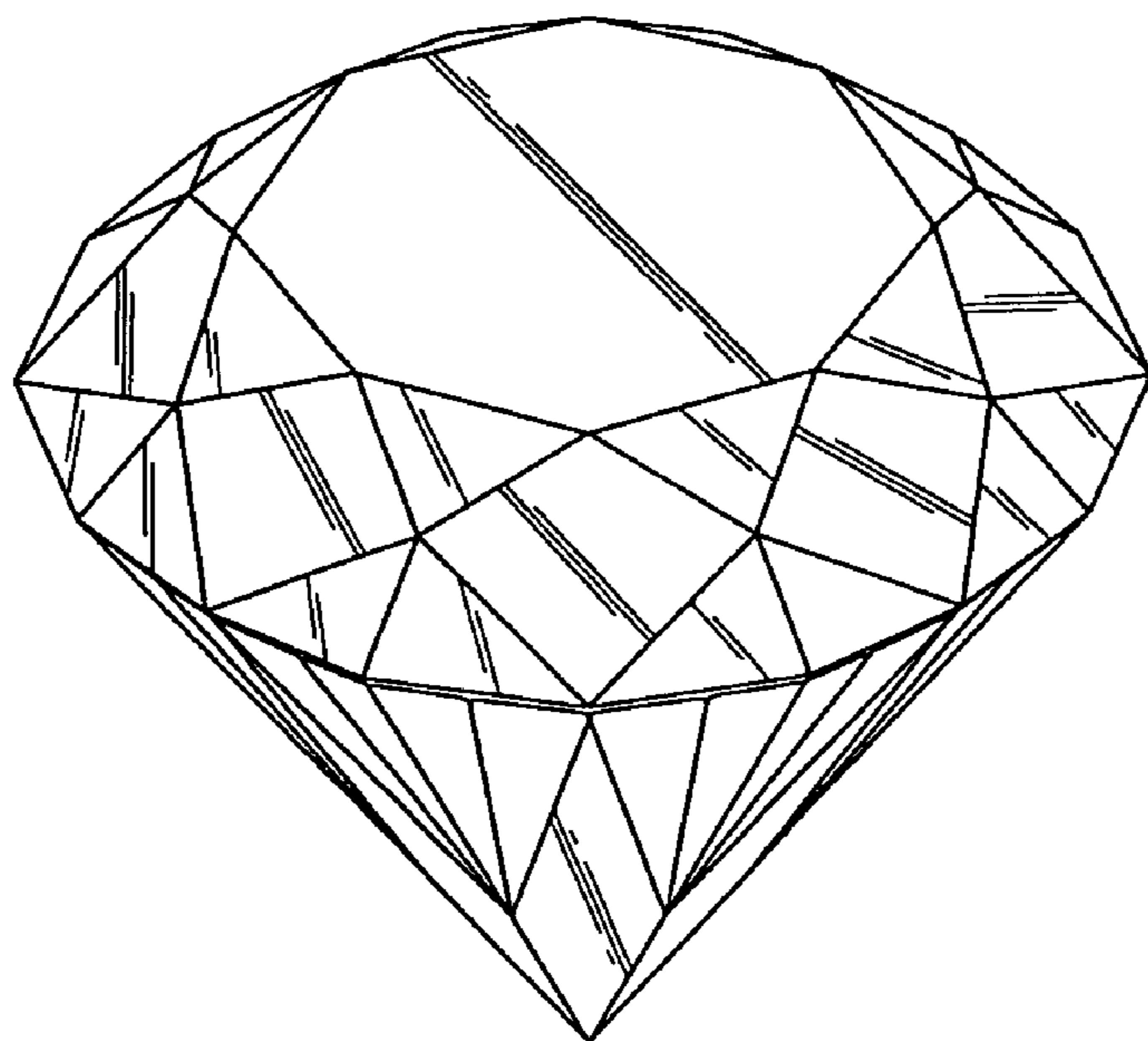

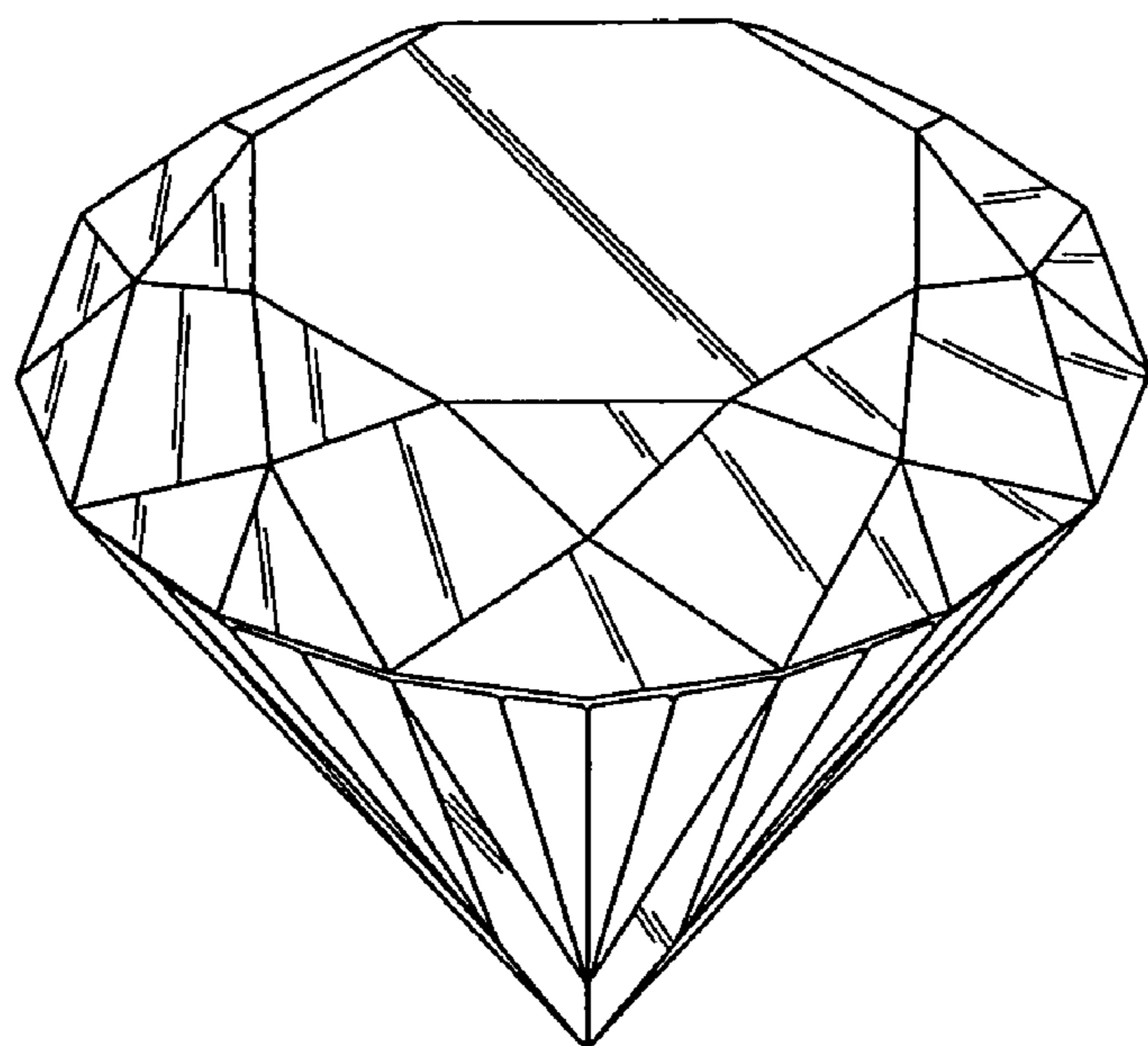

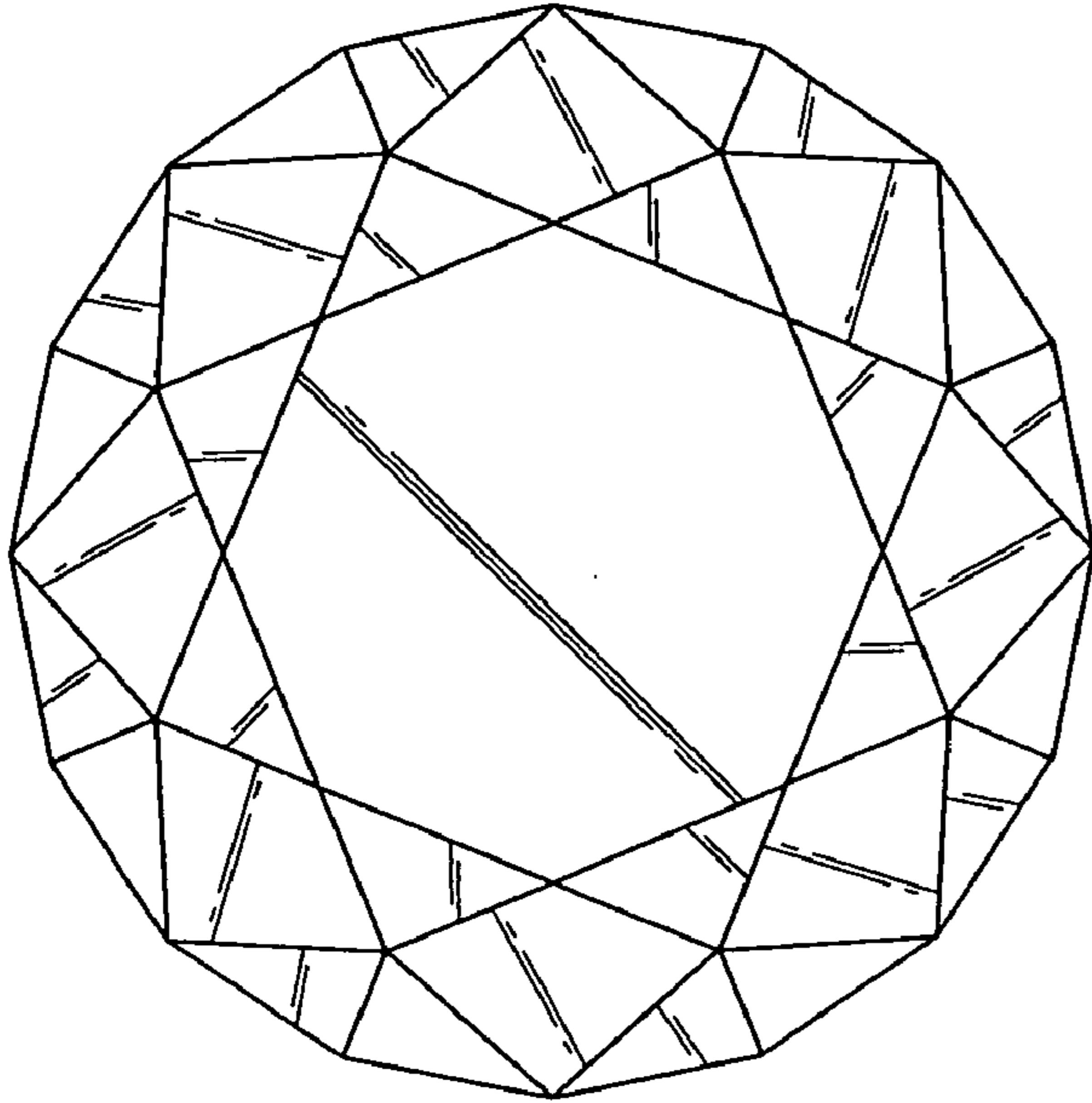

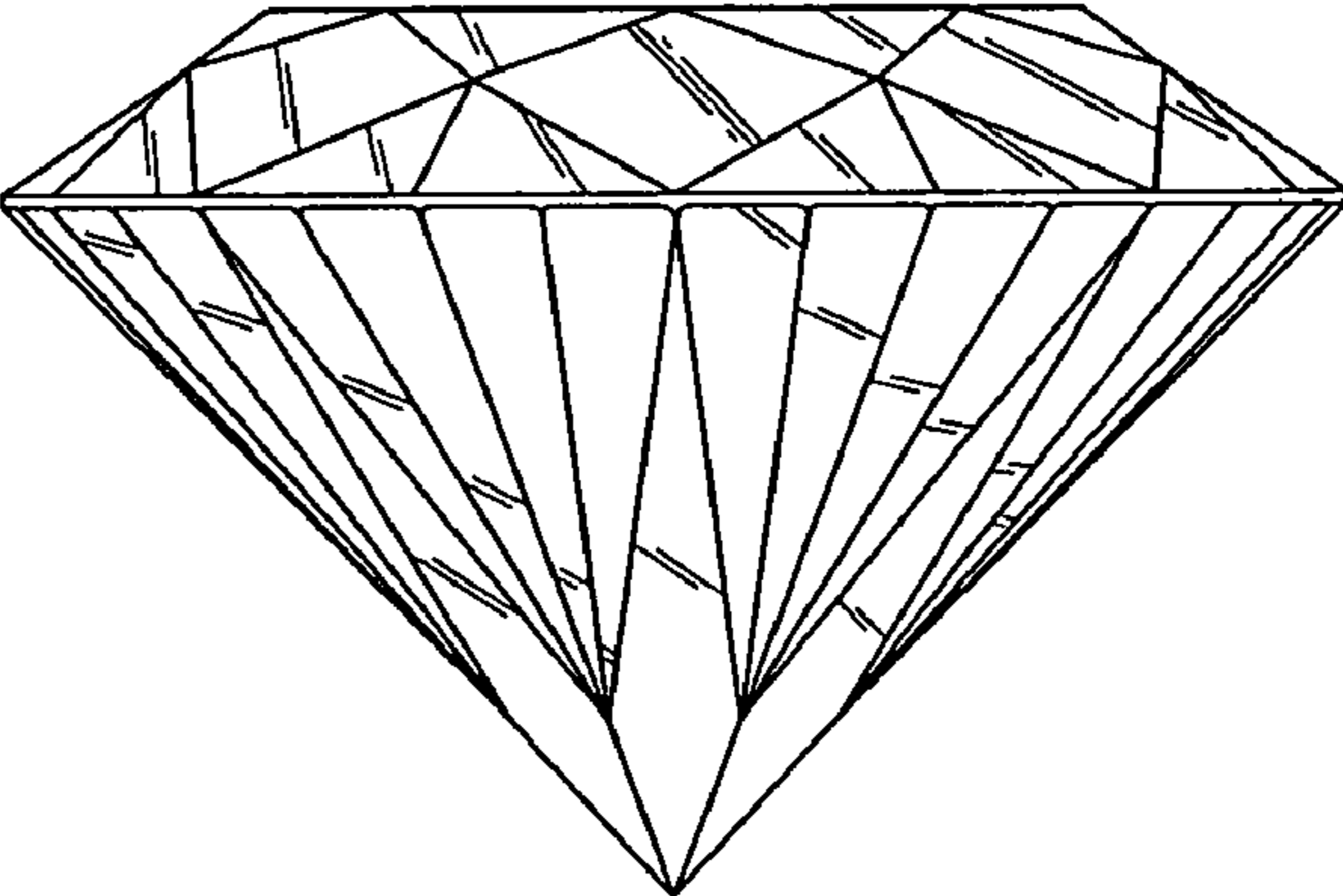

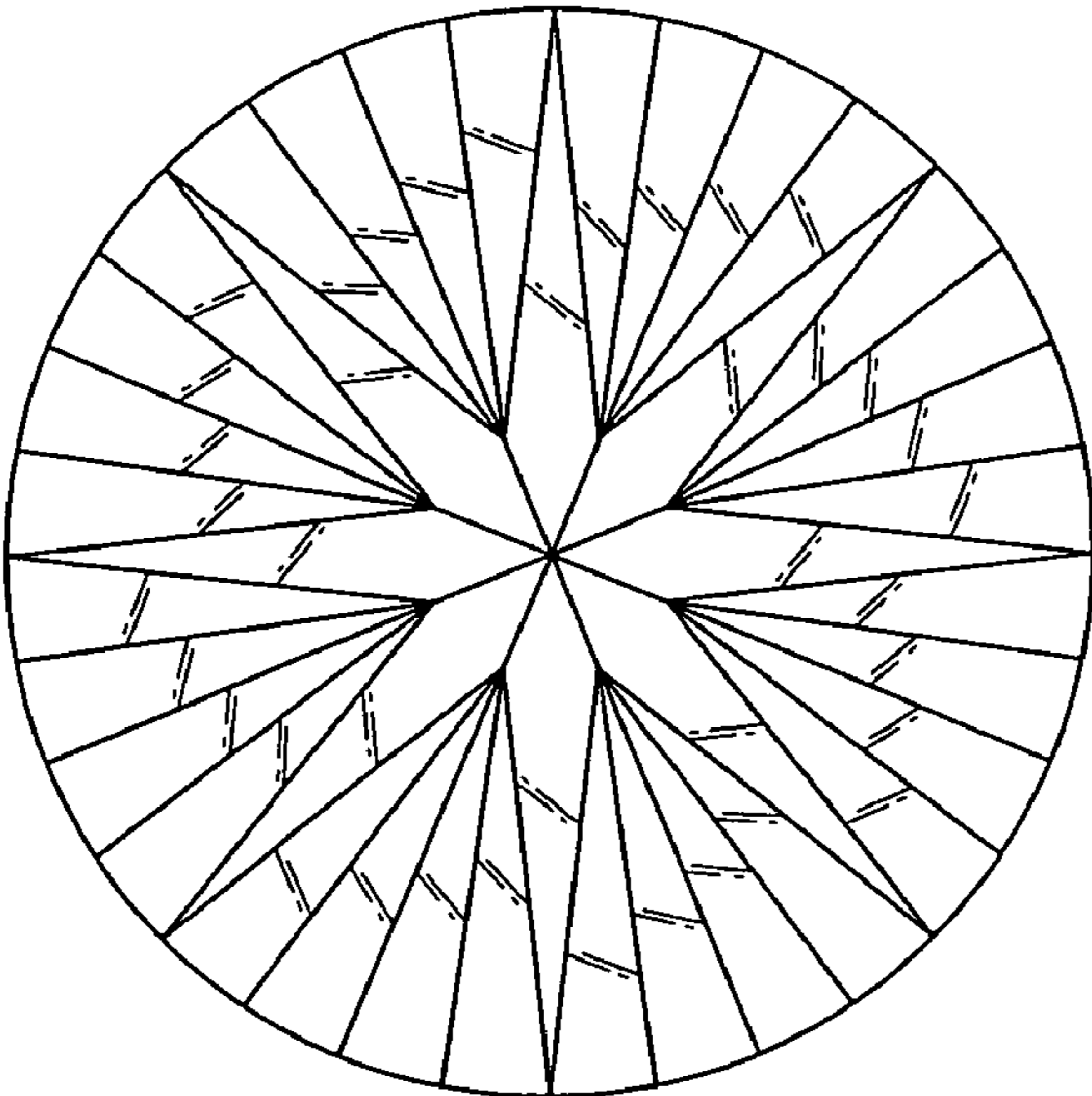
