FIG. 2 is a front elevation view thereof;

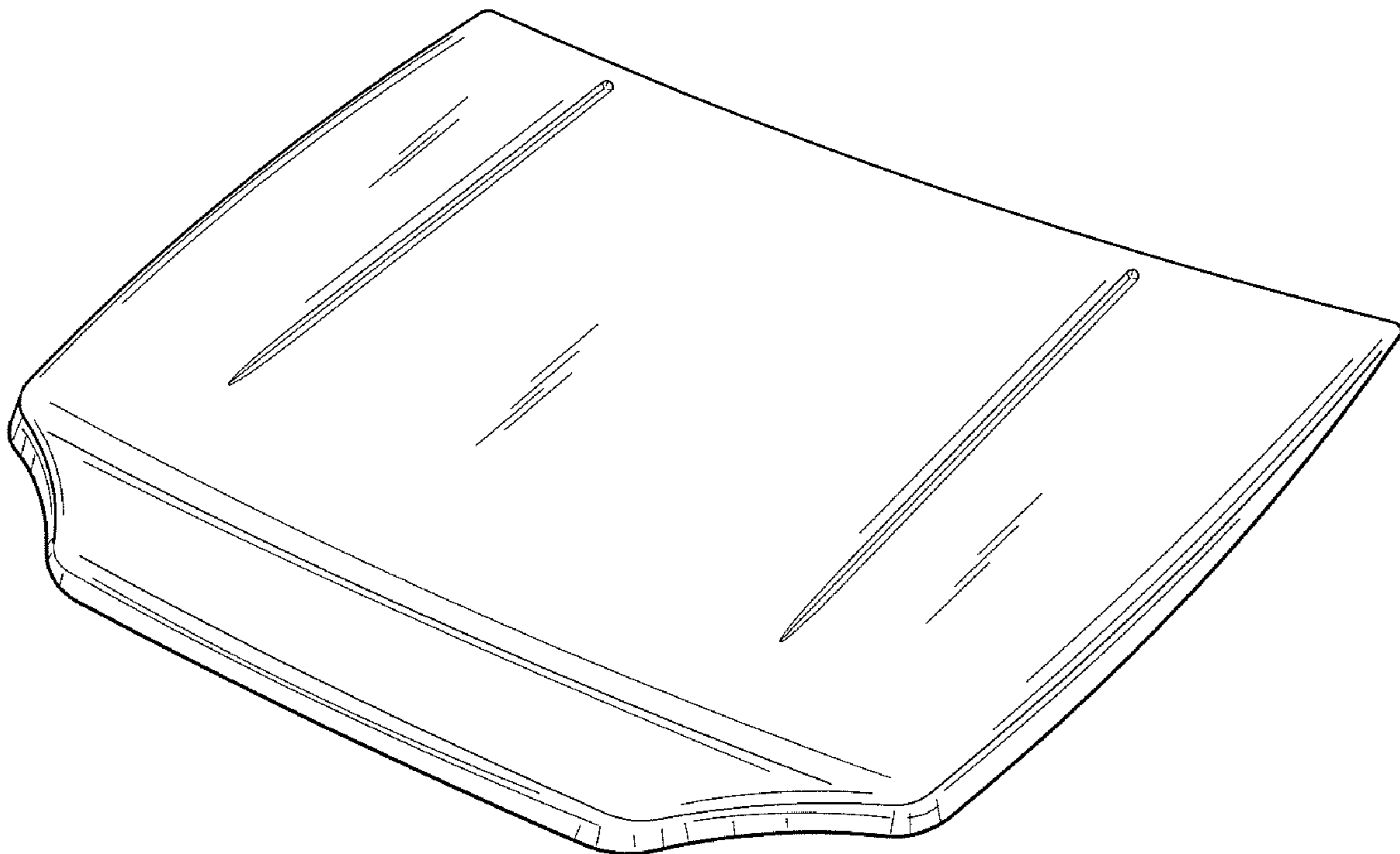
FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;

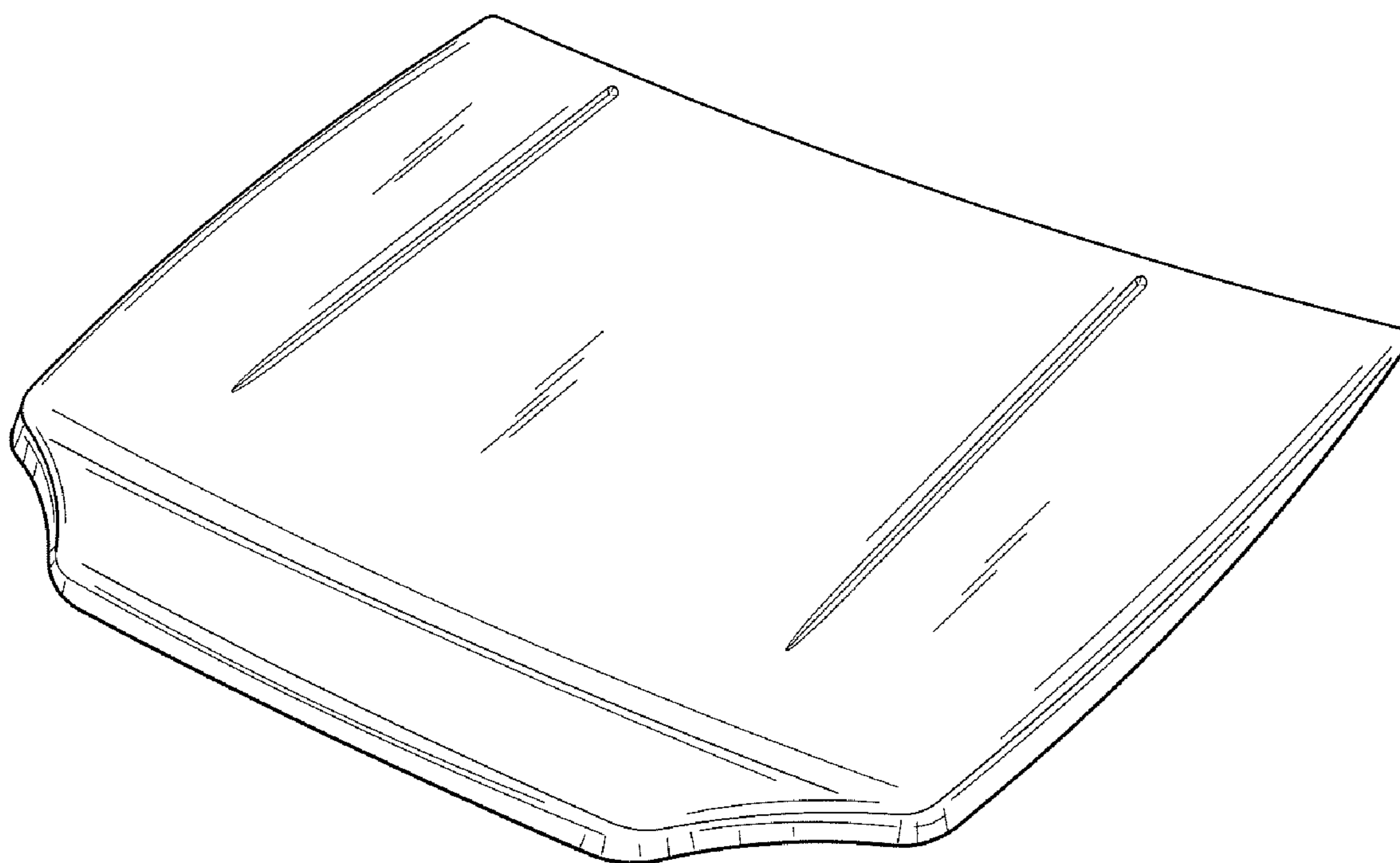

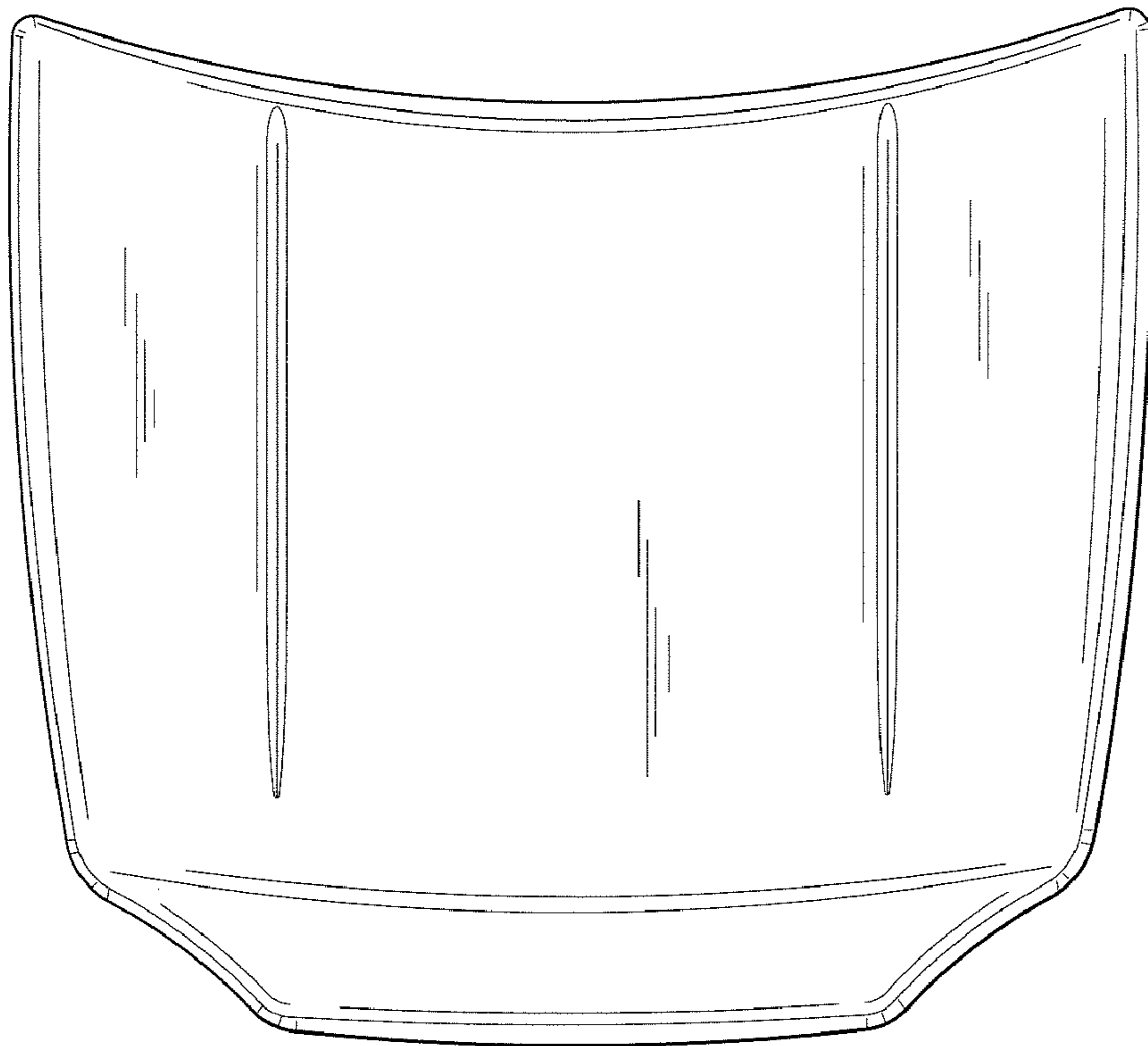

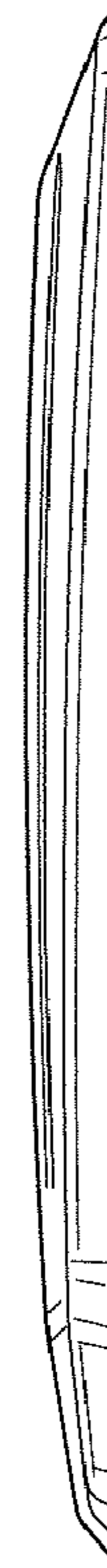

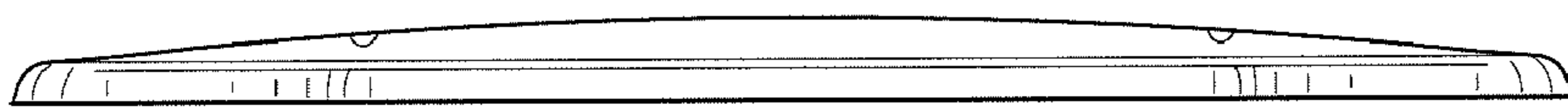

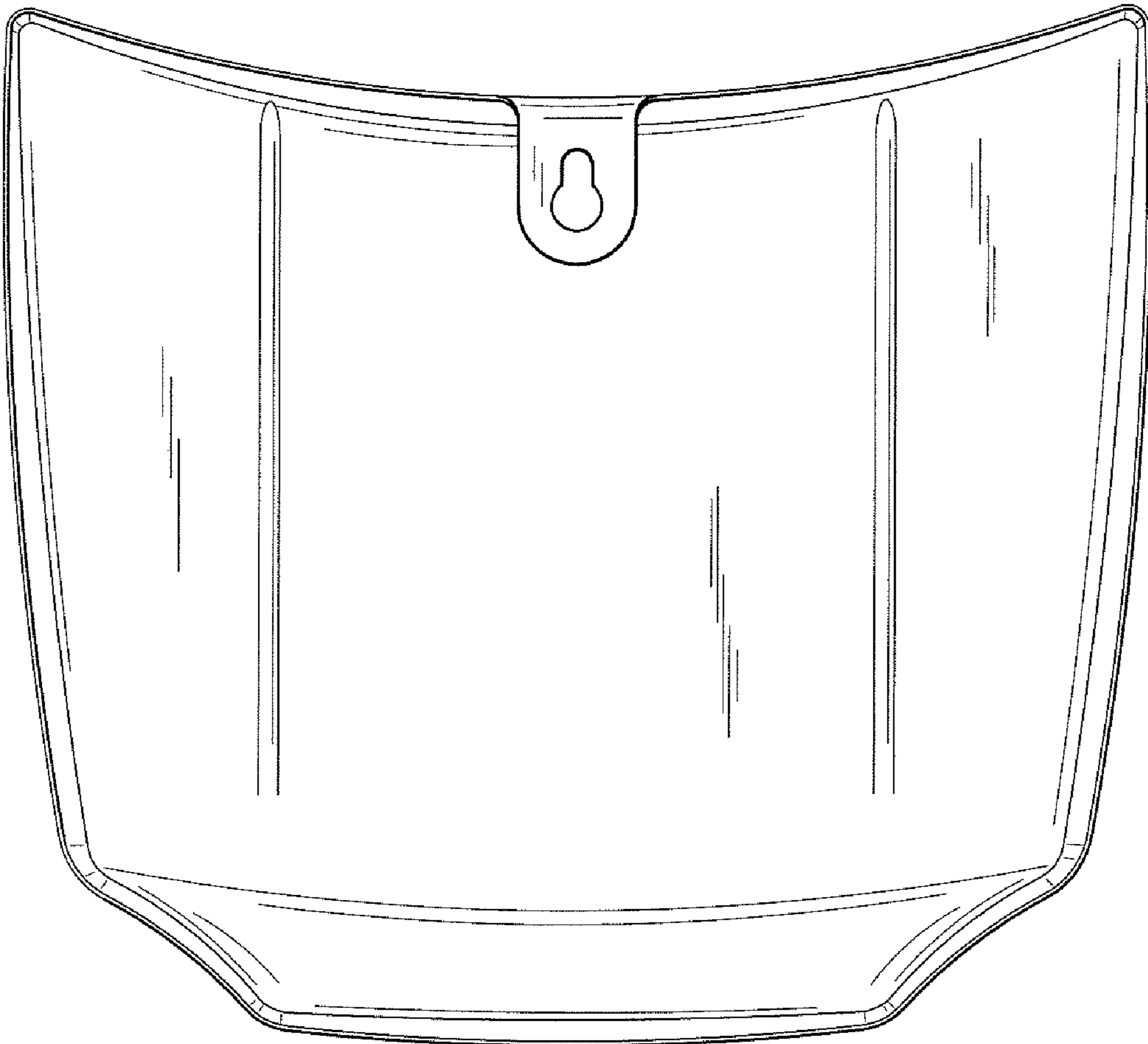
