**DESCRIPTION**

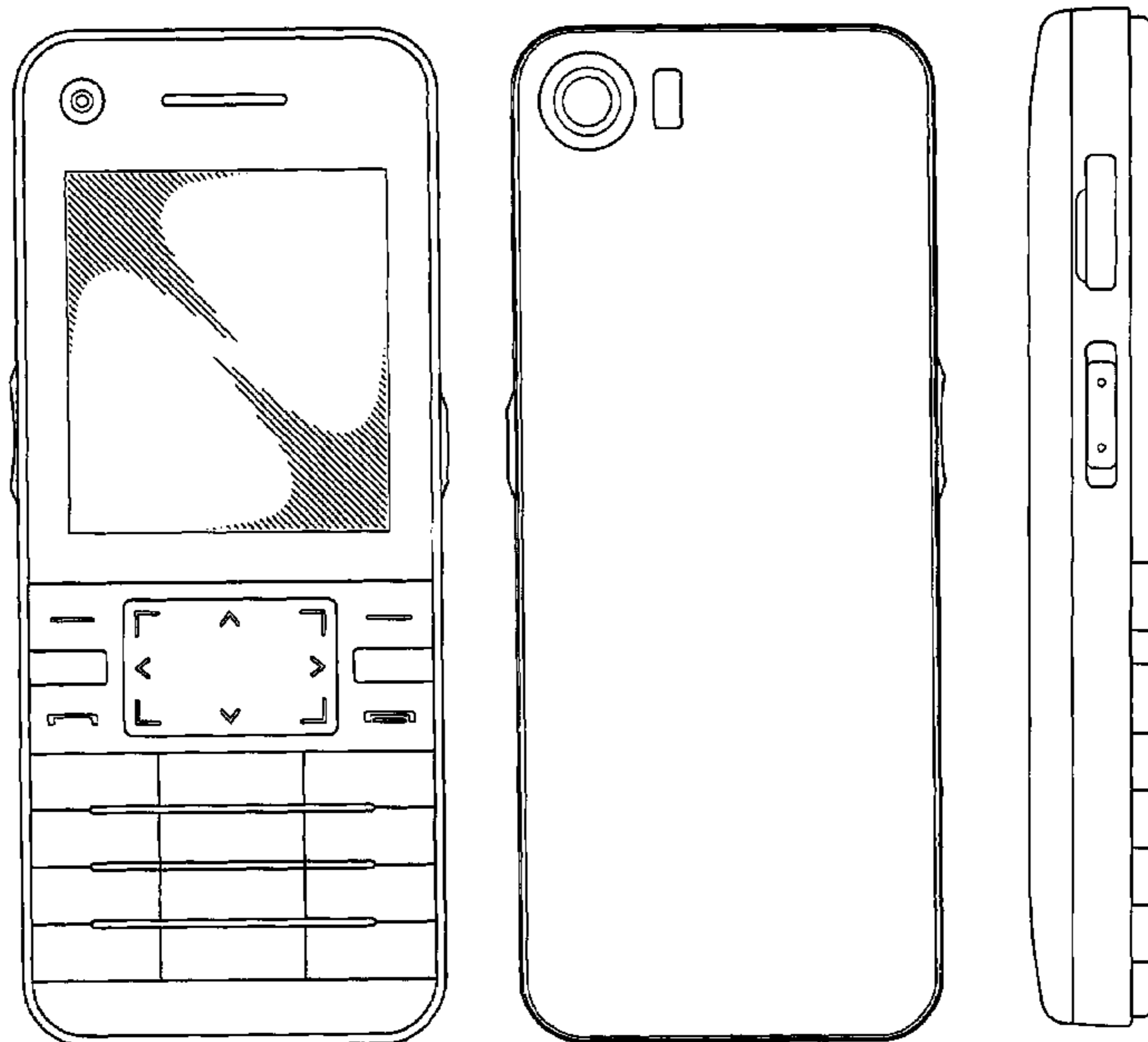

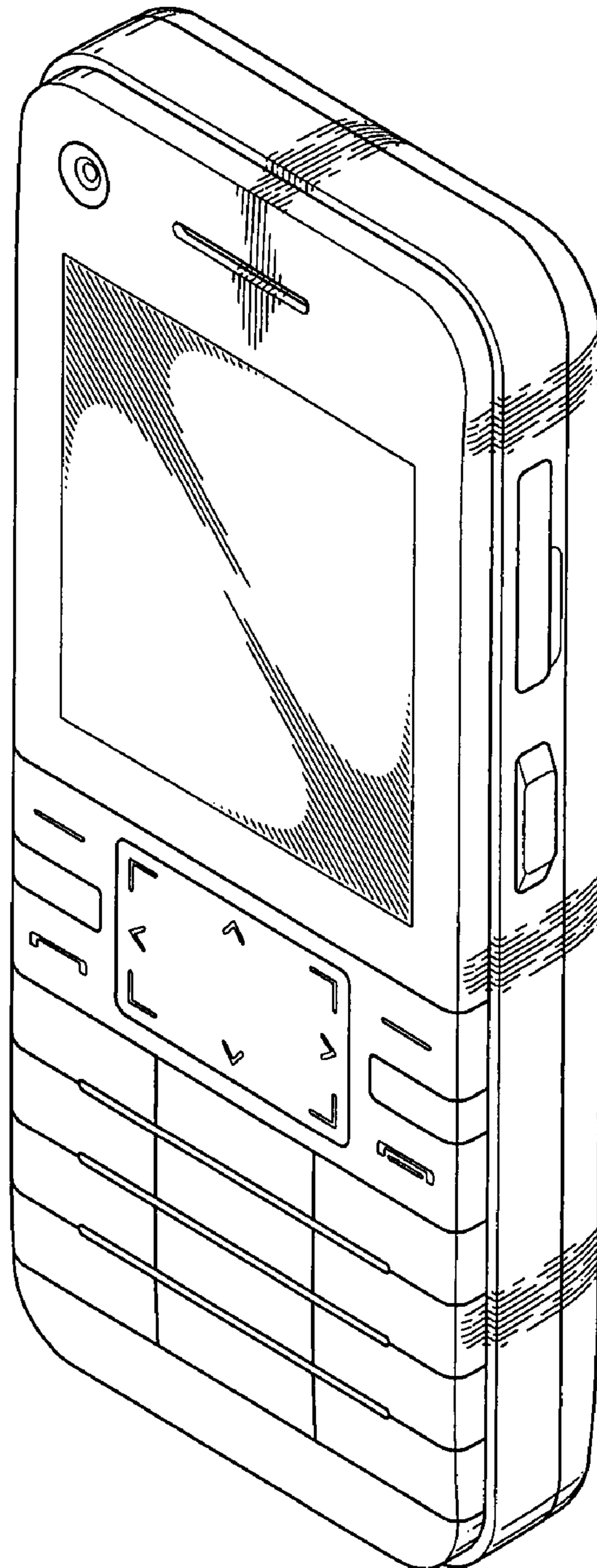

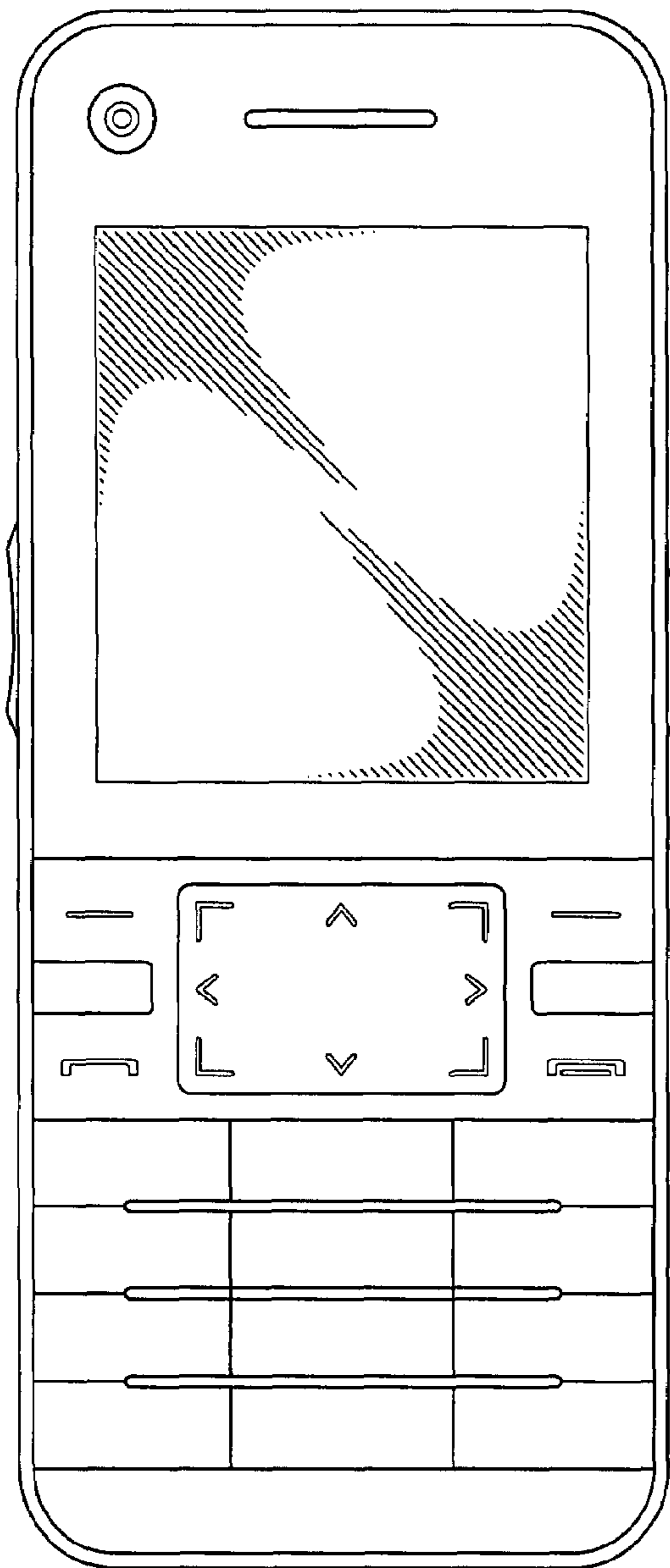

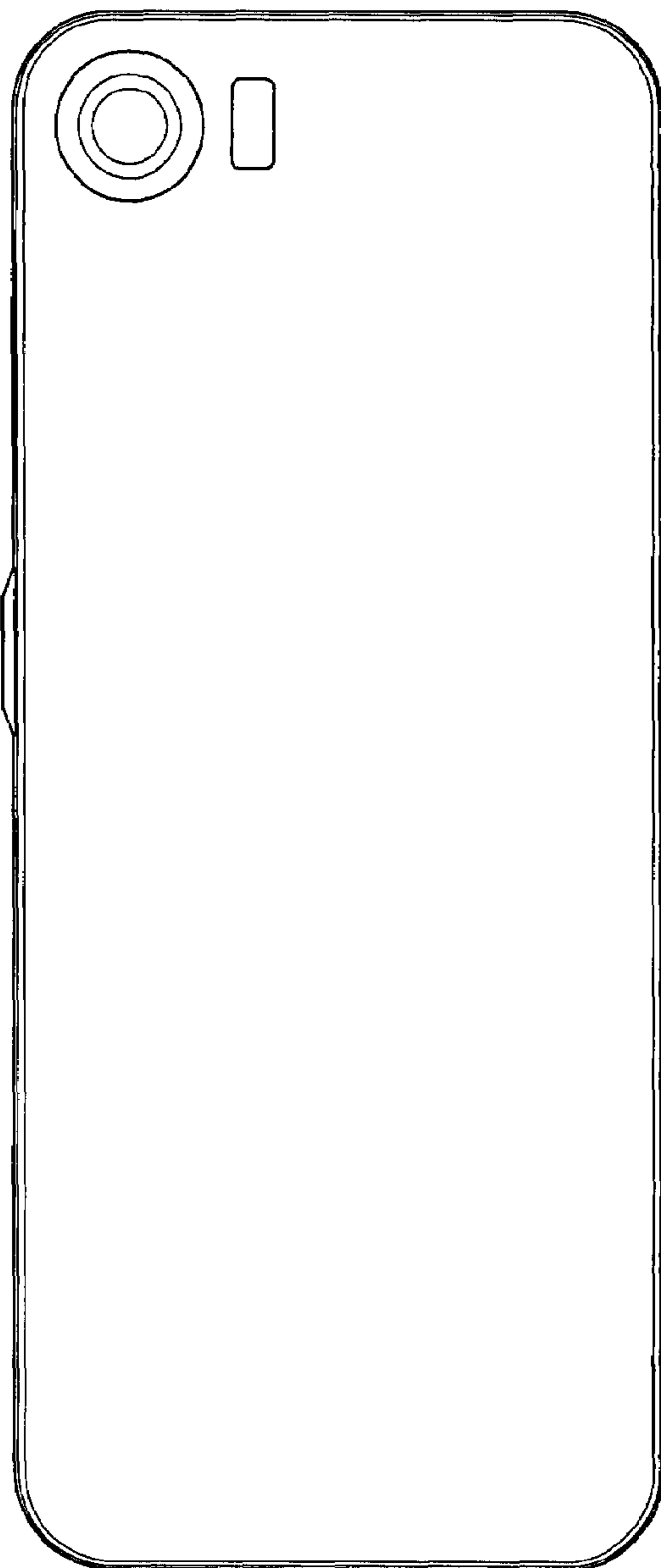

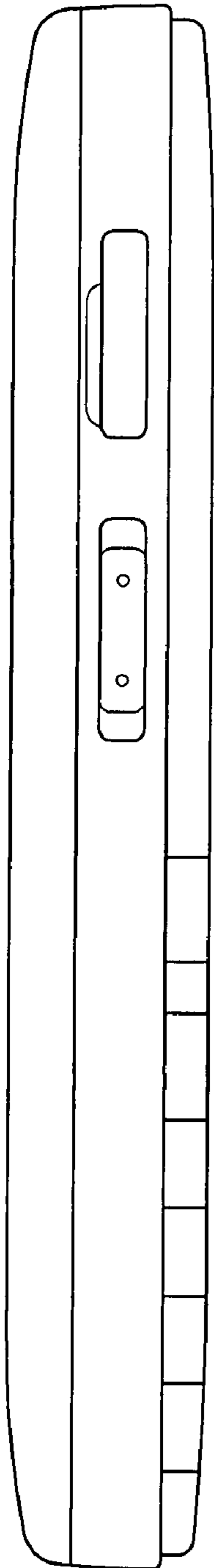

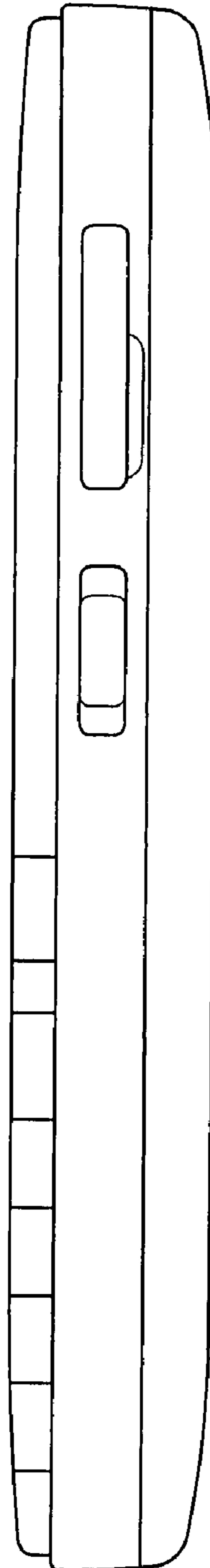

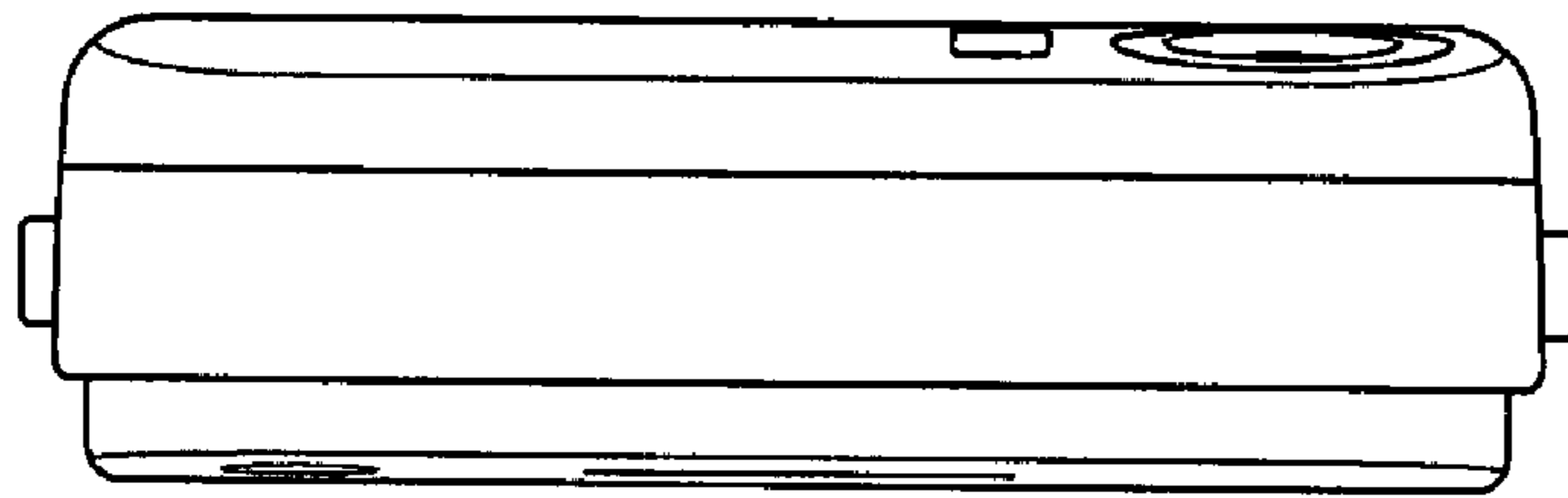
