(57) **CLAIM**

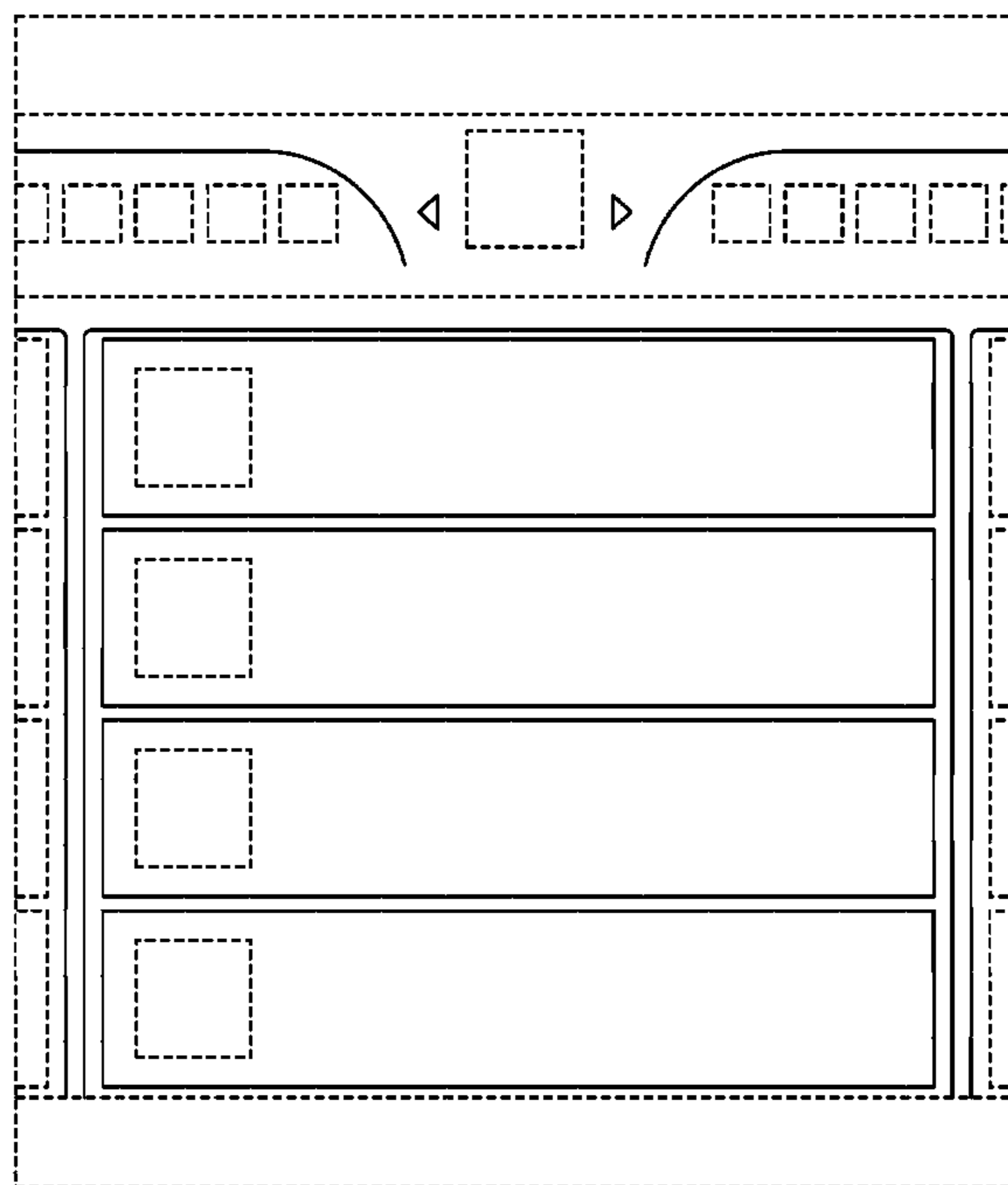
The ornamental design for a portion of a display screen showing a user interface, as shown and described.

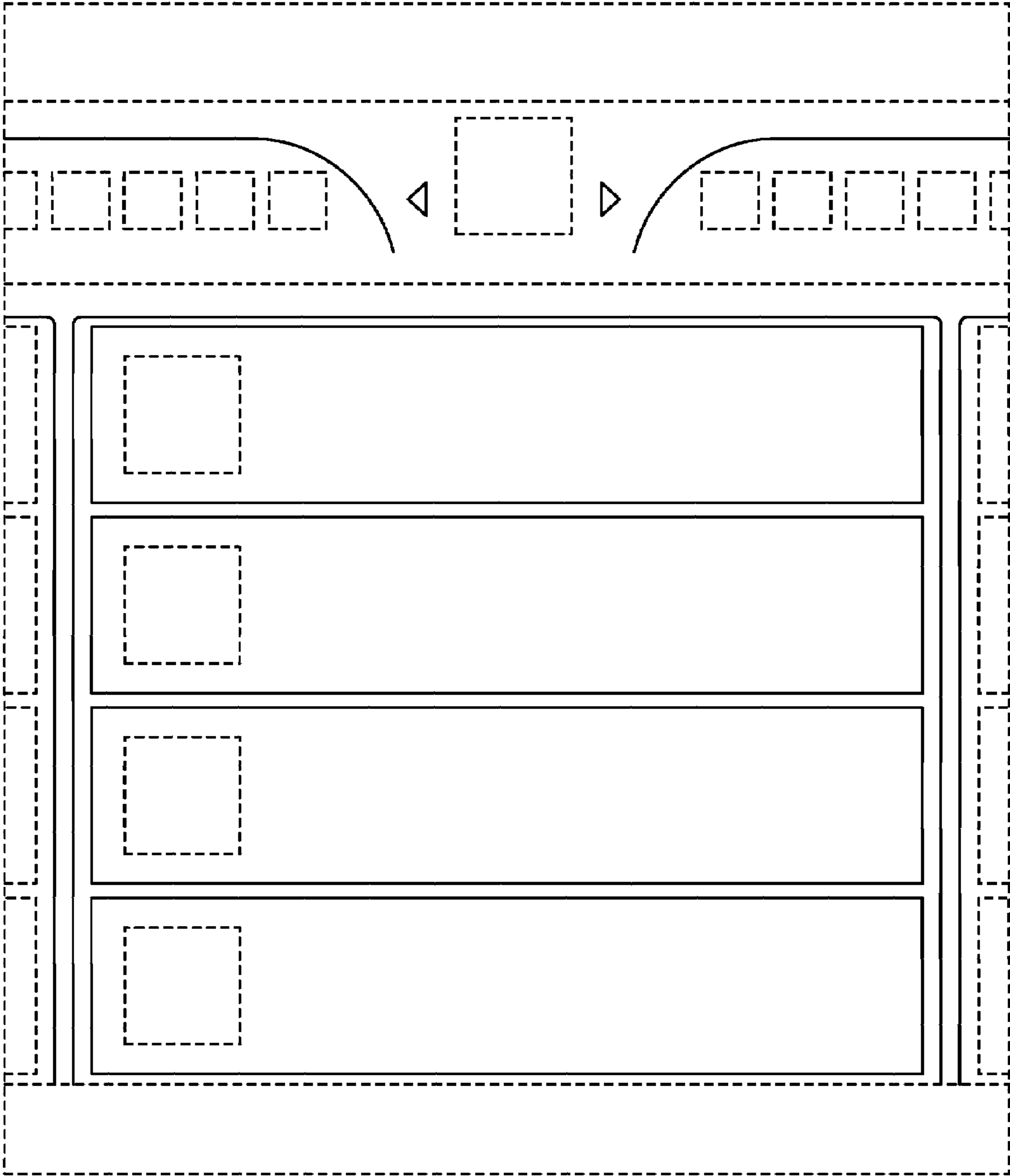
DESCRIPTION
