(57) **CLAIM**

The ornamental design for an anchor pad, as shown and  
described.

**DESCRIPTION**

FIG. 1 is an isometric view of the anchor pad of the present  
invention, illustrated with a portion of the anchor pad shown  
in broken lines;

FIG. 2 is a top plan view of the anchor pad shown in FIG. 1;  
FIG. 3 is a bottom plan view of the anchor pad shown in FIG.  
1;

FIG. 4 is a rear elevational view of the anchor pad shown in  
FIG. 1;

FIG. 5 is a front elevational view of the anchor pad shown in  
FIG. 1; and,

FIG. 6 is a right side elevational view of the anchor pad shown  
in FIG. 1, the left side view being a mirror image of the  
illustrated view.

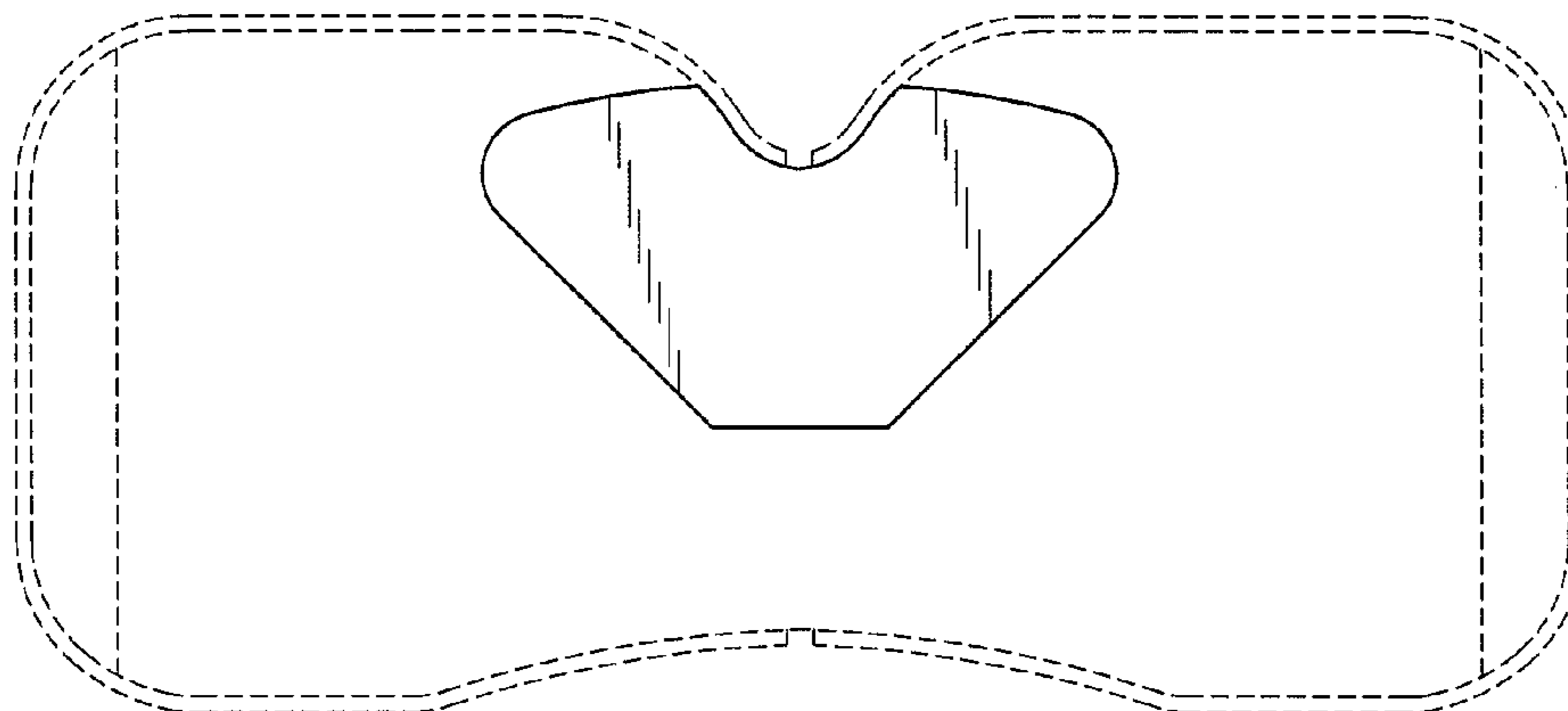
The broken line showing the outer perimeter of the anchor

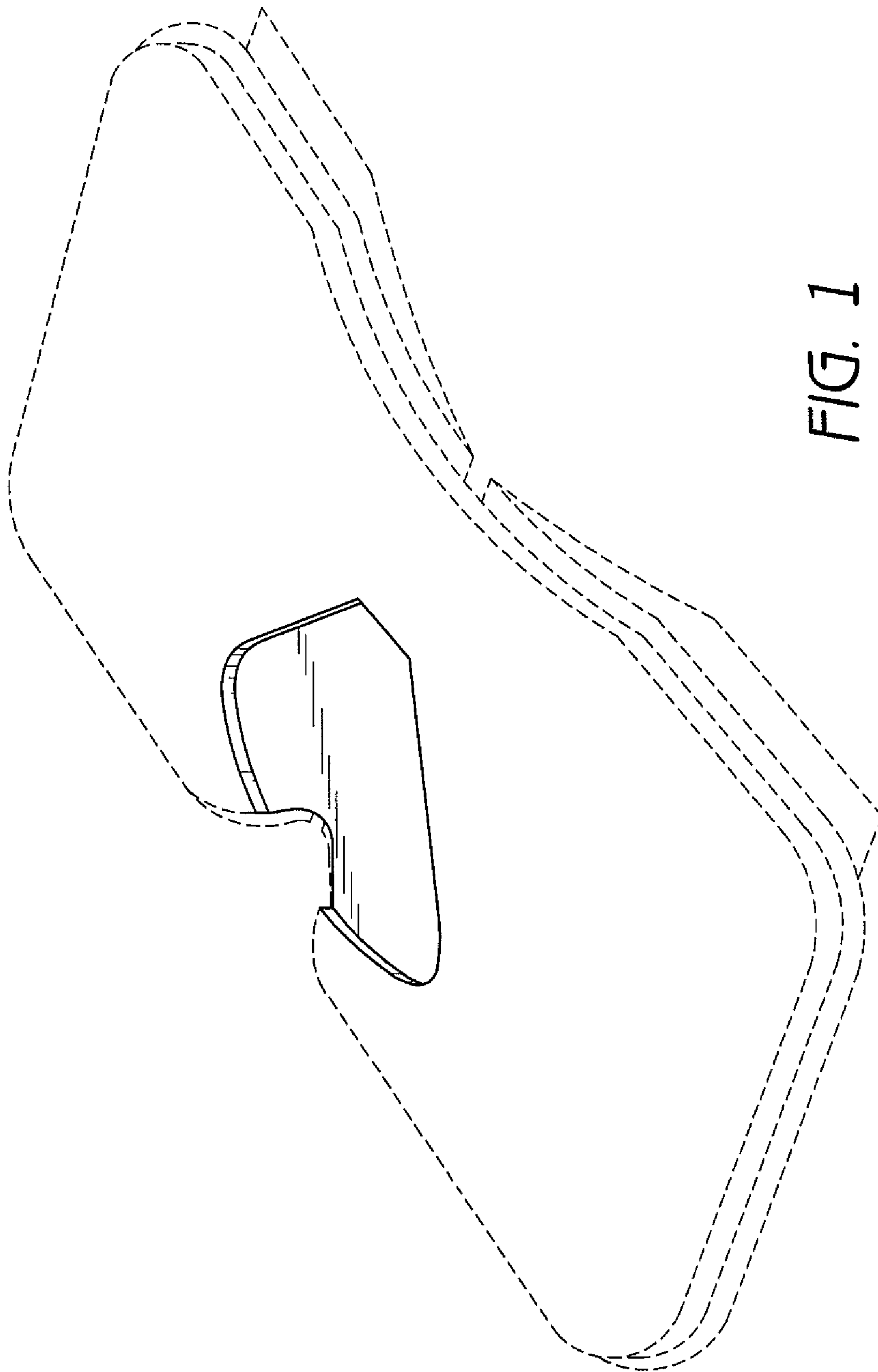

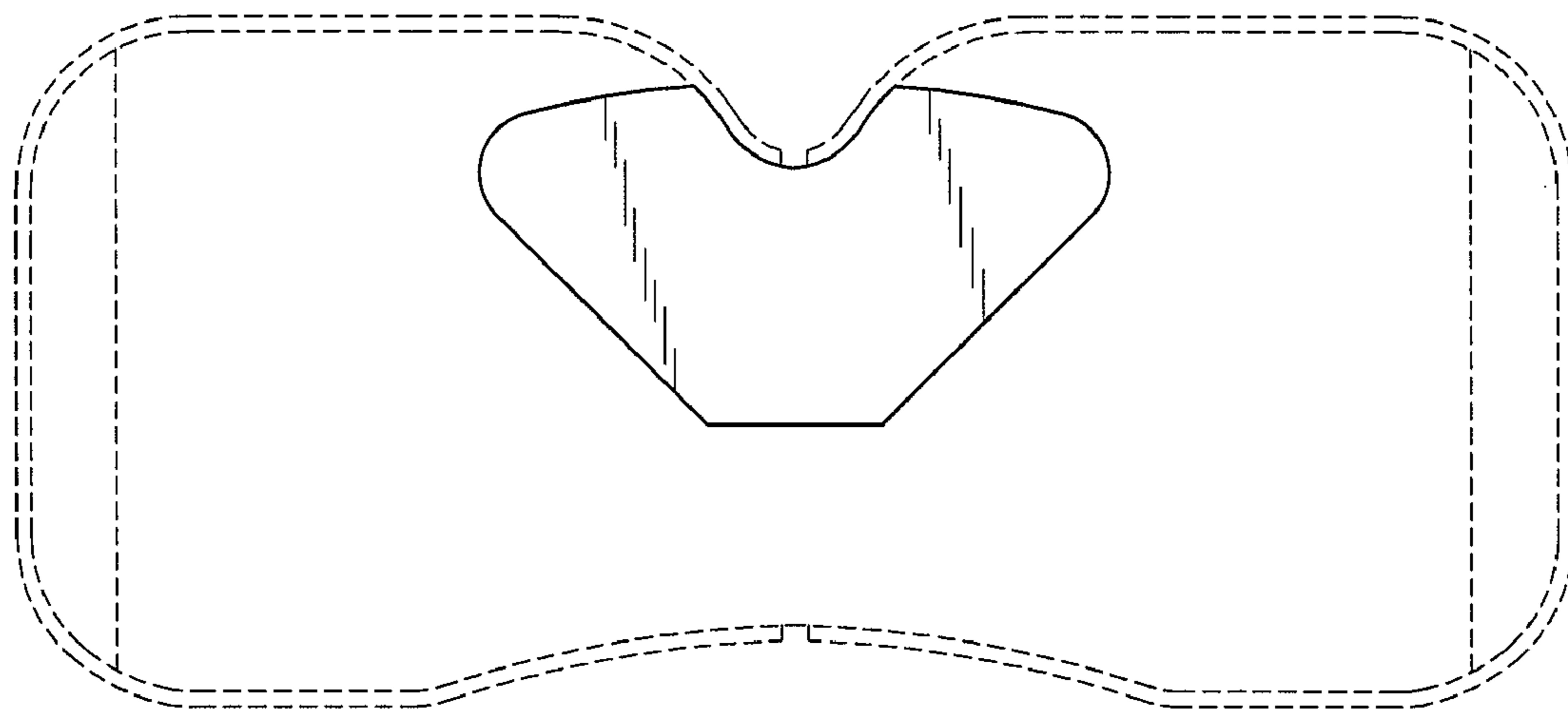

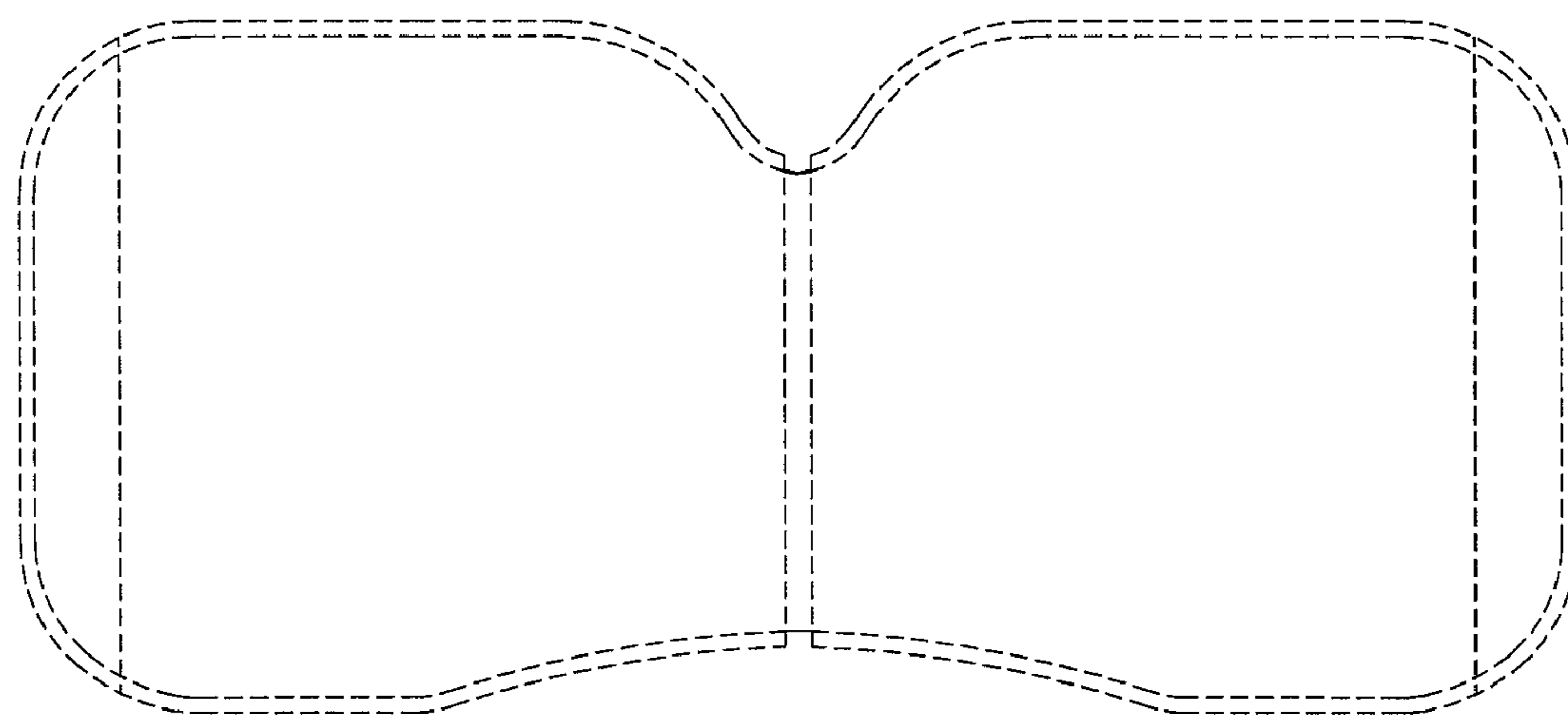

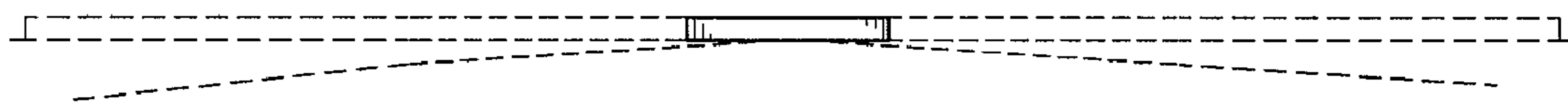

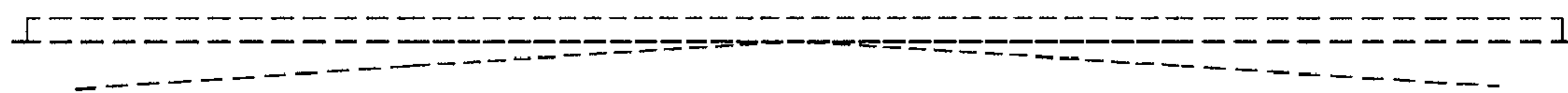

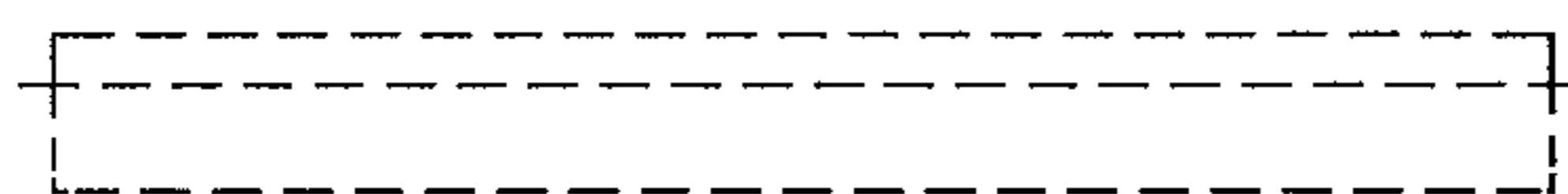
