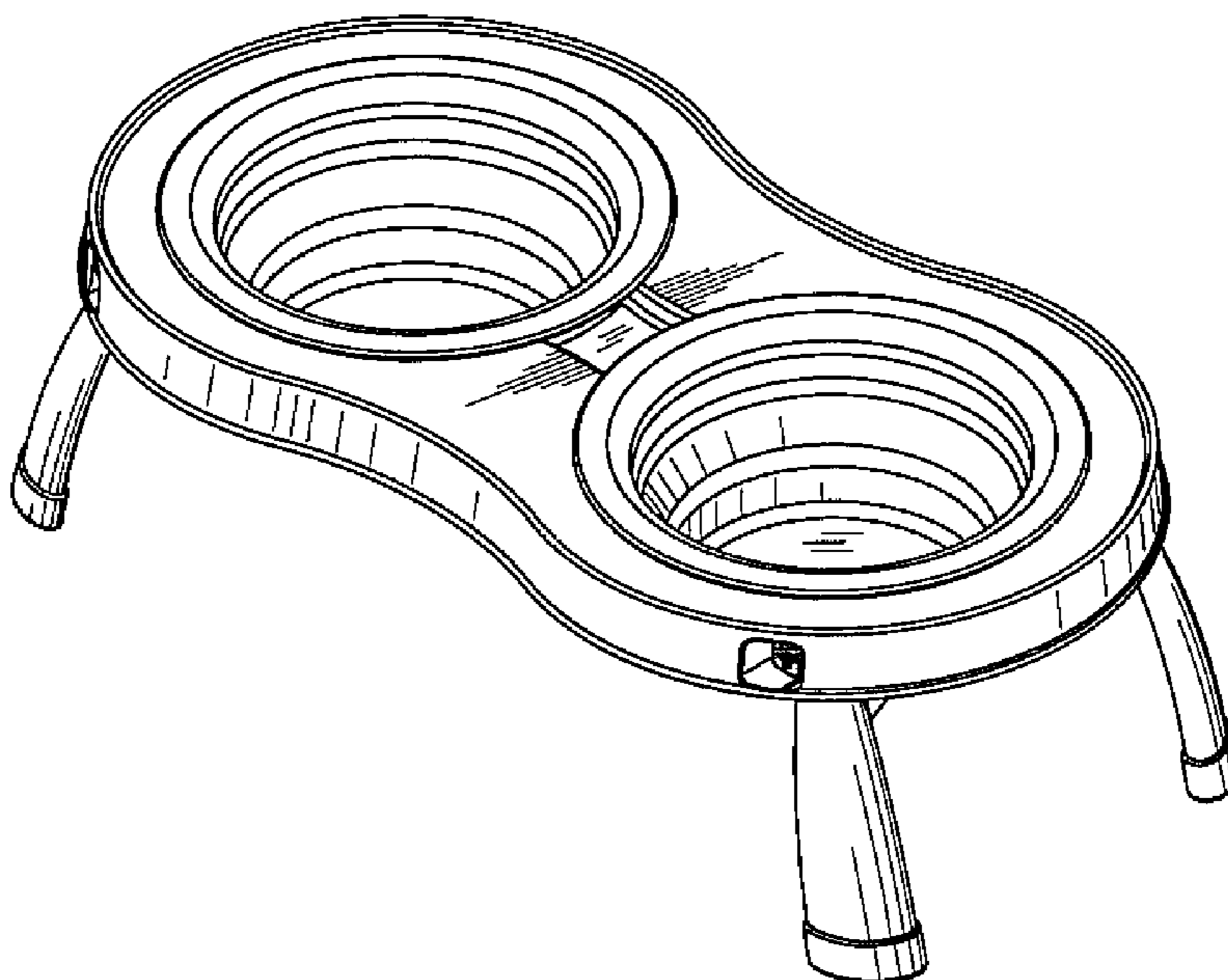
(57) **CLAIM**

The ornamental design for a collapsible pet feeder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the collapsible pet feeder showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof; and,
FIG. 5 is a bottom plan view thereof.
The collapsible pet feeder of the present invention is symmetrical so that the front and rear views are identical as are both side views.

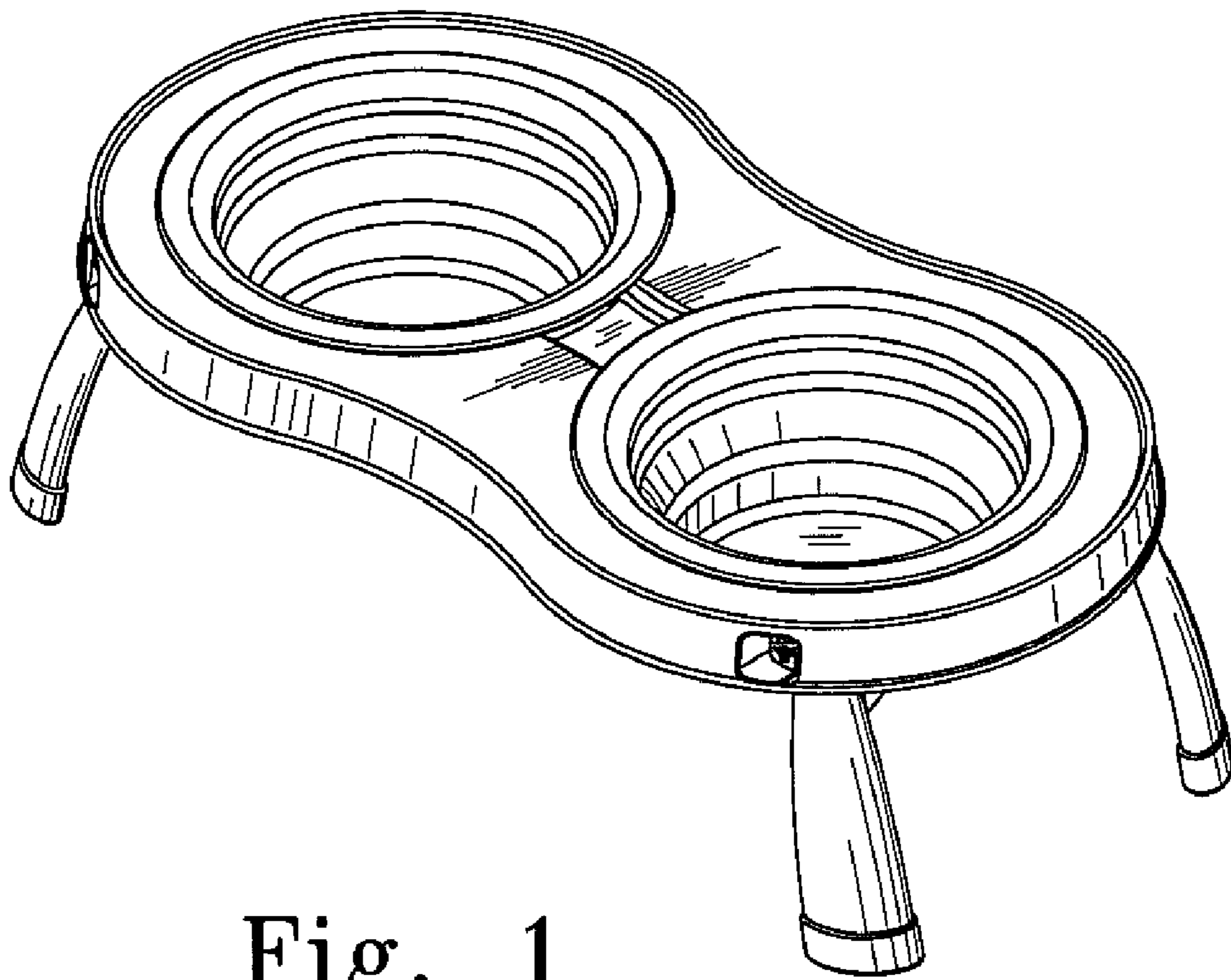

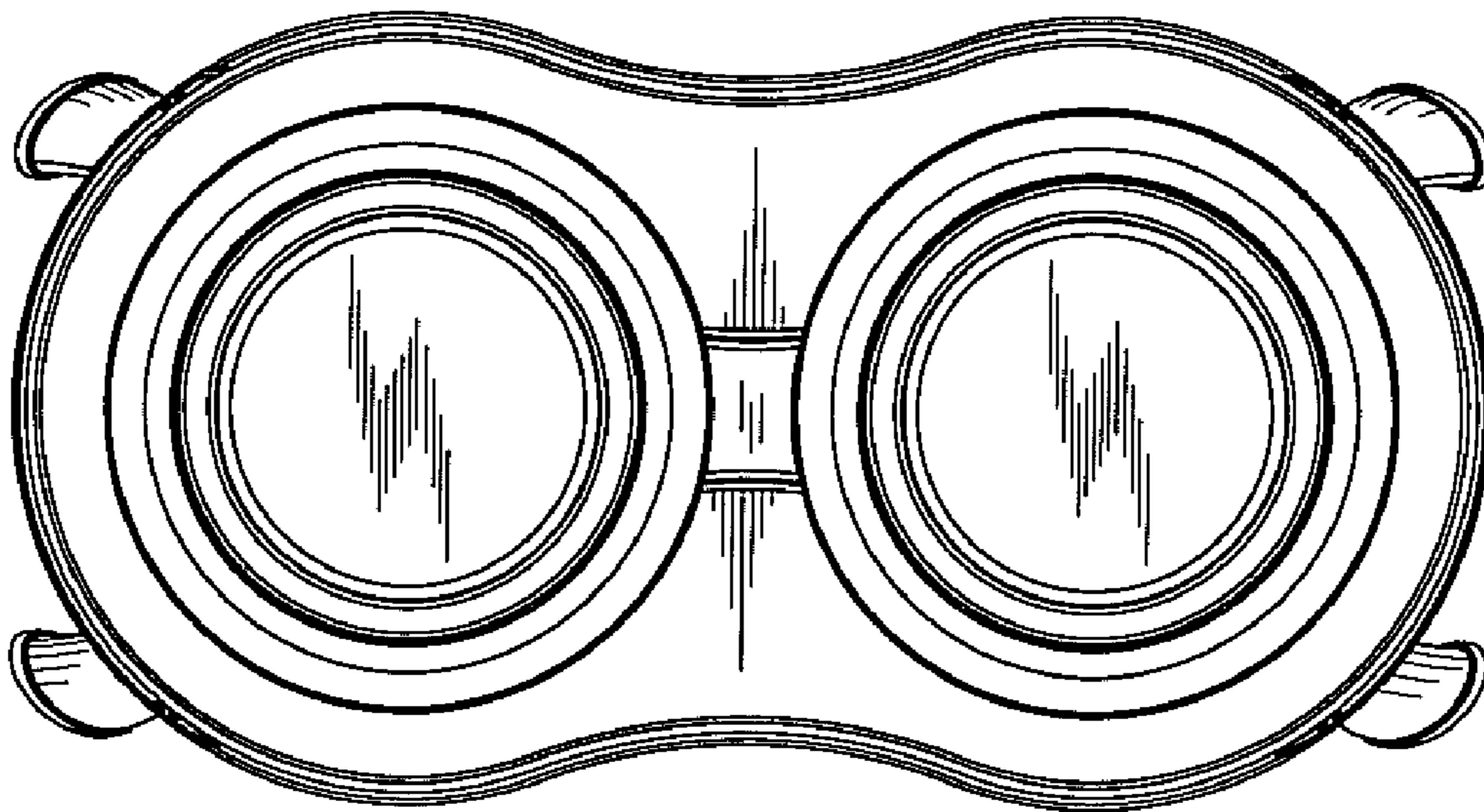

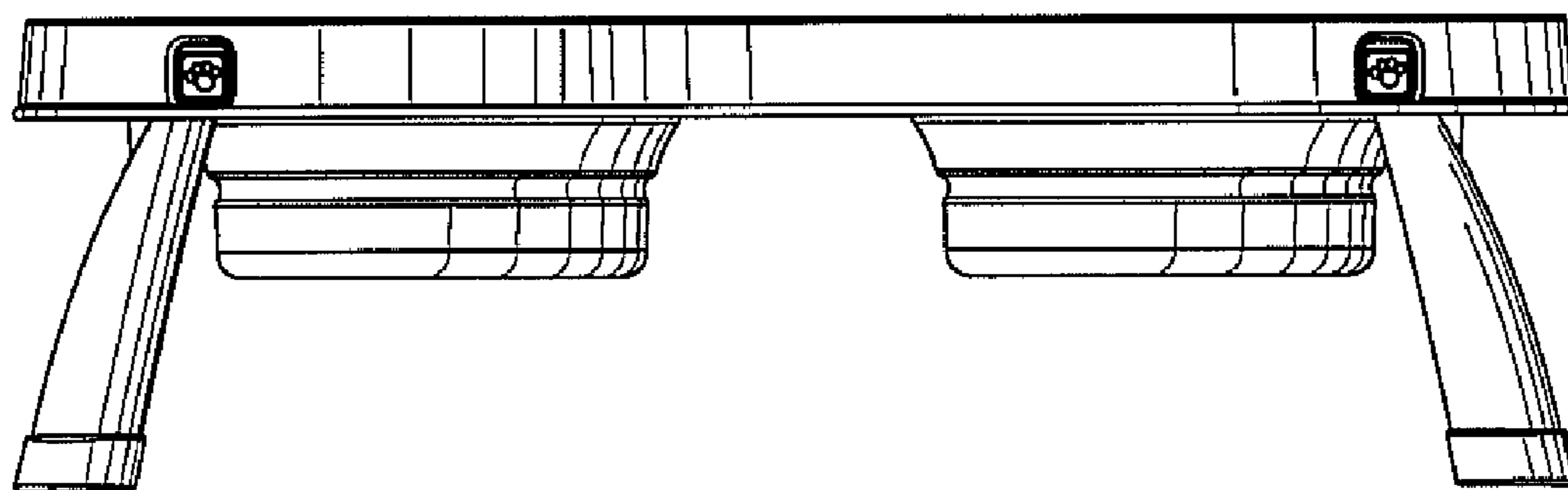

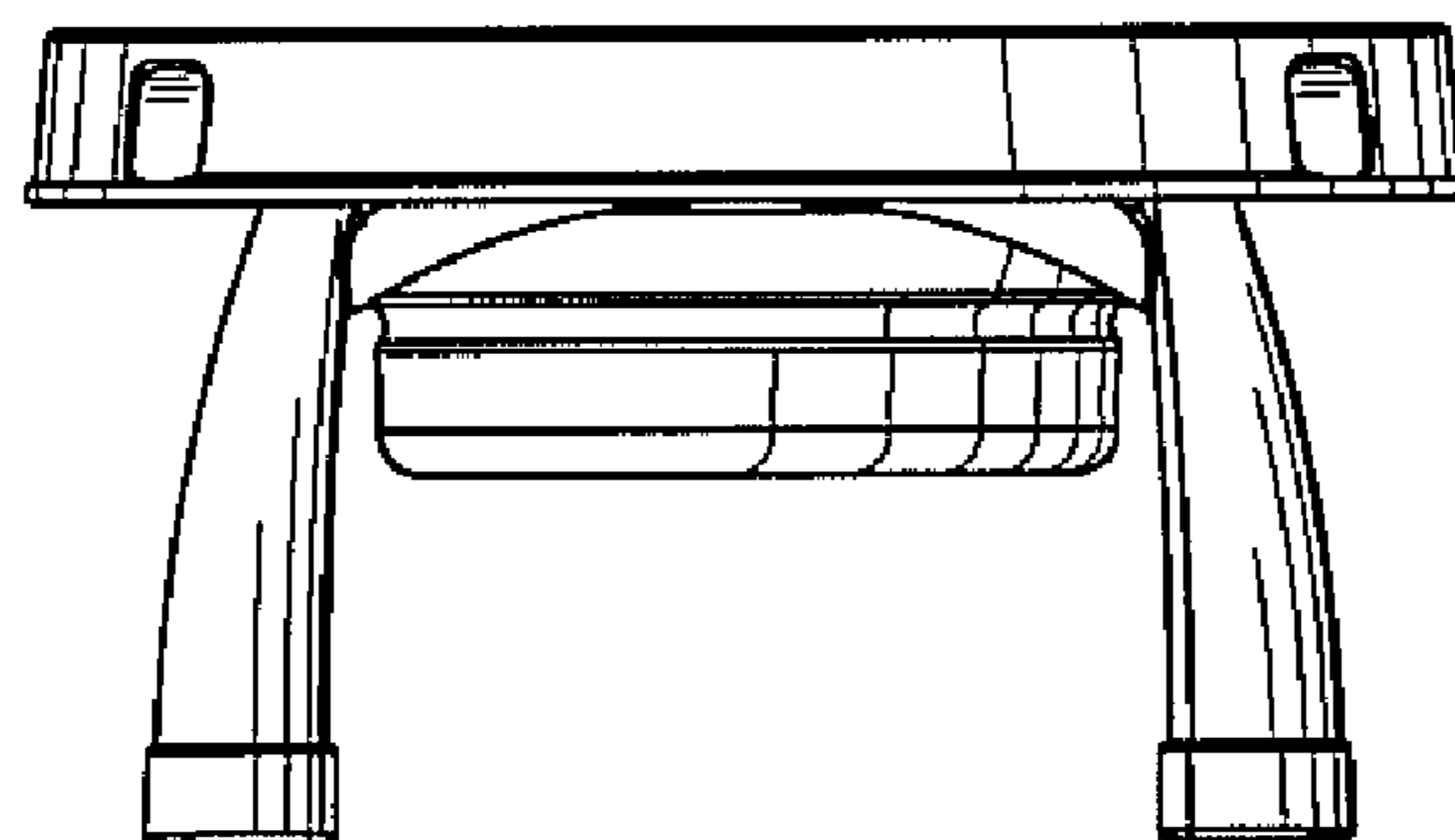

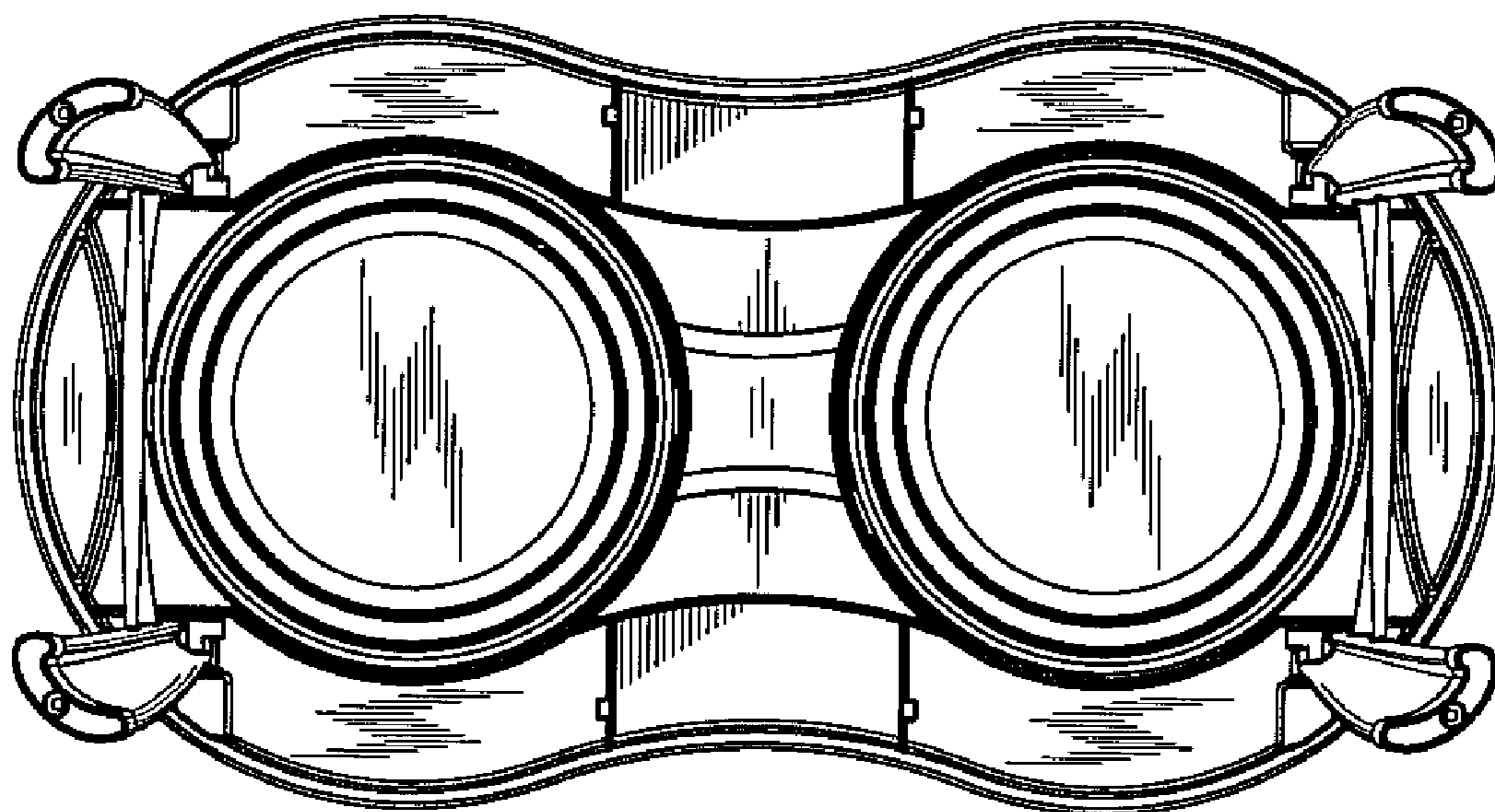
