(57) **CLAIM**

The ornamental design for a decorative strap covering for a bra, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a decorative strap covering for a bra, showing my new design, shown in use;

FIG. 2 is an exploded perspective view thereof;

FIG. 3 is top plan view thereof, shown in a closed condition;

FIG. 4 is a top plan view, shown in an opened condition;

FIG. 5 is a bottom plan view thereof, shown in a closed condition;

FIG. 6 is a bottom plan view, shown in an opened condition;

FIG. 7 is a bottom plan view, shown in a half opened condition;

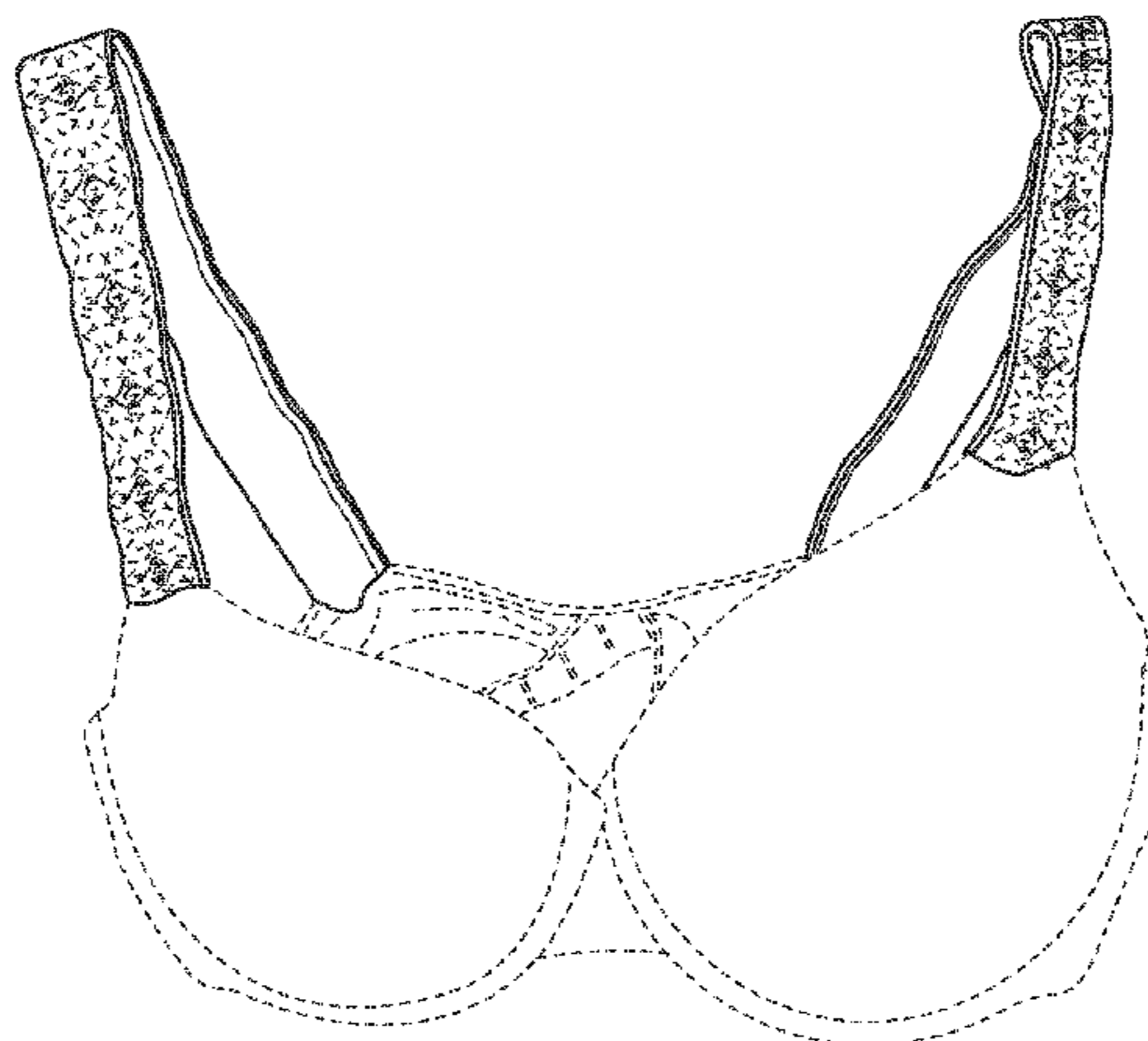
FIG. 8 is a left side elevational view thereof, whereas the right side elevational view is a mirror image; and,

FIG. 9 is a front elevational view thereof, whereas the rear elevational view is a mirror image.

The broken lines shown in the drawings depicting the bra are for illustrative purposes only and form no part of the claimed design.

The lighter weight dashed lines featured on the article represent a stitching line.

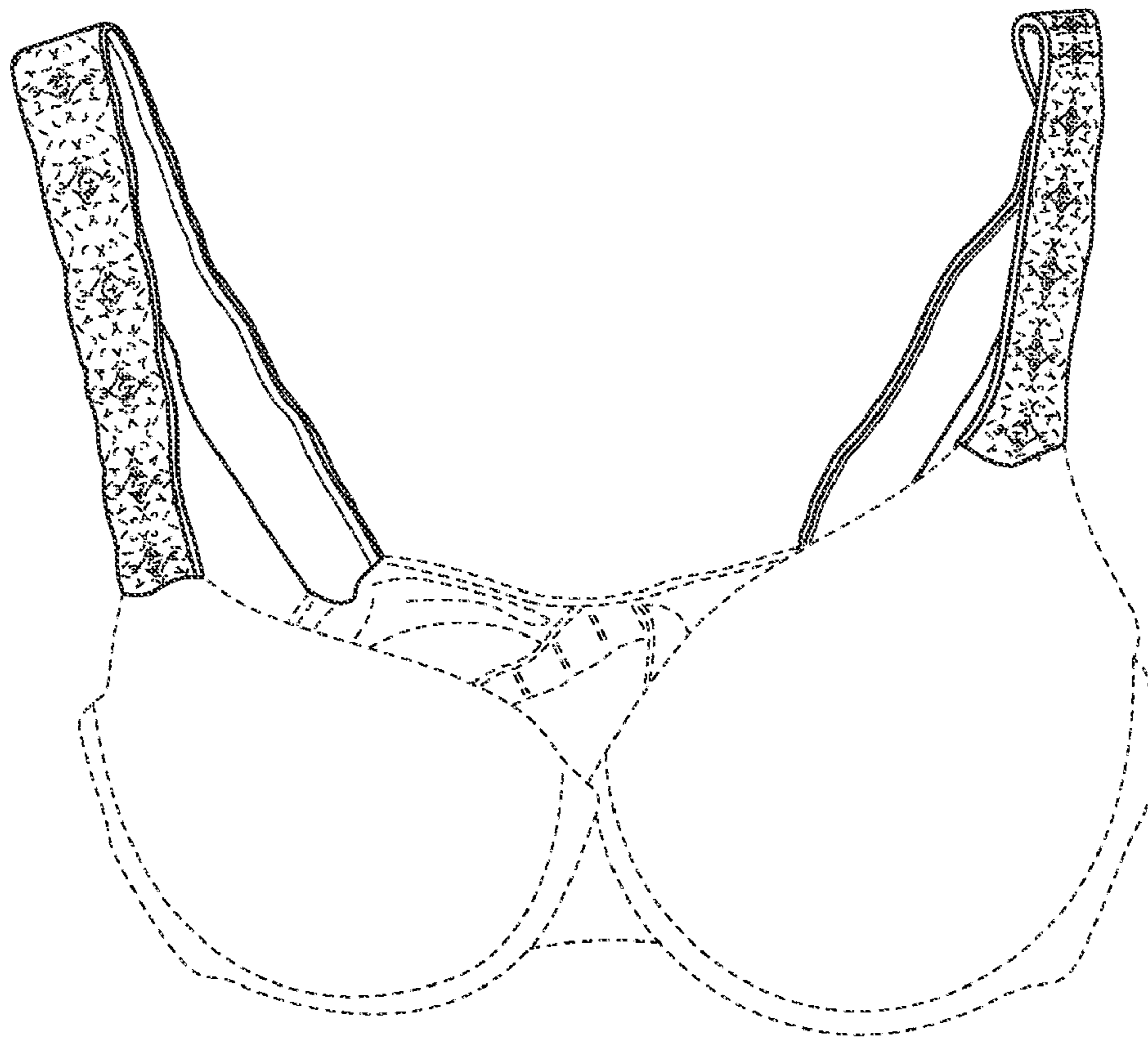

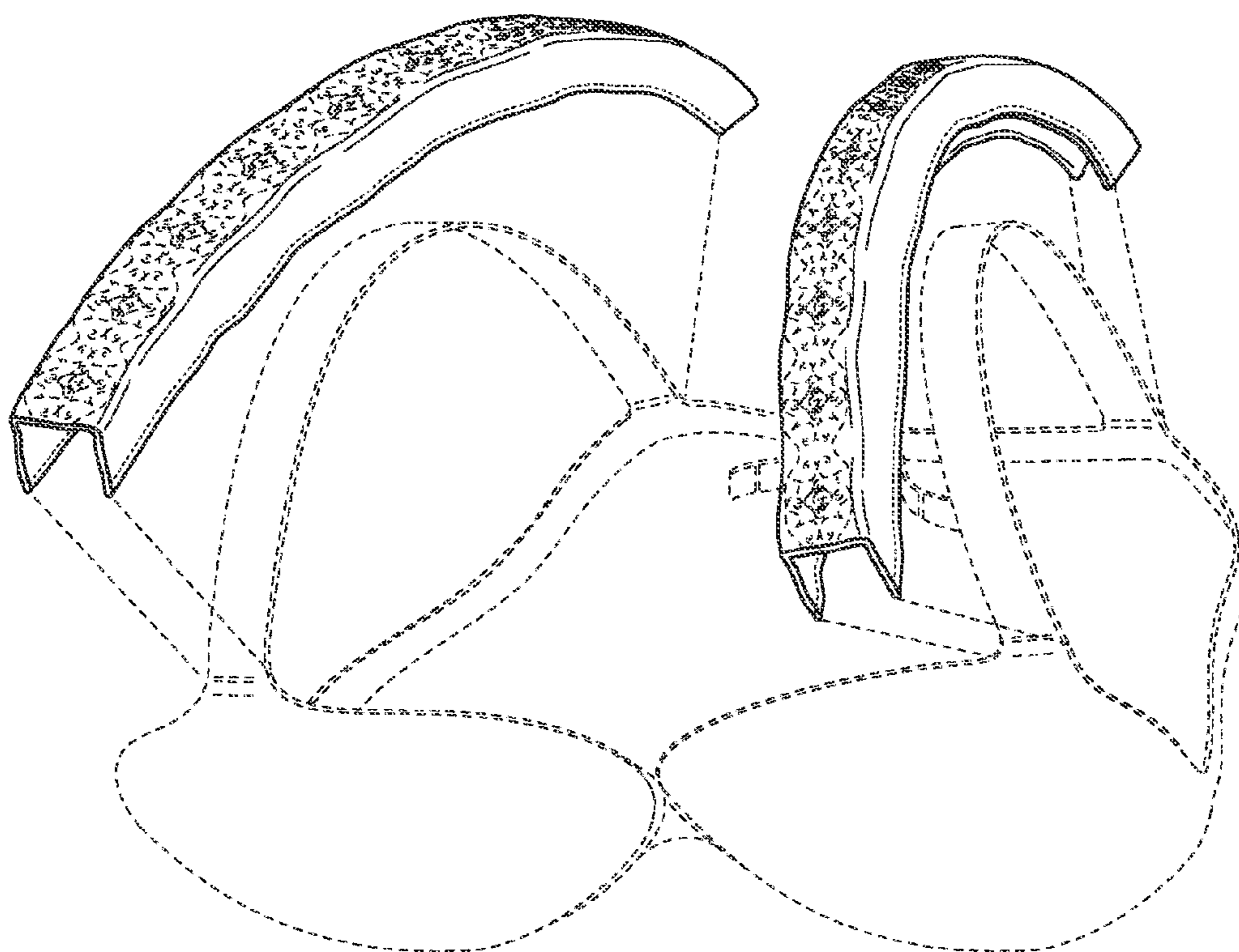

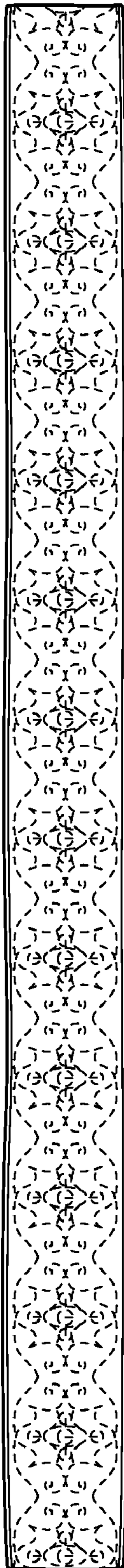

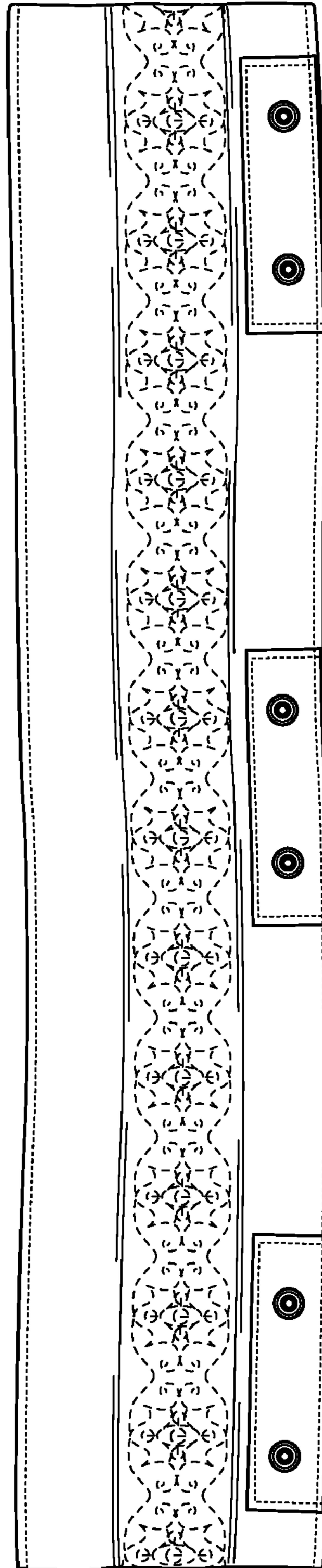

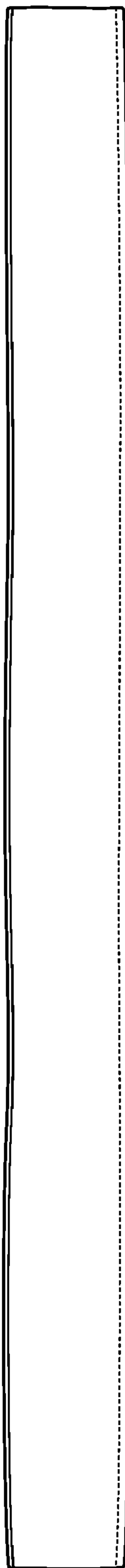

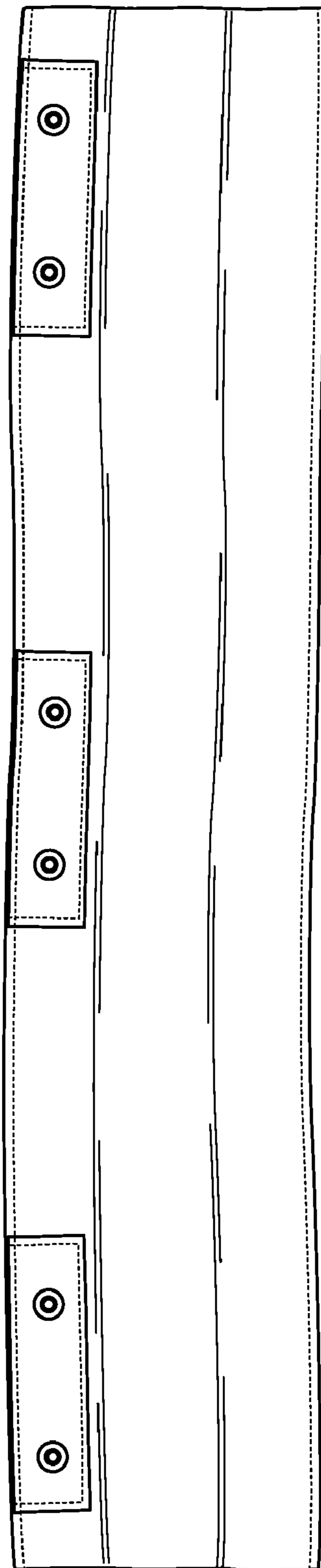

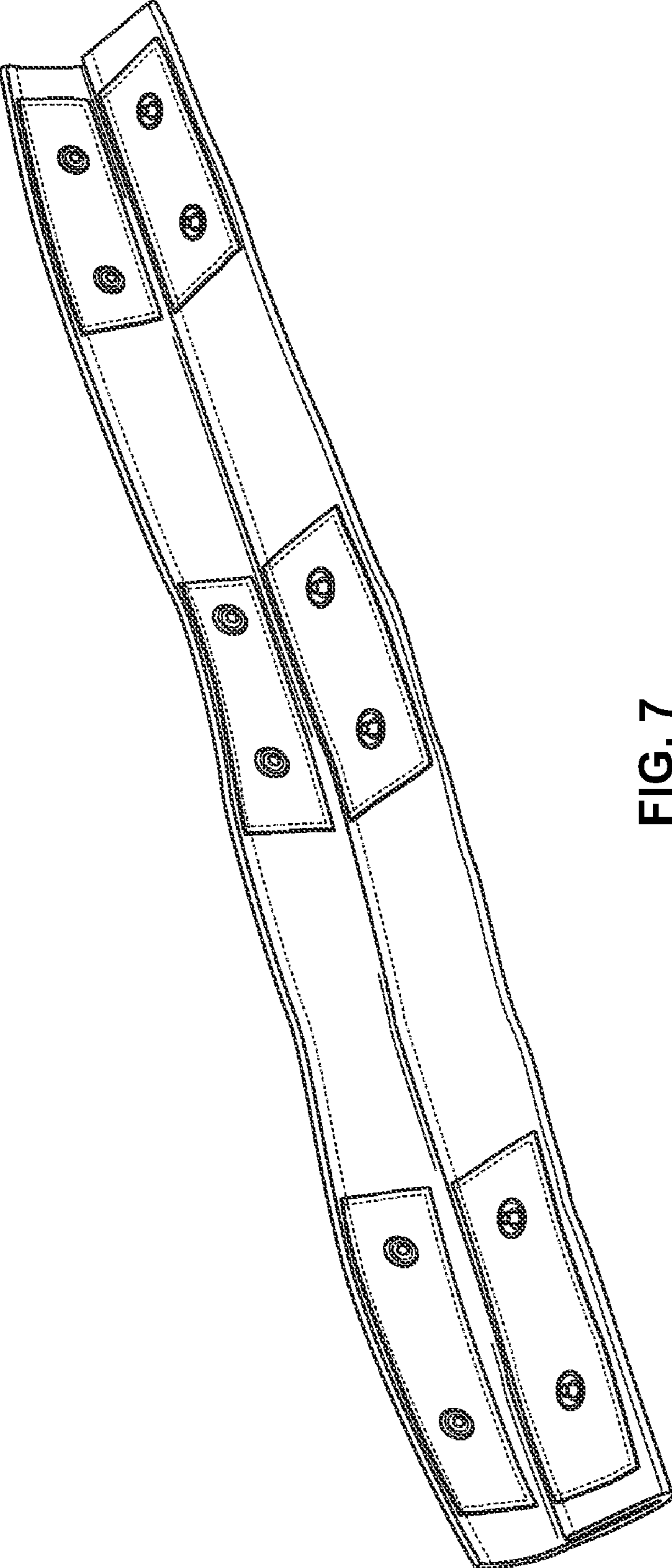
