FIG. 3 is a back end view thereof;

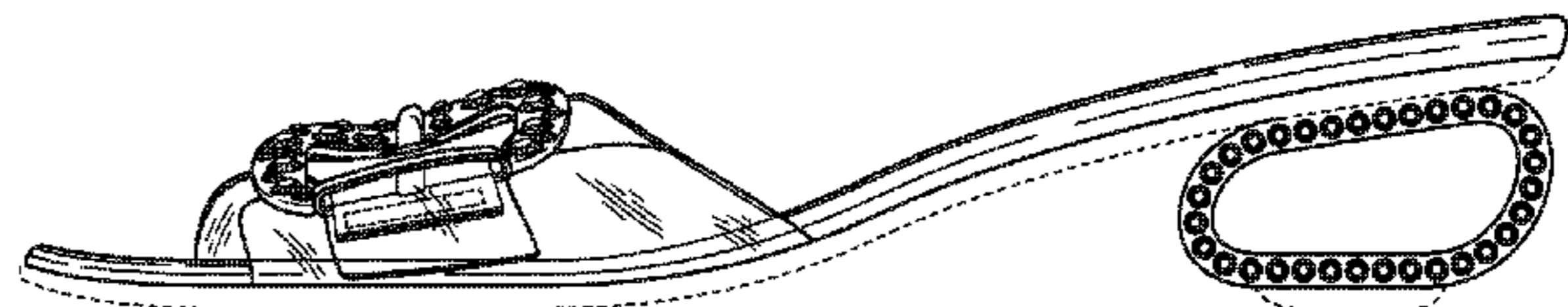
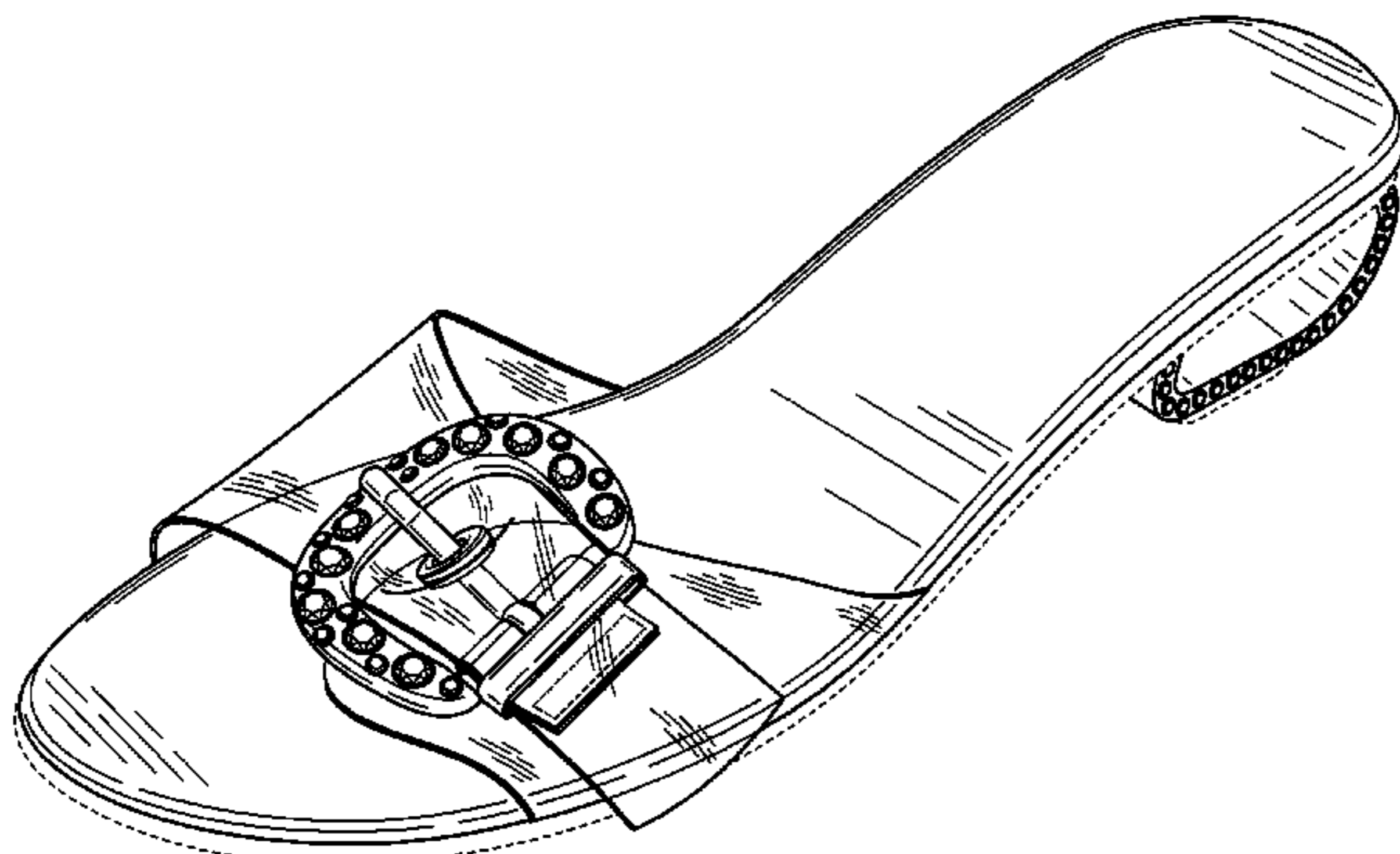
FIG. 4 is a left end view thereof;

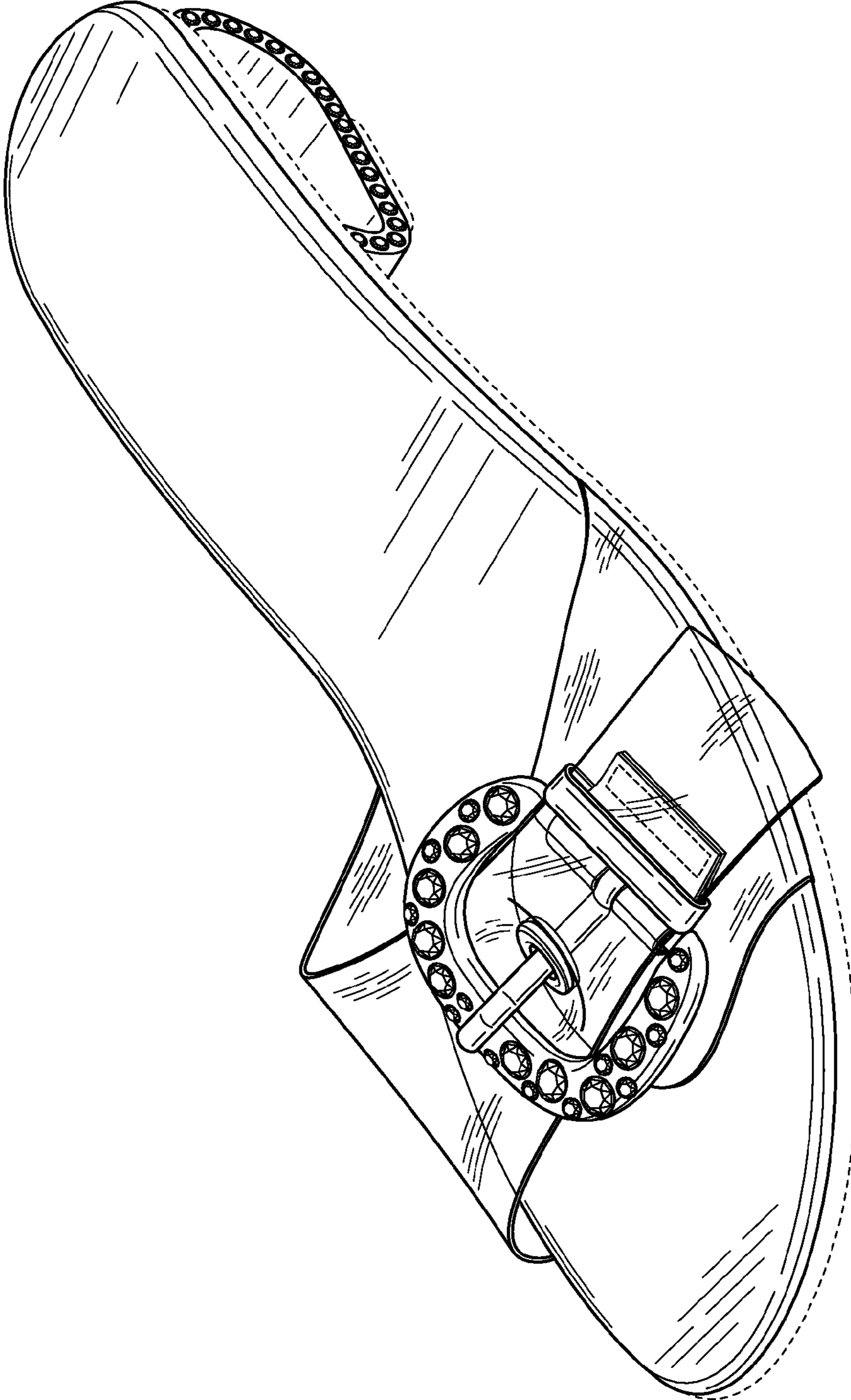

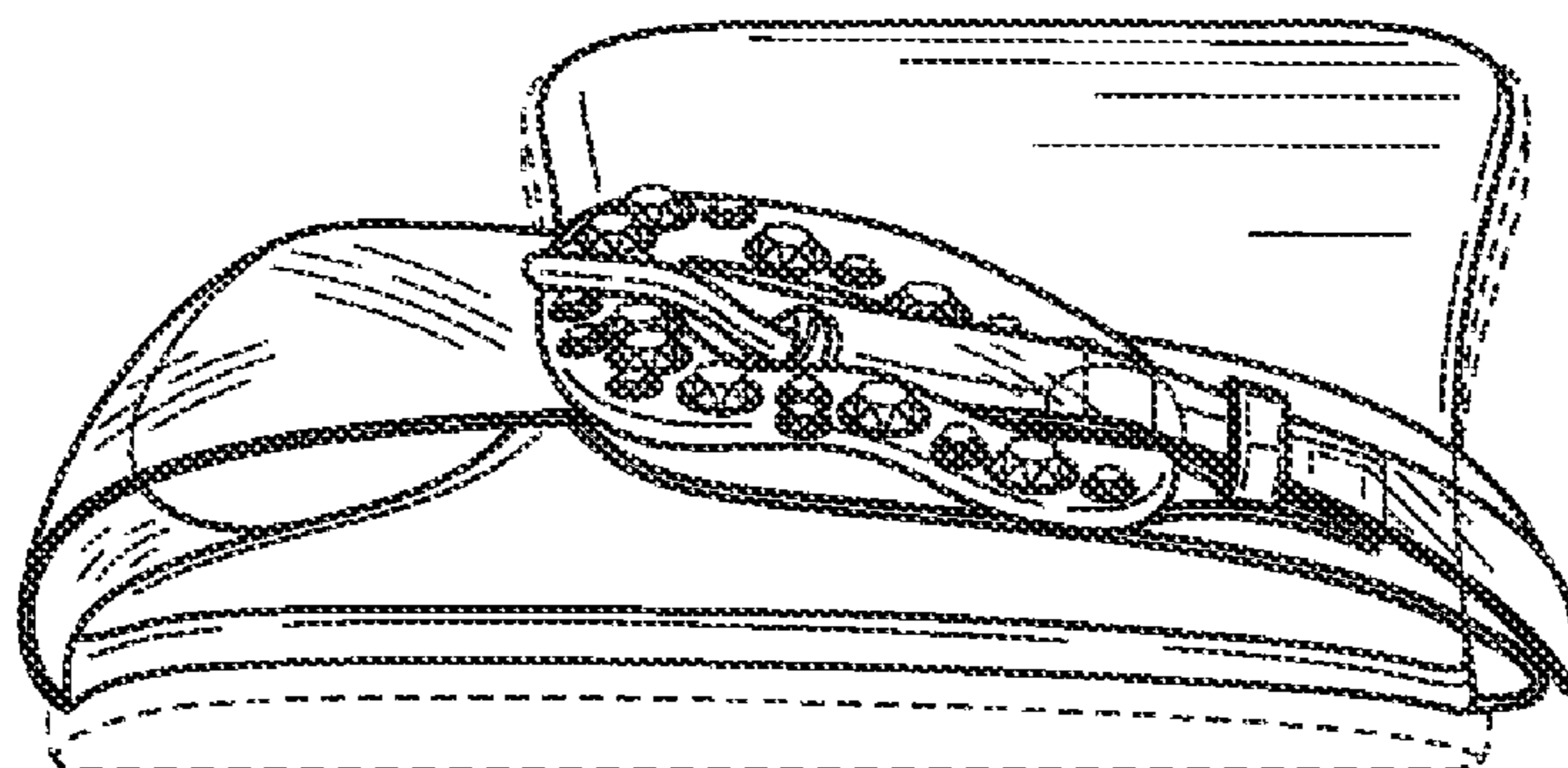

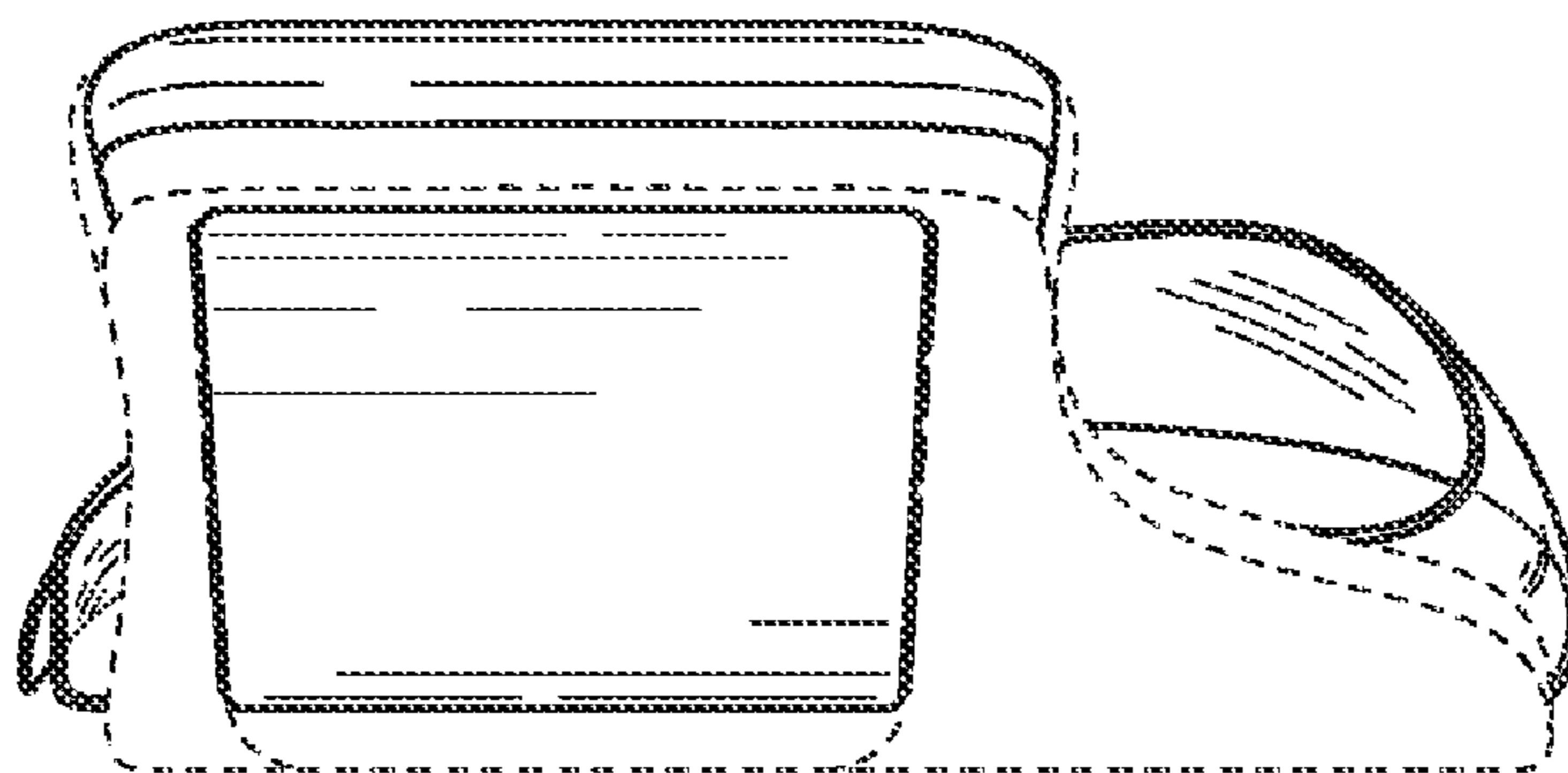

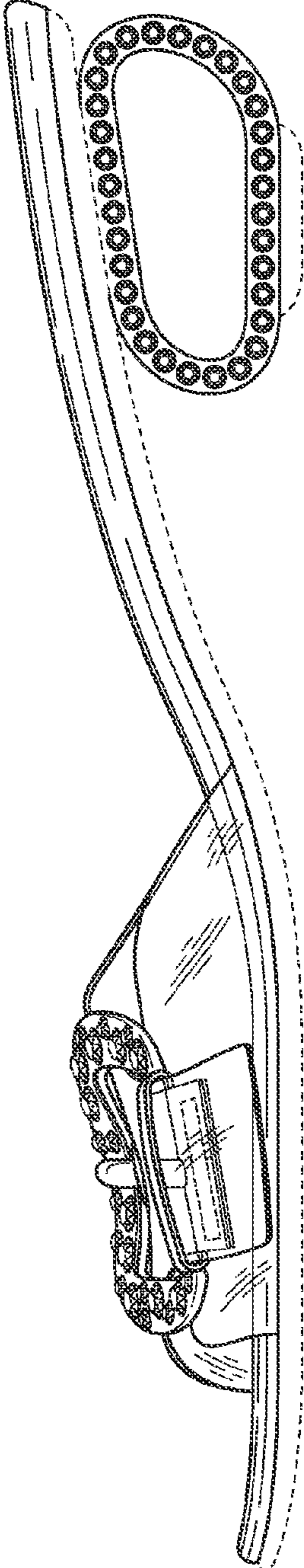

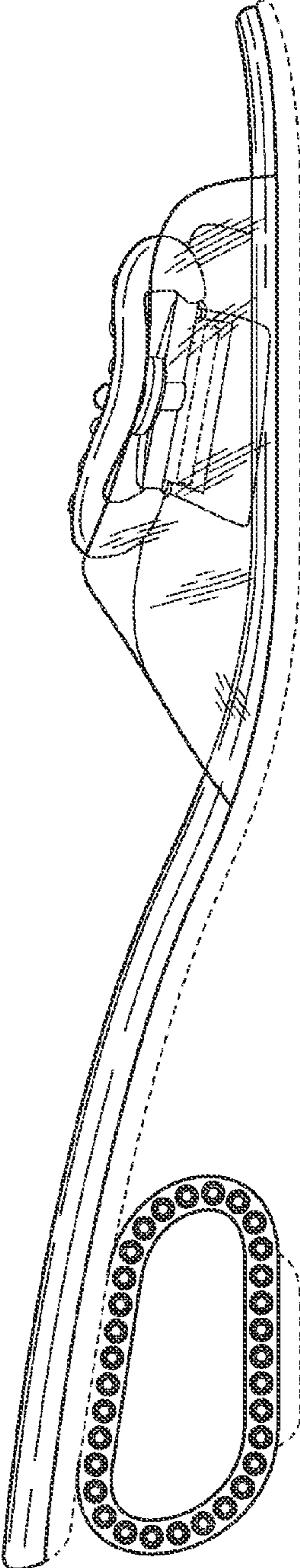

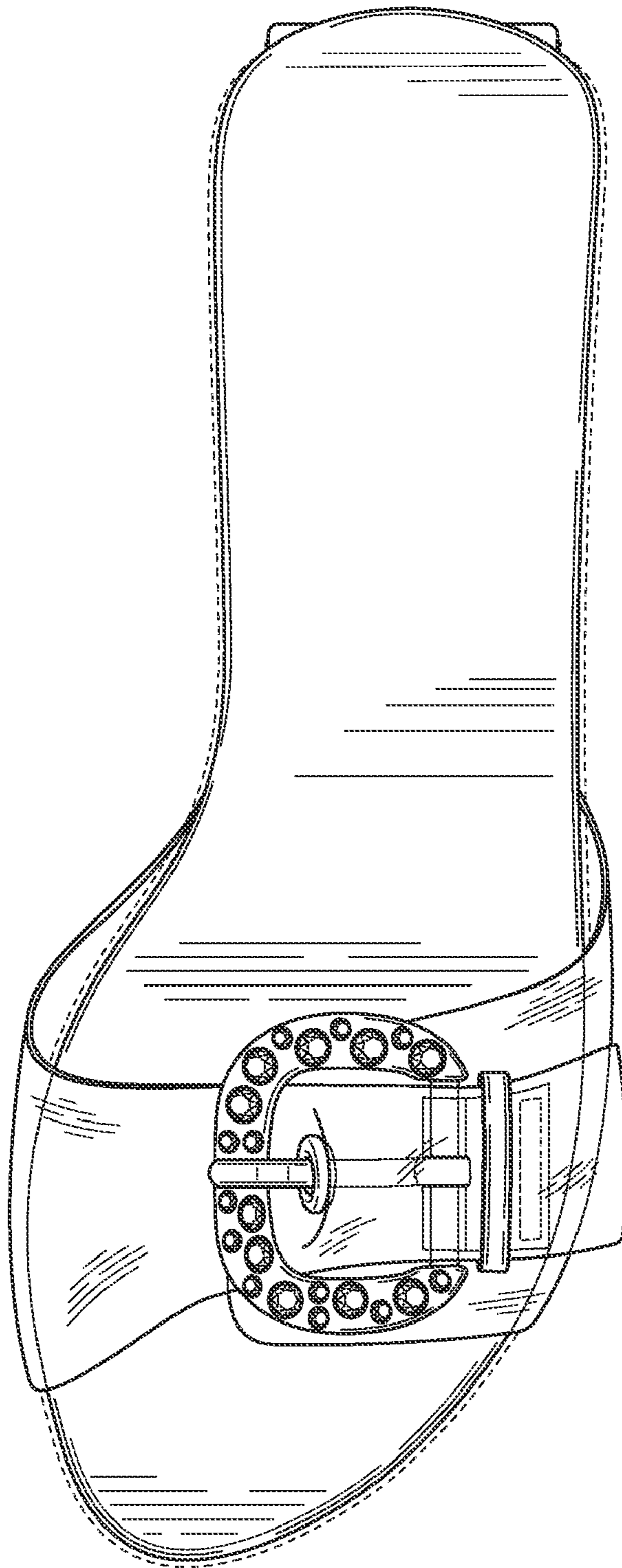

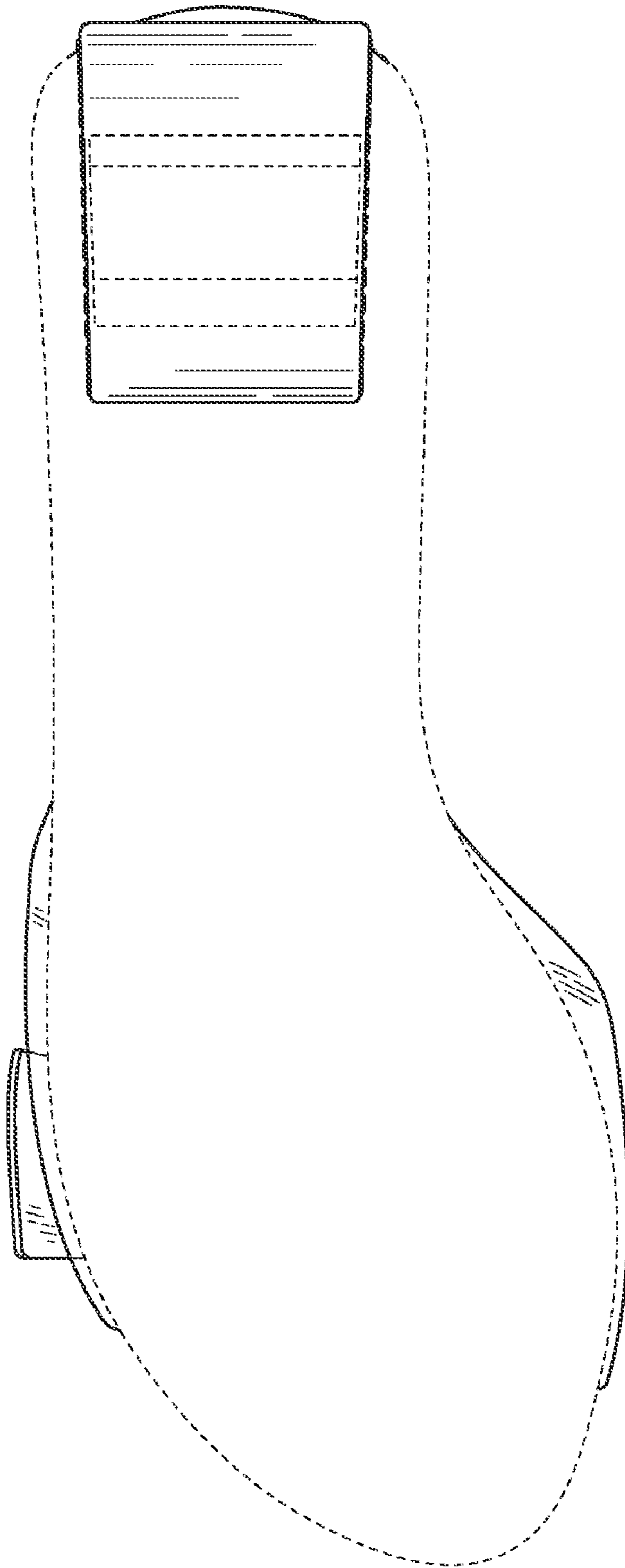
