FIG. 2 is rear elevation view thereof;

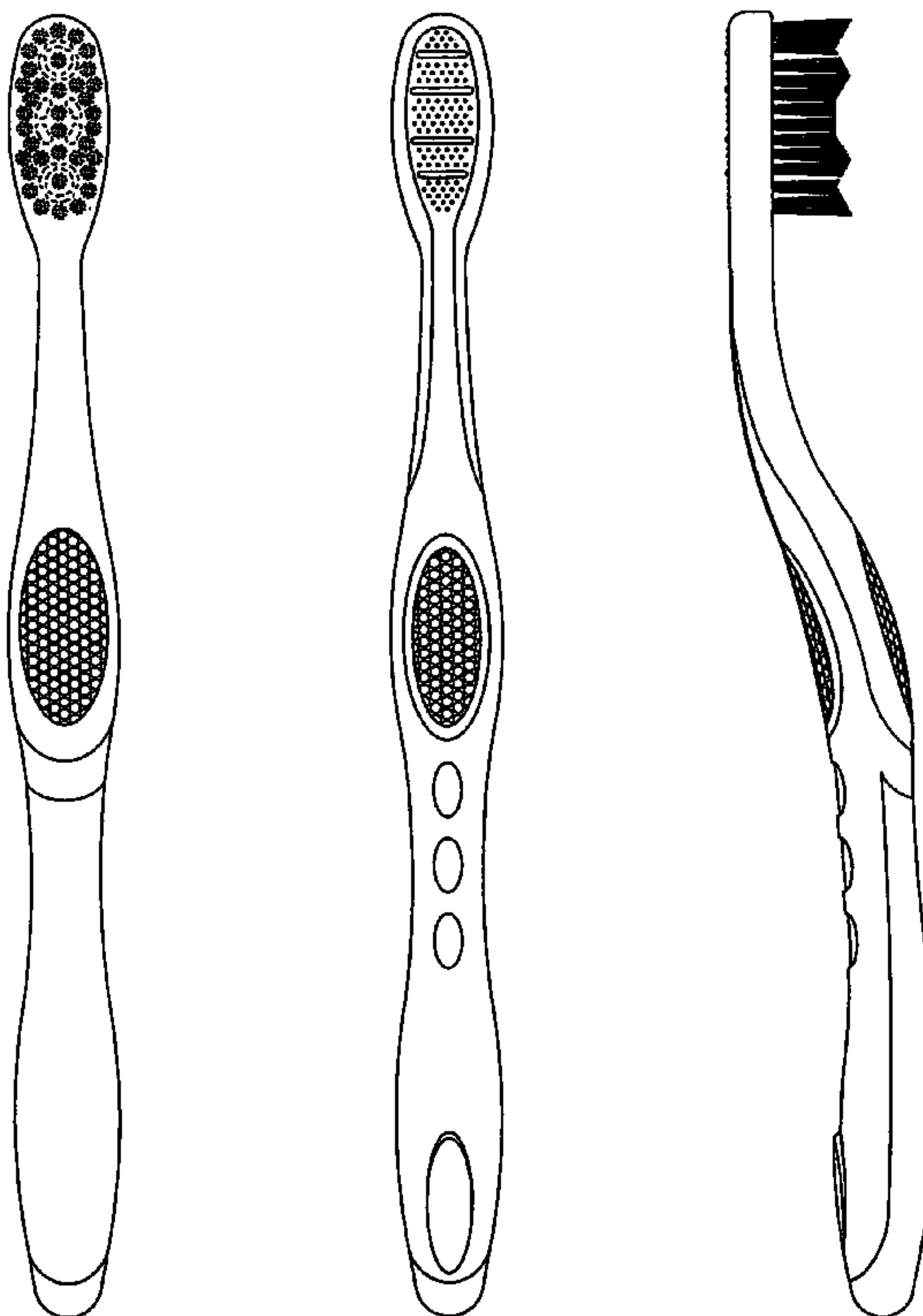
FIG. 3 is a left side elevation view thereof, the right side being a mirror image thereof;

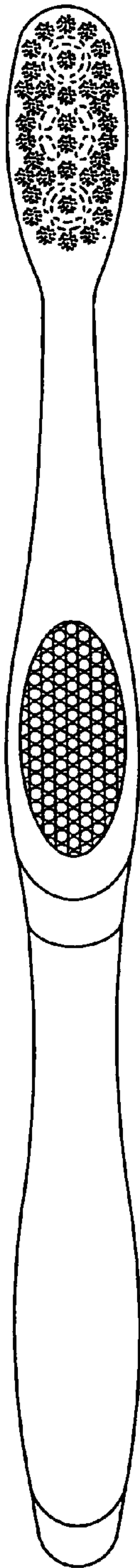

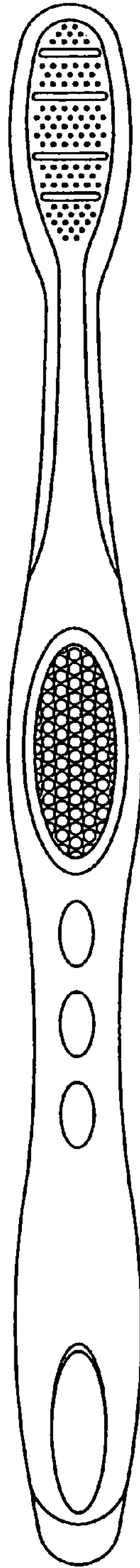

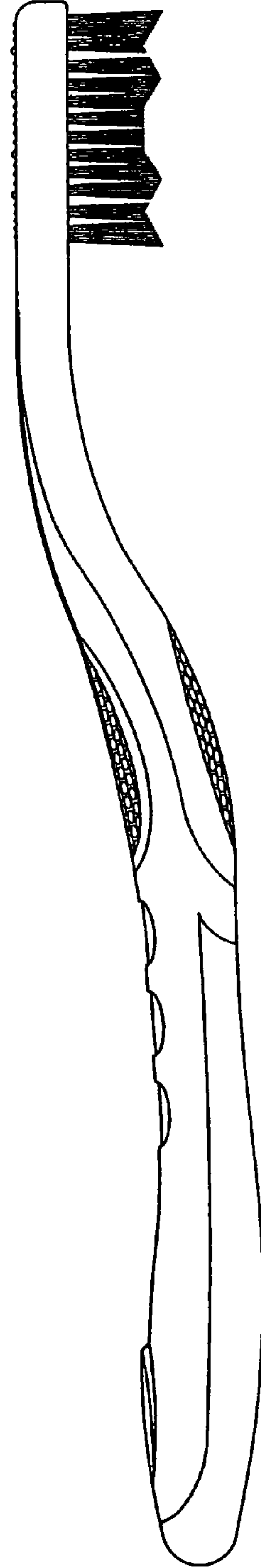

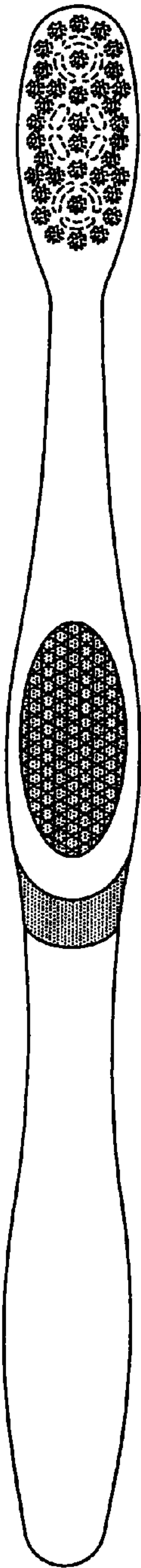

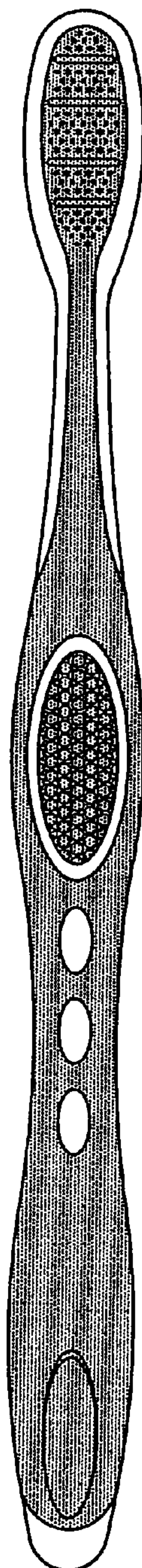

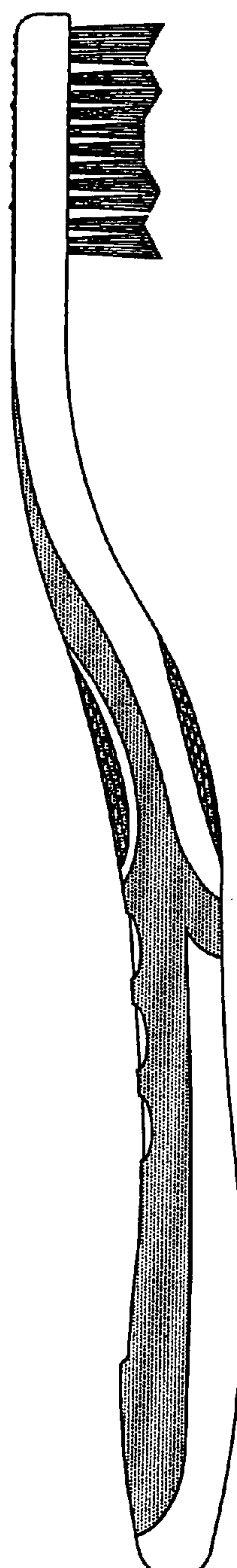
