The ornamental design for a knob for cooking utensil, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a knob for cooking utensil, showing my new design;

FIG. 2 is a side elevational view thereof;

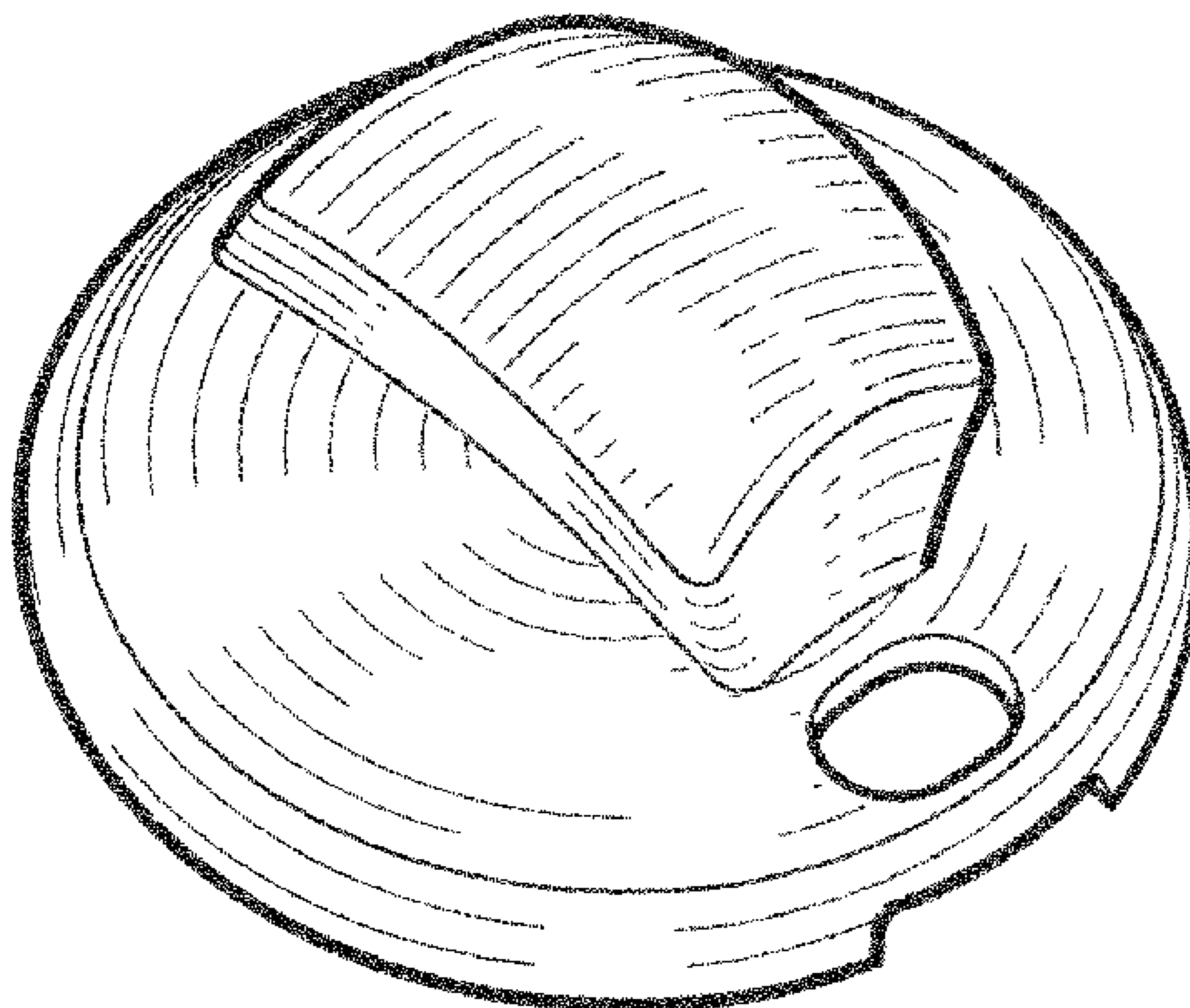
FIG. 3 is a top plan view thereof;

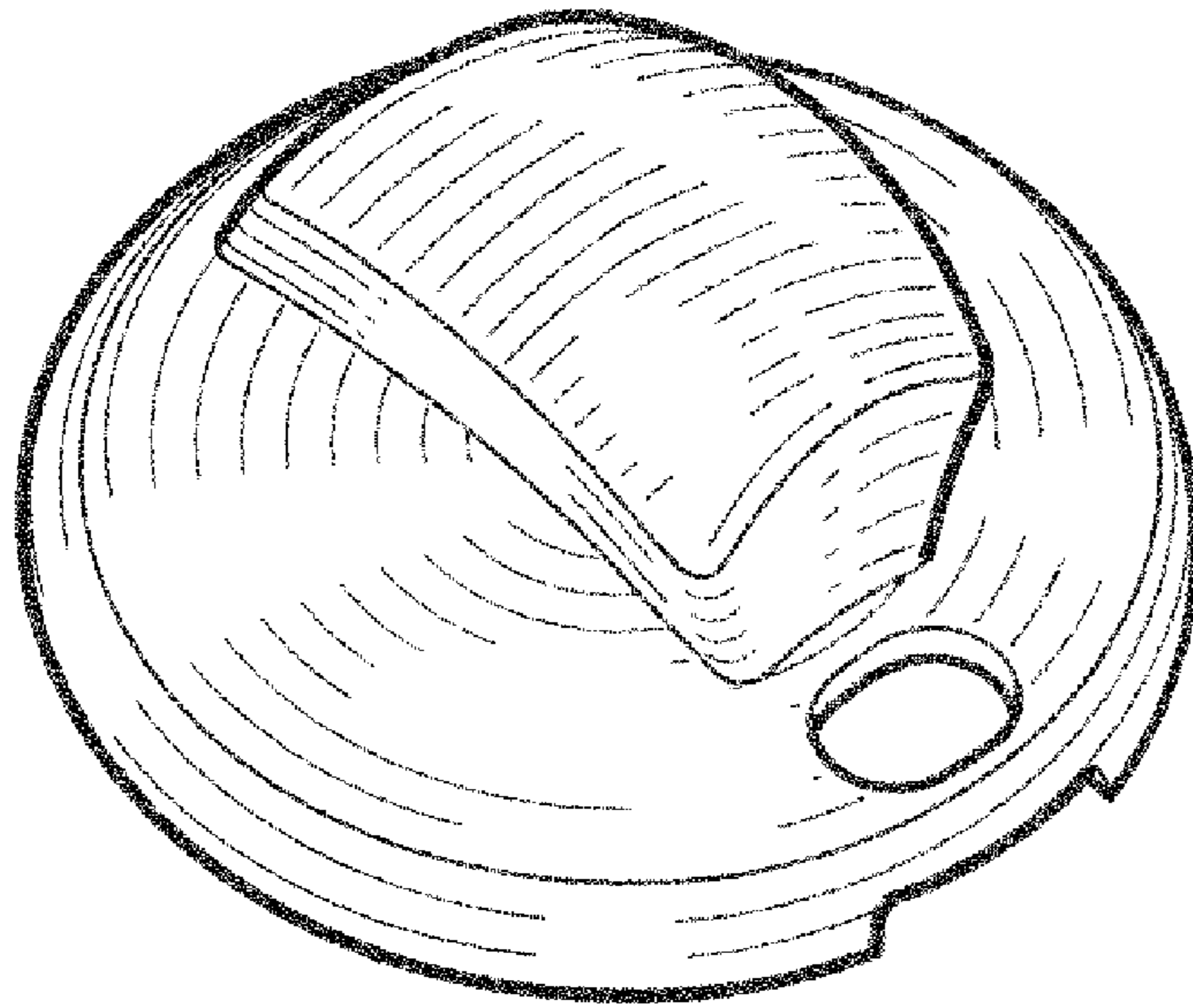

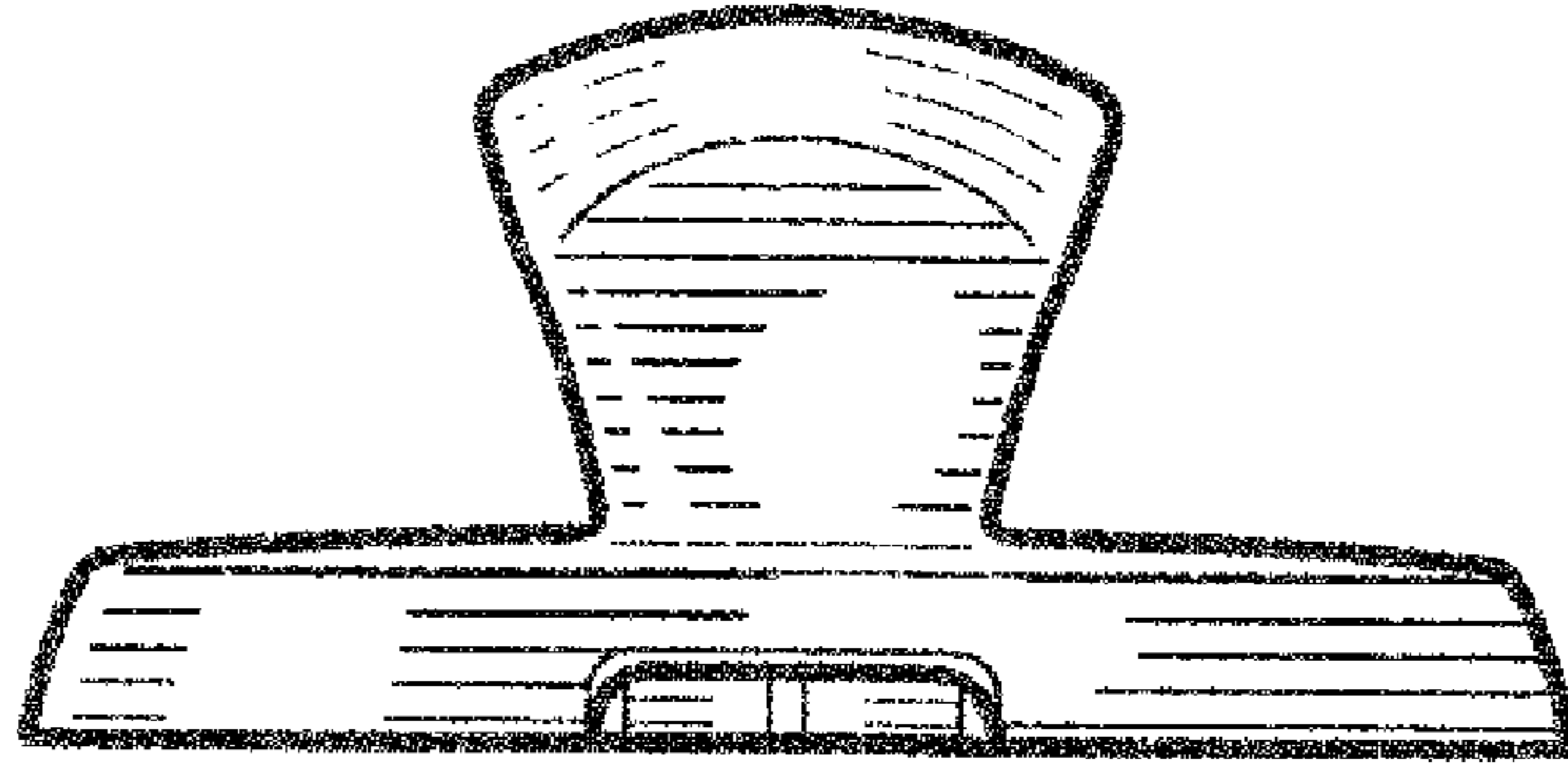

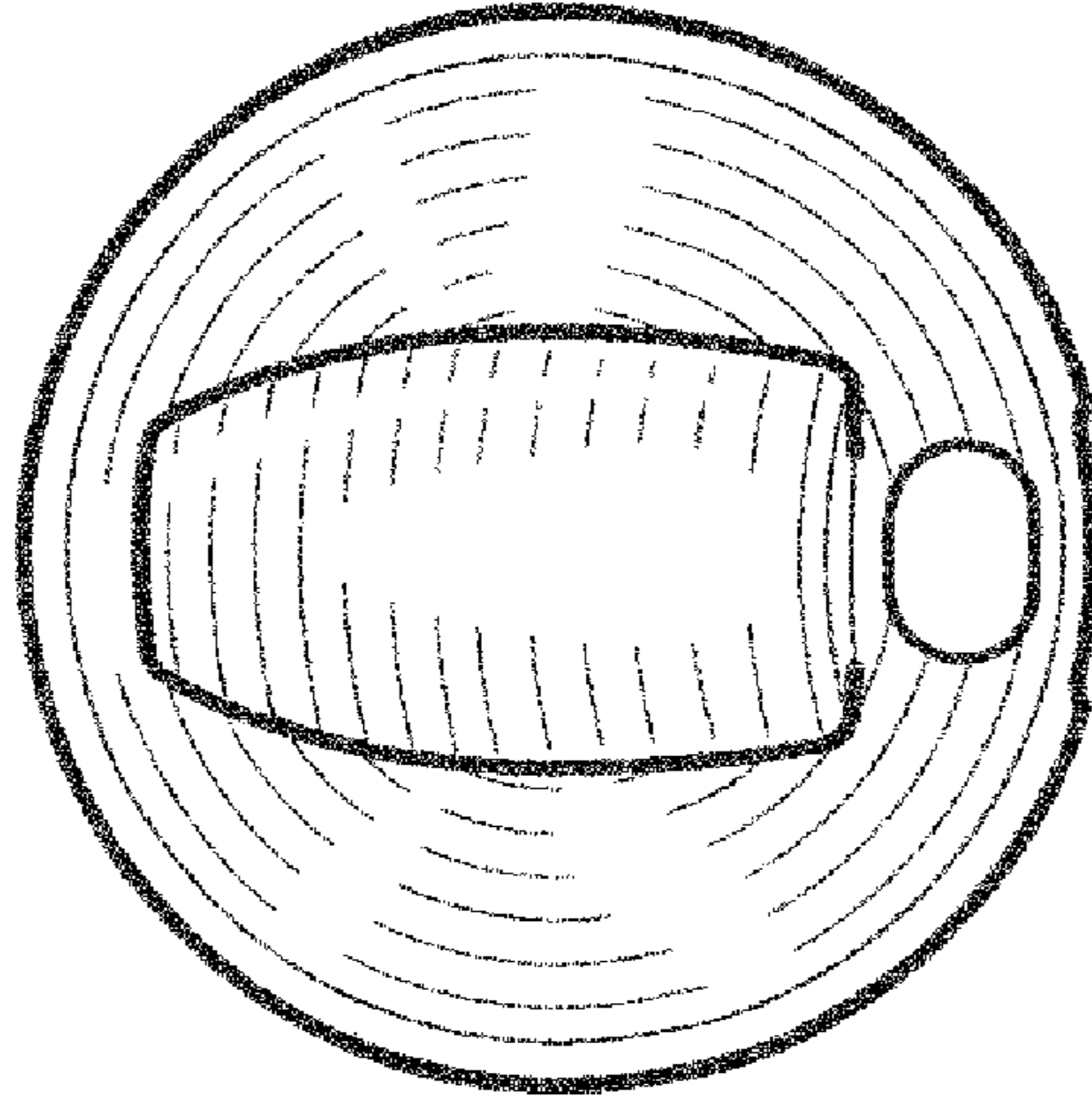
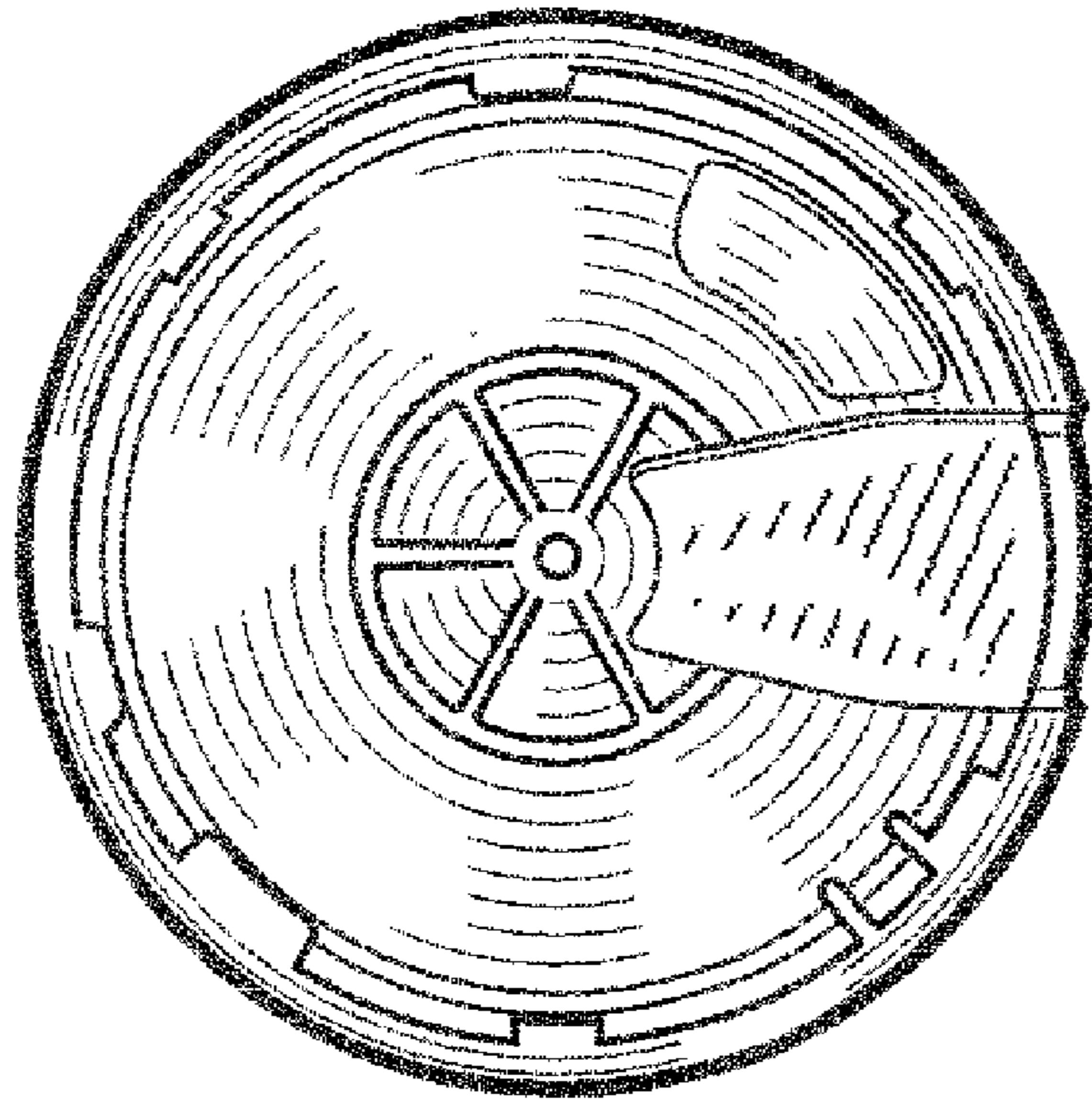
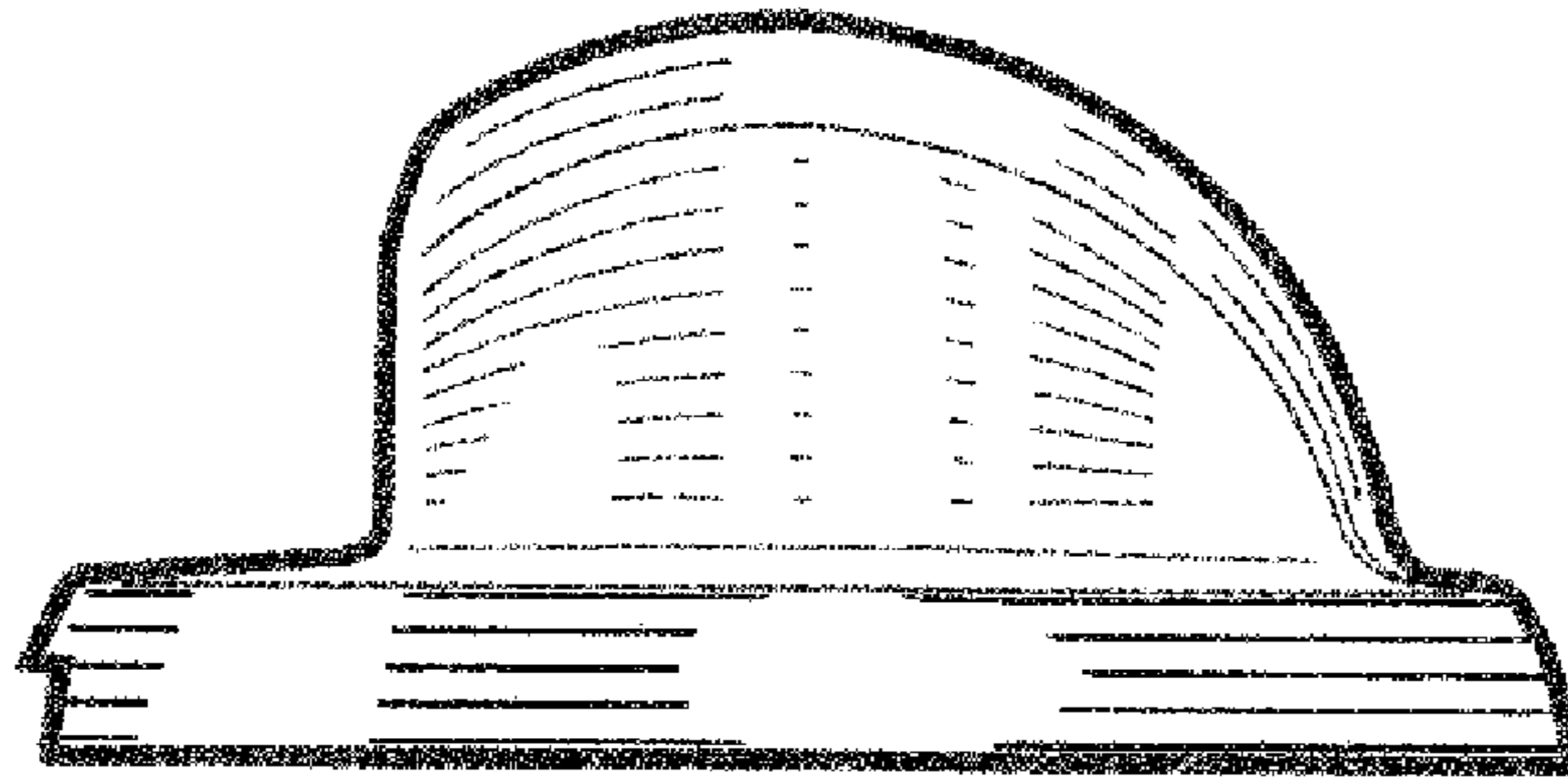


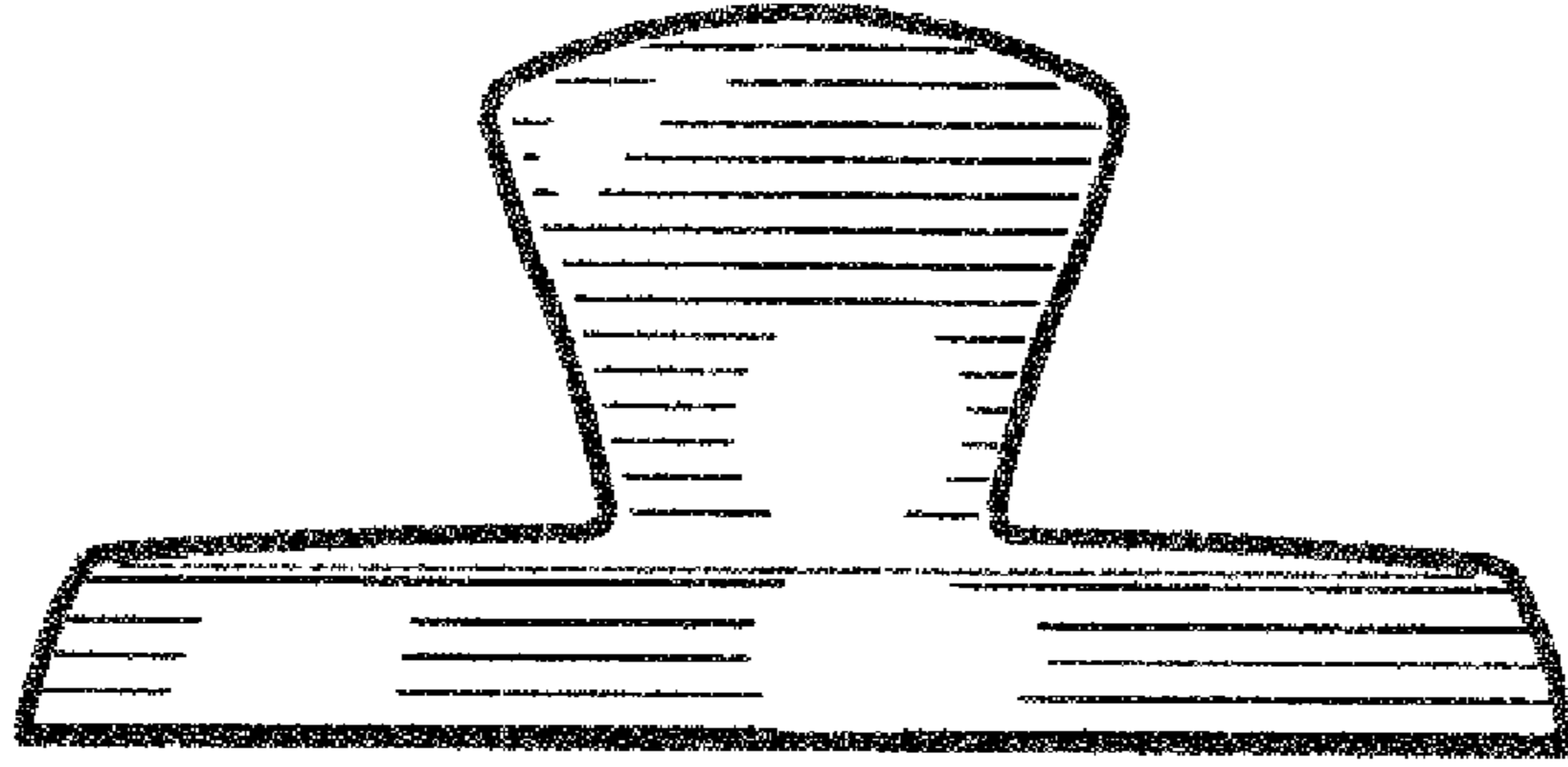
