The ornamental design for a handle for a kitchen and eating utensil, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a handle for a kitchen utensil and eating utensil showing our new design.

FIG. 2 is a side view thereof, the opposite side view being a mirror image;

FIG. 3 is a rear view thereof;

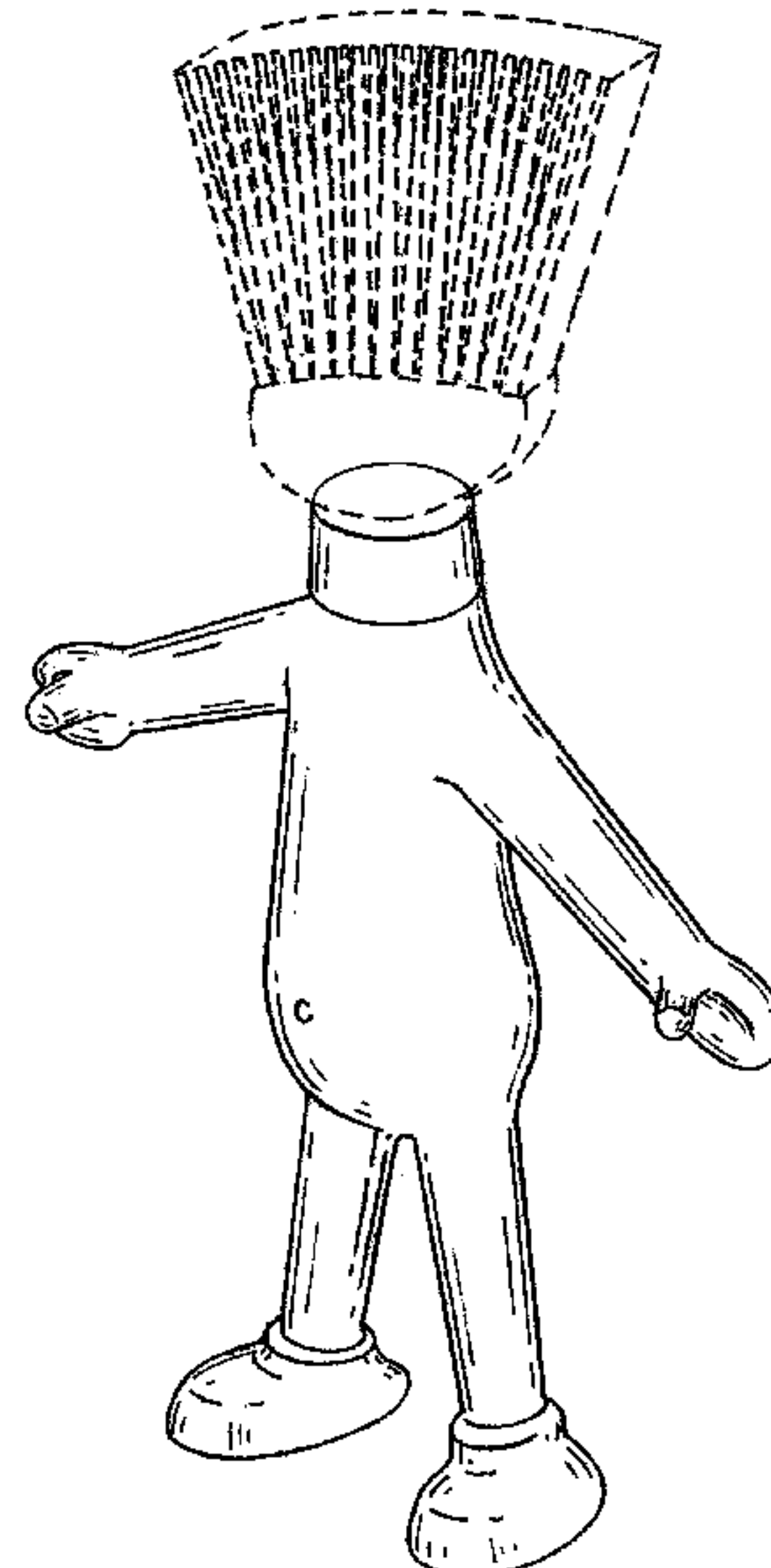
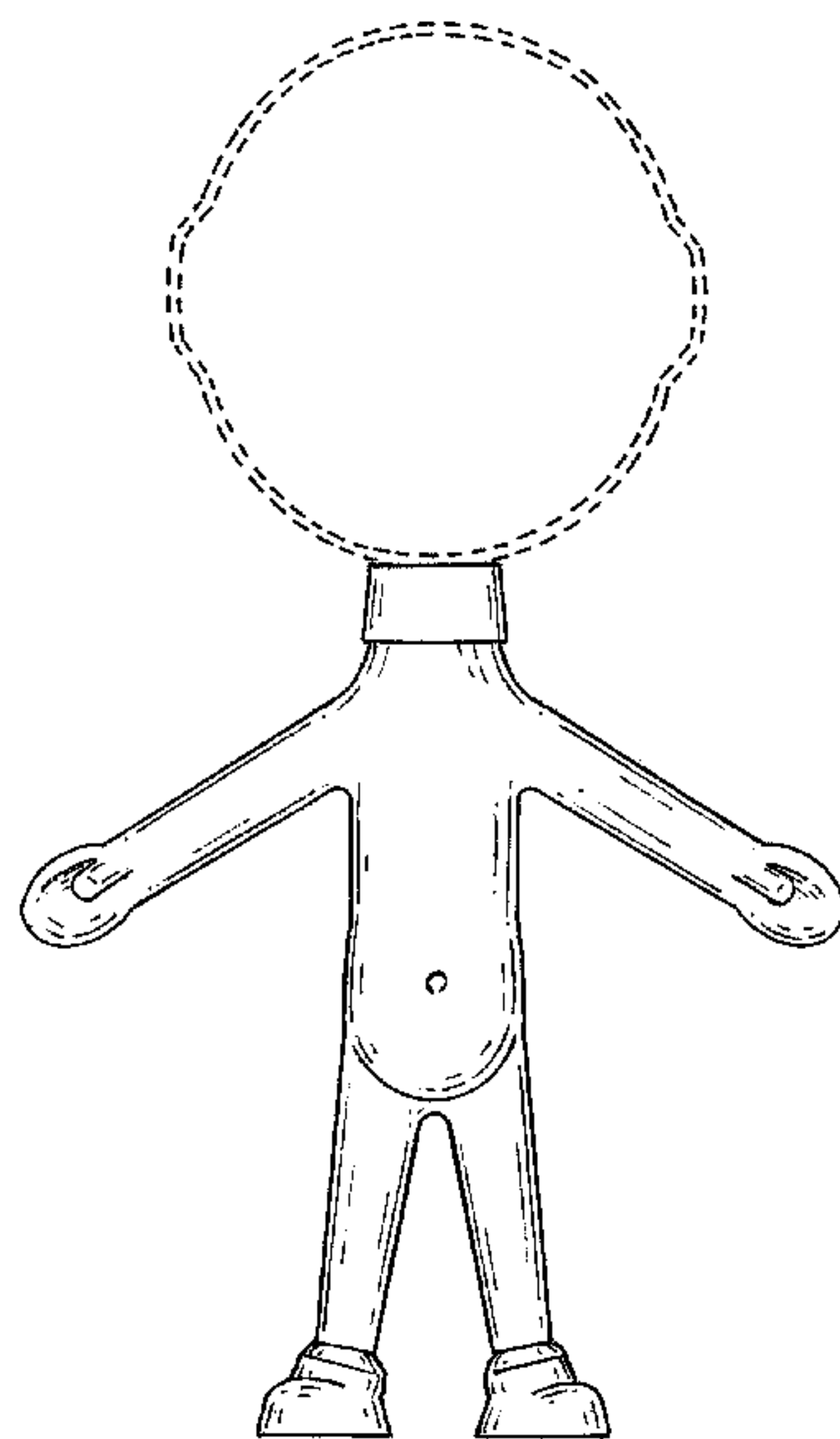
FIG. 4 is a top view thereof shown in an alternate environment;

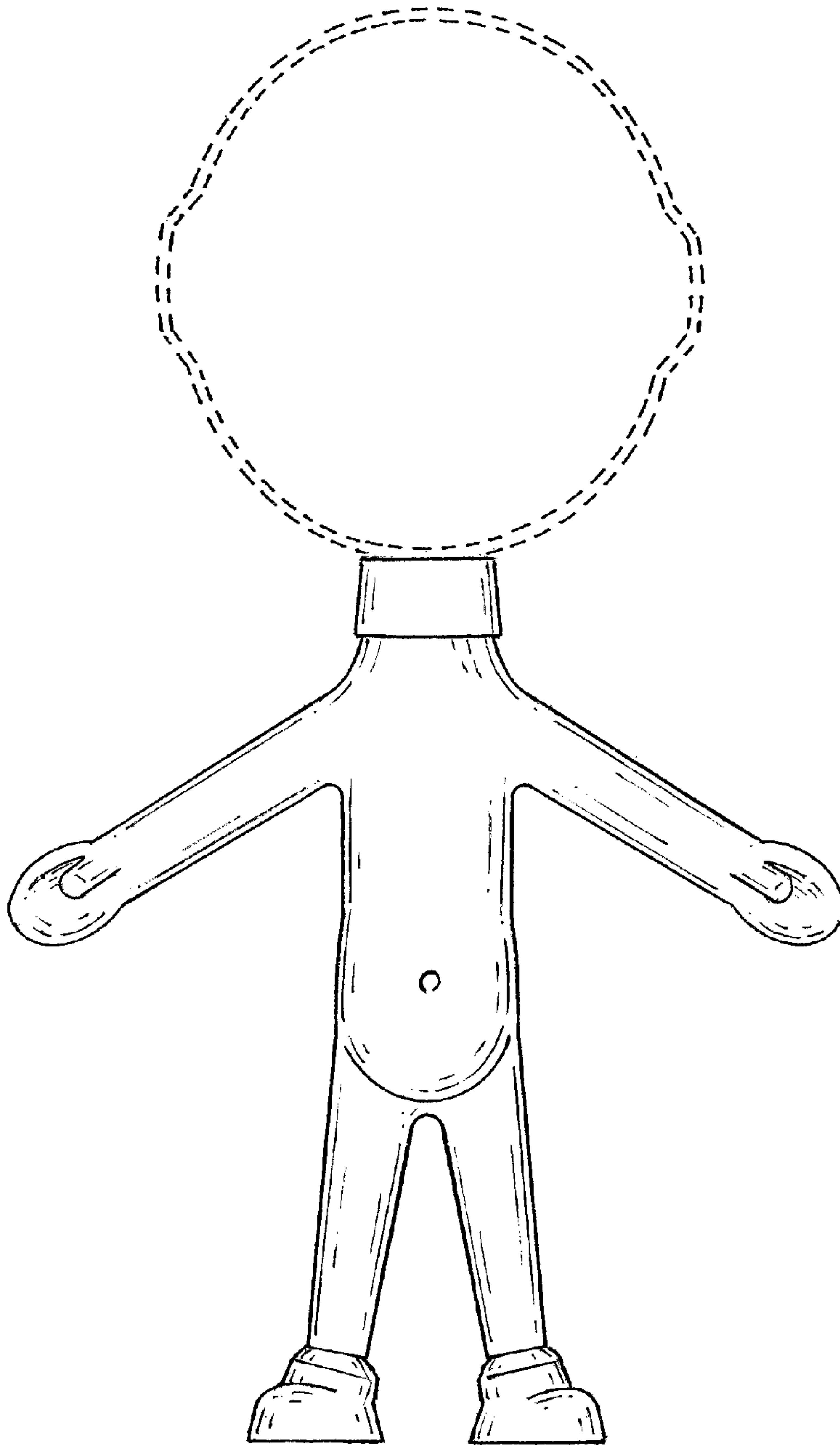

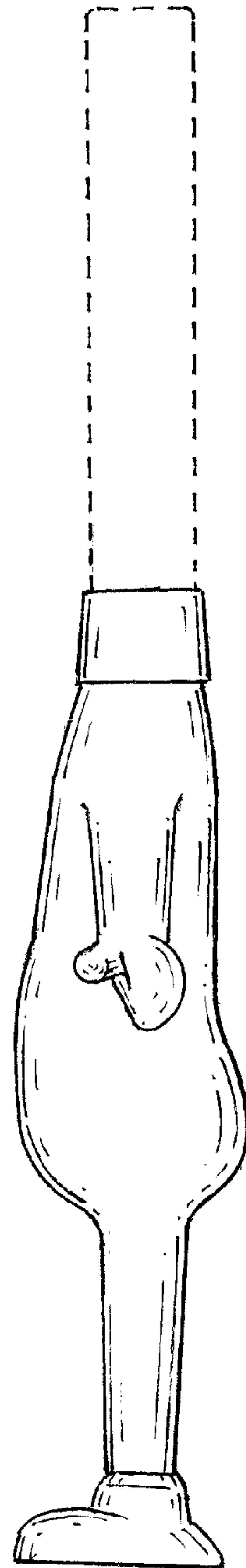

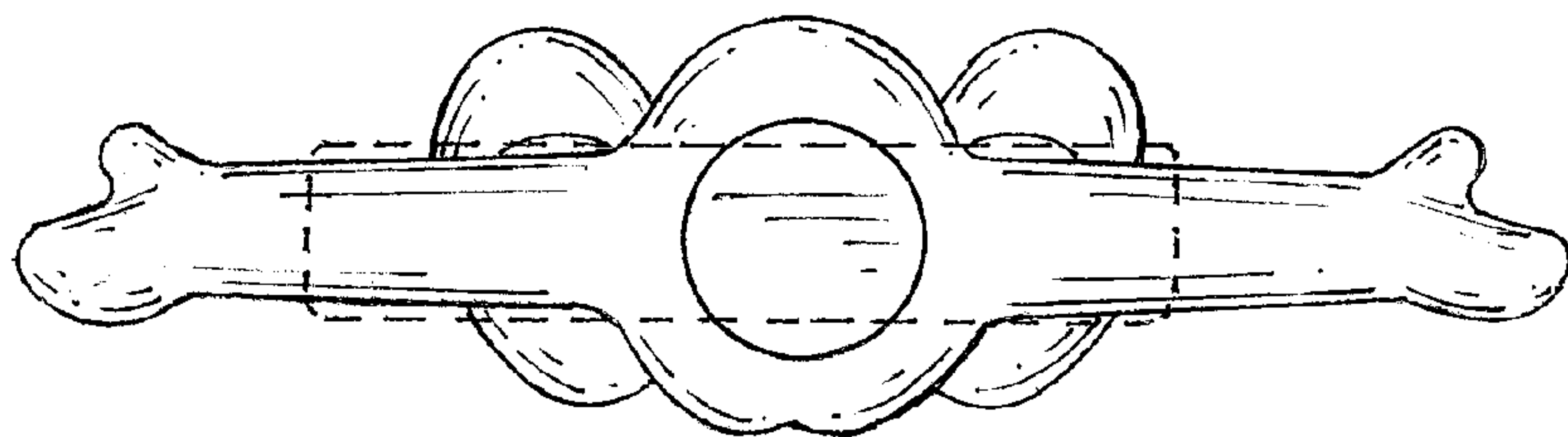

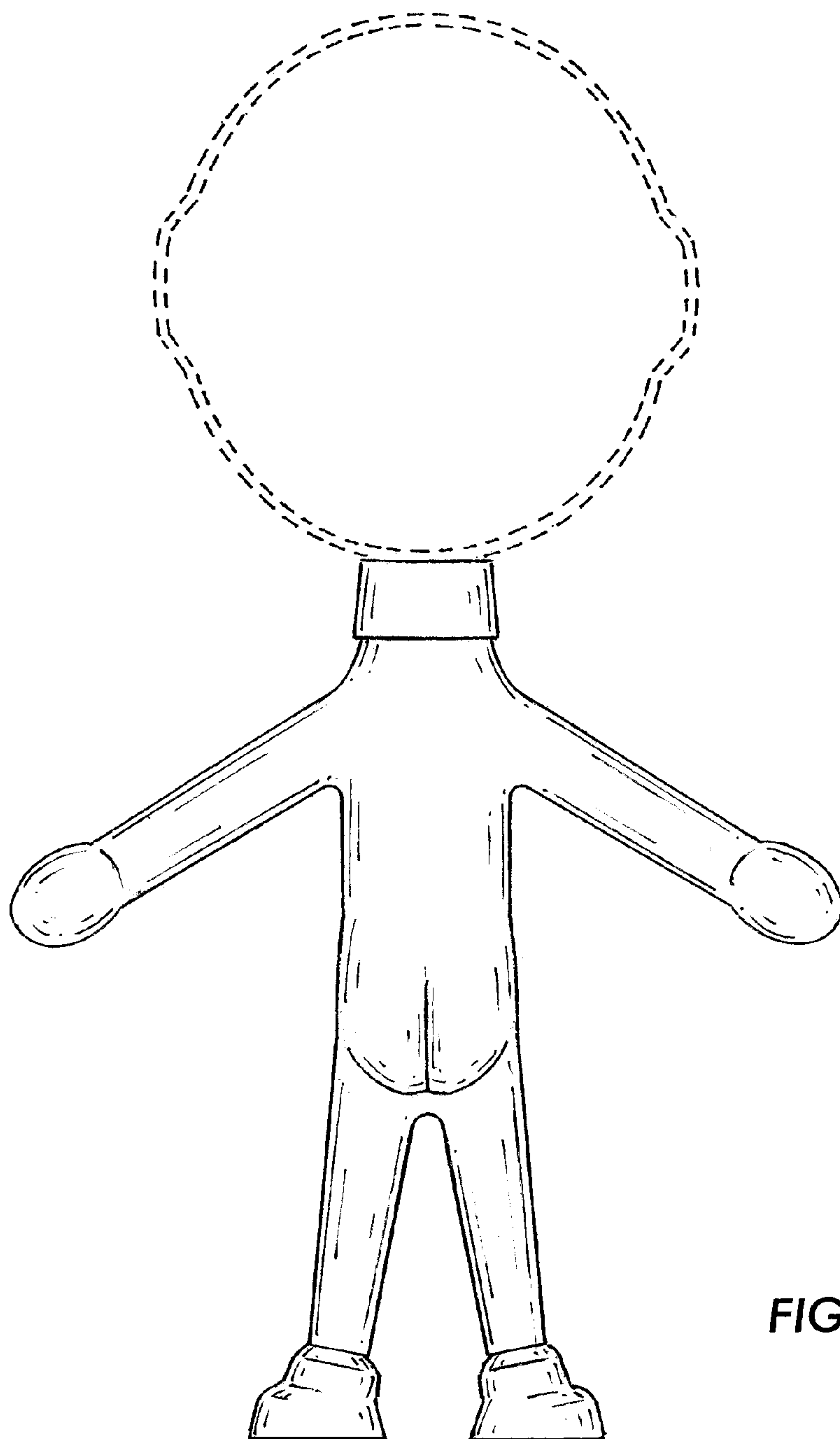

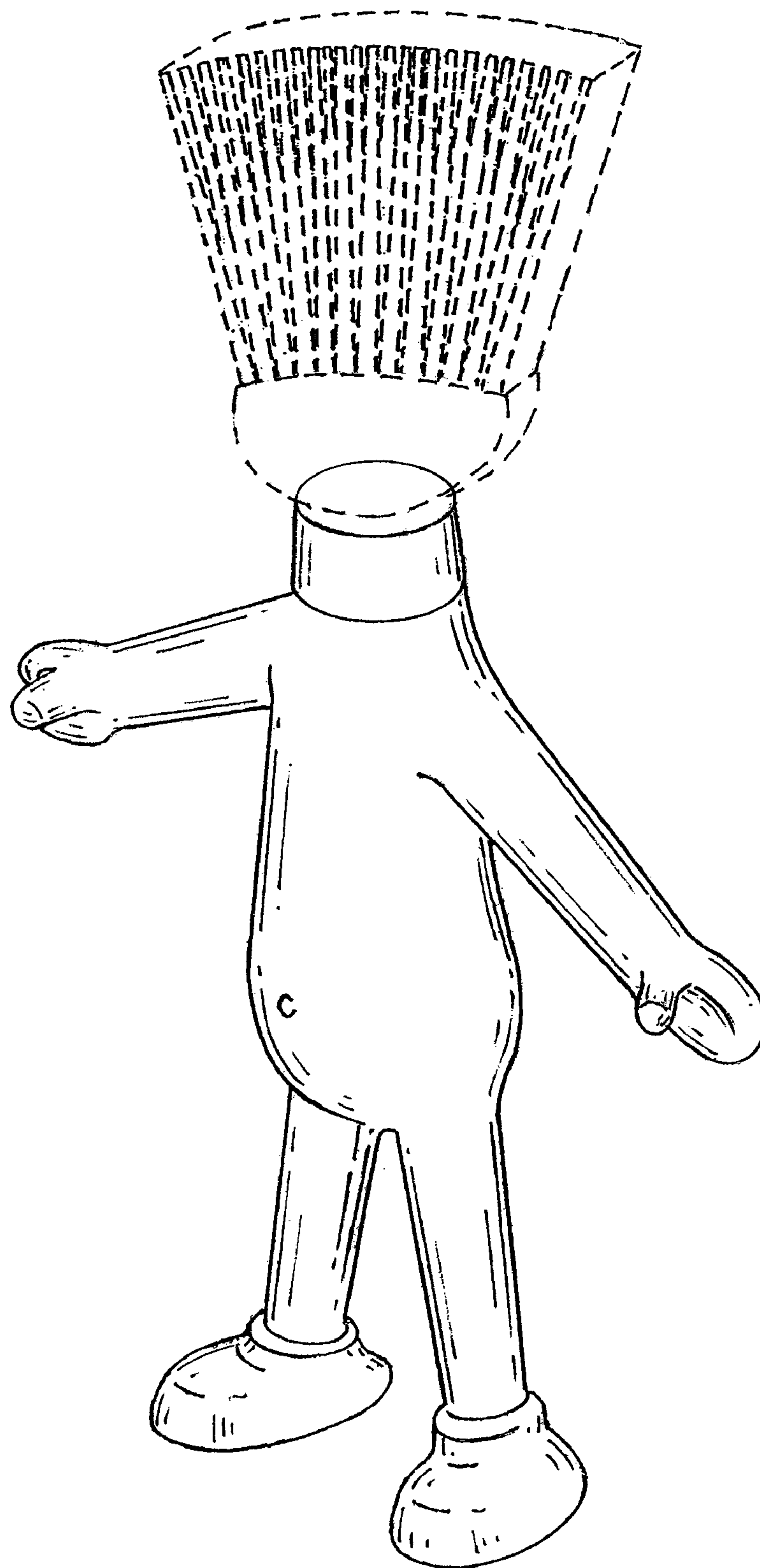

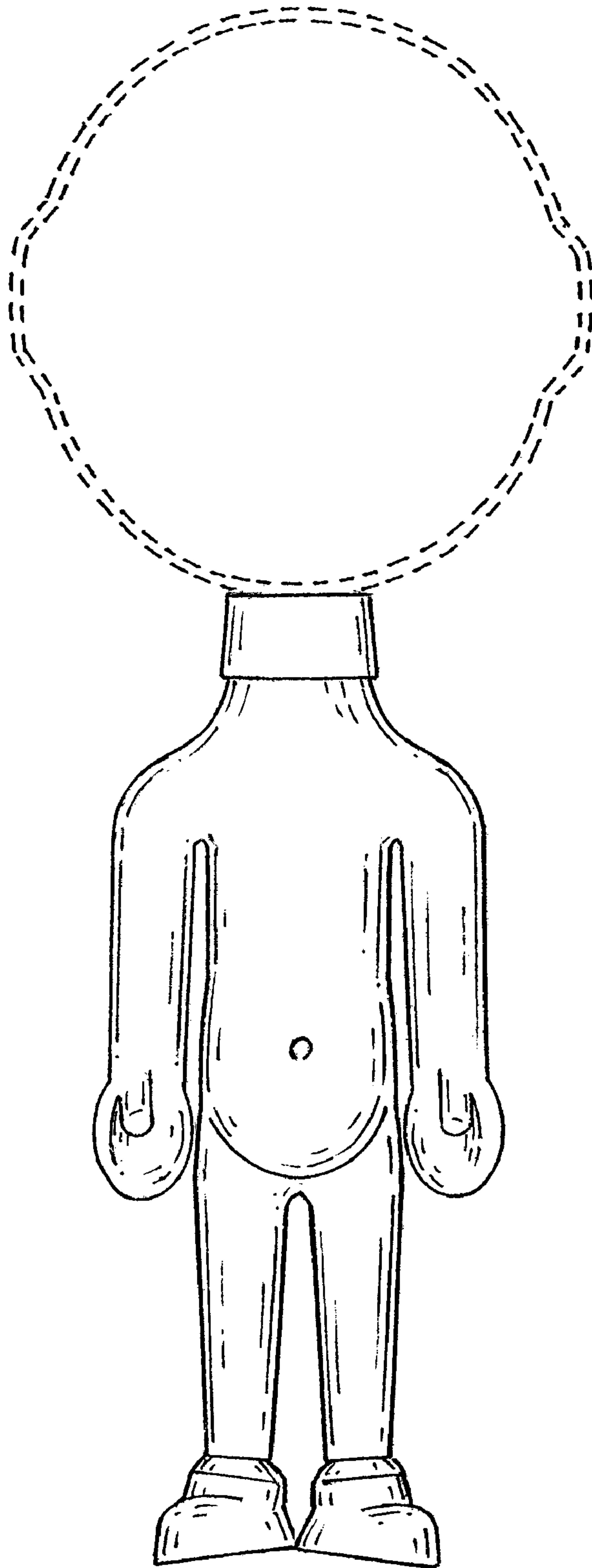
