(57) **CLAIM**

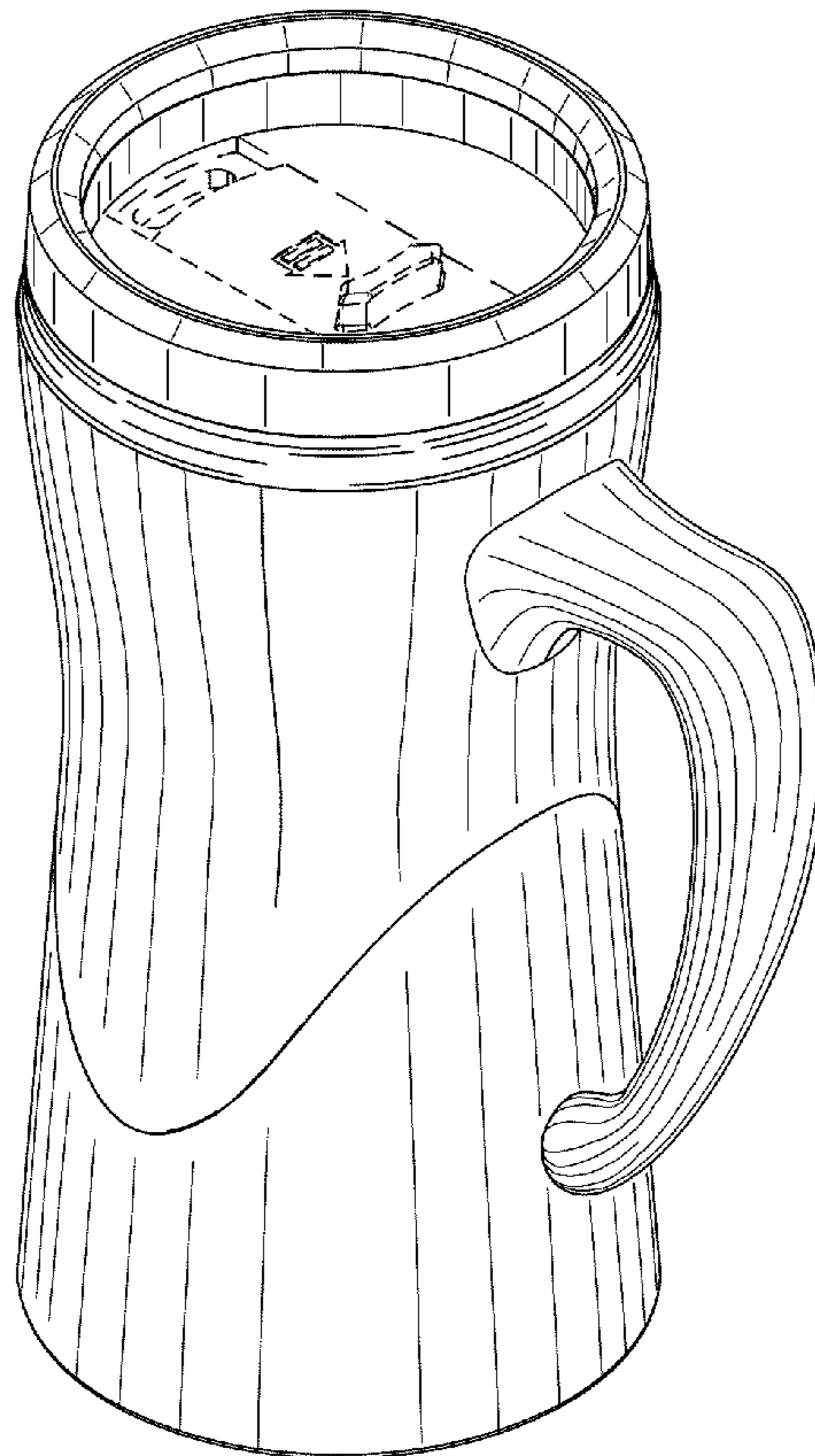
The ornamental design for a mug, as shown and described.

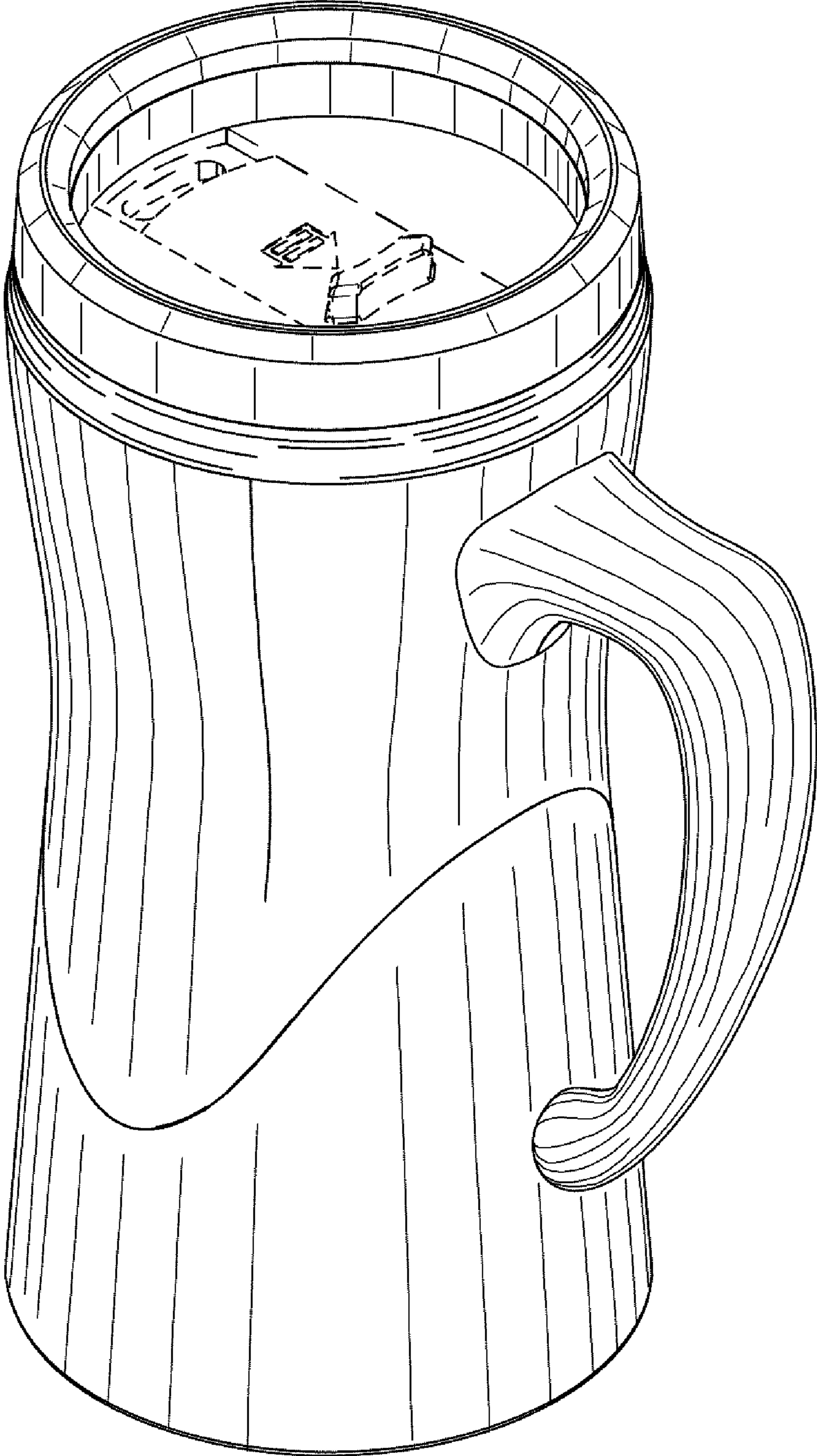

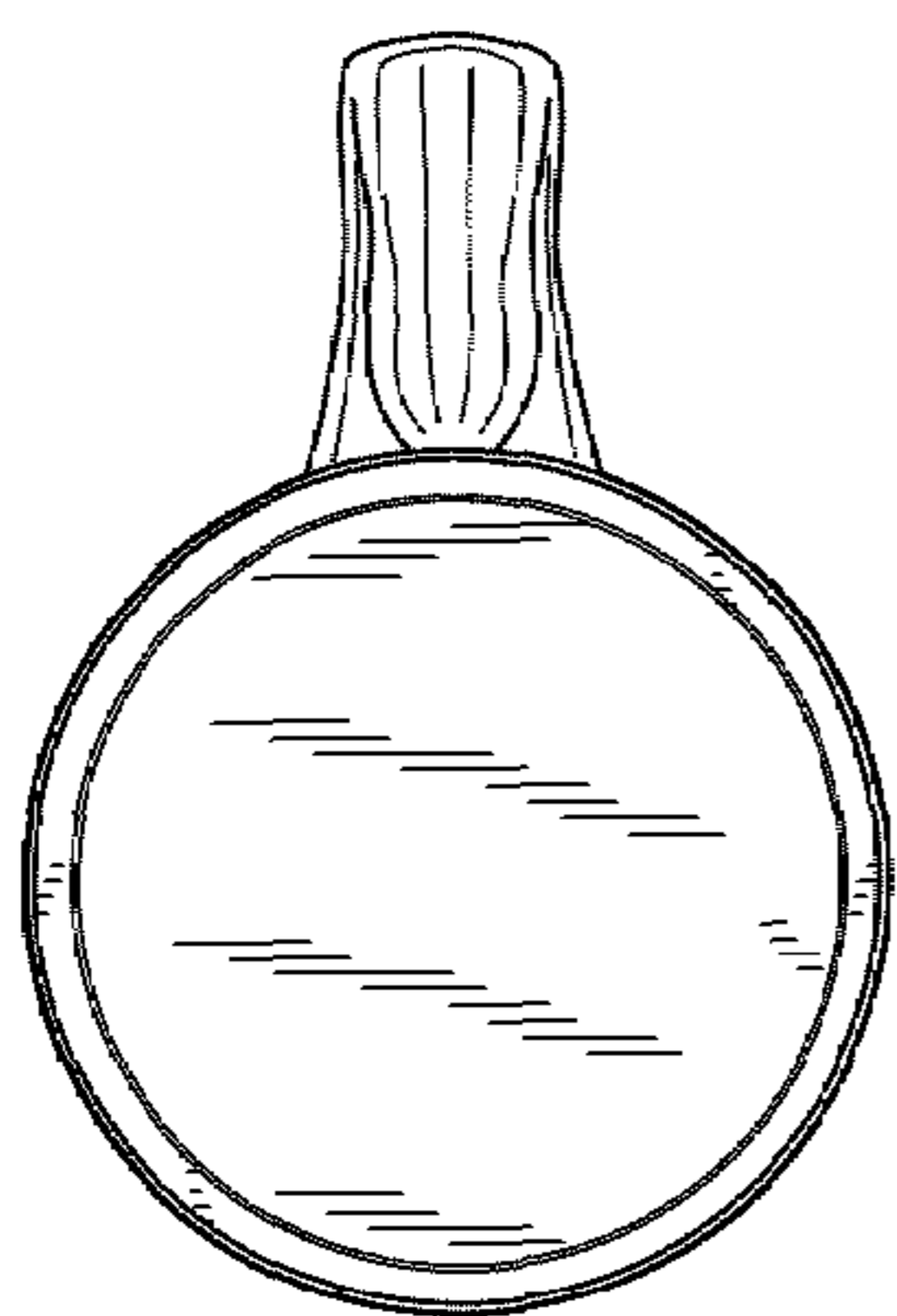

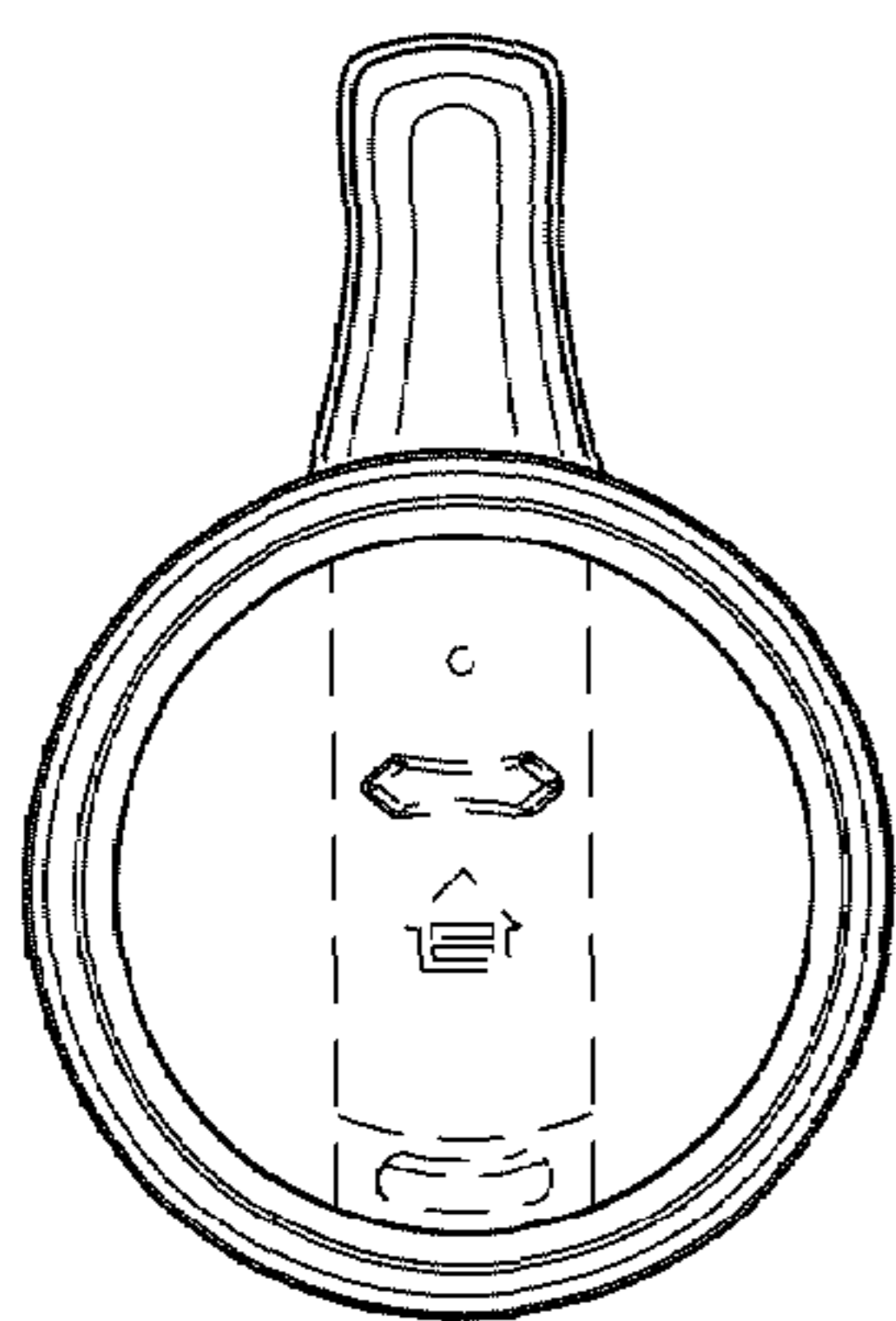

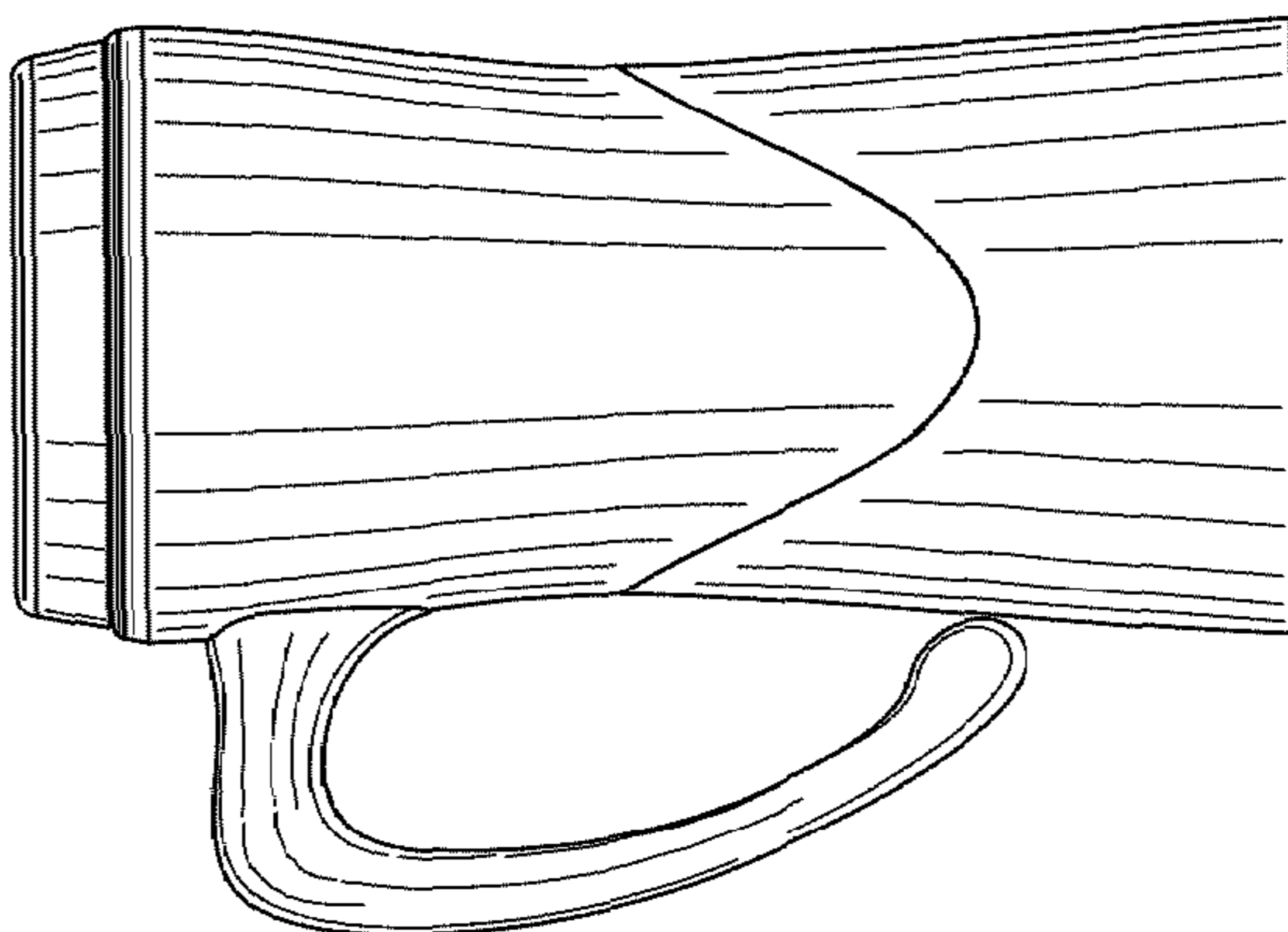

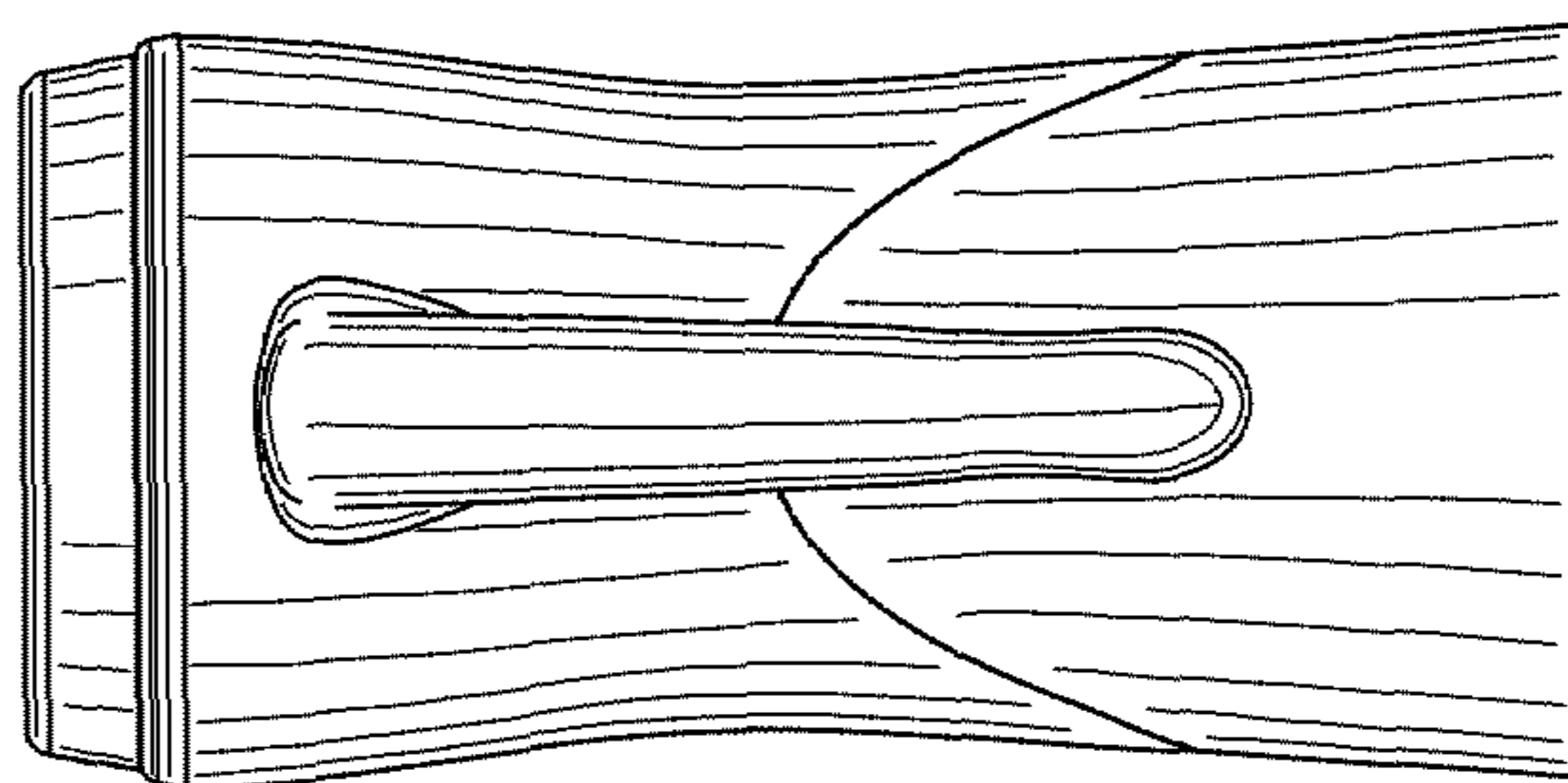

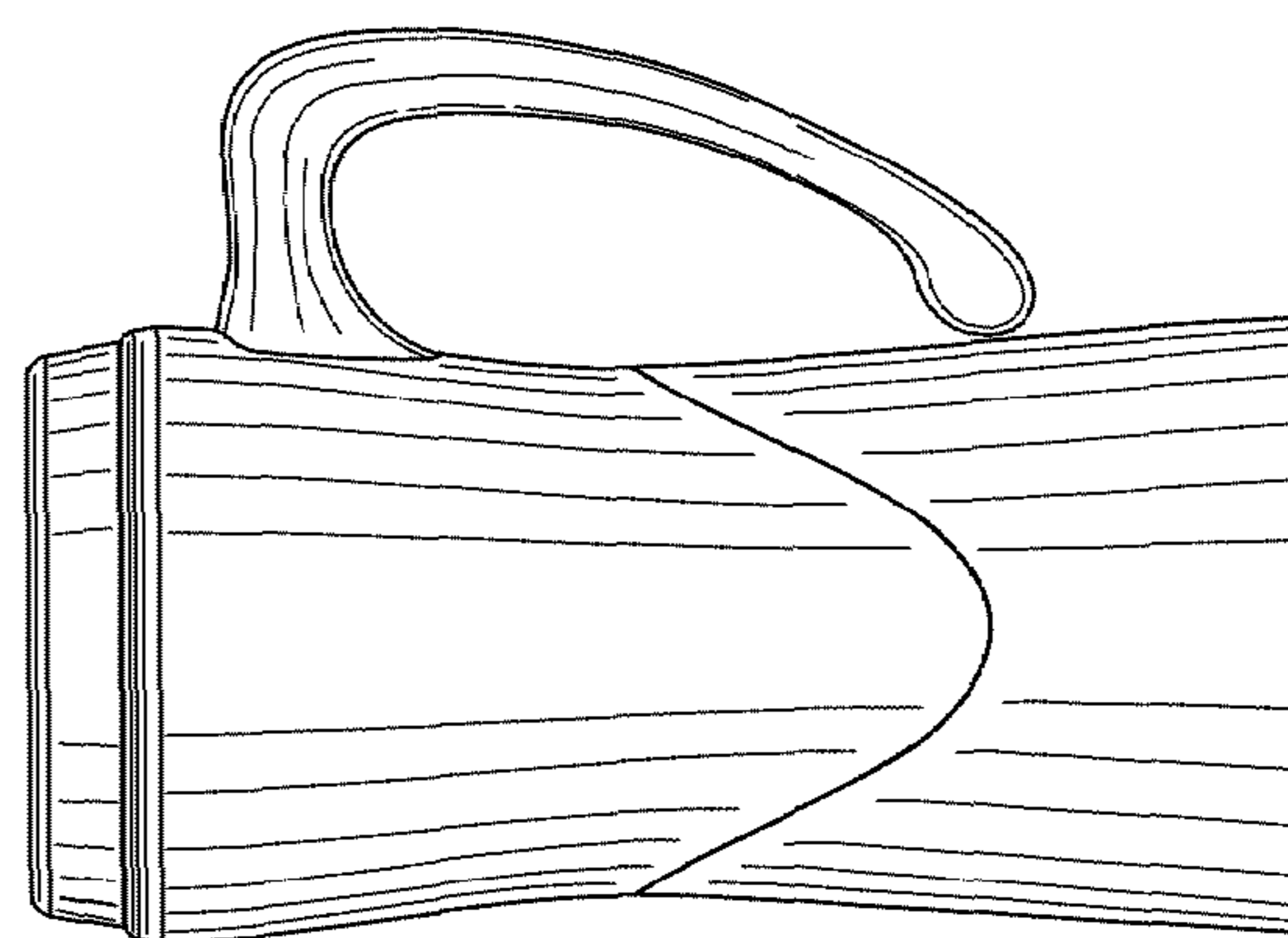

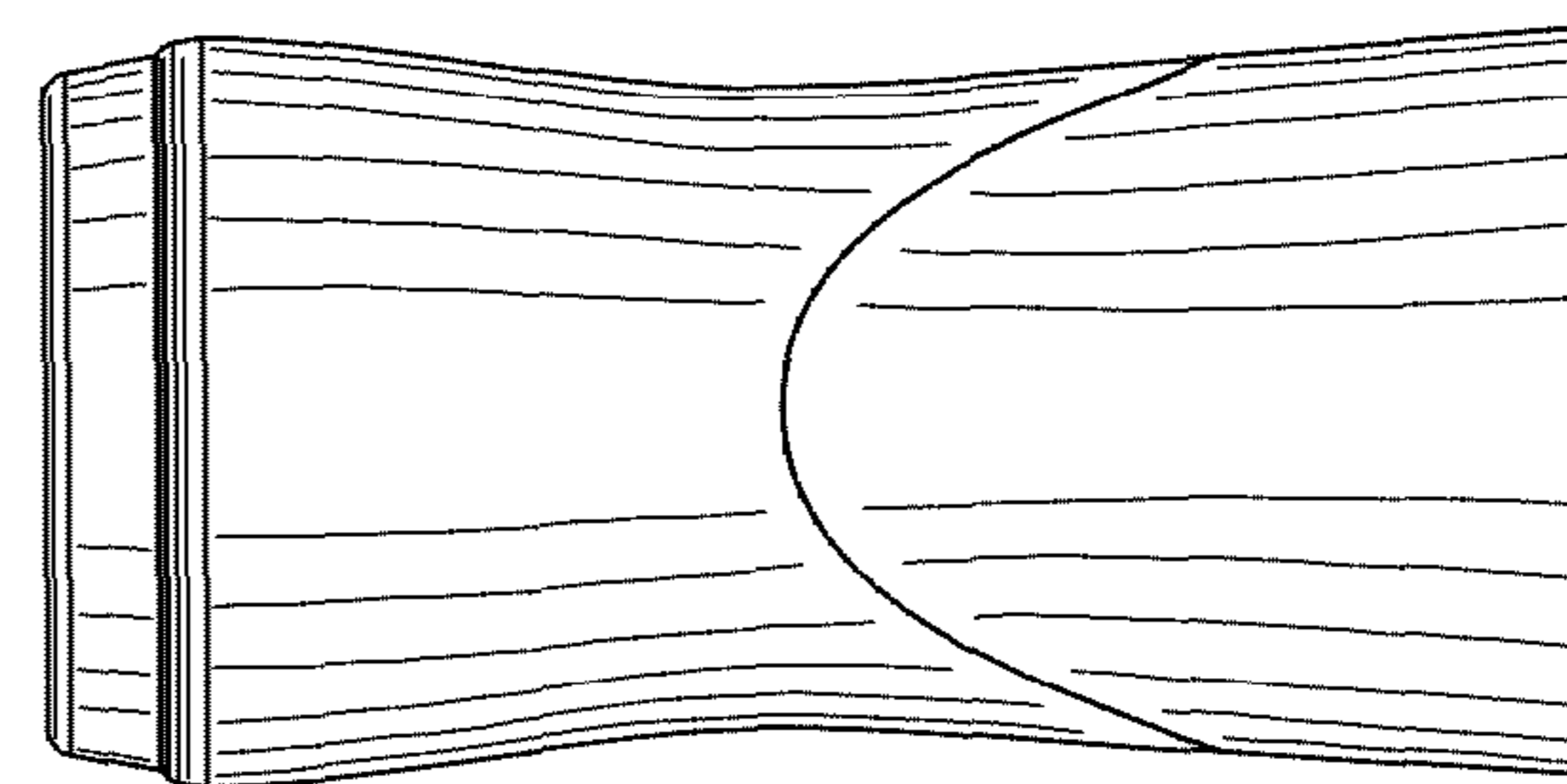
