FIG. 3 is a left side elevational view of the moving image cork packaging block; and

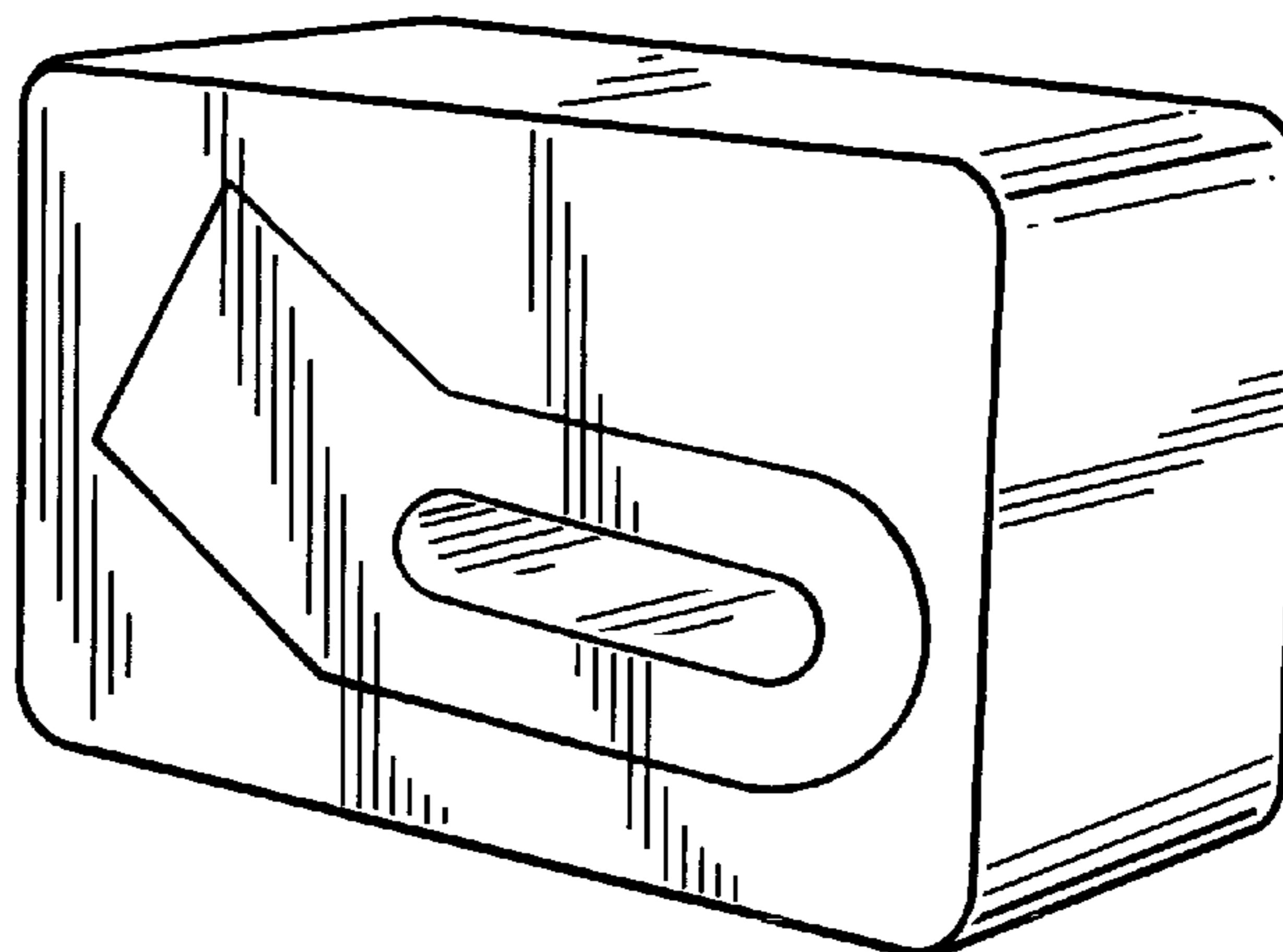
FIG. 4 is a rear view of the moving image cork packaging block;

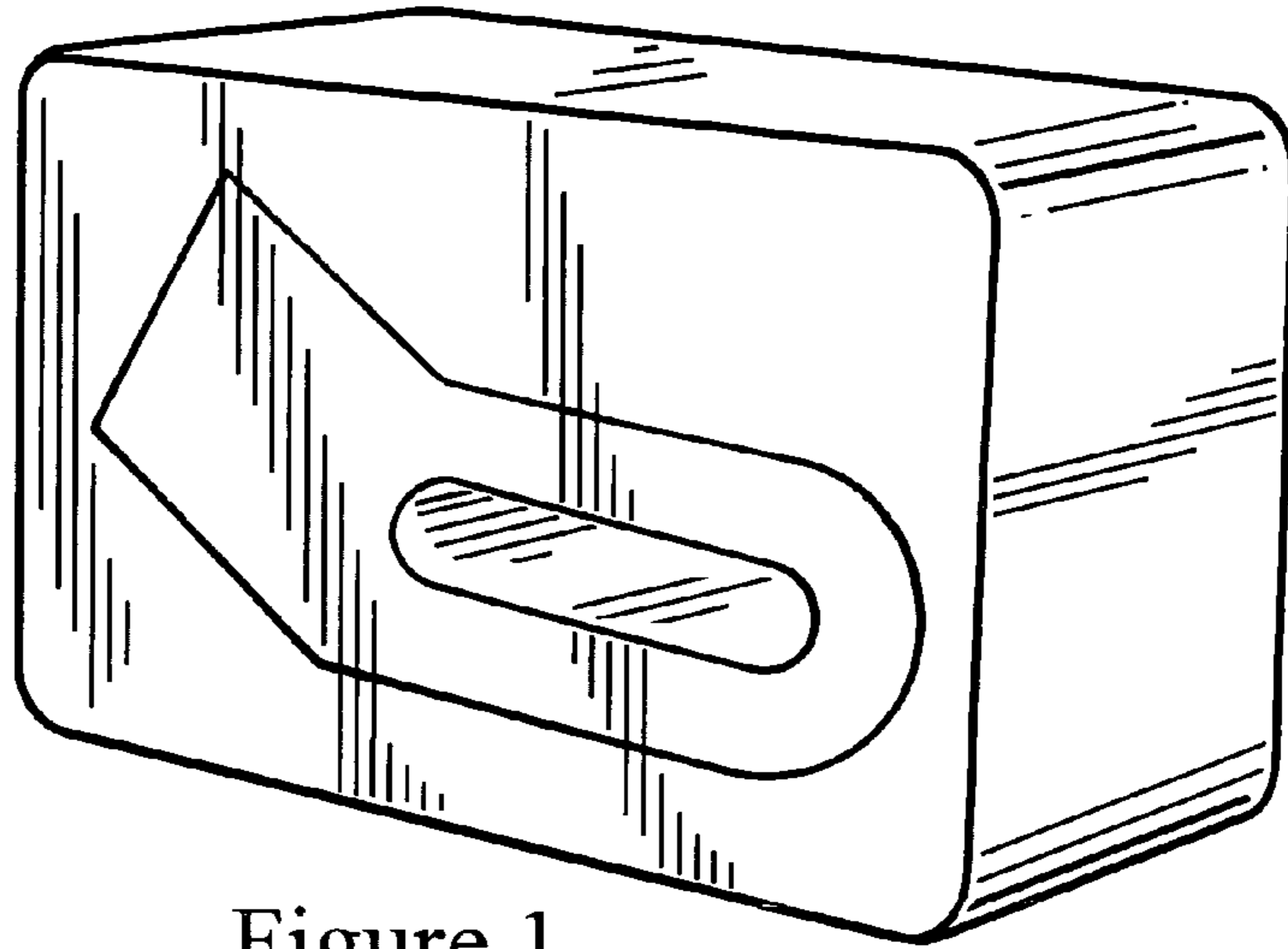

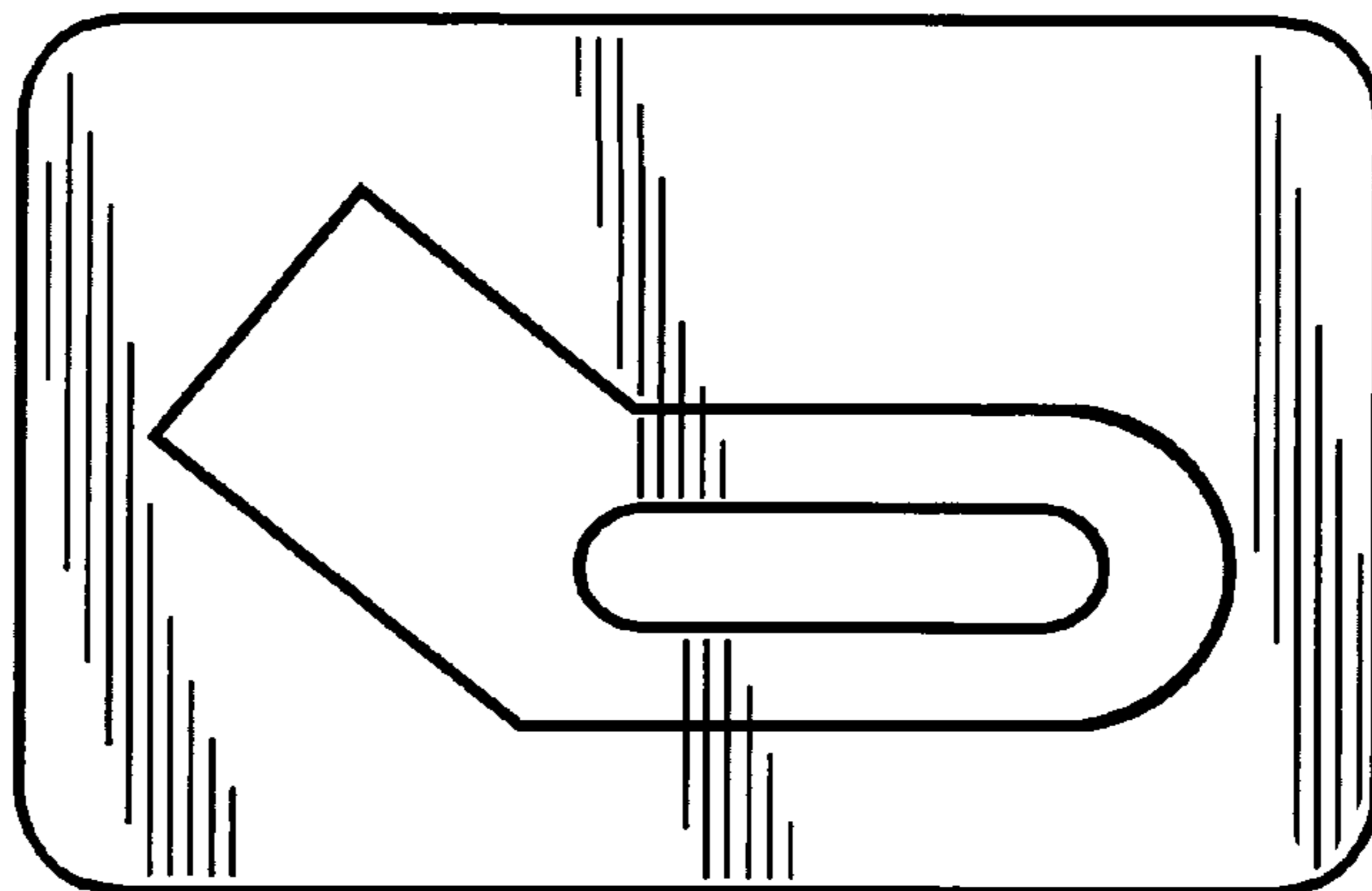

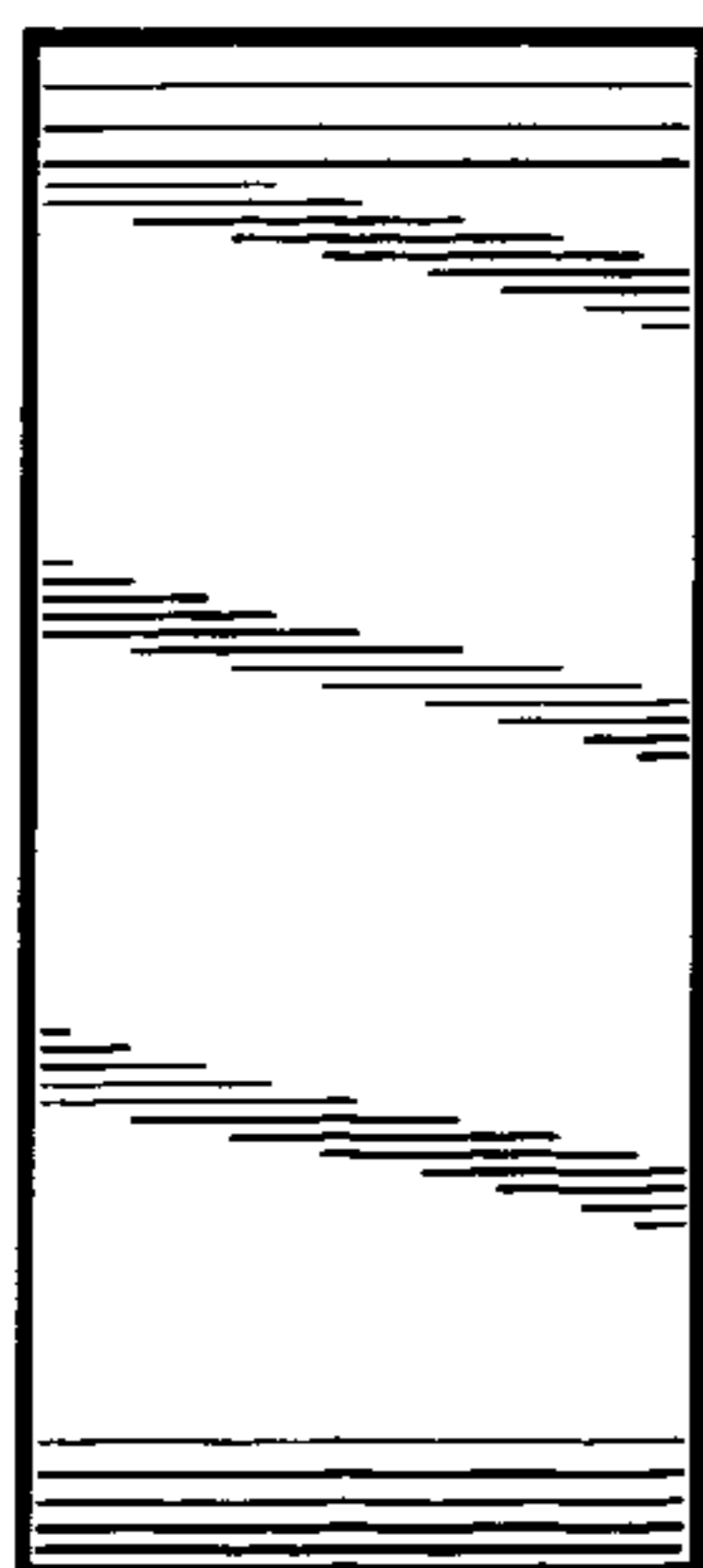

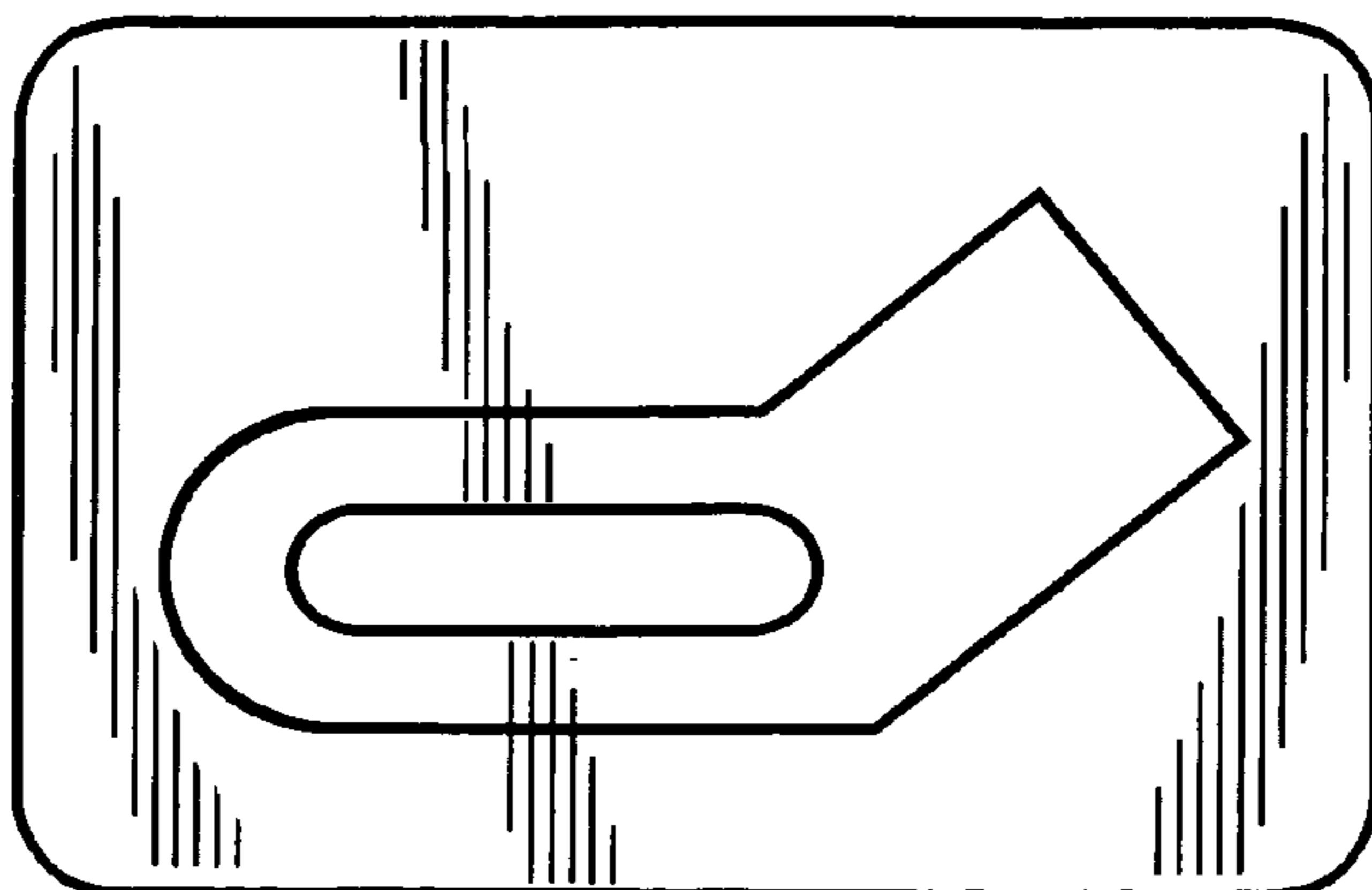

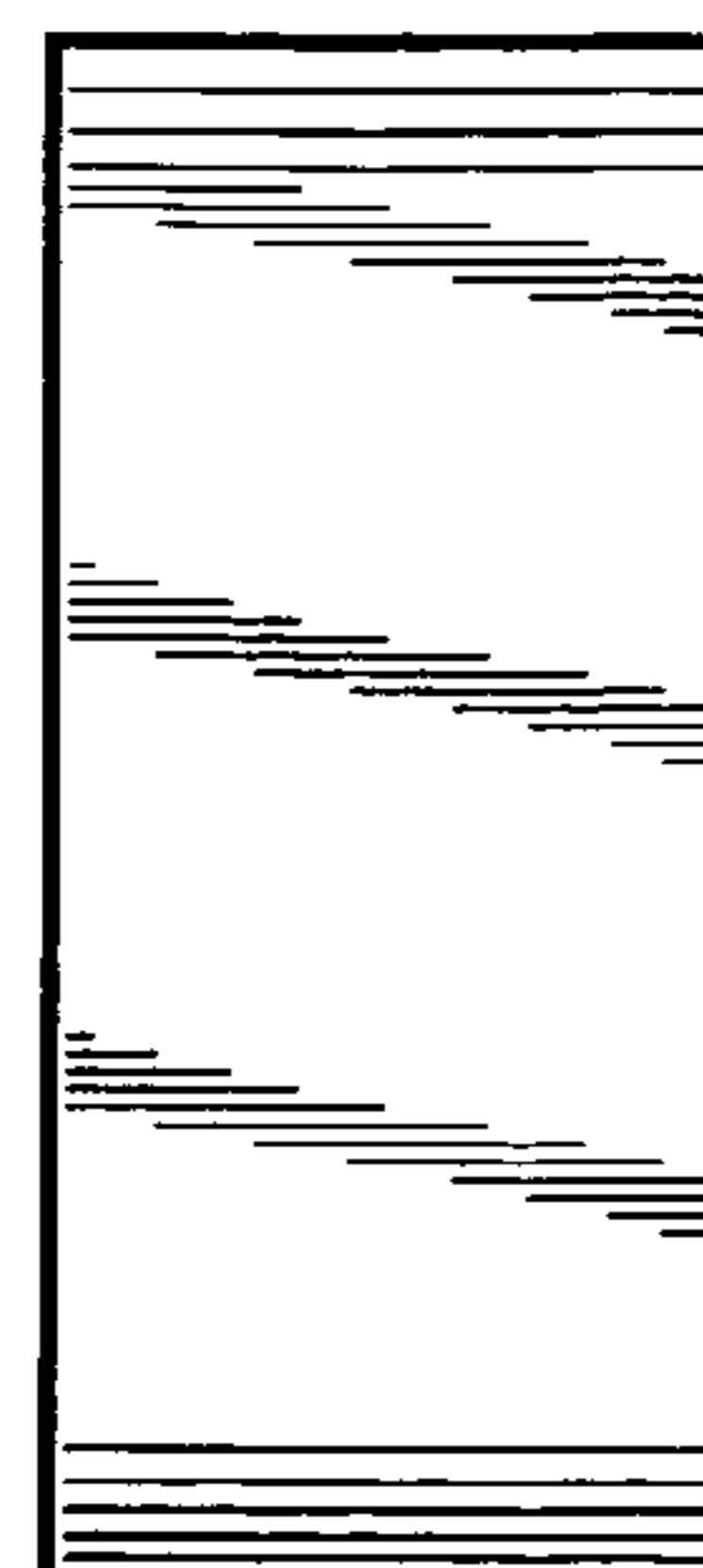

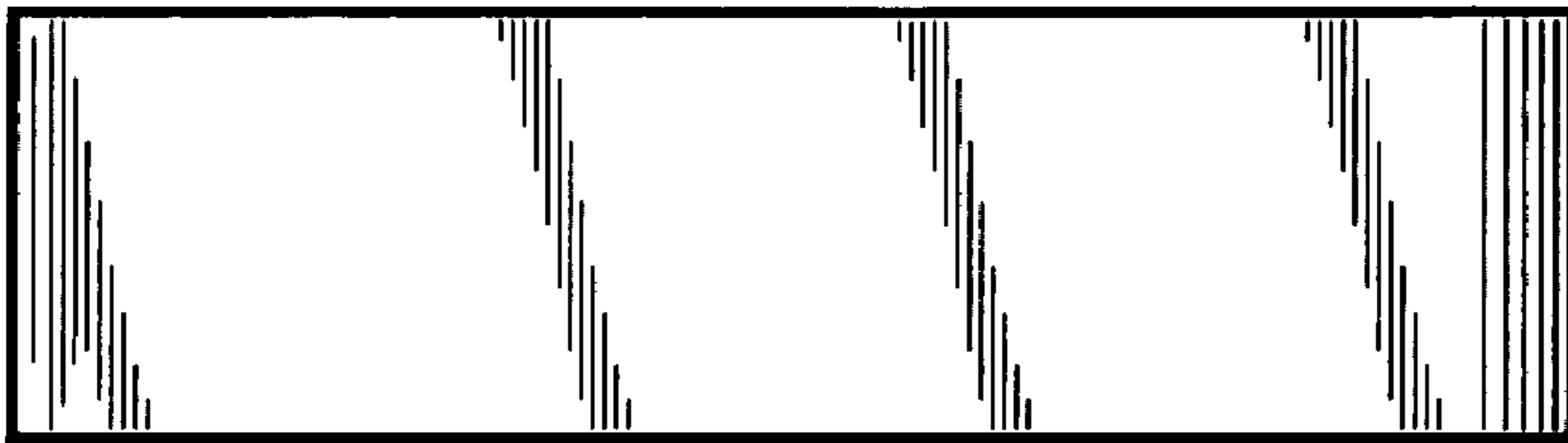

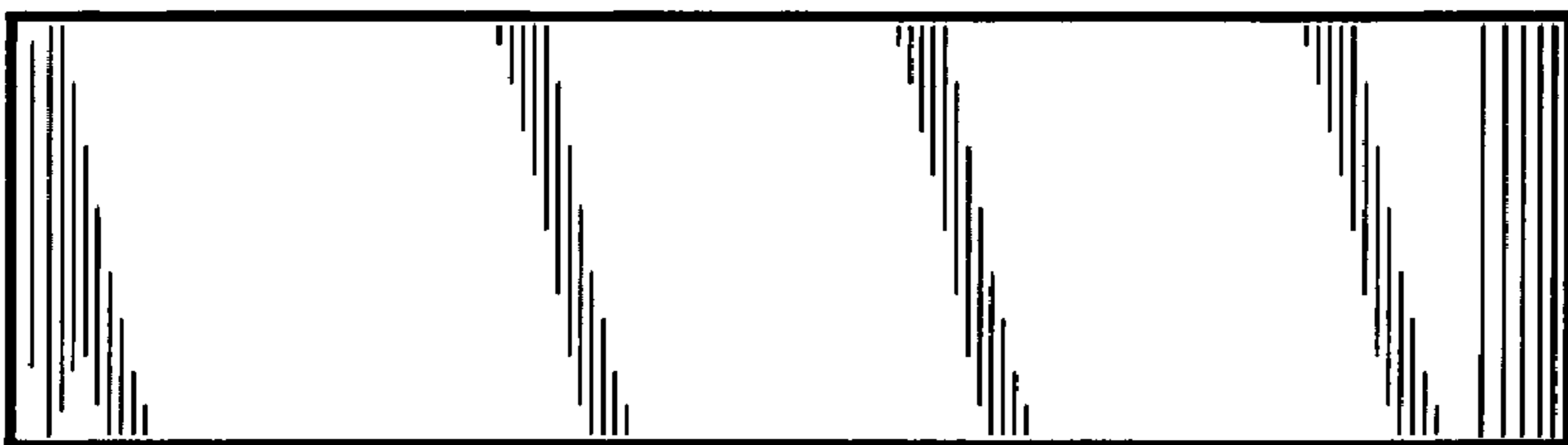
