The ornamental design for a nozzle with twist-off cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a nozzle with twist-off cap showing my new design;

FIG. 5 is a top view thereof;

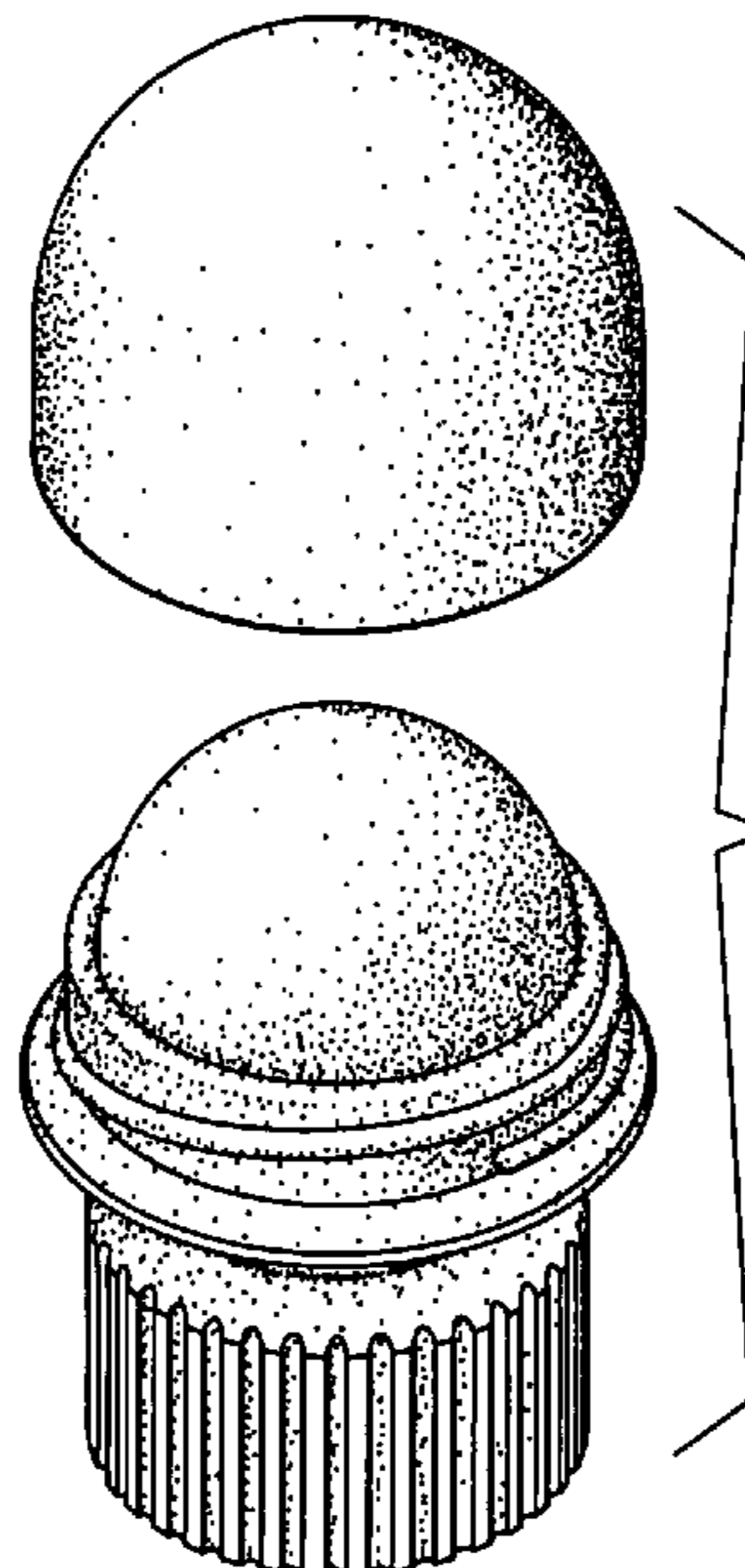
FIG. 6 is a bottom view thereof;

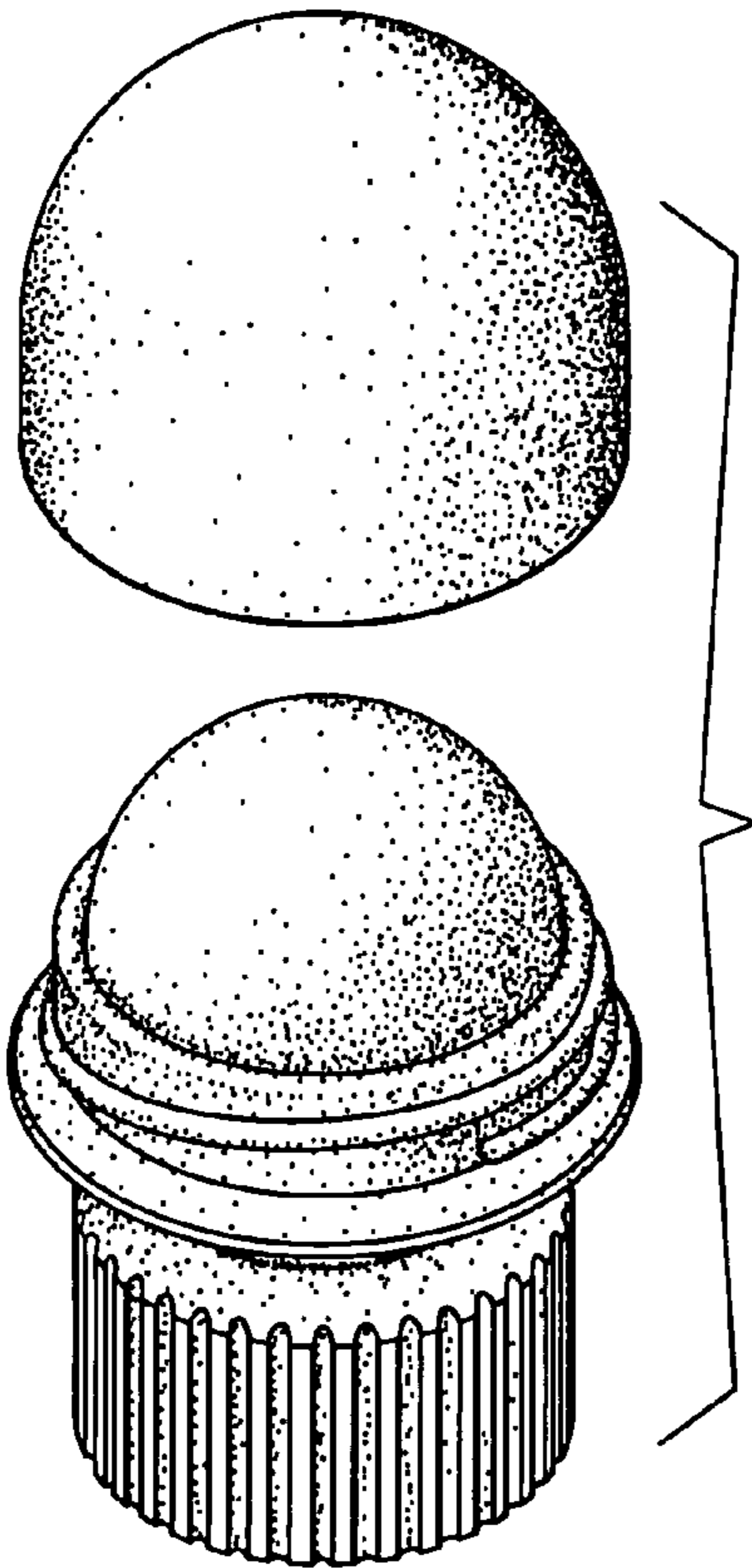

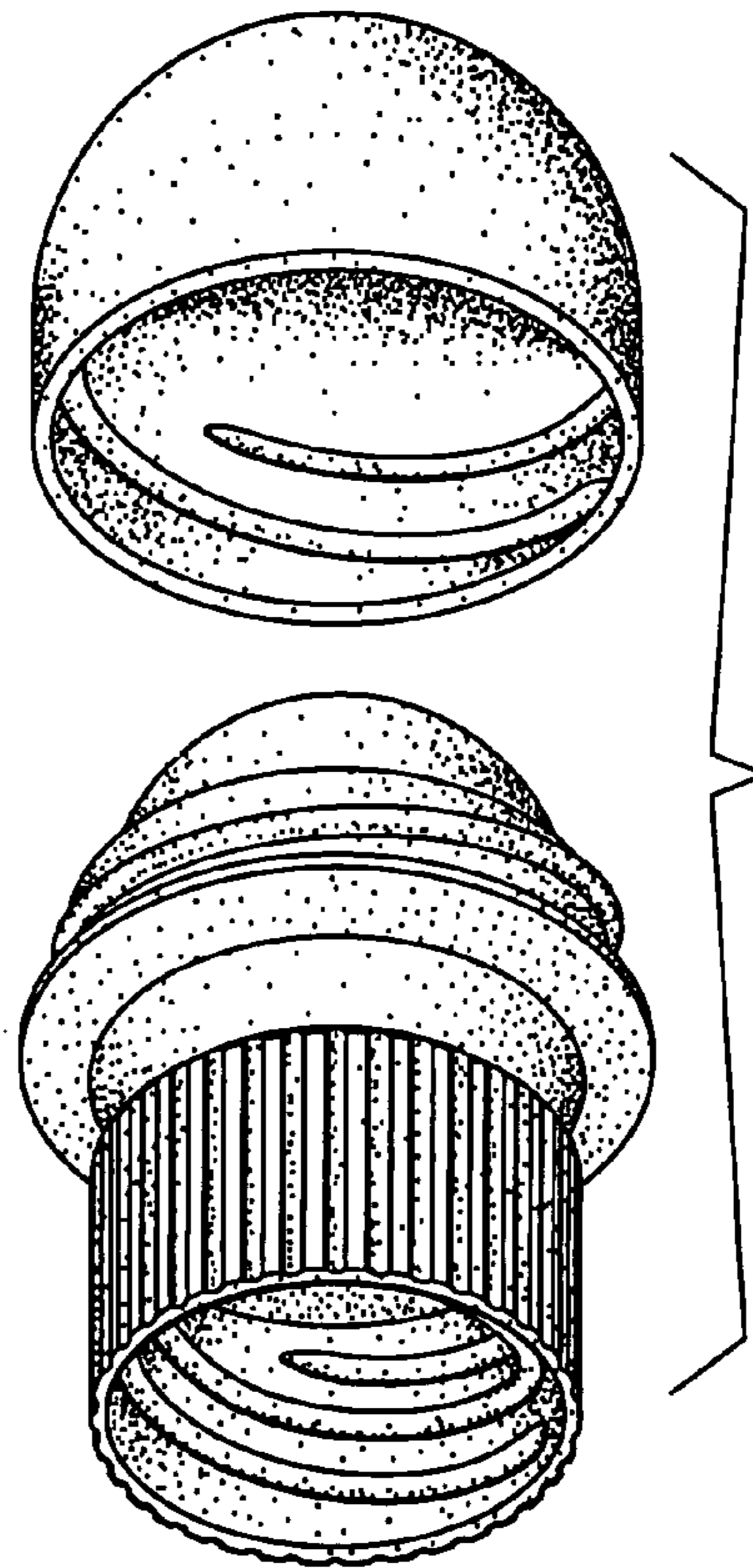

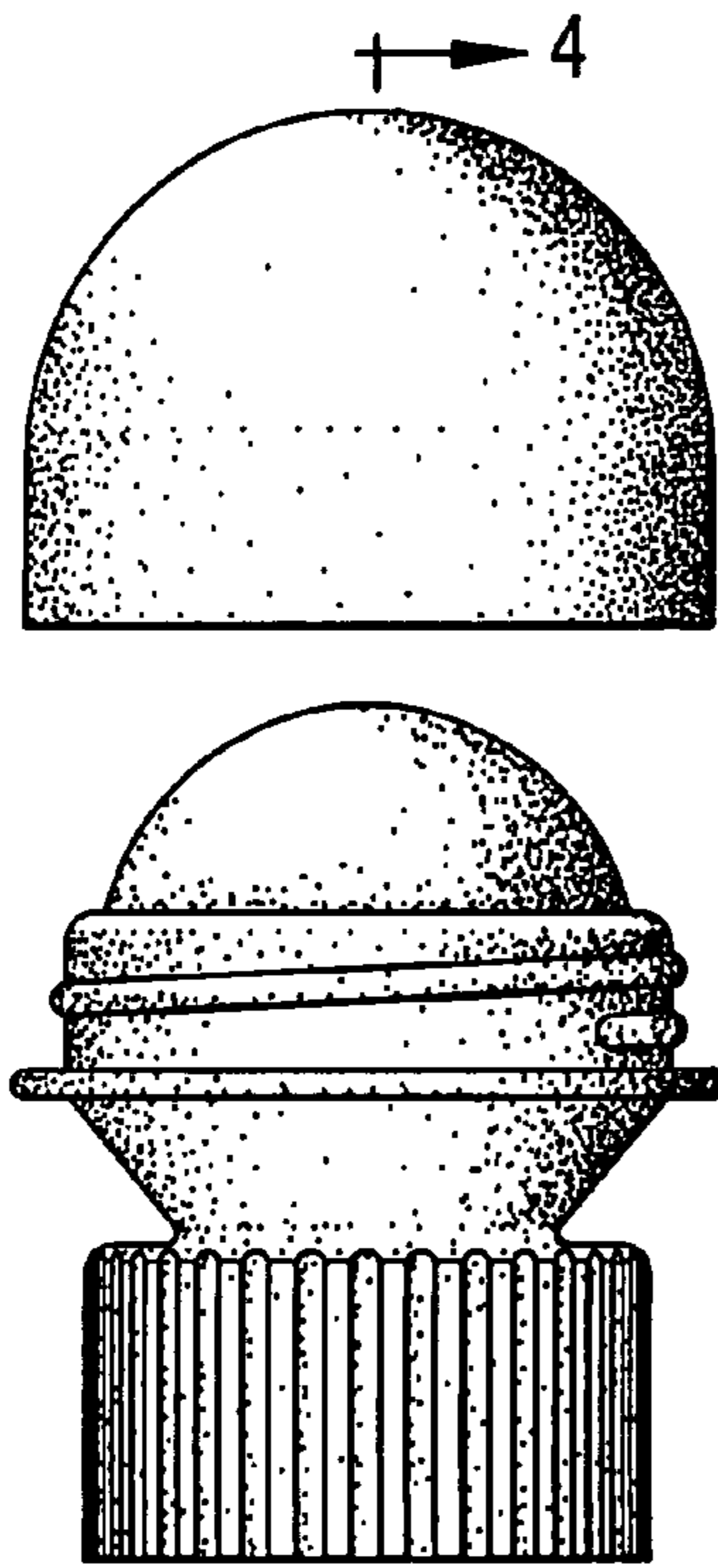

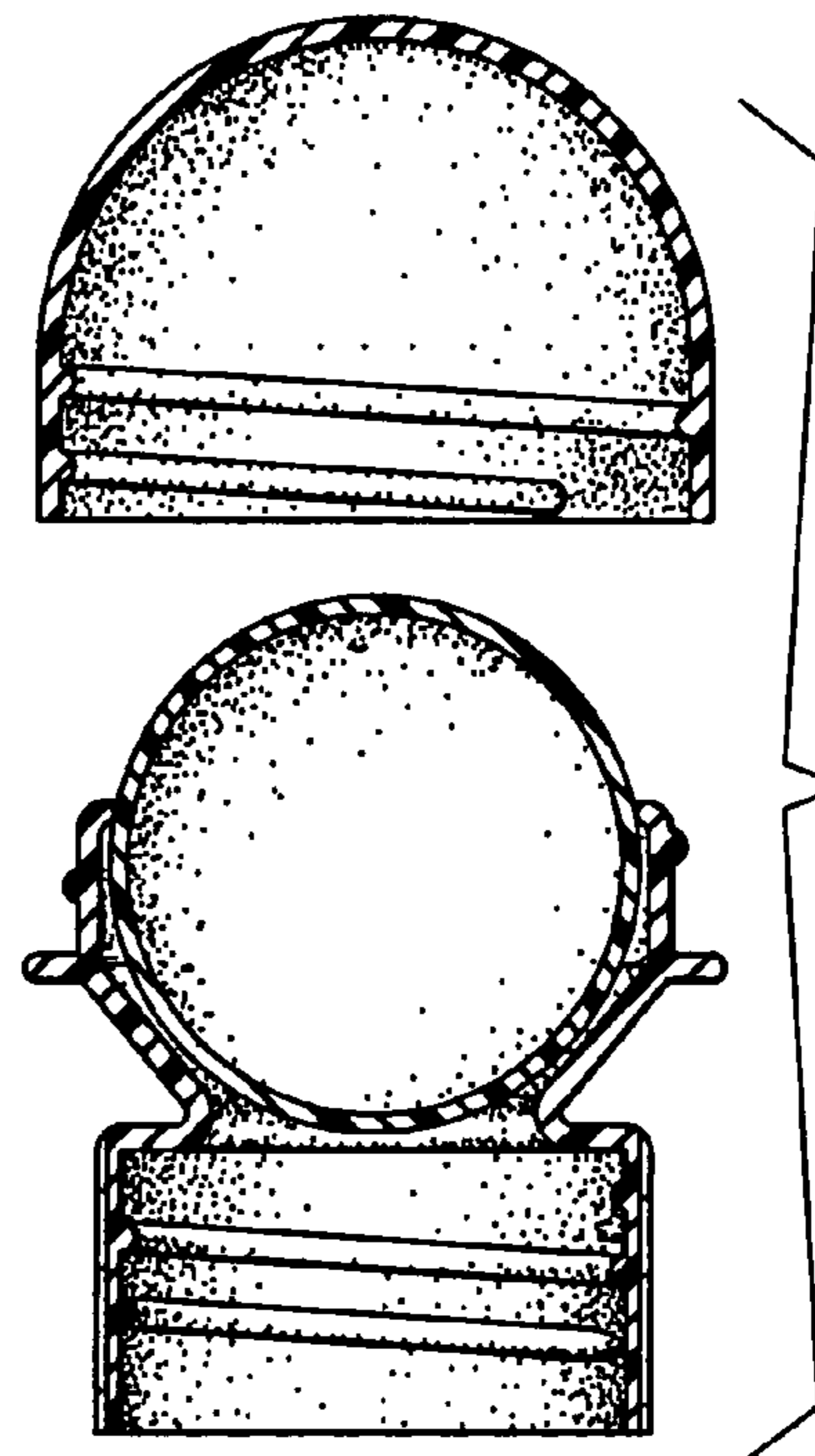

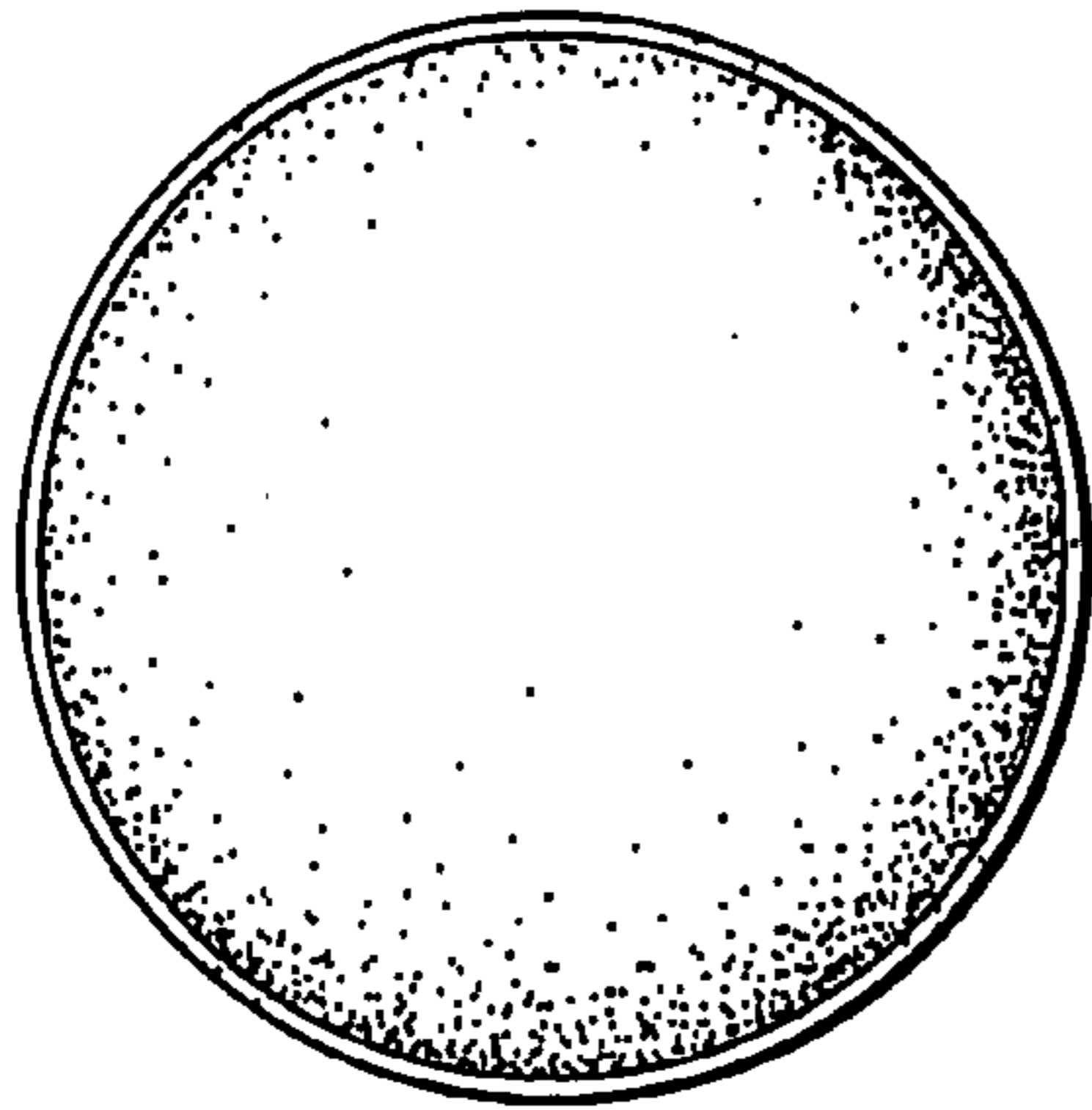

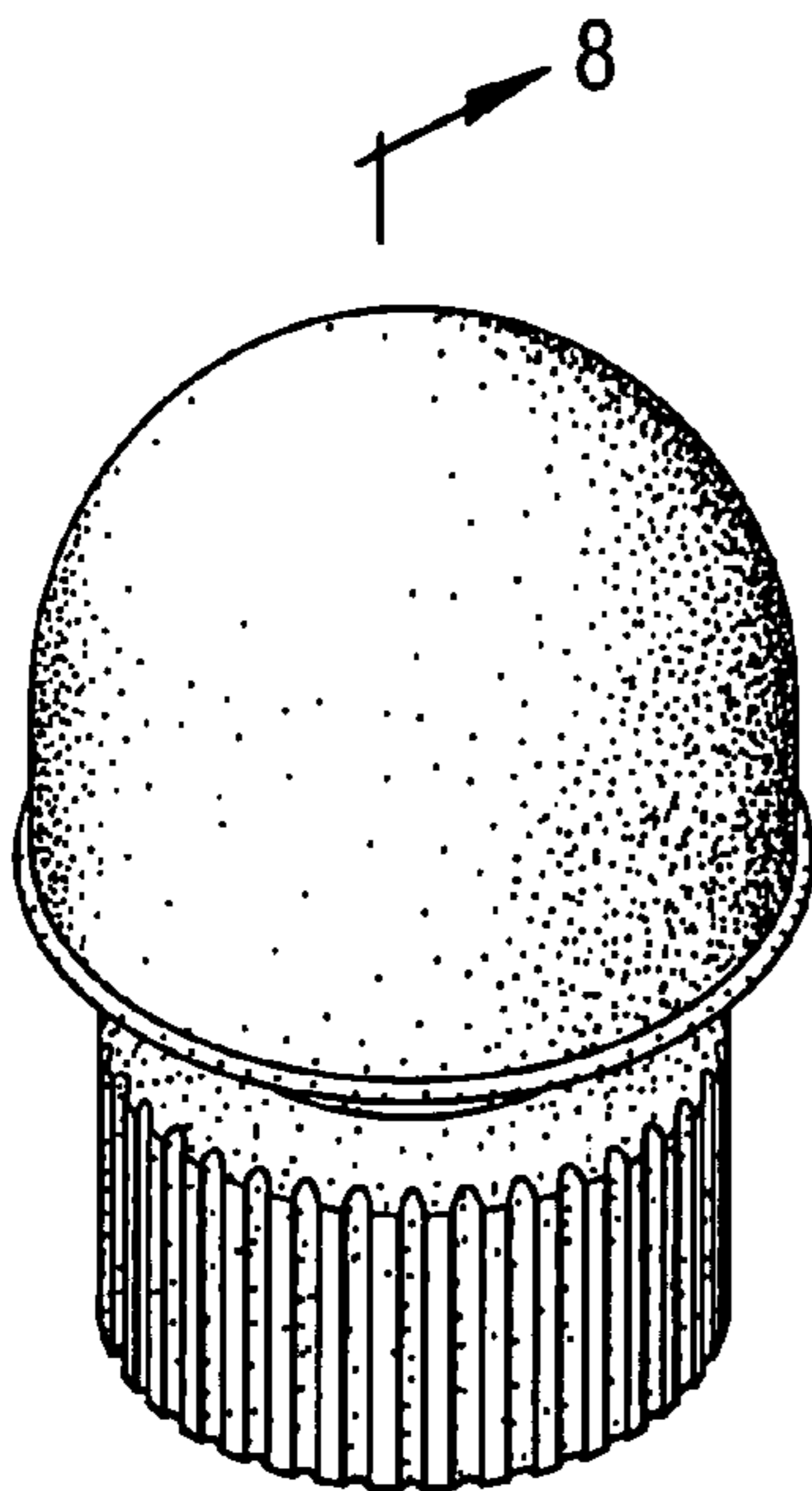
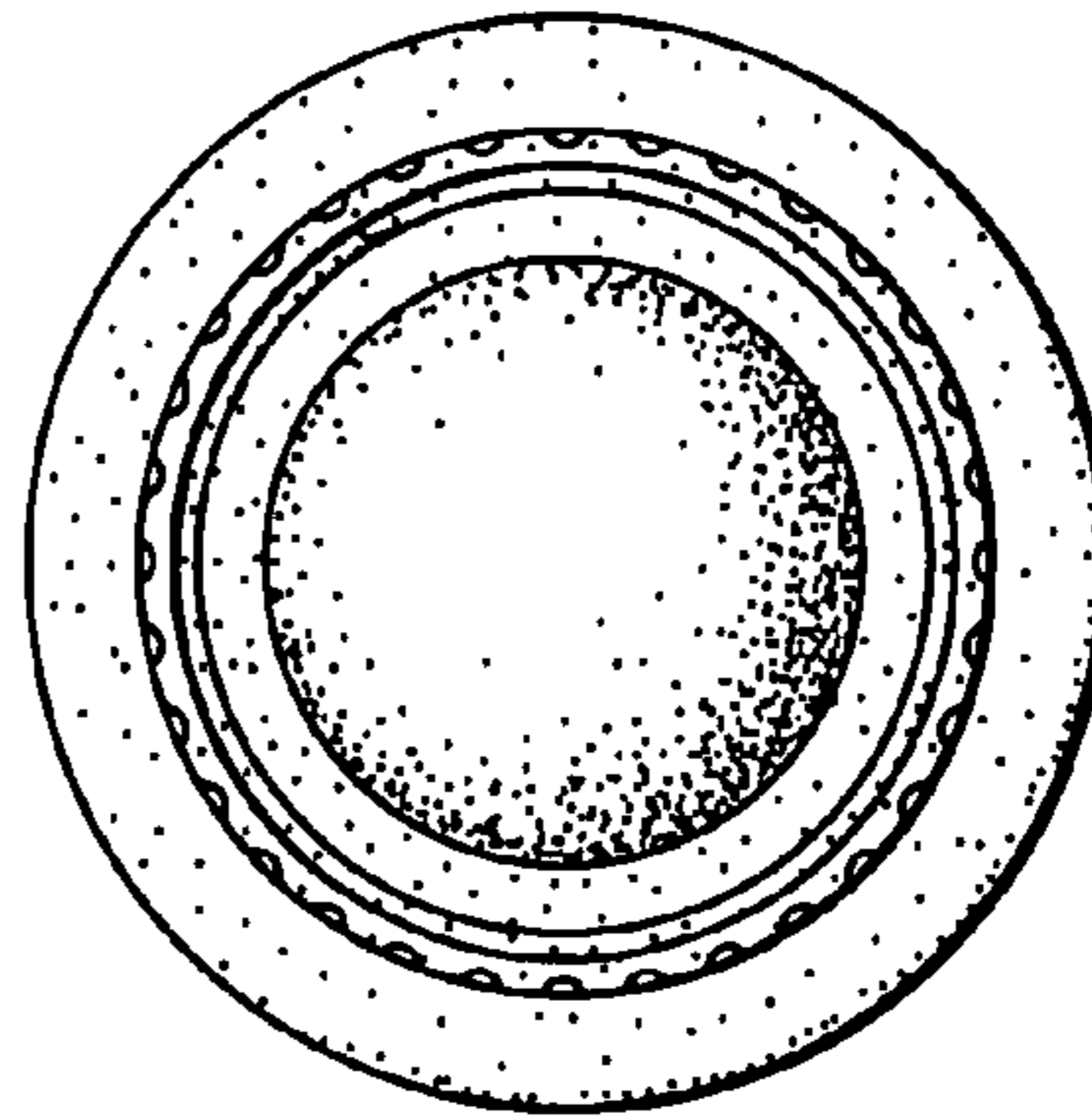

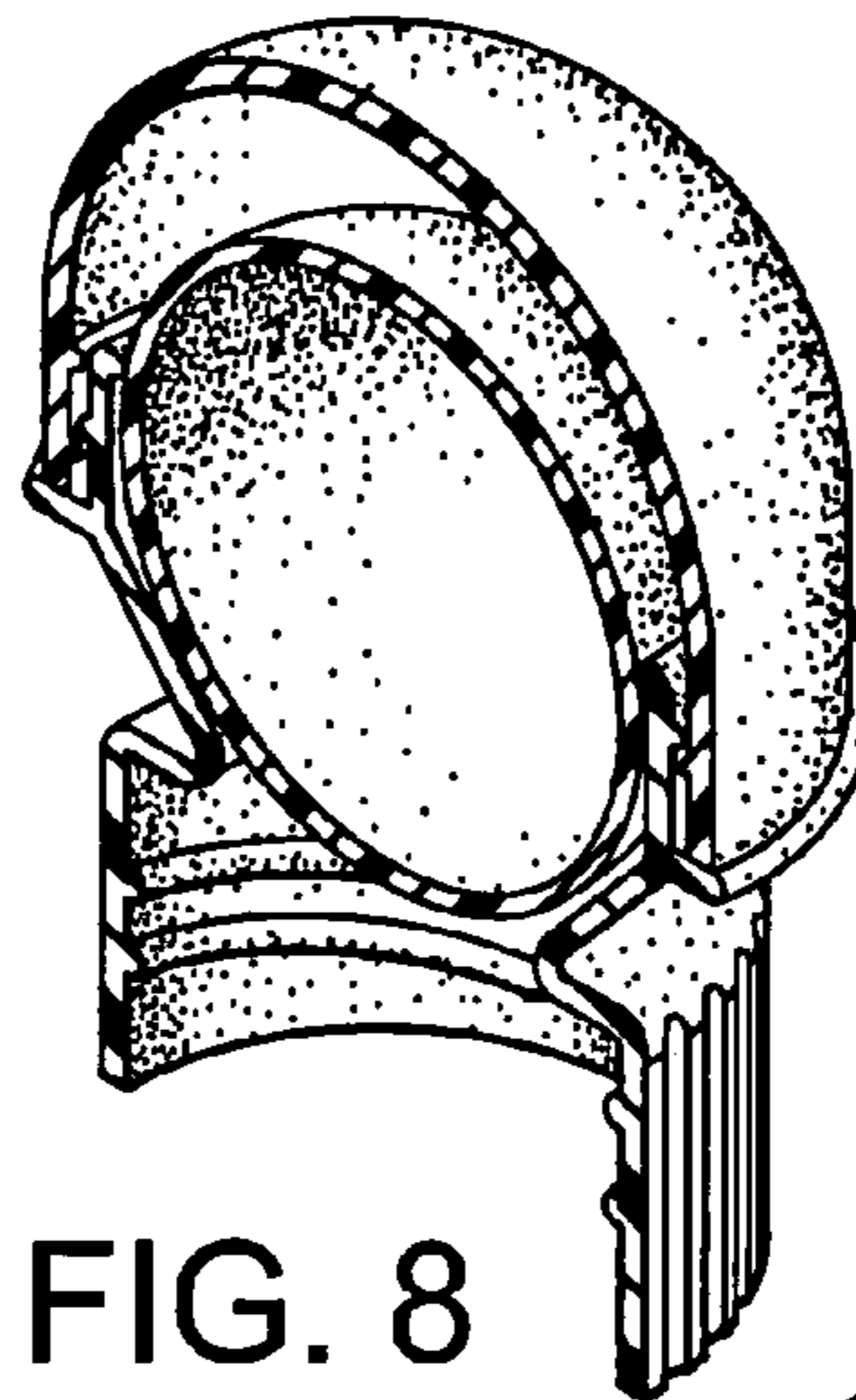

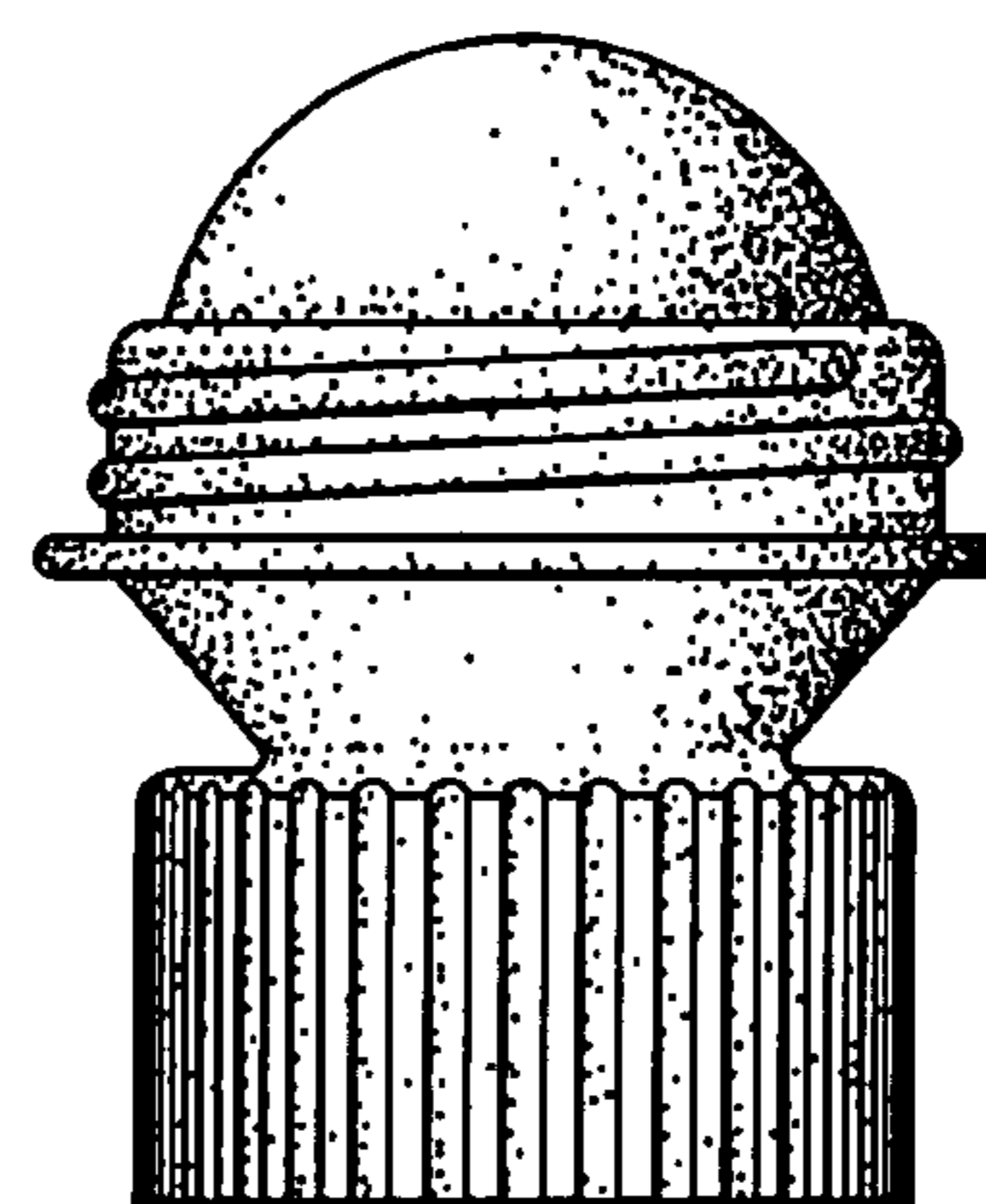
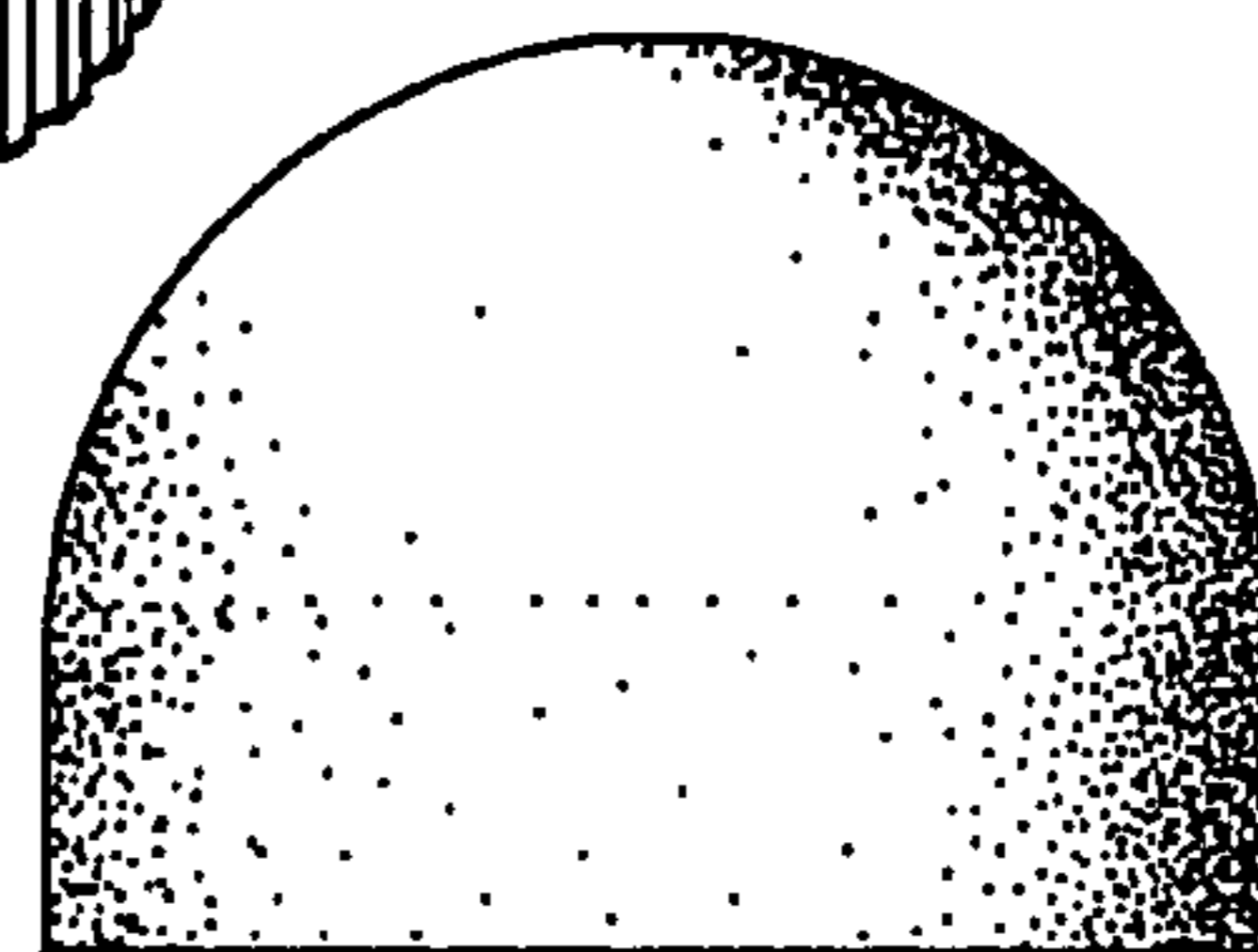
