The ornamental design for a dispensing closure, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of a dispensing closure embodying our new design;

FIG. 2 is a front elevation view of the dispensing closure shown in FIG. 1;

FIG. 3 is a rear elevation view of the dispensing closure shown in FIG. 1;

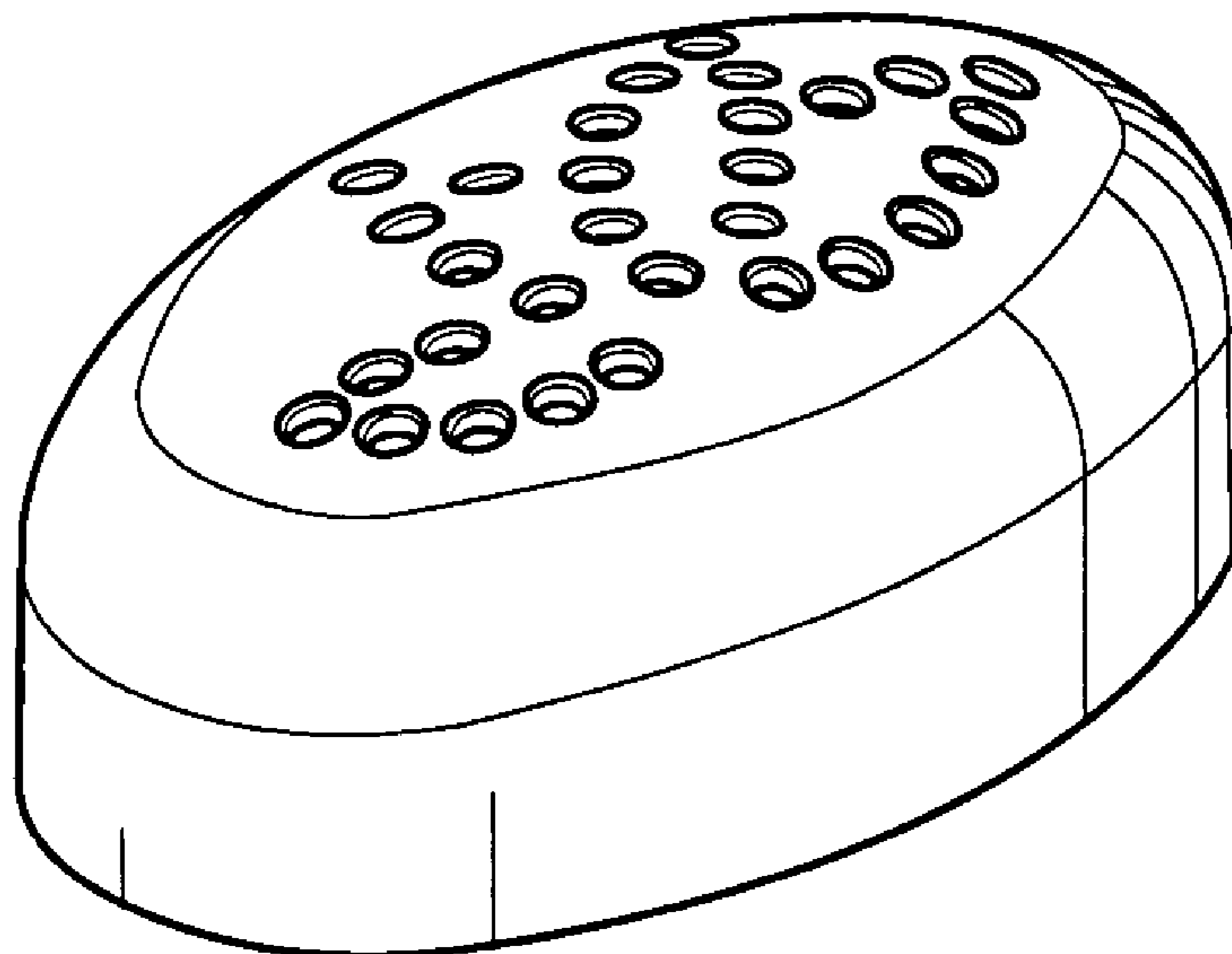
FIG. 4 is a left side elevation view of the dispensing closure shown in FIG. 1;

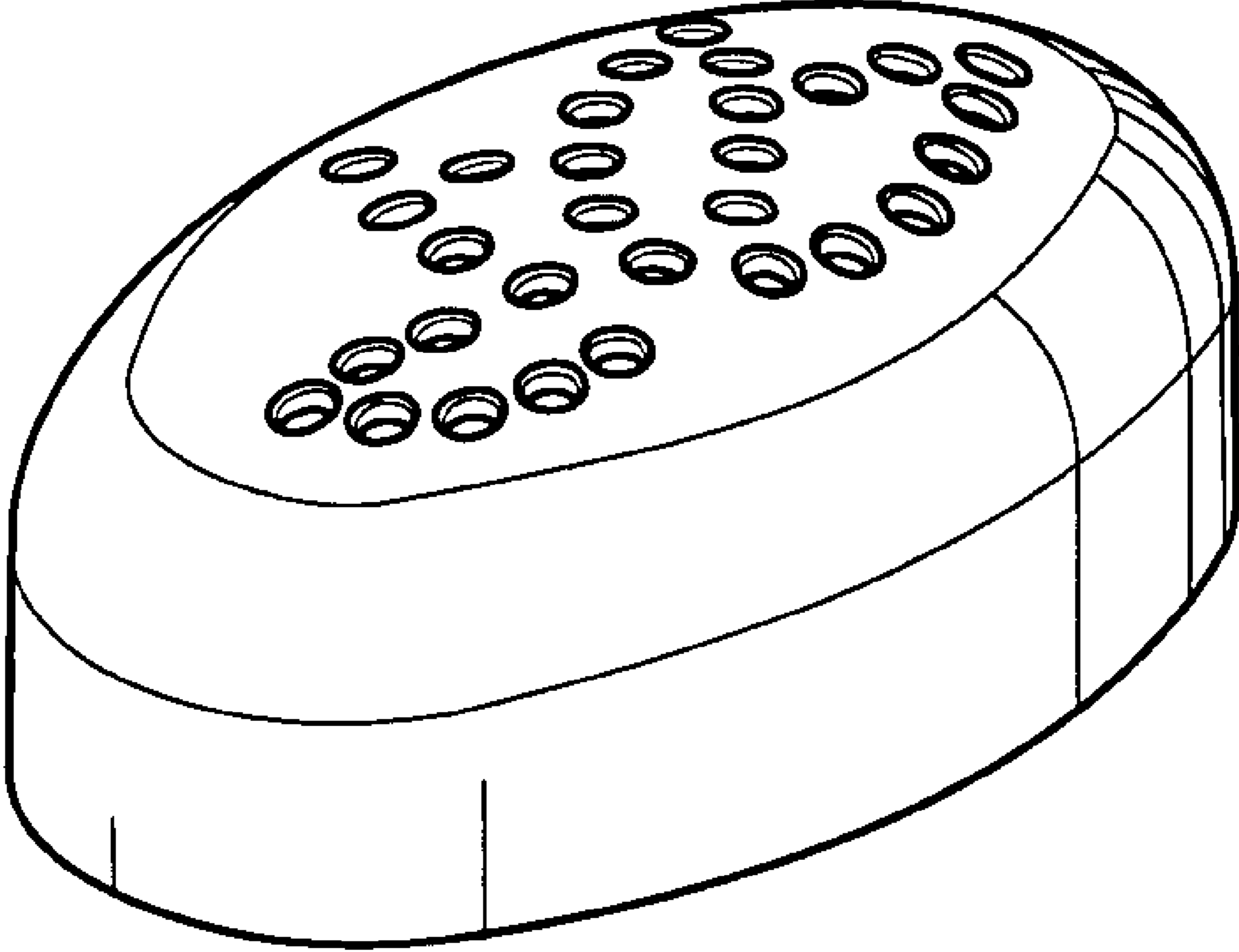

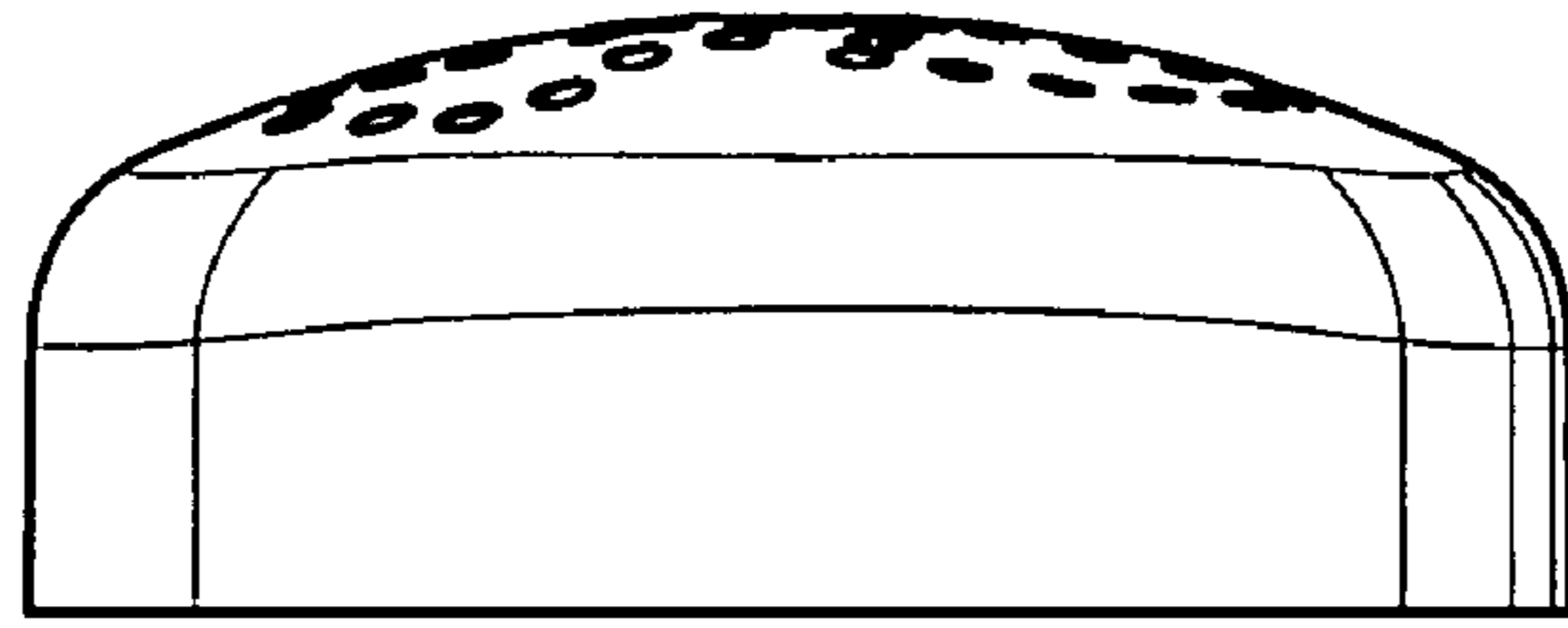

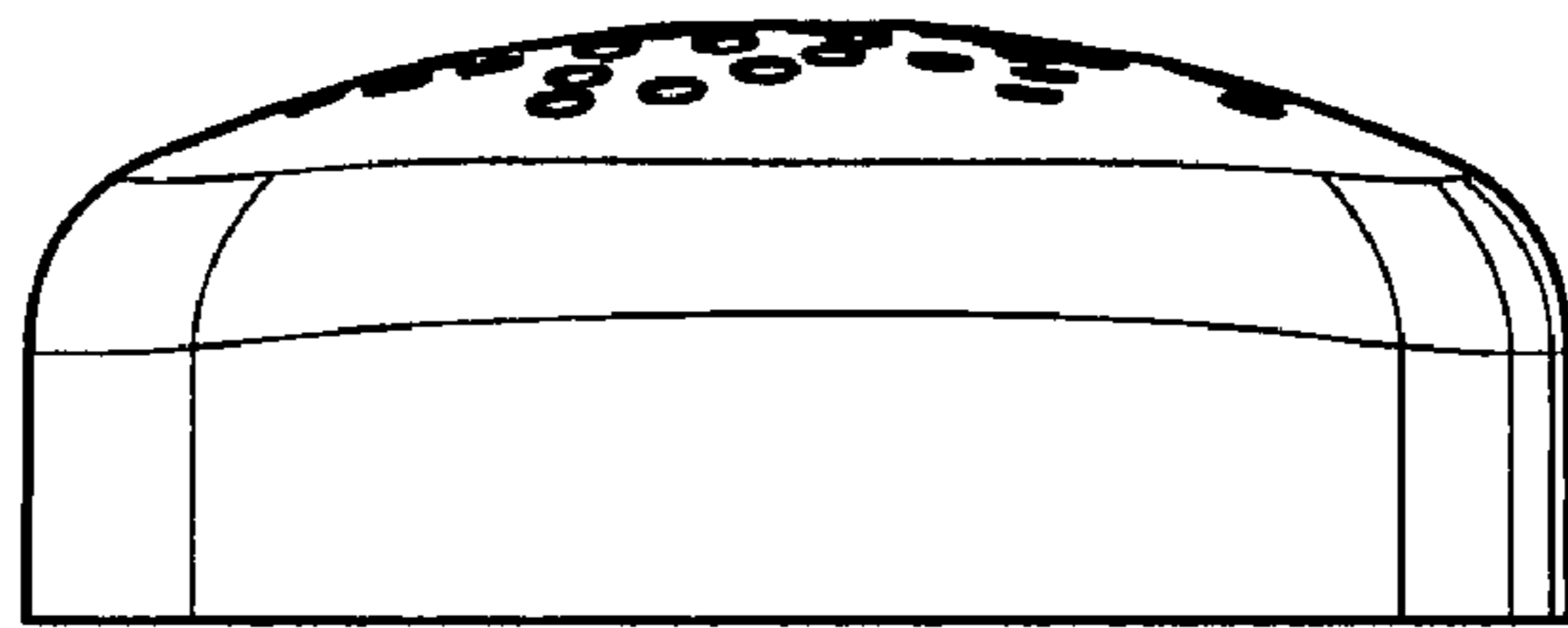

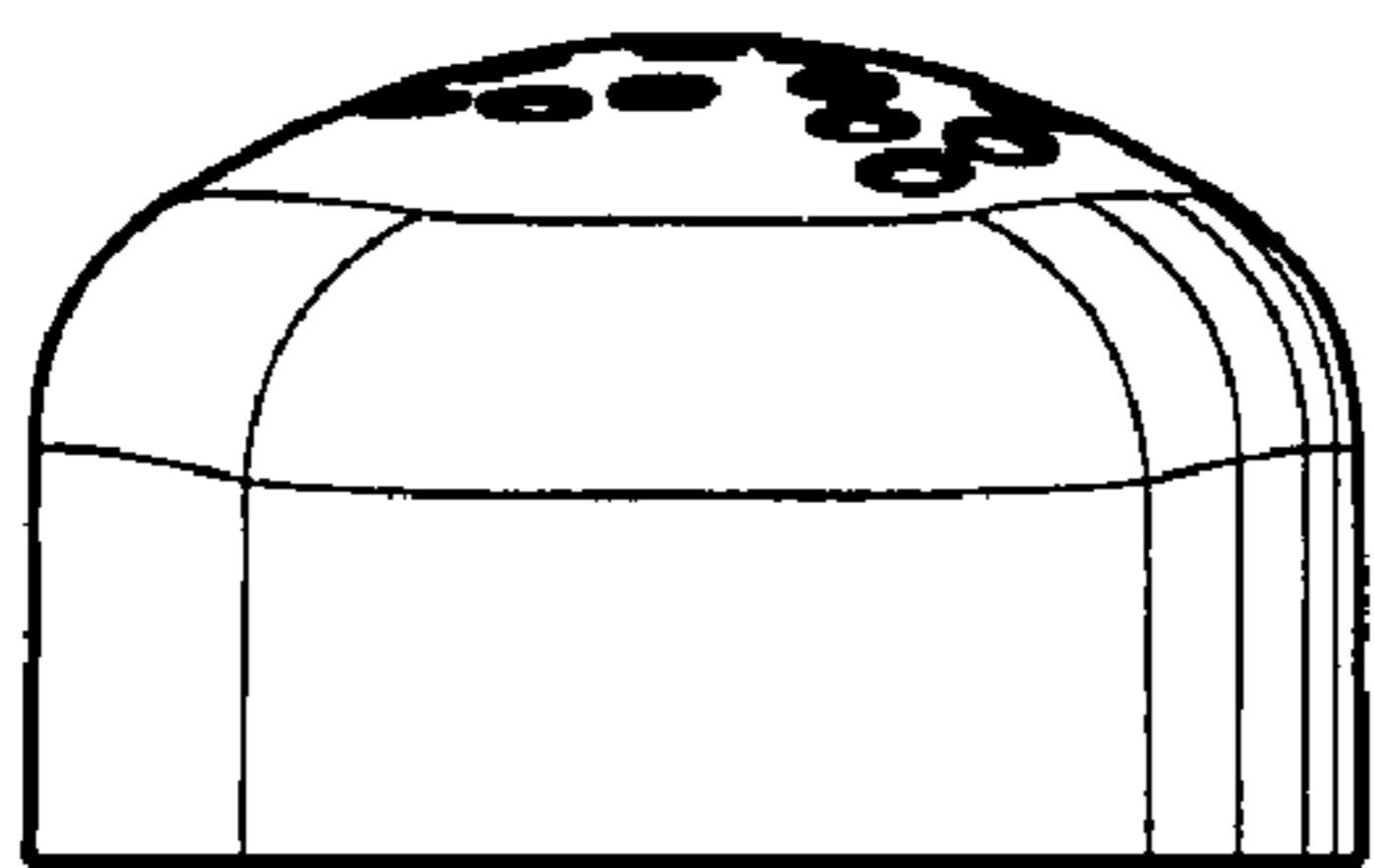

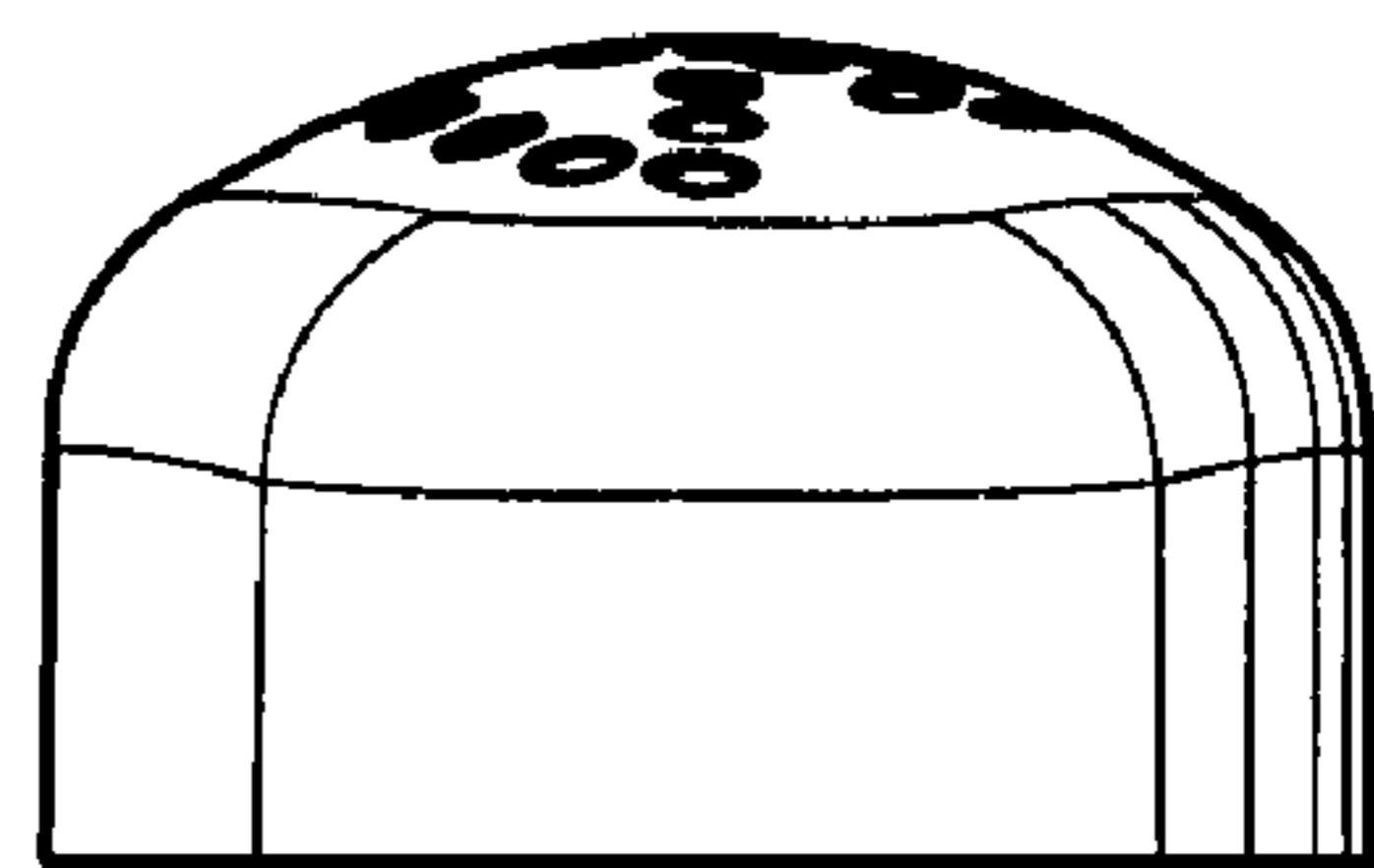

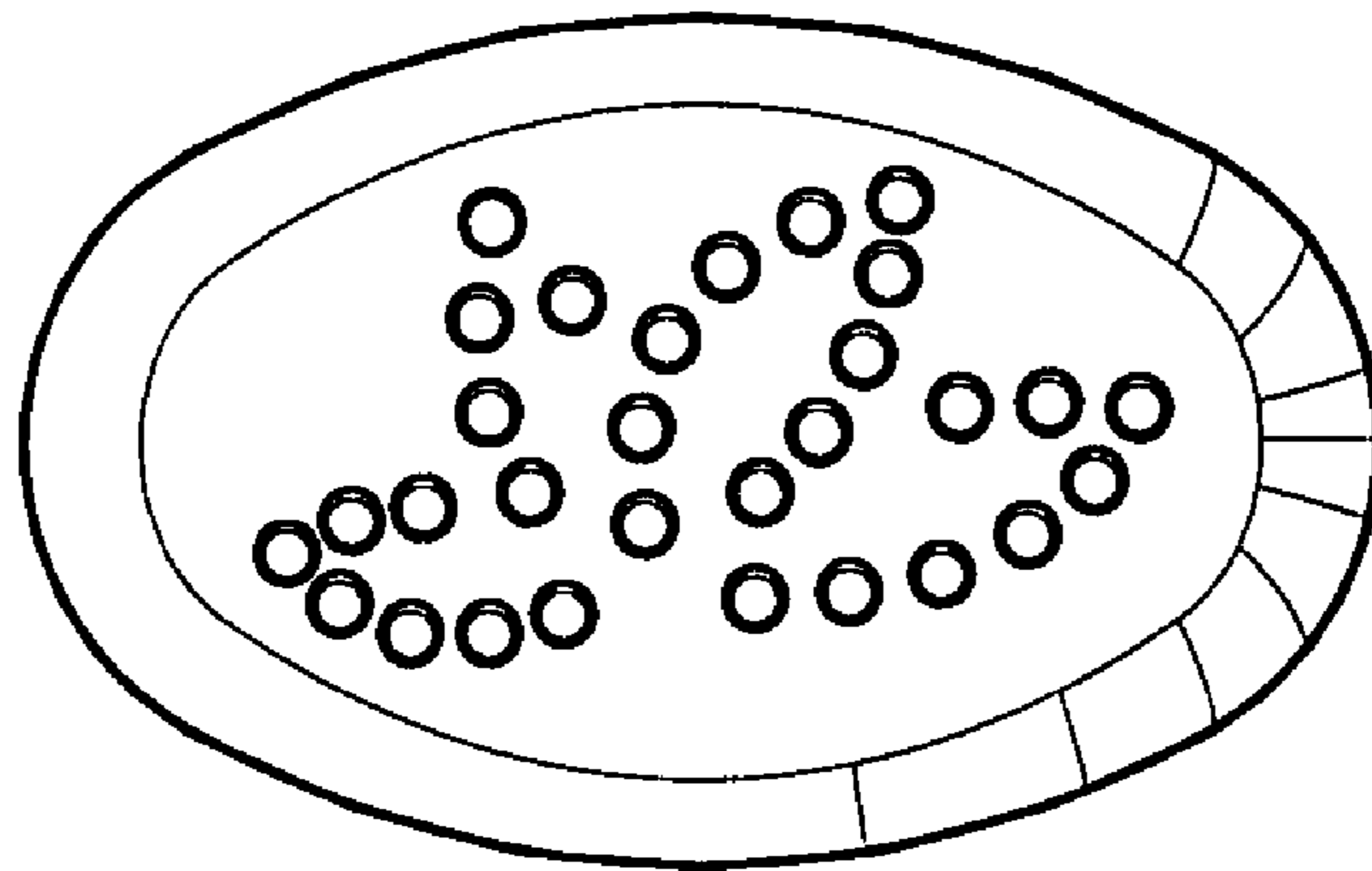

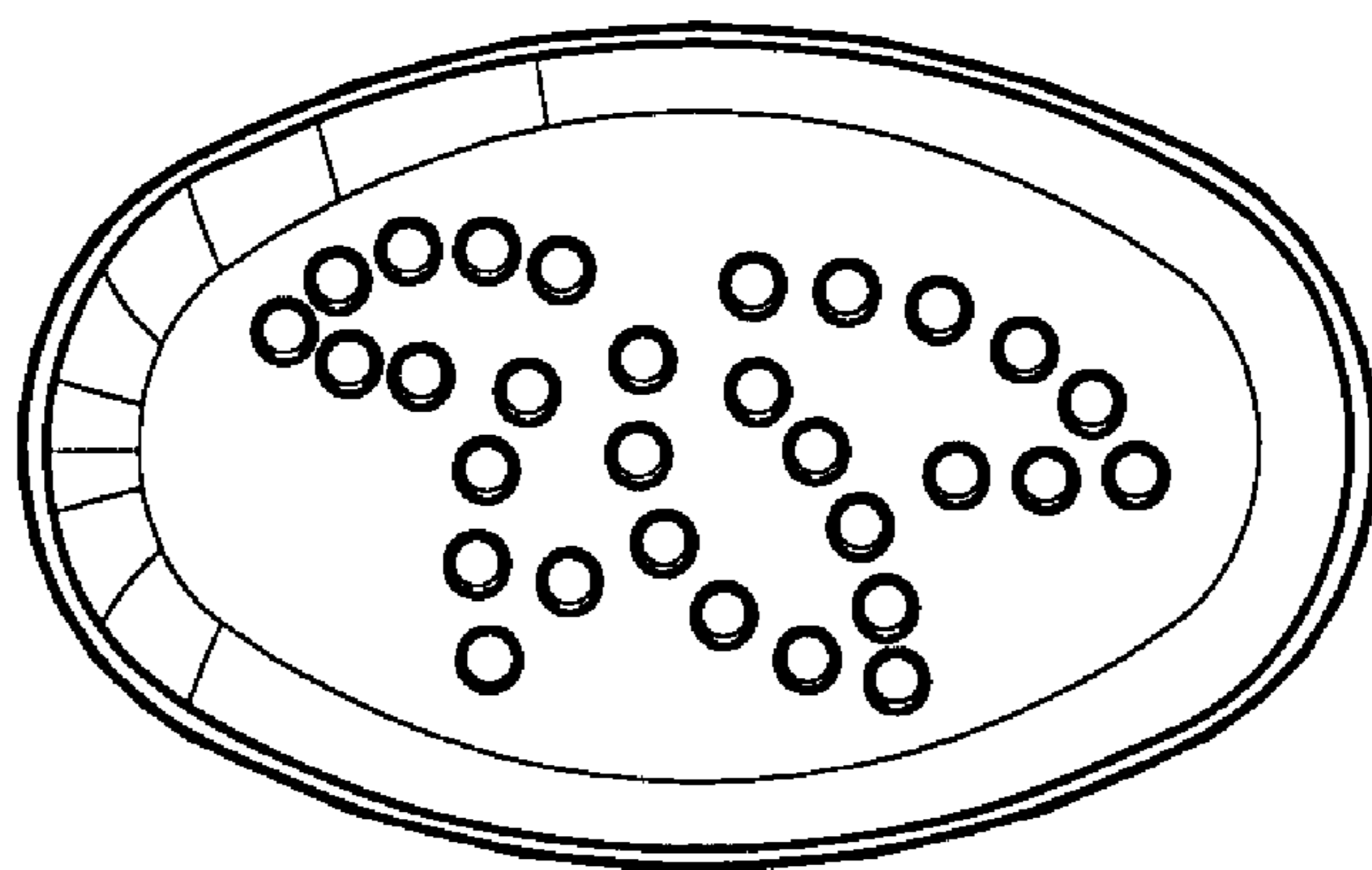
