FIG. 3 is a bottom view of the watch.

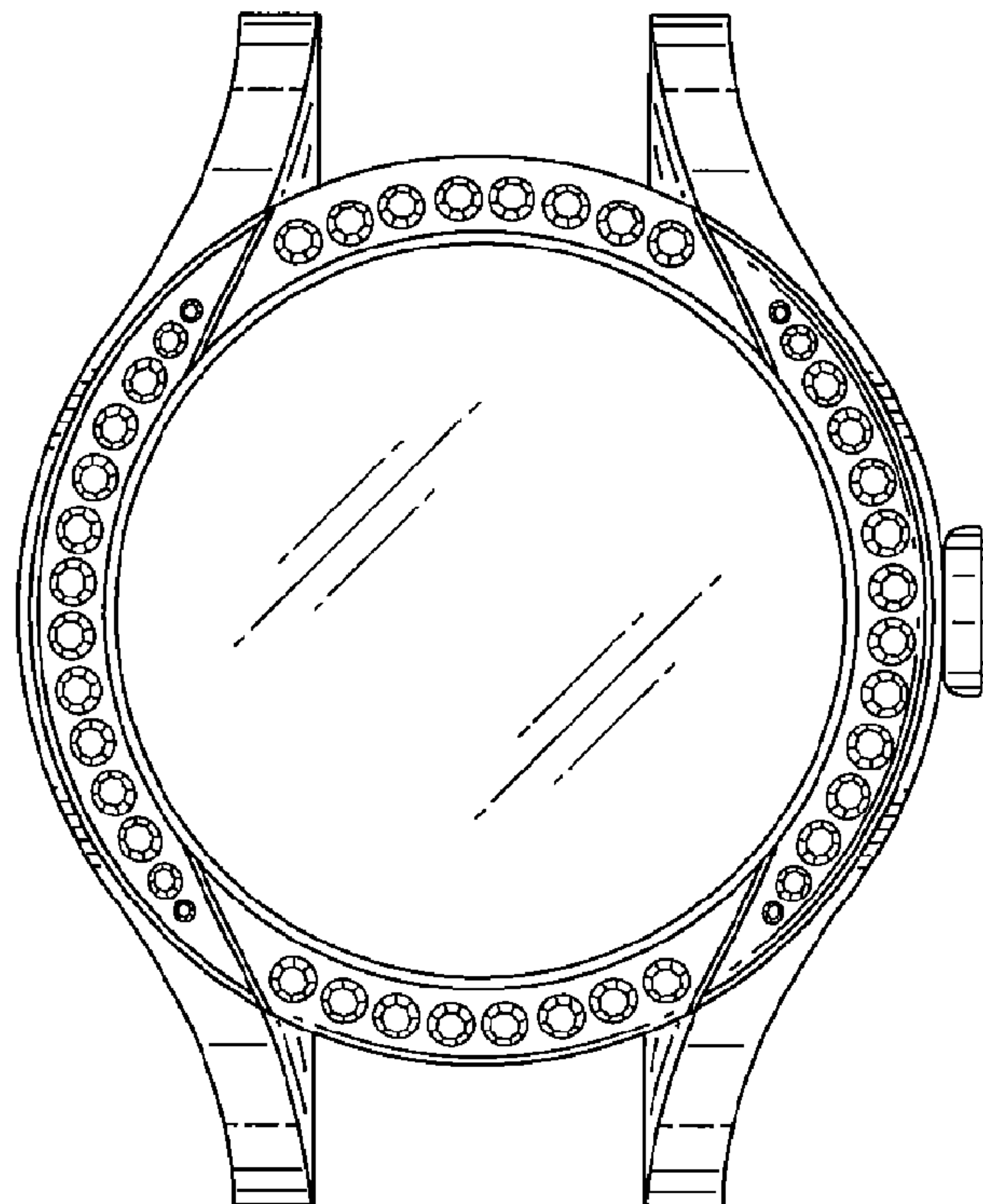
FIG. 4 is a front view of the watch.

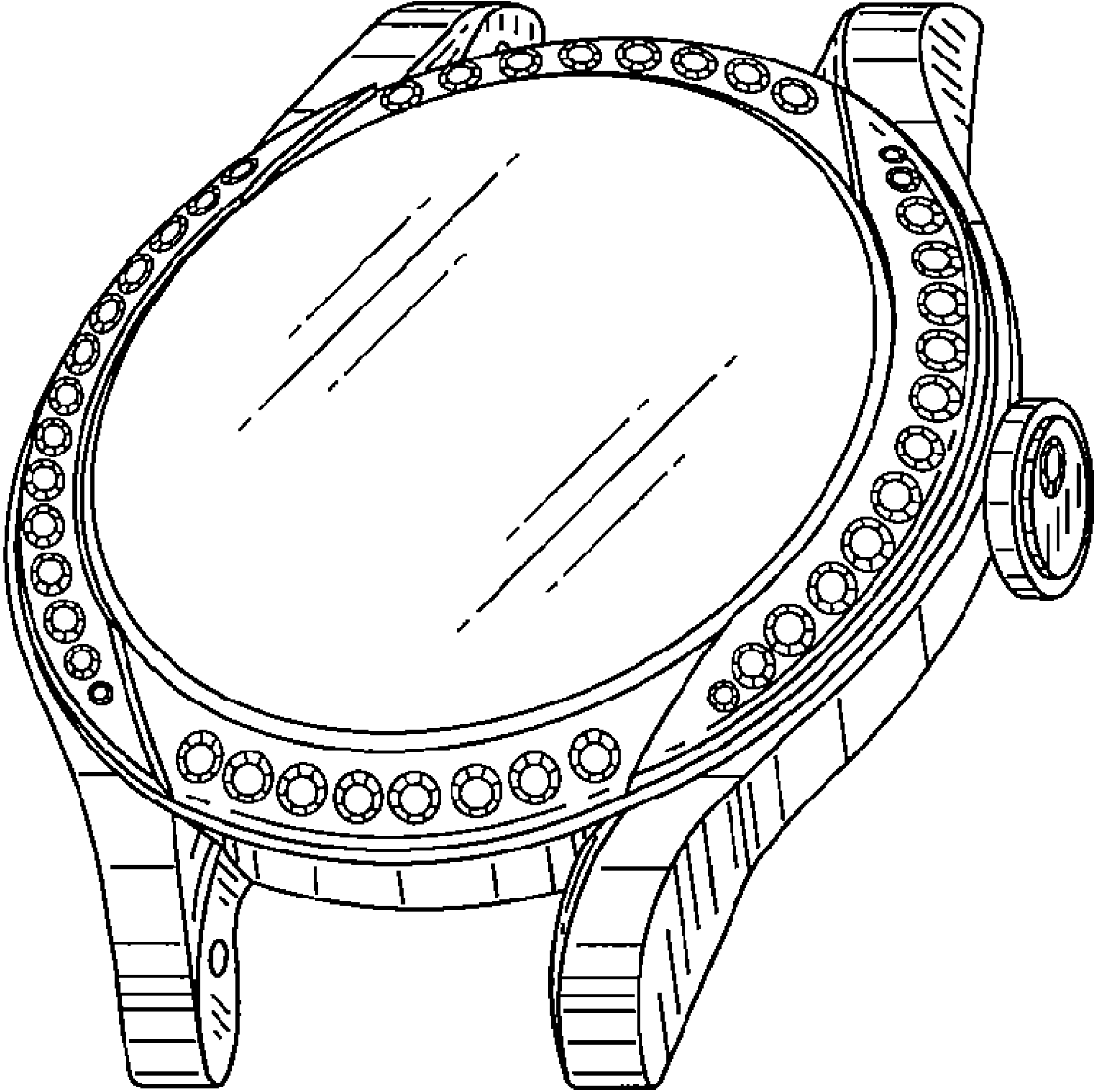
FIG. 5 is a back view of the watch.

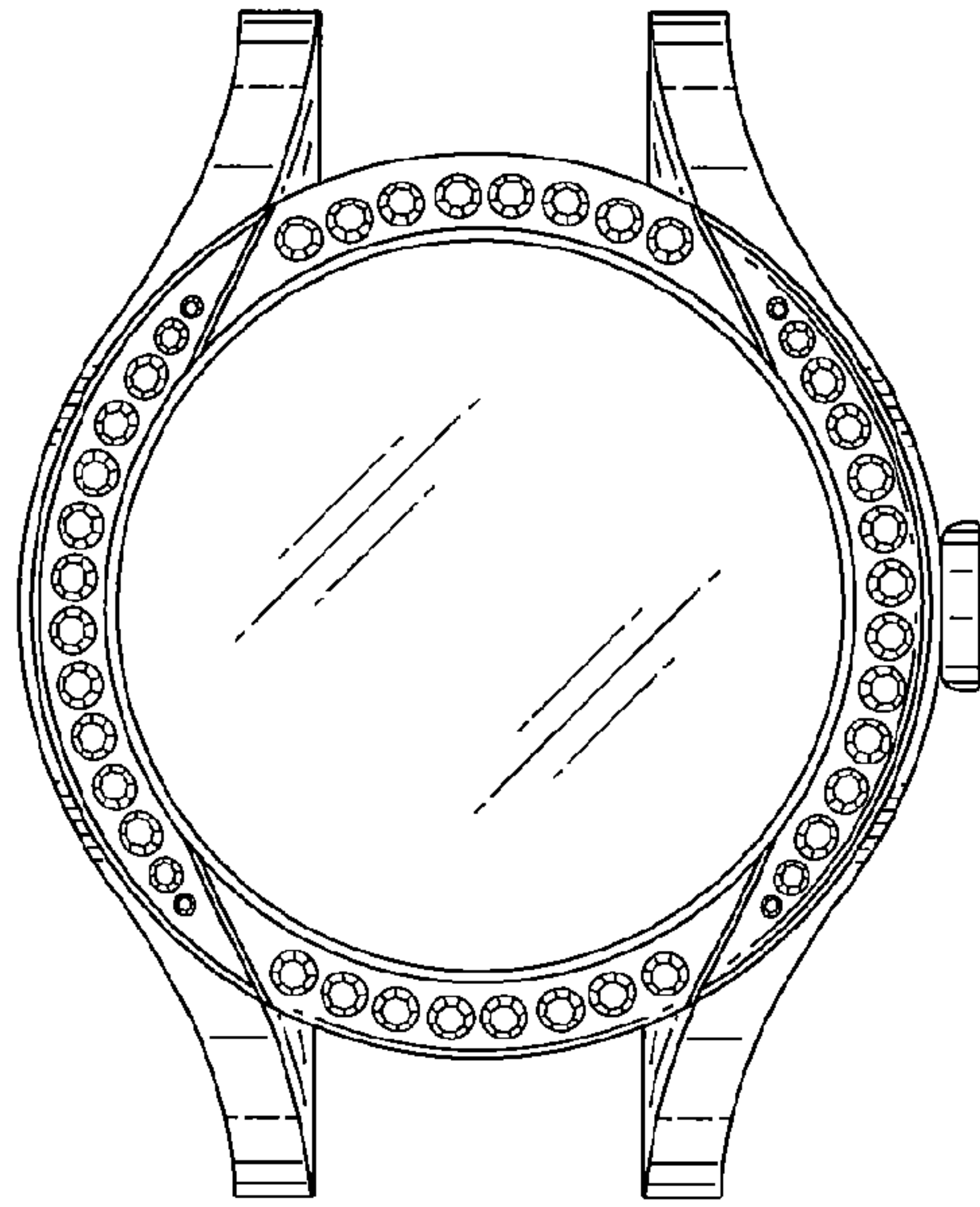

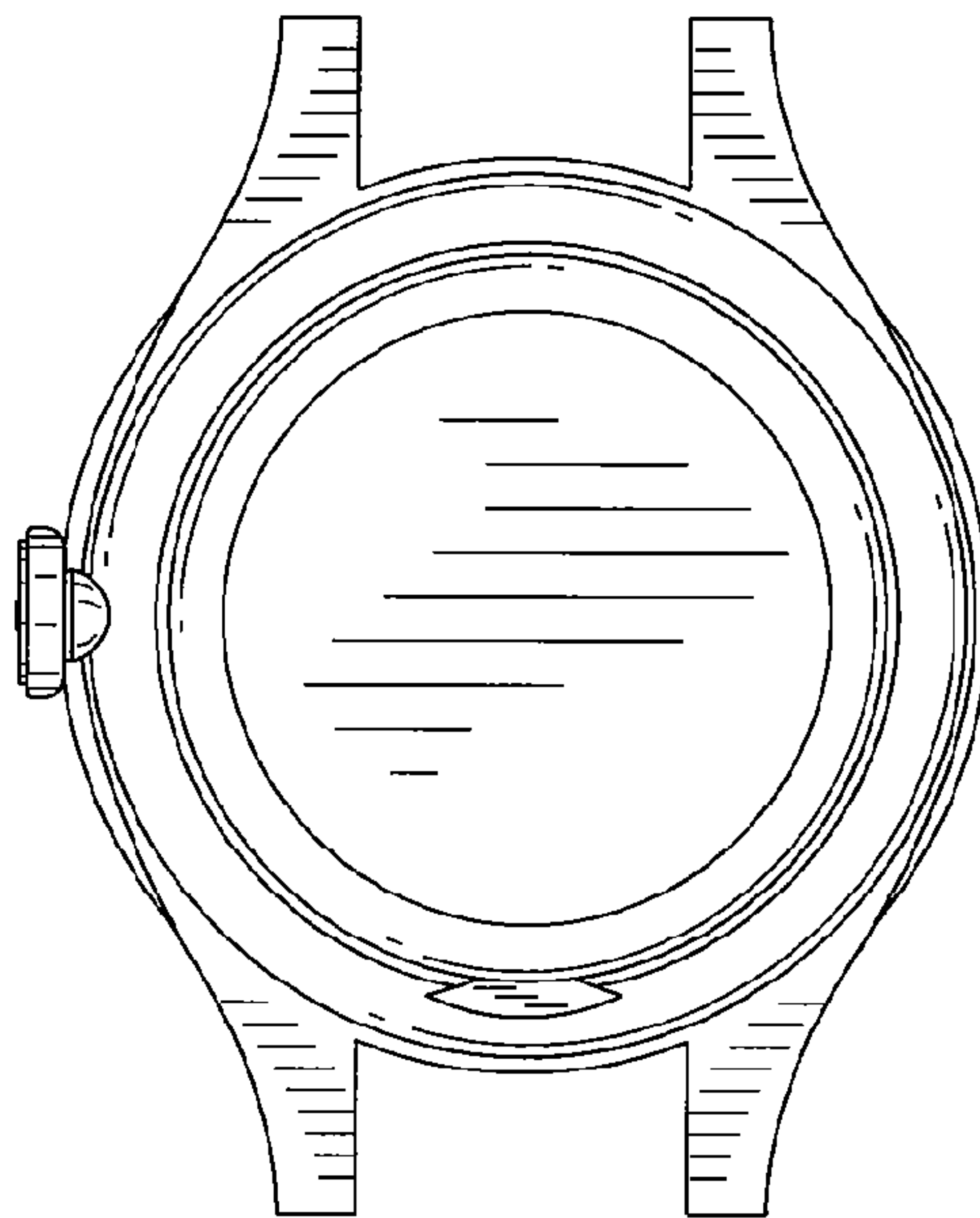
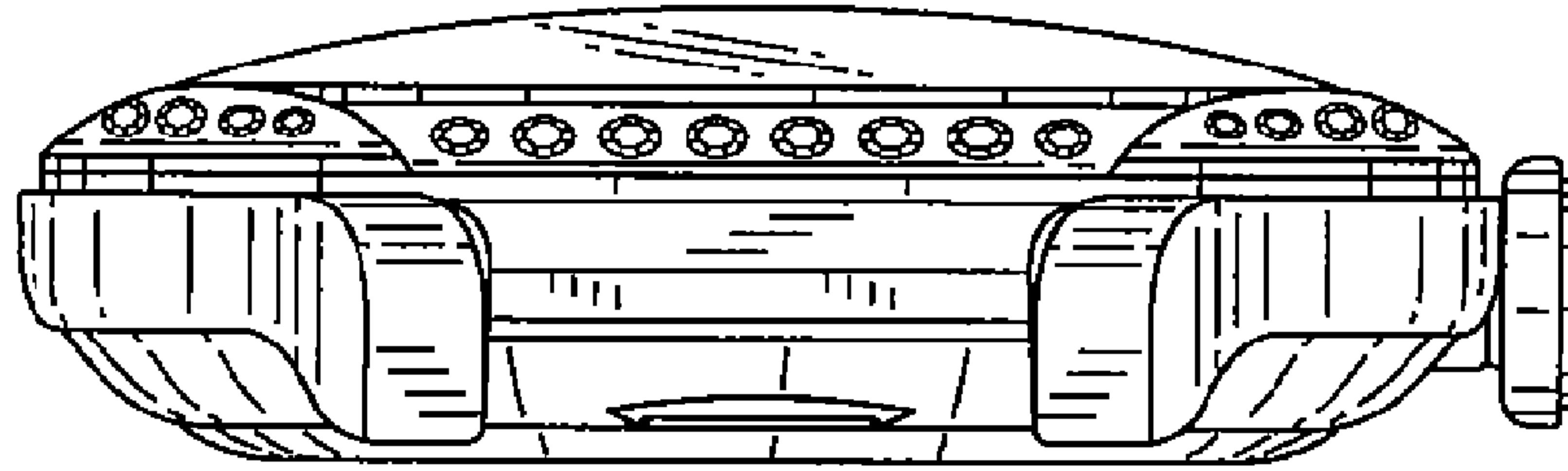
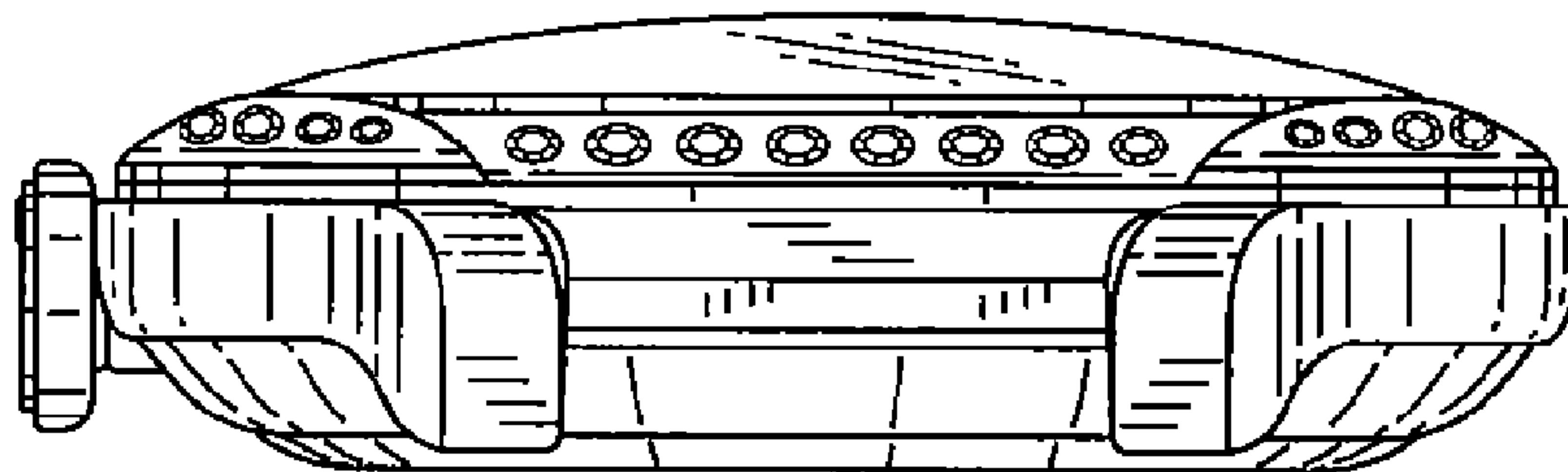


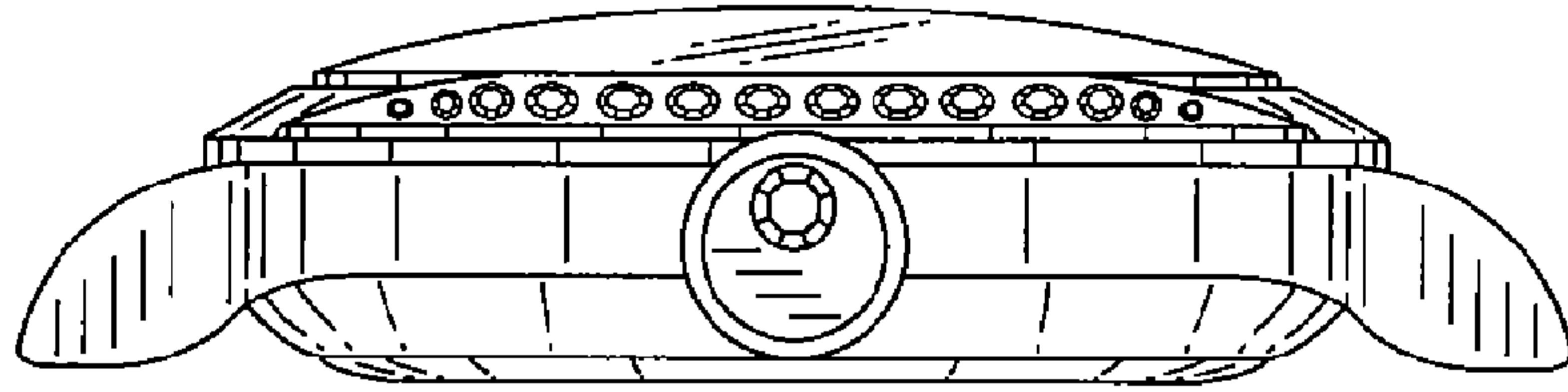

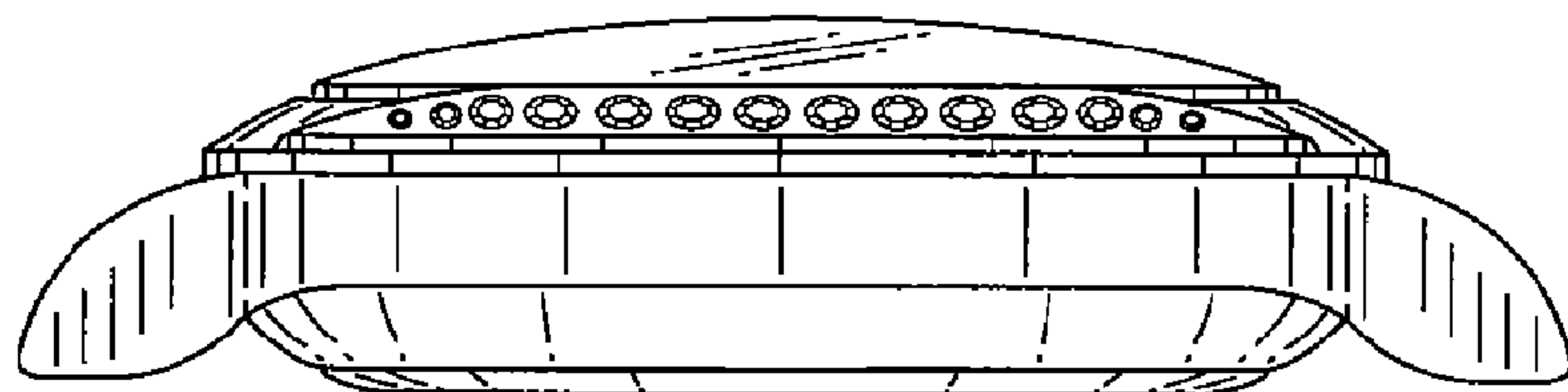
