(57) **CLAIM**

We claim the ornamental design for a light source of light emitting diode, as shown and described.

**DESCRIPTION**

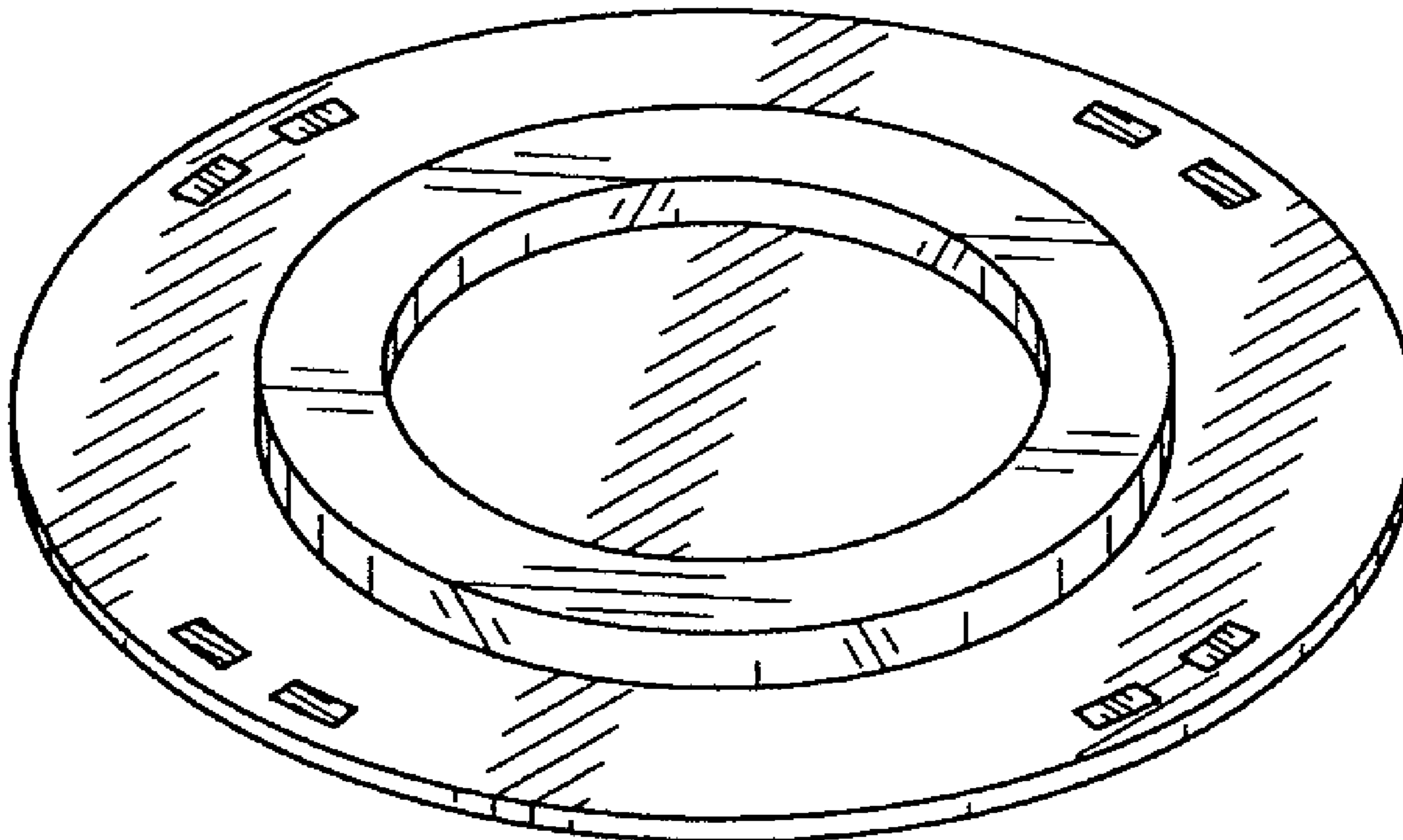

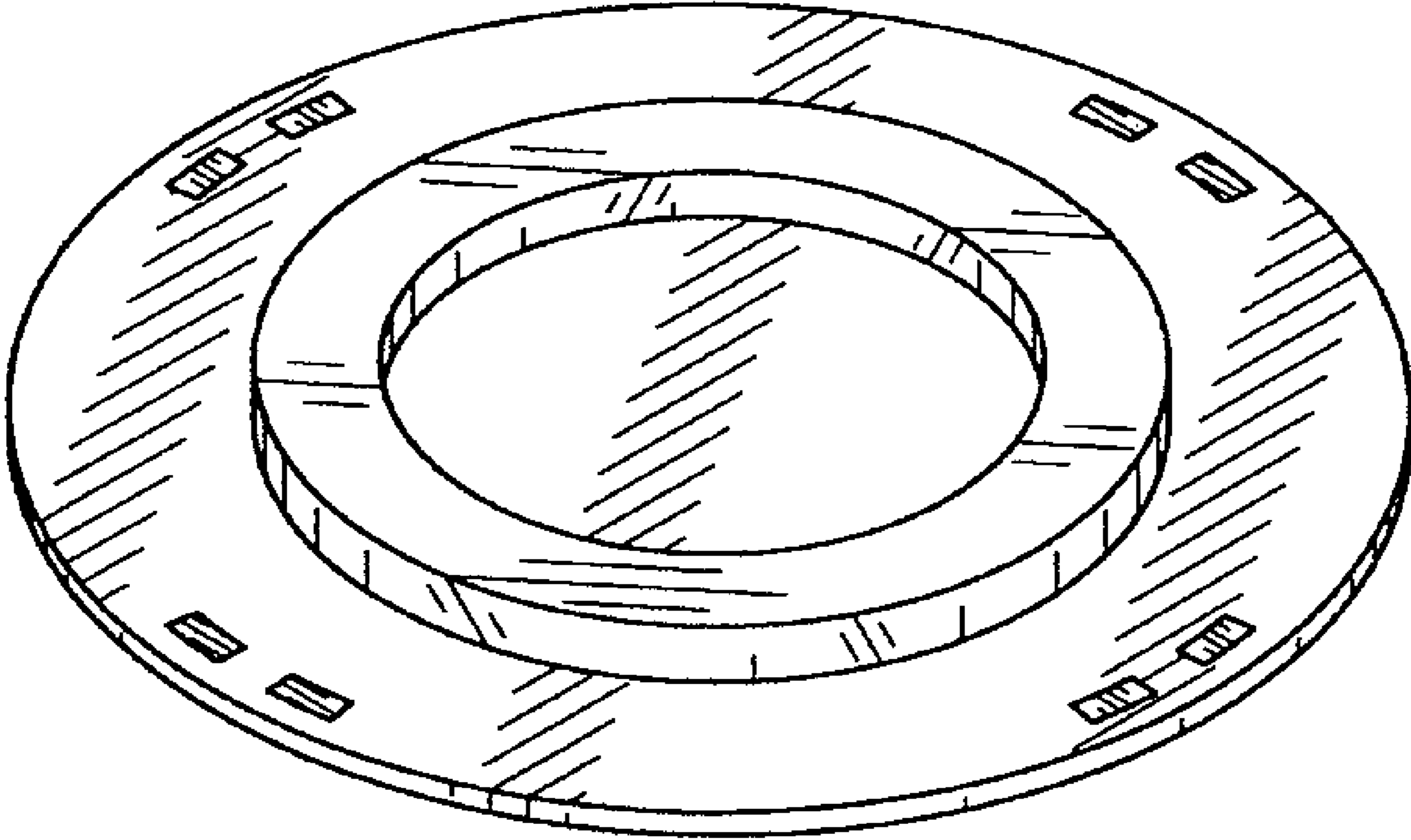
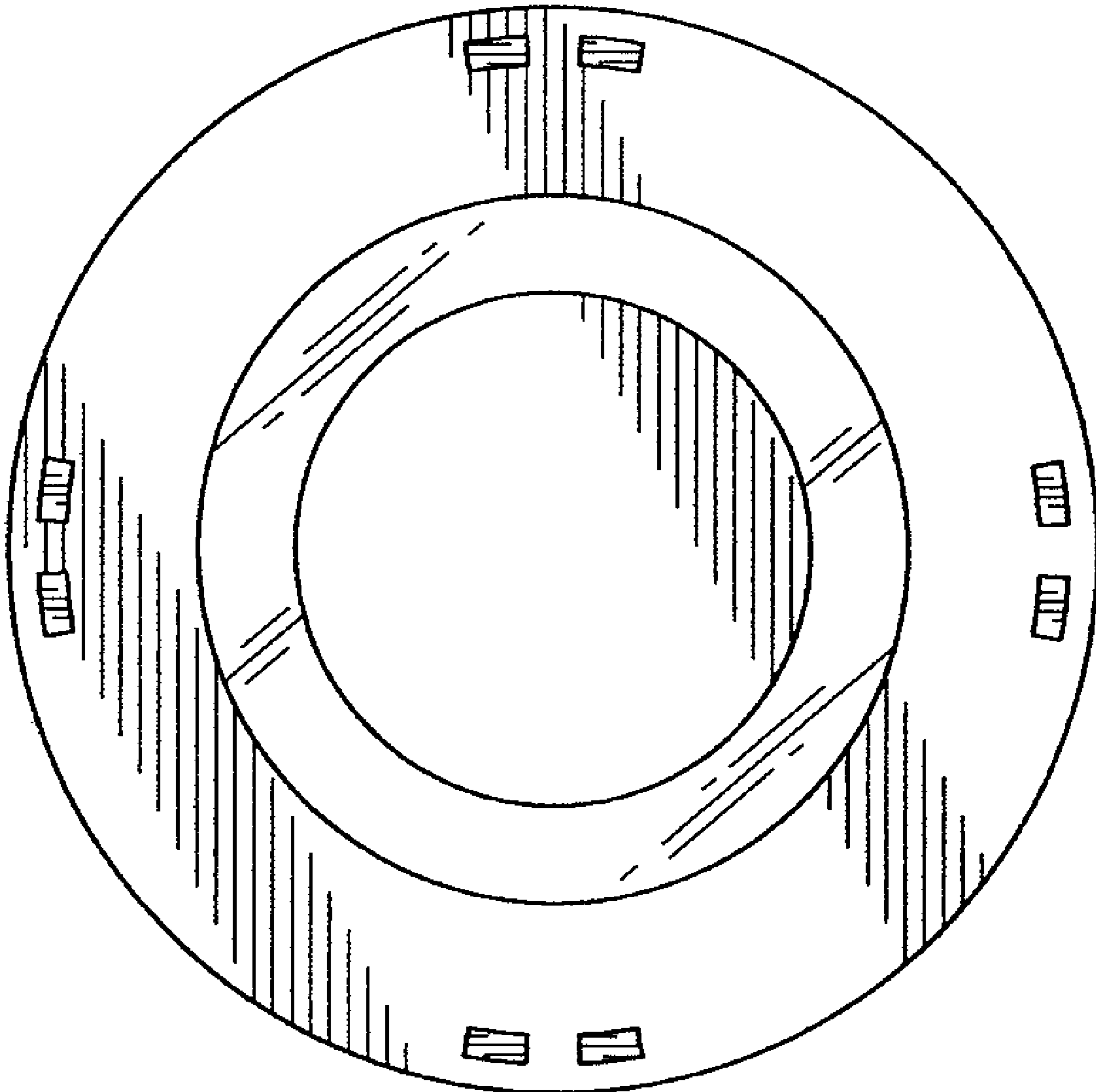
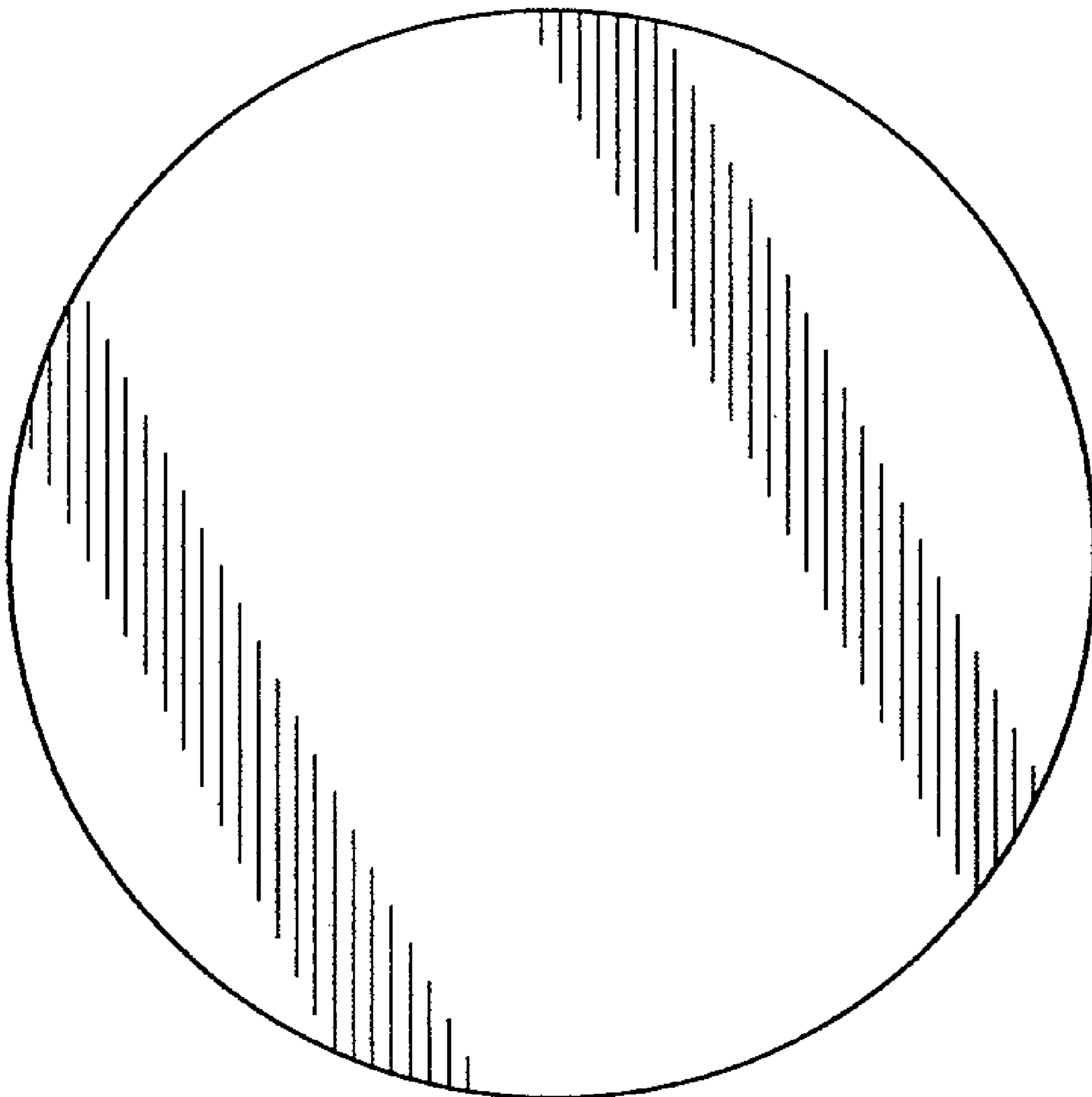

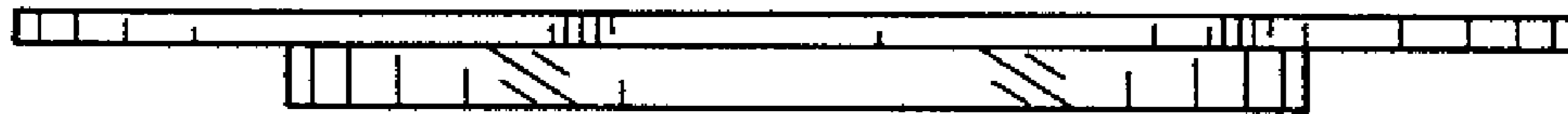
