The ornamental design for a portable communication terminal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable communication terminal;

FIG. 4 is left-side of the portable communication terminal of FIG. 1;

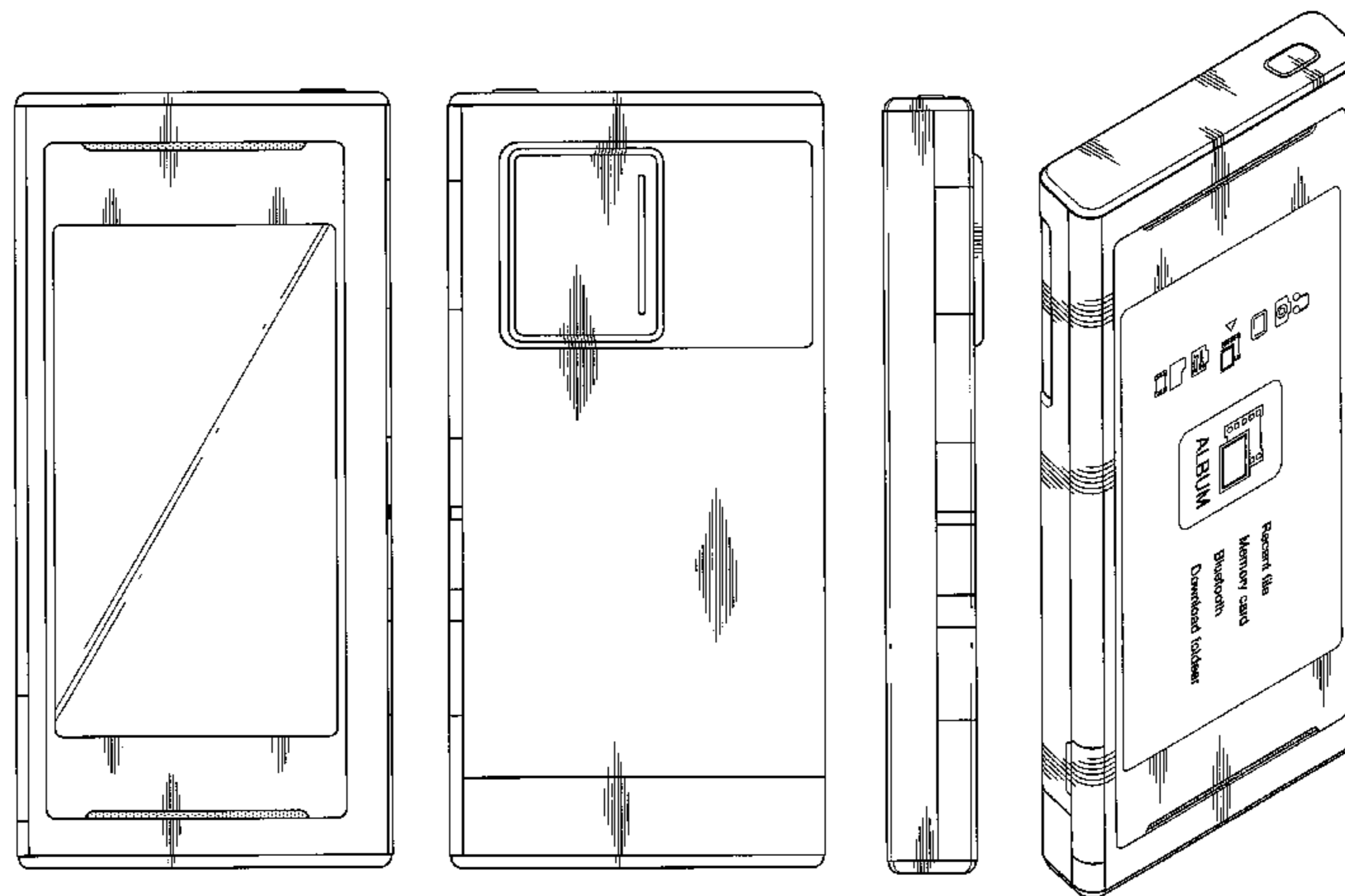
FIG. 5 is right-side of the portable communication terminal of FIG. 1;

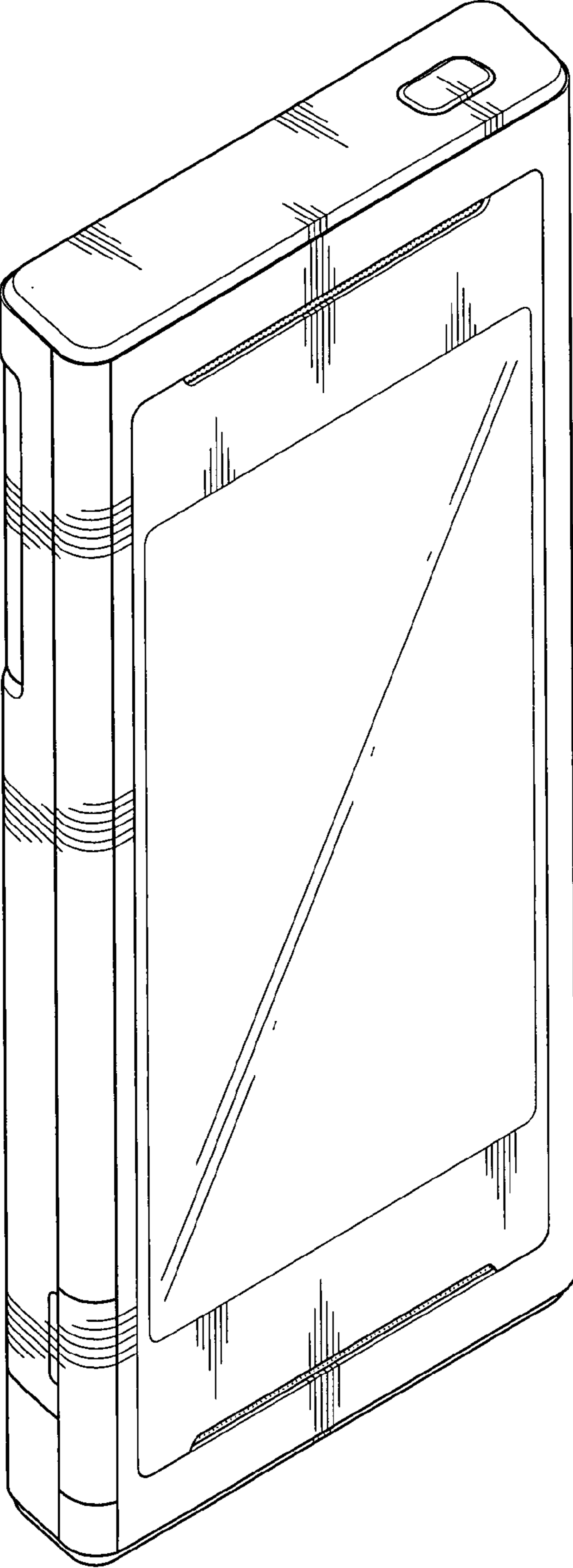

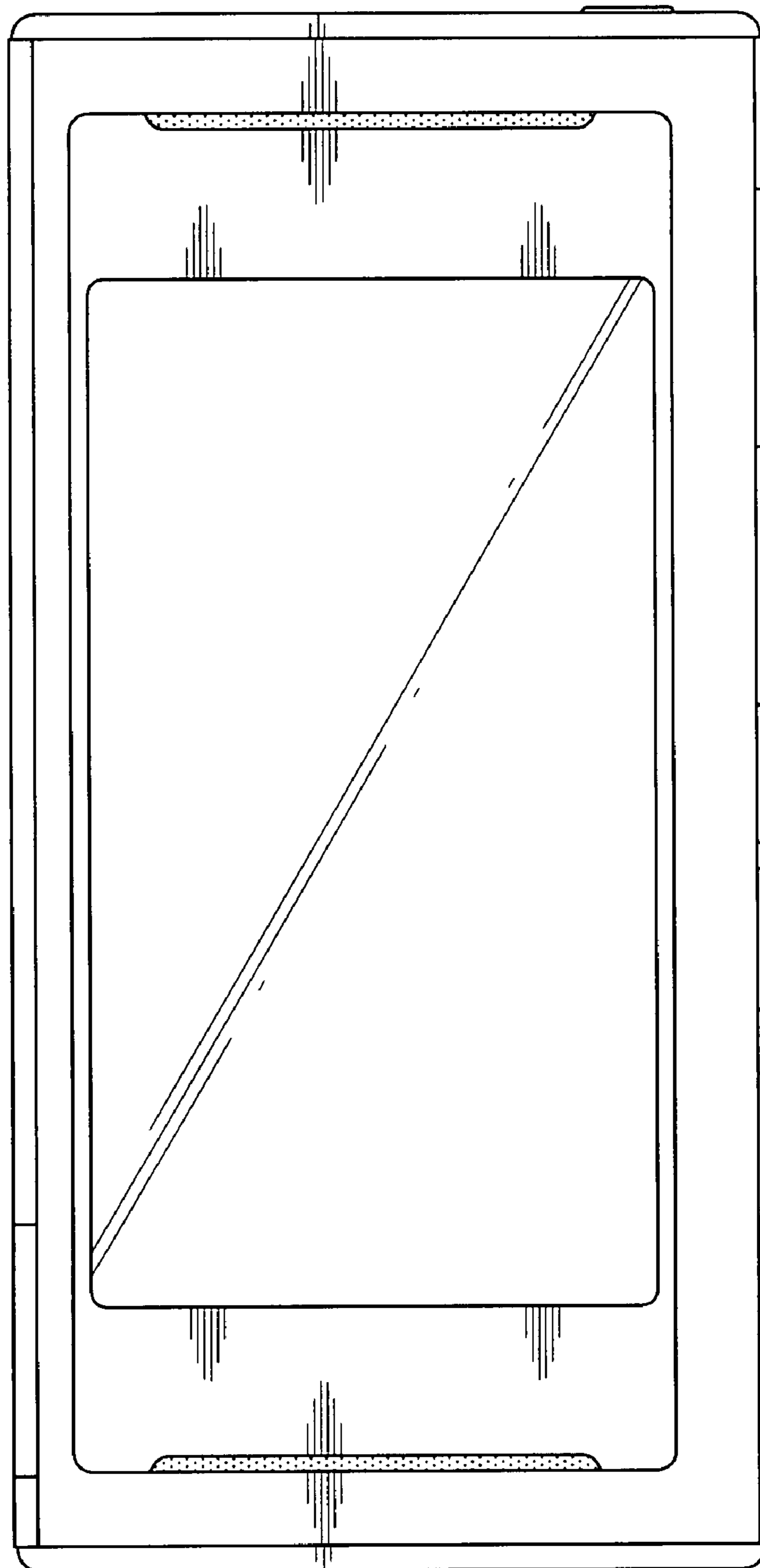

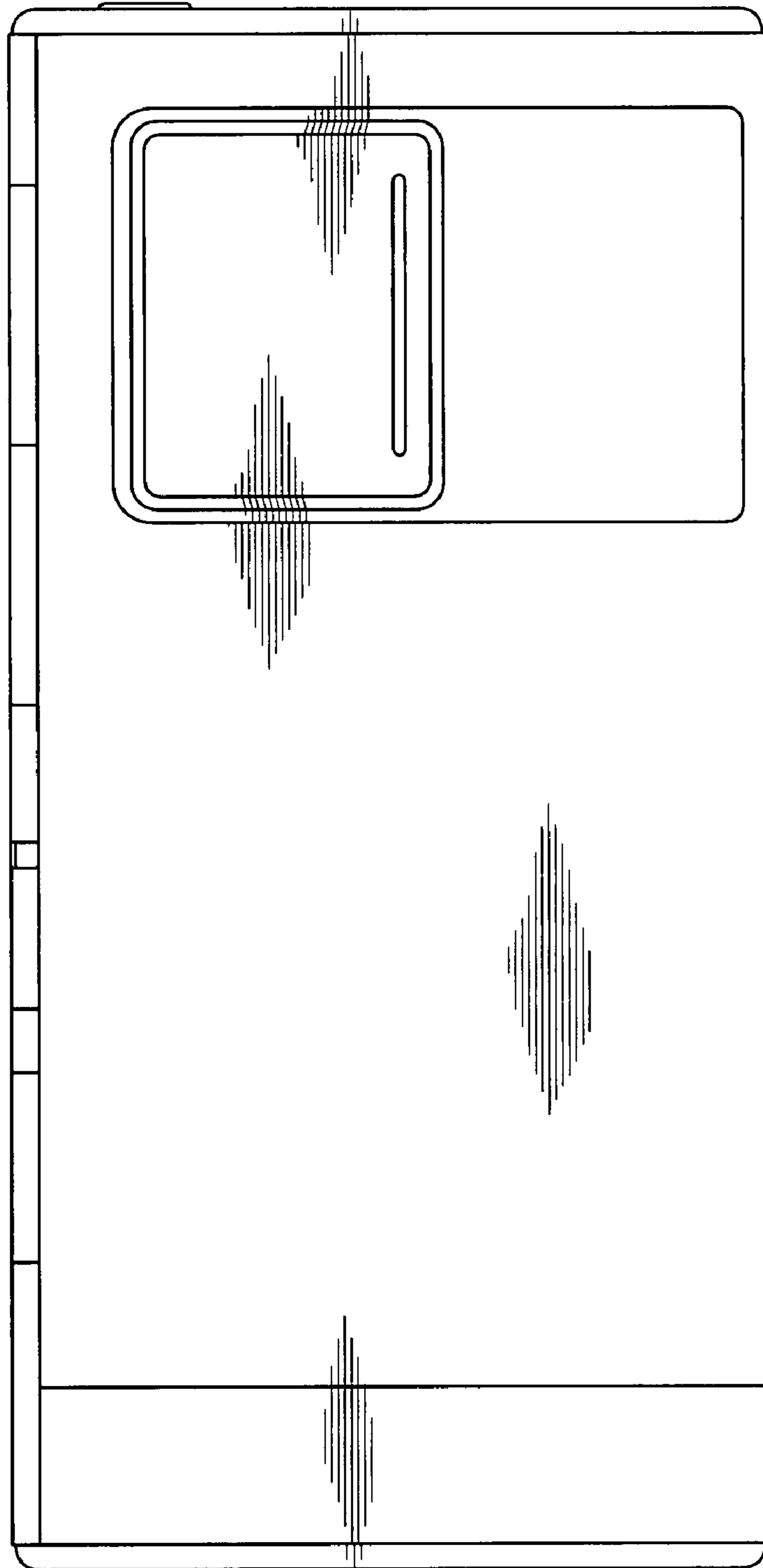

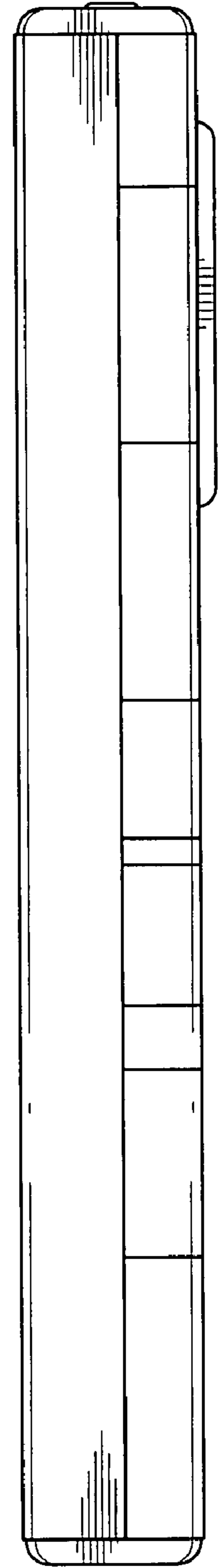
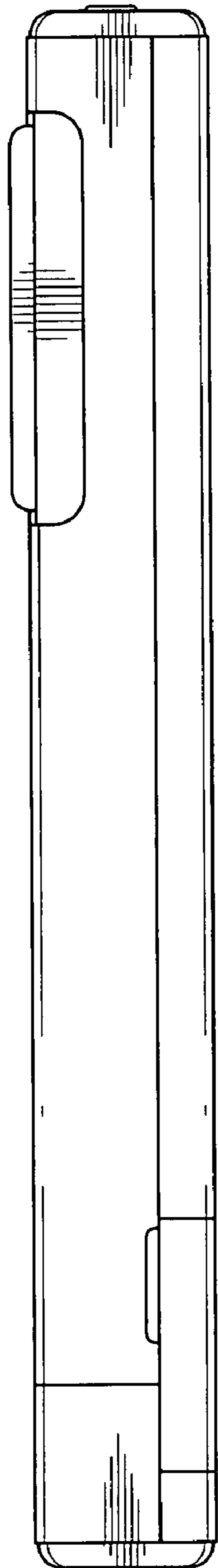

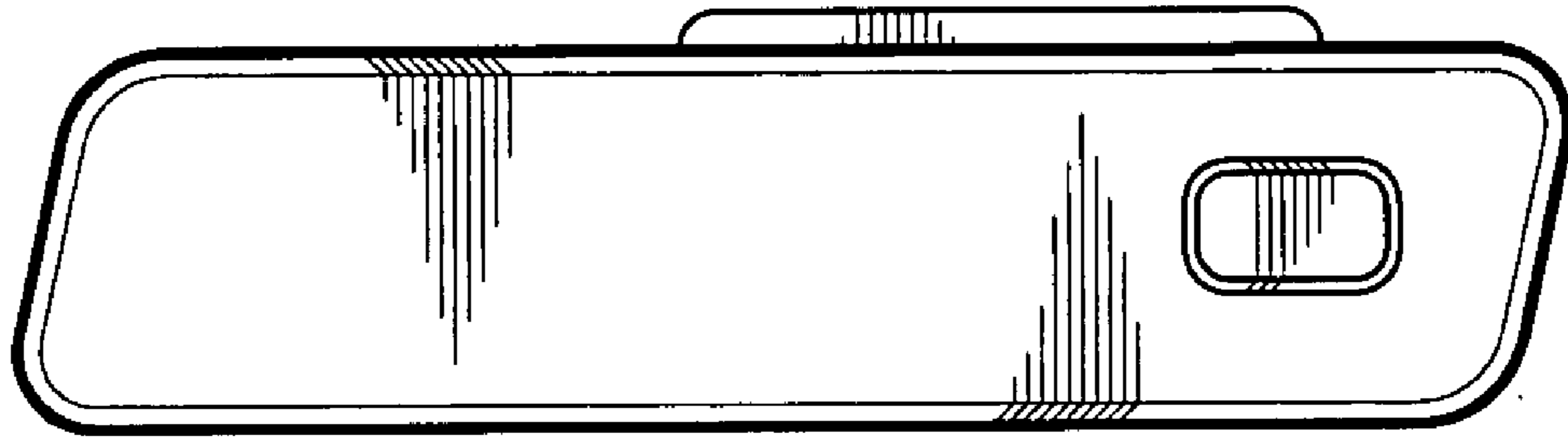

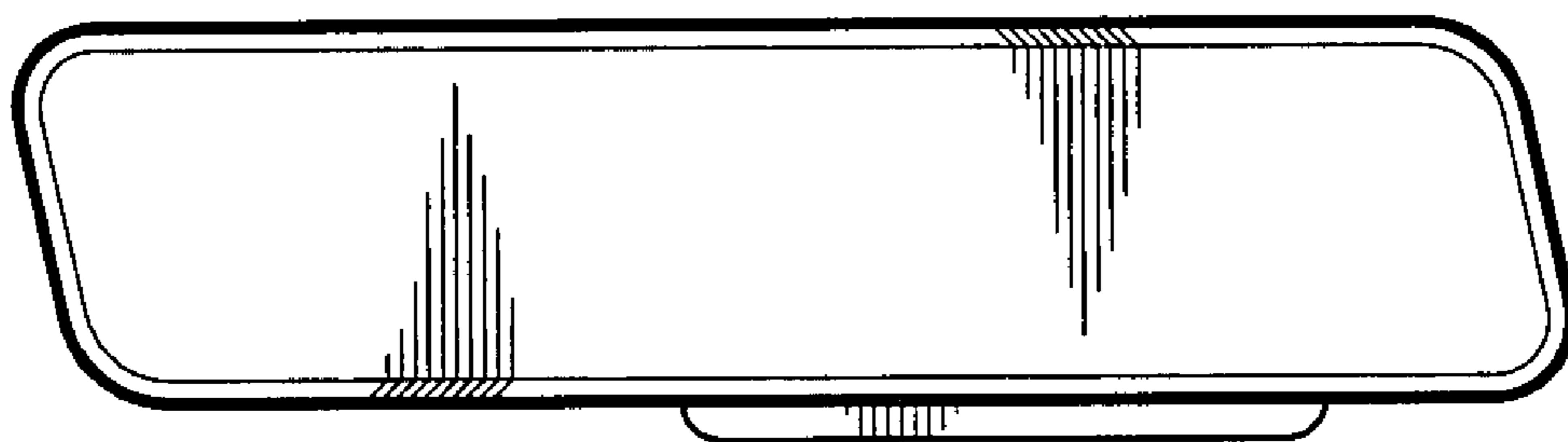
