The ornamental design for a boom extension arm, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a boom extension arm in  
accordance with the present invention;

FIG. 2 is a right side elevational view of the boom extension  
arm of FIG. 1, the left side elevational view being a mirror  
image of the right side;

FIG. 3 is a front elevational view of the boom extension arm  
of FIG. 1;

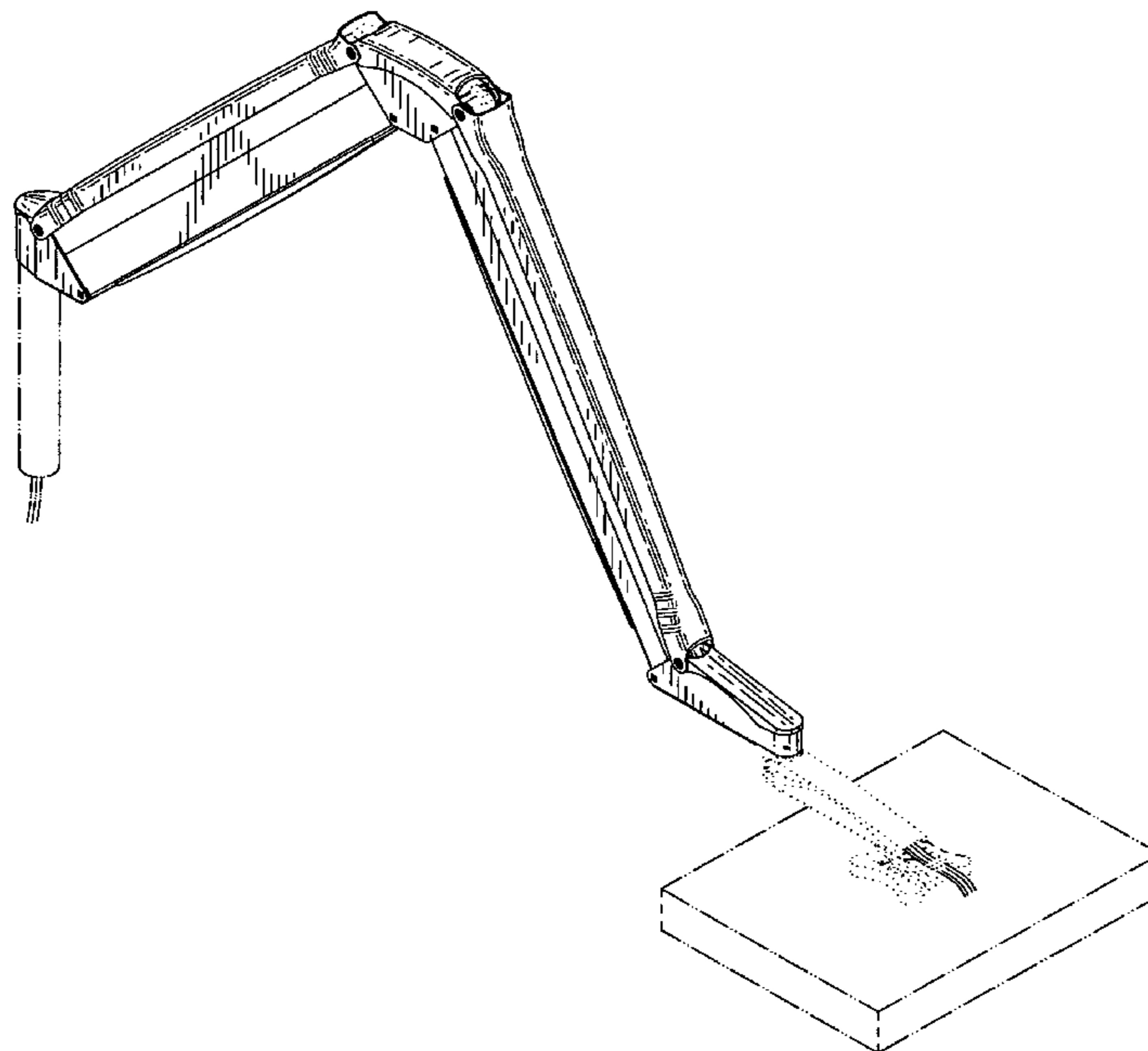
FIG. 4 is a rear elevational view of the boom extension arm of

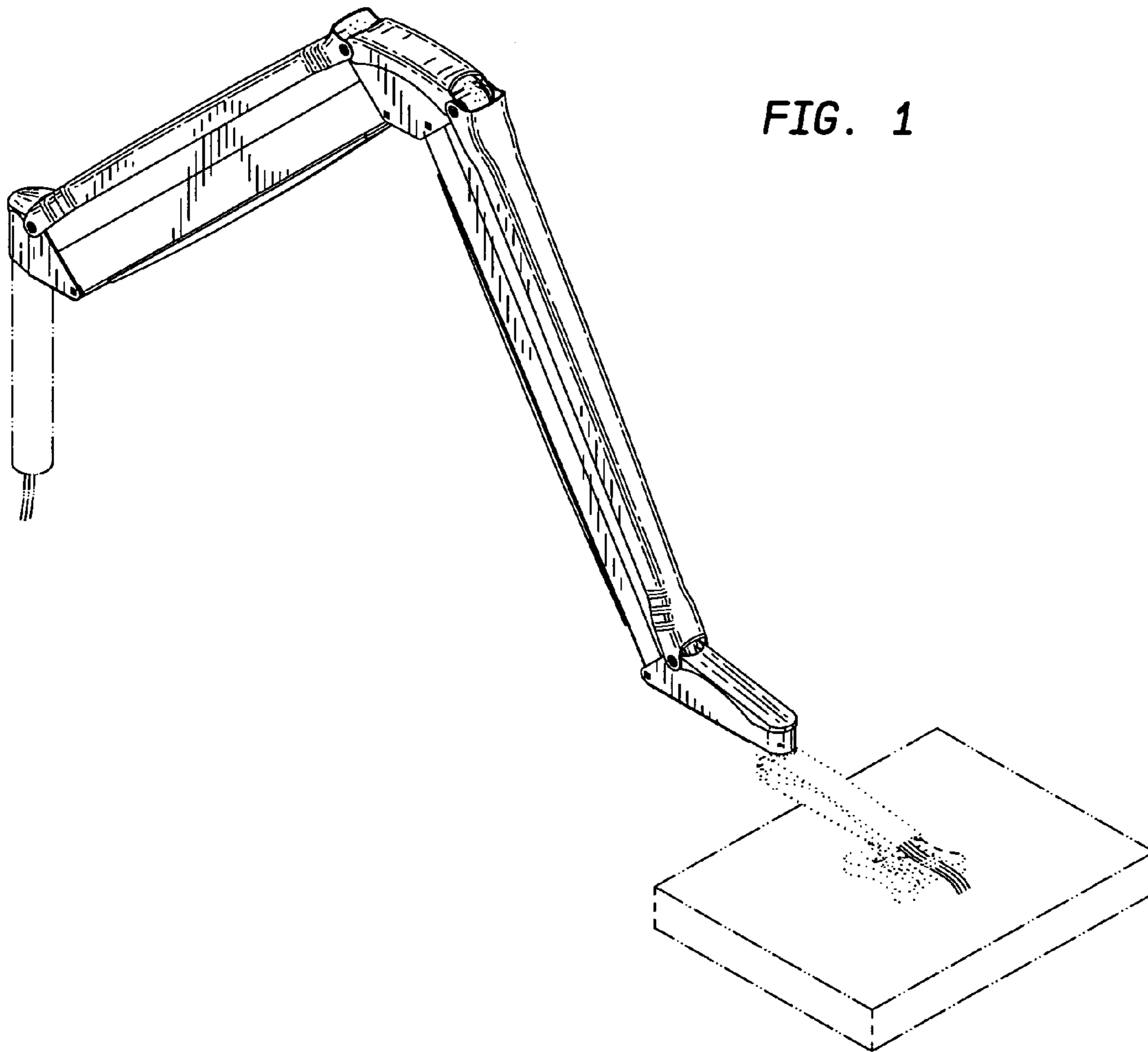
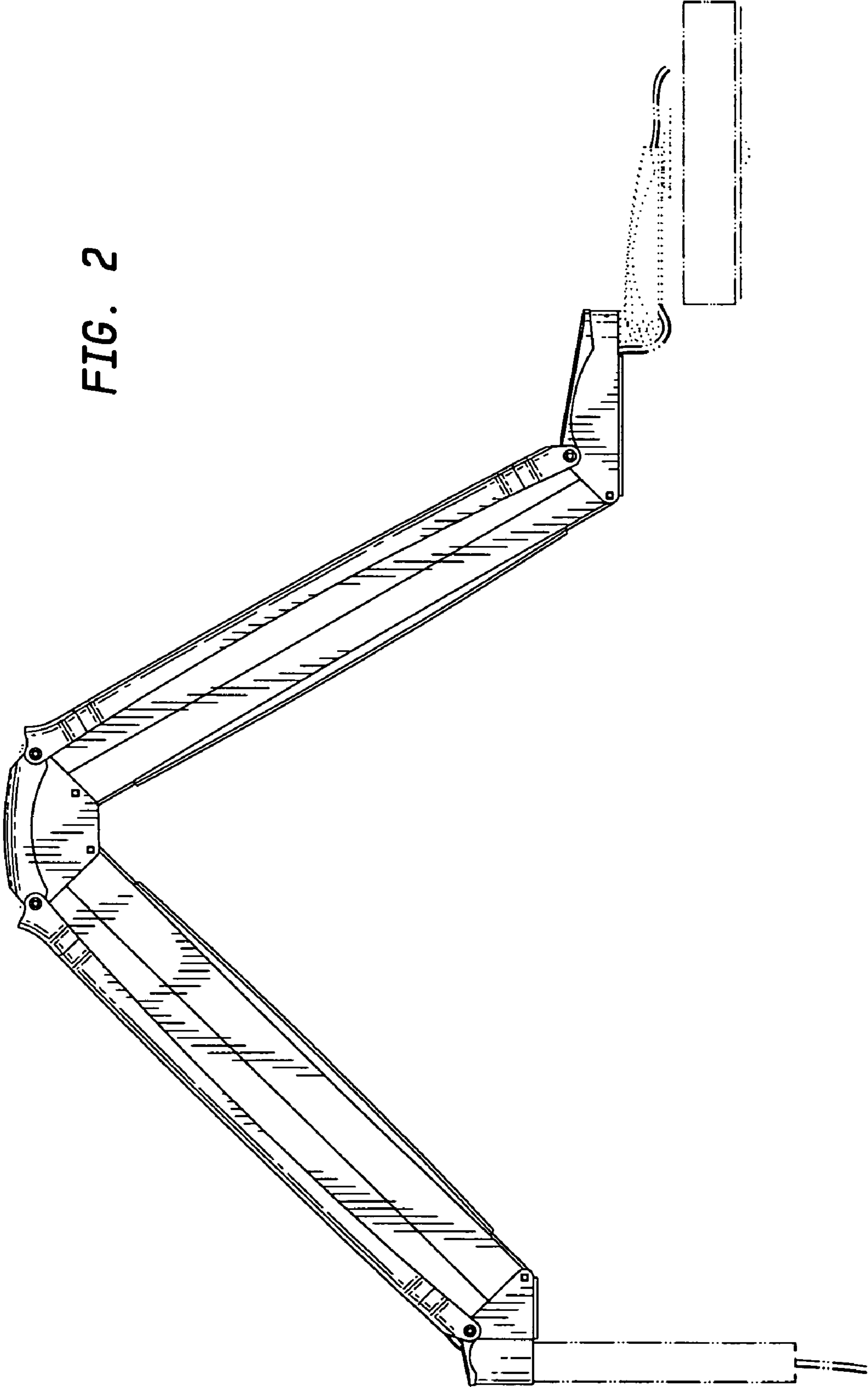
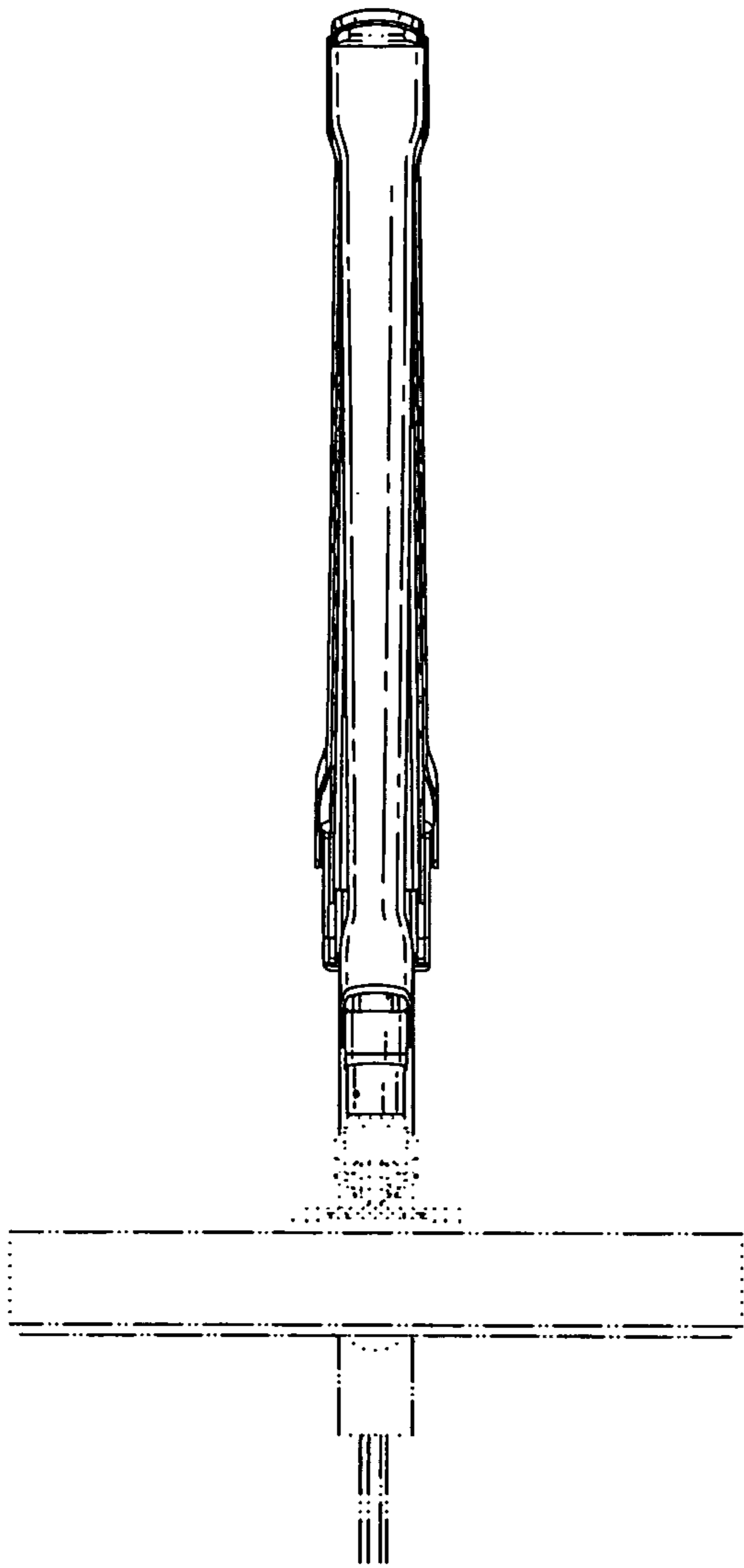

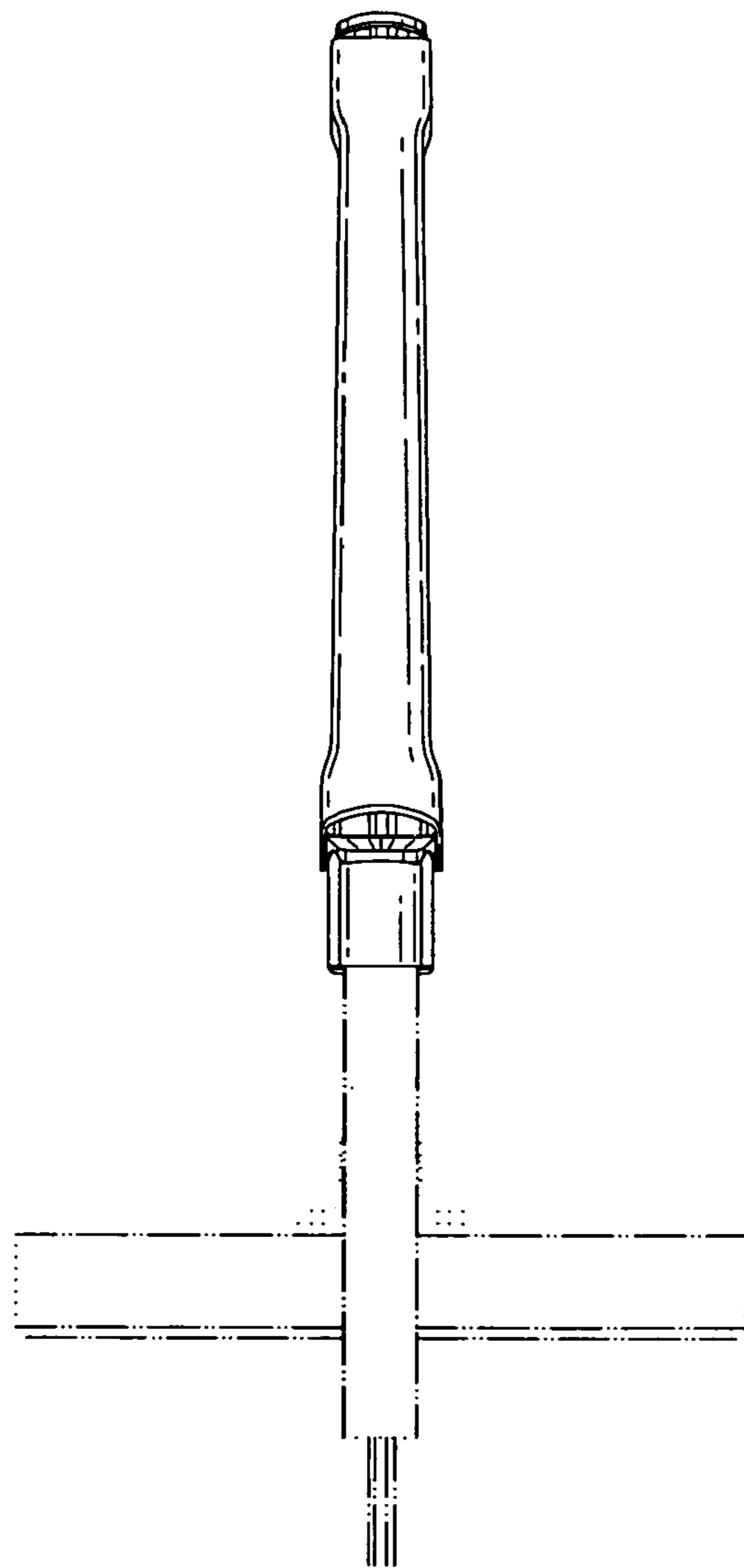

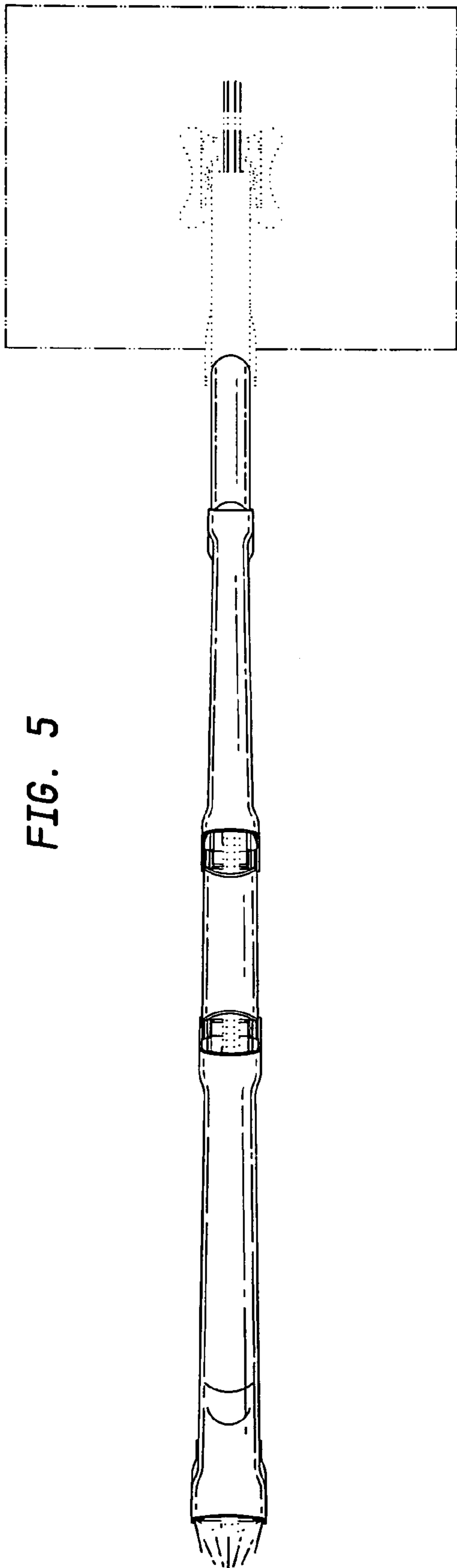

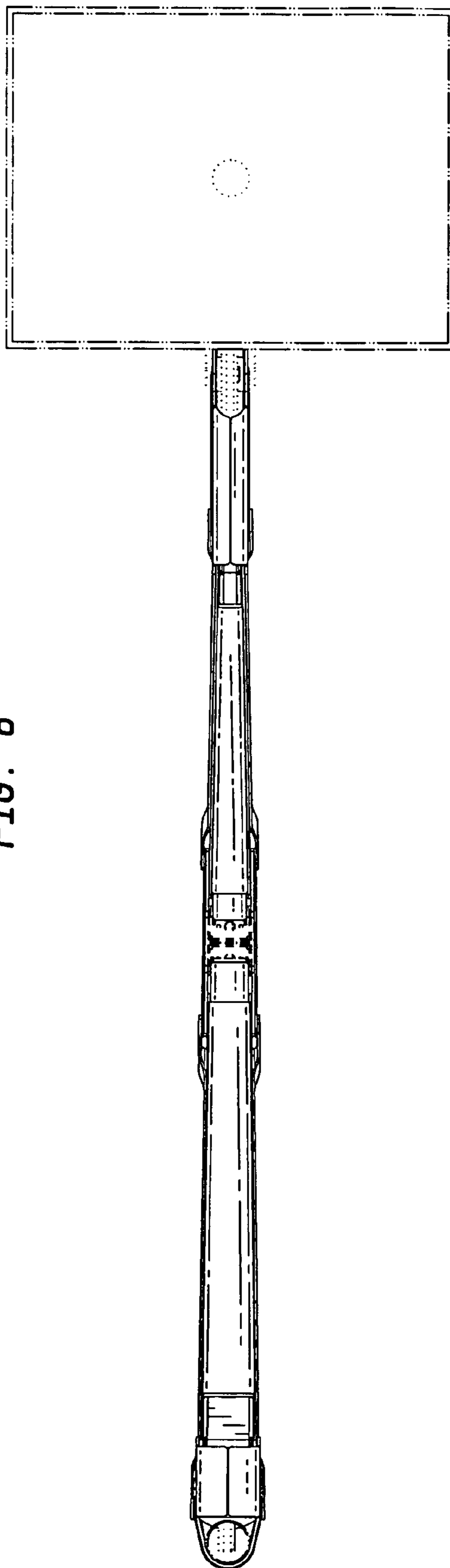
