FIG. 5 is a top view of the design according to the invention.

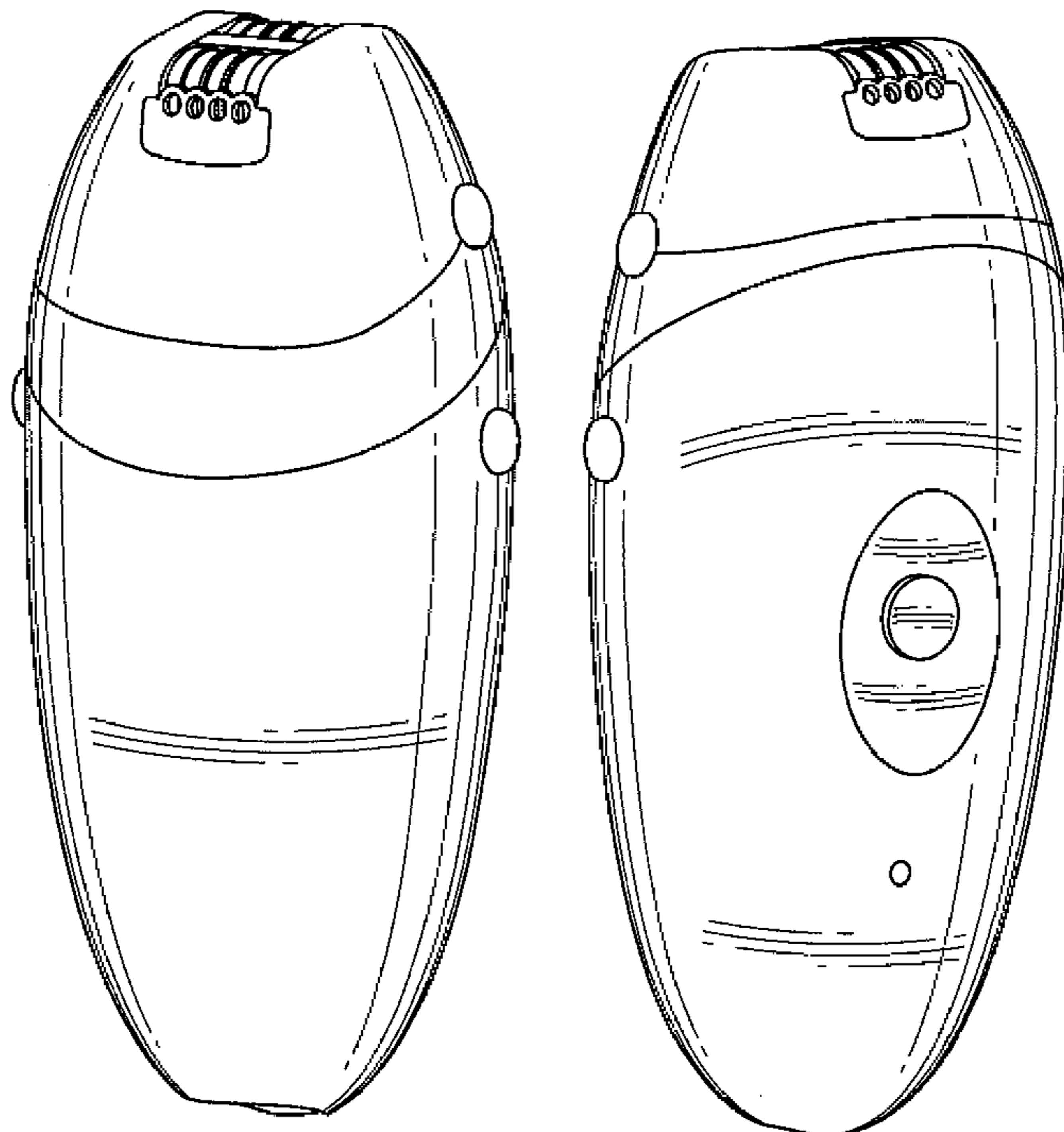
FIG. 6 is a rear view of the design according to the invention.

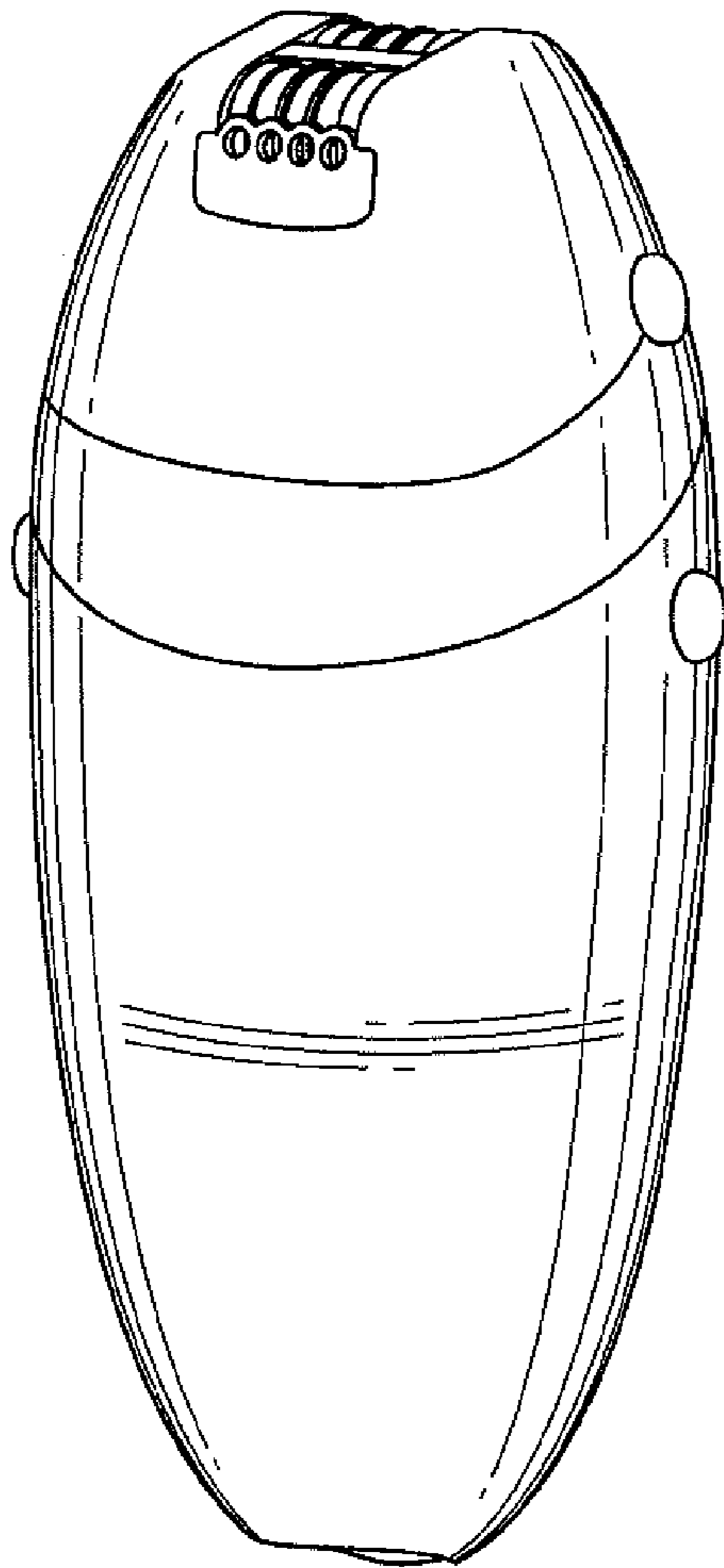

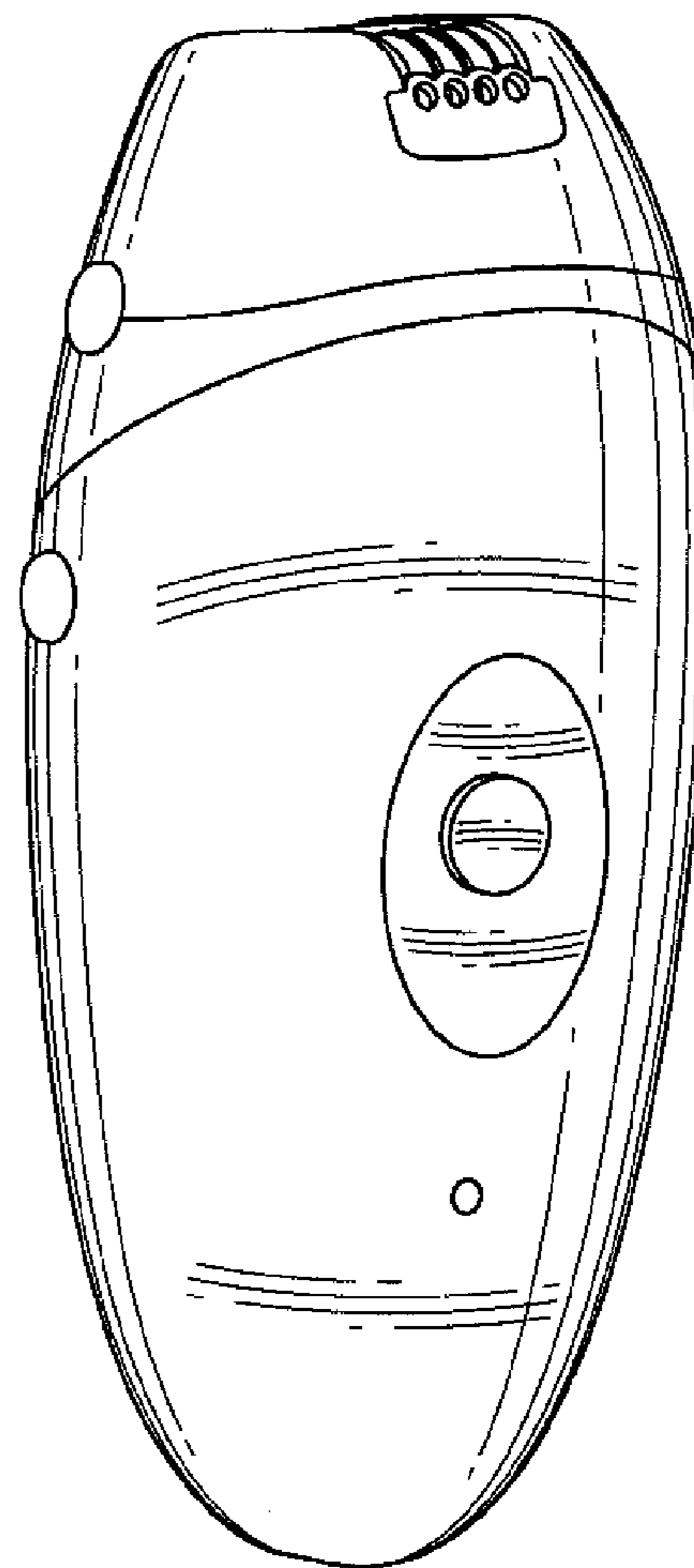

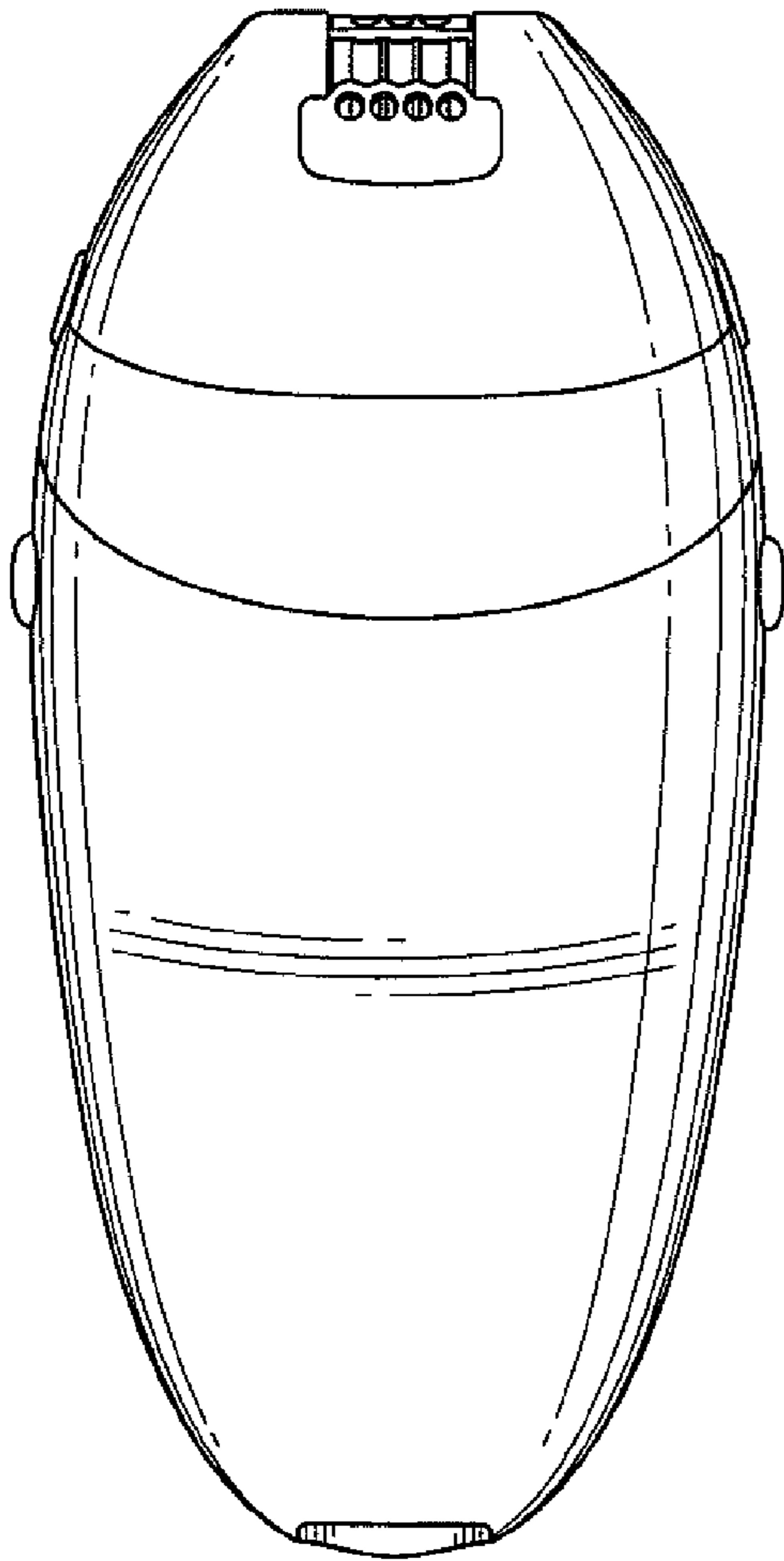

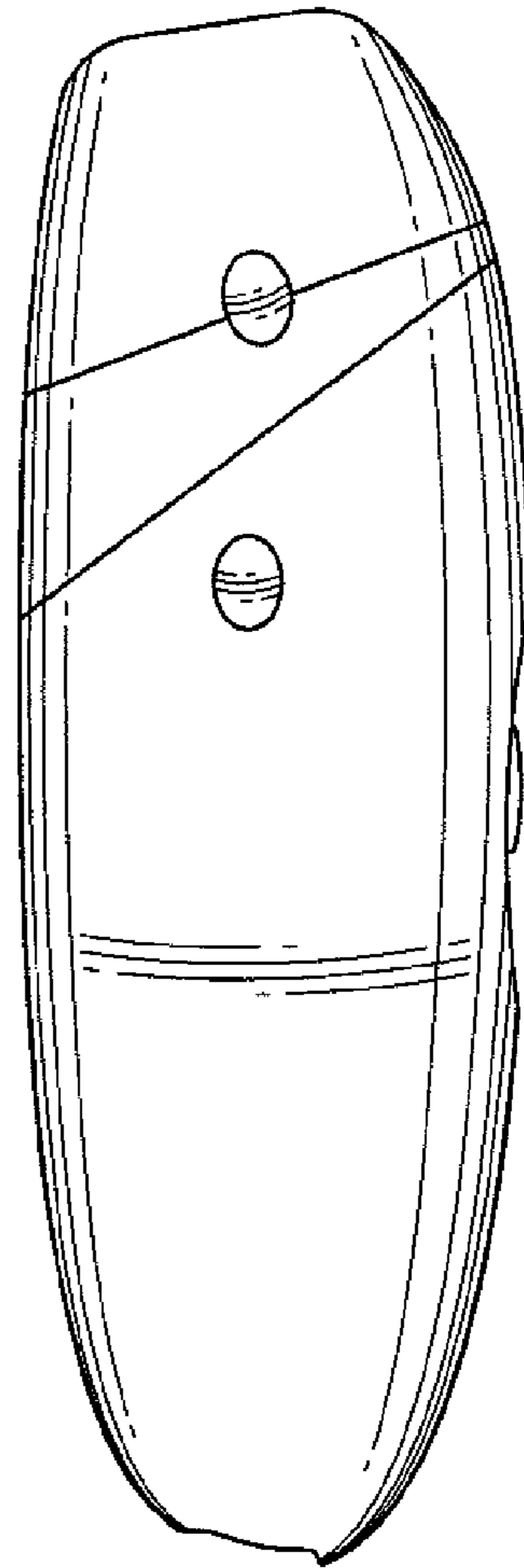

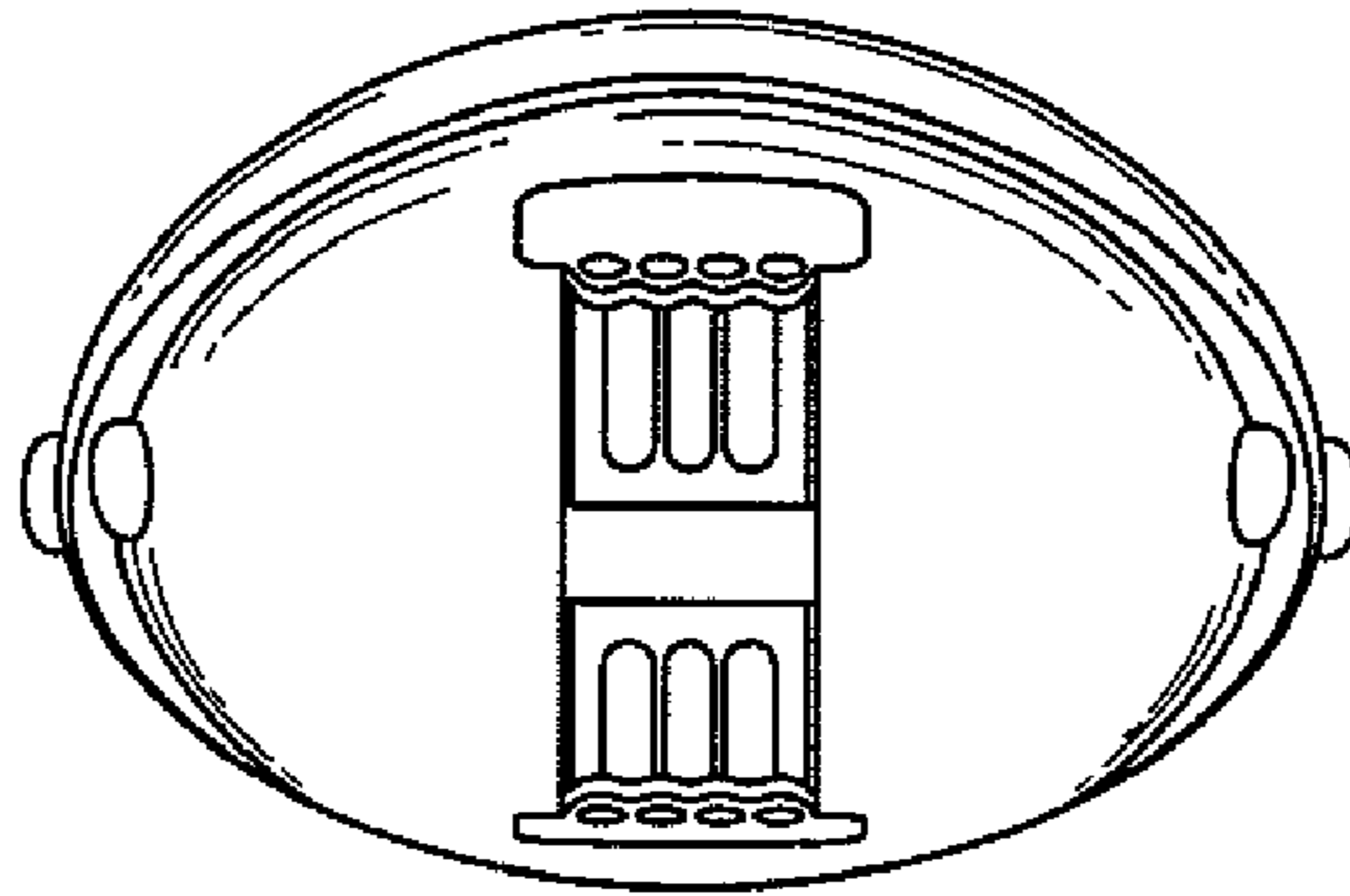

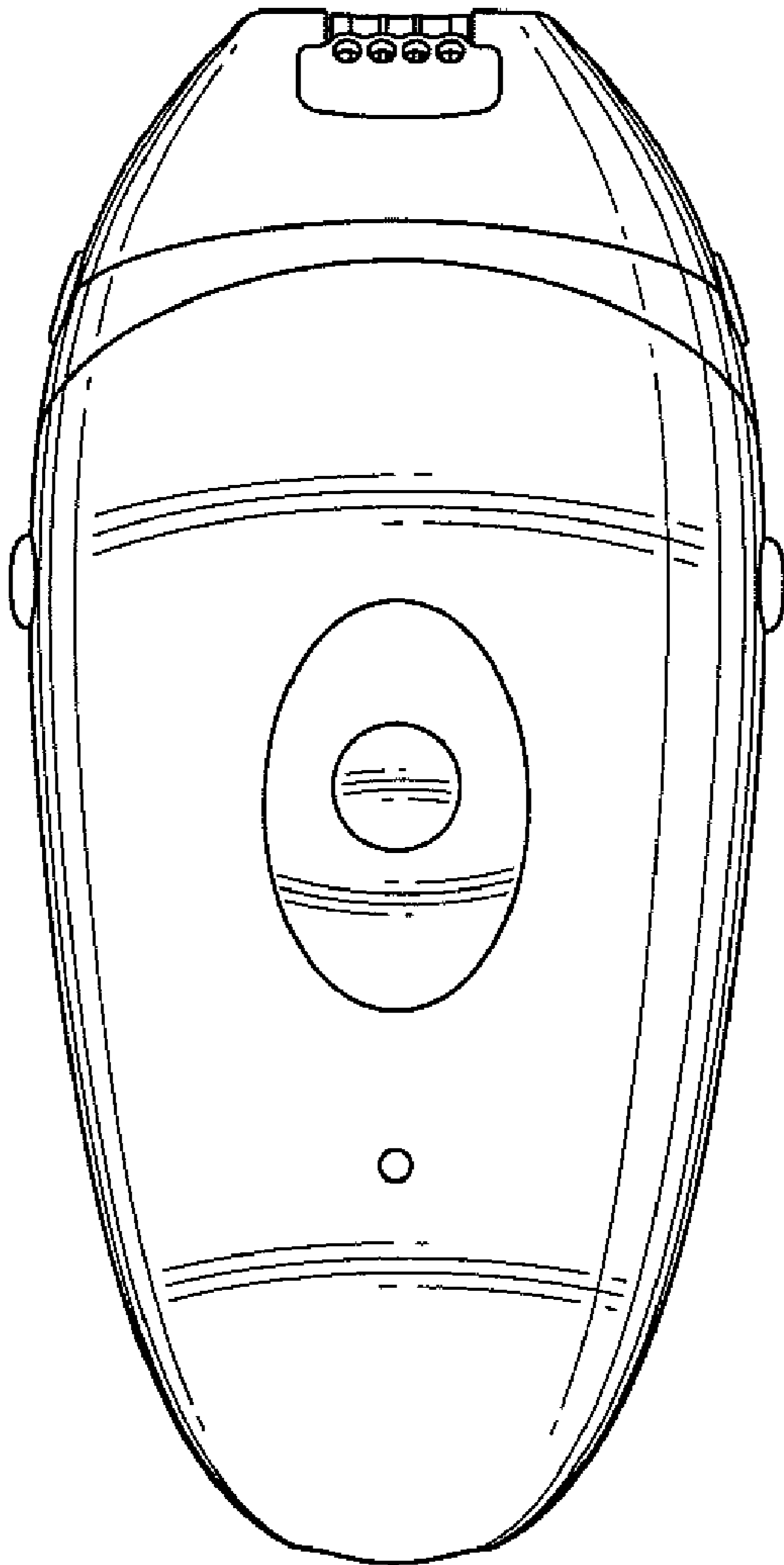

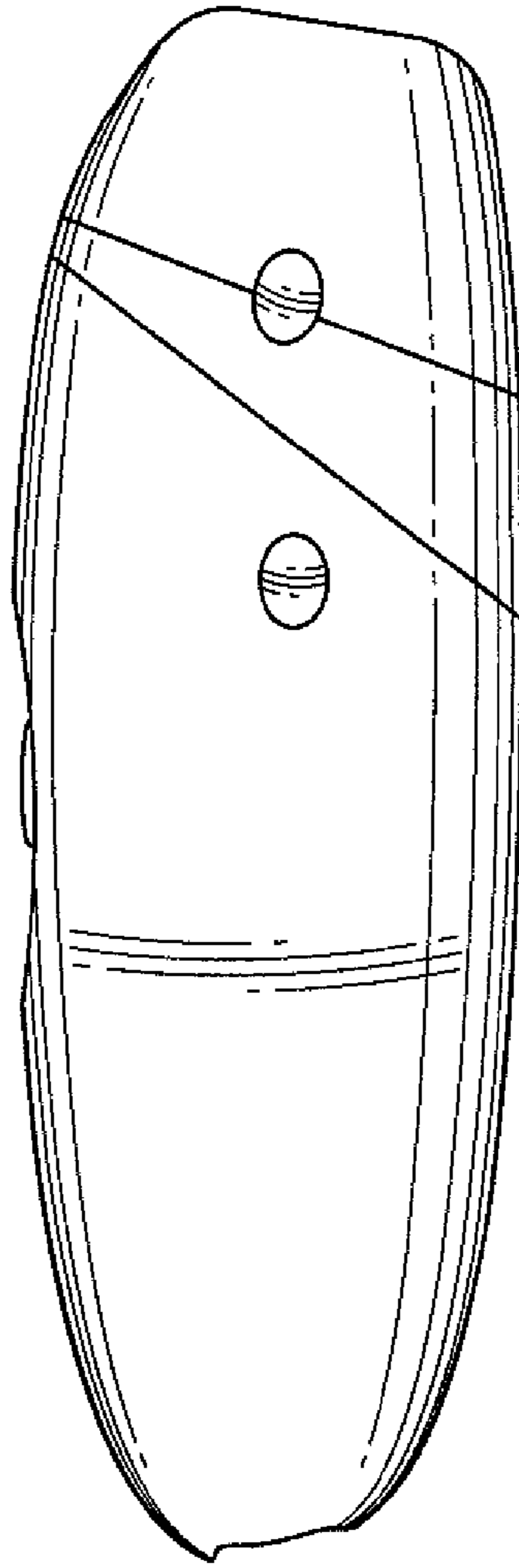

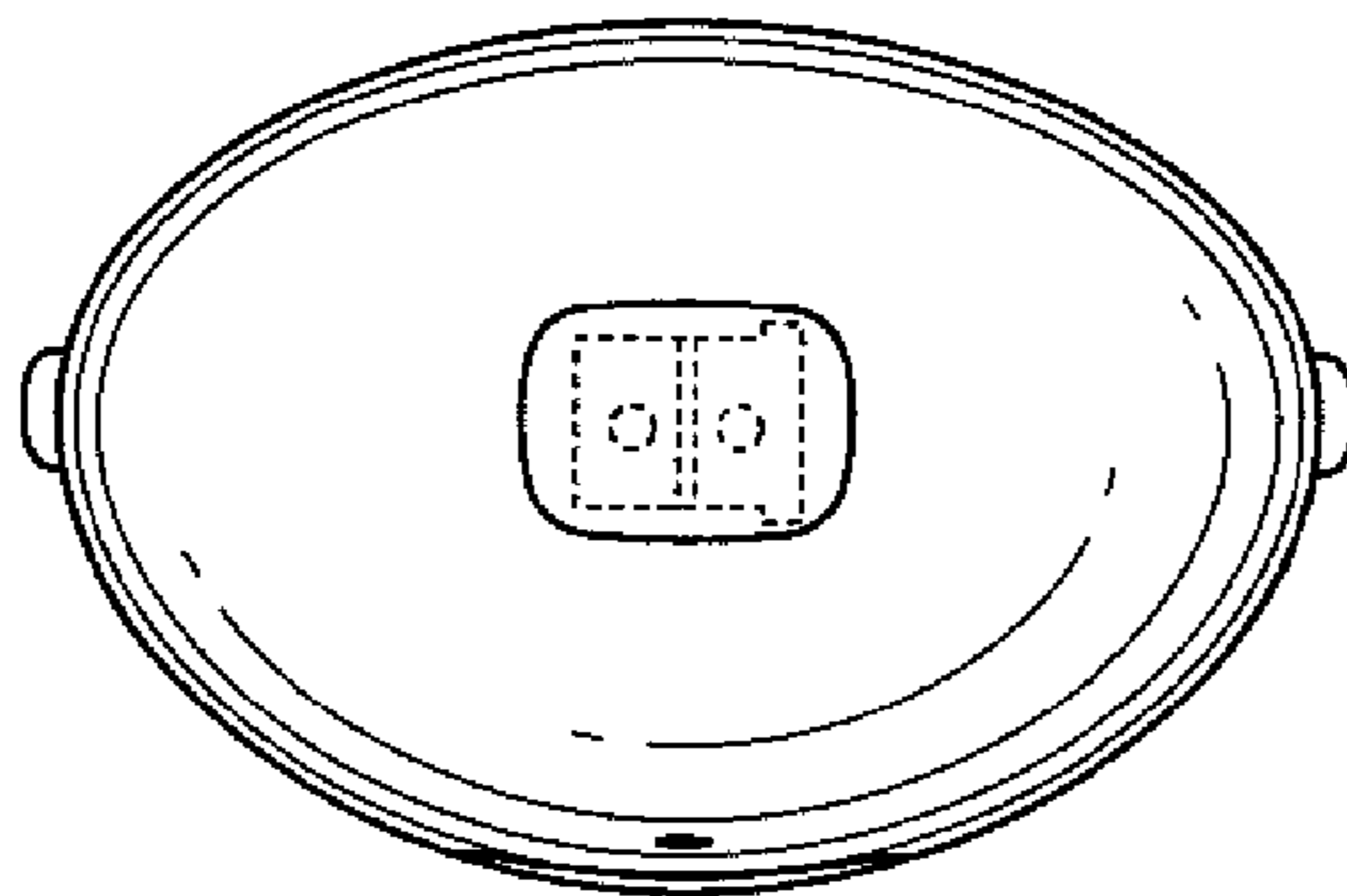
