**DESCRIPTION**

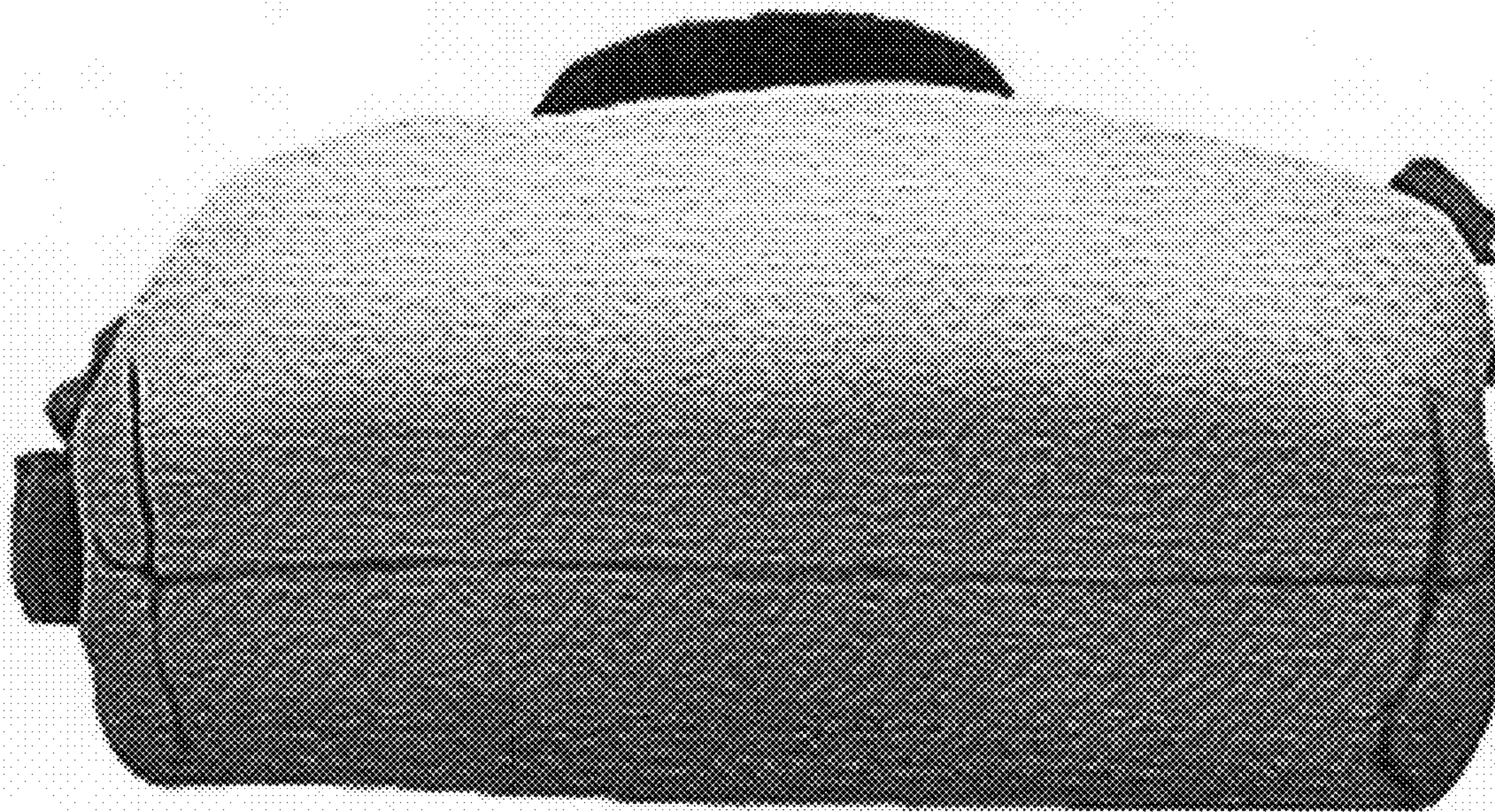

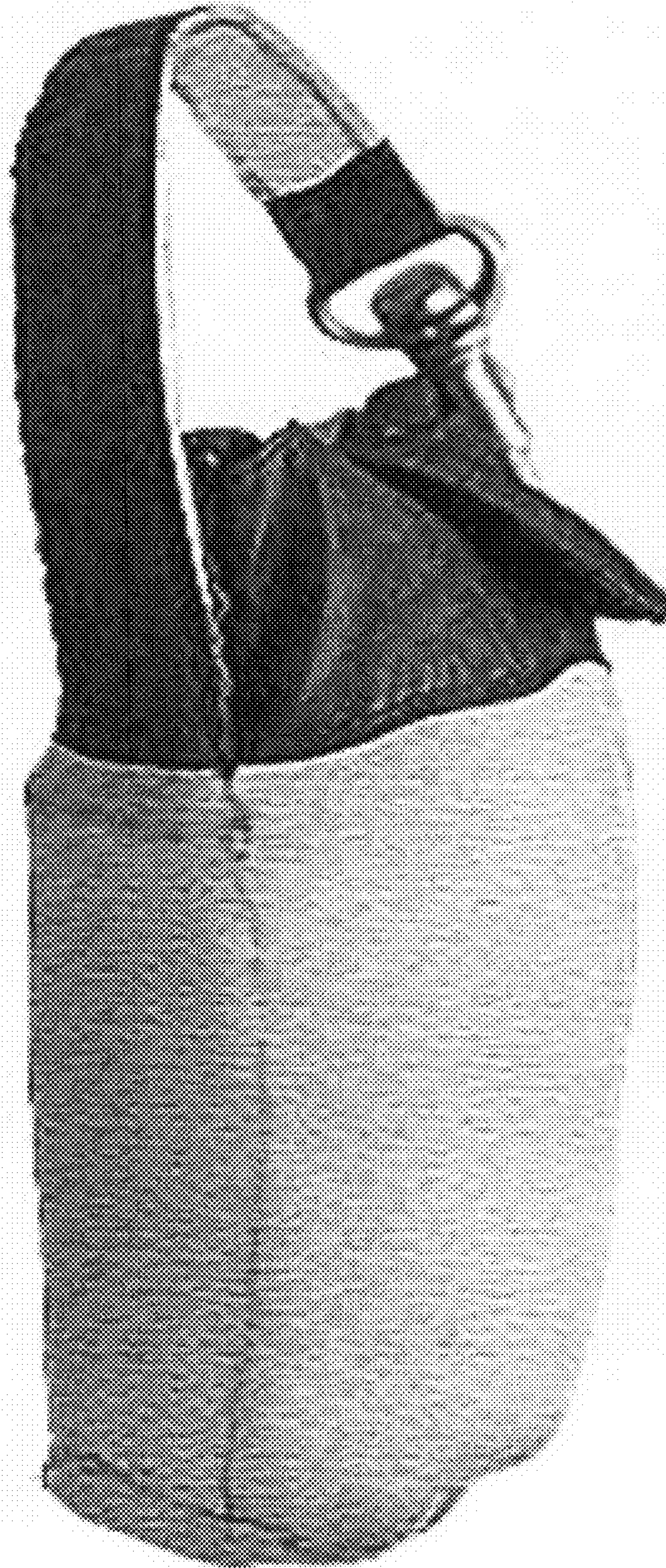

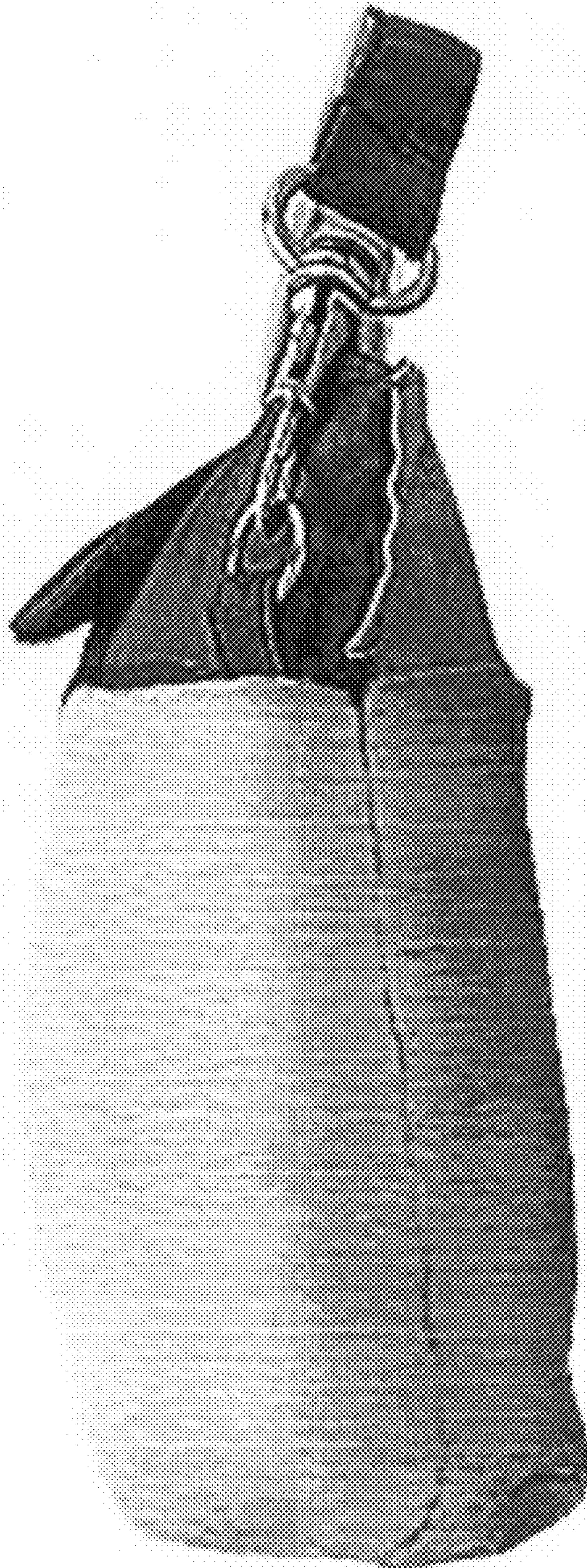

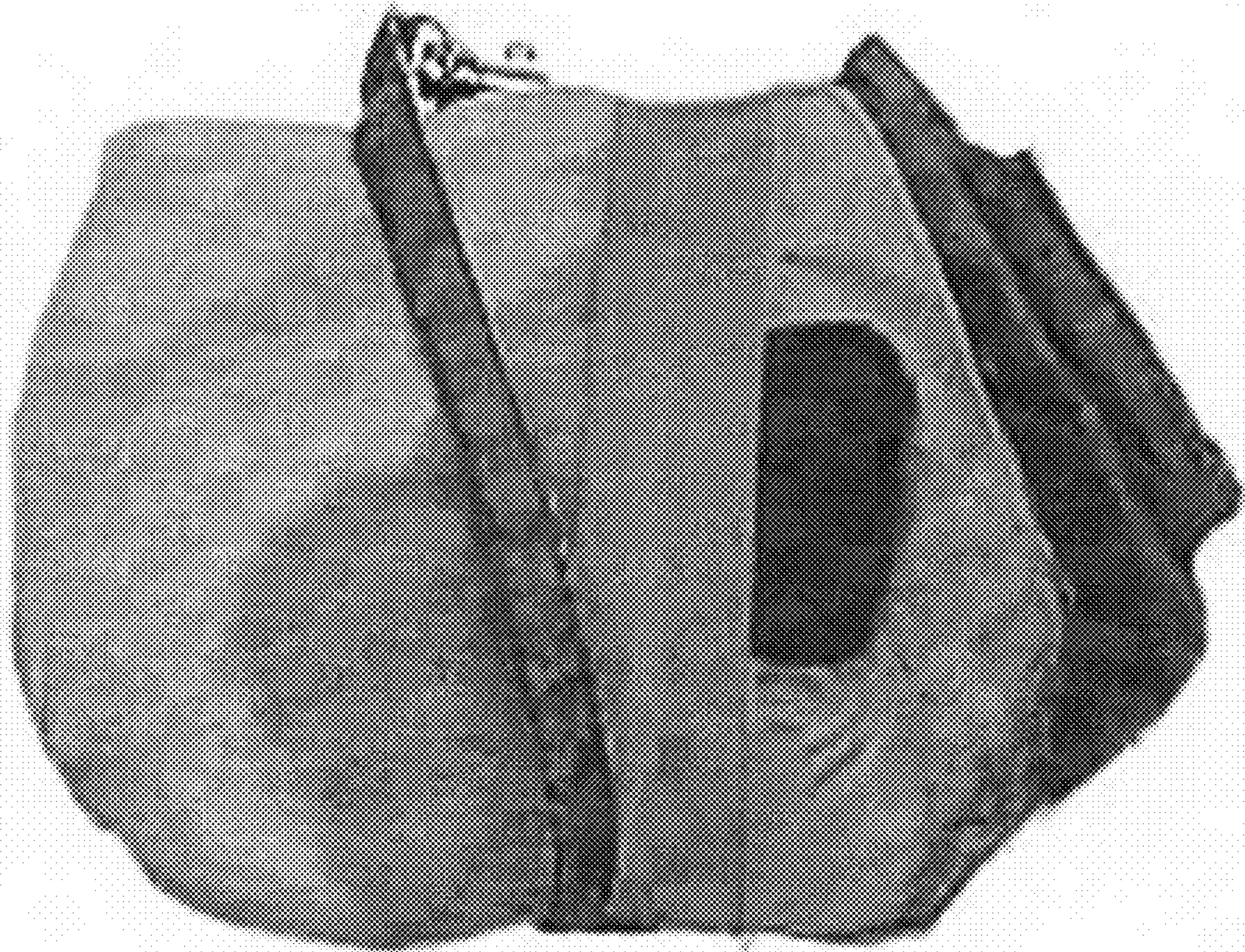

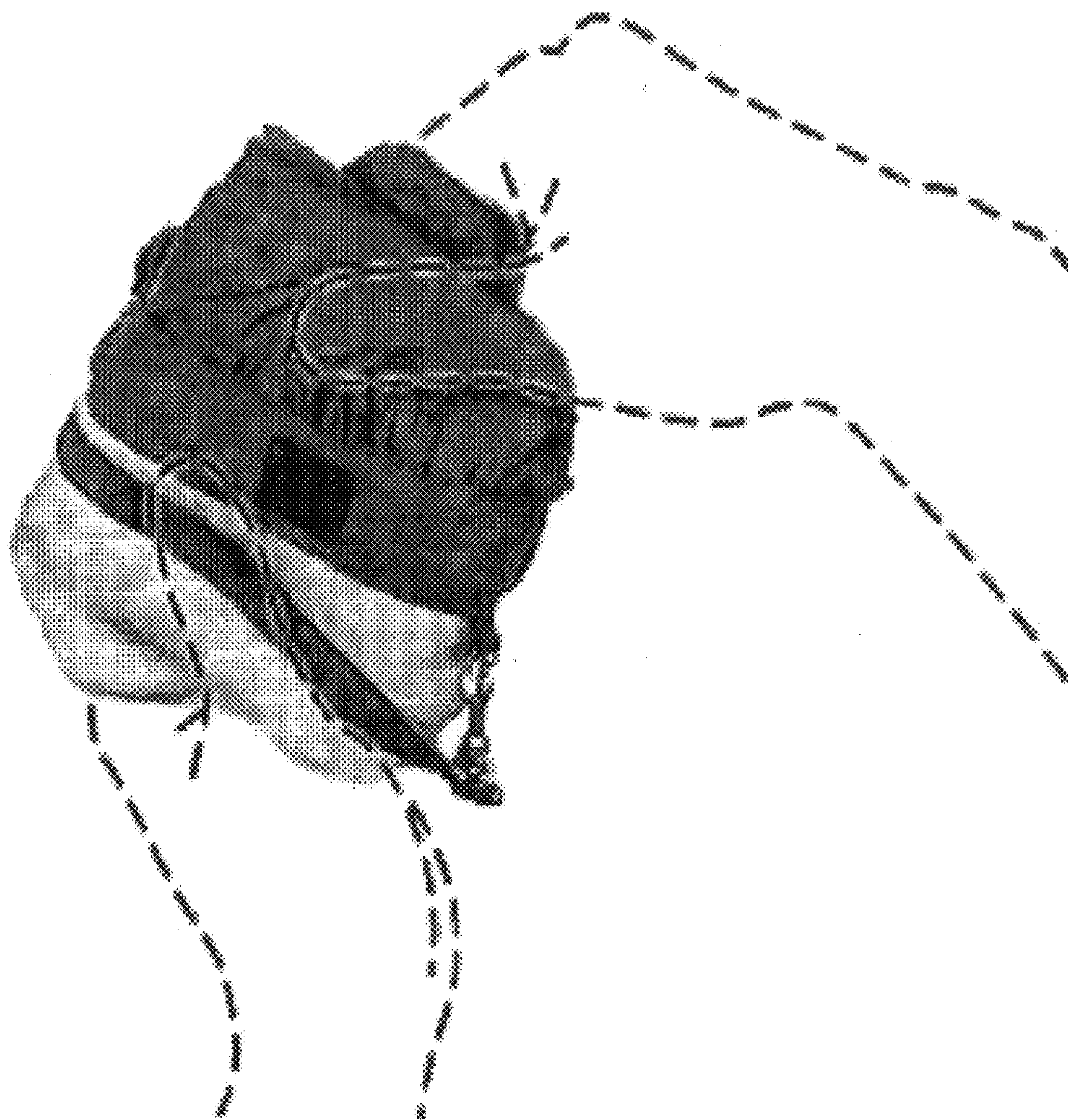

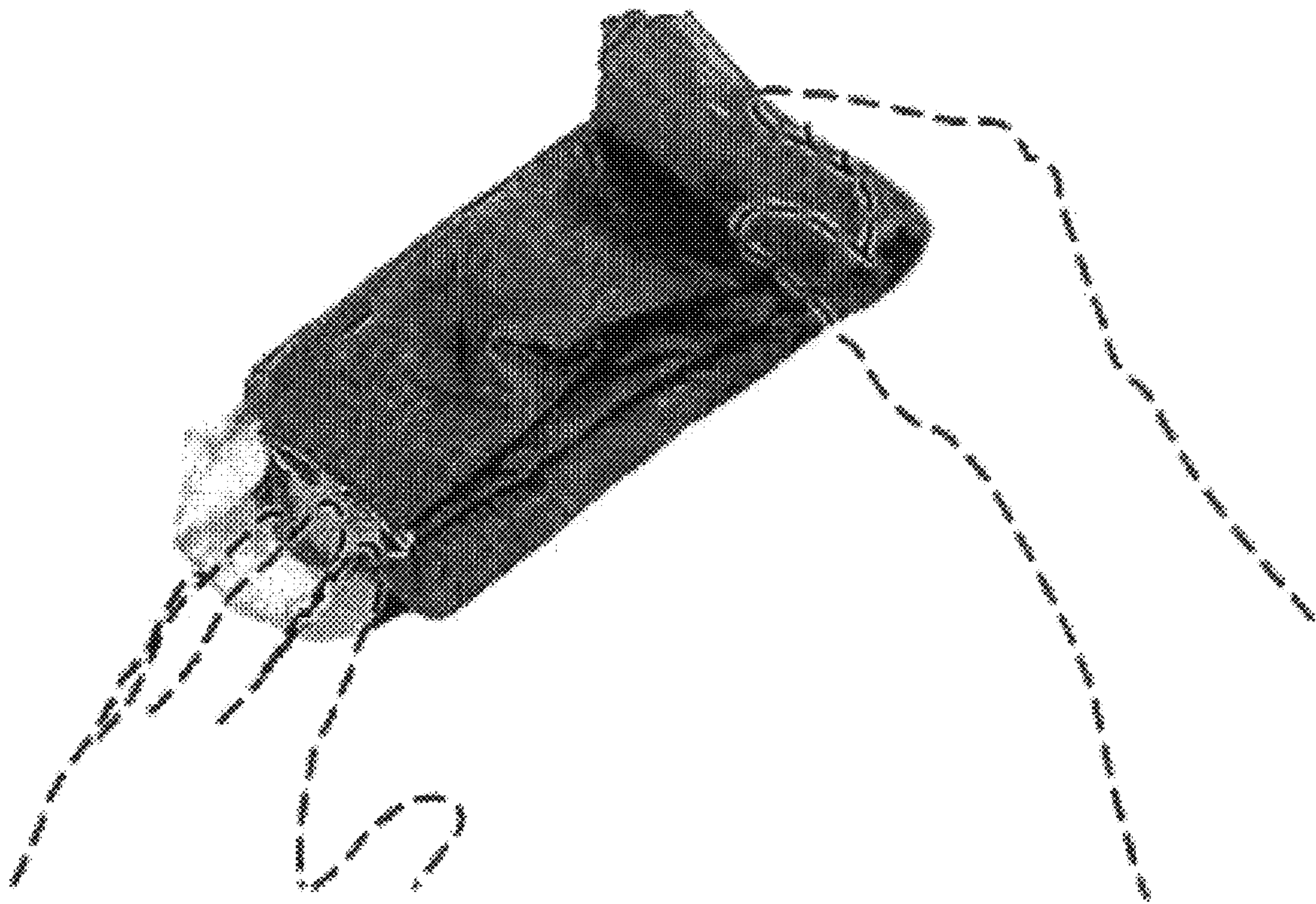

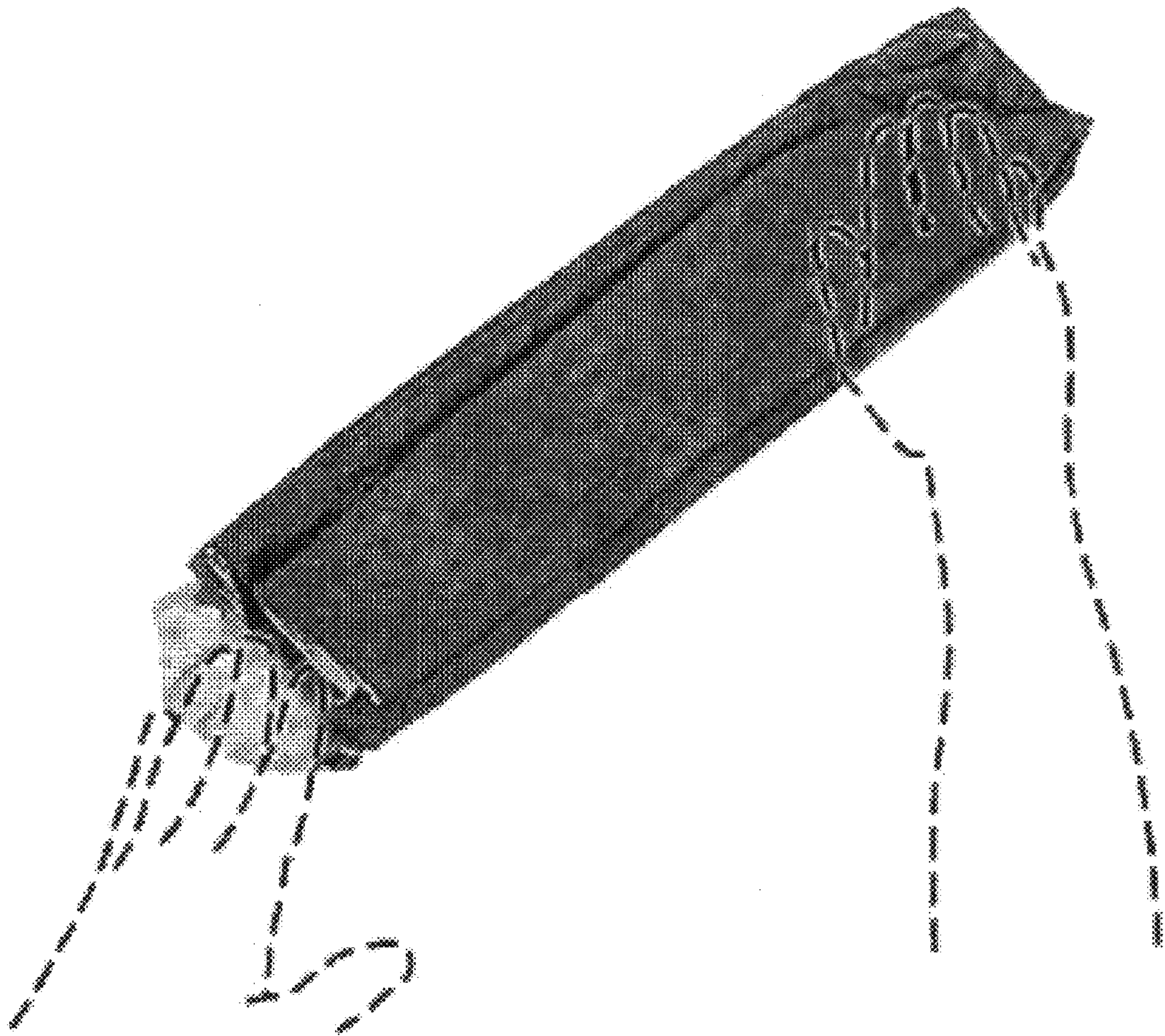

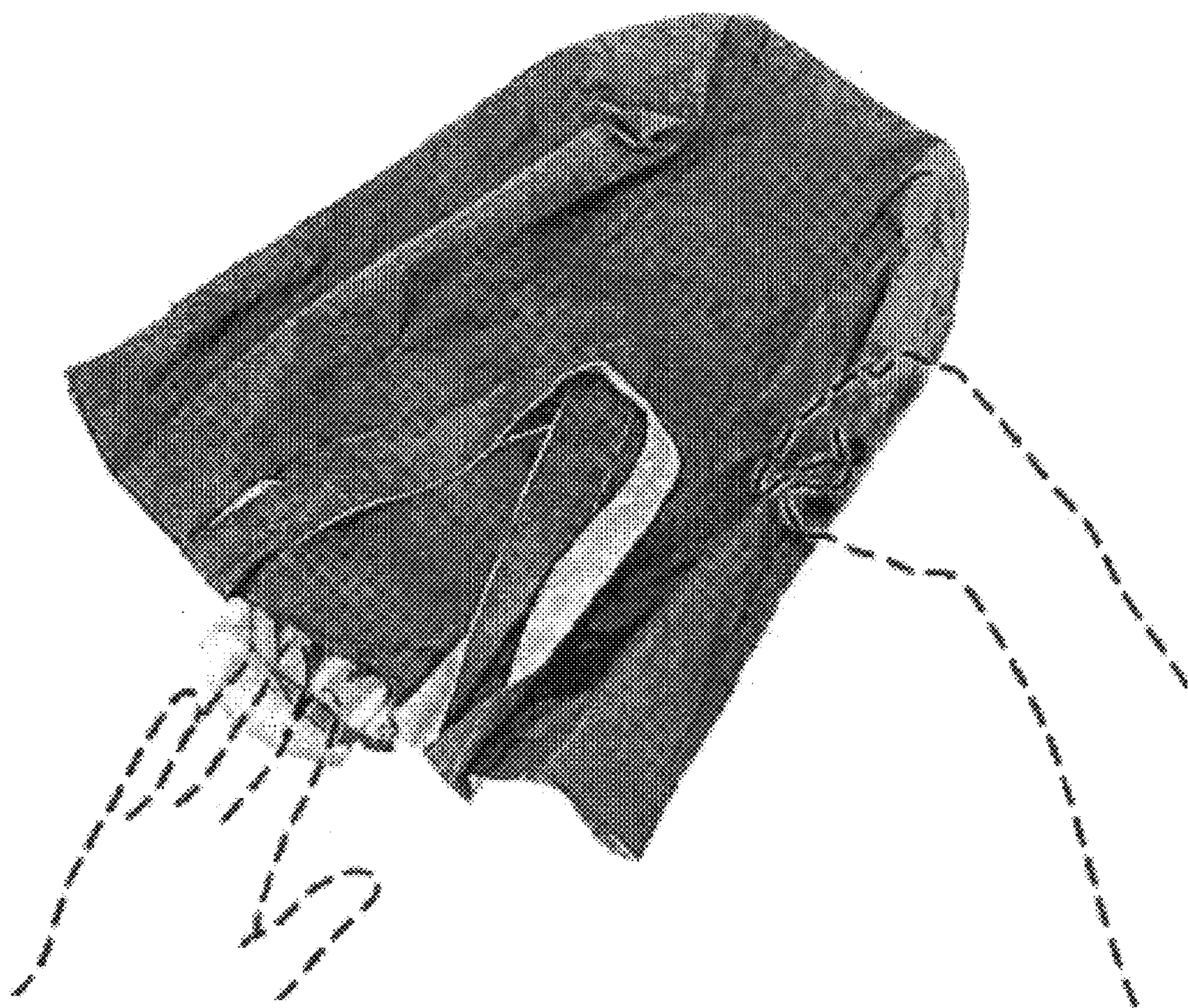

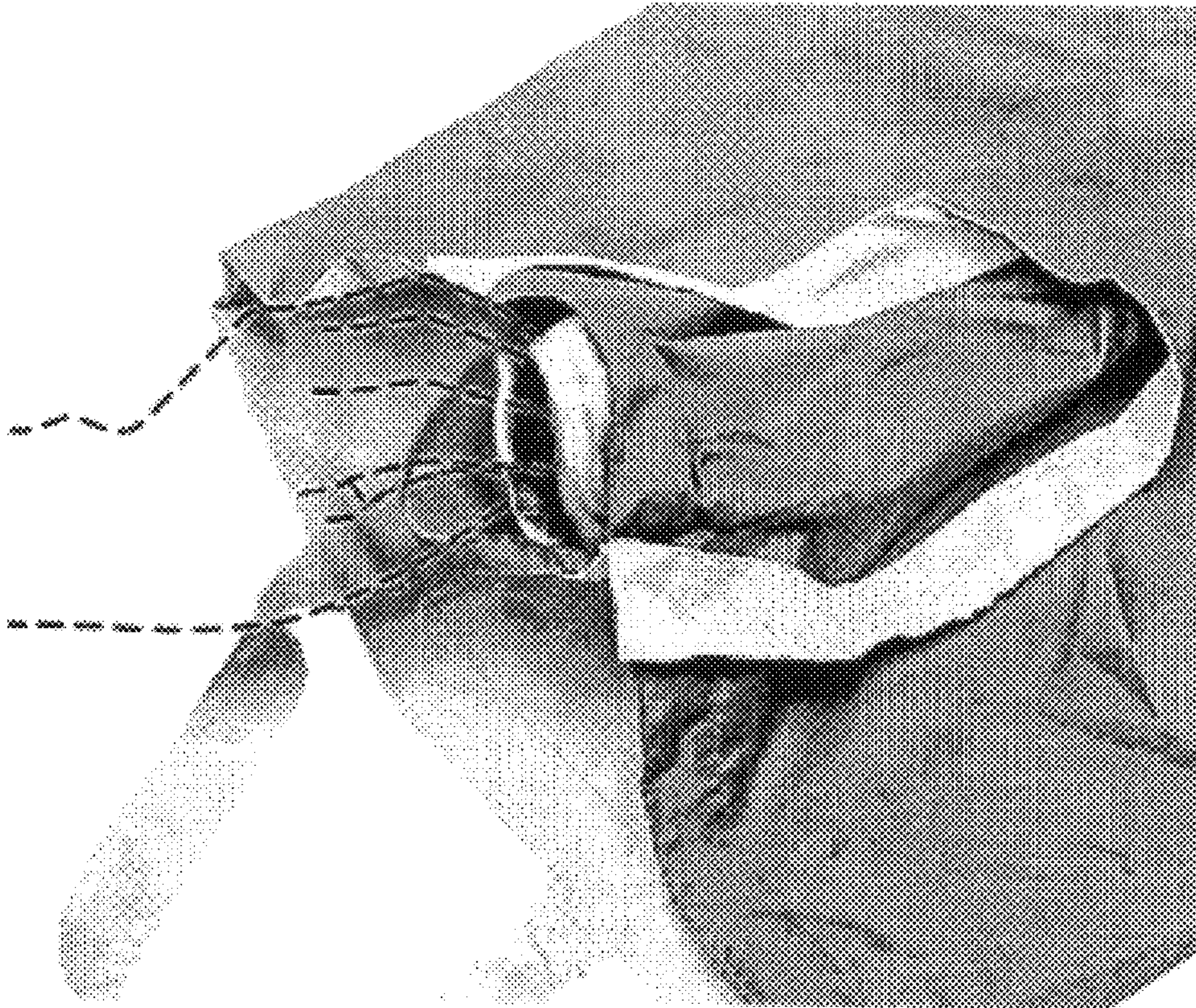

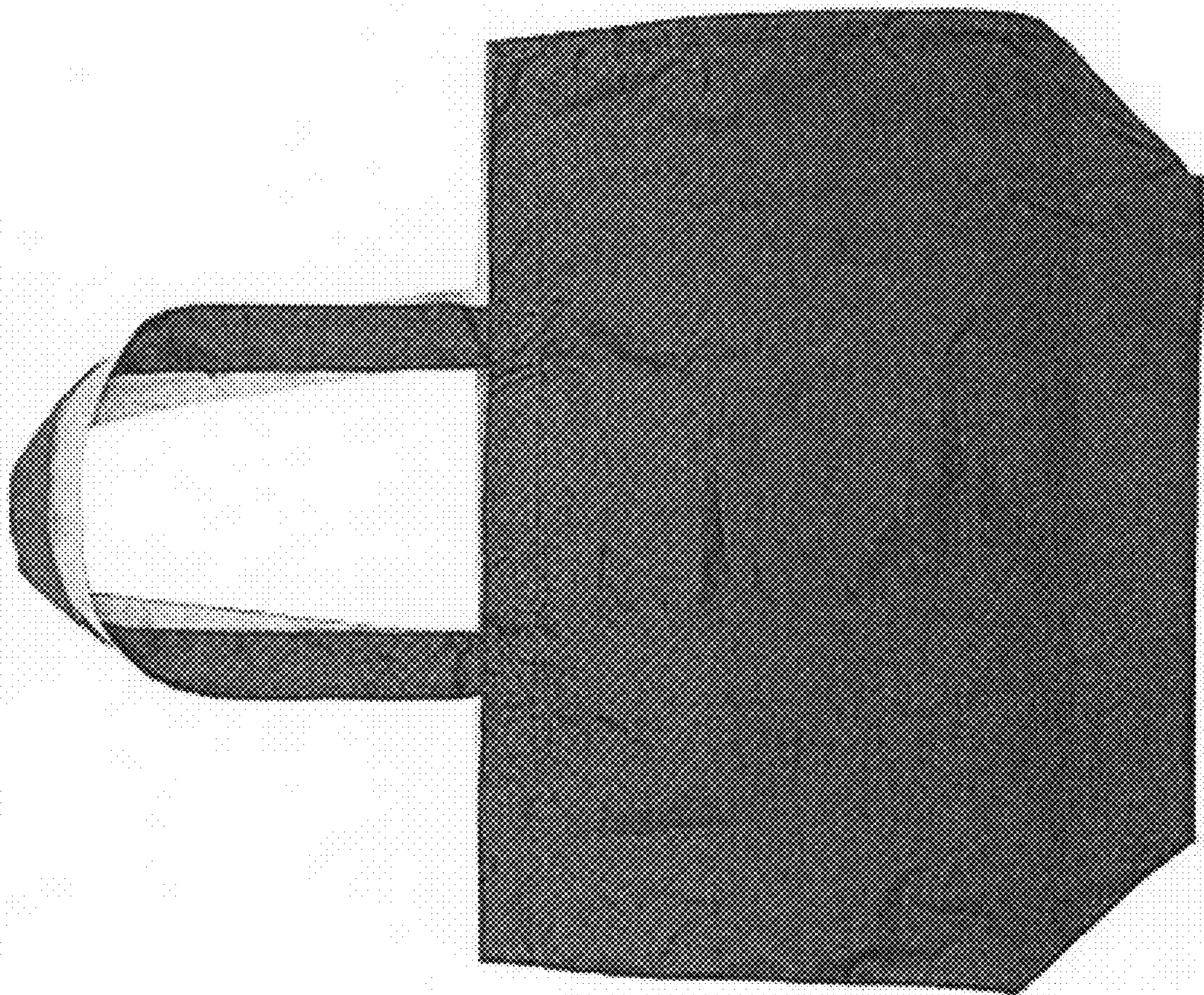
