(57) **CLAIM**

We claim the ornamental design for a case configured to hold computer, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right isometric view of the case in a closed position;

FIG. 2 is a back, bottom, right isometric view of the case in the closed position;

FIG. 3 is a top view of the case in the closed position;

FIG. 4 is a left side view of the case in the closed position where the right side view is a mirror image of the left side view;

FIG. 5 is a front view of the case in the closed position;

FIG. 6 is a back view of the case in the closed position;

FIG. 7 is a bottom view of the case in the closed position;

FIG. 8 is a front, top, right isometric view of the case in an open position;

FIG. 9 is a left side view of the case in the open position where the right side view is a mirror image of the left side view;

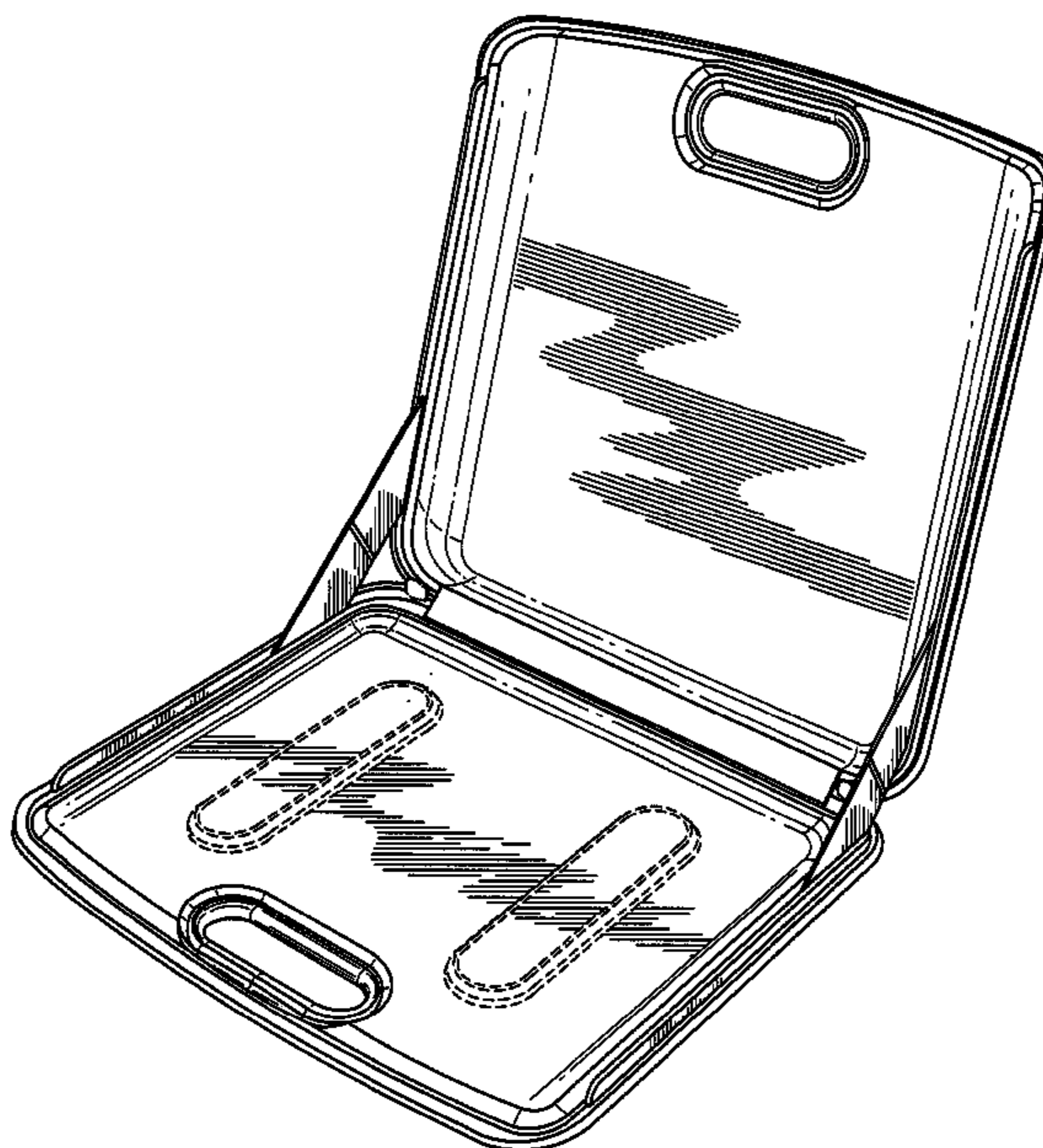
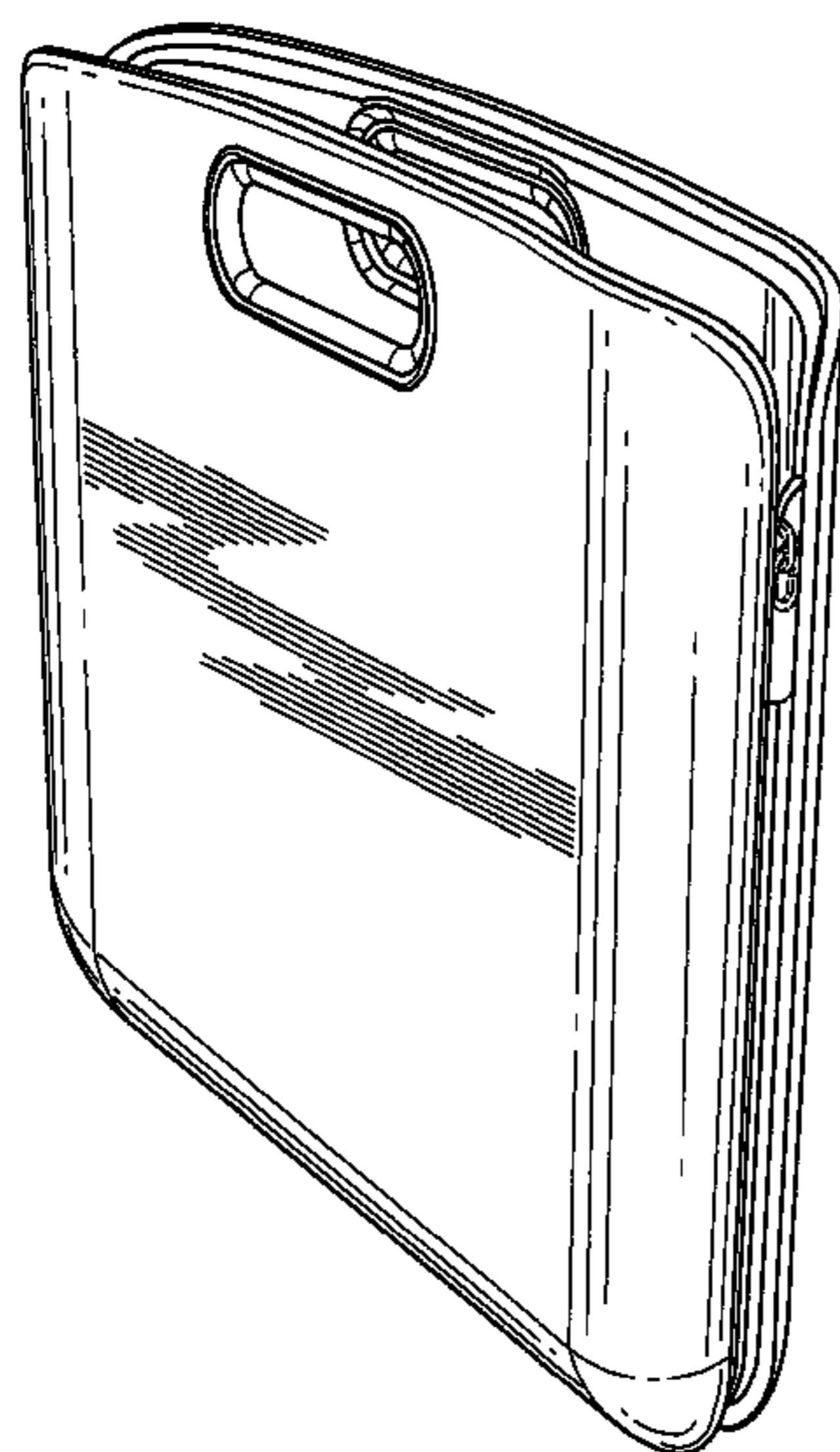
FIG. 10 is a top view of the case in the open position;

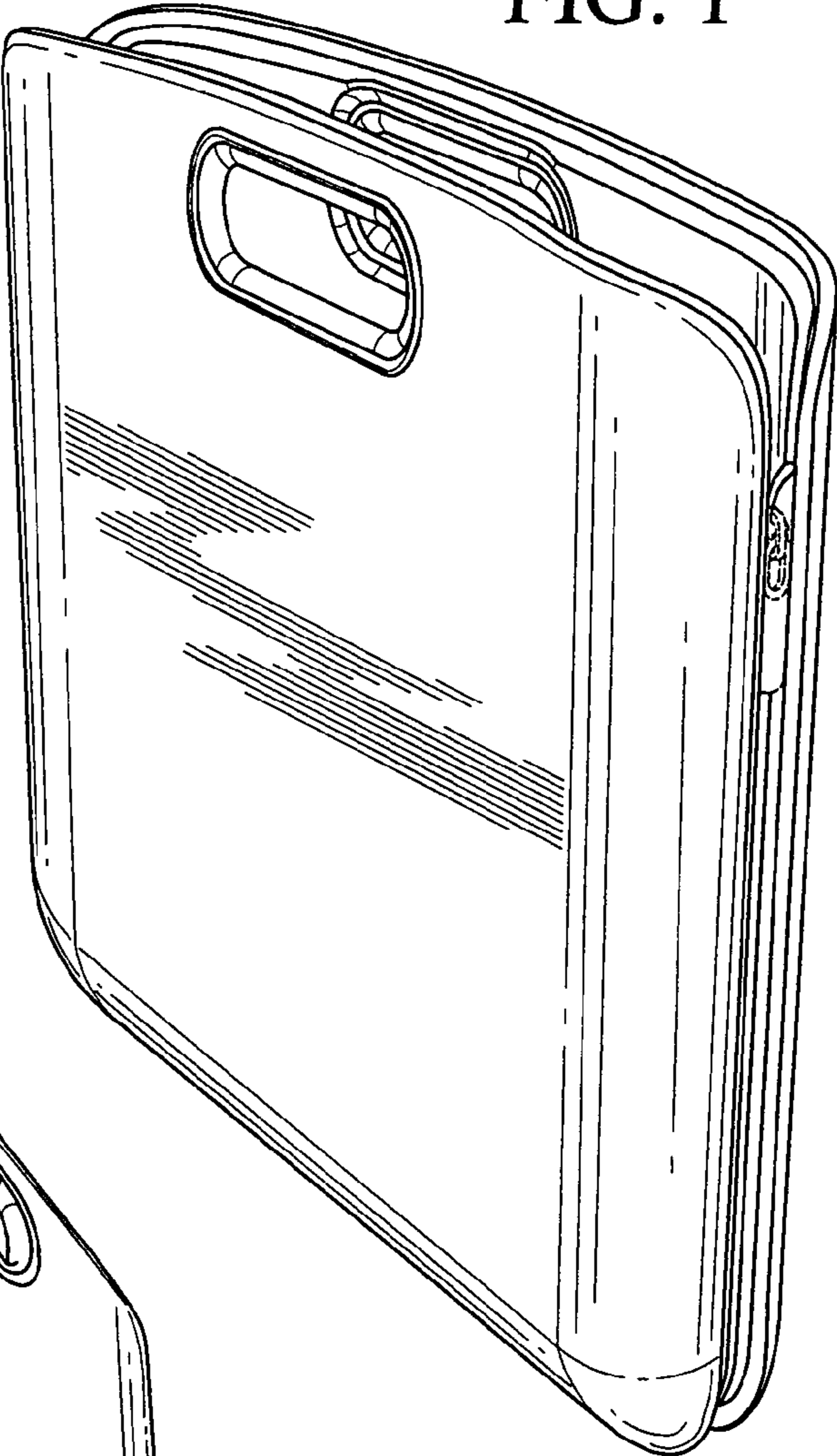

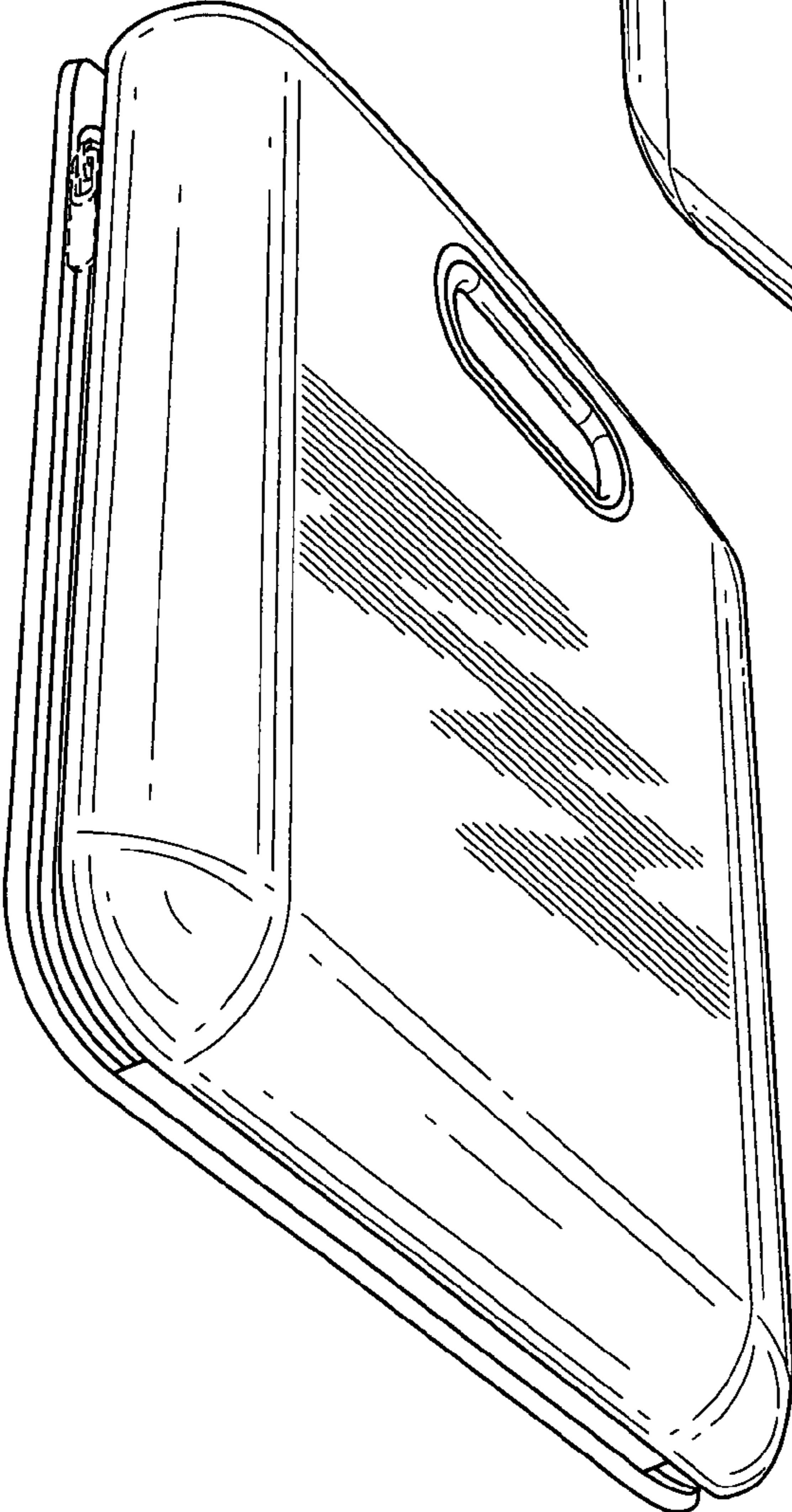

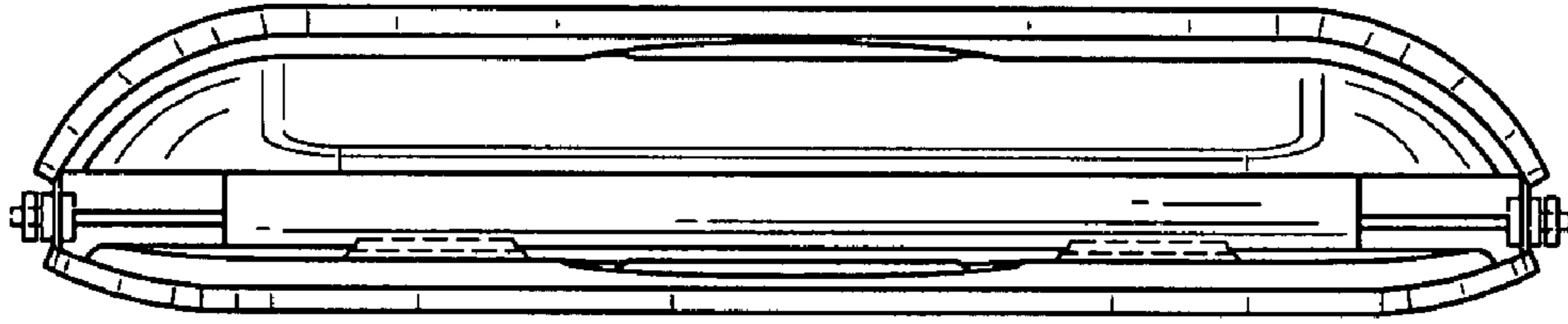

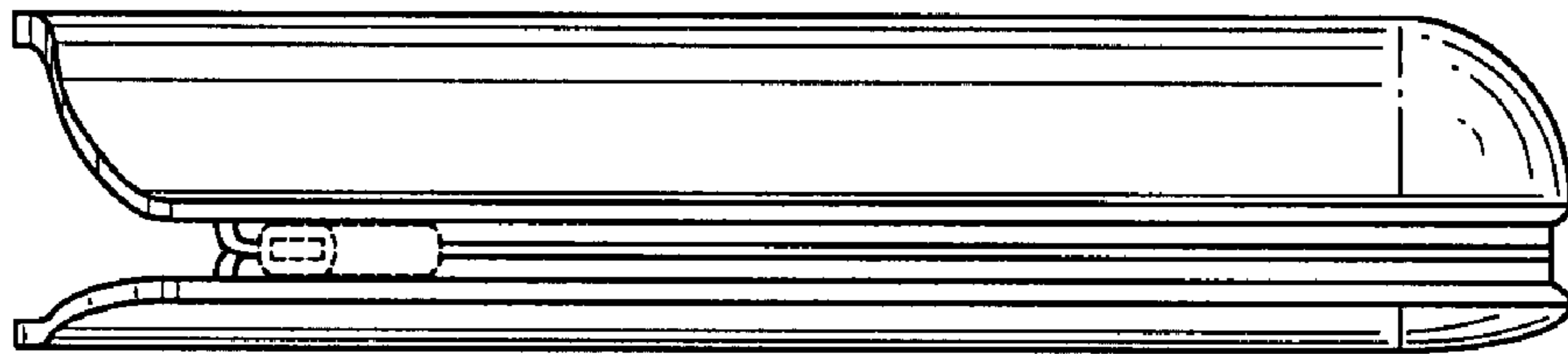

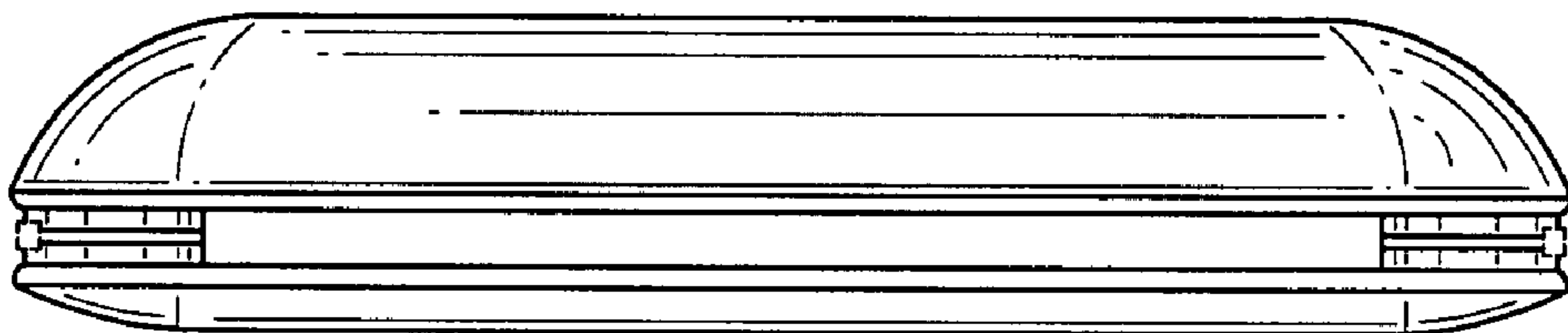

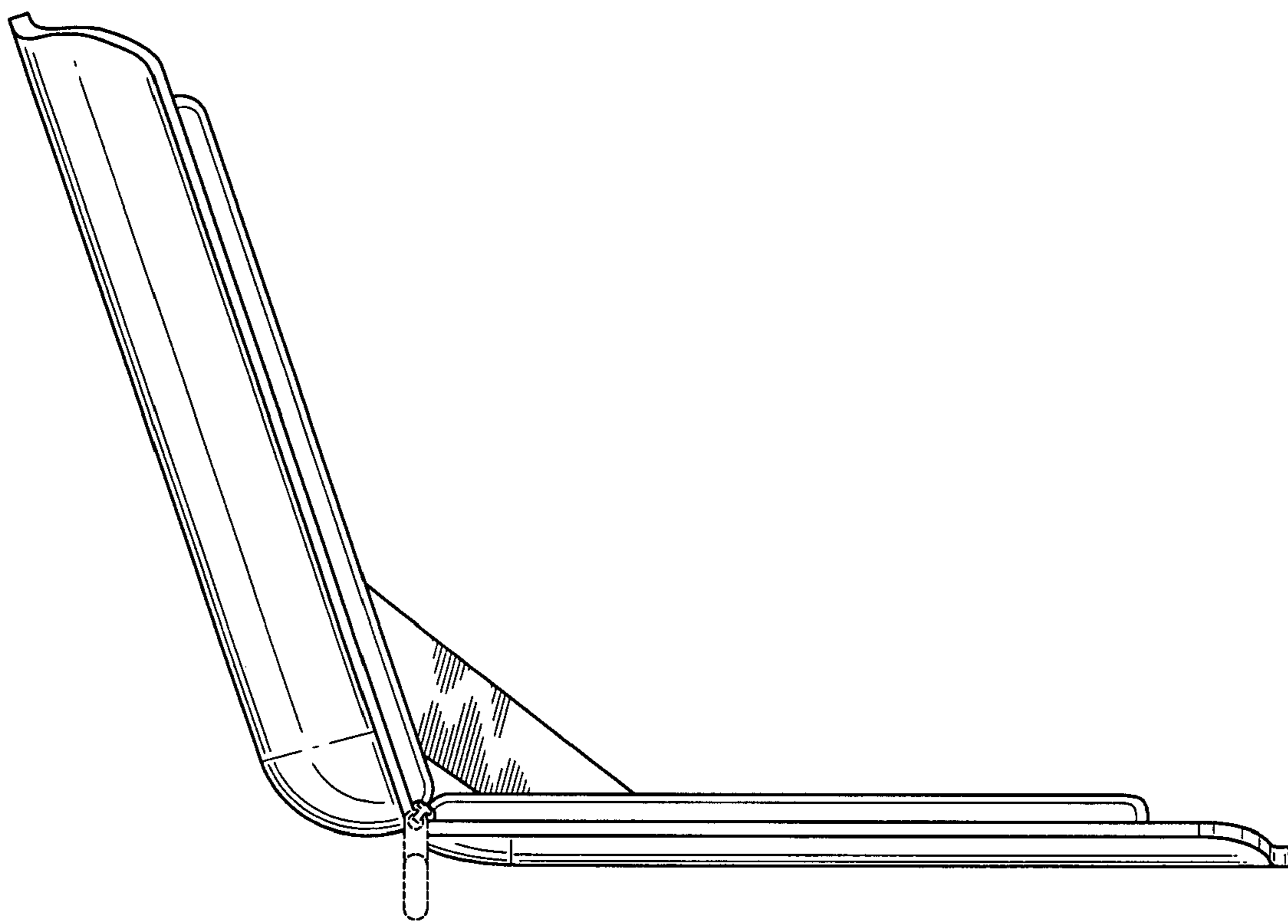

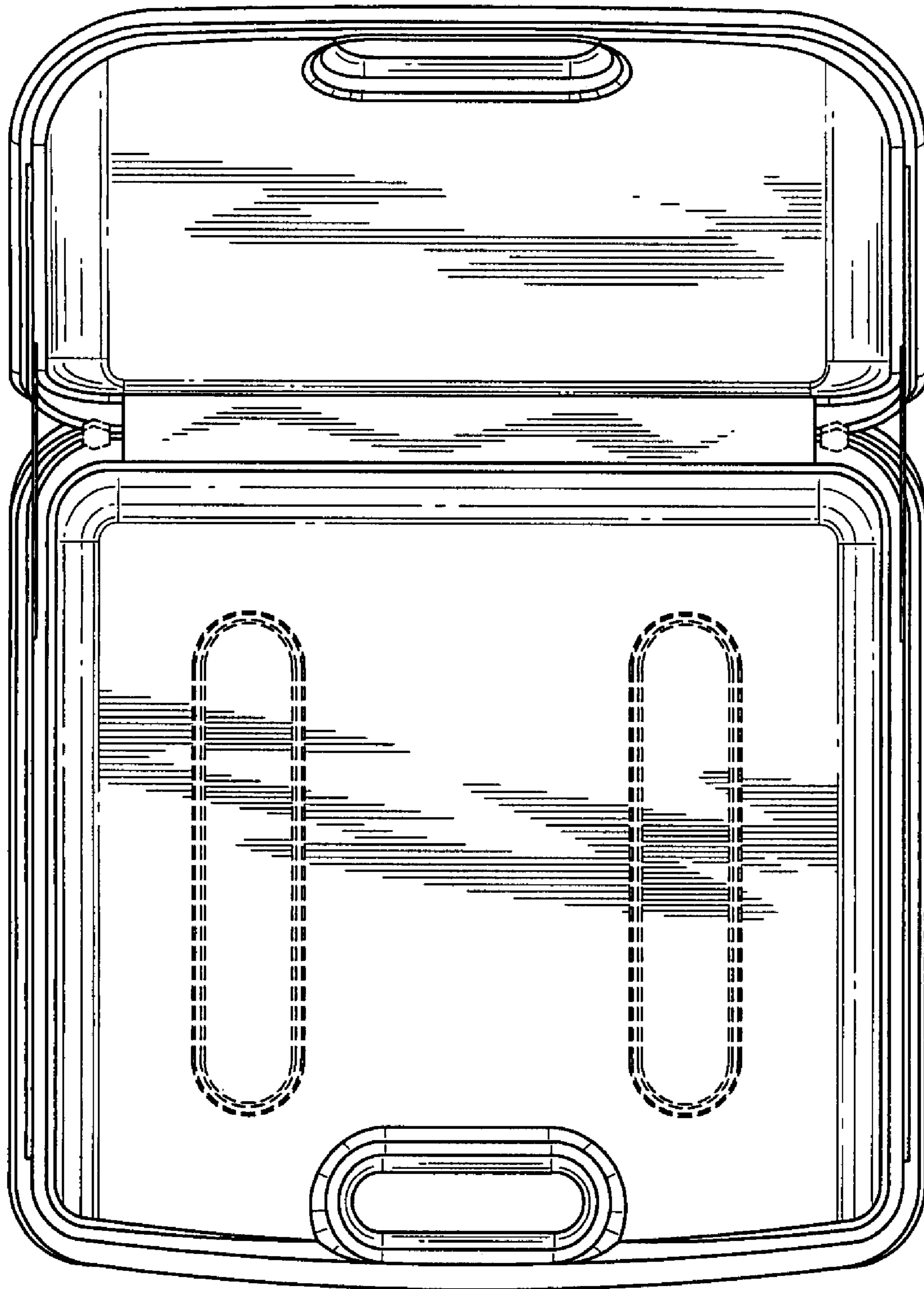

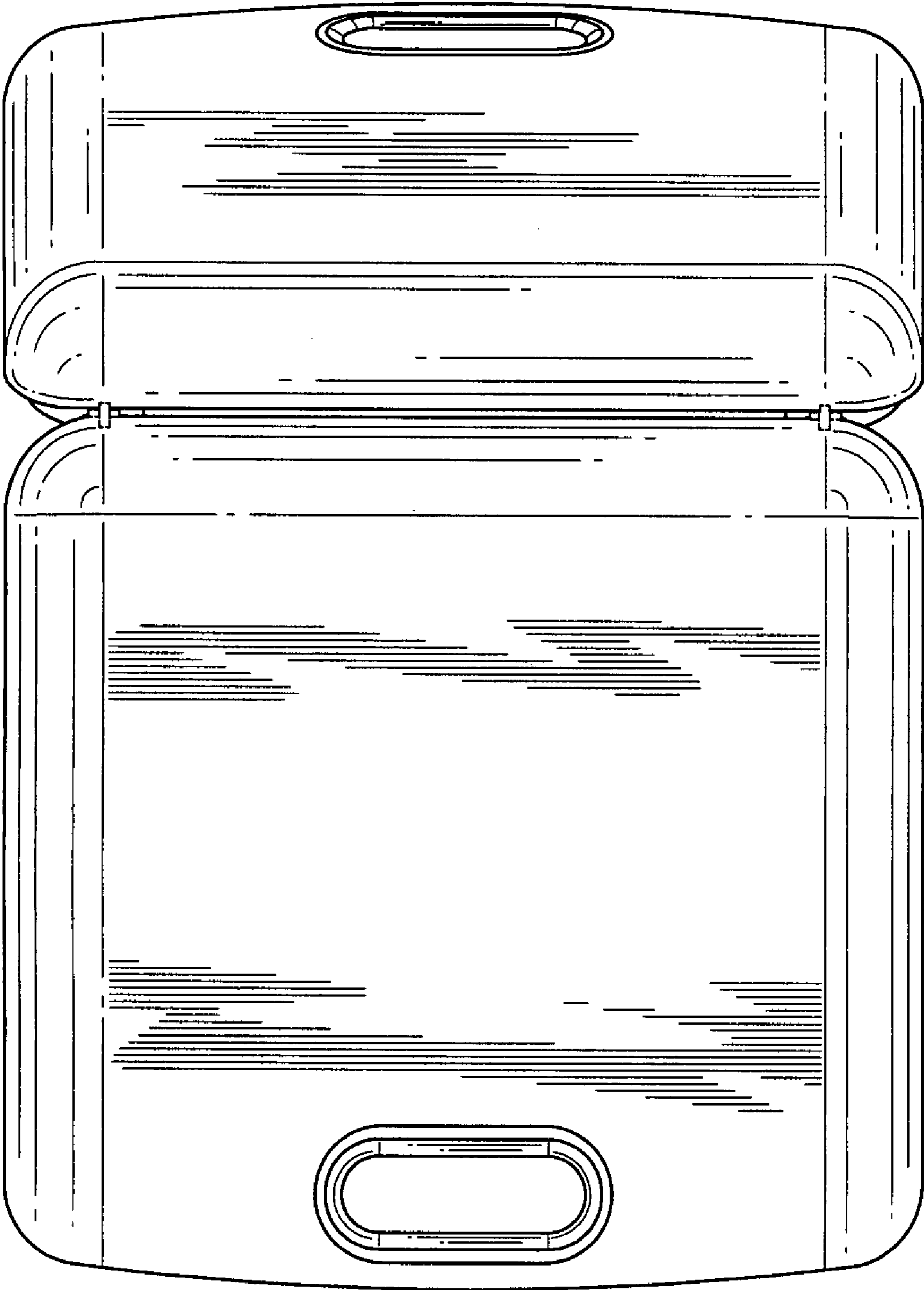
